The ornamental design for an eyeliner application device, as shown and described.

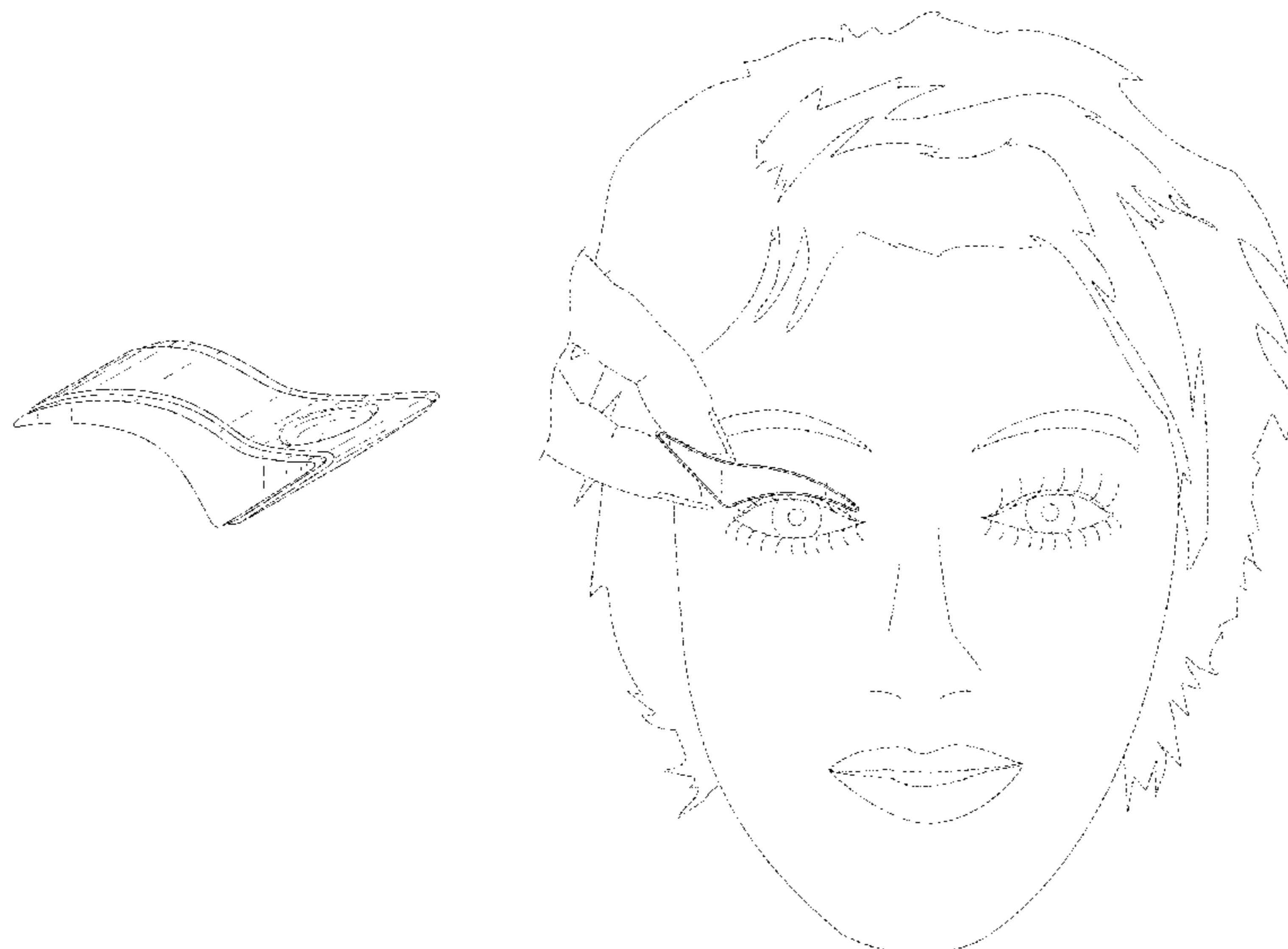
**DESCRIPTION**

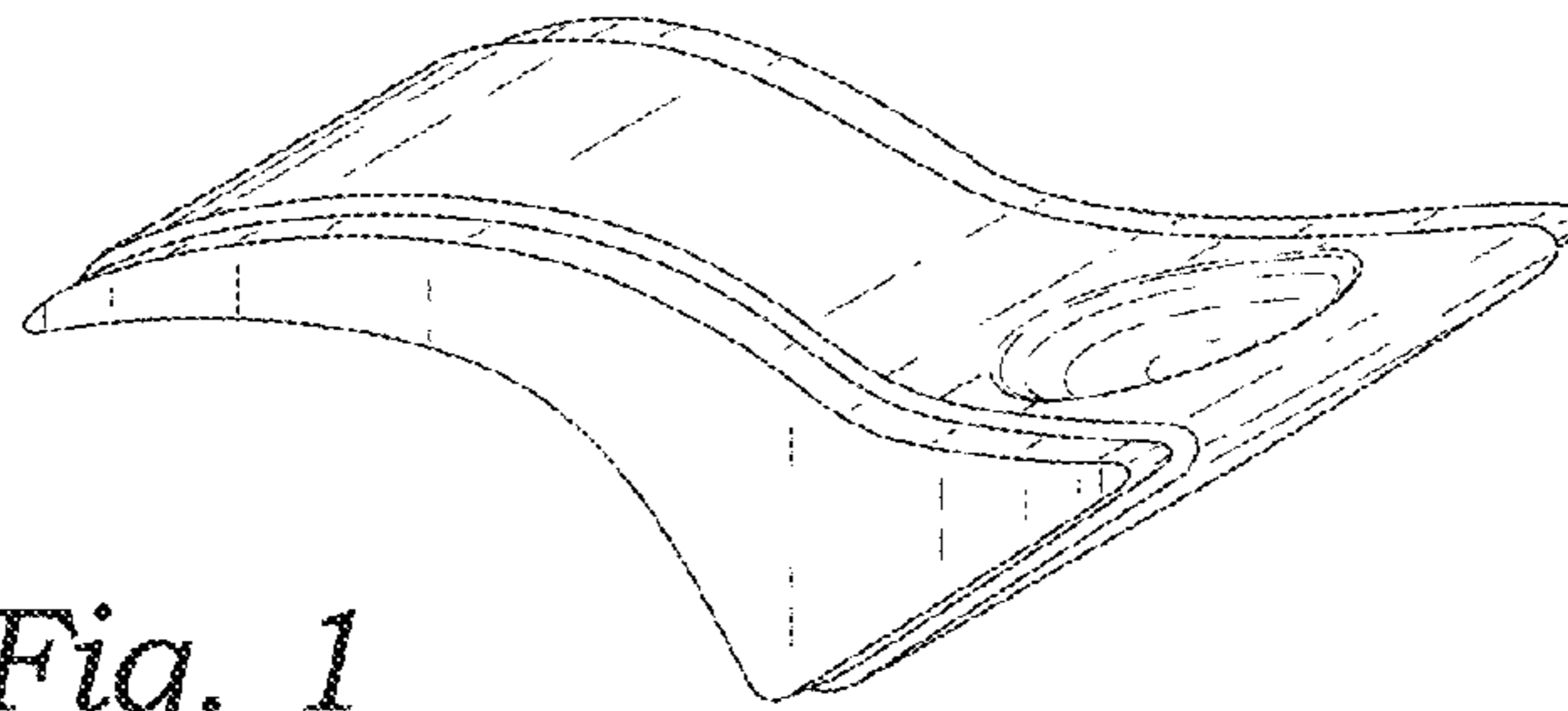

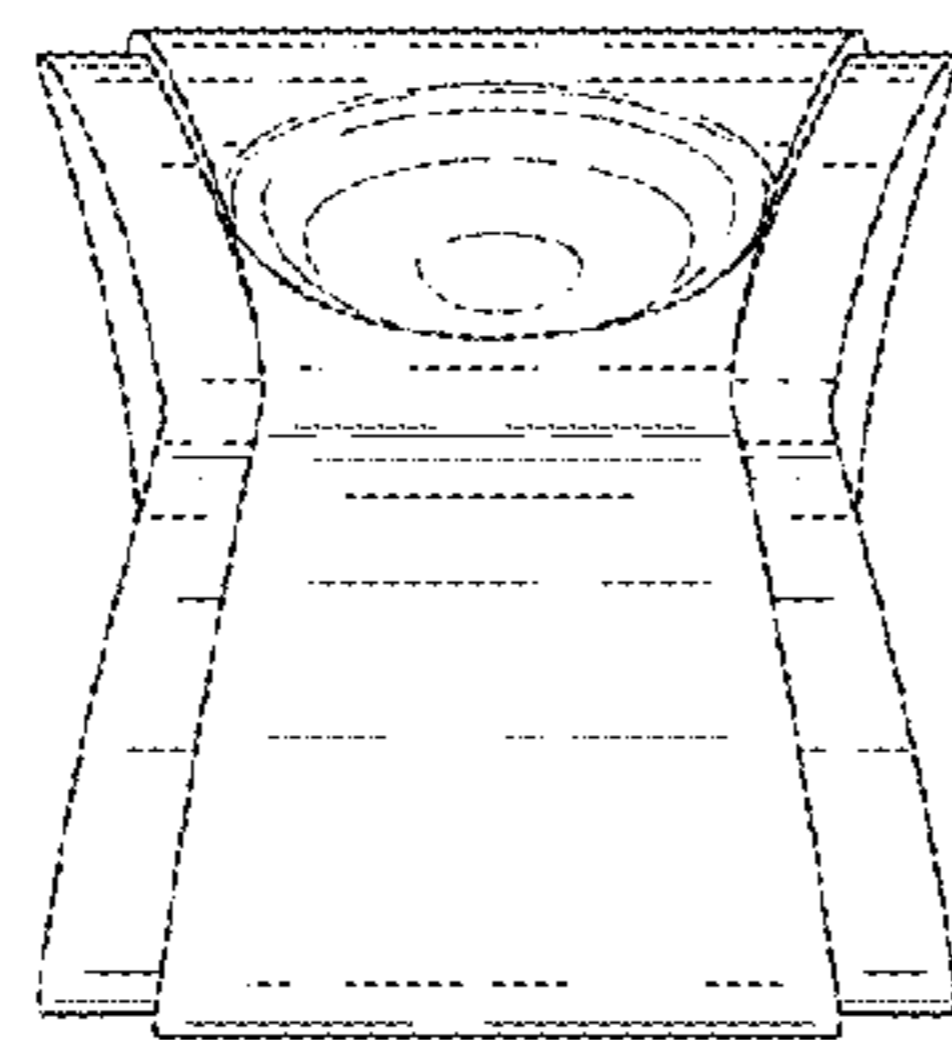

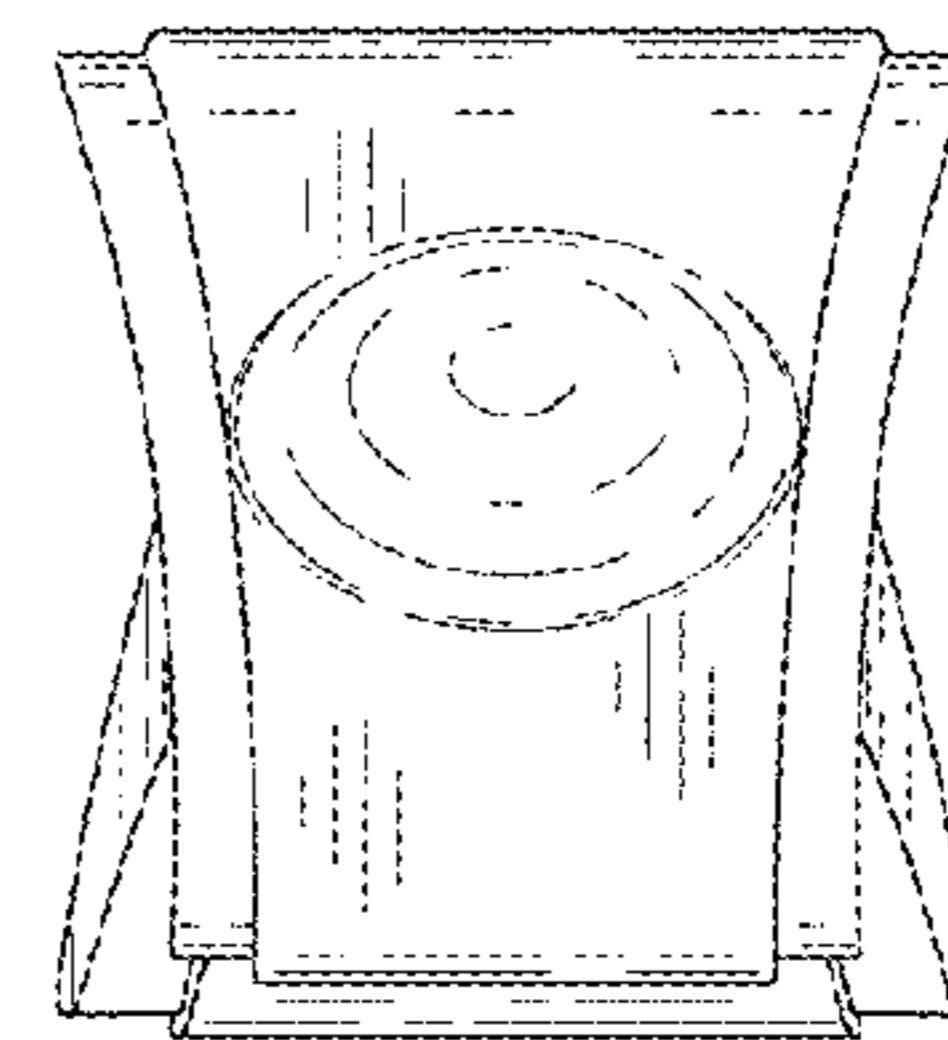

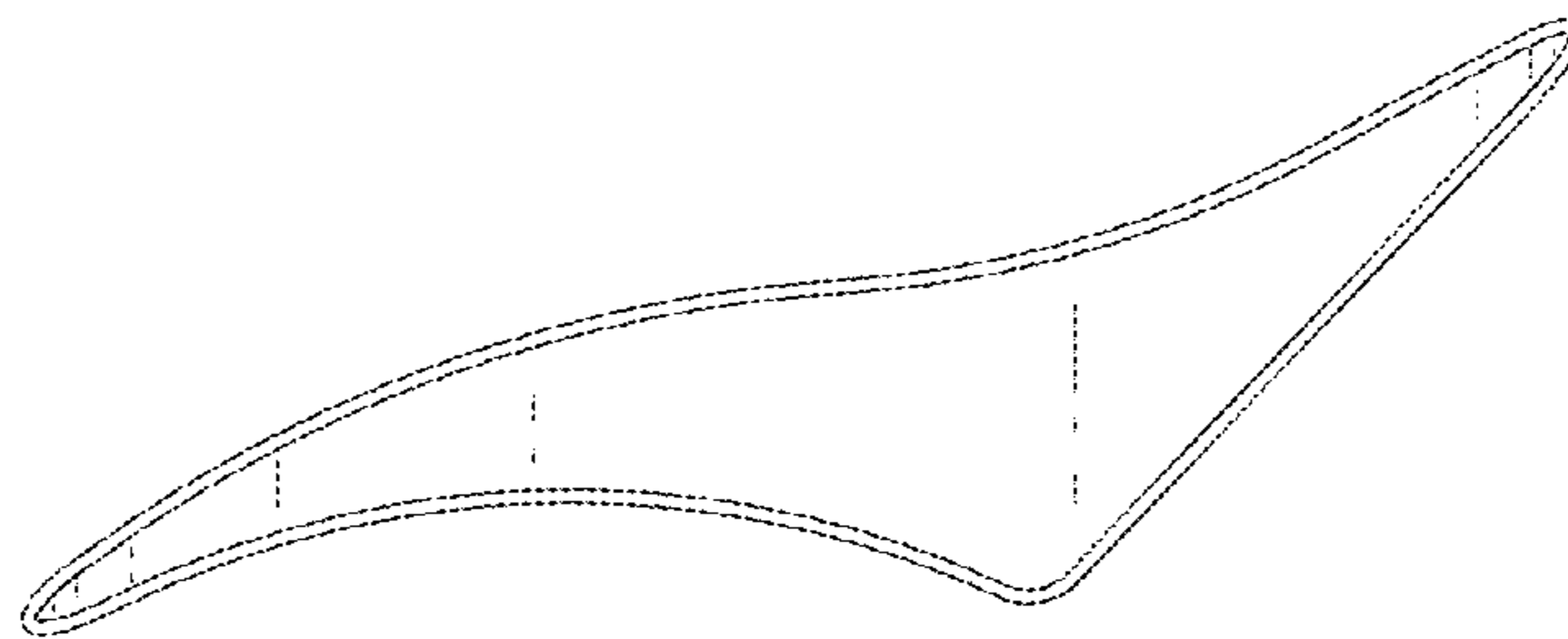

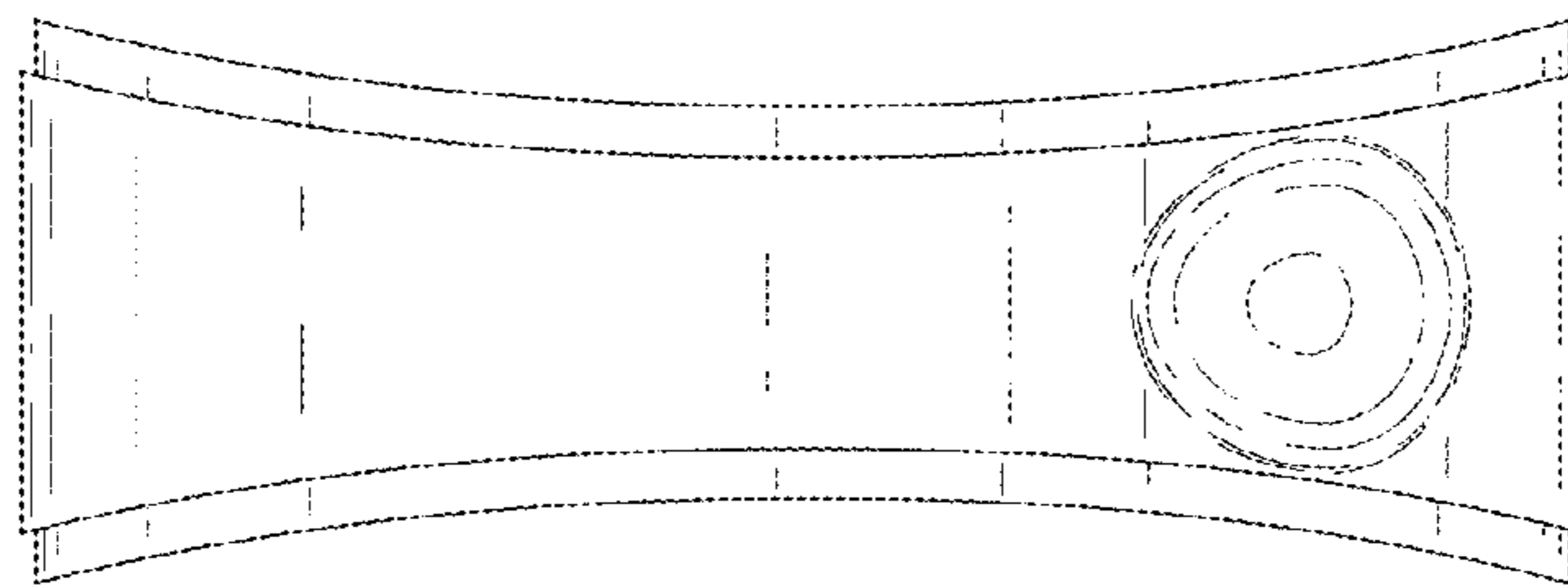

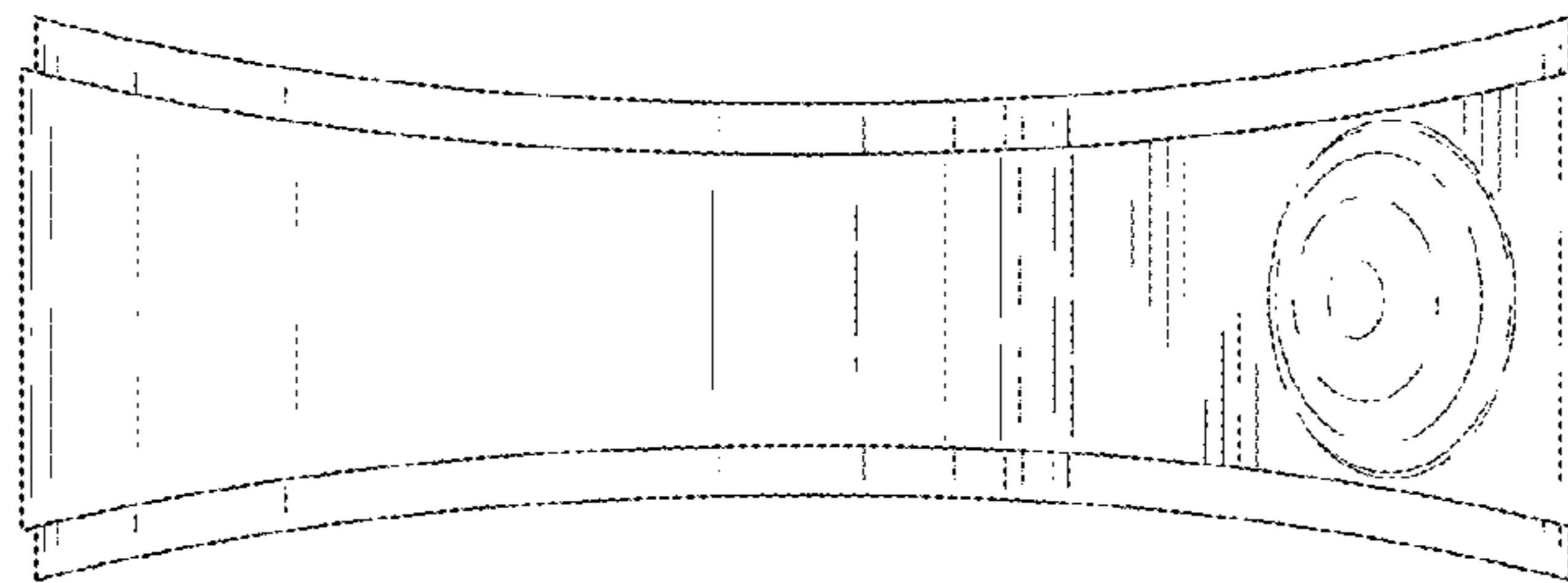
