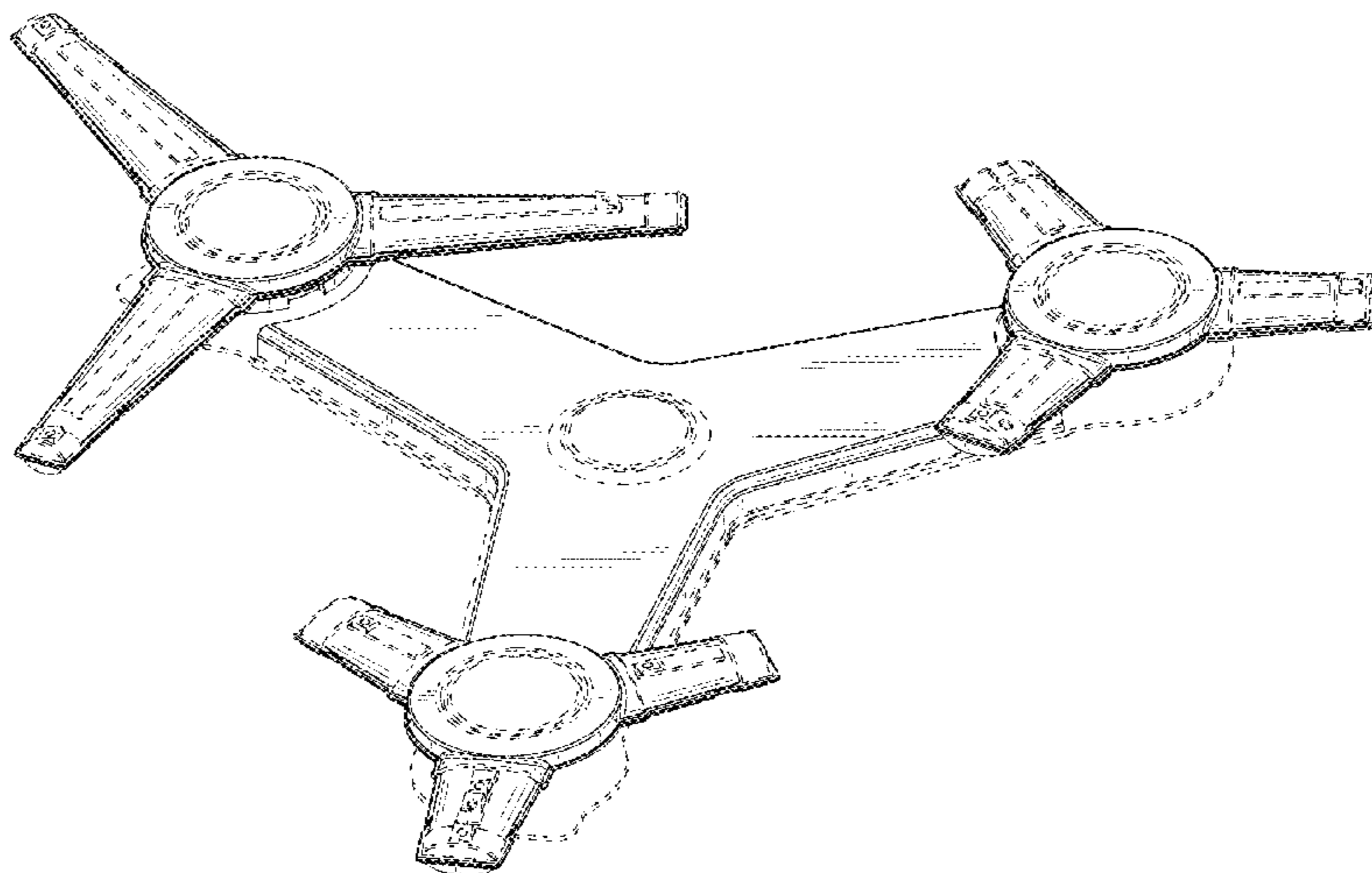
(57) **CLAIM**

We claim the ornamental design for a wash arm, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a wash arm of the present disclosure;
FIG. 2 is a rear perspective view of the wash arm of FIG. 1;
FIG. 3 is a first side elevational view of the wash arm of FIG. 1;
FIG. 4 is a second side elevational view of the wash arm of FIG. 1;
FIG. 5 is a third side elevational view of the wash arm of FIG. 1;

FIG. 7 is a top plan view of the wash arm of FIG. 1; and,

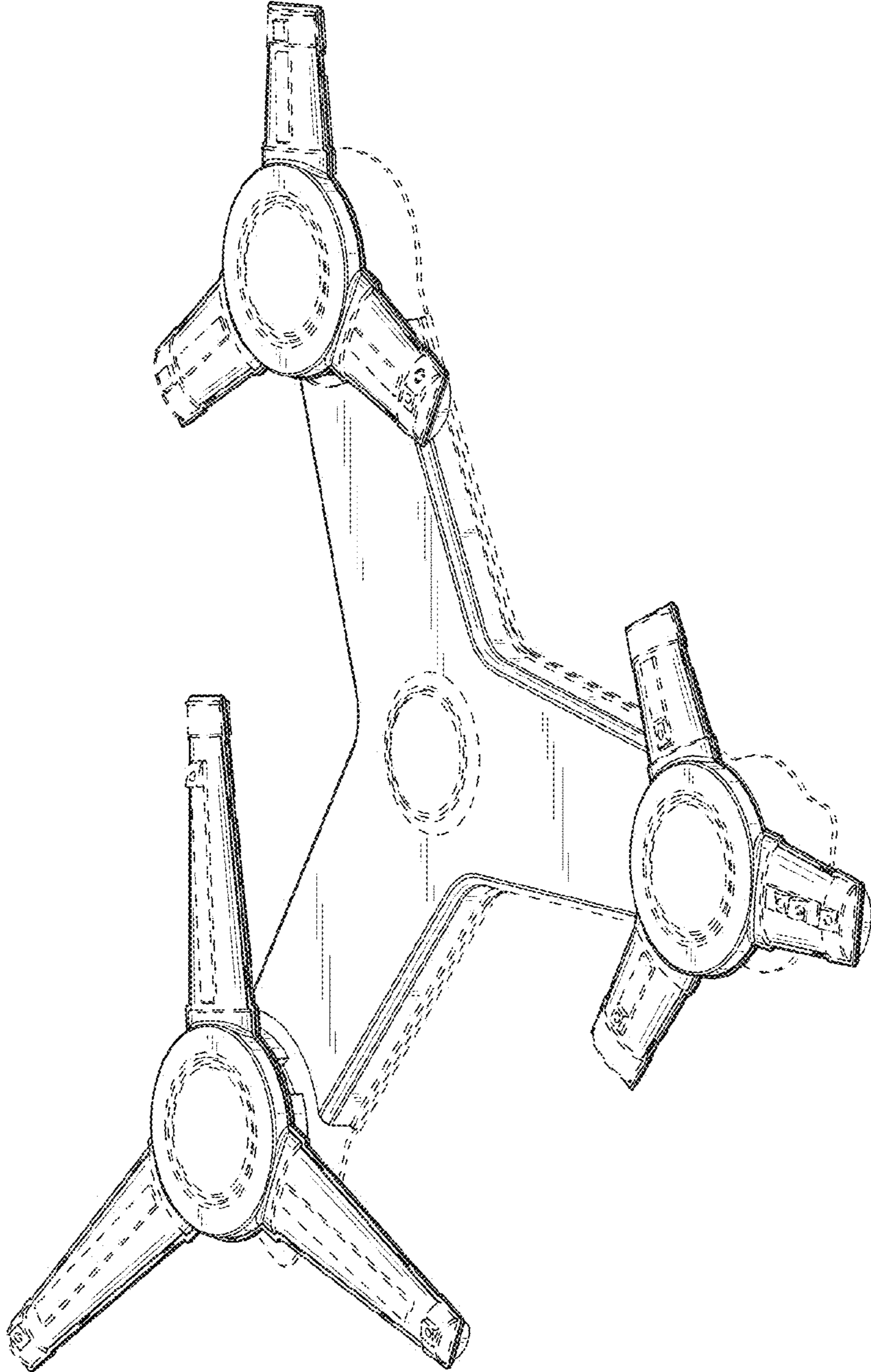

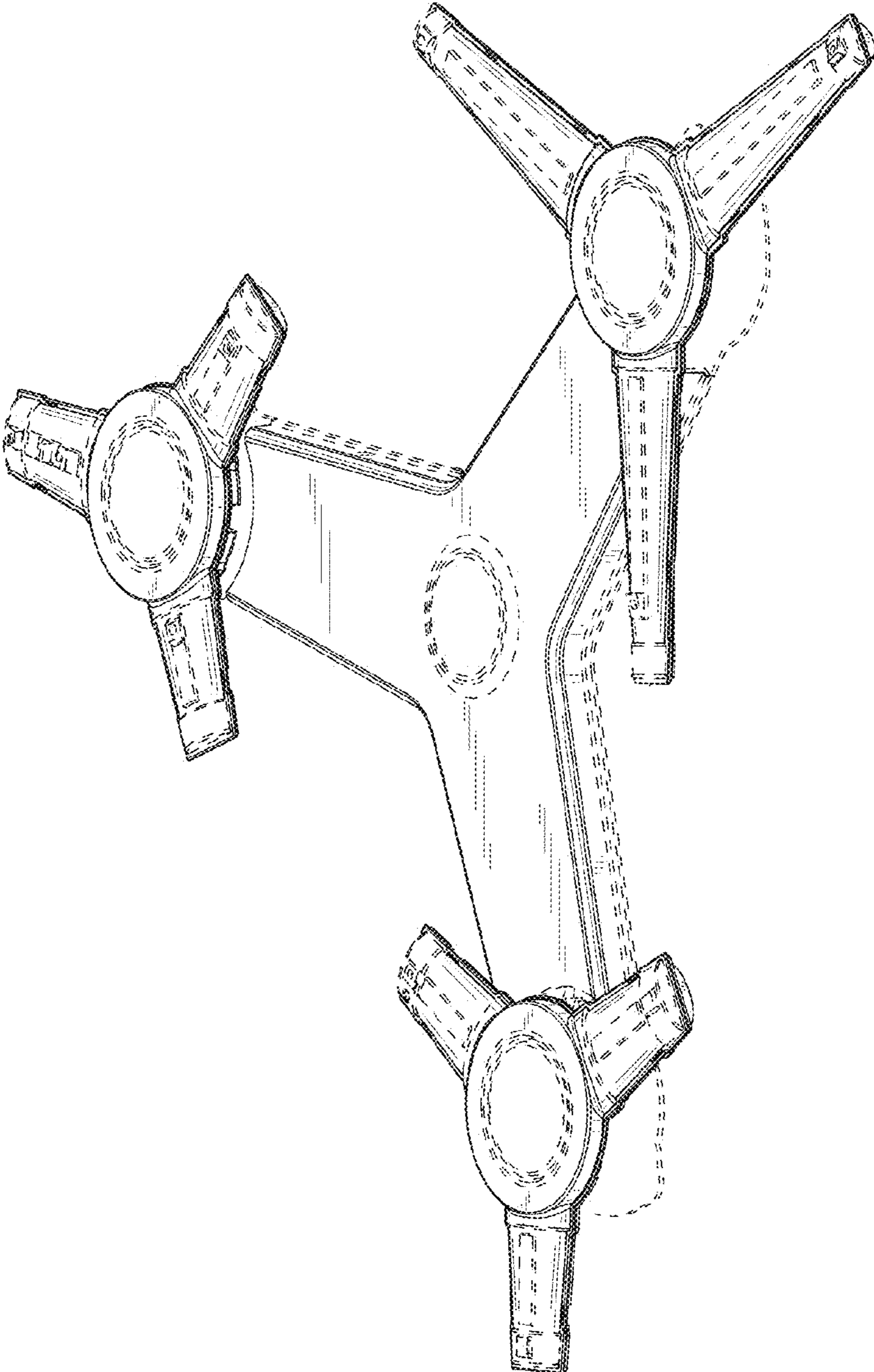

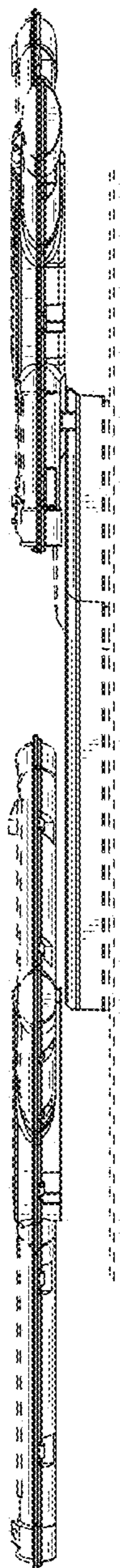

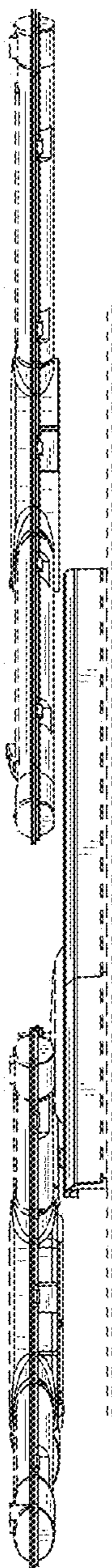

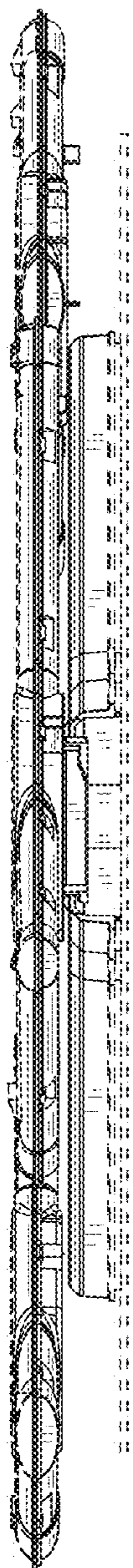

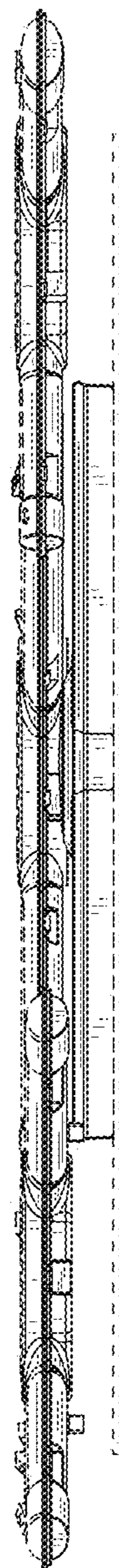

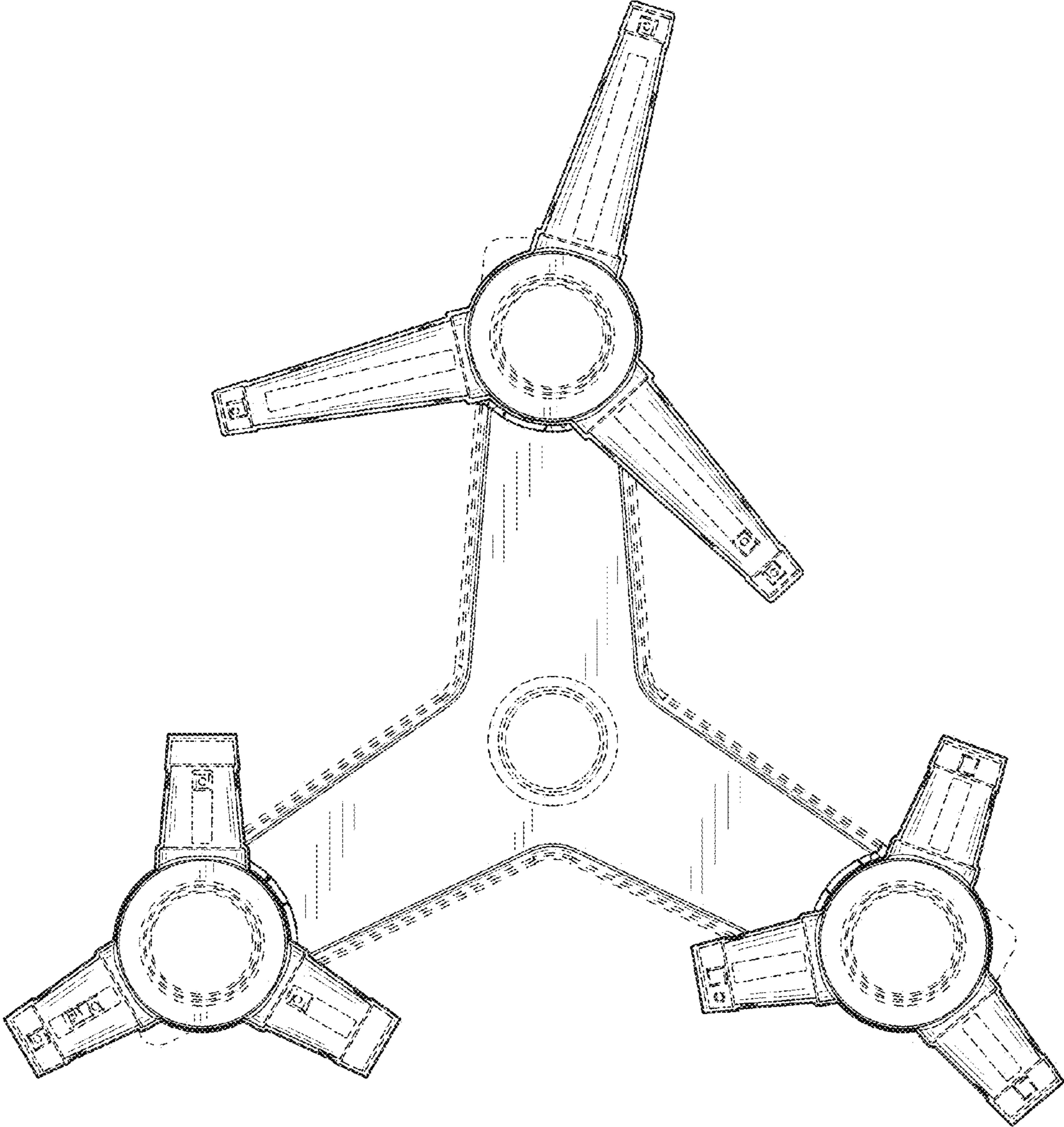

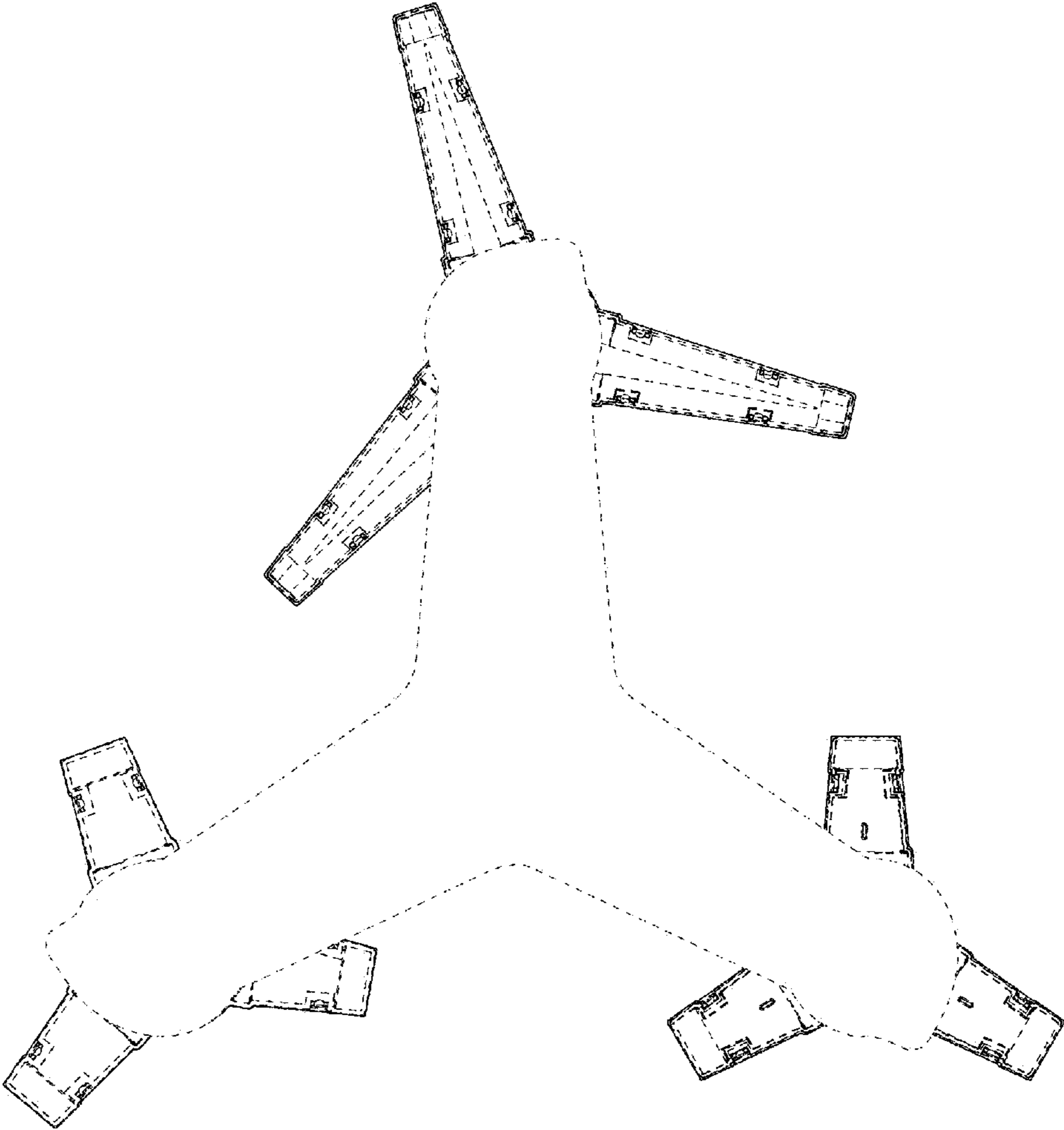
