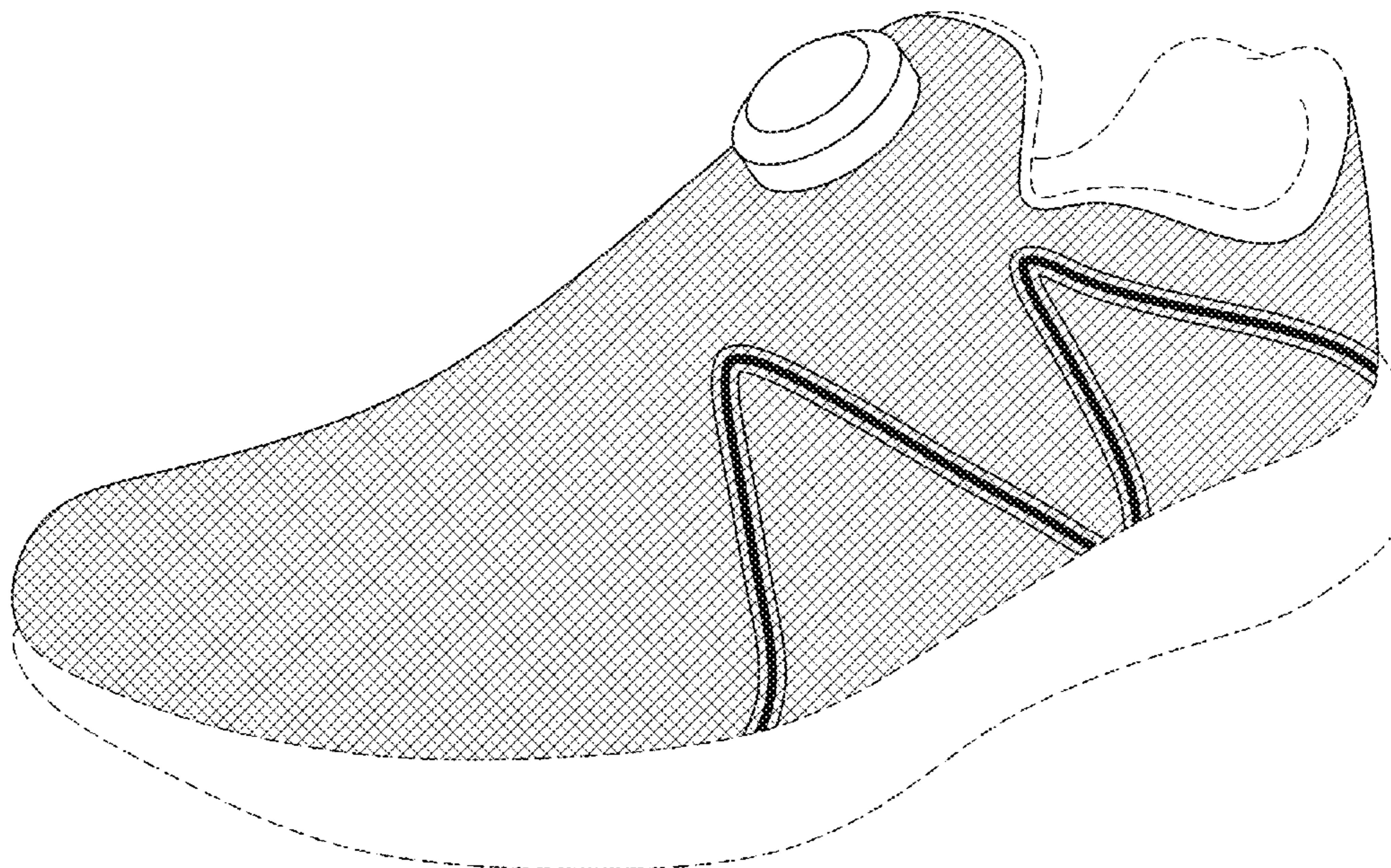
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top left front perspective view the shoe upper showing our new design;

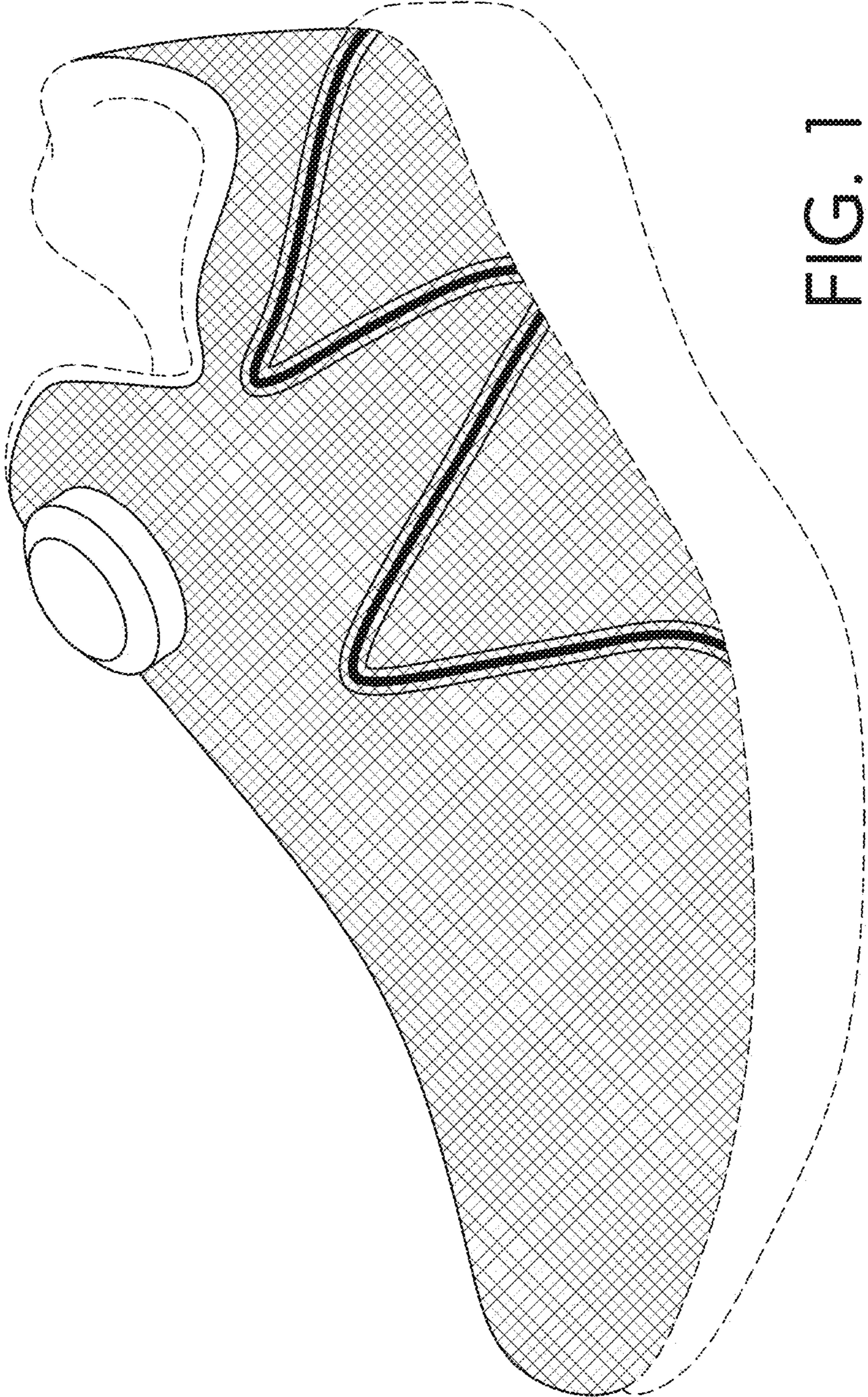

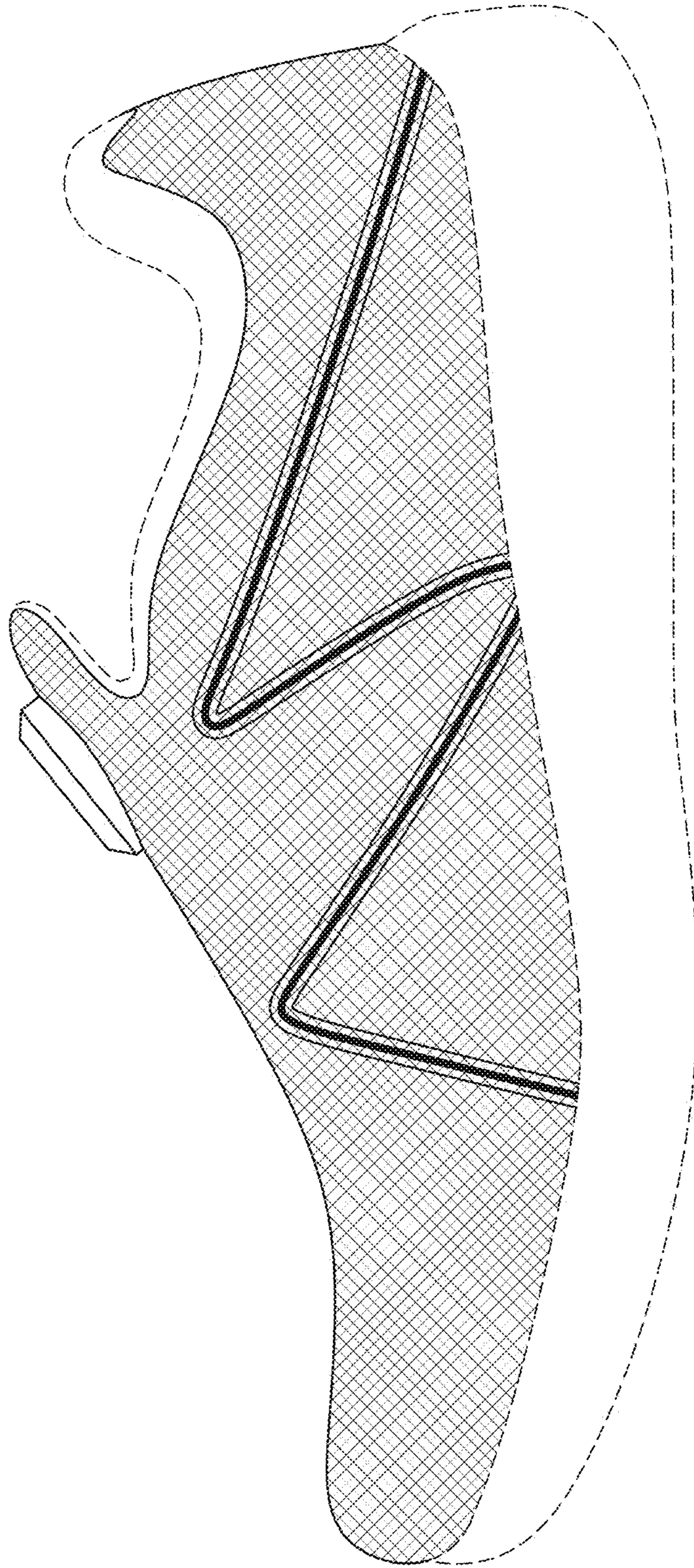

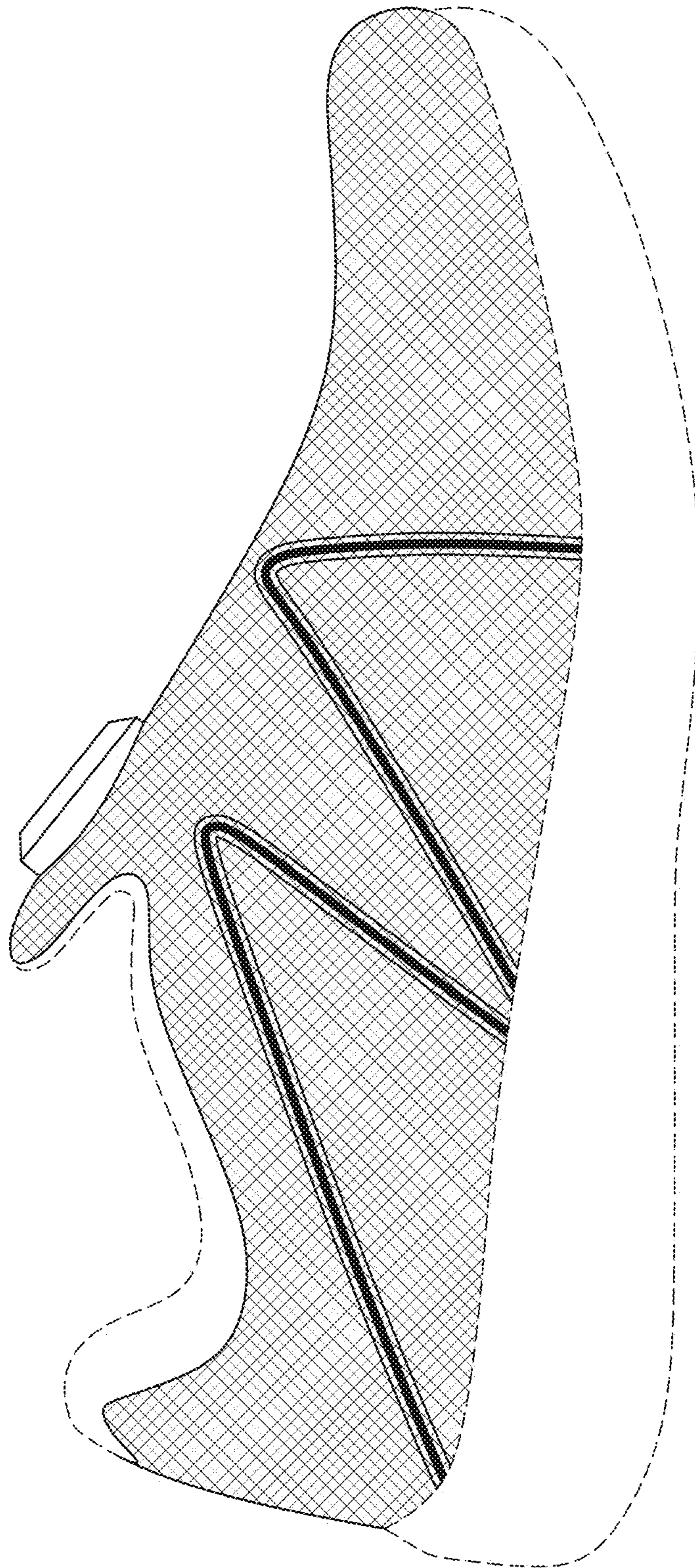

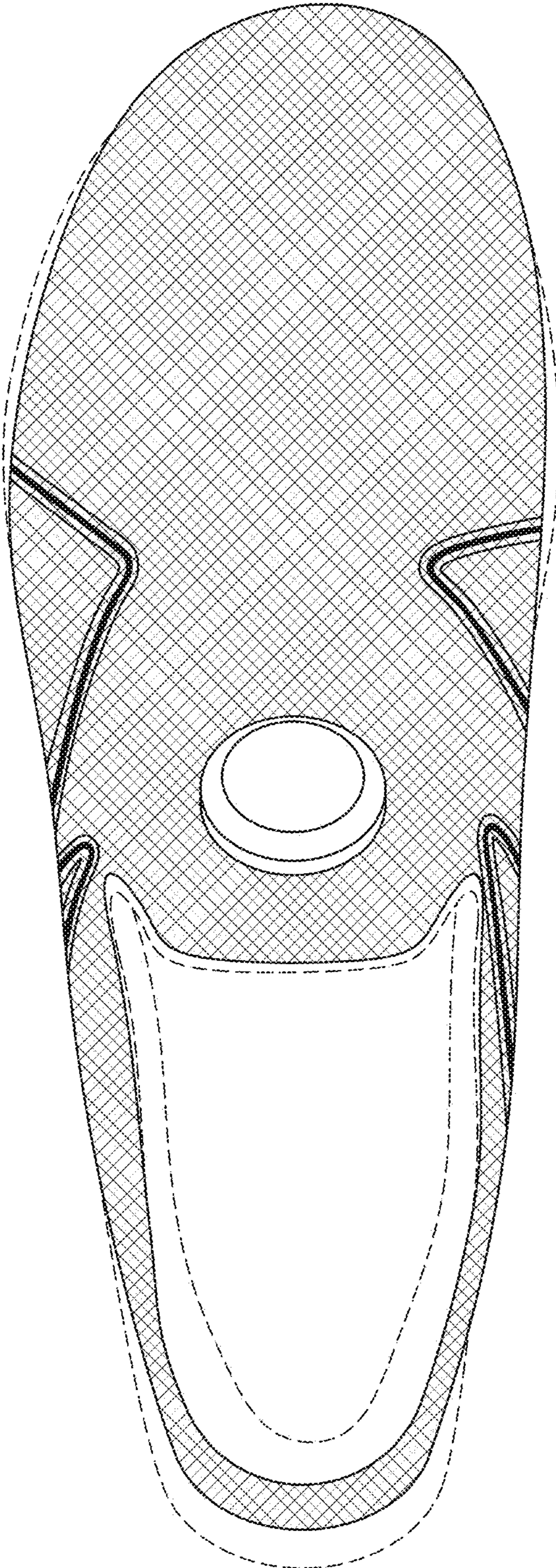

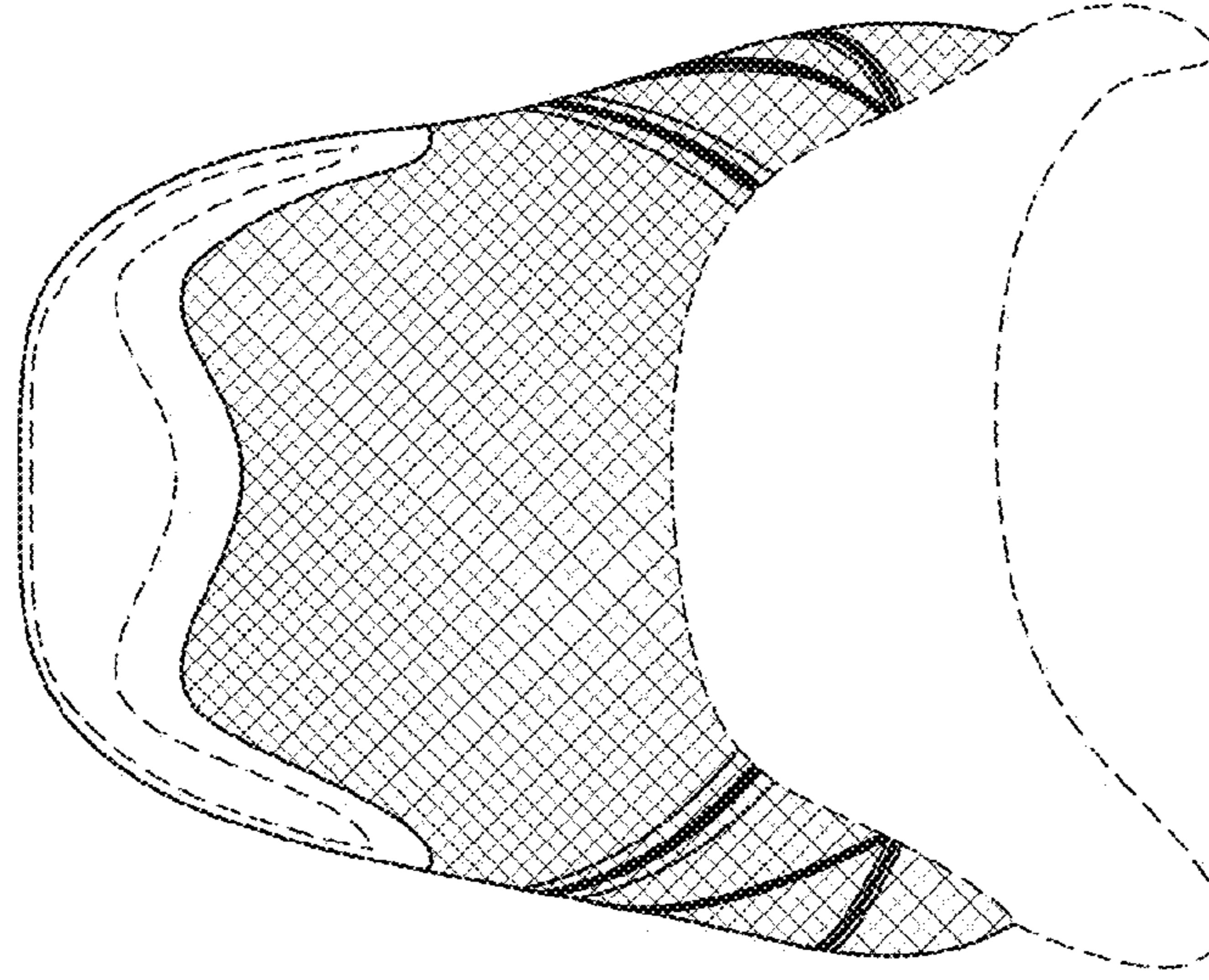

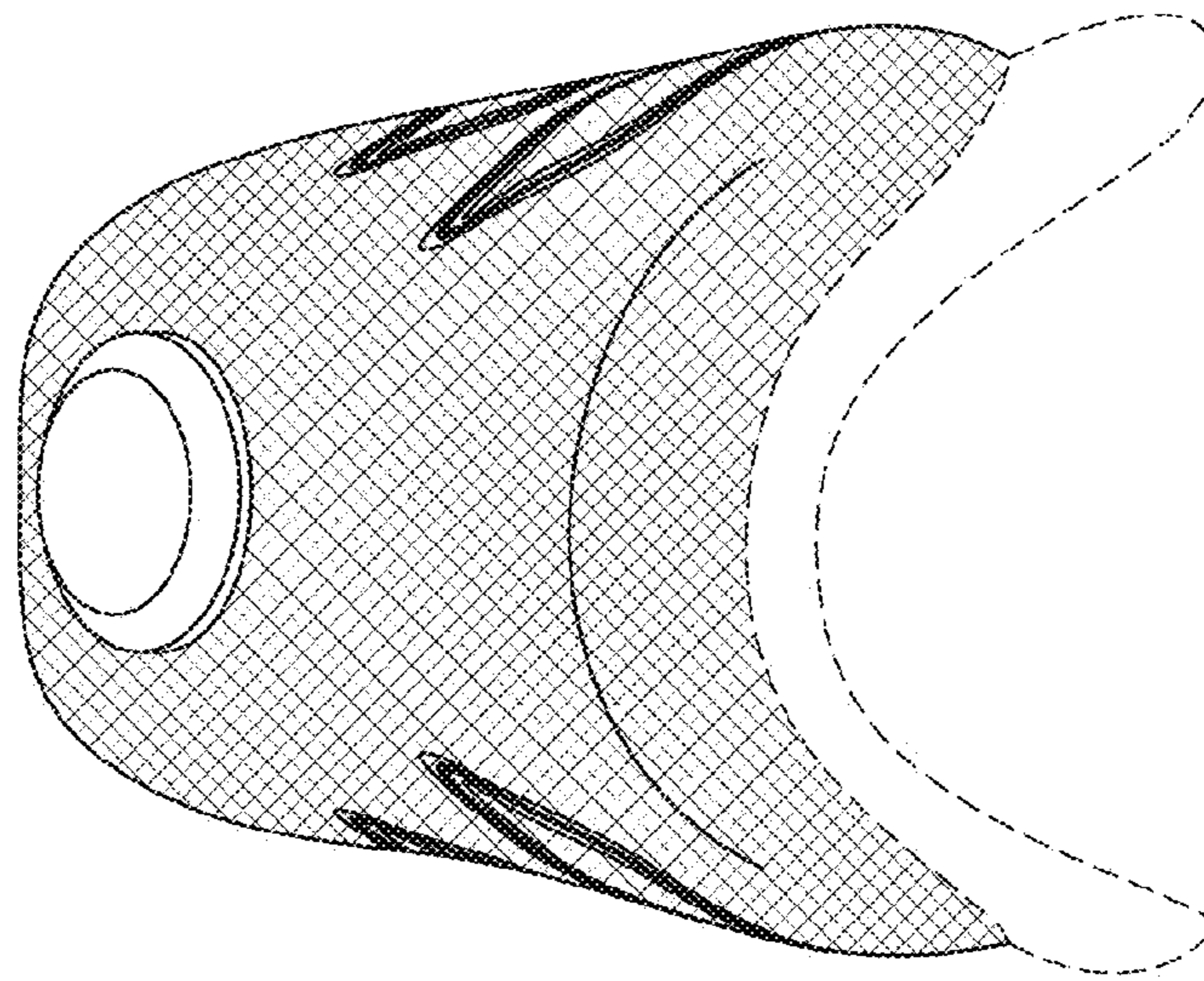
