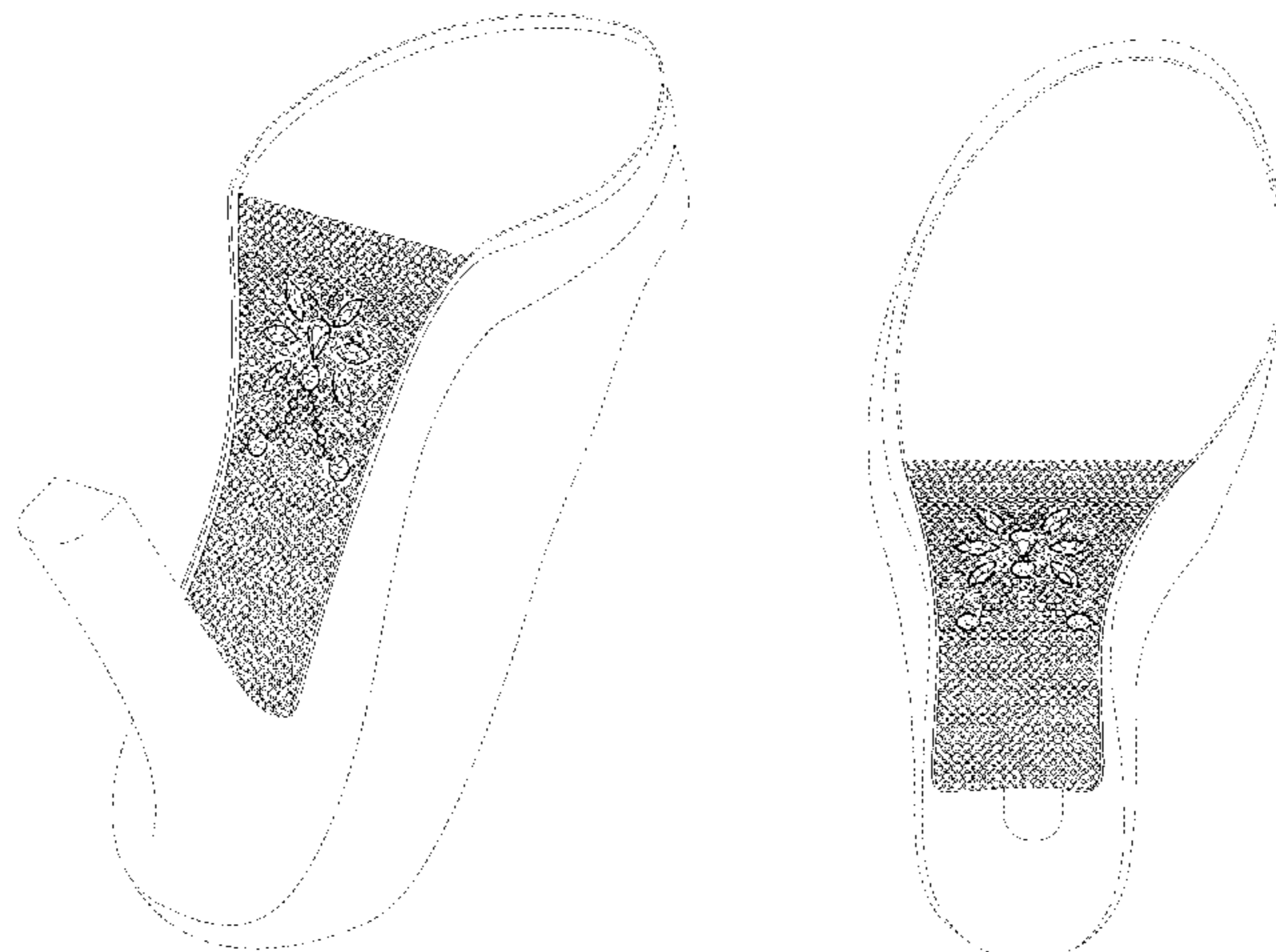
(57) **CLAIM**

The ornamental design for a shoe with decorative sole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of the shoe with decorative sole;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a front elevational view thereof; and,
 FIG. 7 is a rear elevational view thereof.

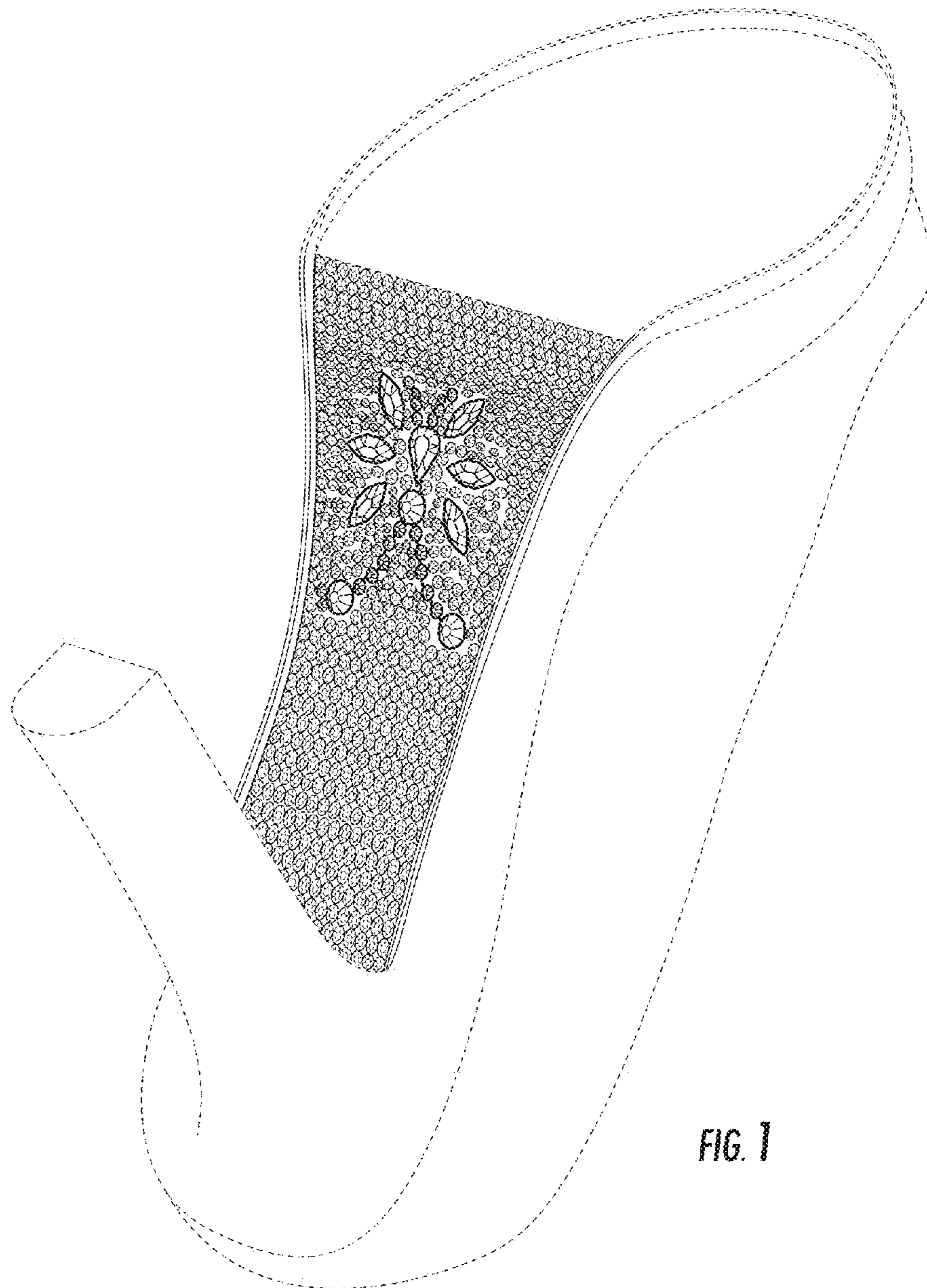

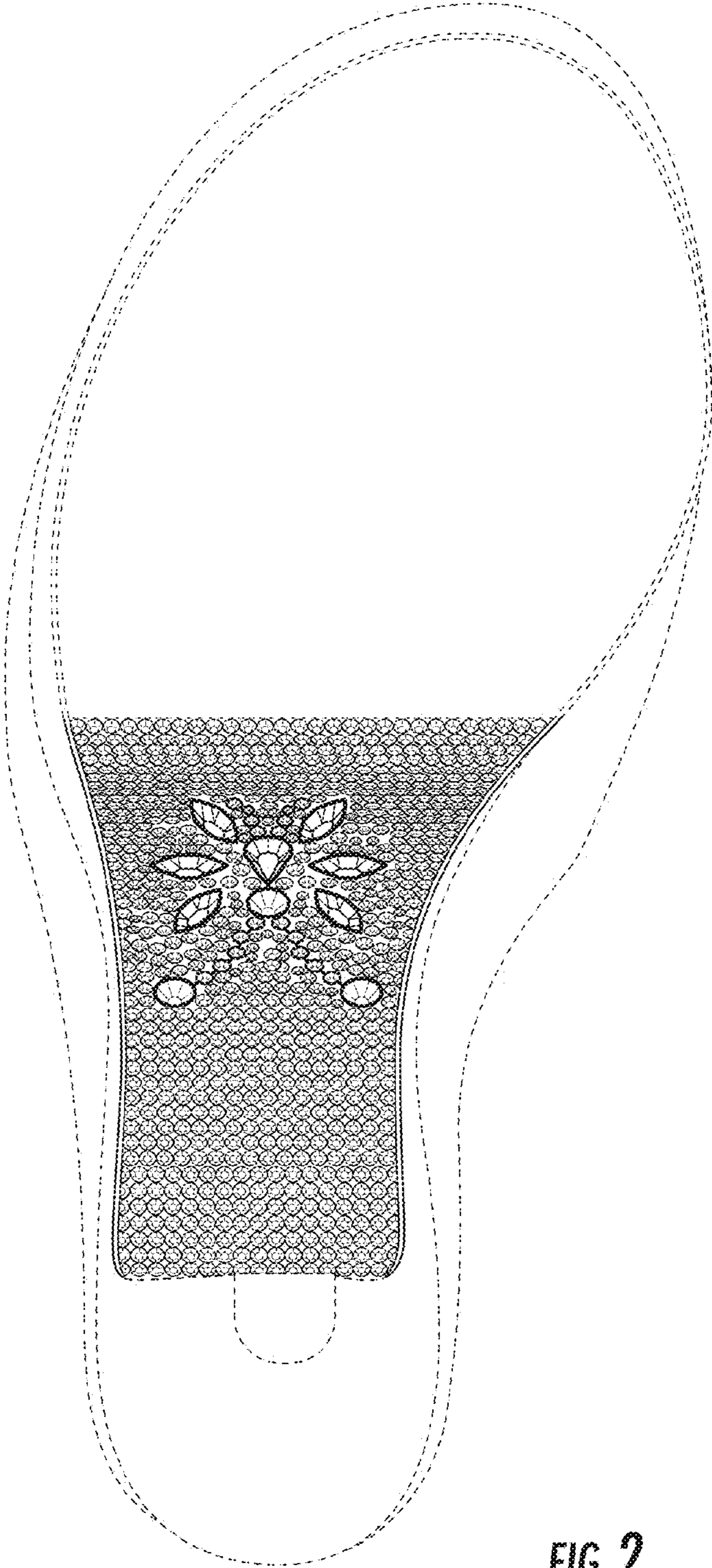

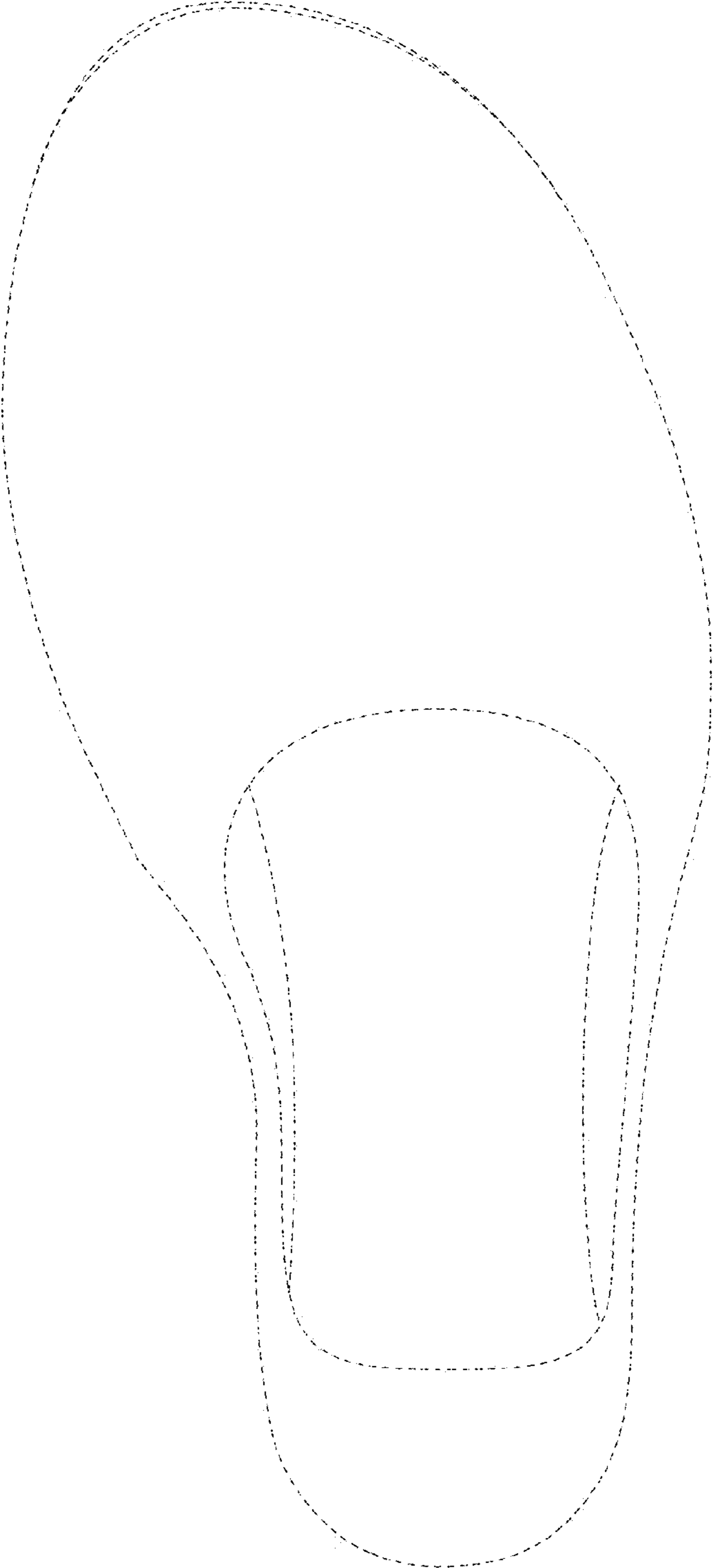

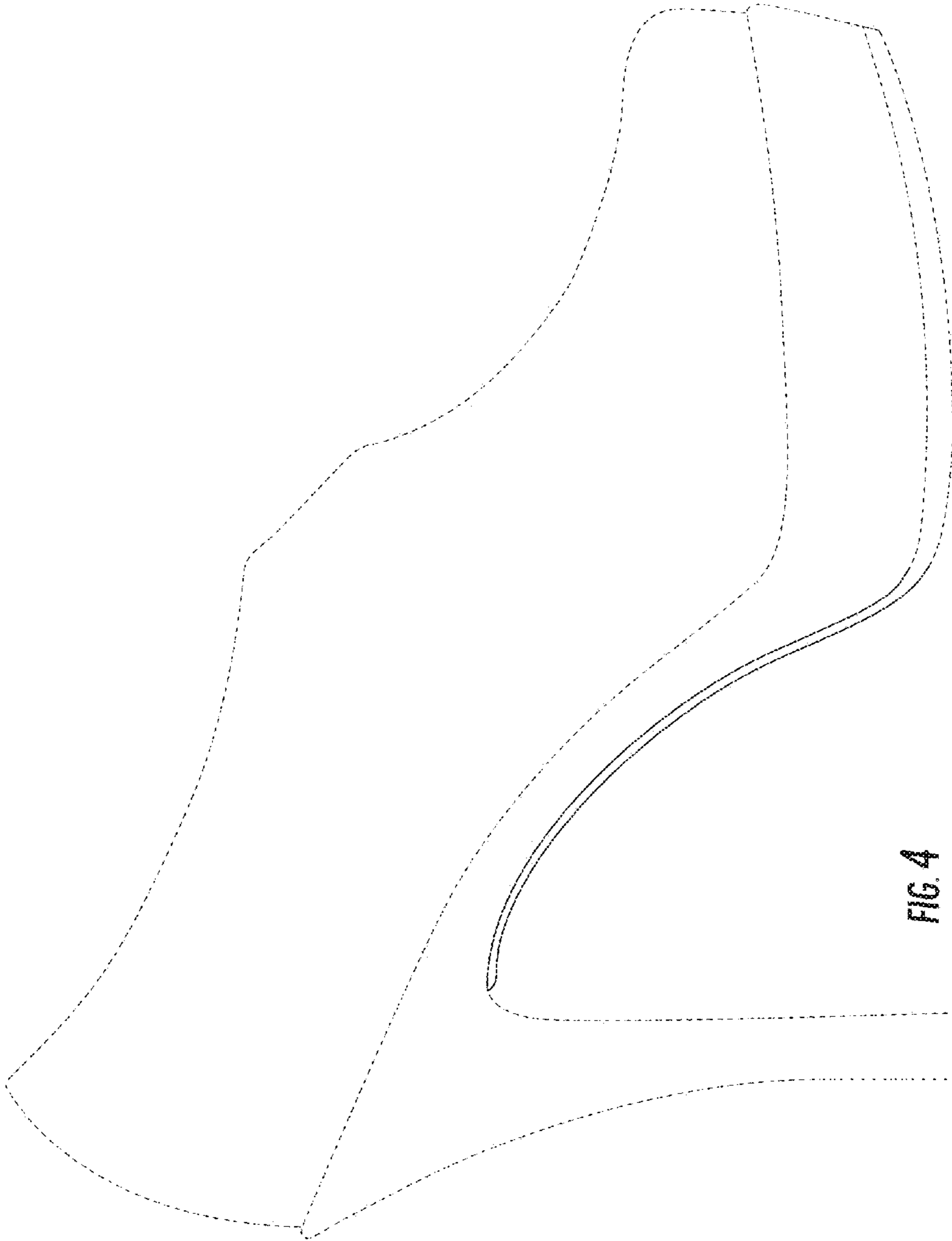

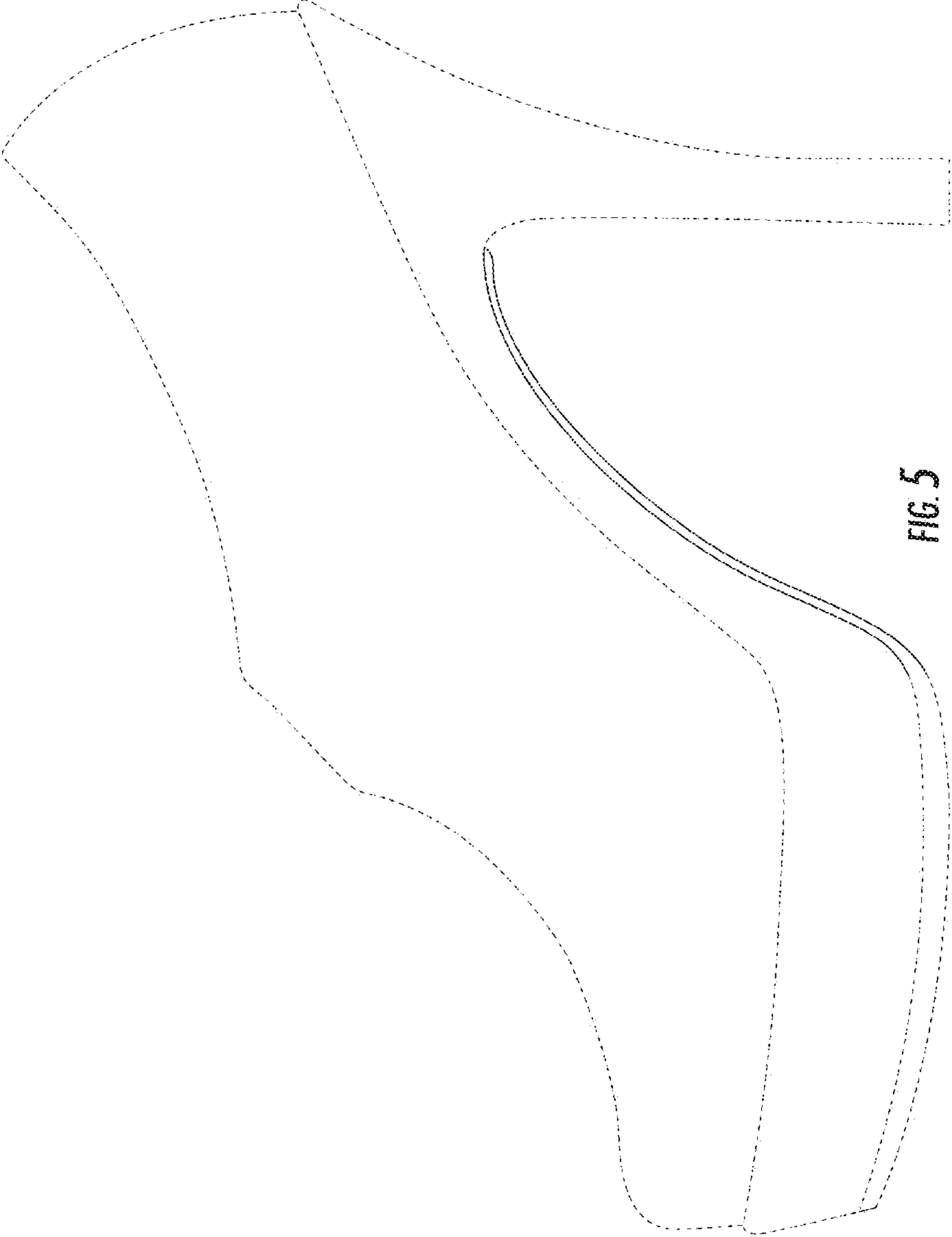

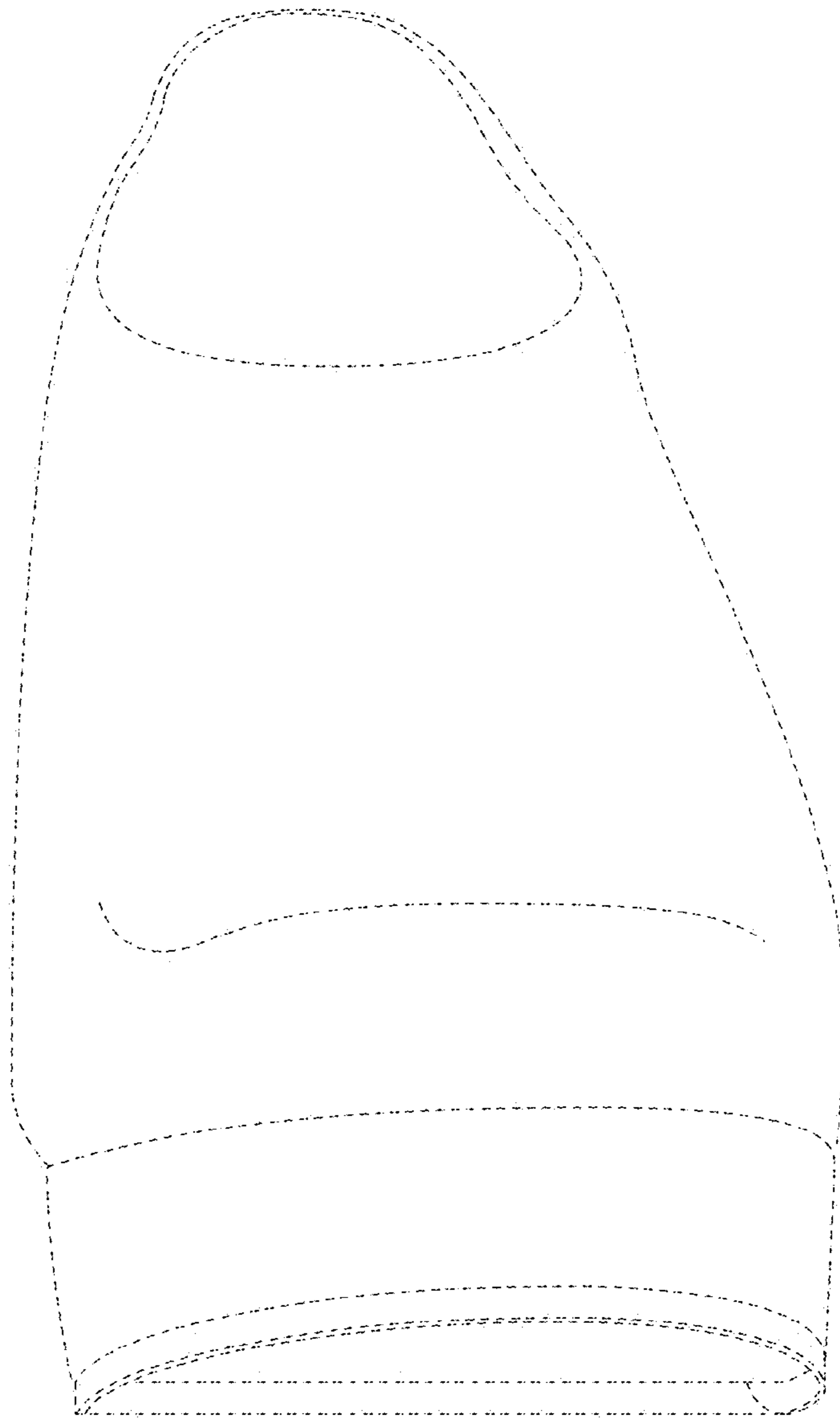

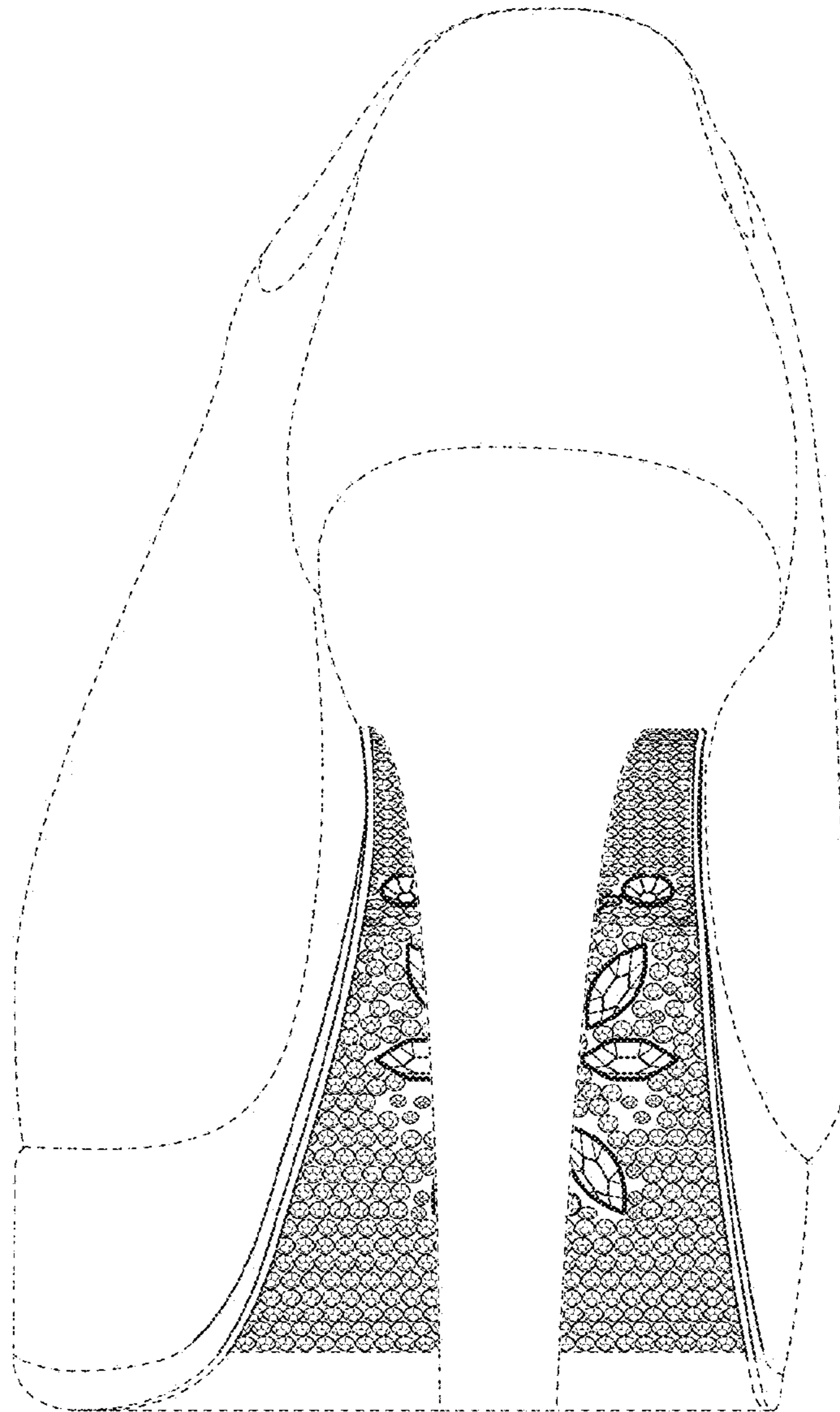
