(57) **CLAIM**

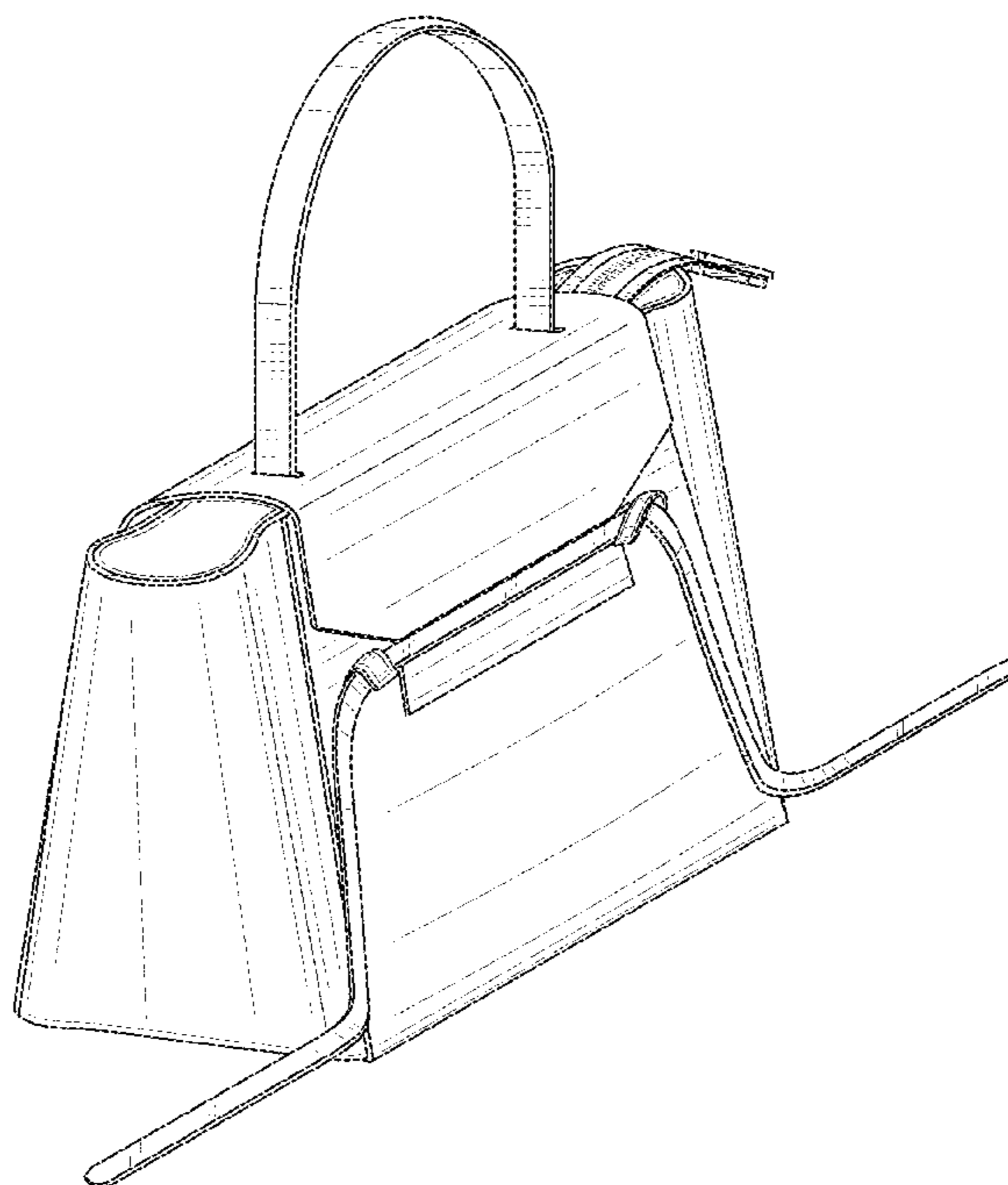
The ornamented design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handbag, showing my new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a right side view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom view thereof; and,
 FIG. 8 is a top plan view in an alternate configuration, where the bag is open.

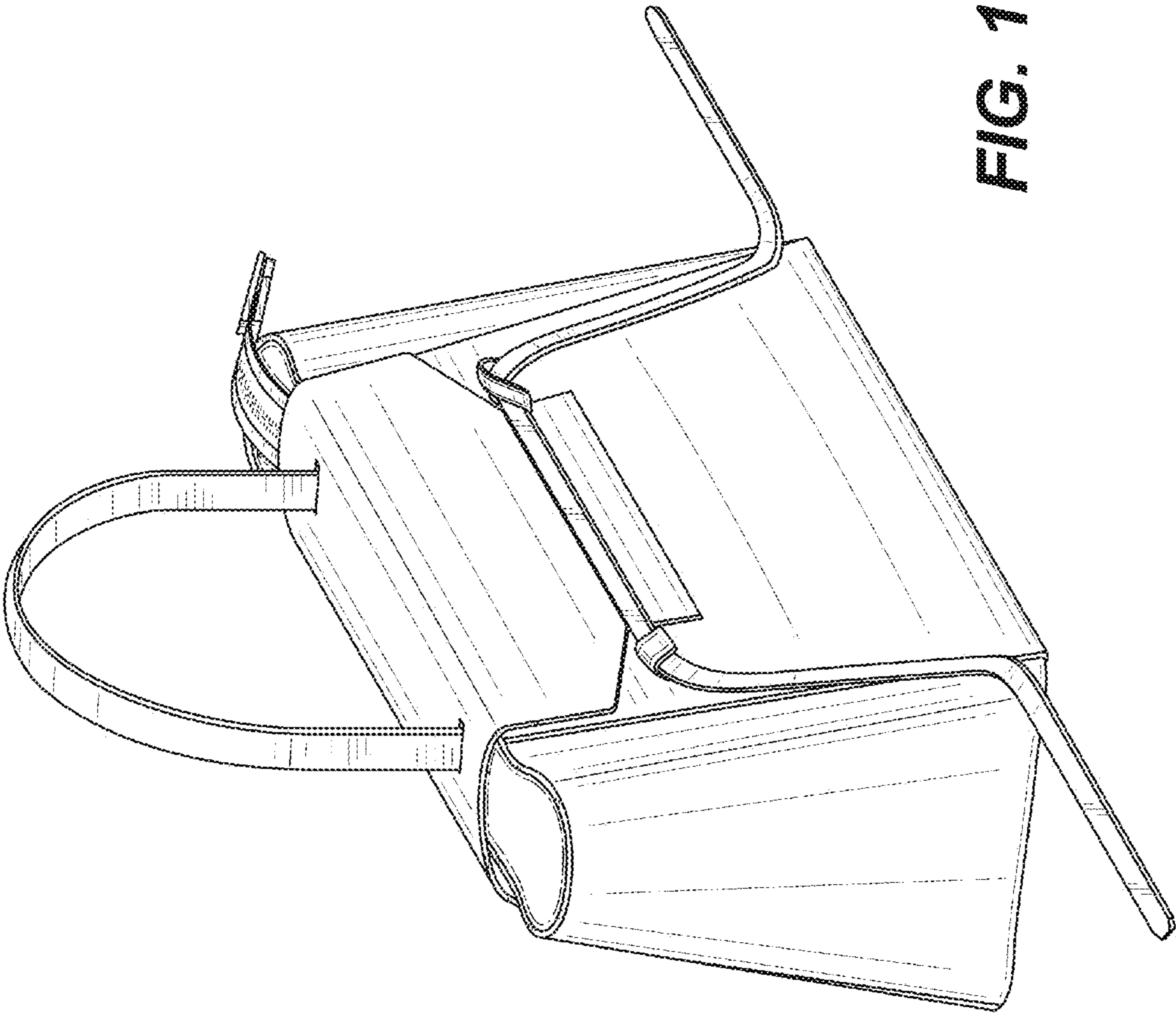

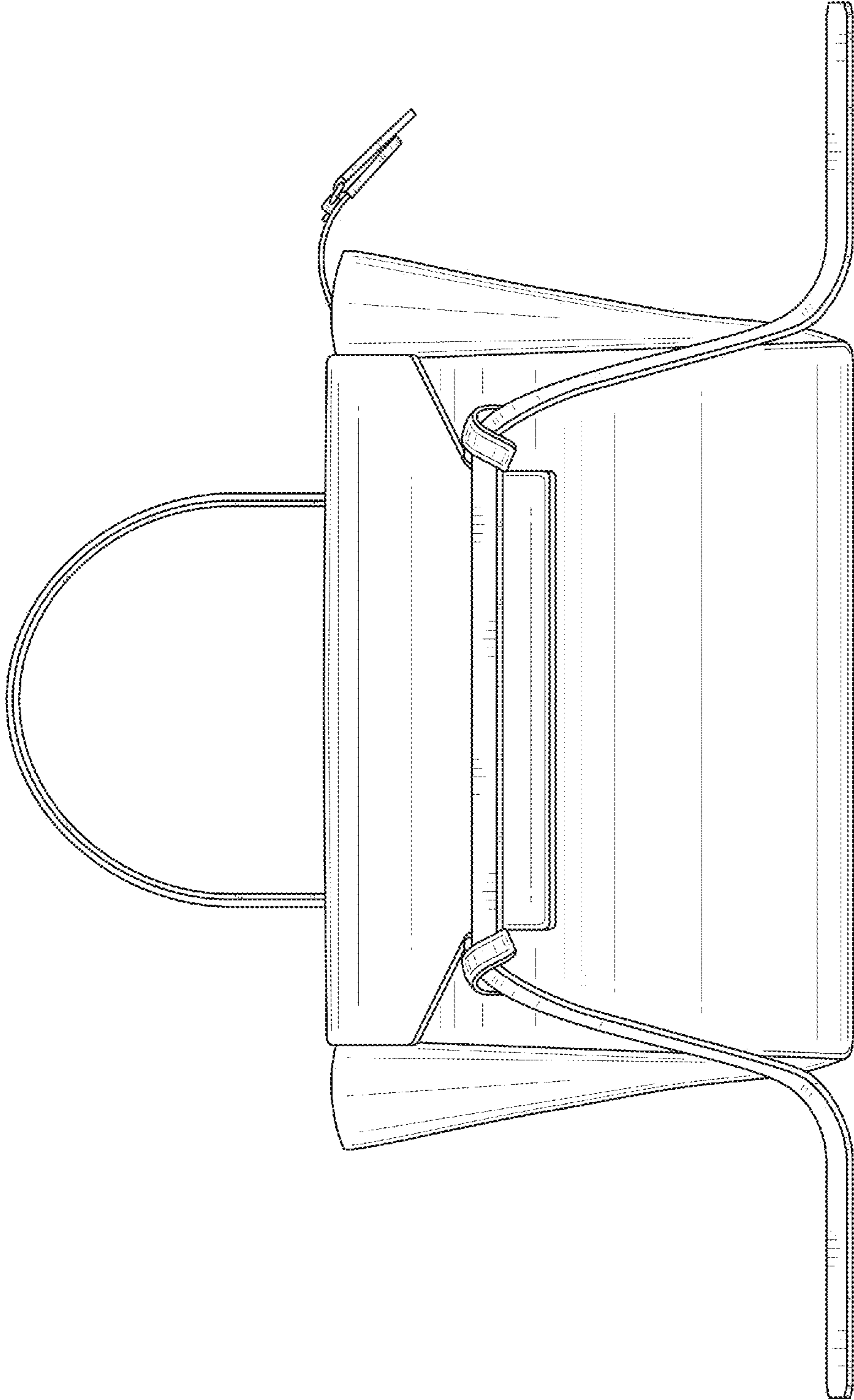

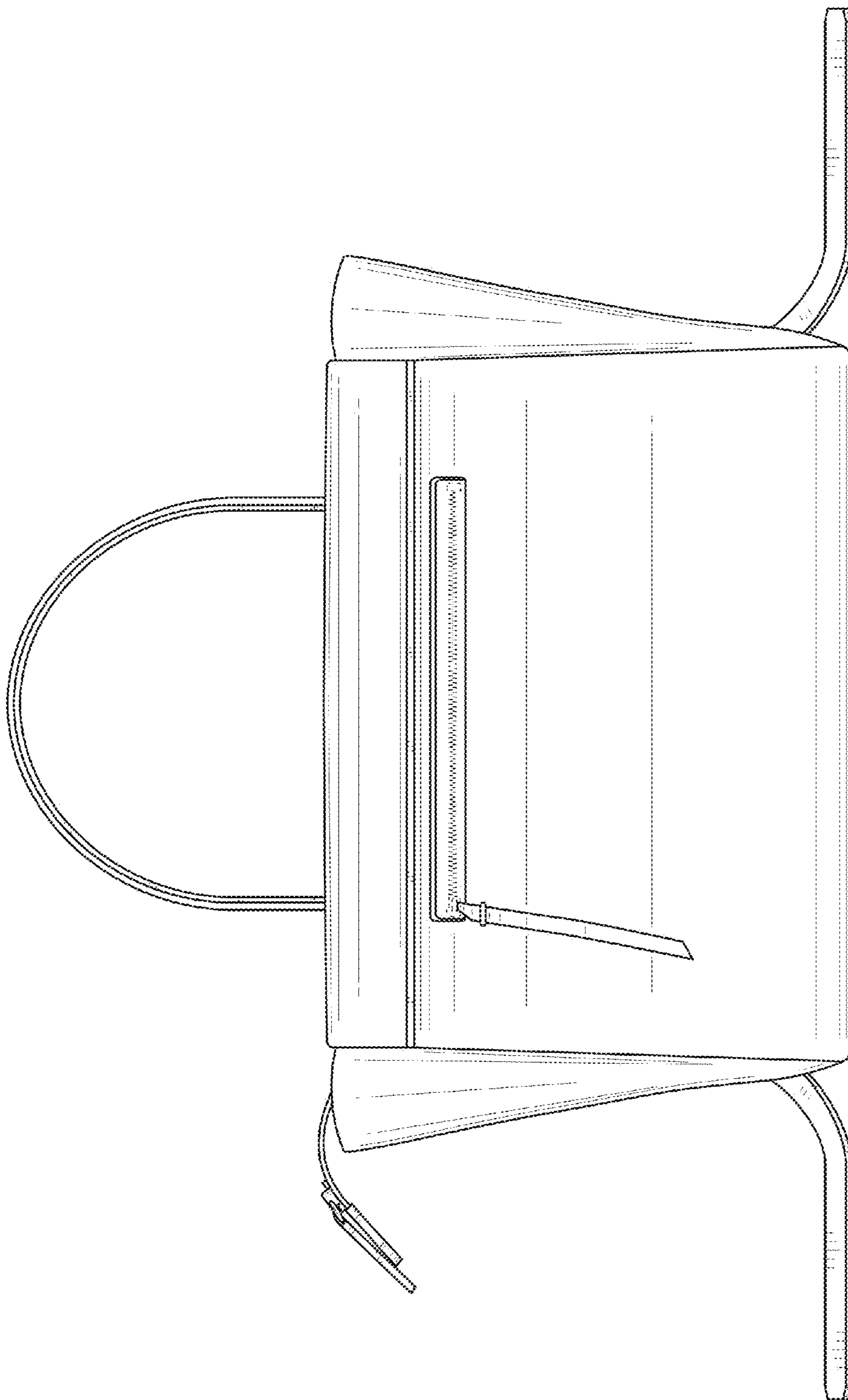

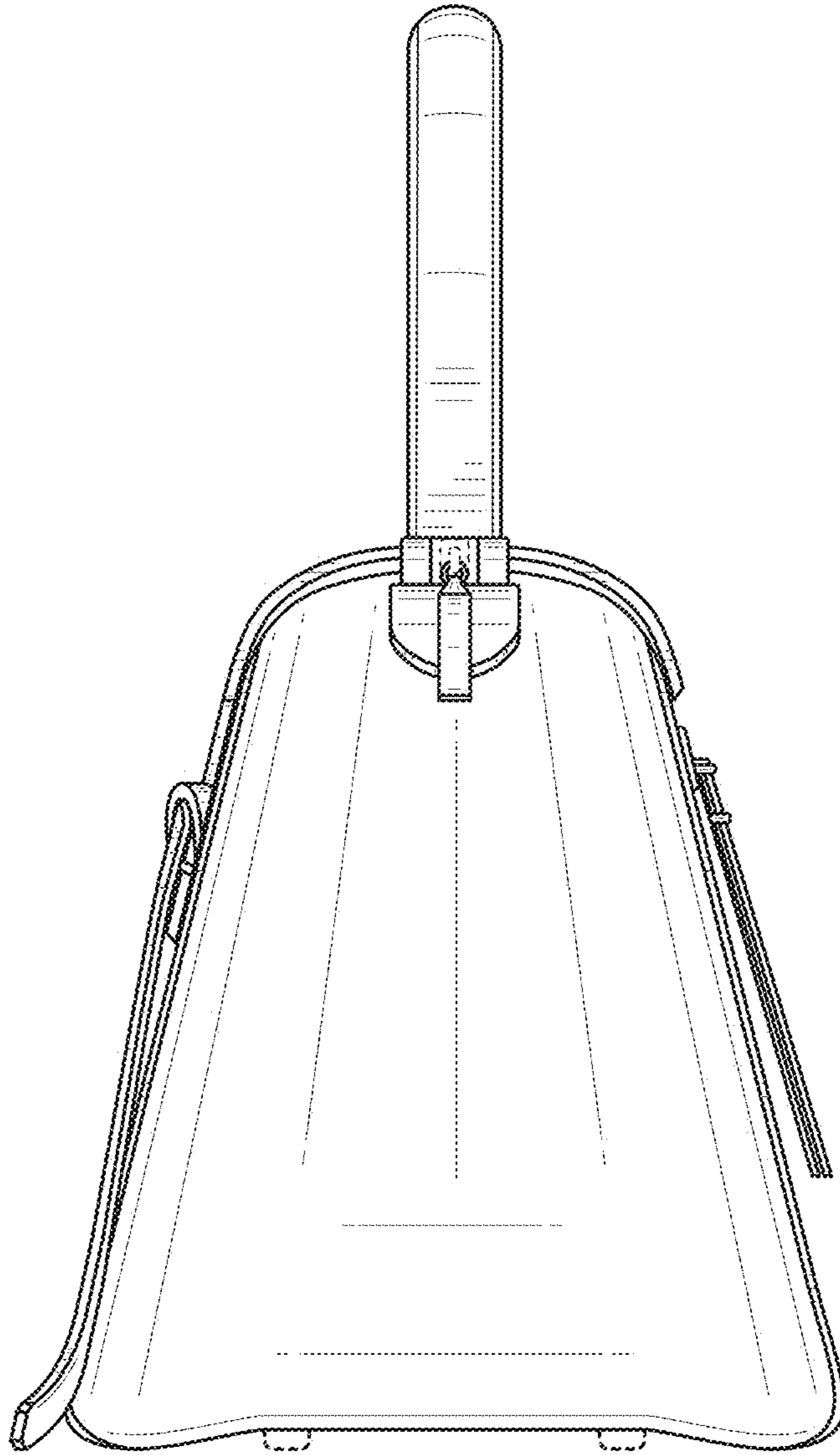

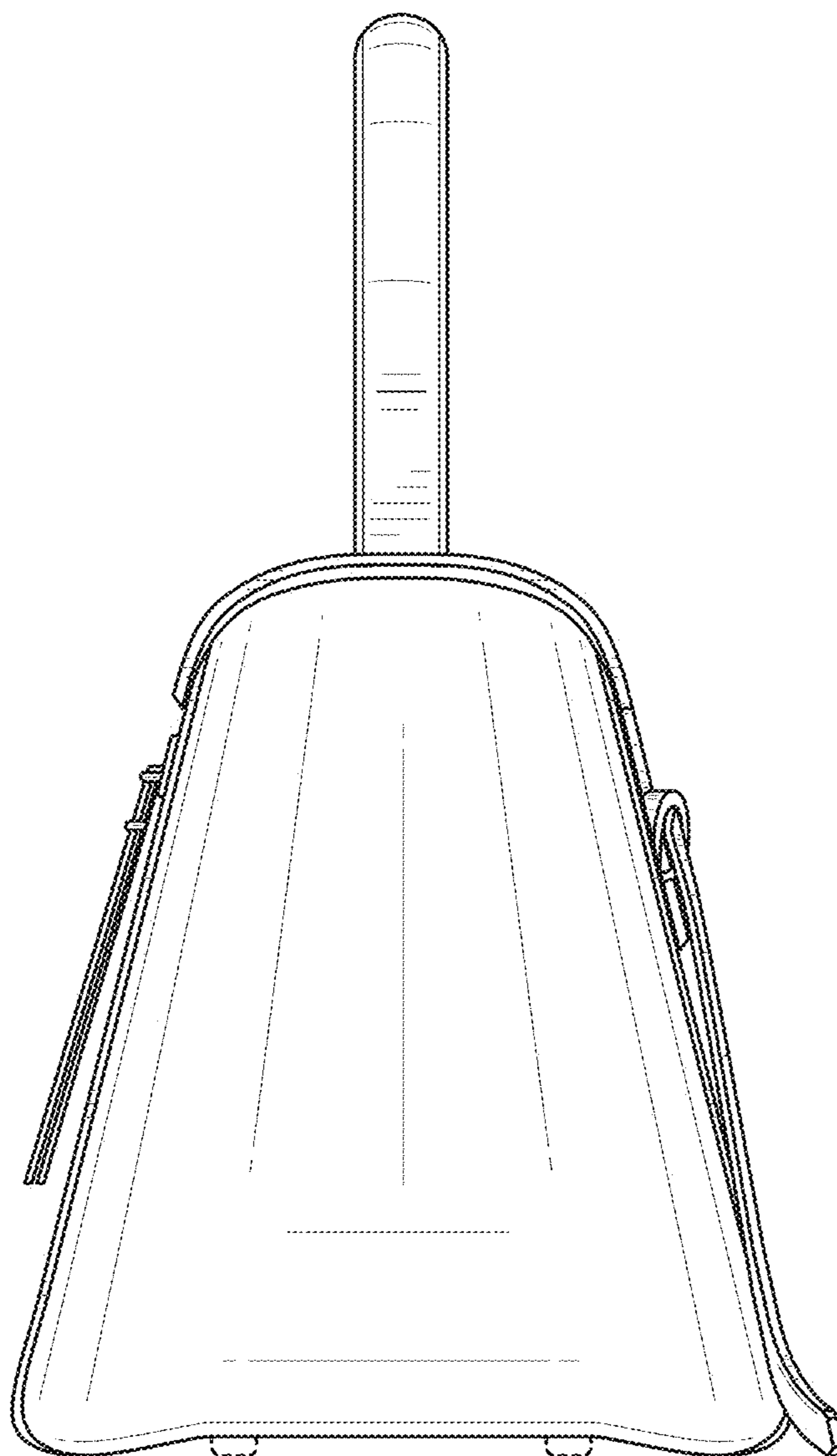

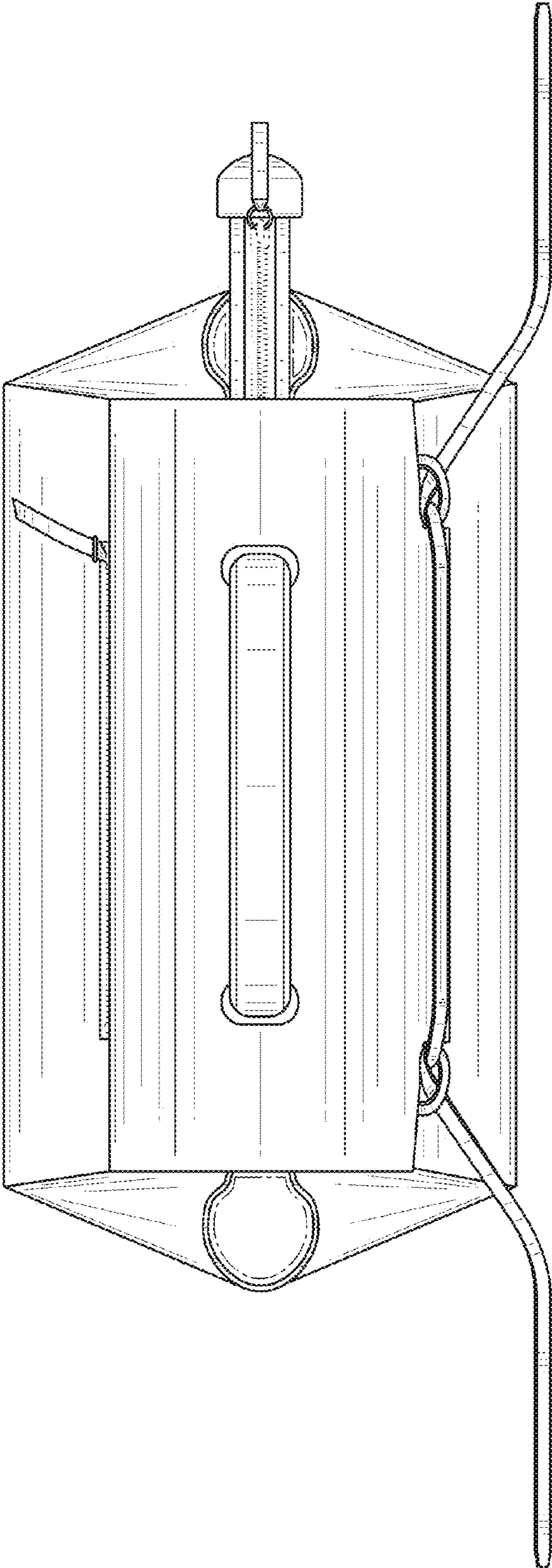

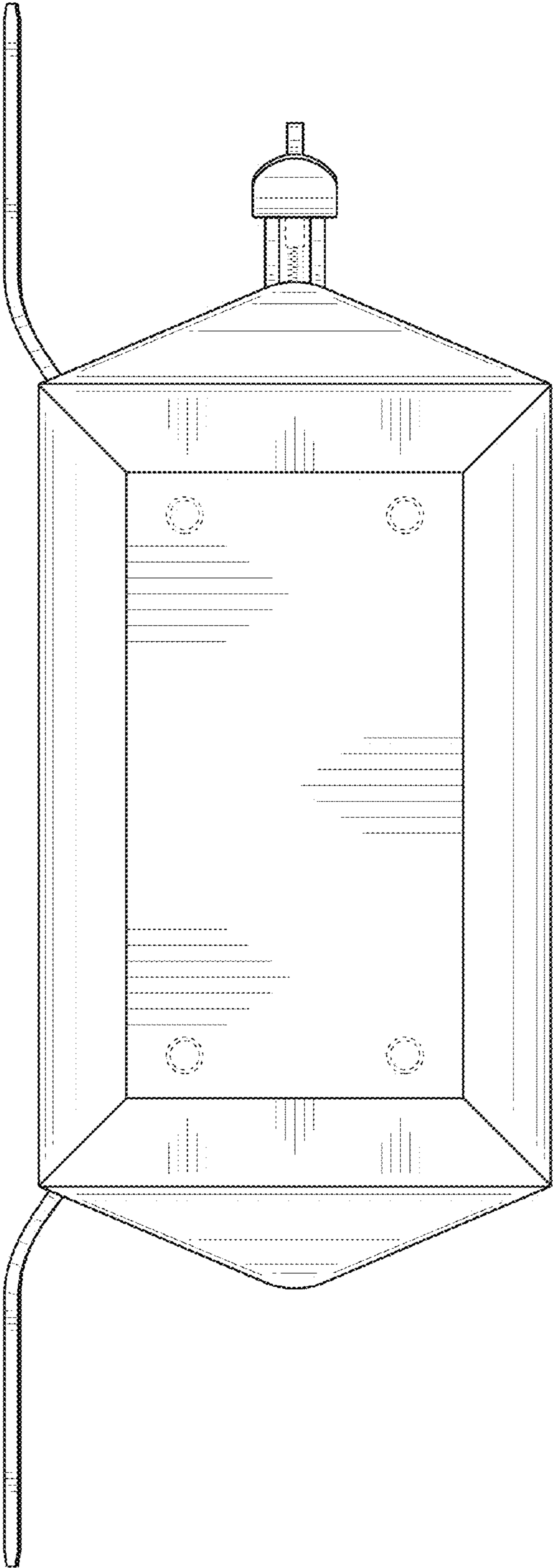

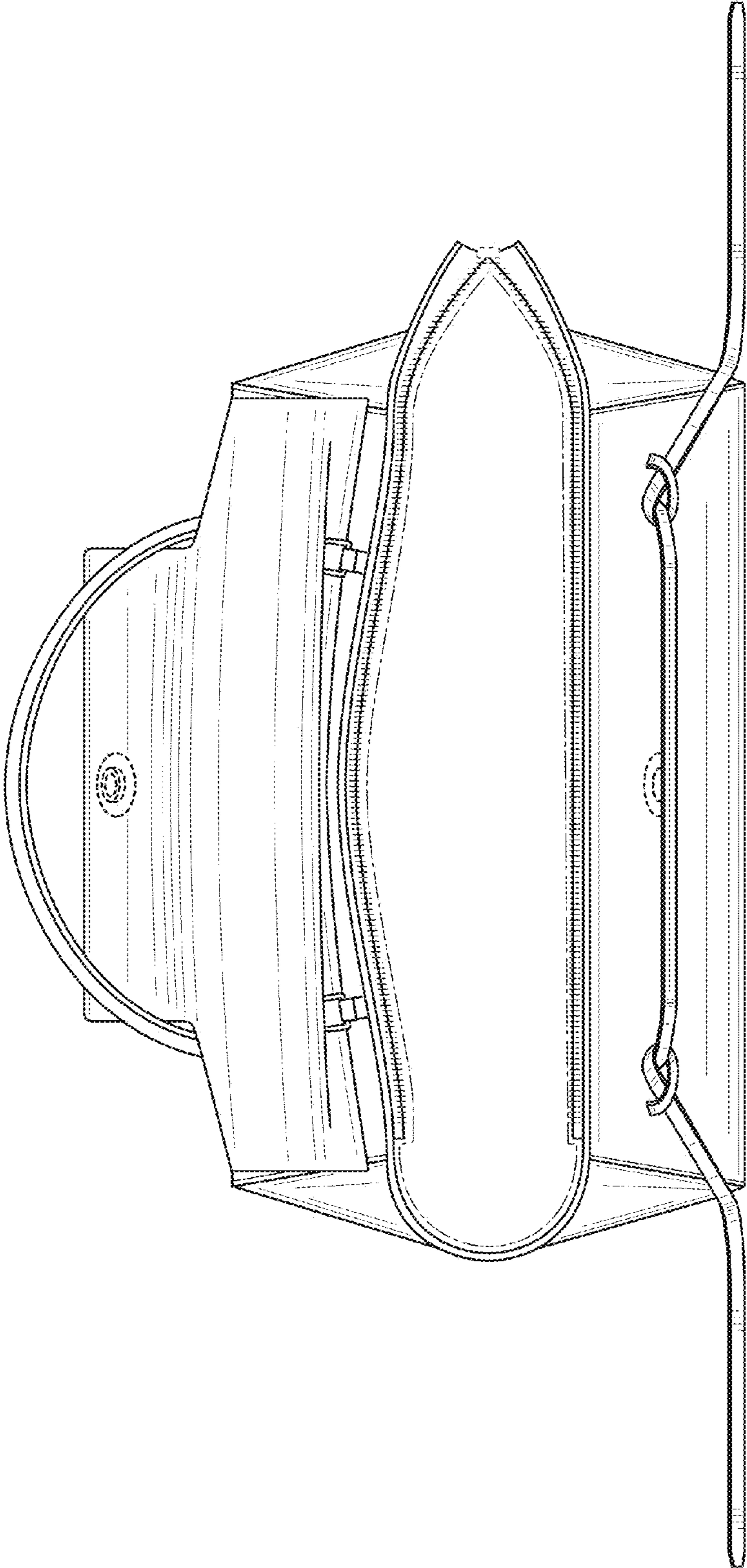
