(57) **CLAIM**  
The ornamental design for the handbag, as shown and described.

**DESCRIPTION**

1. Handbag  
FIG. 1.1 is a front view of a handbag according to the design;  
FIG. 1.2 is a back view of the handbag;  
FIG. 1.3 is a left side view of the handbag, the right side view of the handbag is omitted because it is a mirror image of the left side view;  
FIG. 1.4 is a bottom view of the handbag;  
FIG. 1.5 is a top view of the handbag;  
FIG. 1.6 is a front view of the handbag with the zipped closure opened and an inner purse partially extracted;  
FIG. 1.7 is a front view of the handbag with the inner purse of FIG. 1.6 totally extracted.

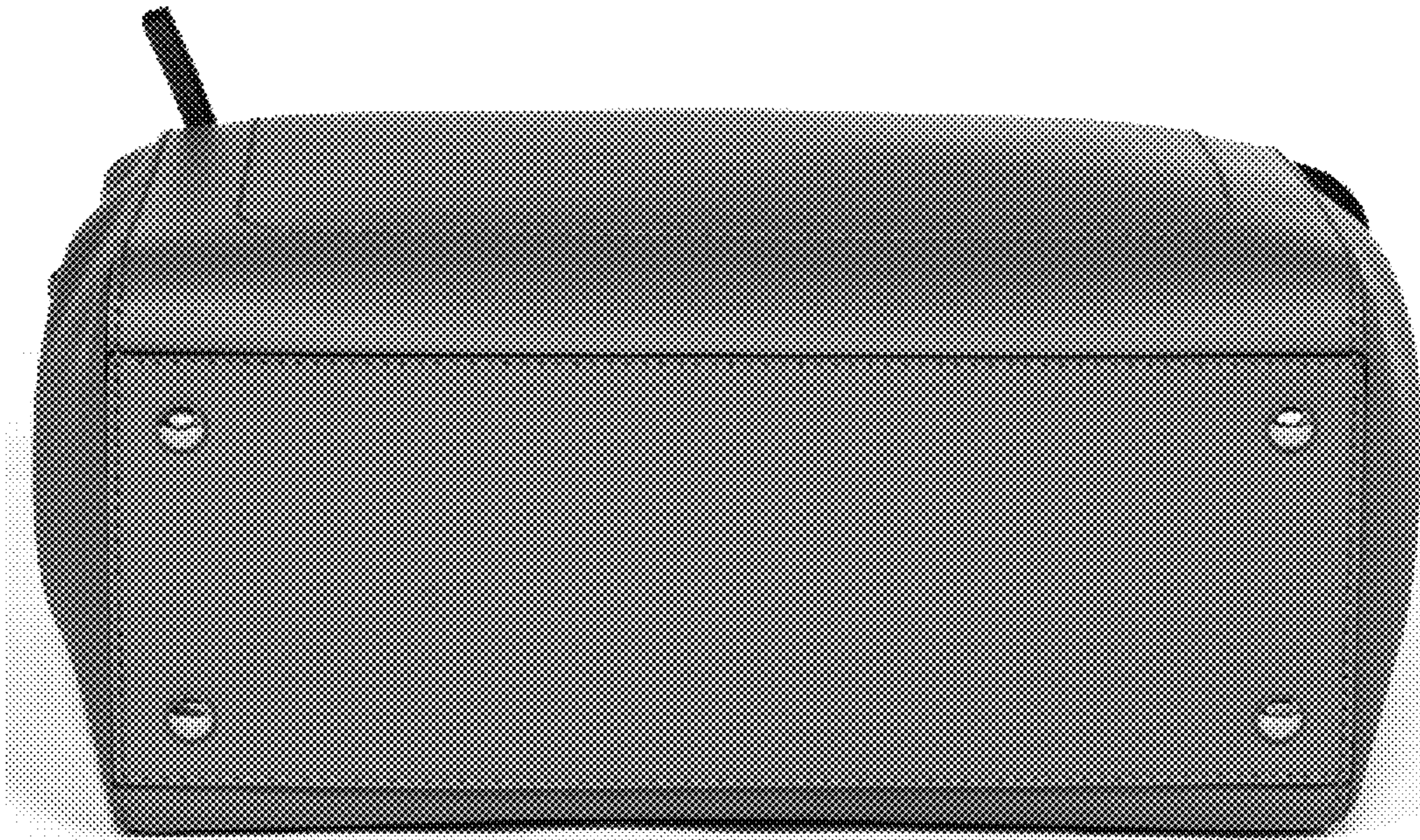
