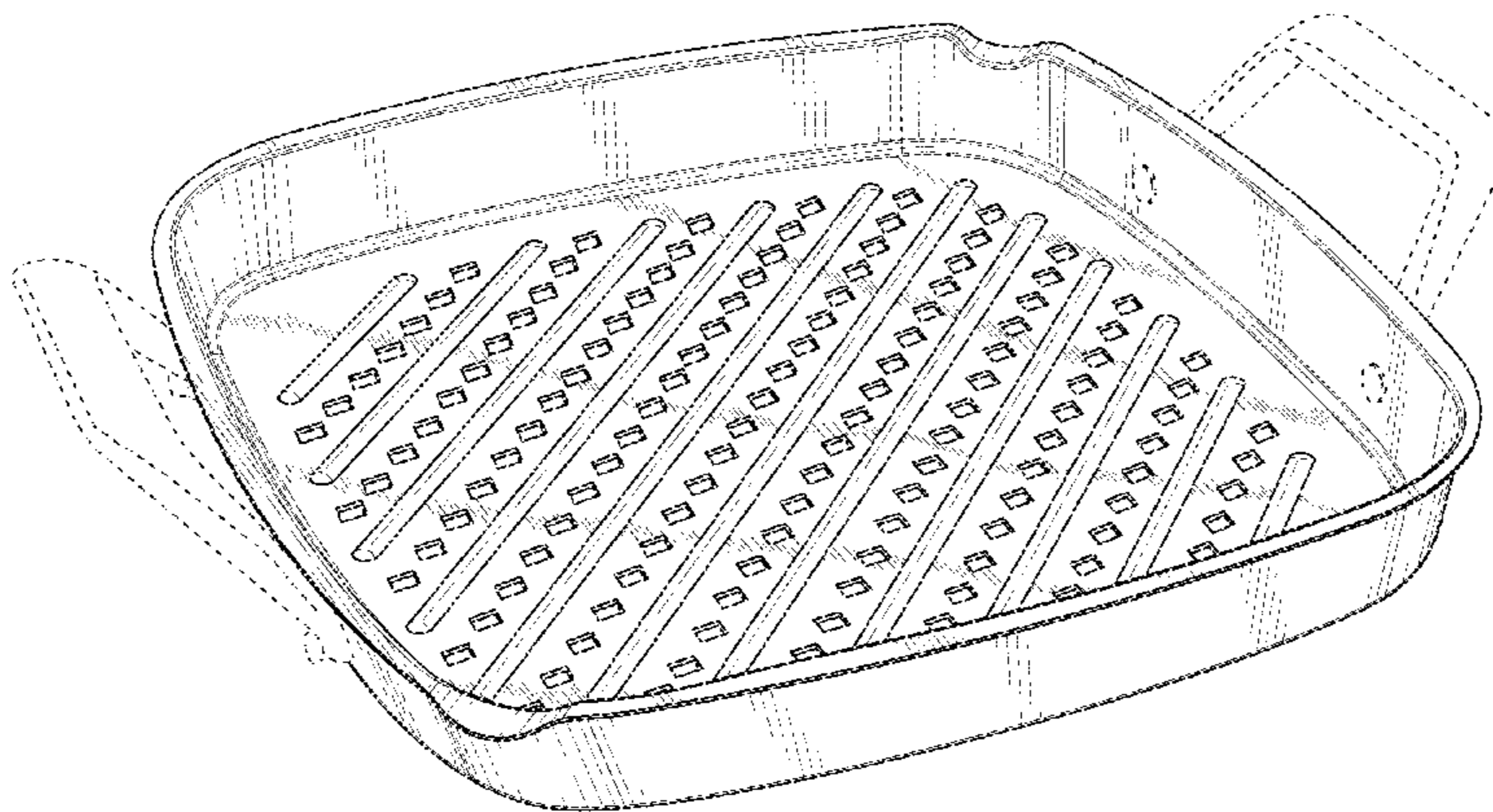
(57) **CLAIM**
The ornamental design for a grill tray, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a grill tray in accordance with the present design;
FIG. 2 is a front side elevational view thereof, the rear side elevational view being a mirror image thereof;
FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines shown in the drawings illustrate portions of the grill tray that form no part of the claimed design.

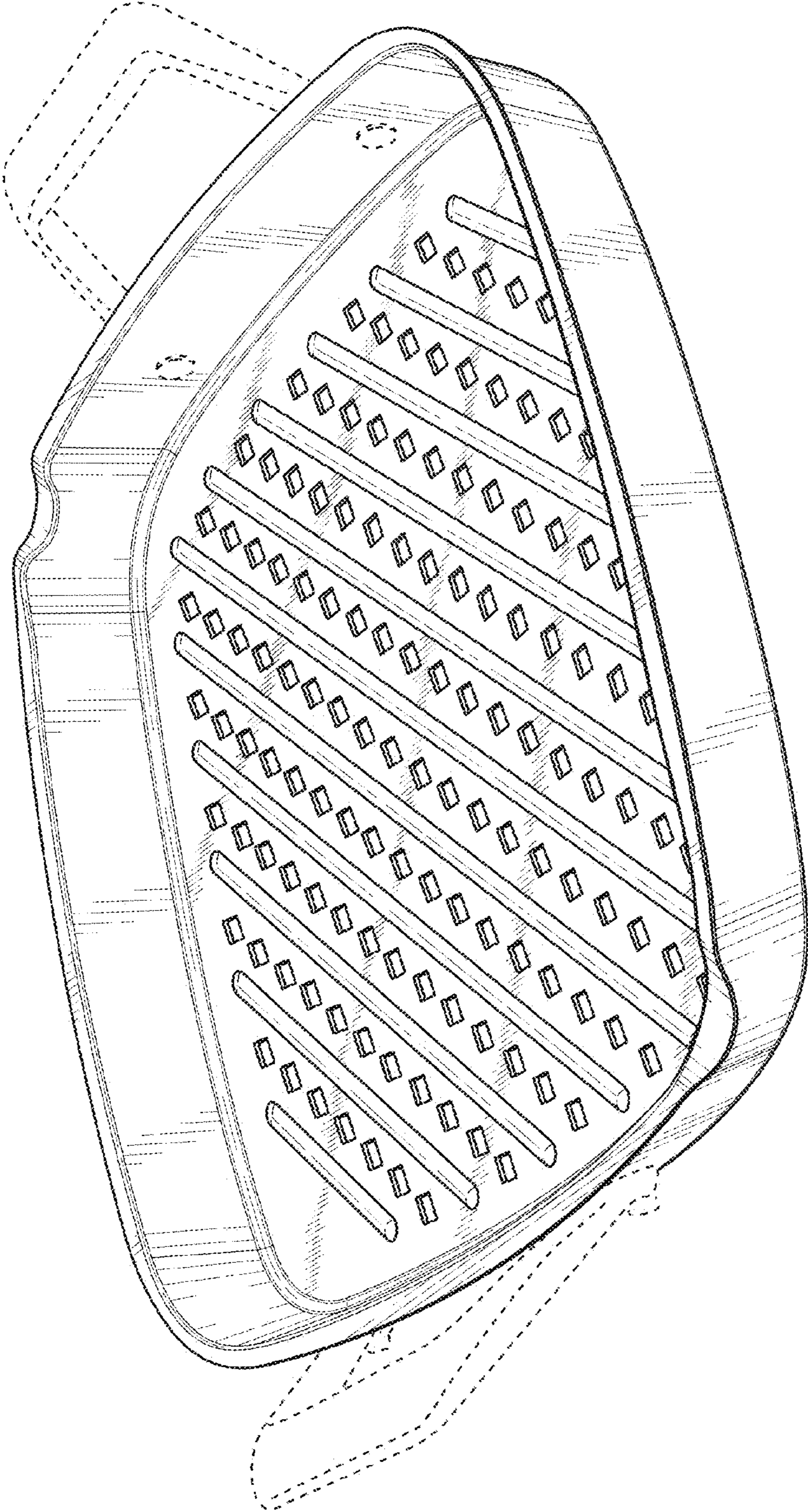

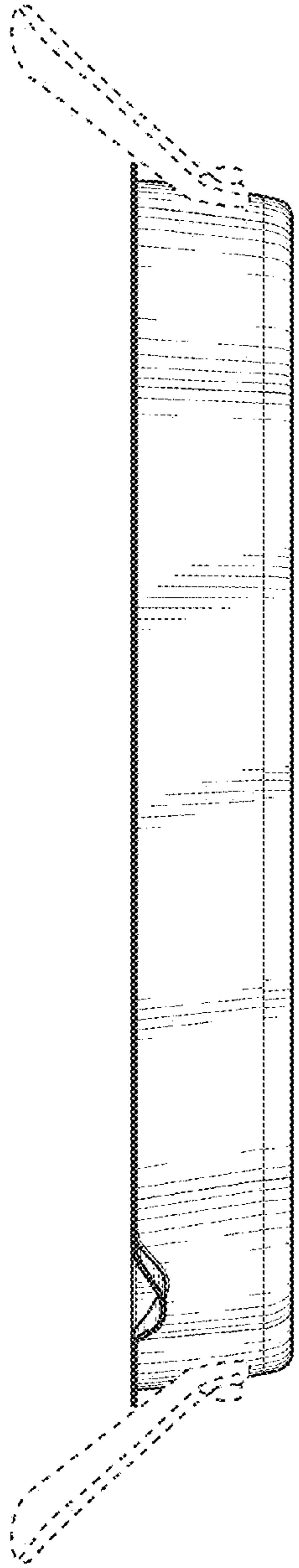

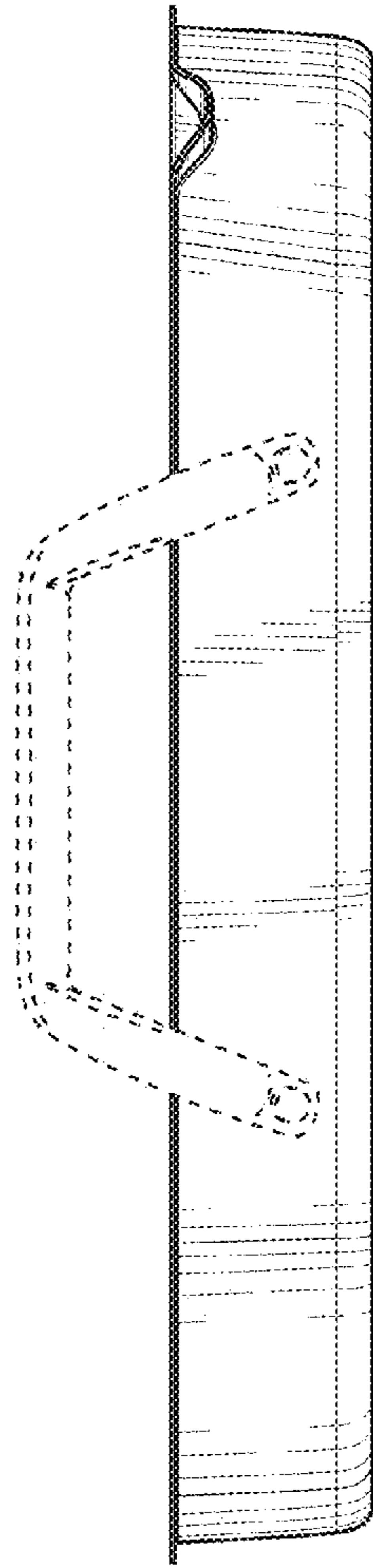

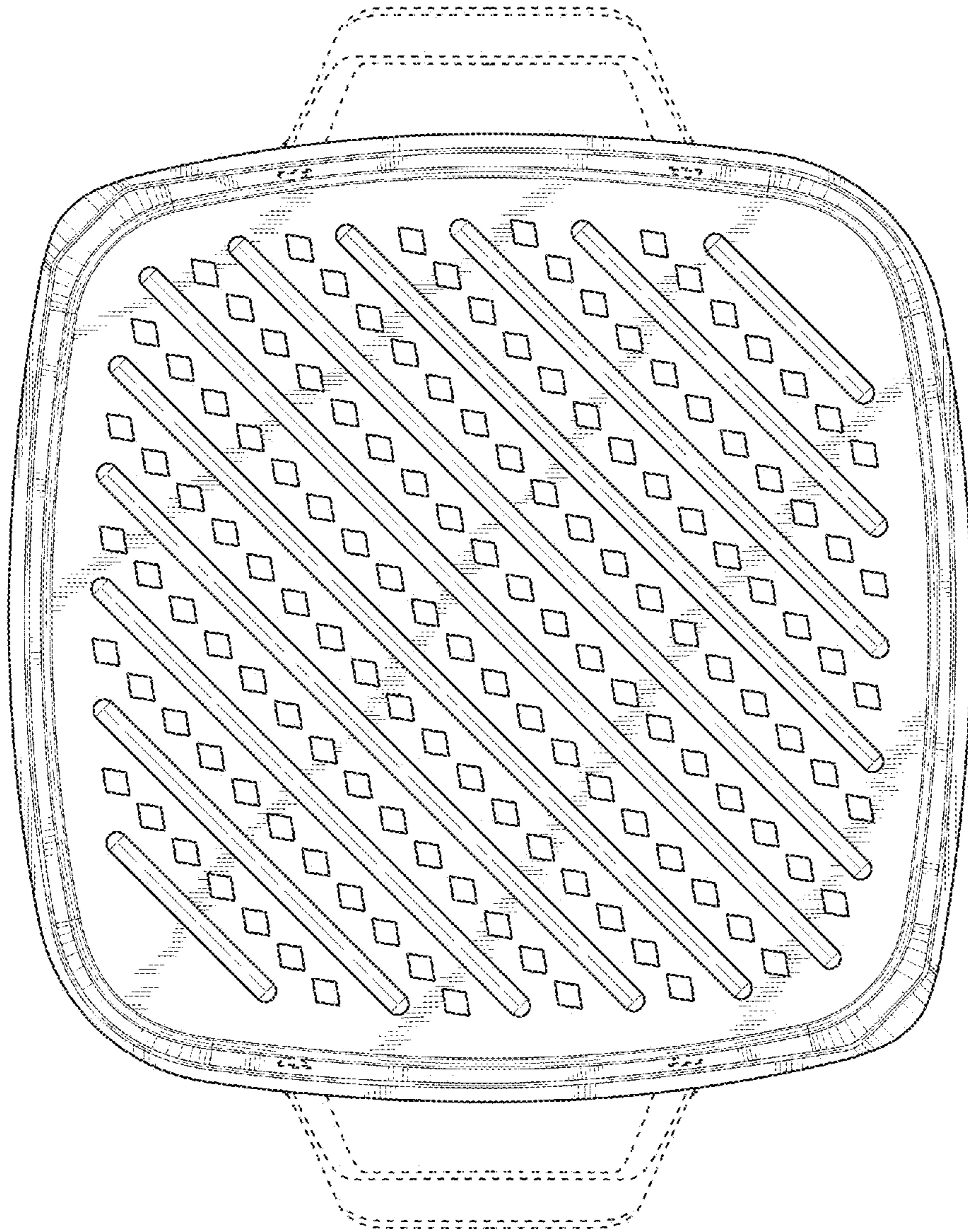

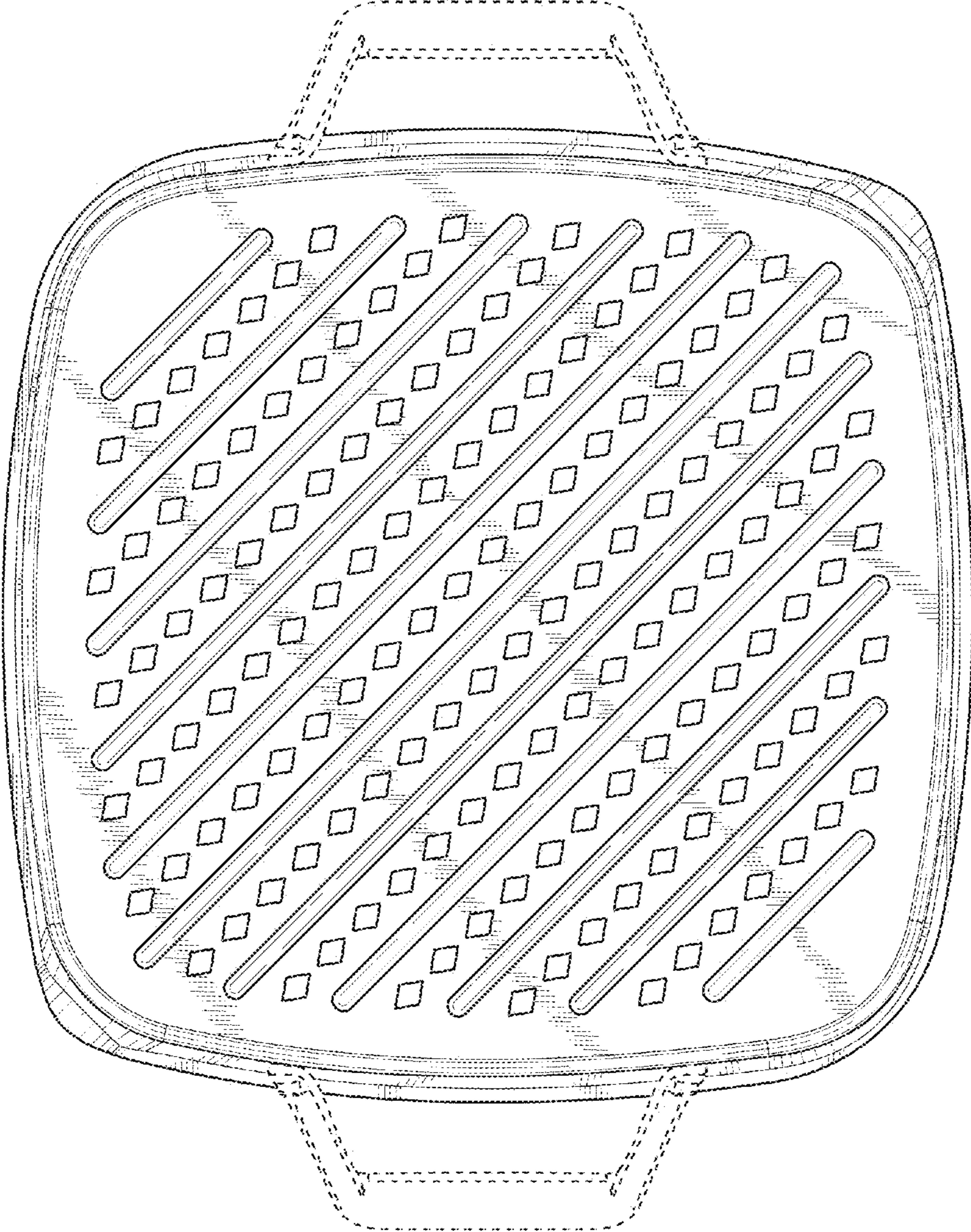
