(57) **CLAIM**

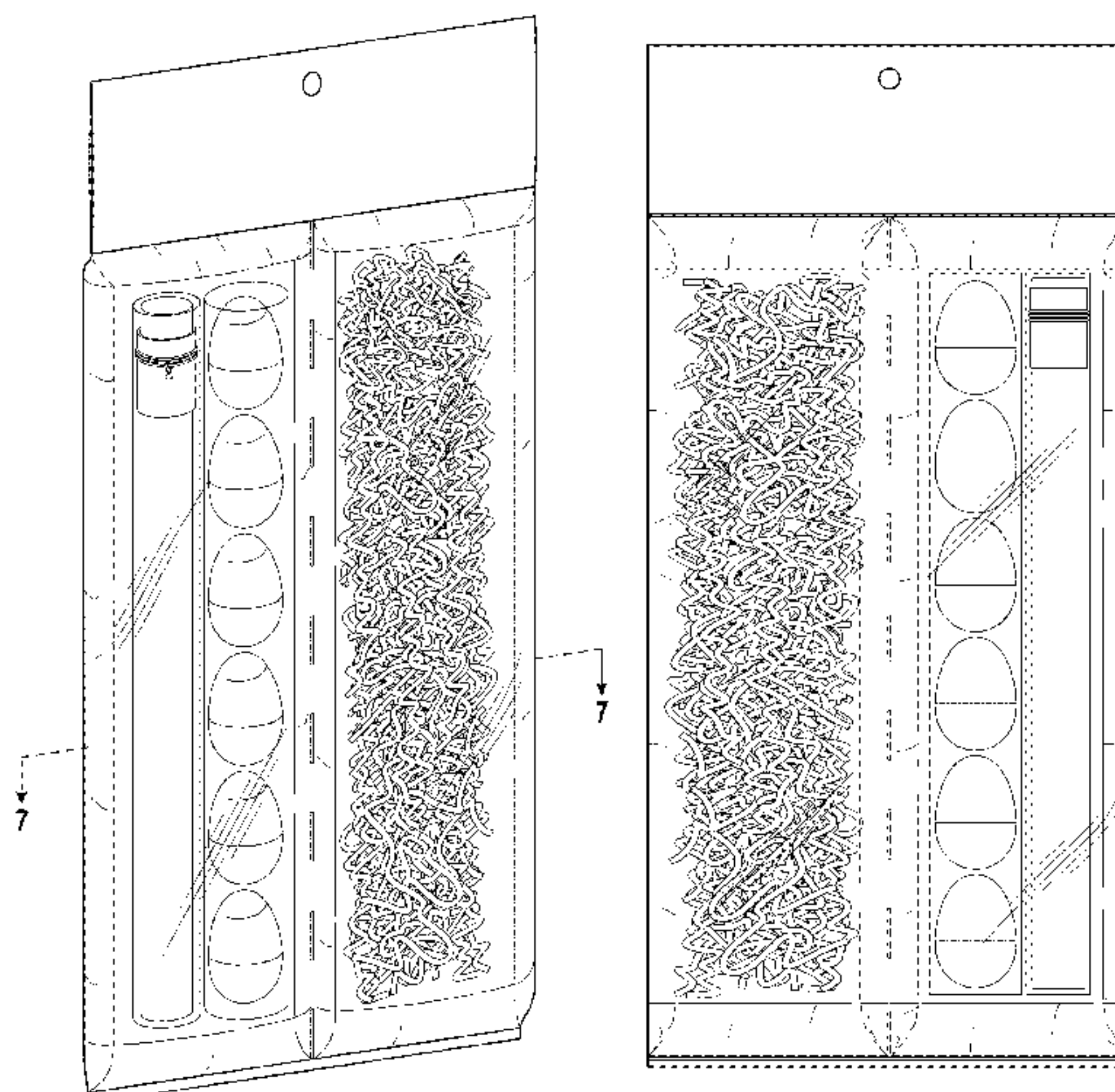
The ornamental design for a decorative packaging kit, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a decorative packaging kit showing my new design; FIG. 2 is a rear view of the decorative packaging kit of FIG. 1; FIG. 3 is a side view thereof; FIG. 4 is a side view thereof, showing the opposite side with respect to the side view of FIG. 3; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; and, FIG. 7 is a cross-sectional view thereof taken along line 7-7 of FIG. 1.

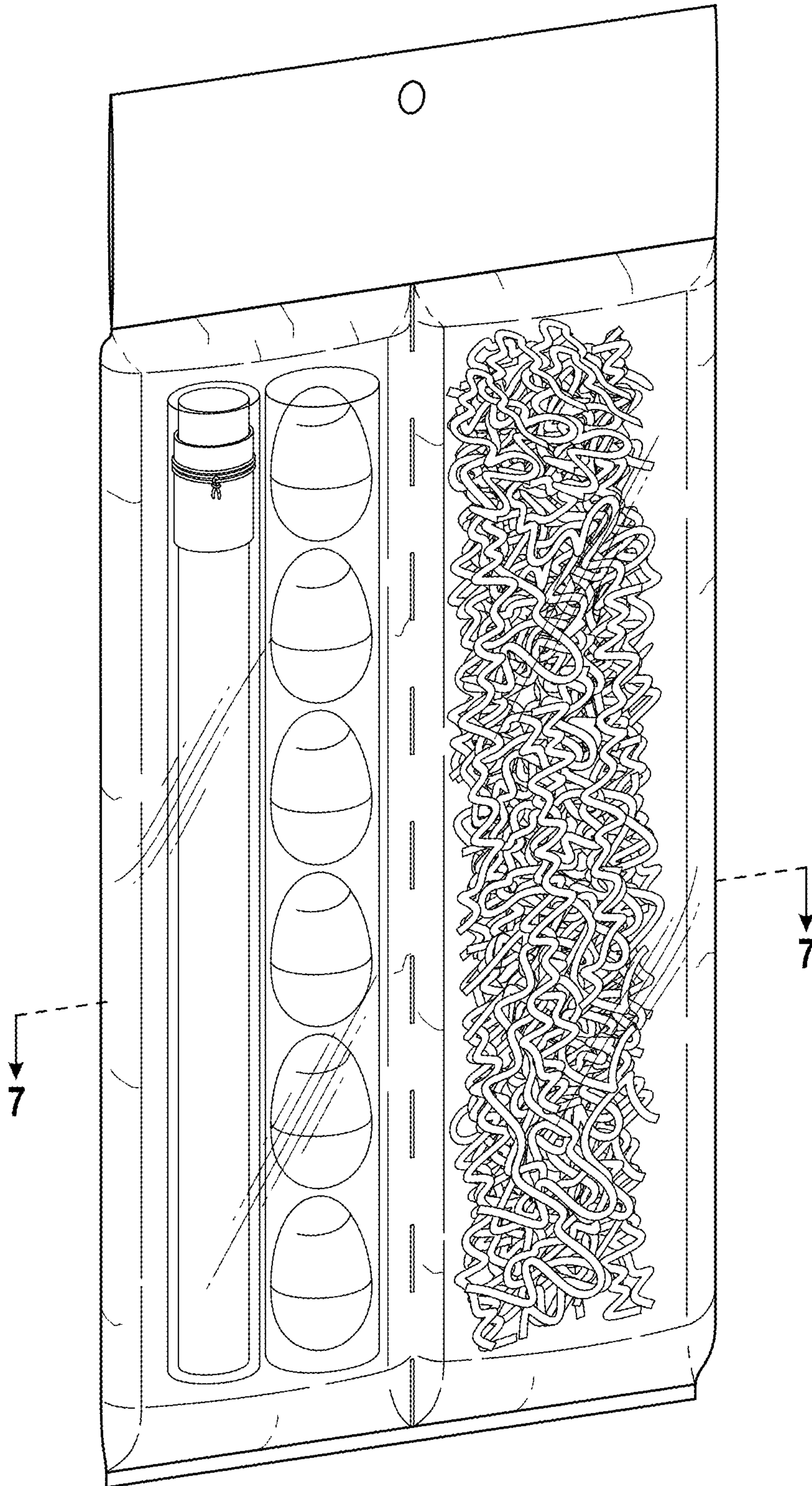

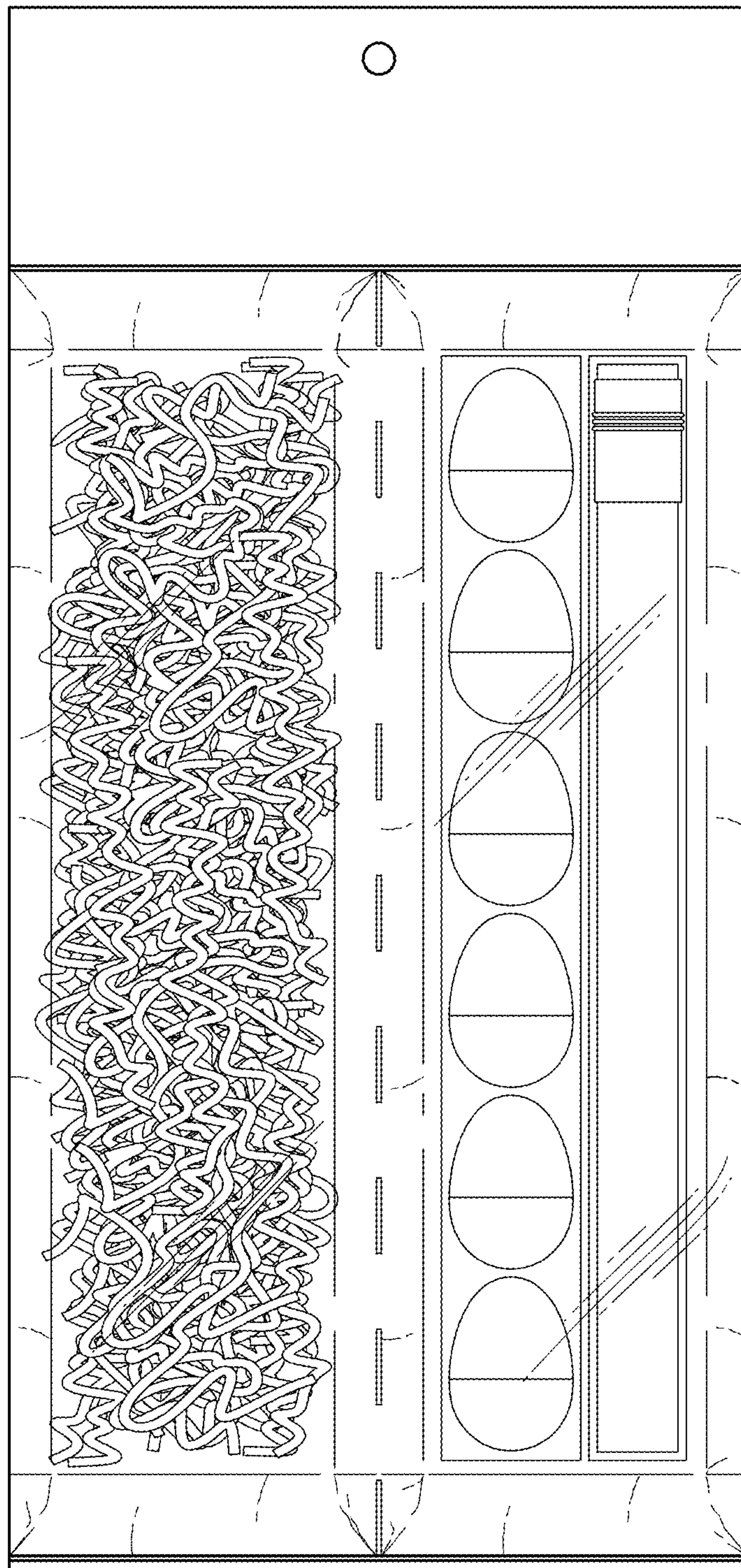

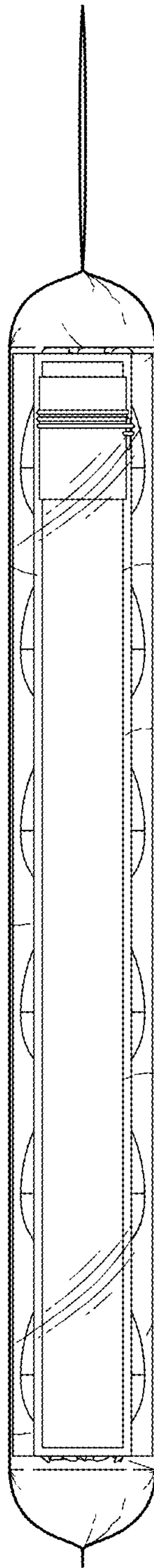

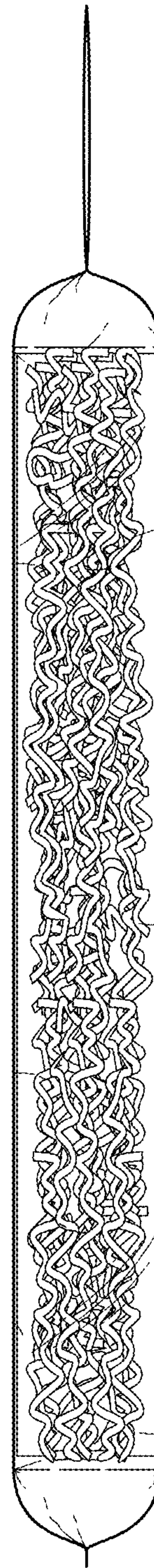

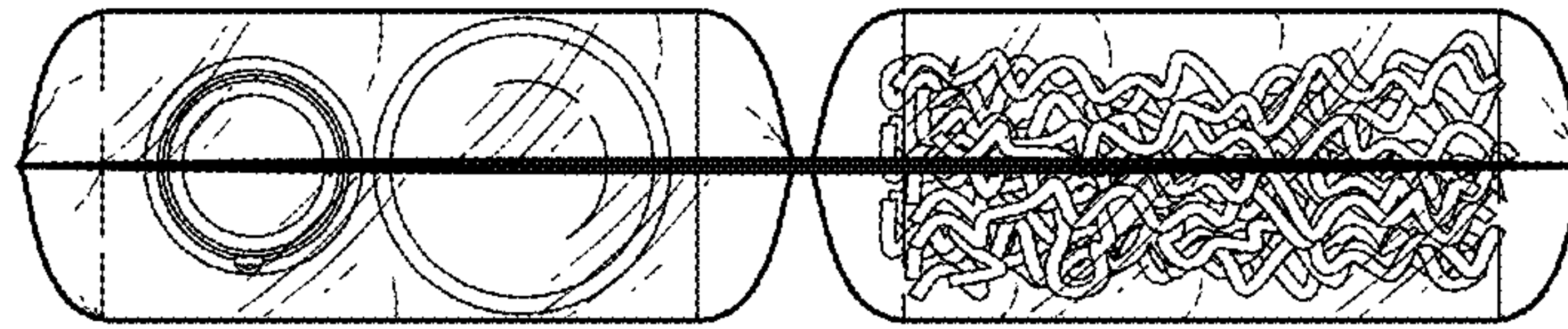

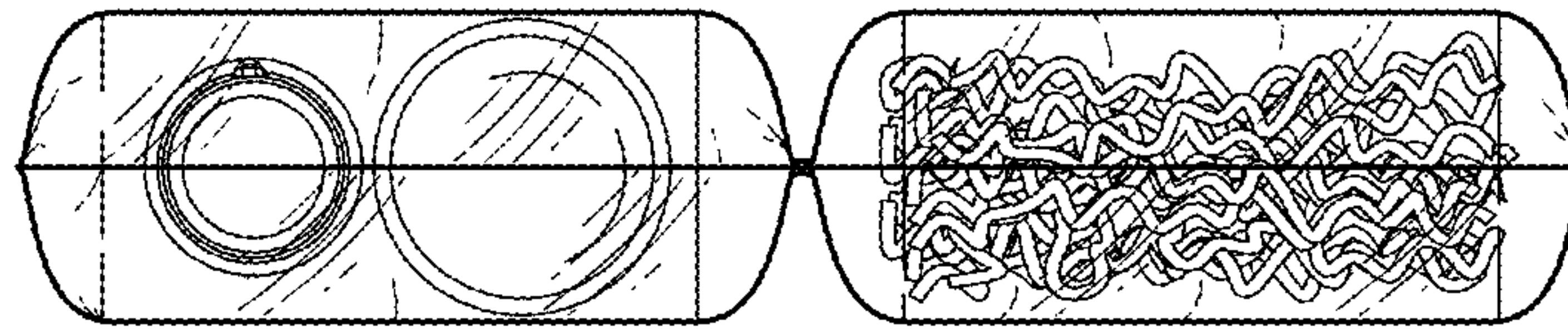

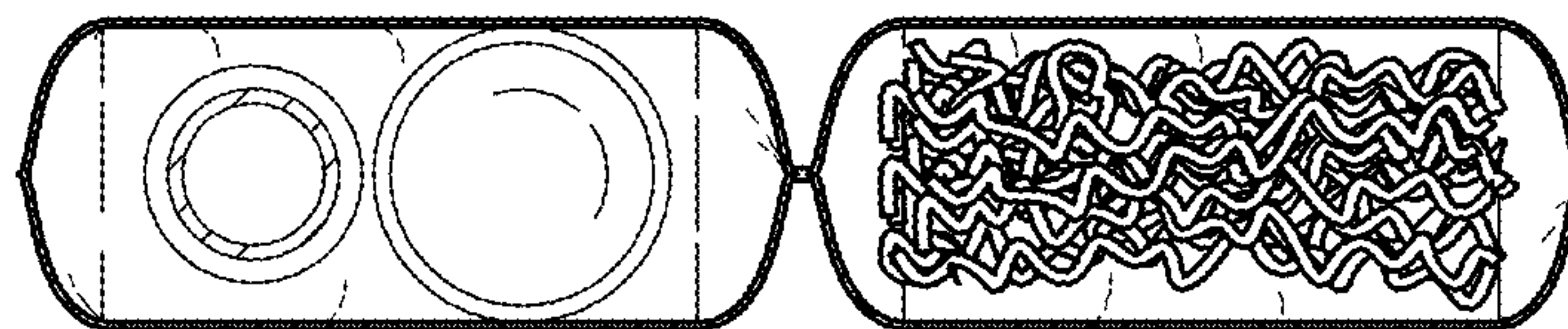
