The ornamental design for case for cellular phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right side, perspective view of a case for cellular phone showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

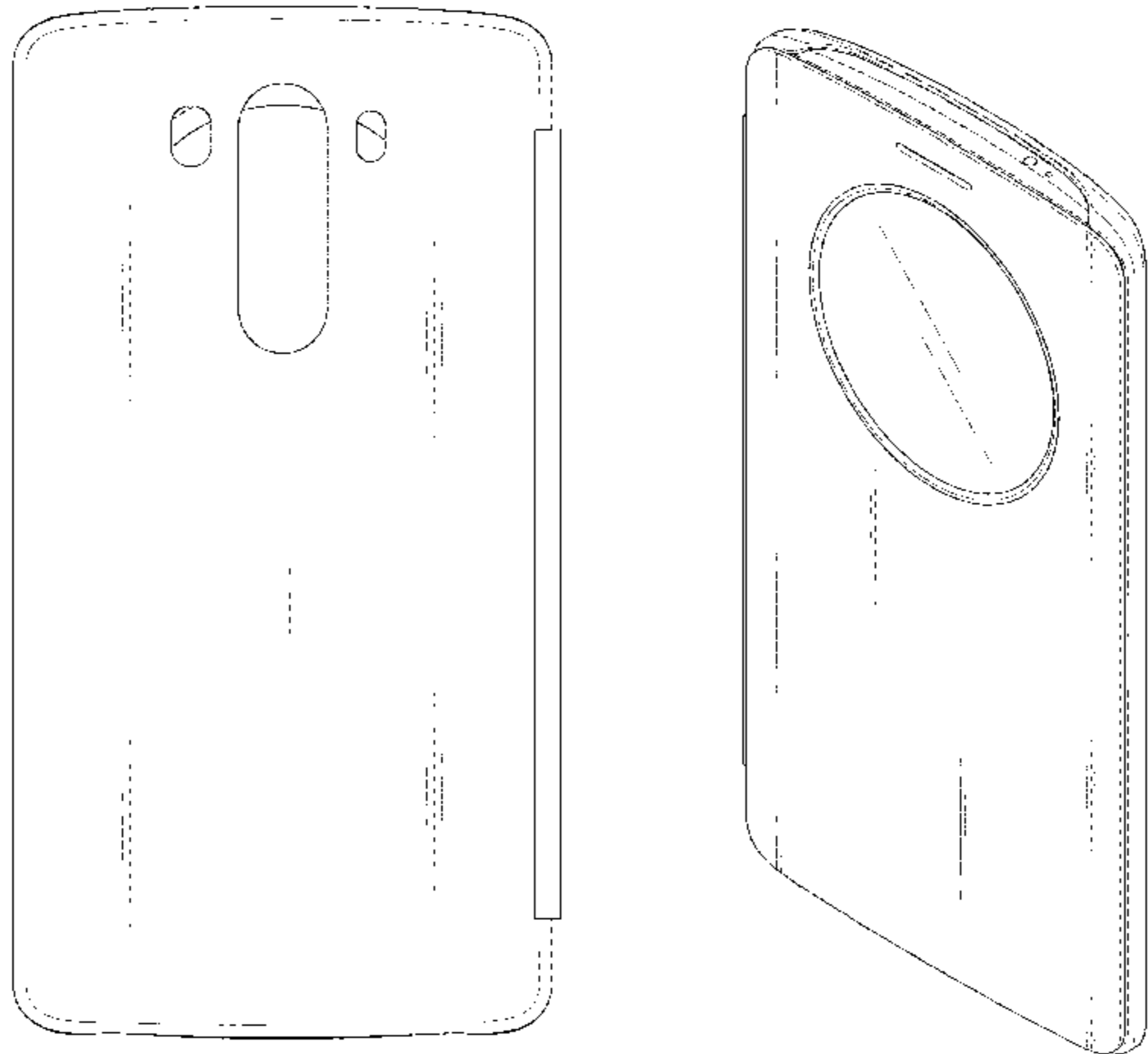
FIG. 6 is a top view thereof;

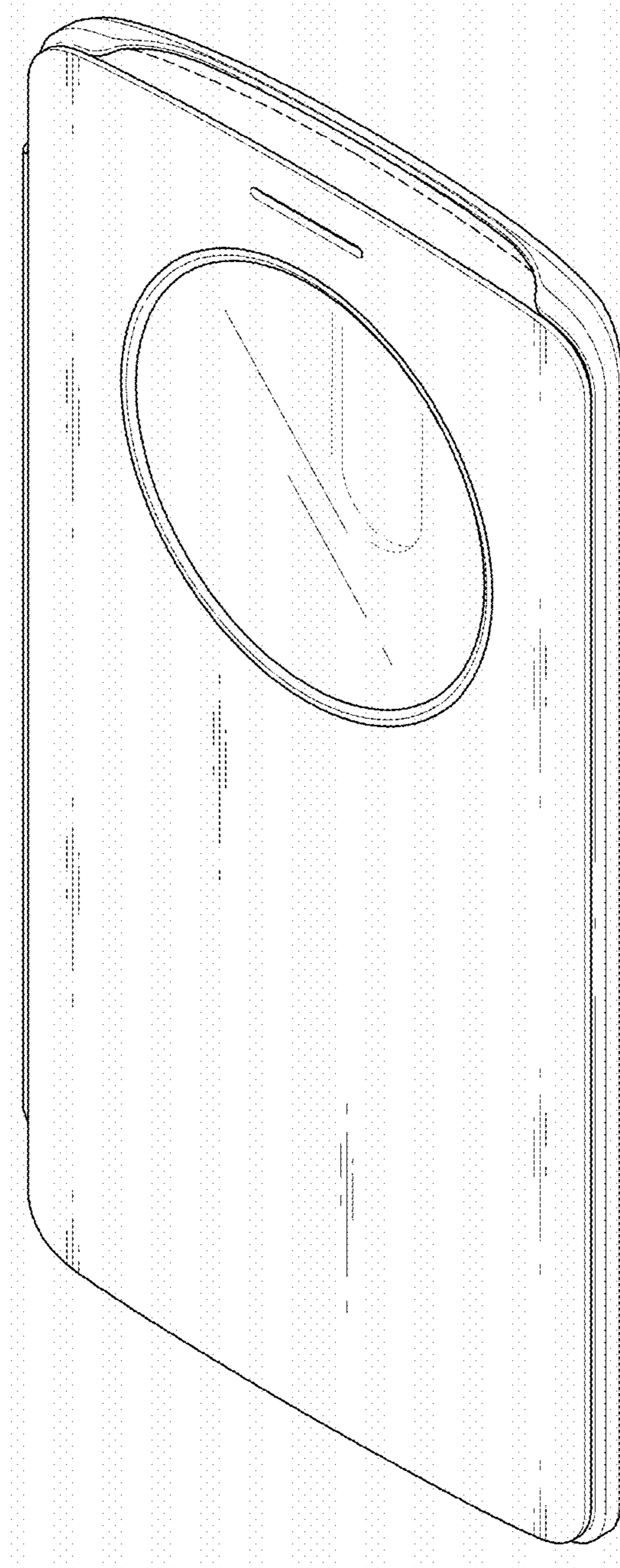

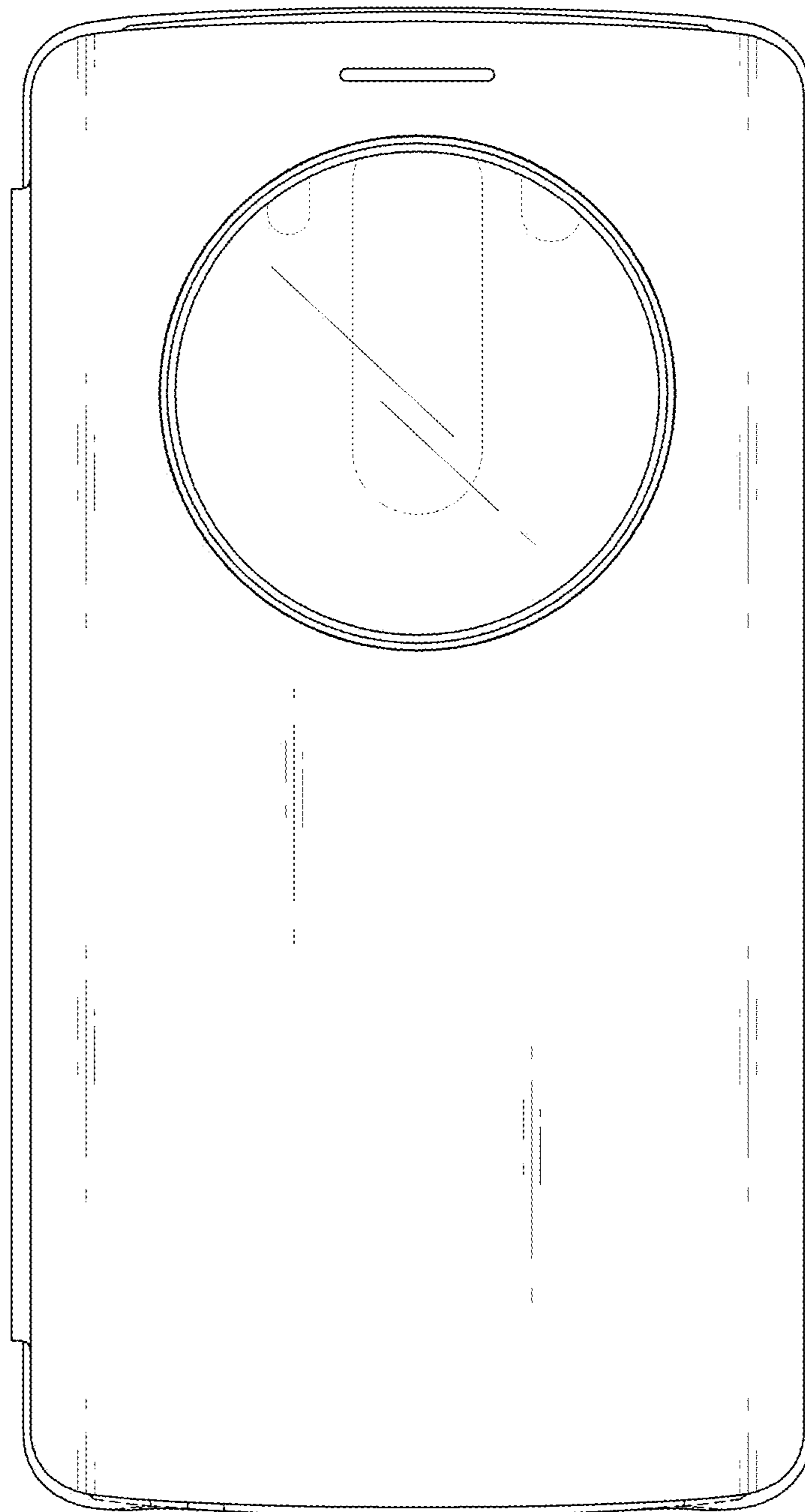

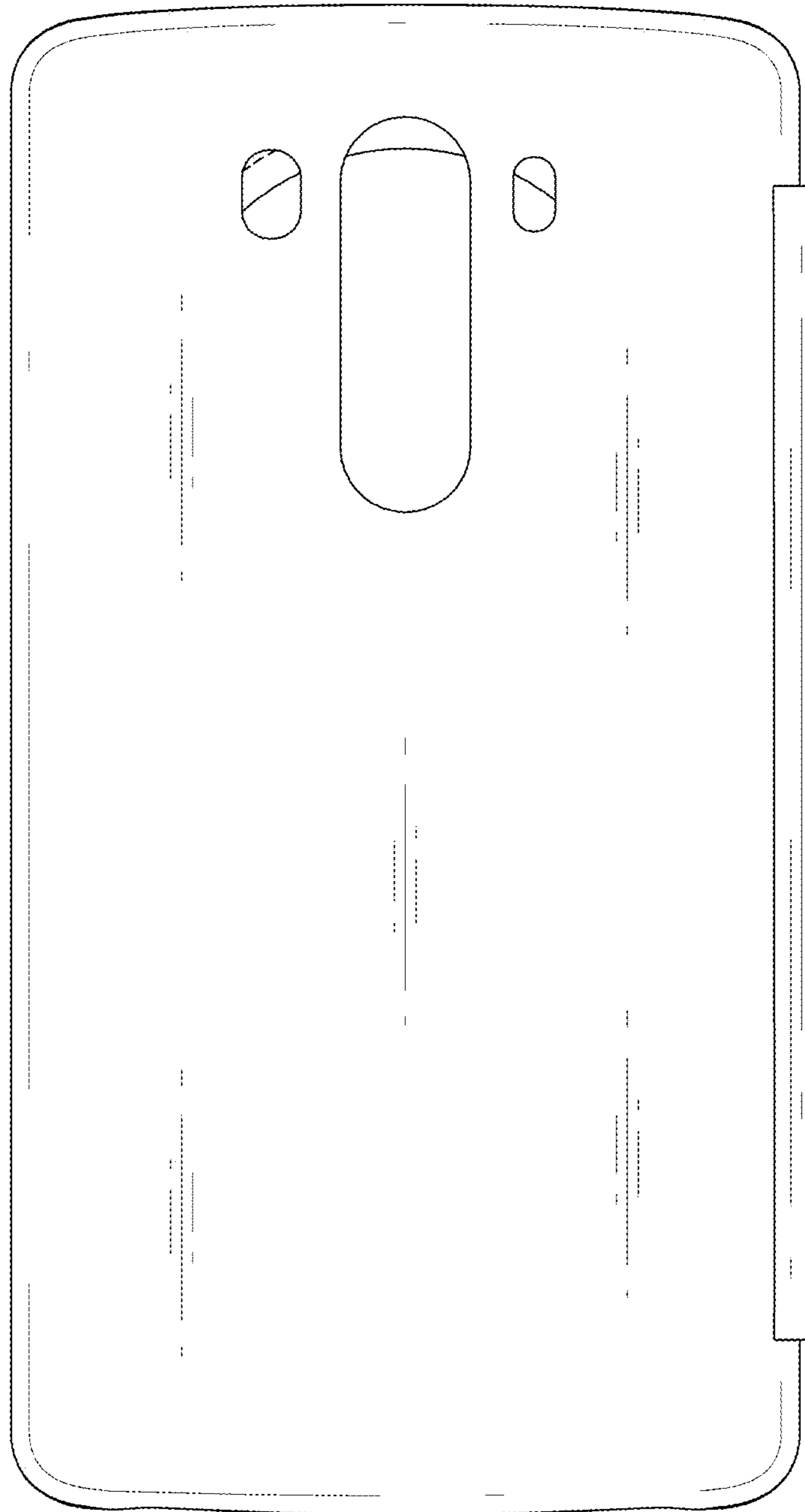

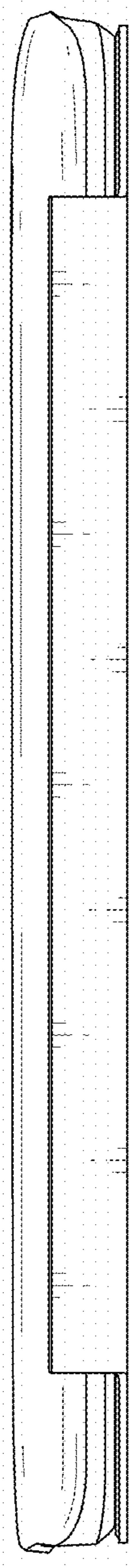

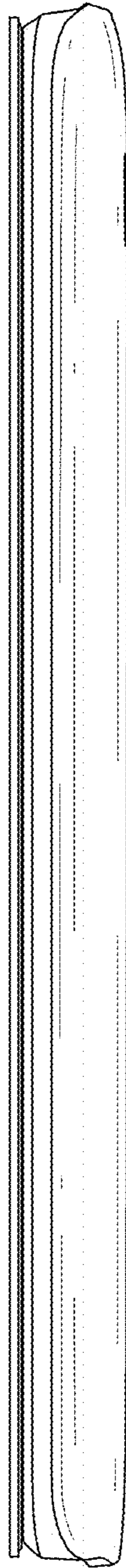

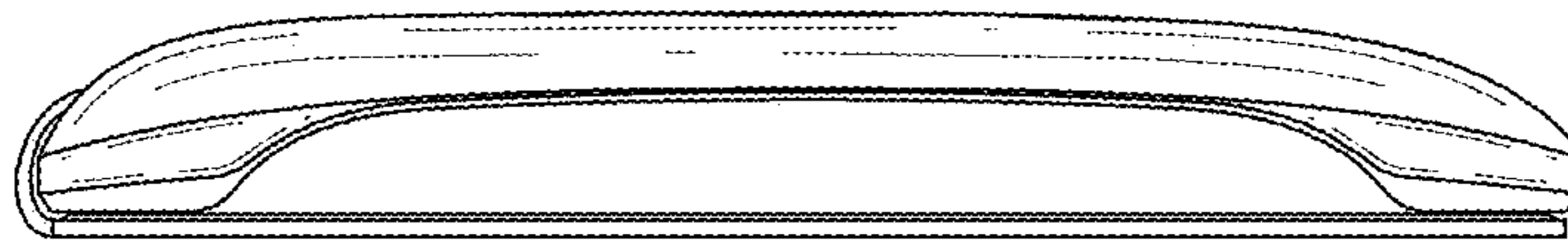

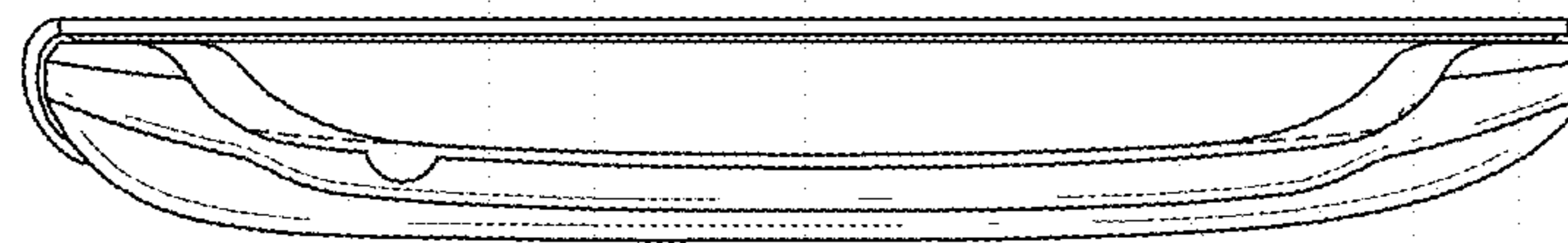
