FIG. 1 is a front view of a first embodiment of a mobile application interface for display or portion thereof of our new design.

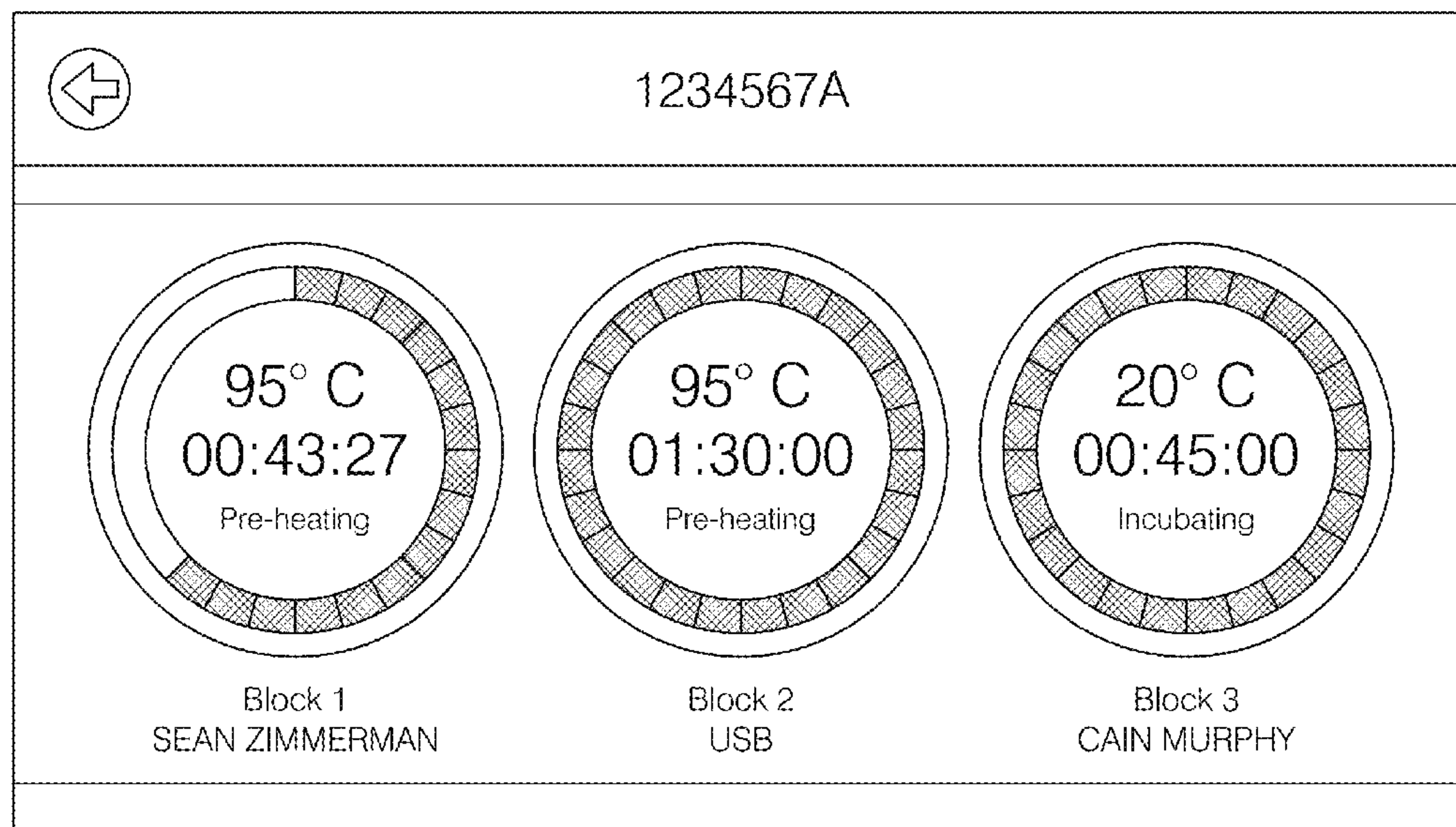
FIG. 2 is a front view of a second embodiment of a mobile application interface for display or portion thereof of our new design.

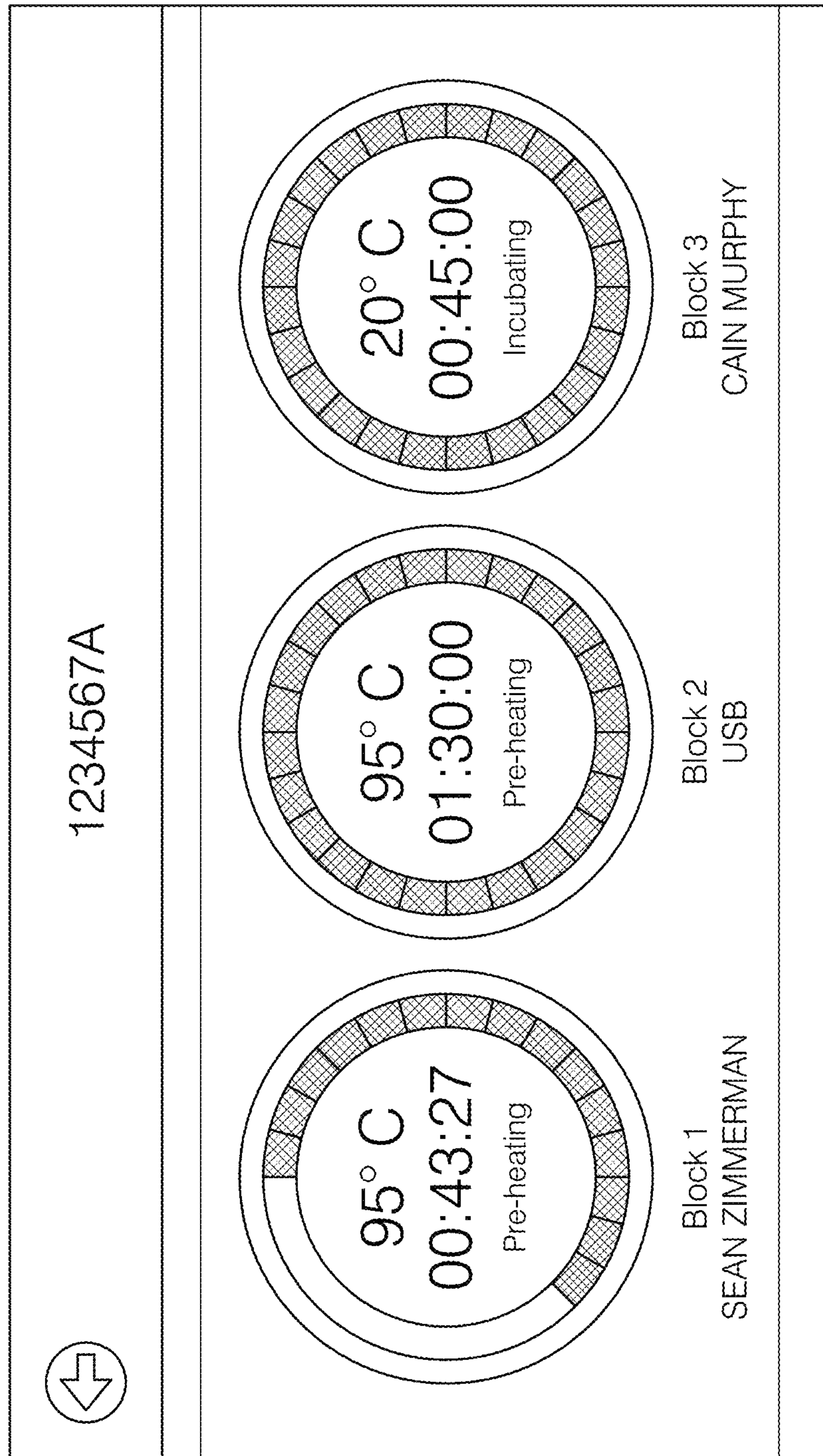

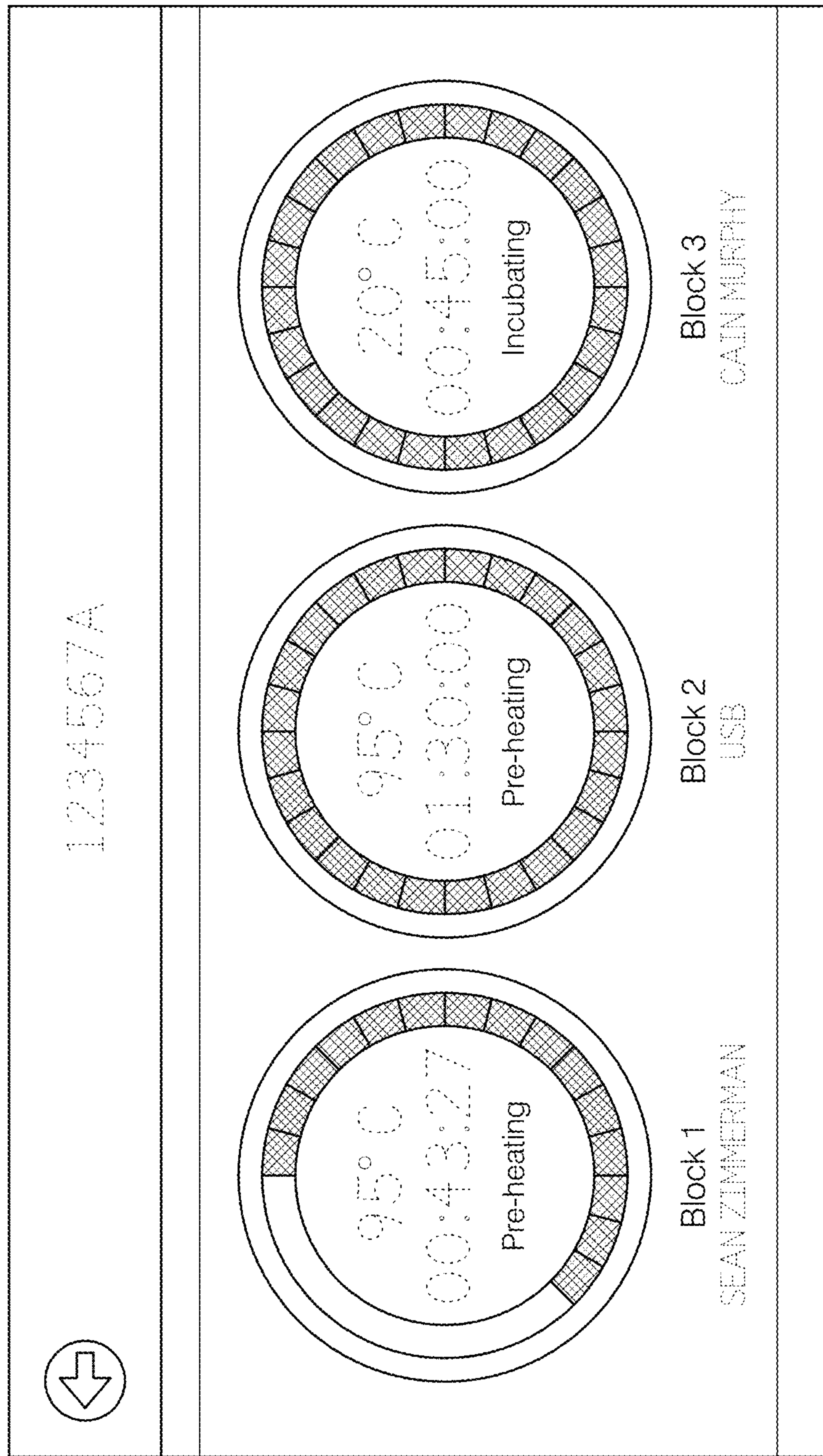

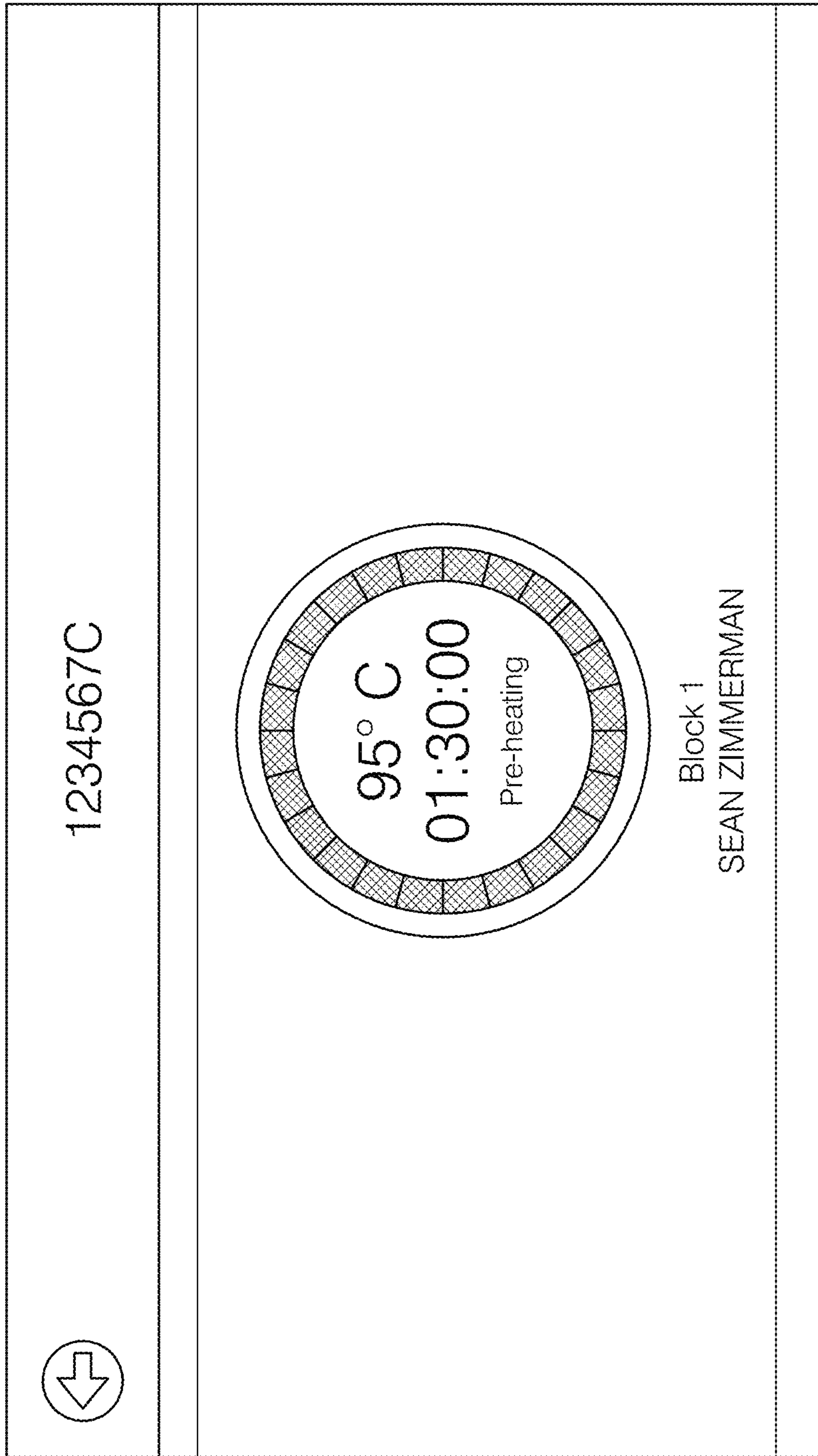

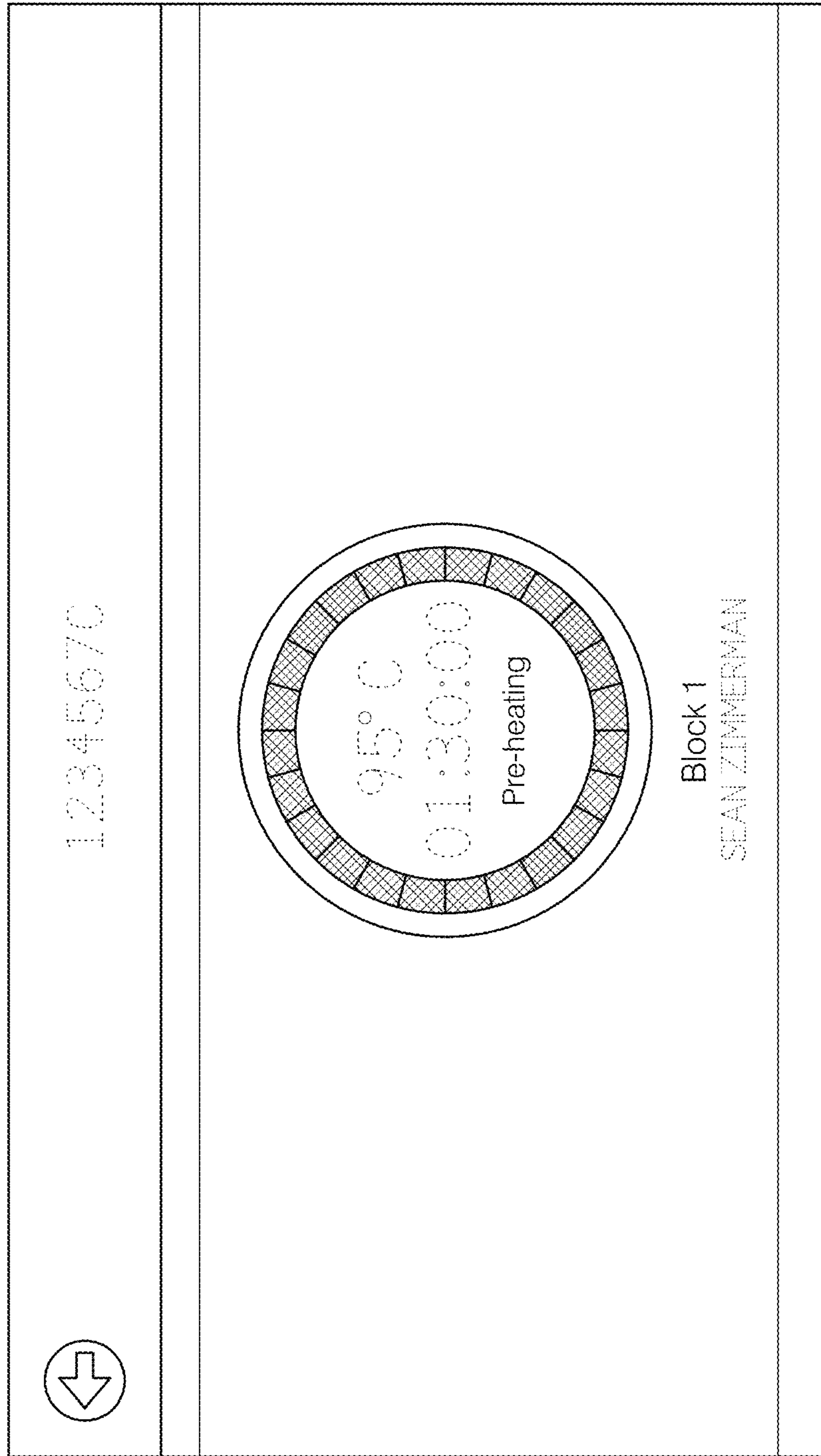
