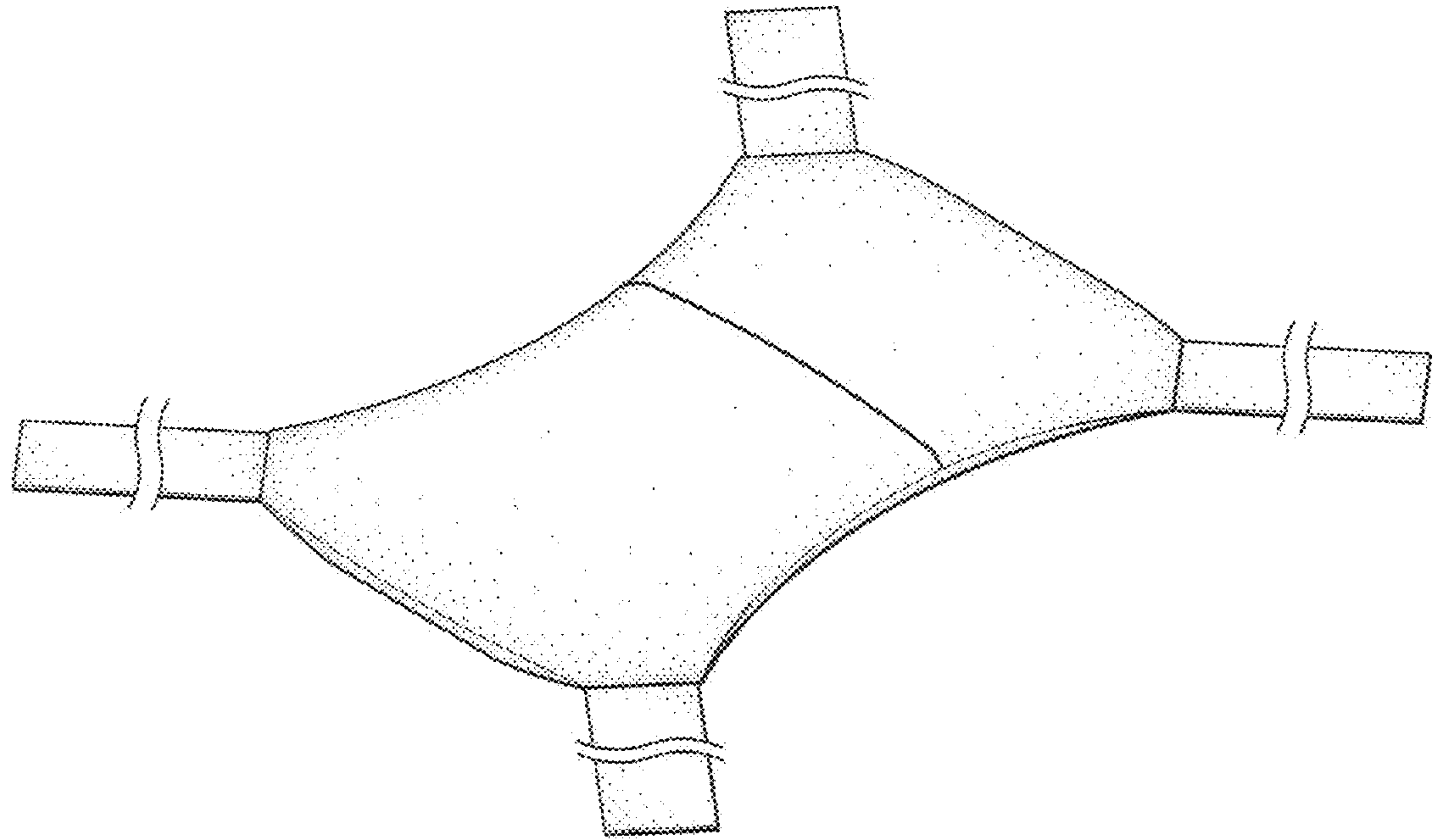

(57) **CLAIM**  
I claim the ornamental design of a heat or cold pack, as shown and described.

**DESCRIPTION**

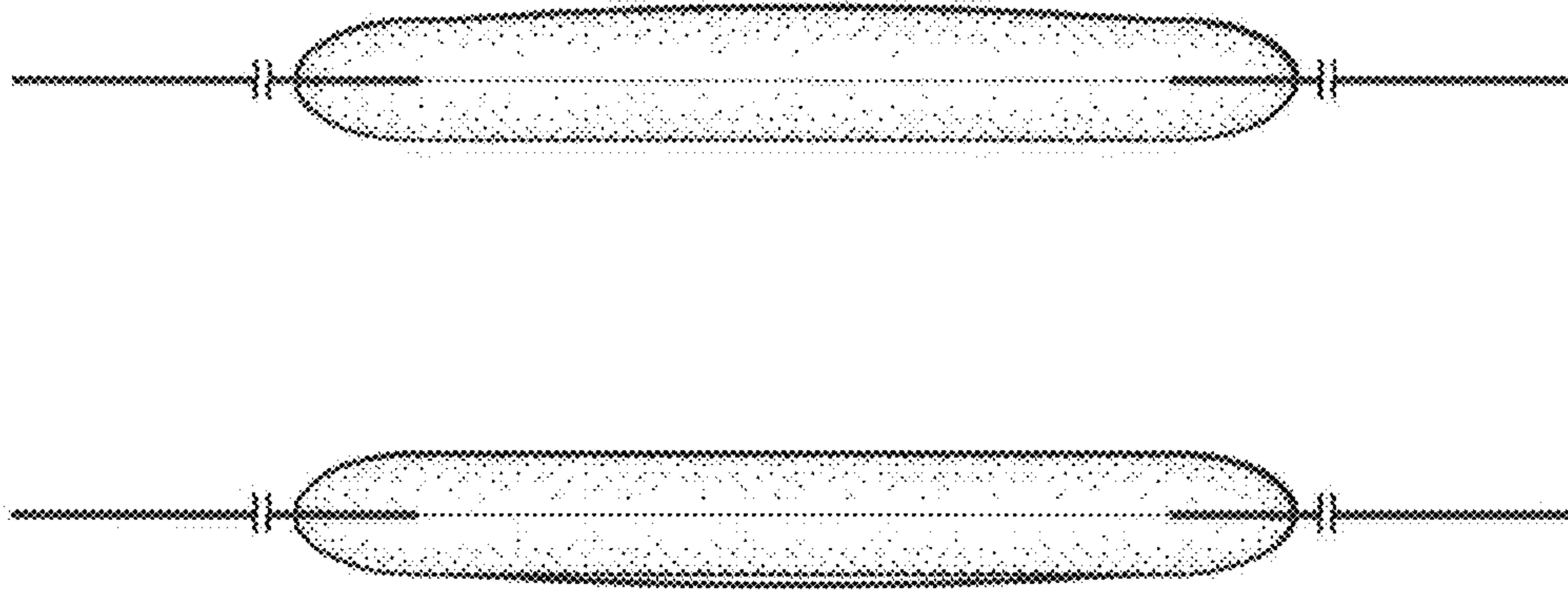


FIG. 6 FIG. 7

FIG. 1 is a perspective view of the heat or cold pack of the present invention shown as it would be worn on a patient. FIG. 2 is a perspective bottom plan view of the heat or cold pack of the present invention. FIG. 3 is a top plan view of the heat or cold pack of the present invention. FIG. 4 is a left side elevation view thereof. FIG. 5 is a right side elevation view thereof. FIG. 6 is a first end view thereof. FIG. 7 is a second end view thereof; and, FIG. 8 is a bottom plan view thereof. The broken away symbols in the attached drawings indicate that any portion of the article beyond what is shown forms no part of the claimed design.

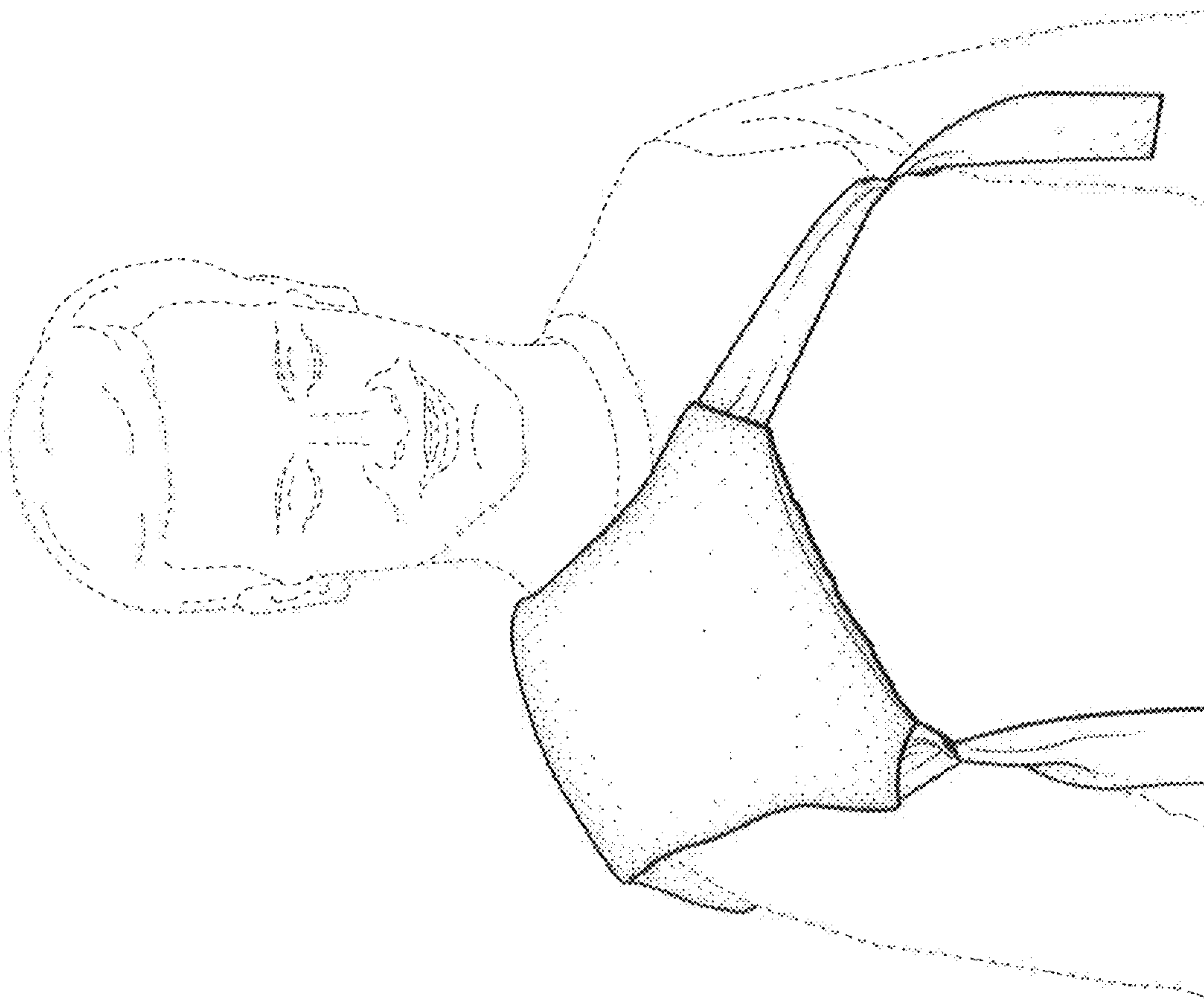

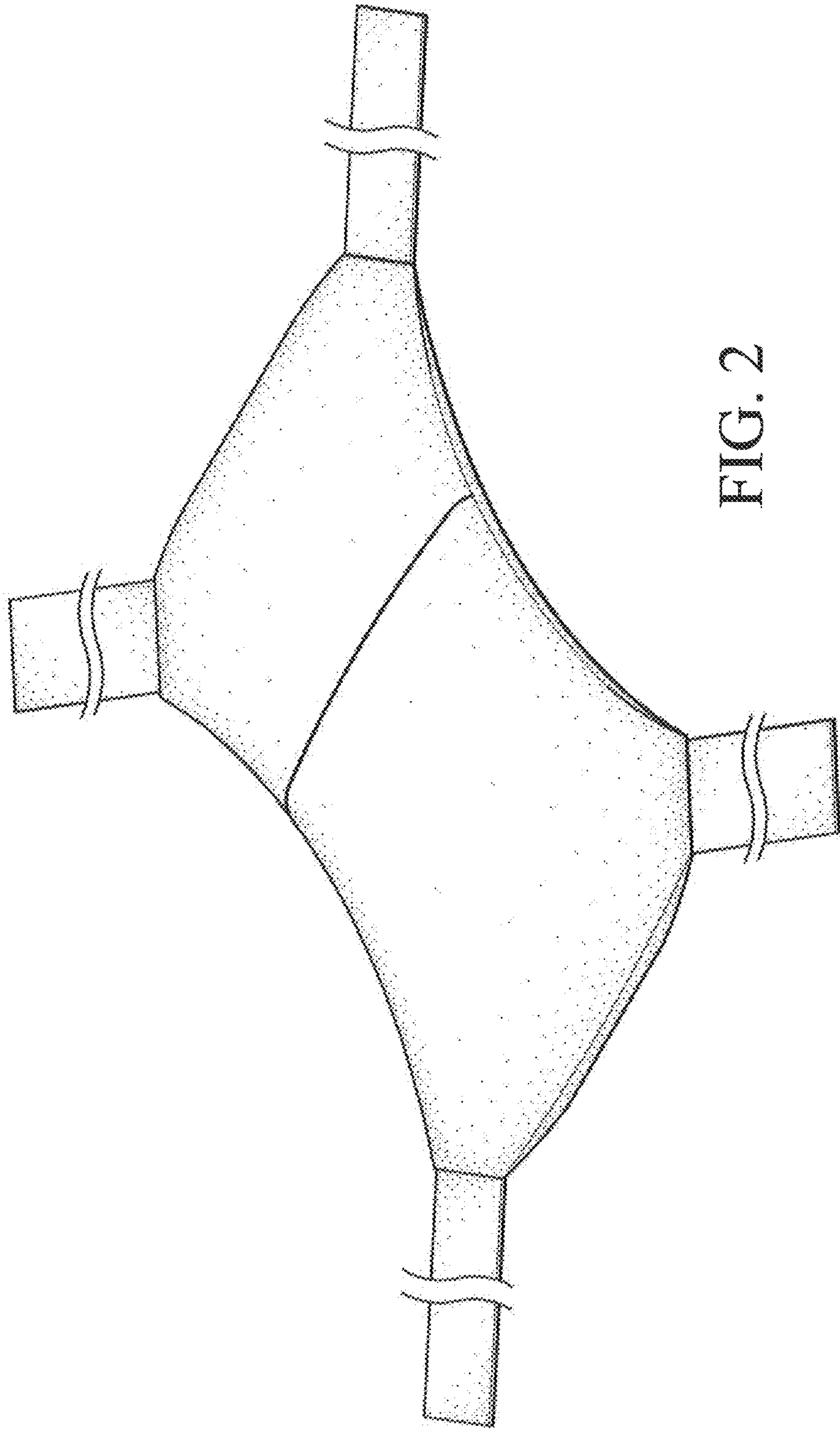

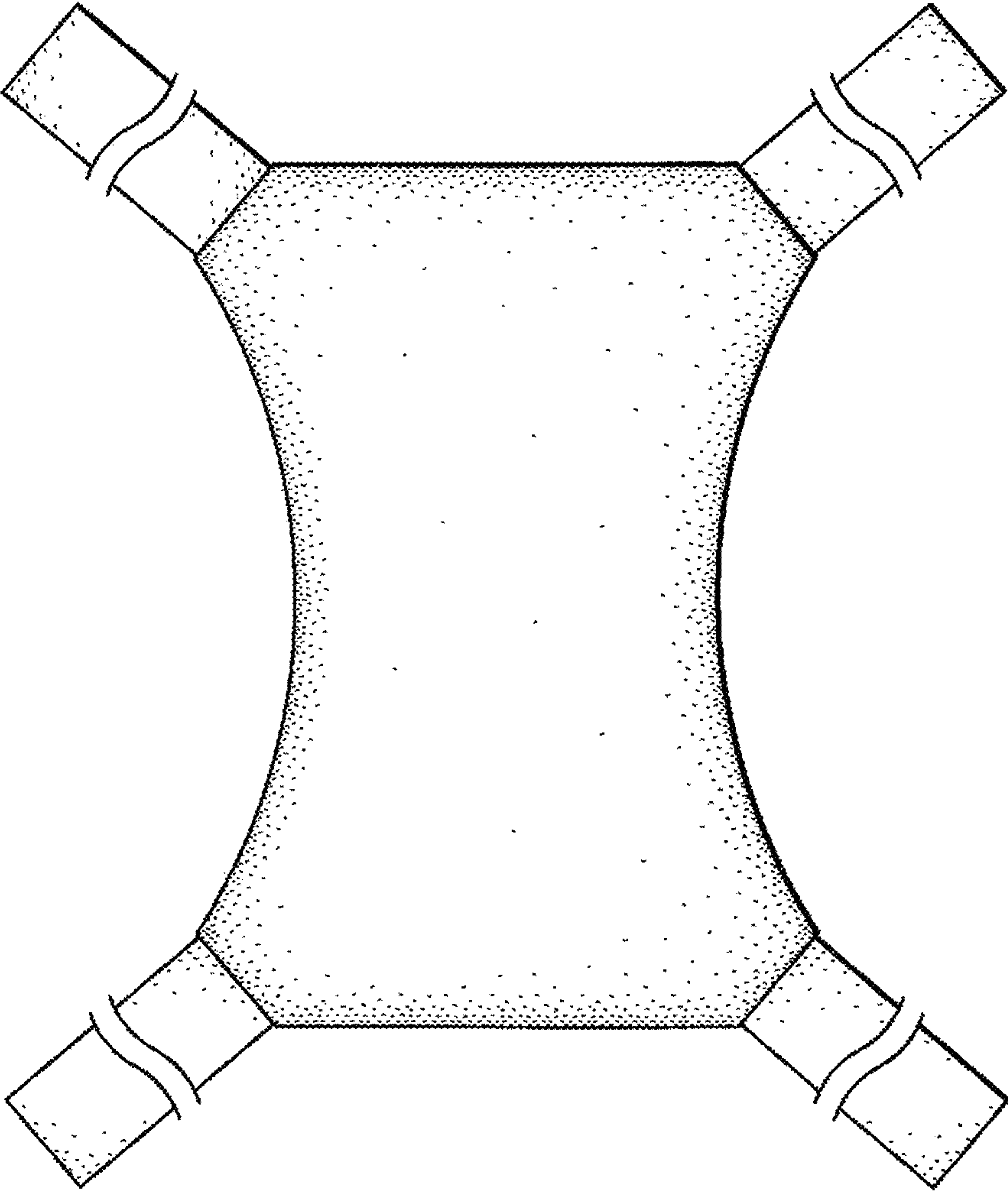

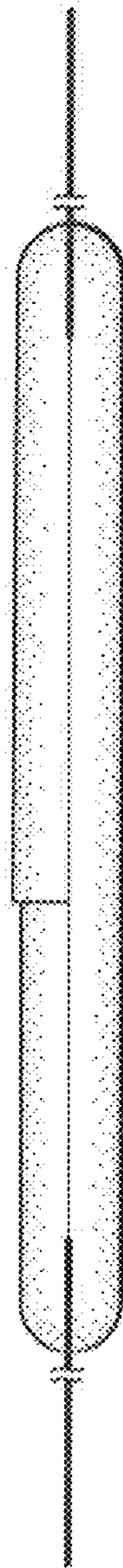

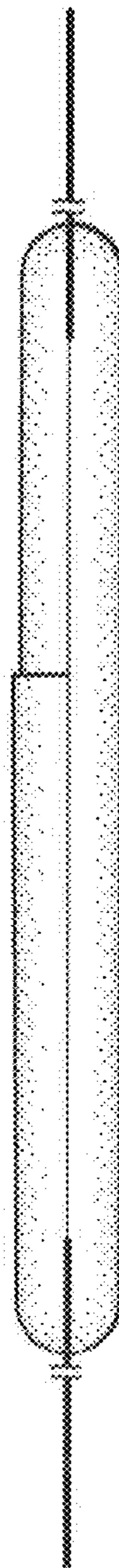

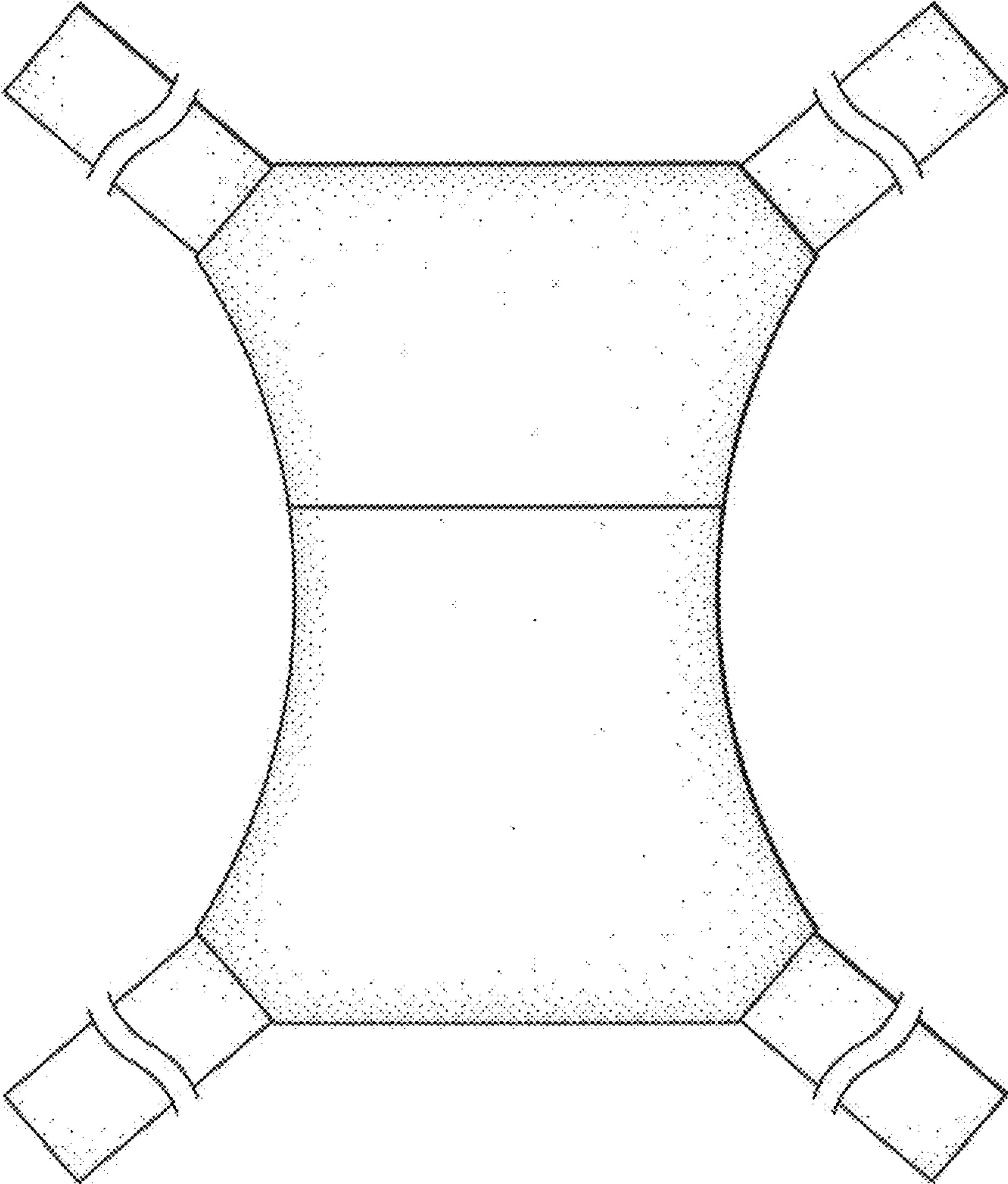
