(57) **CLAIM**

The ornamental design for a food bar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a food bar showing our new design.

FIG. 2 is another perspective view thereof.

FIG. 3 is a front view thereof.

FIG. 4 is a back view thereof.

FIG. 5 is a right side view thereof.

FIG. 6 is a left side view thereof.

FIG. 7 is a top view thereof; and,

FIG. 8 is a bottom view thereof.

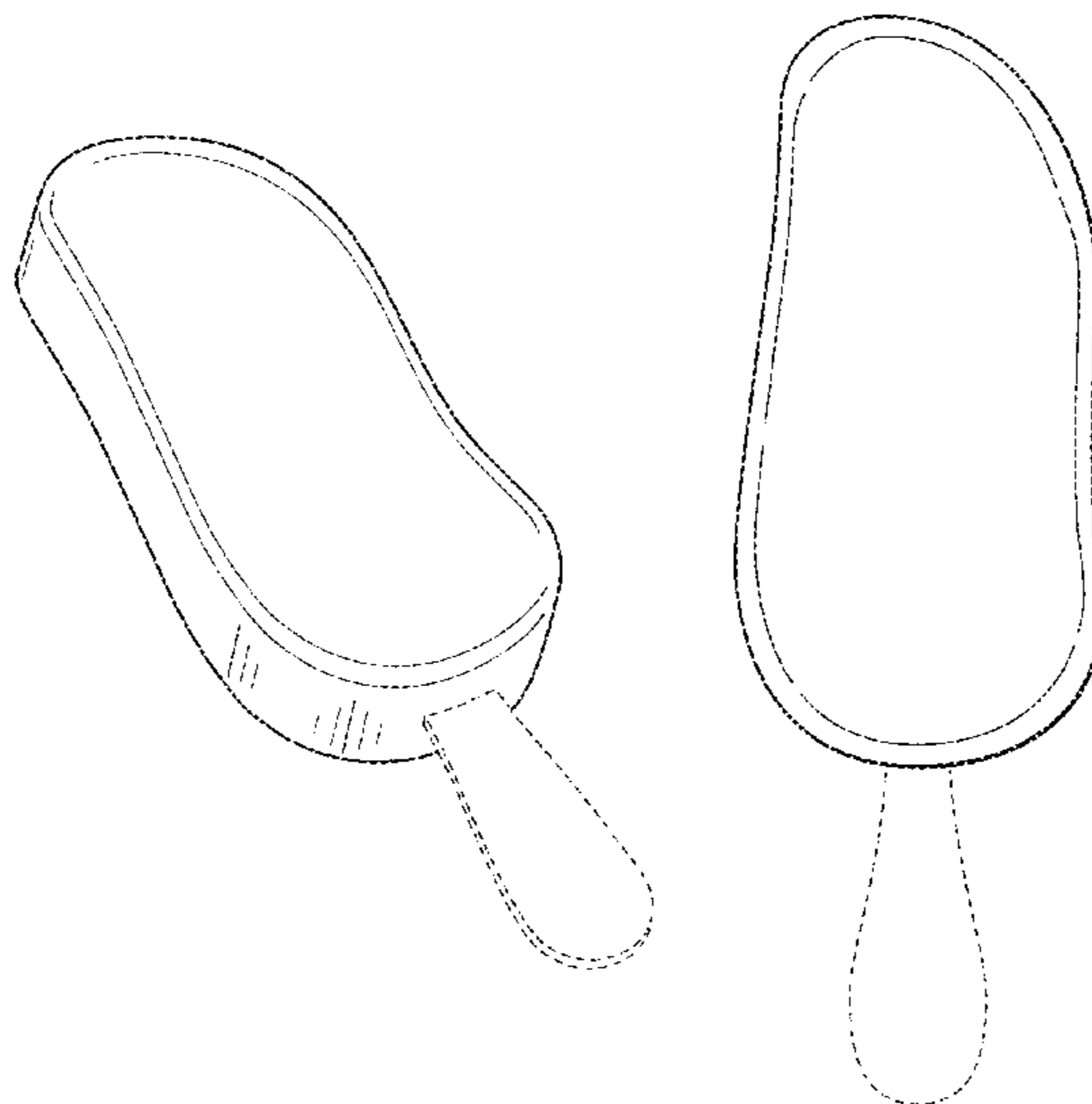
The food bar is not limited to the scale shown herein.

The broken lines in FIGS. 1-6 and 8 illustrate portions of the food bar that form no part of the claimed design.

The light weight lines in the figures show surface contour and not surface ornamentation.

The food bar is a frozen confection, such as, for example, a popsicle, a frozen fruit bar, a frozen yogurt bar, an ice cream bar, a frozen pudding bar, a gelato bar, or a frozen custard bar.

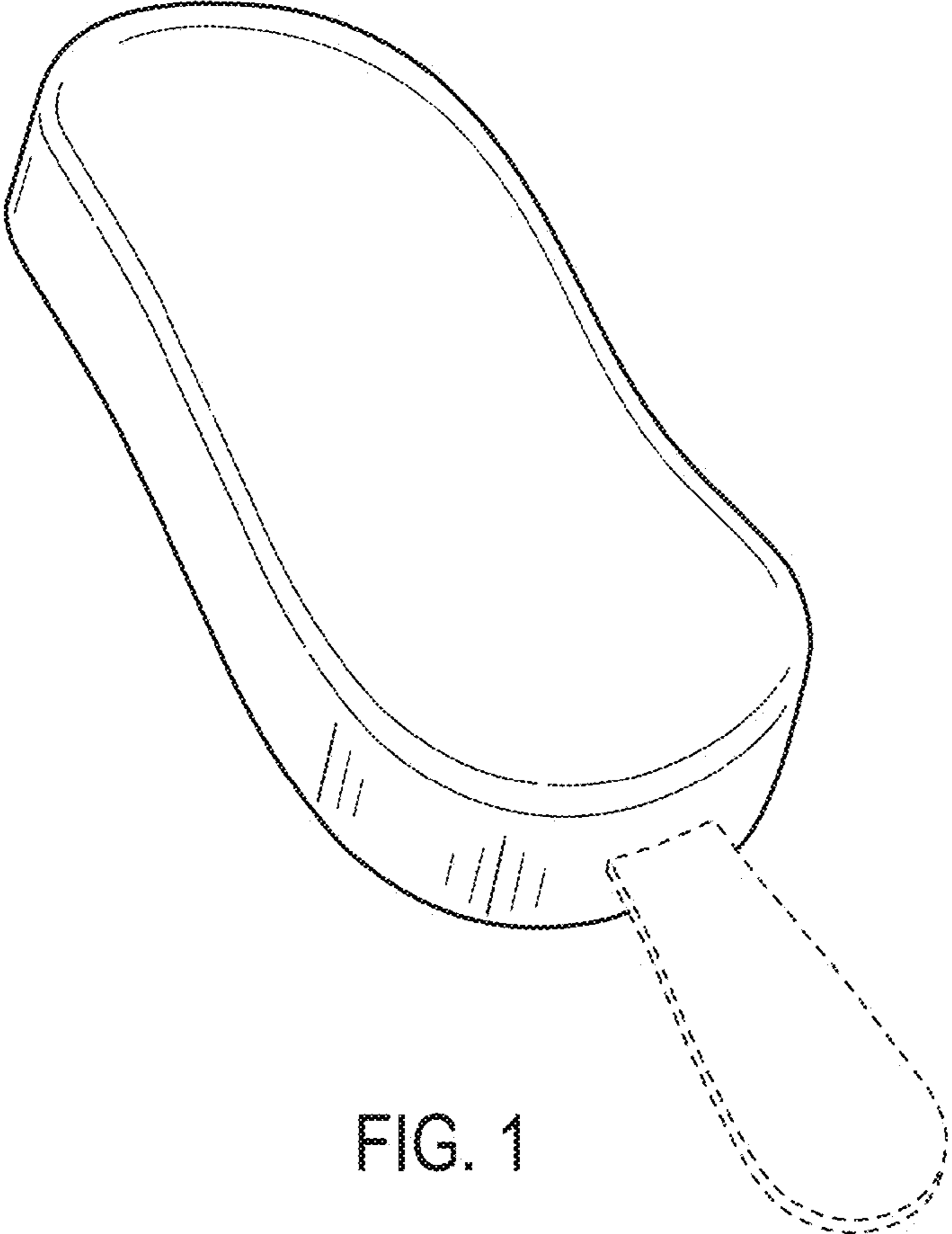

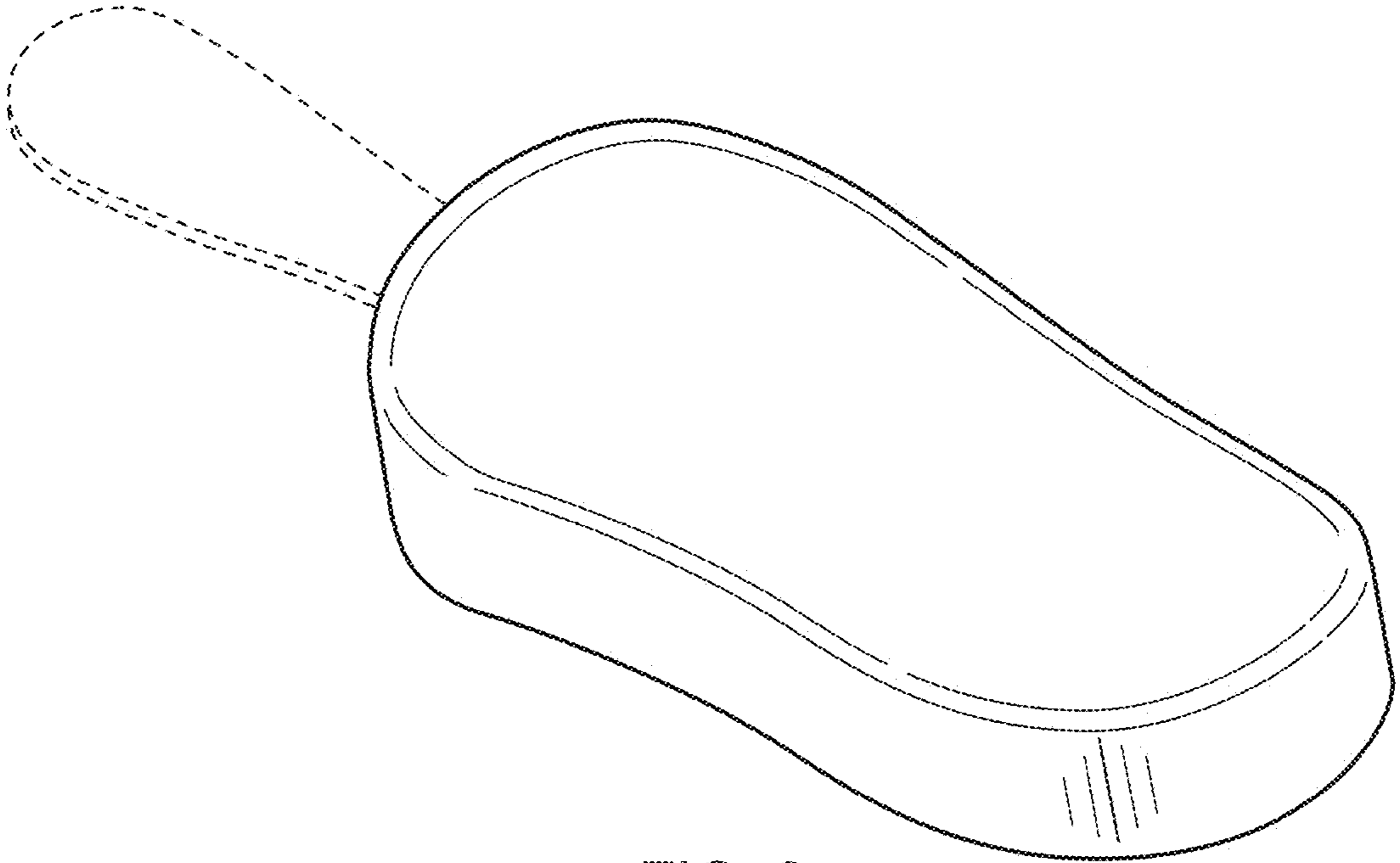

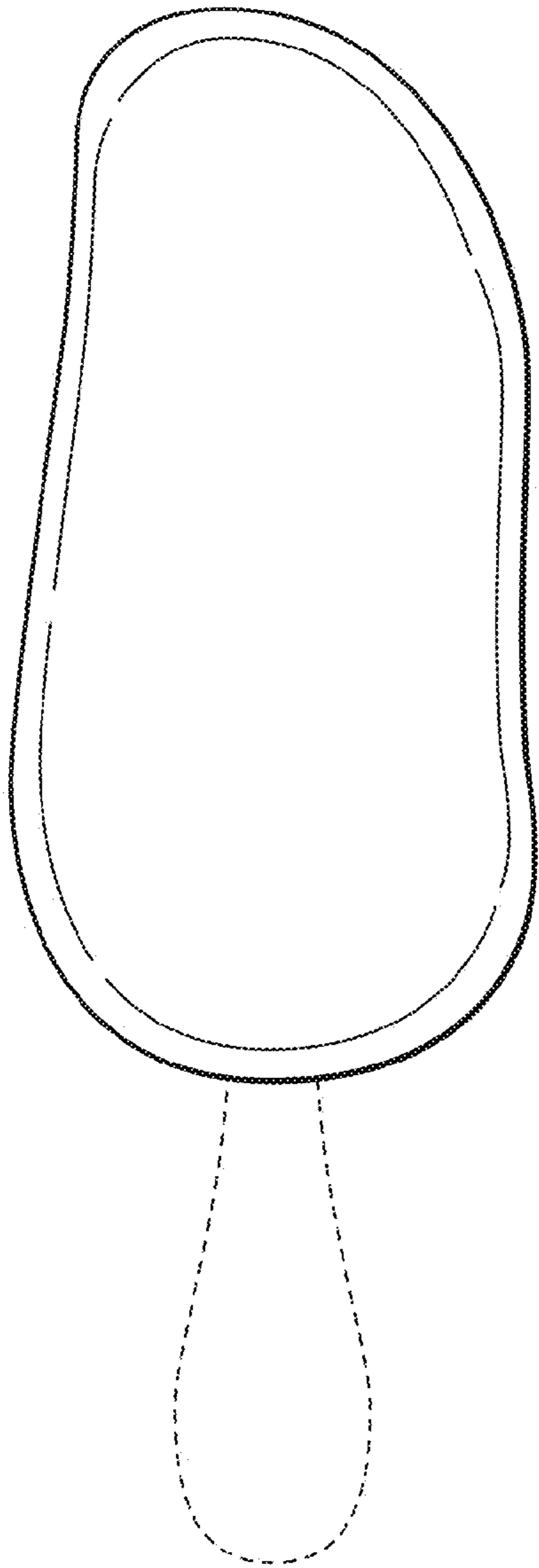

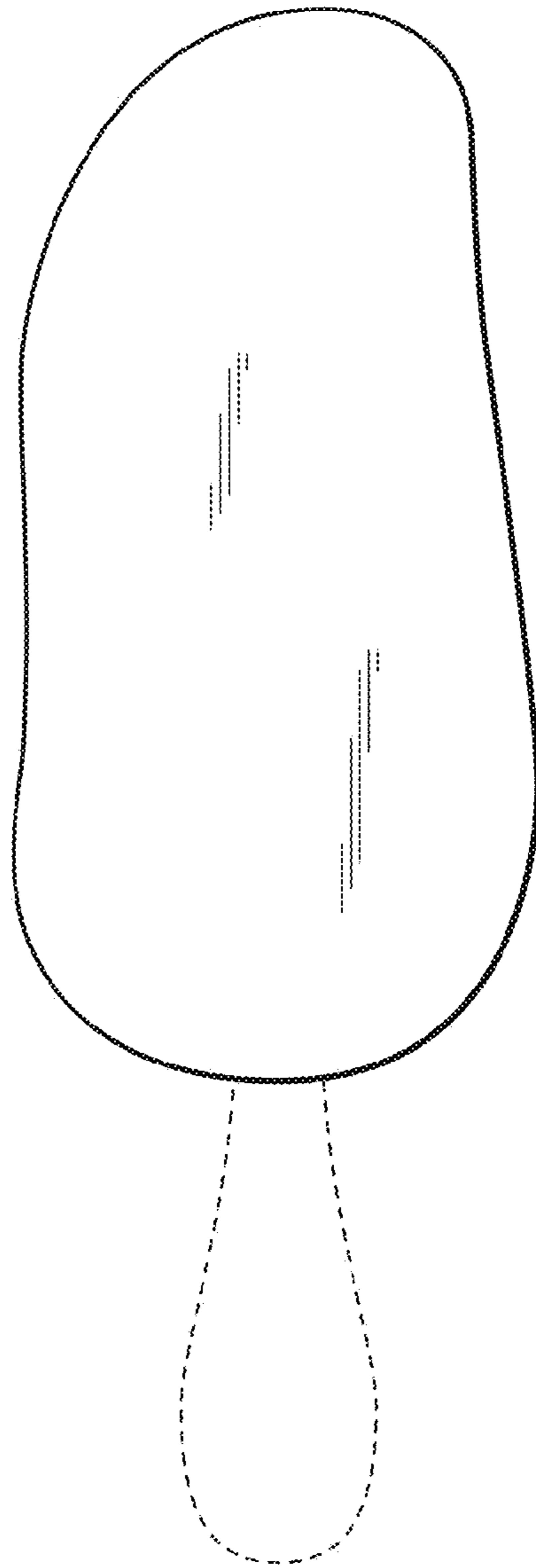

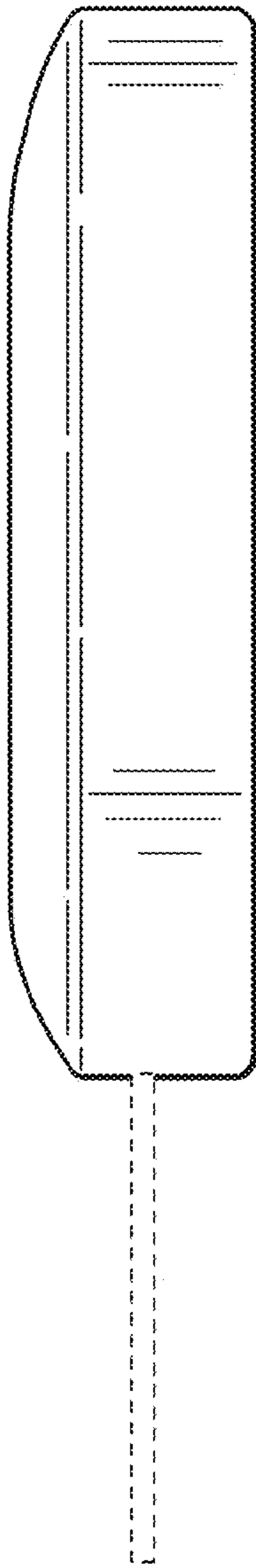

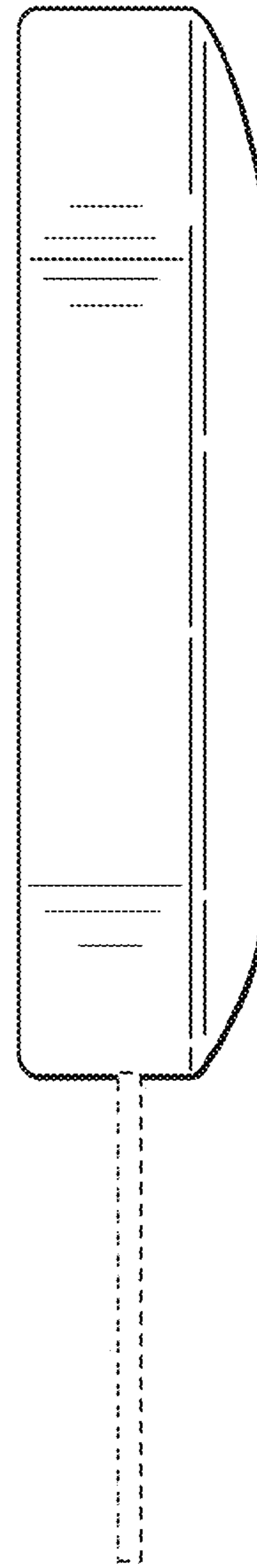

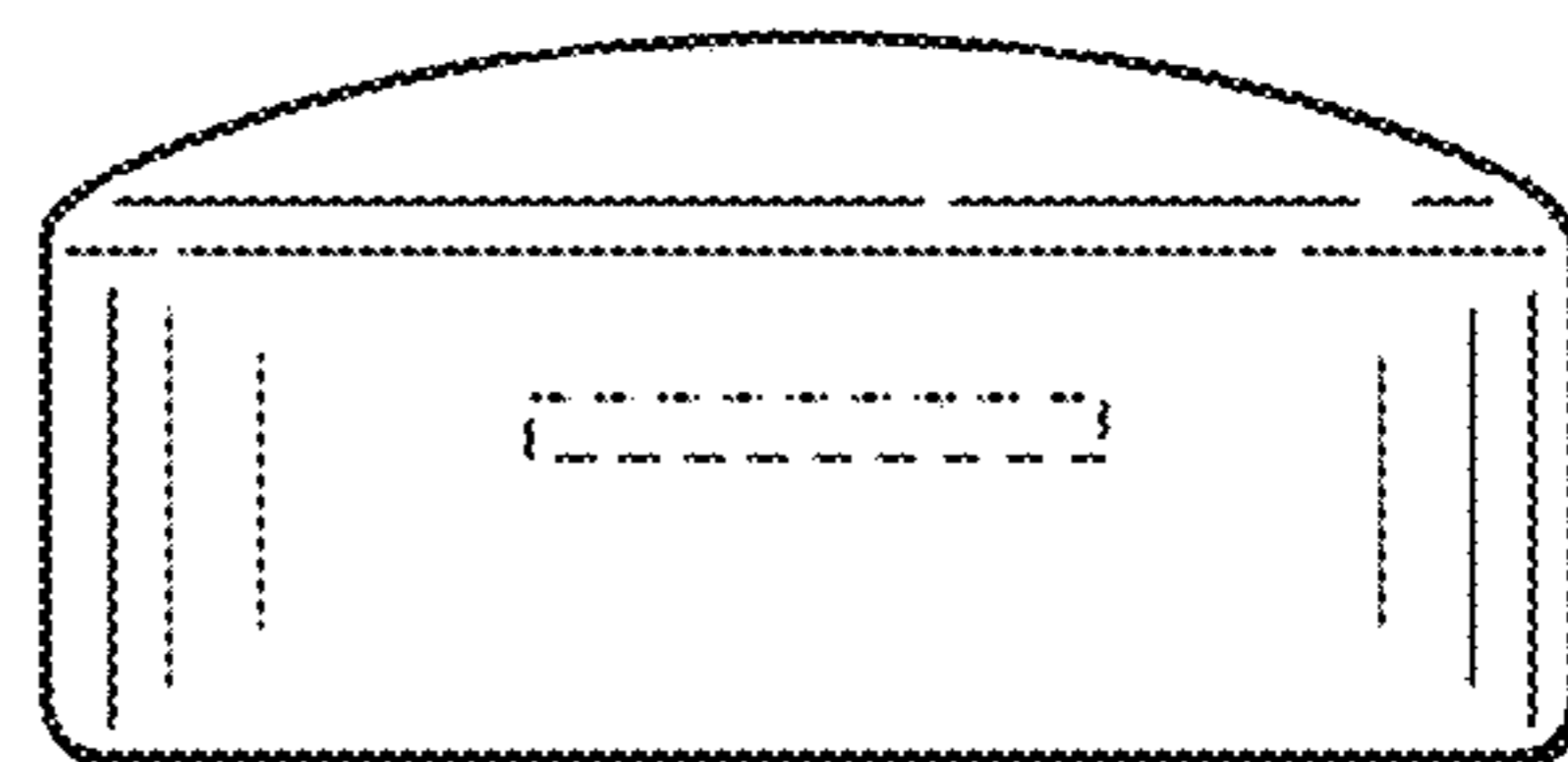
