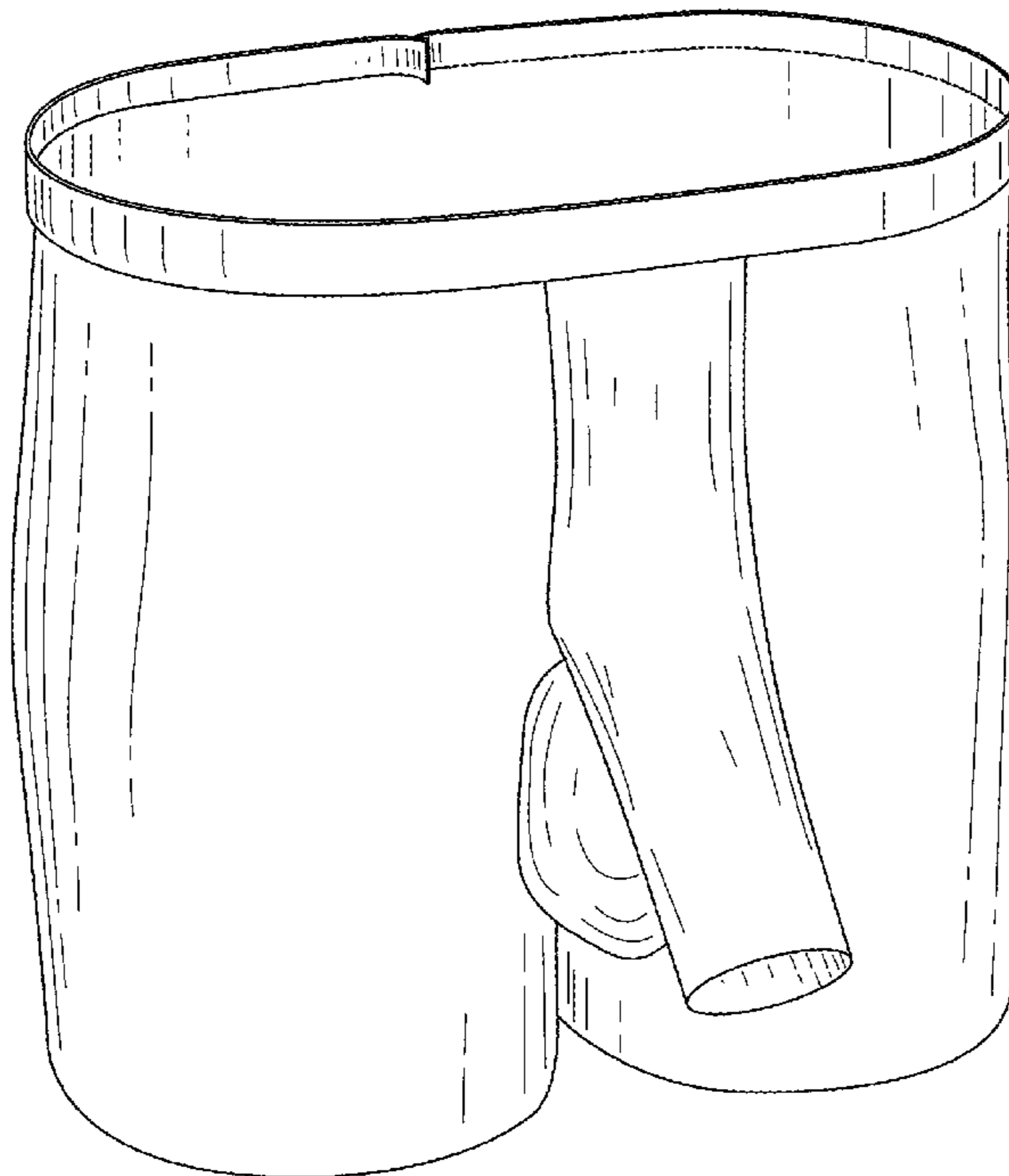
FIG. 5 is a right-side elevational view thereof;

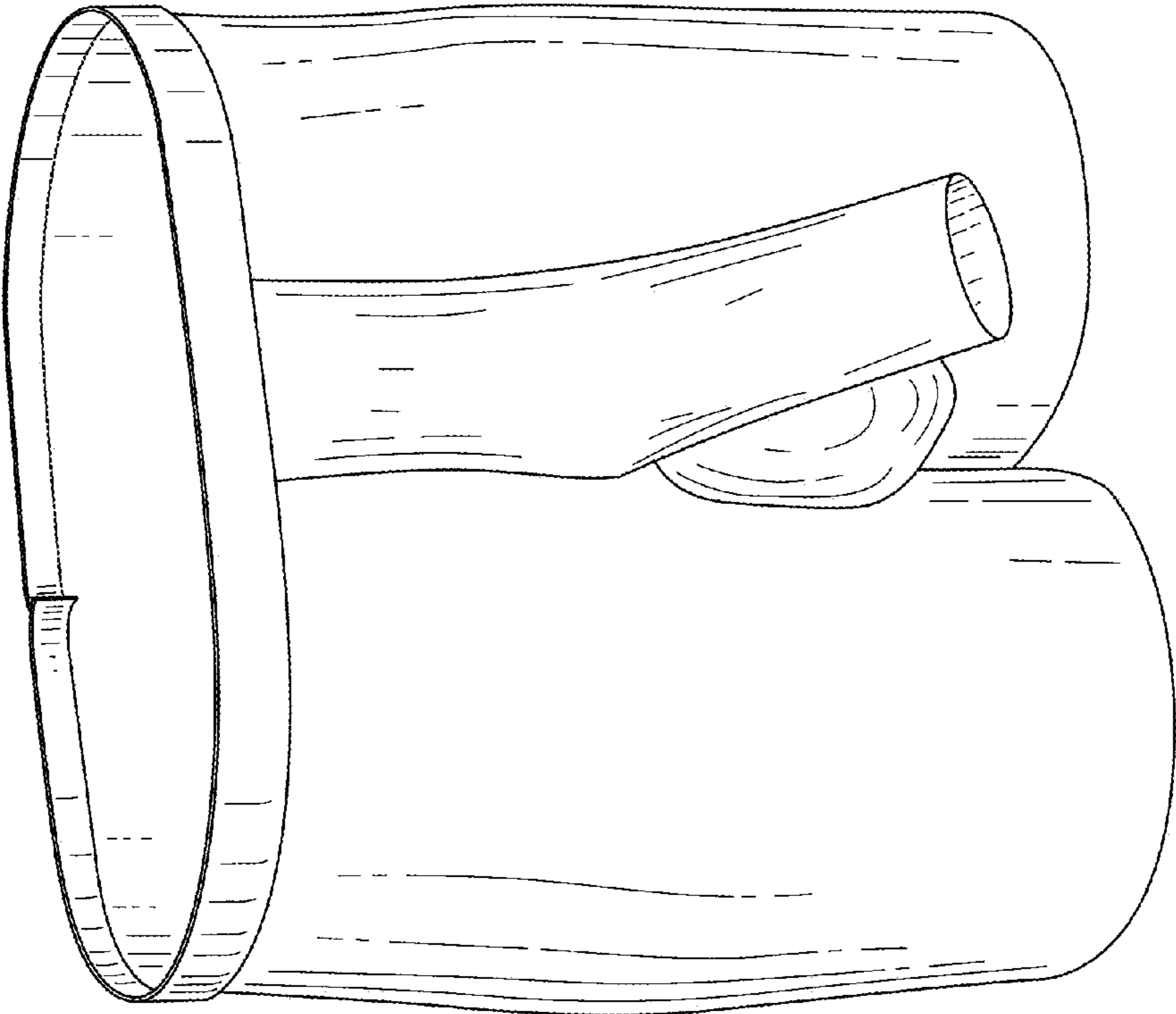

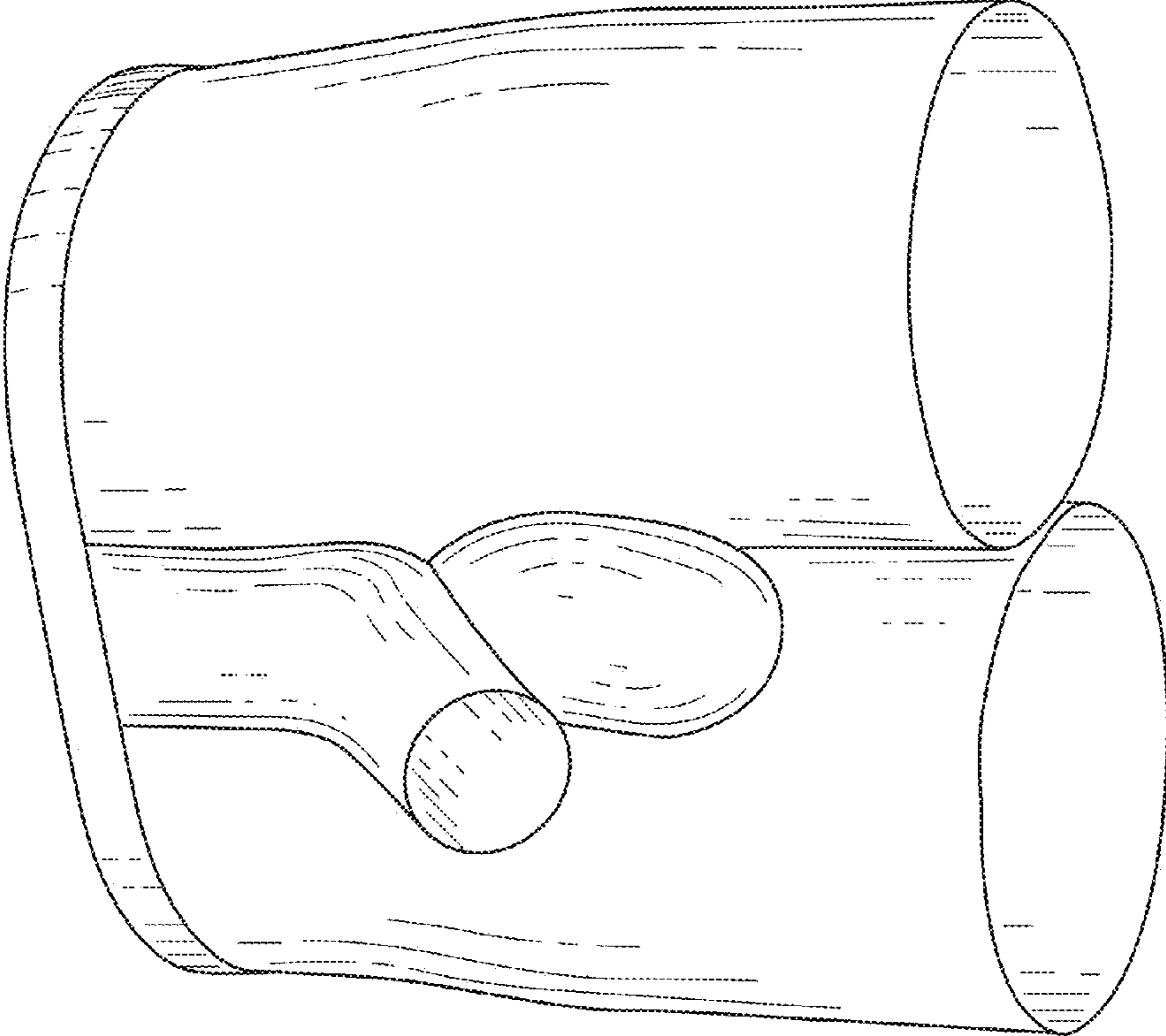

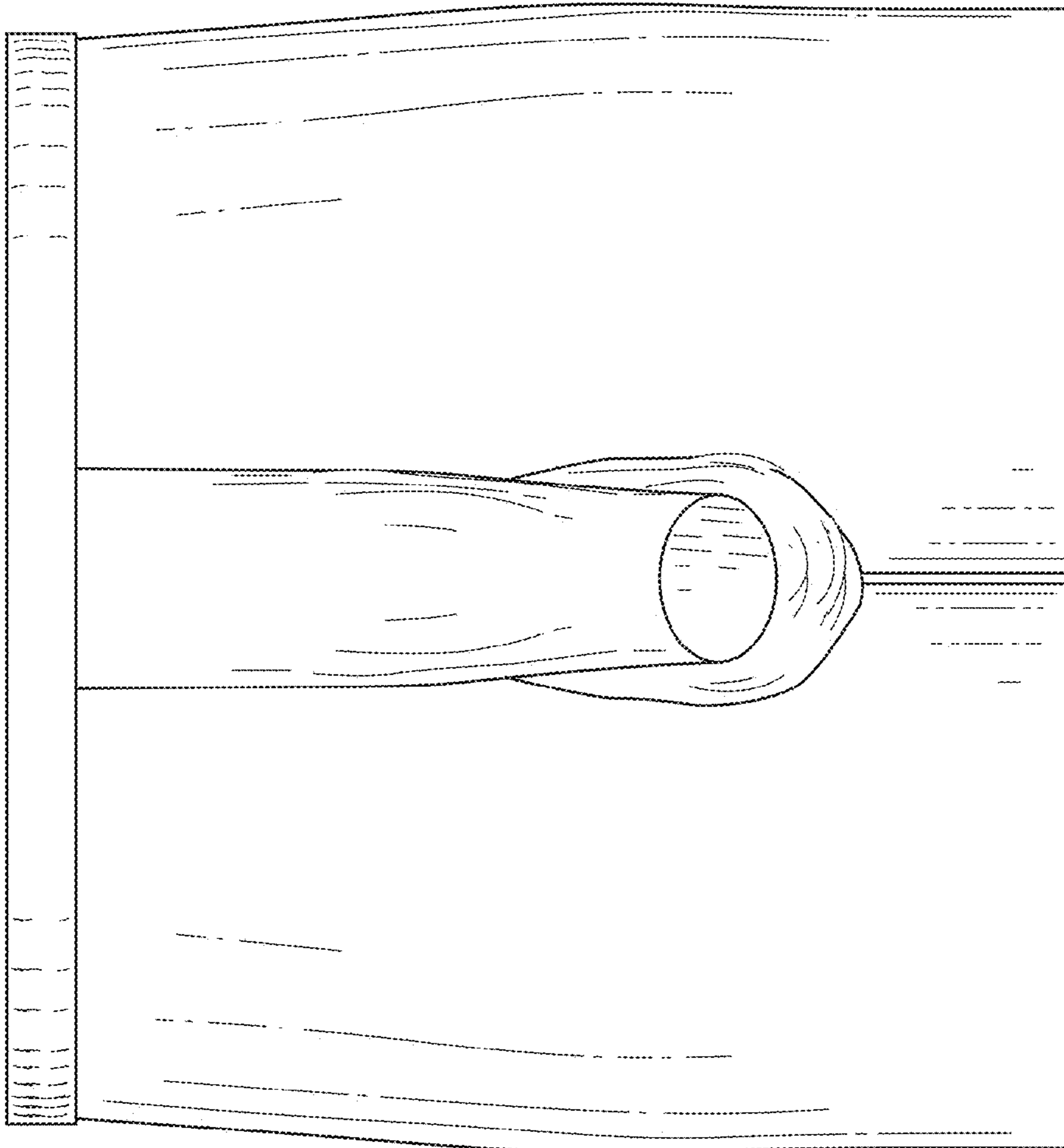

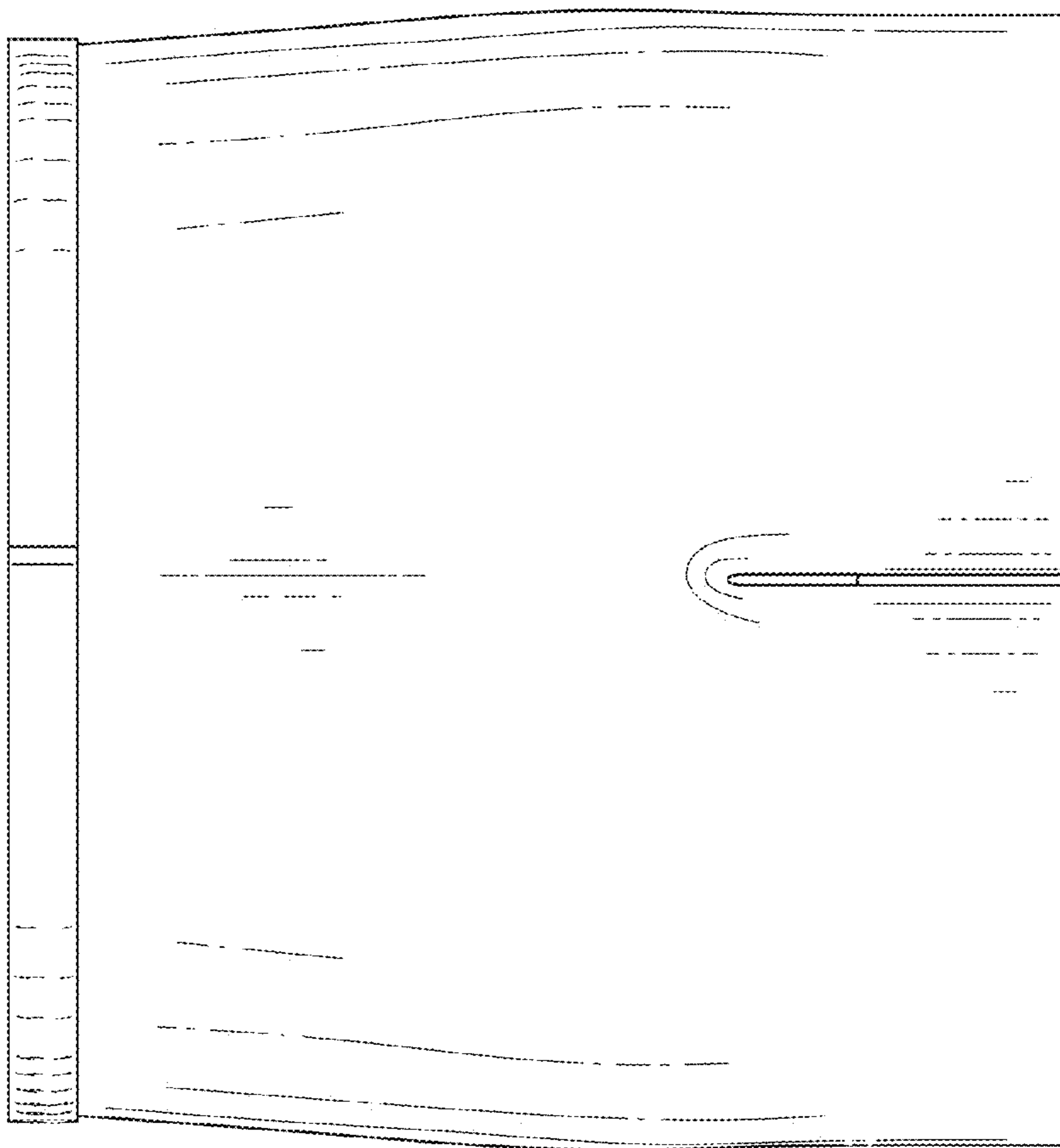

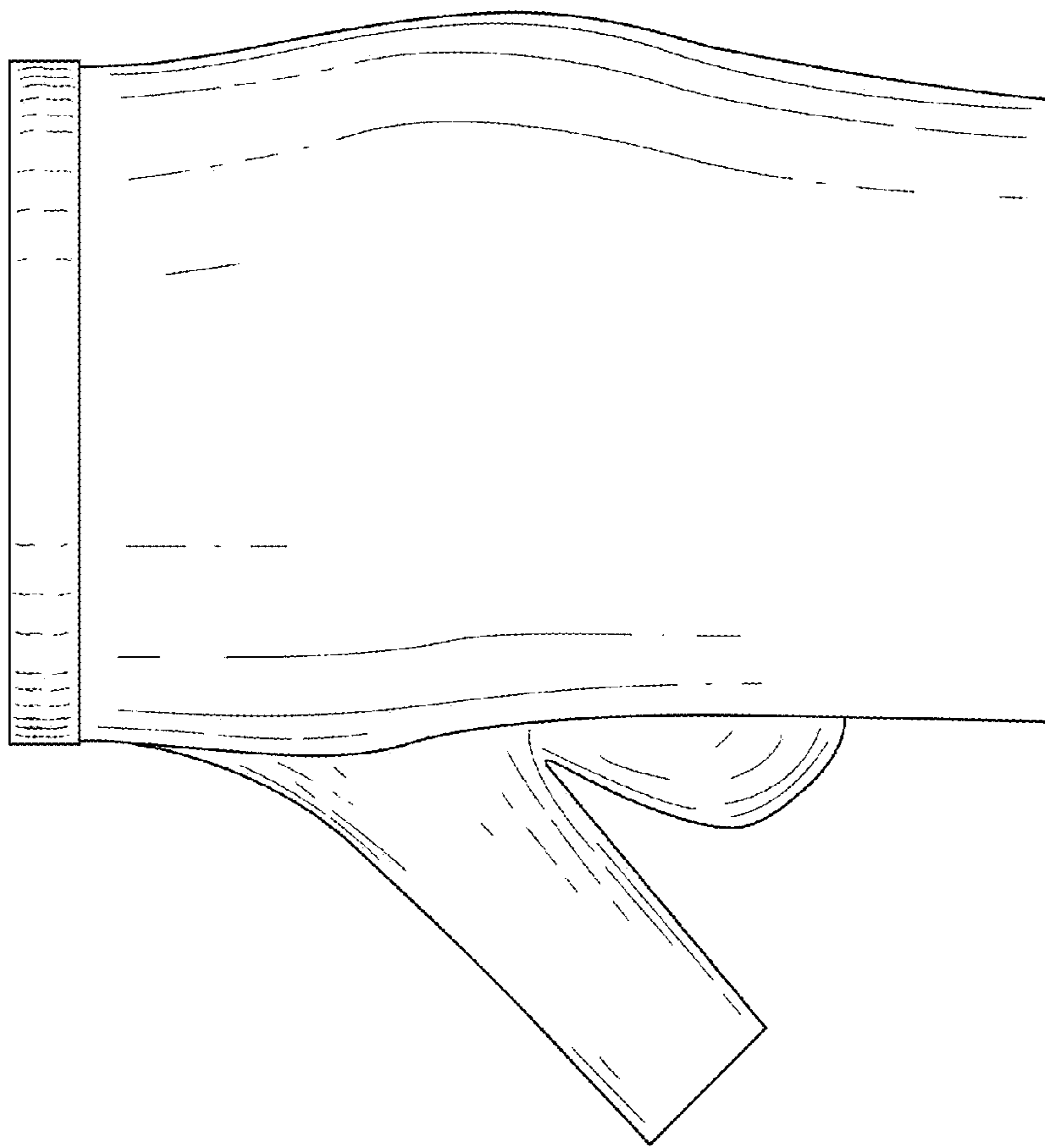

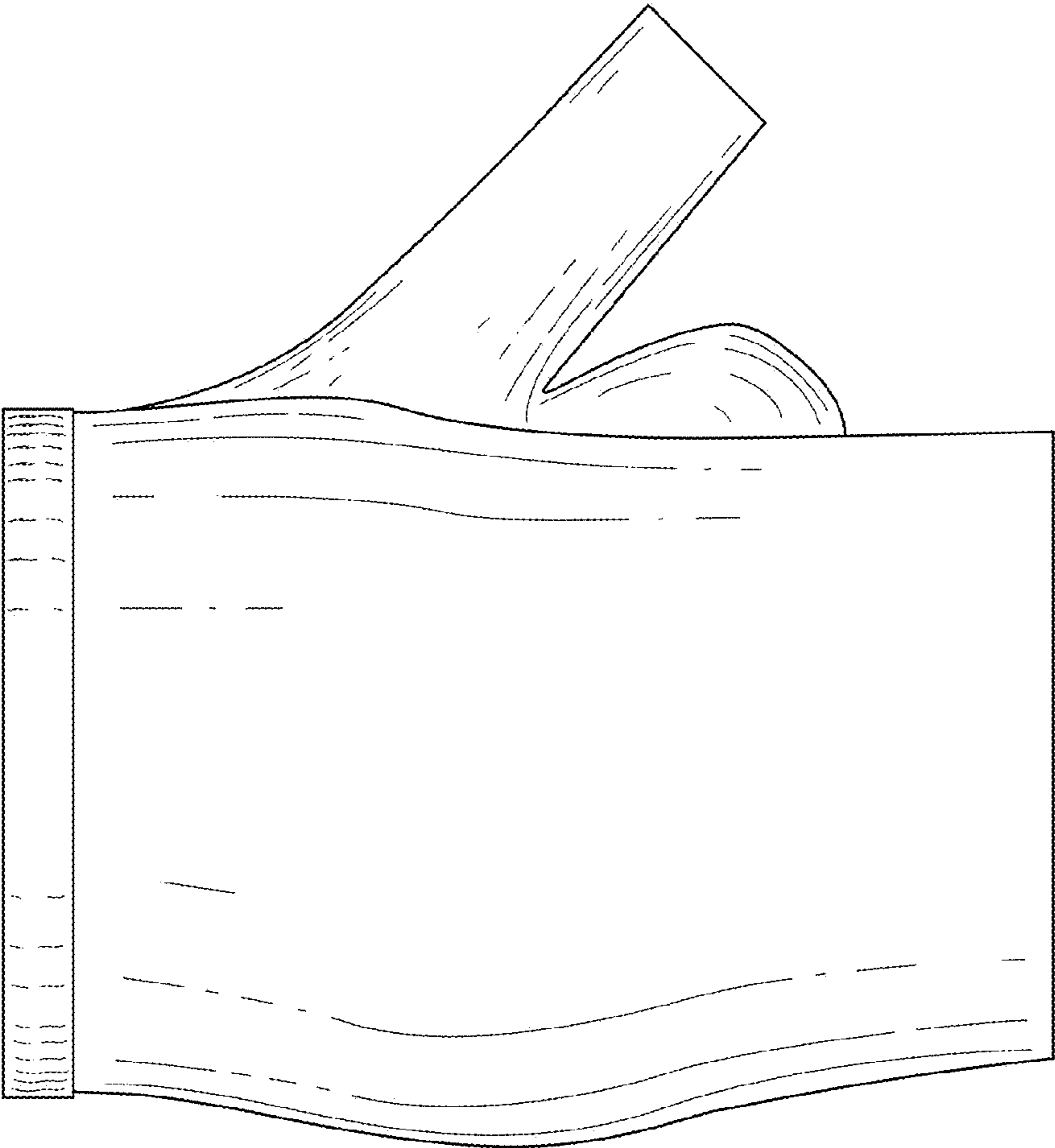

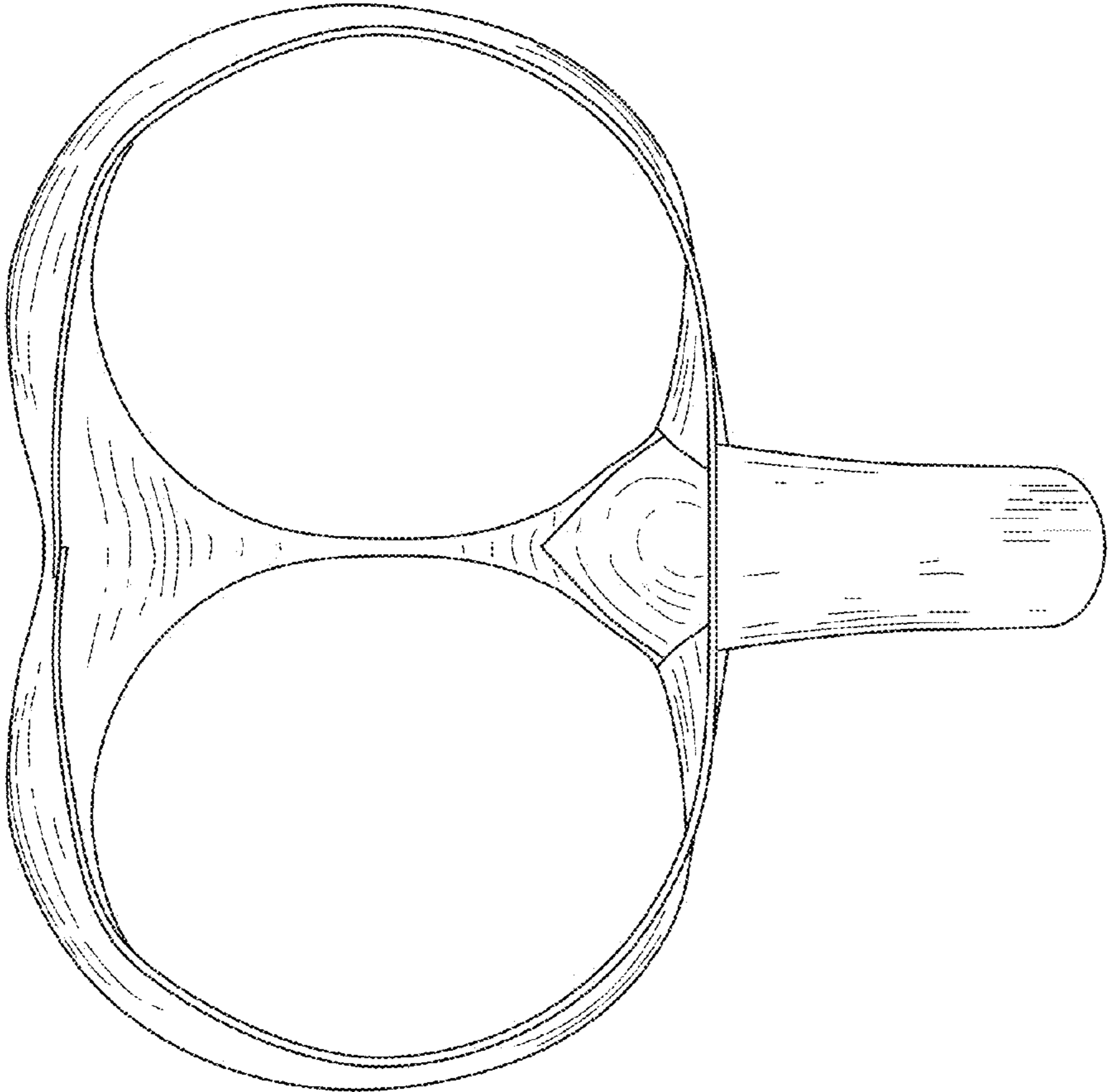

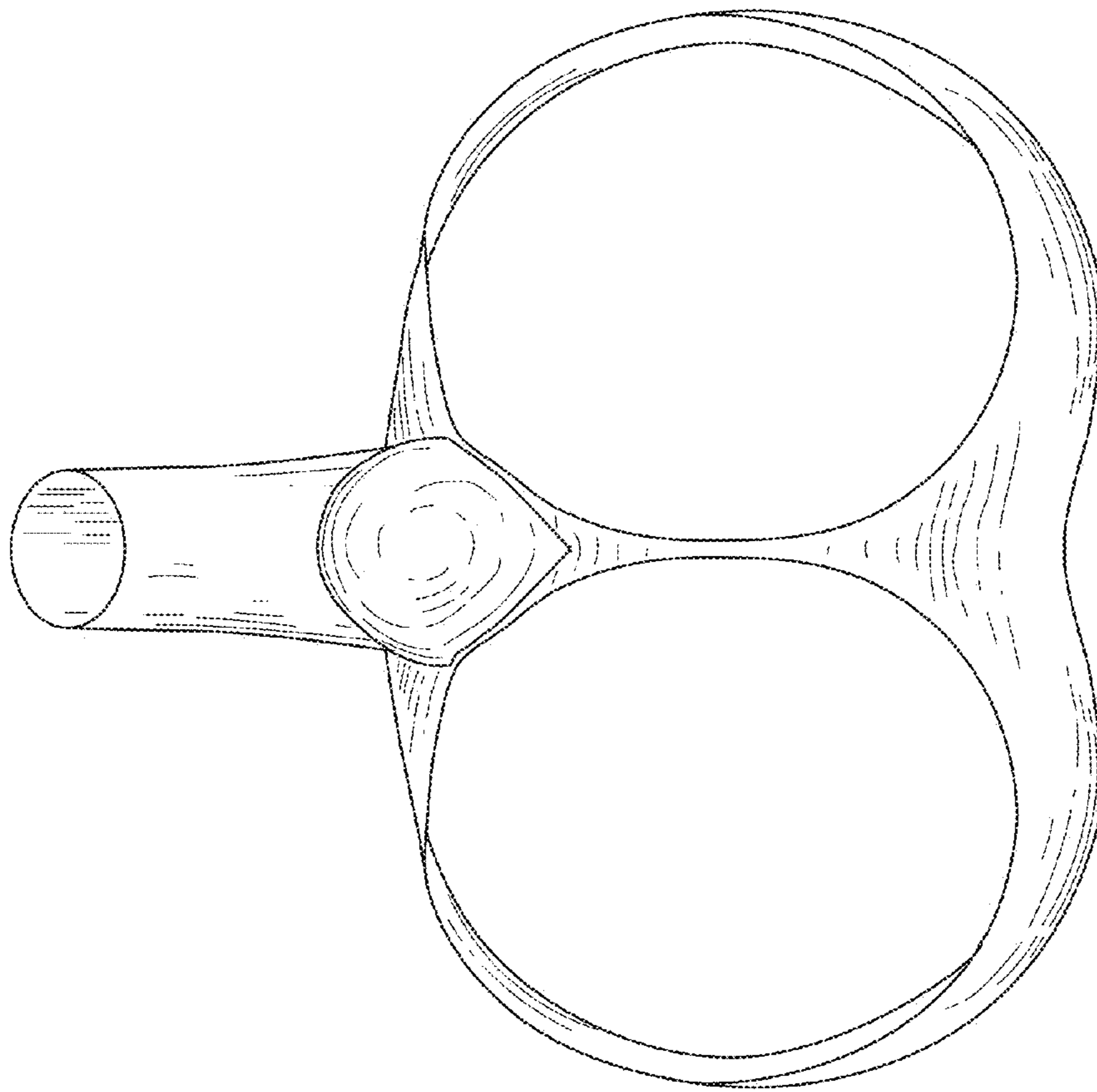
