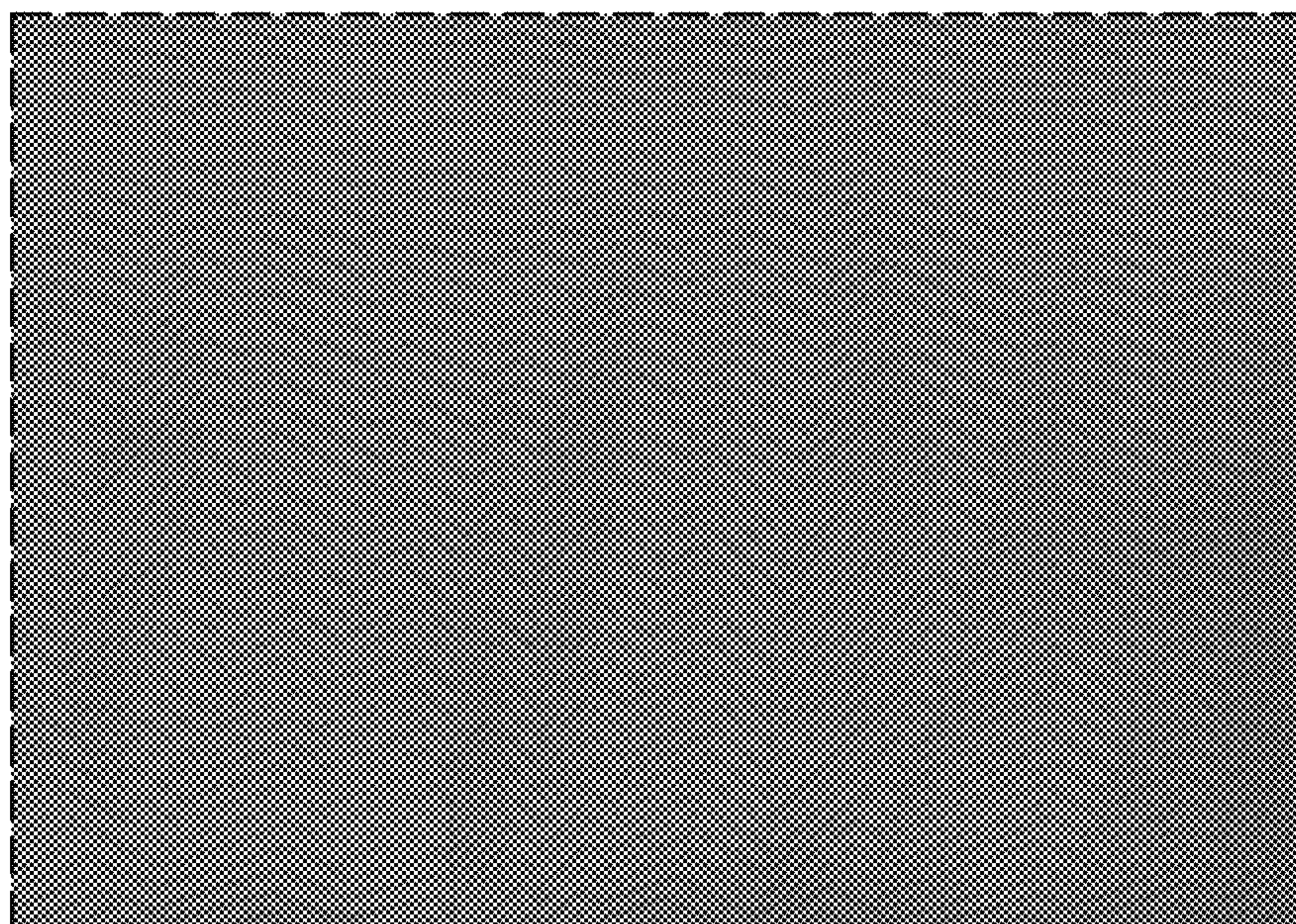
(57) **CLAIM**  
The ornamental design for a leather sheet, as shown and described.

**DESCRIPTION**

FIG. 1 is a surface view of a leather sheet according to our new design;  
FIG. 2 is a reference view of FIG. 1, with dot dash broken lines shown therein to identify the area 3 which the detail view, FIG. 3, is taken; and,  
FIG. 3 is an enlarged detail view of the area 3 circumscribed by dot dash broken lines within FIG. 2.  
The leather sheet is intended to be used for an automobile interior material.  
The broken lines surrounding FIGS. 1 and 2 represent the boundaries of the claim and form no part thereof. The dot dash dot broken lines within FIG. 2 and surrounding FIG. 3 represent the boundaries of the detail area and form no part no part of the claimed design.  
The rear of the leather sheet is not included in the claim.

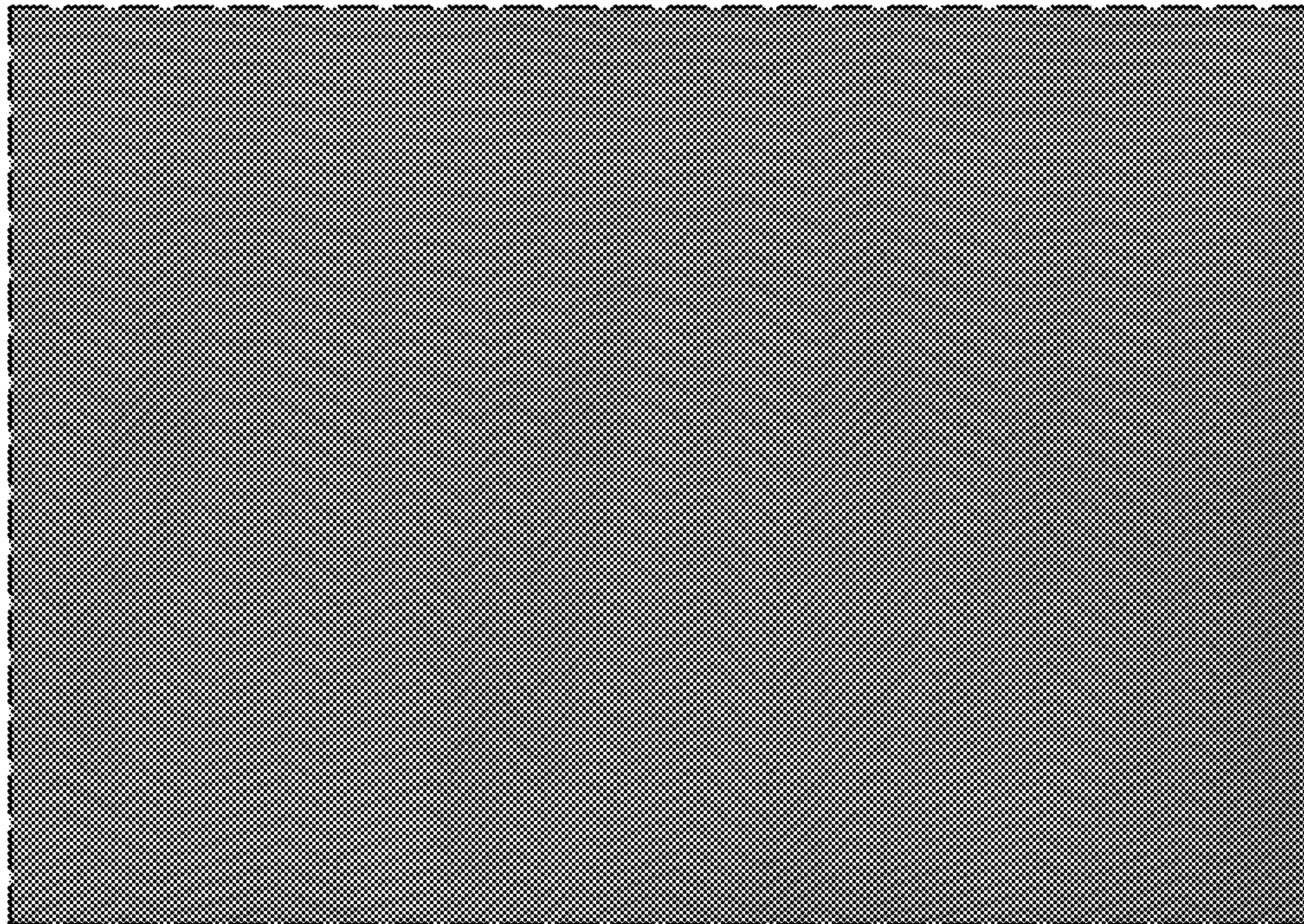
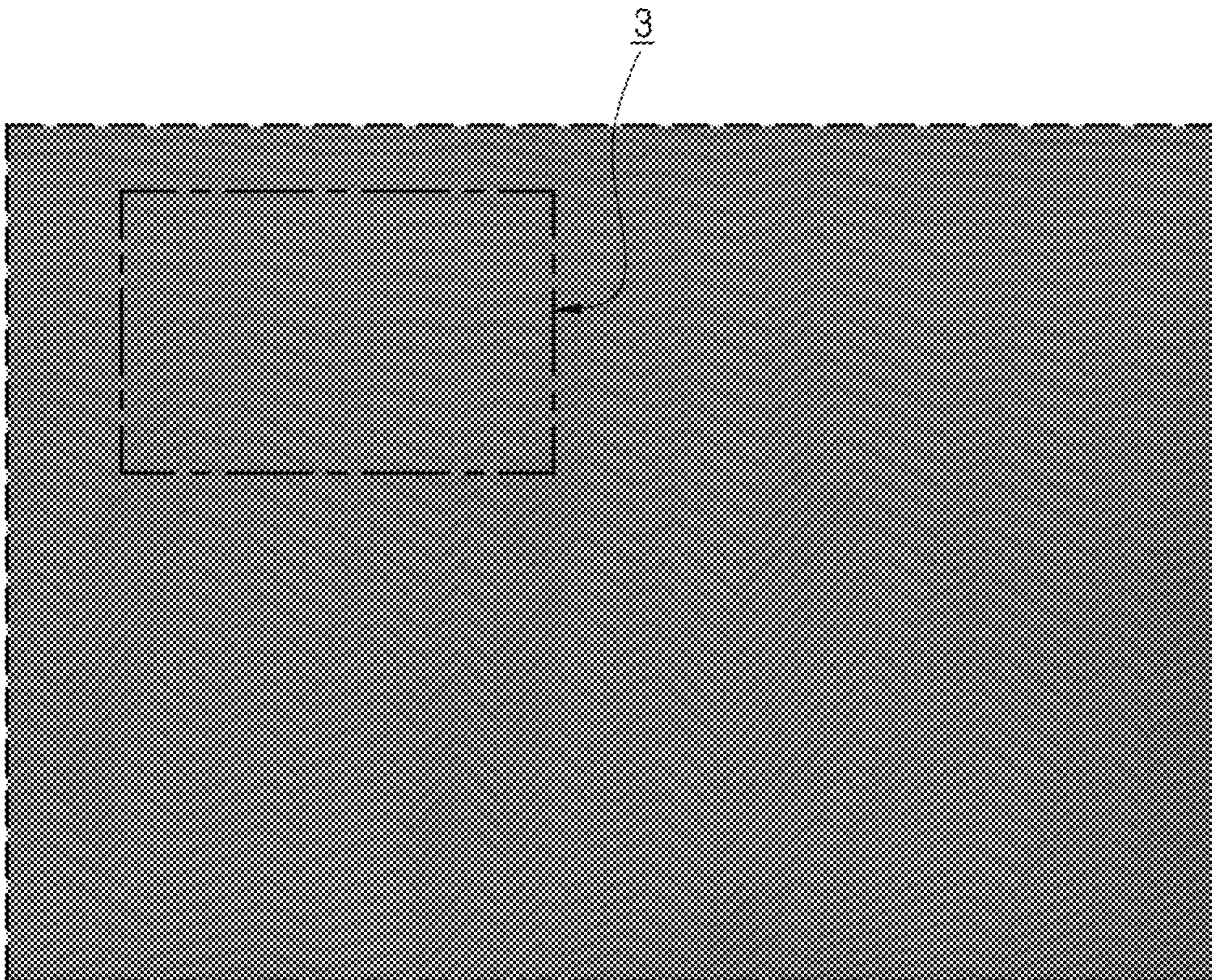
