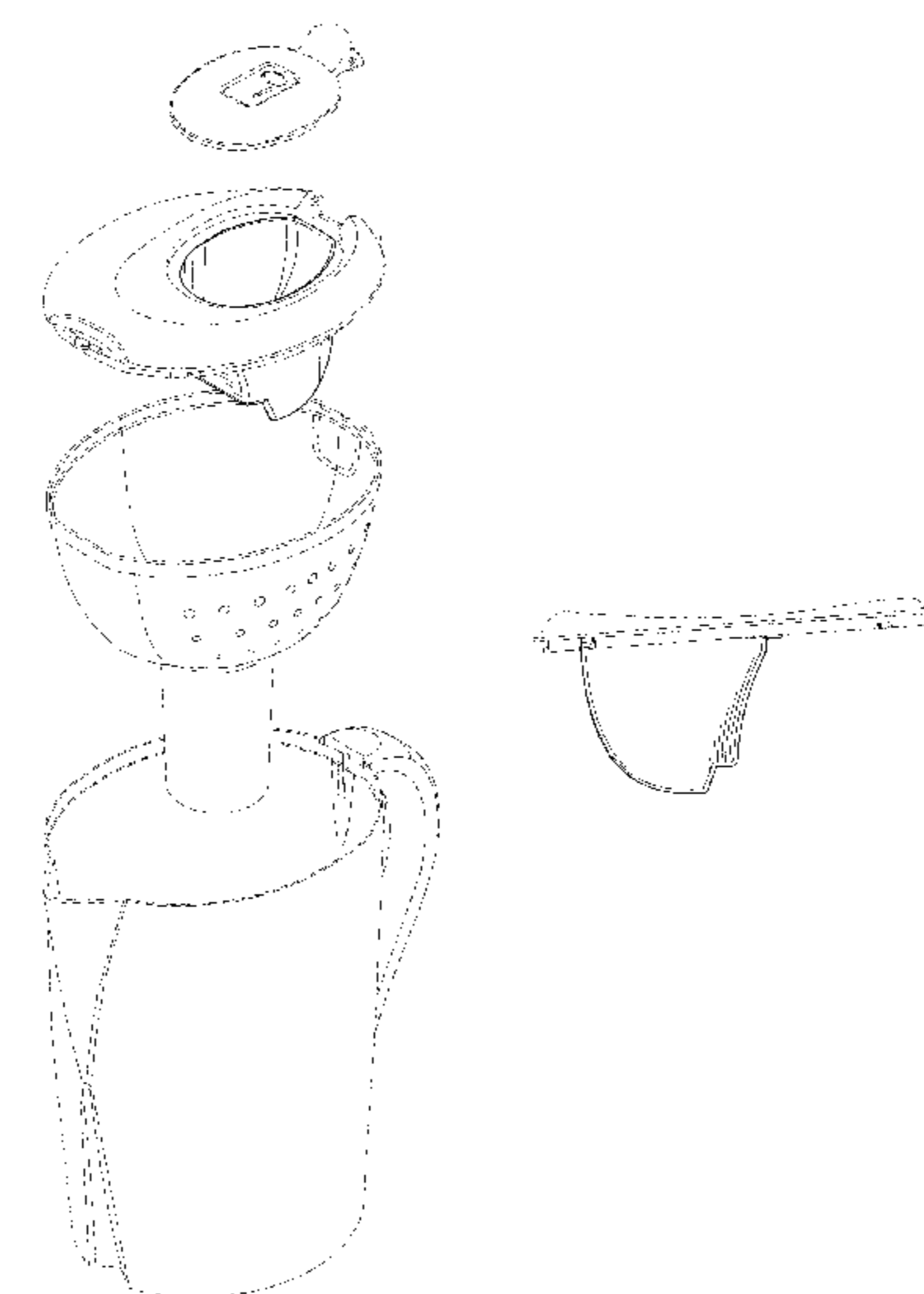

The ornamental design for a portion of a water pitcher lid, as shown and described.

DESCRIPTION

FIG. 1 is an exploded perspective view of a portion of a water pitcher lid and showing our new design; FIG. 2 is a front perspective view thereof; FIG. 3 is a top plan view of FIG. 2; FIG. 4 is bottom plan view of FIG. 2; FIG. 5 is a left side elevational view of FIG. 2; FIG. 6 is a right side elevational view of FIG. 2; FIG. 7 is back view of FIG. 2; and, FIG. 8 is a front view of FIG. 2. 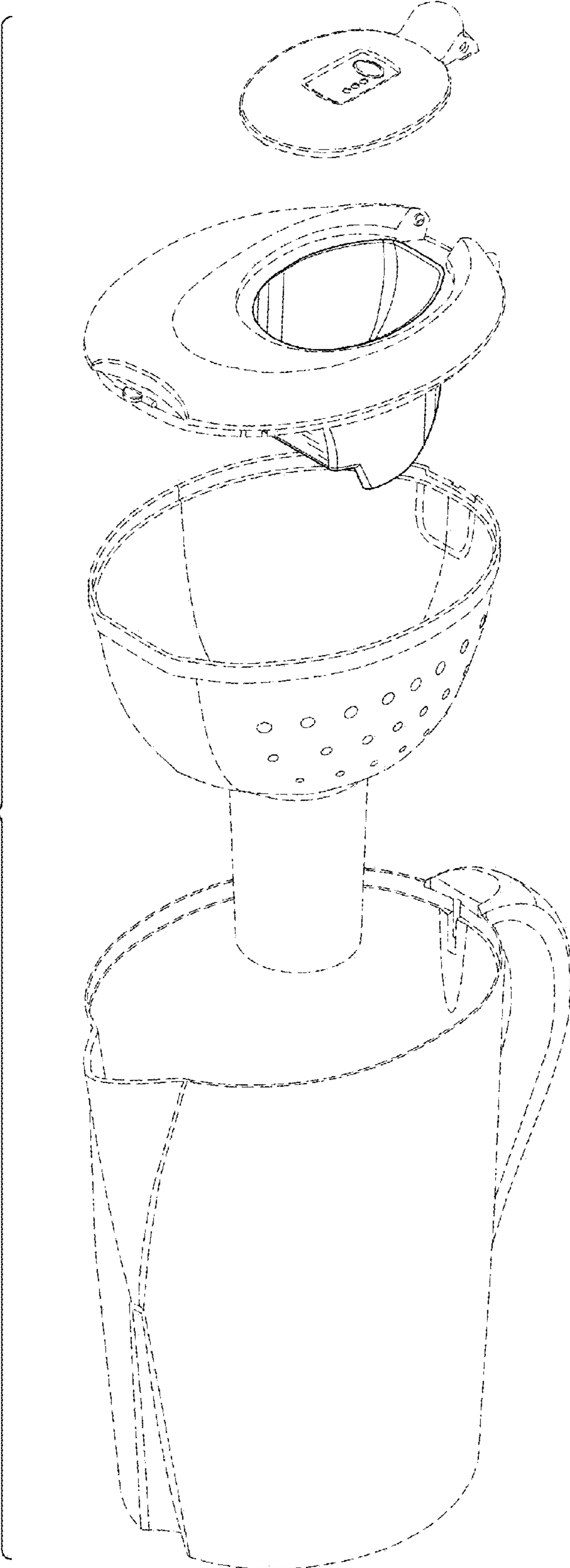

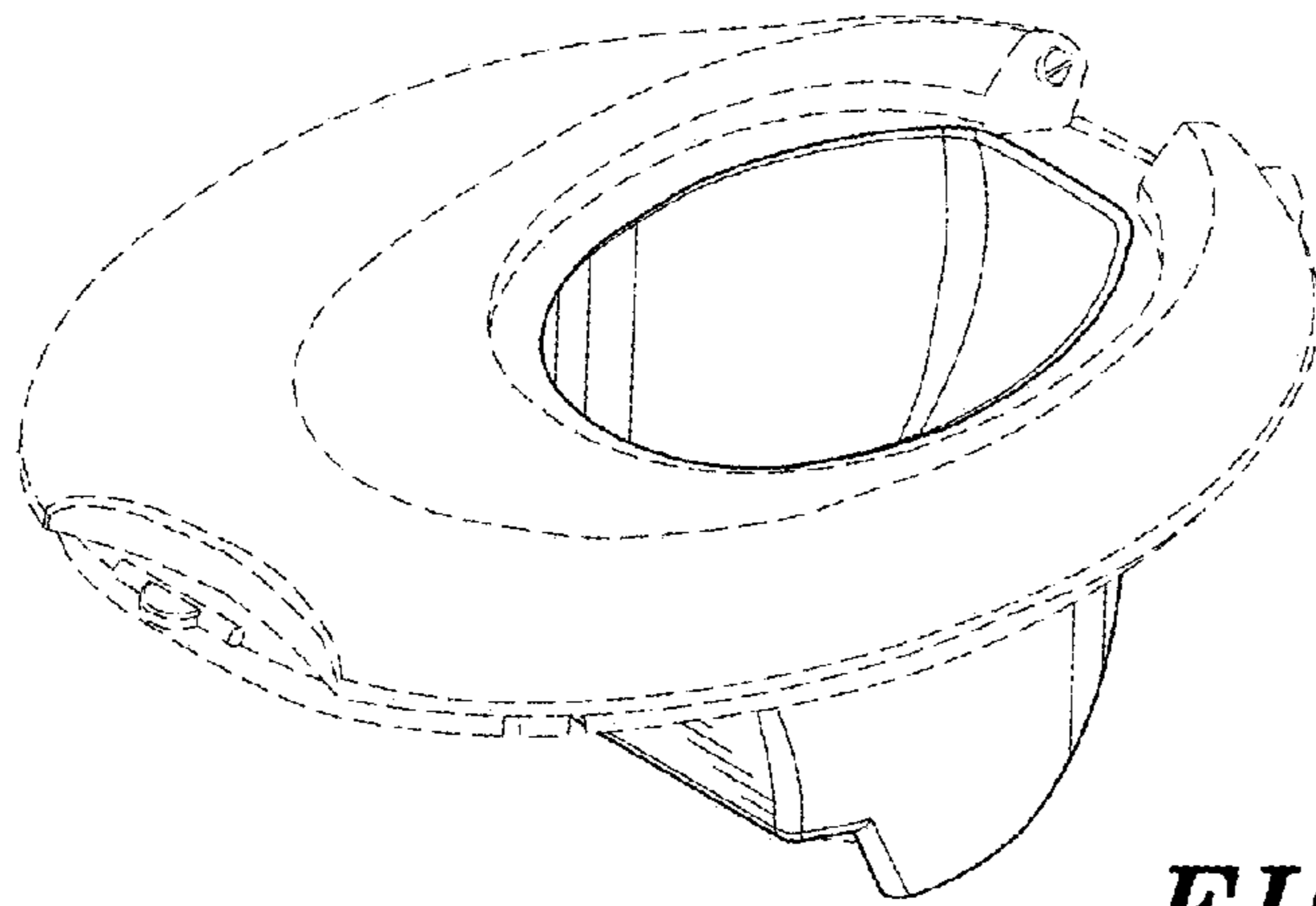

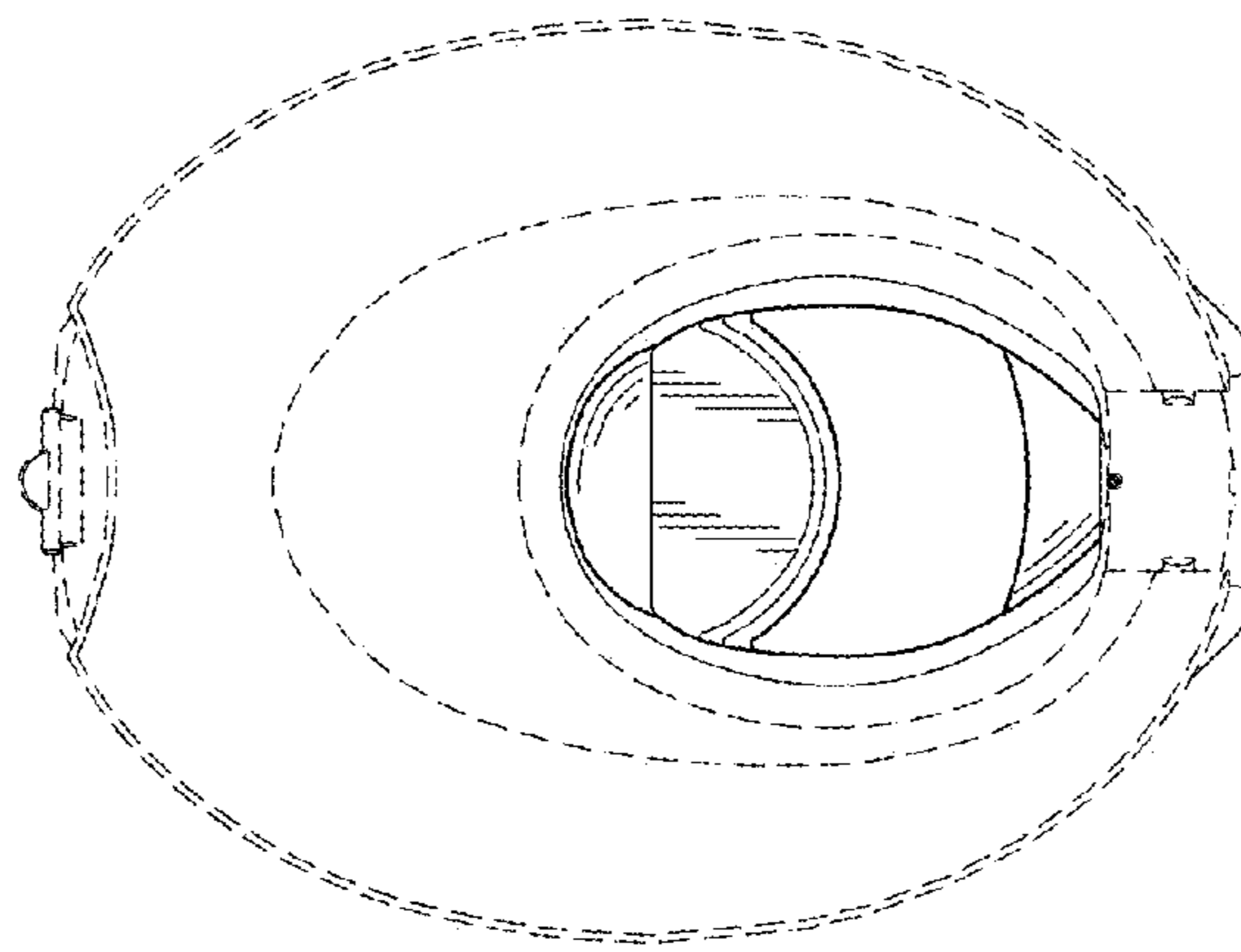

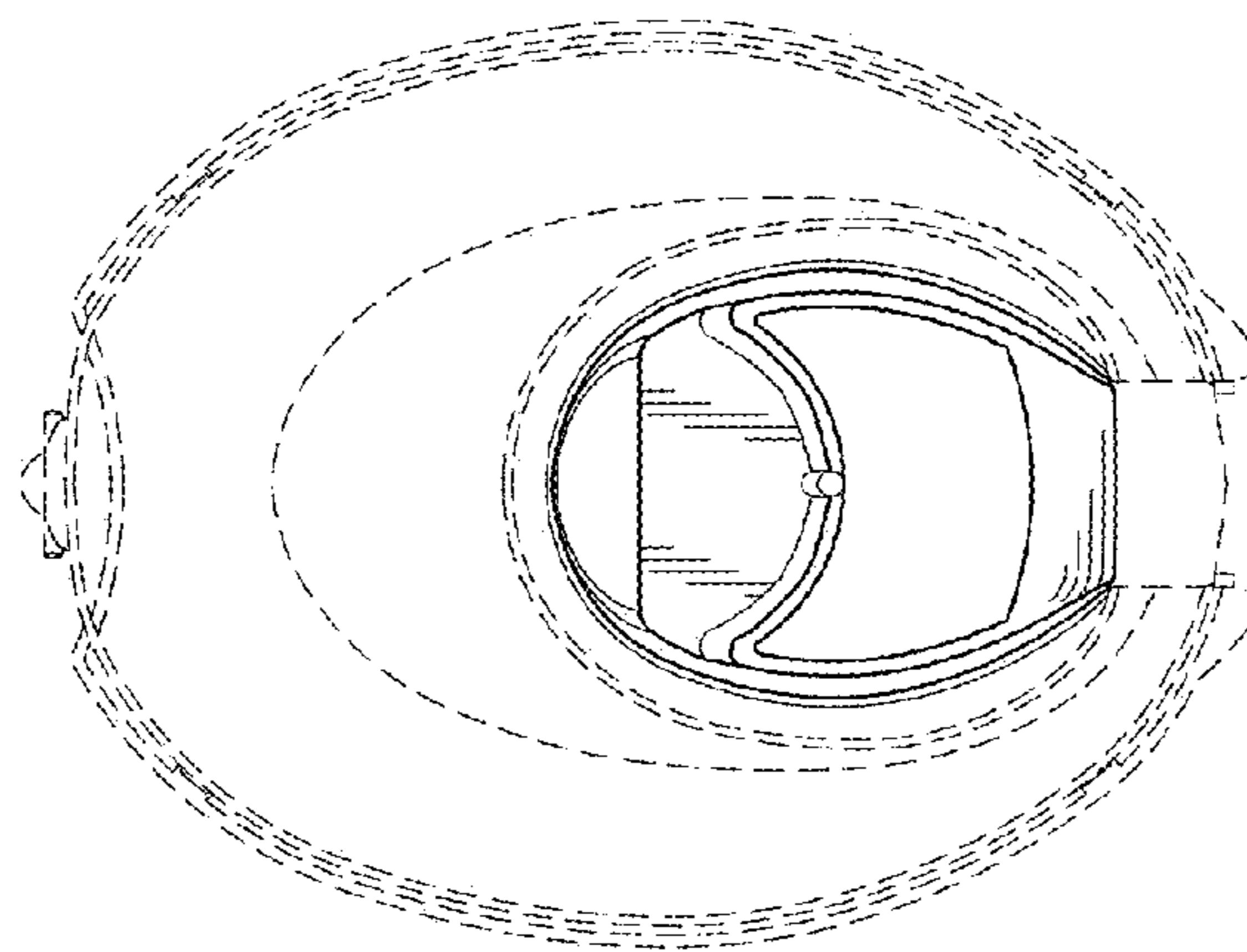

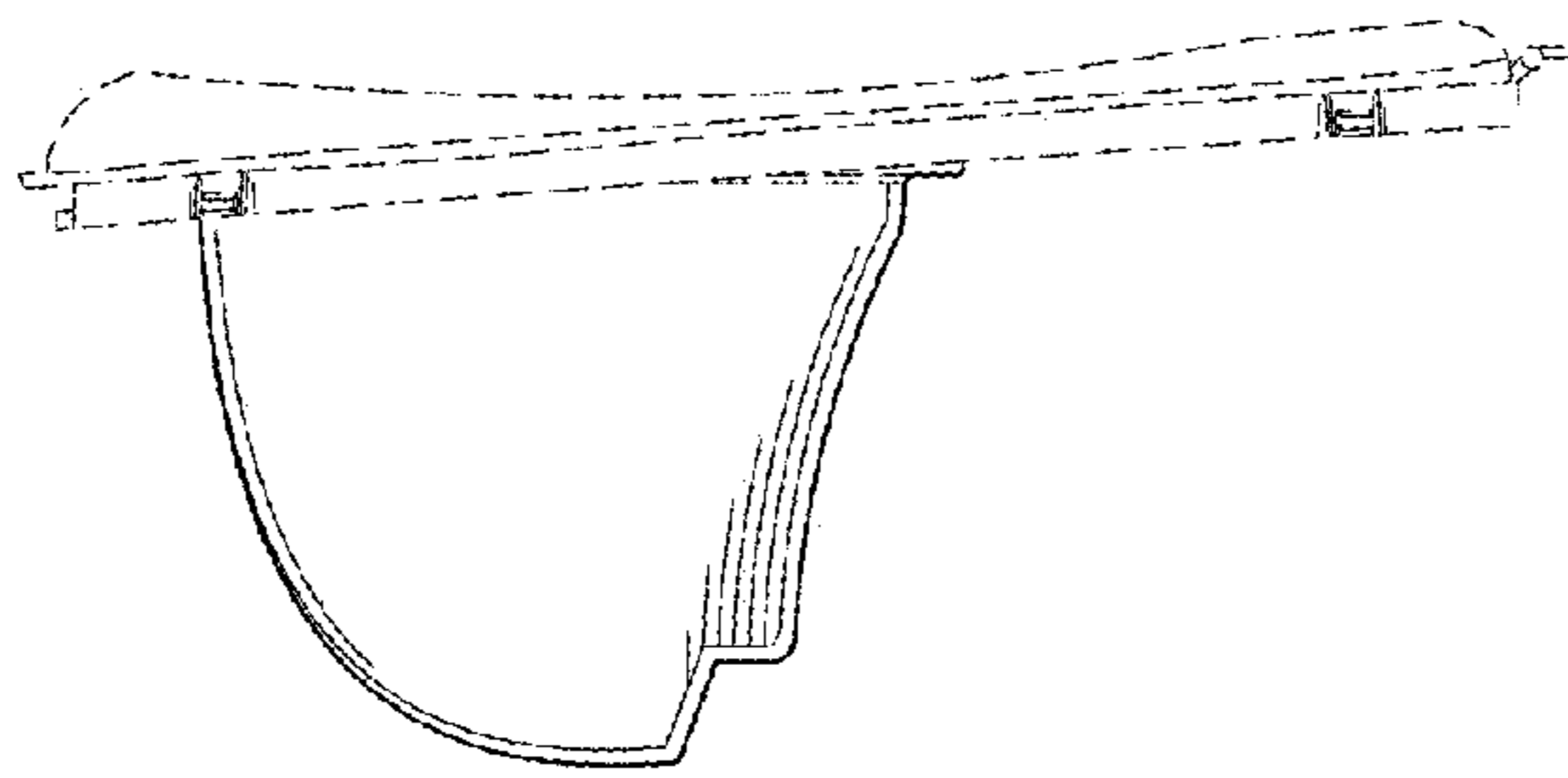

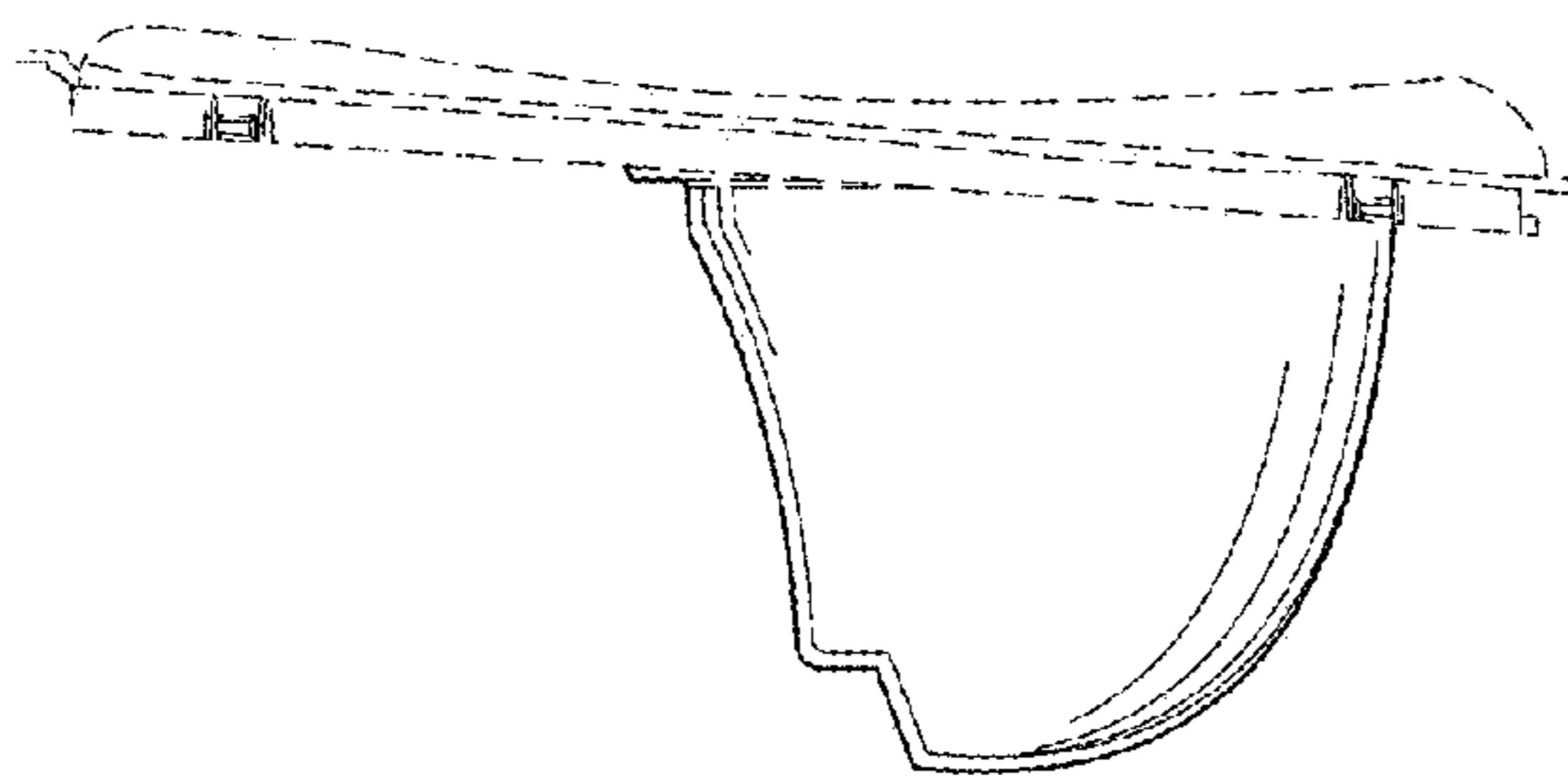

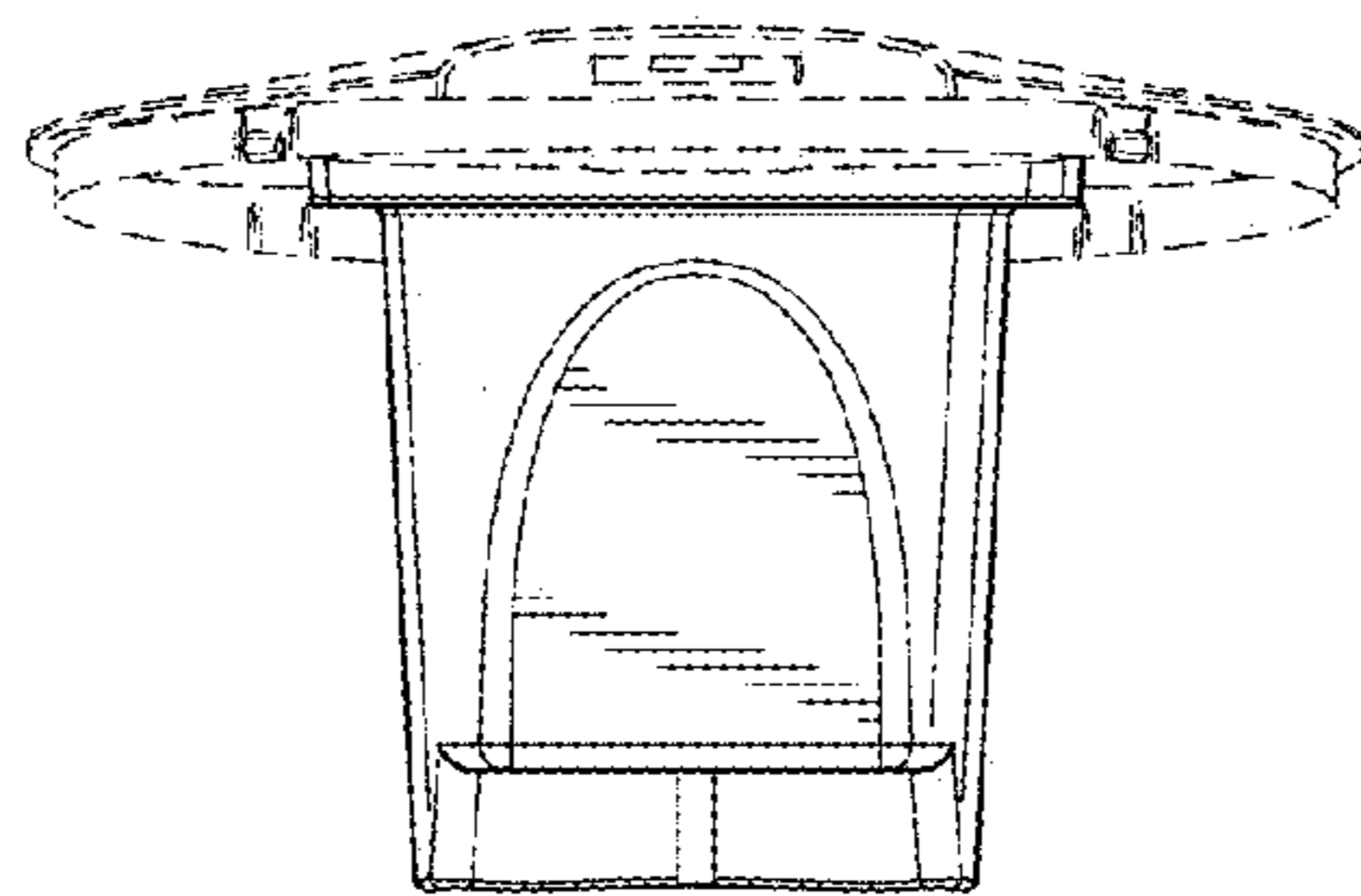

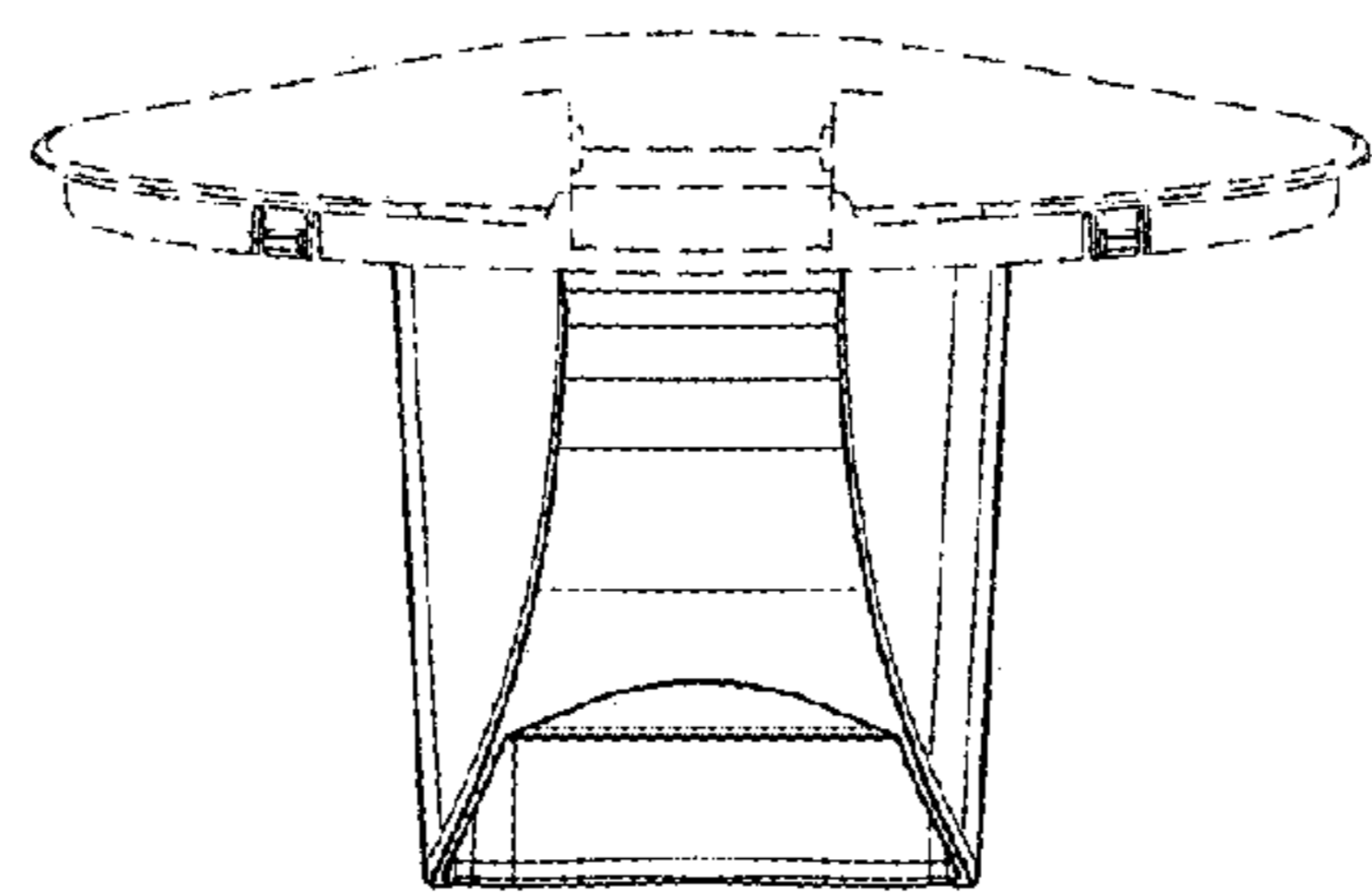
