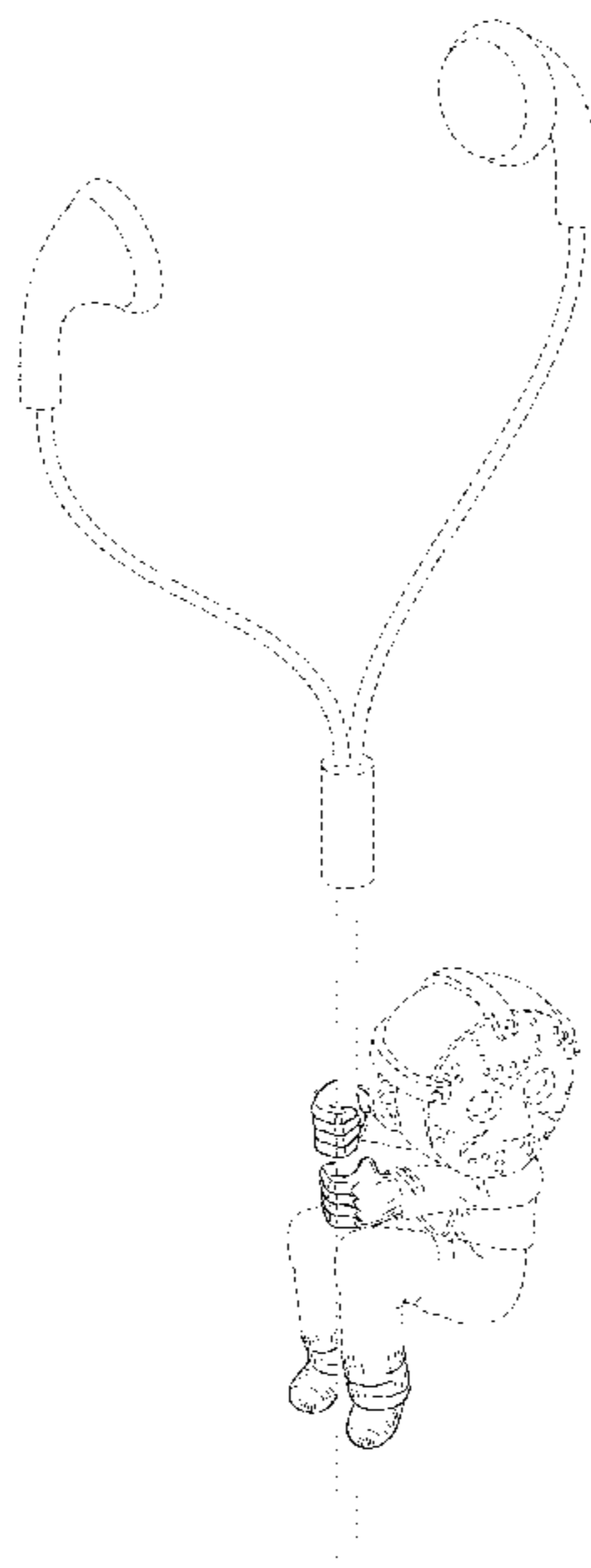
(57) **CLAIM**
The ornamental design for a cable accessory, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cable accessory as shown and described;
FIG. 2 is a front view of the cable accessory of FIG. 1;
FIG. 3 is a back view of the cable accessory of FIG. 1;
FIG. 4 is a right view of the cable accessory of FIG. 1;
FIG. 5 is a left view of the cable accessory of FIG. 1;

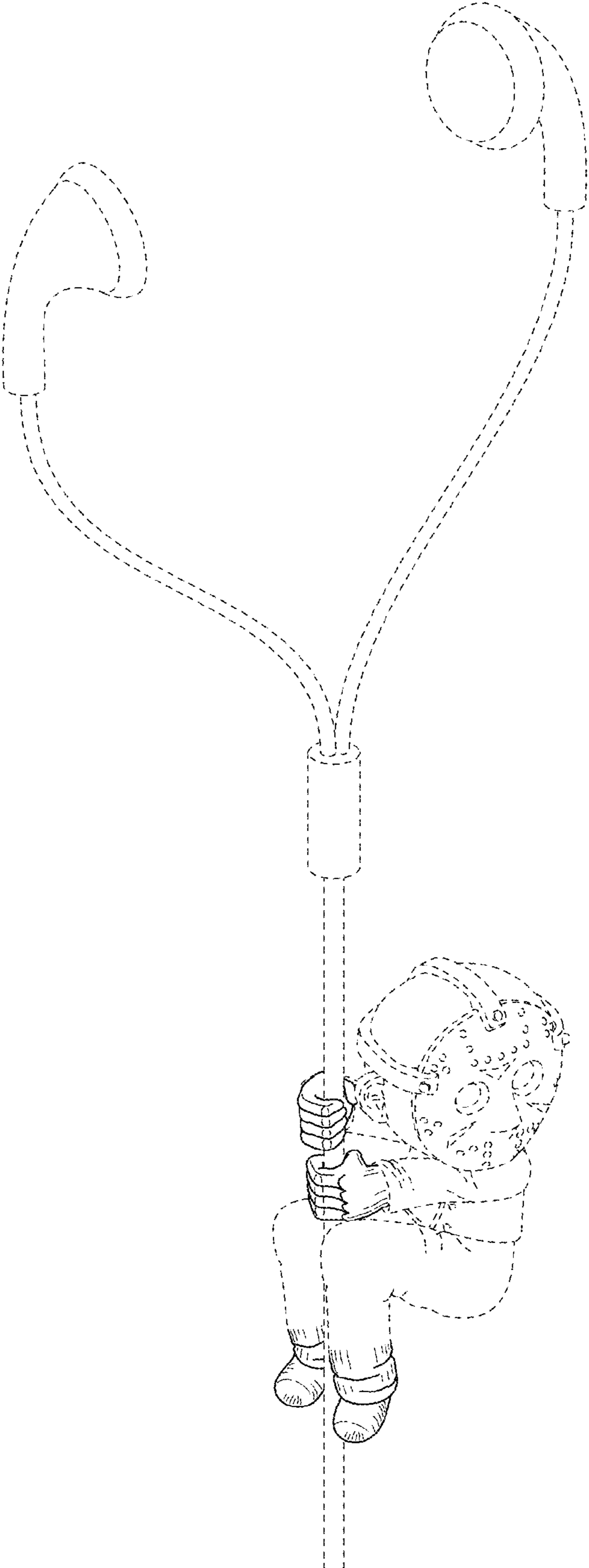

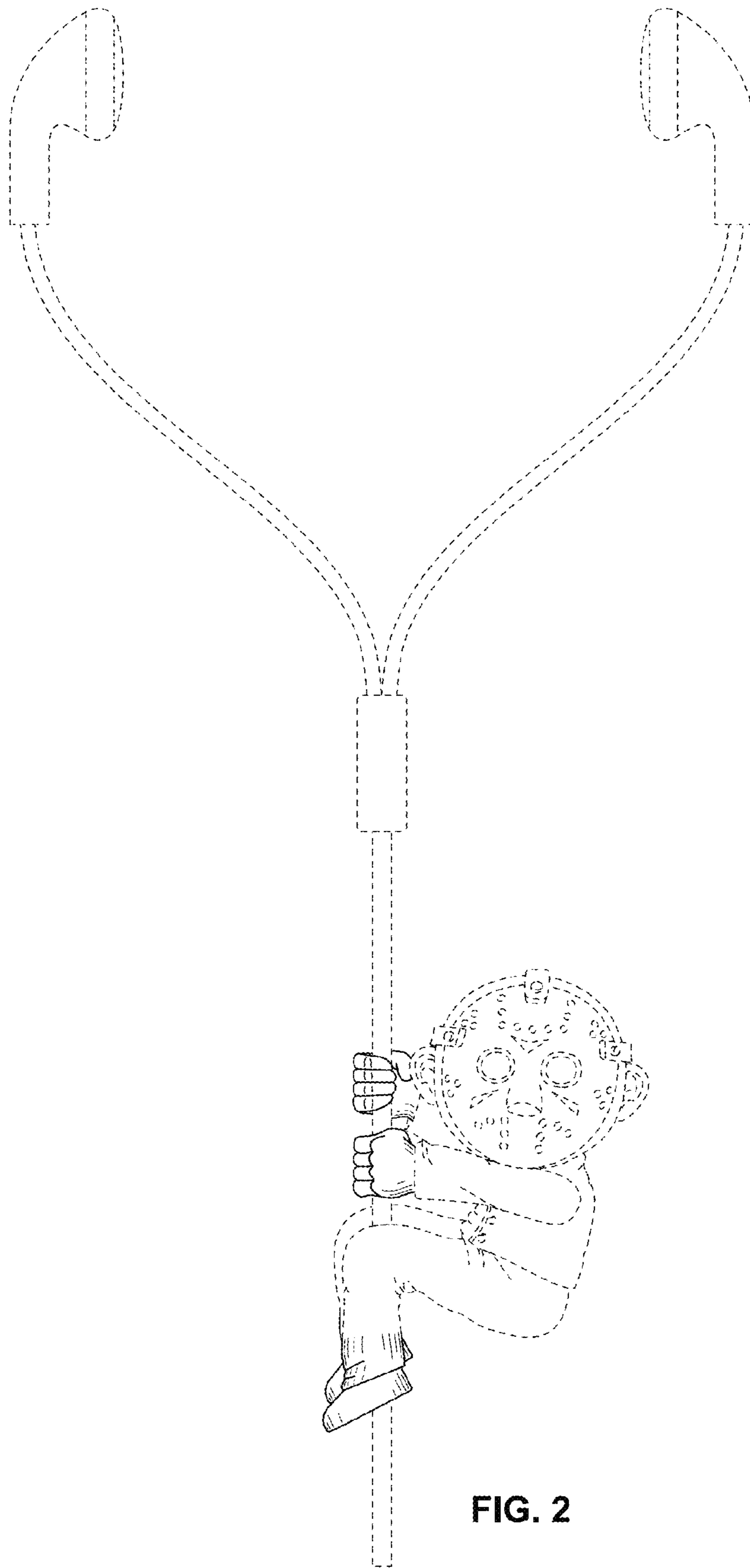

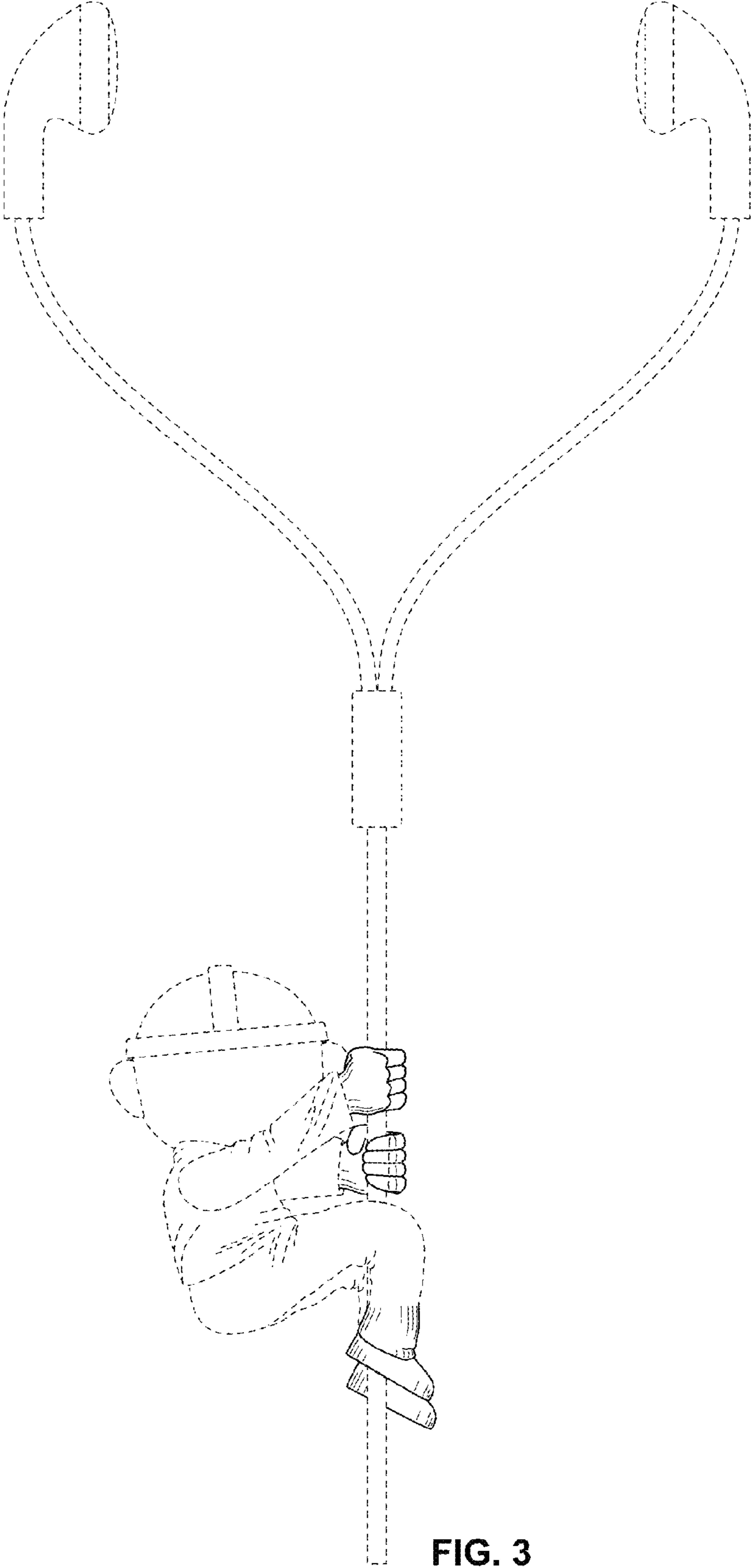

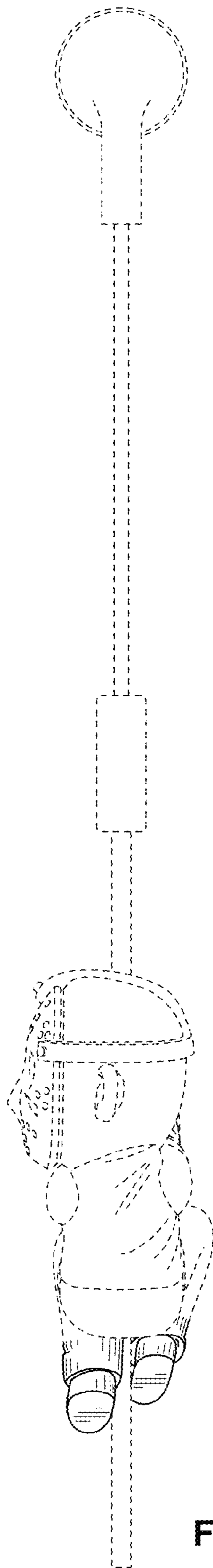

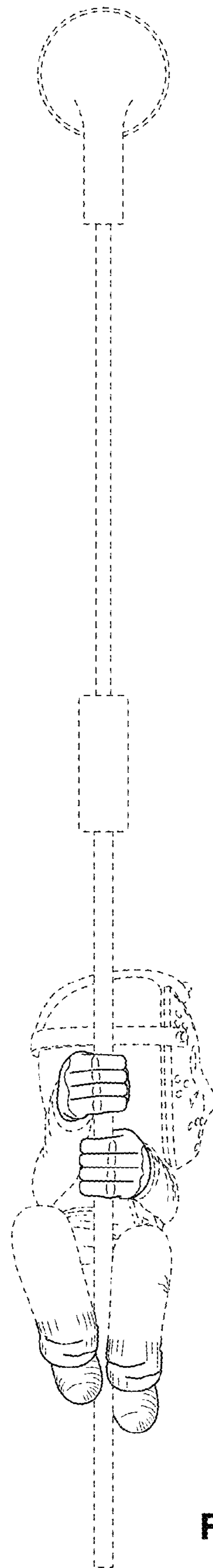

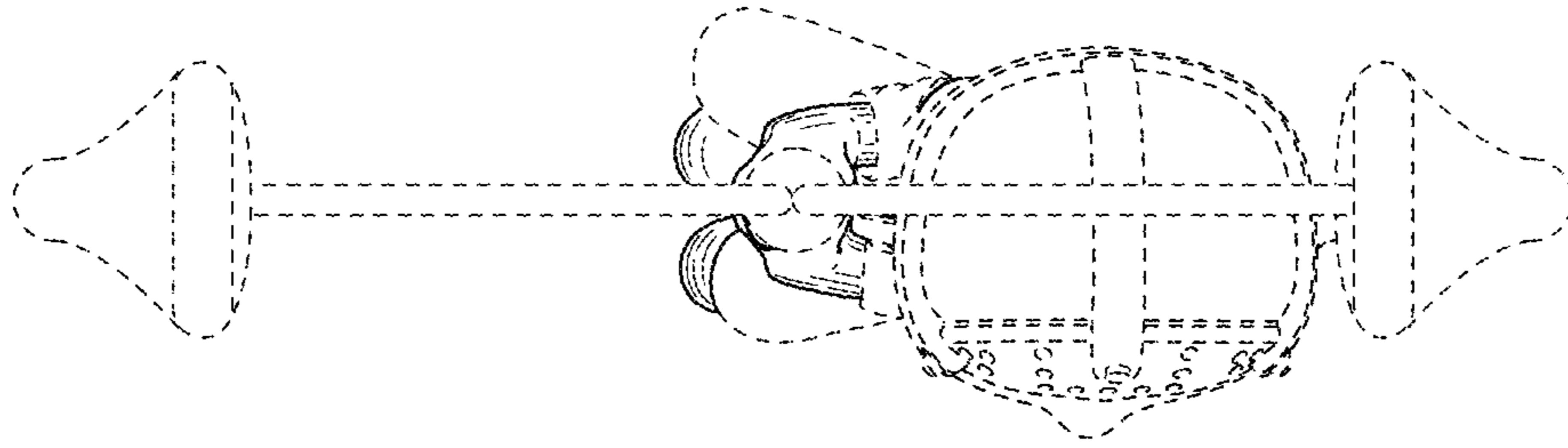

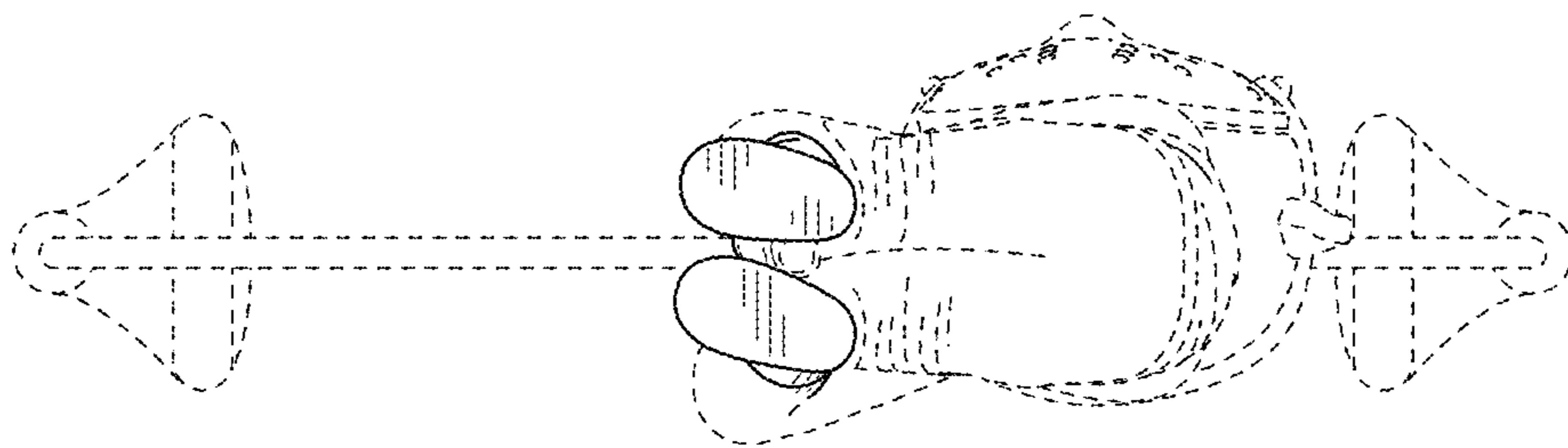
