The ornamental design for a display screen or portion thereof including graphical user interface for access control, as shown and described.

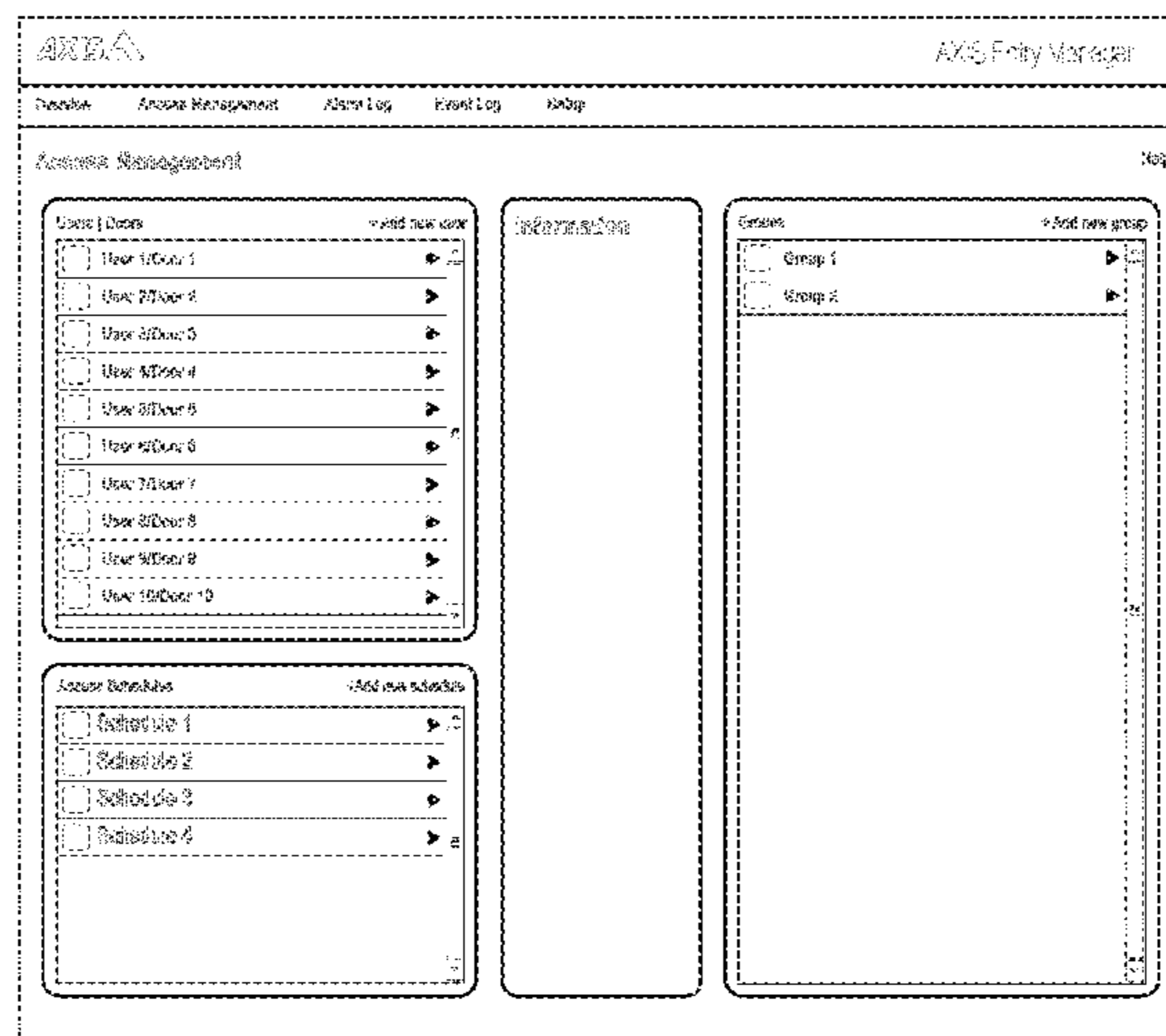
DESCRIPTION

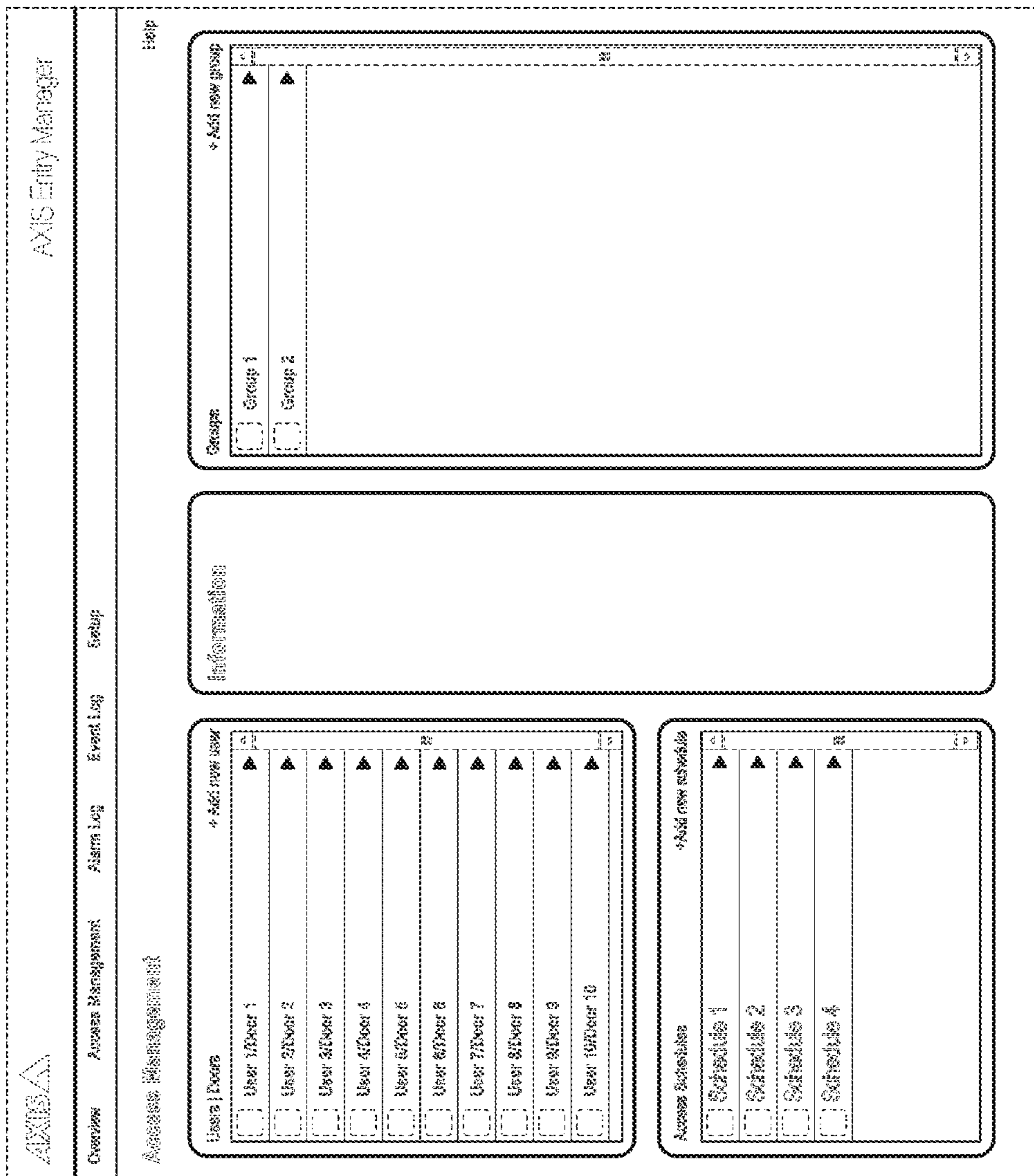

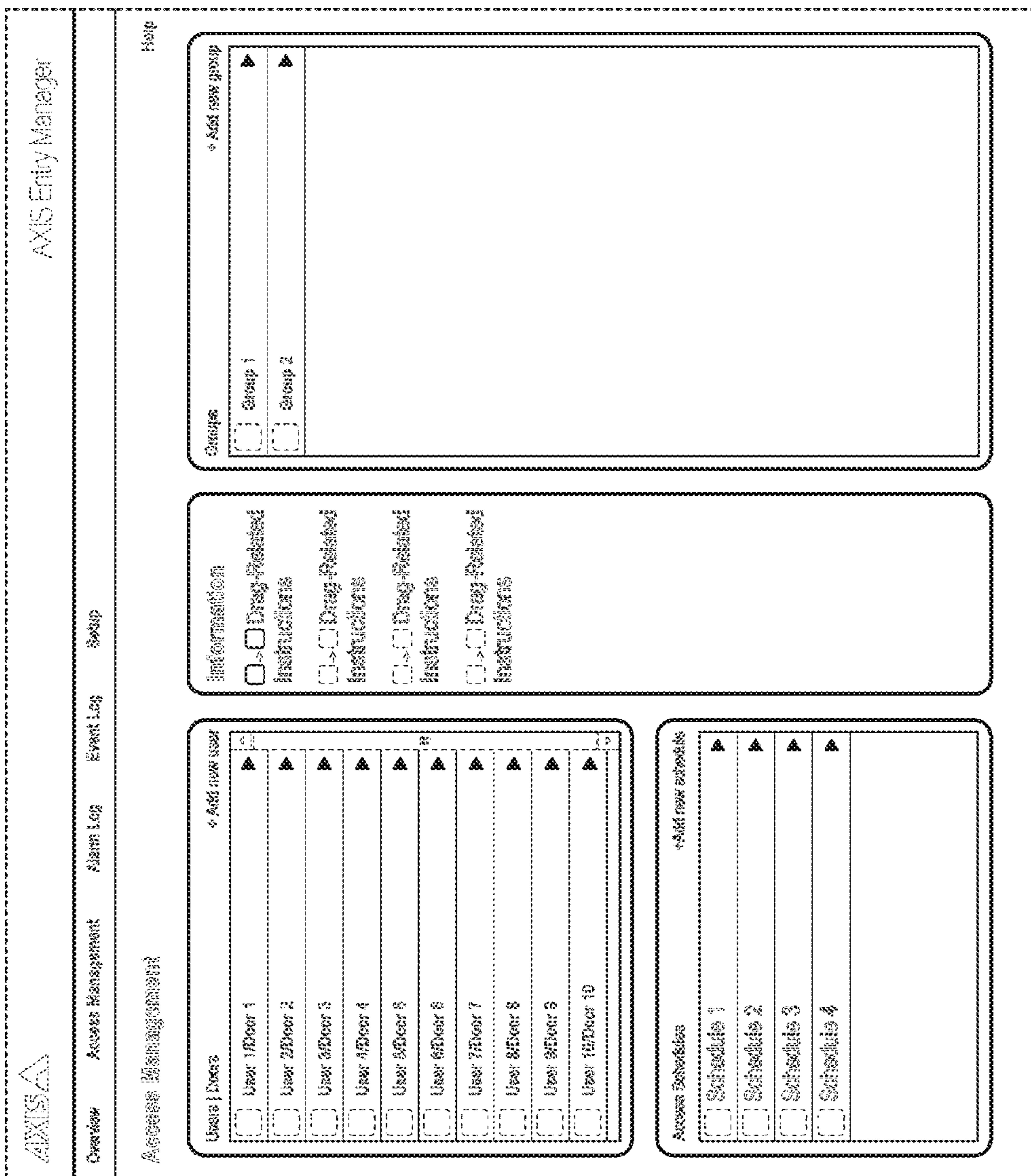
