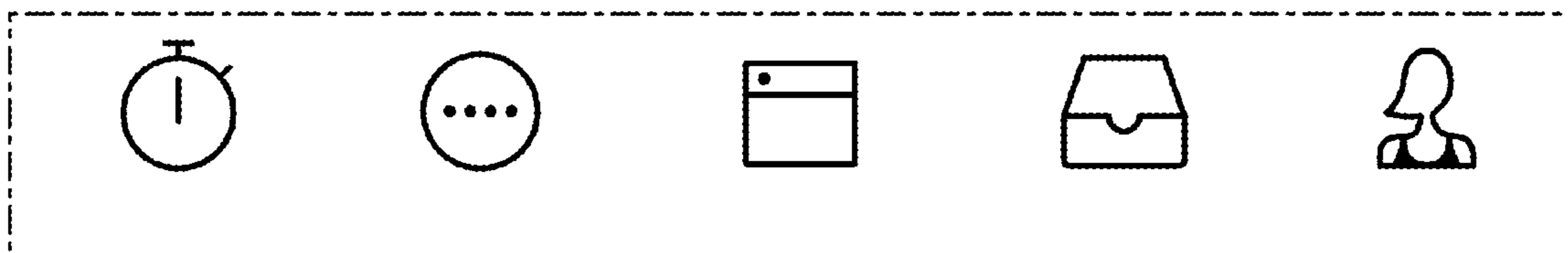

(57) **CLAIM**
The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is front view of a display screen with graphical user interface showing our new design;
FIG. 2 is a front view of the display screen with graphical user interface of FIG. 1, shown on a handset.
FIG. 3 is a front perspective view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a bottom view thereof.
The uneven-length broken line in the figures illustrate a boundary of the graphical user interface. The even-length broken lines in FIGS. 2-8 illustrate a display screen and an electronic device. None of the broken lines form part of the claimed design.

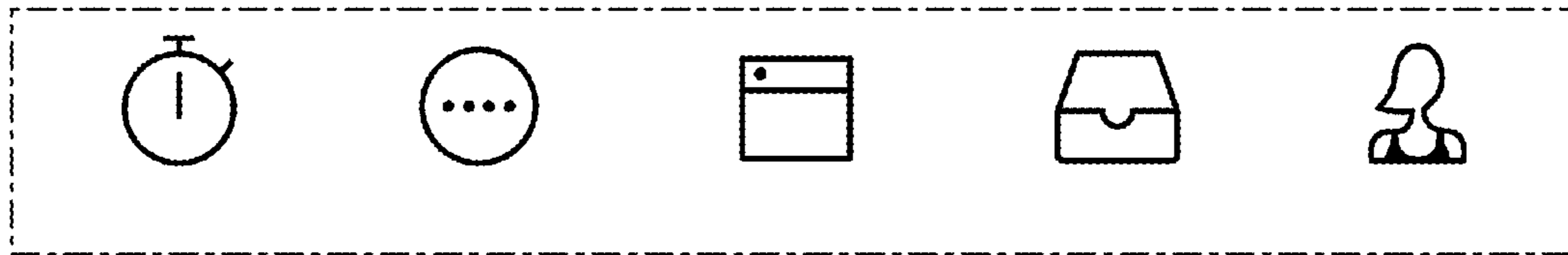

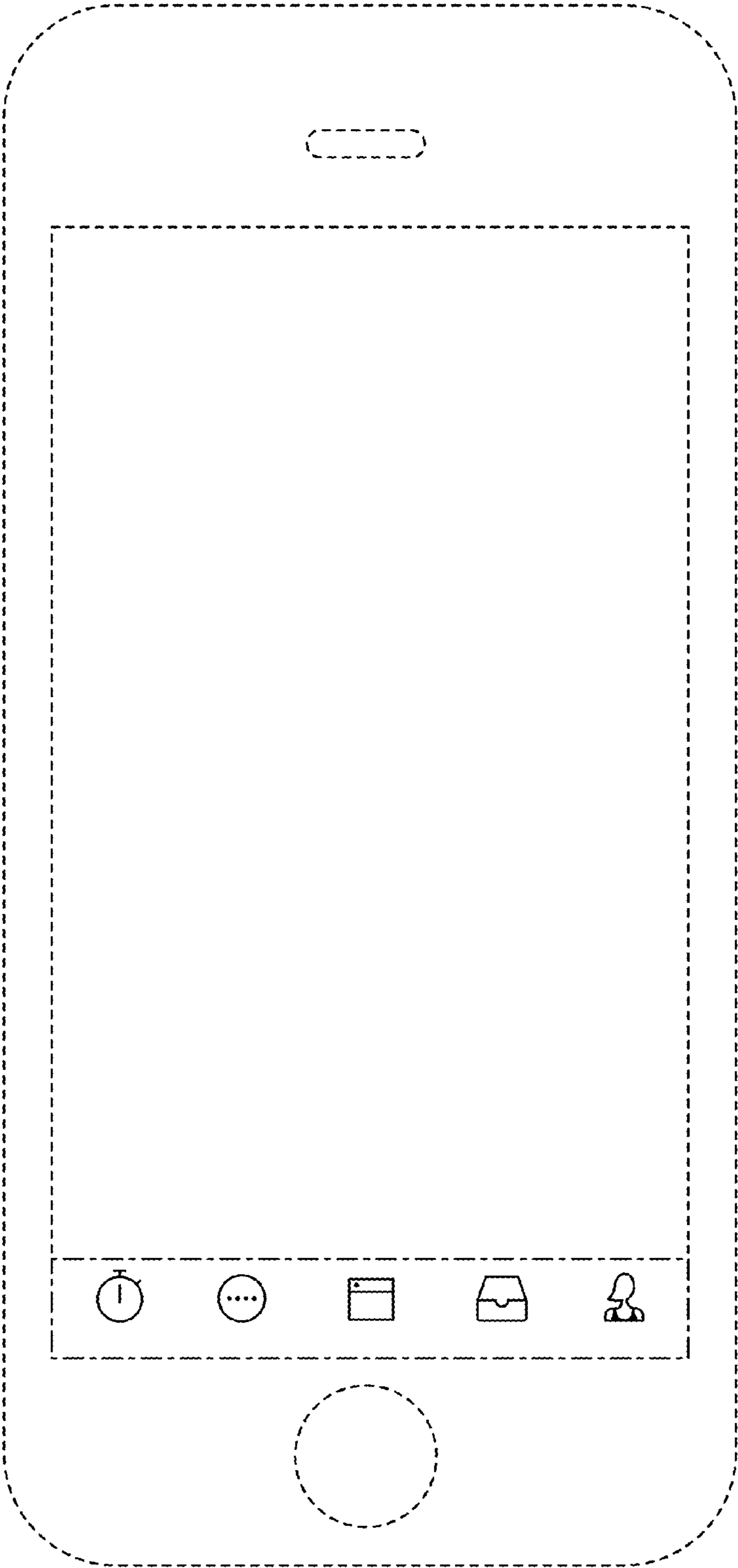

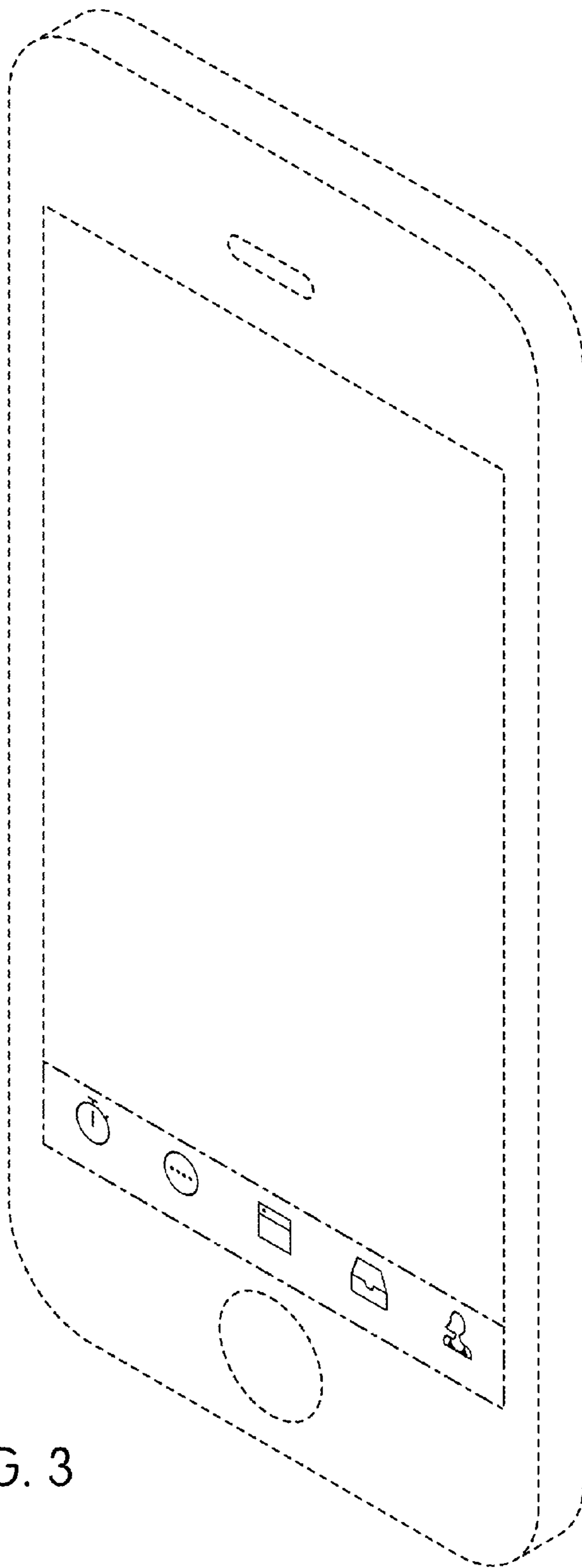

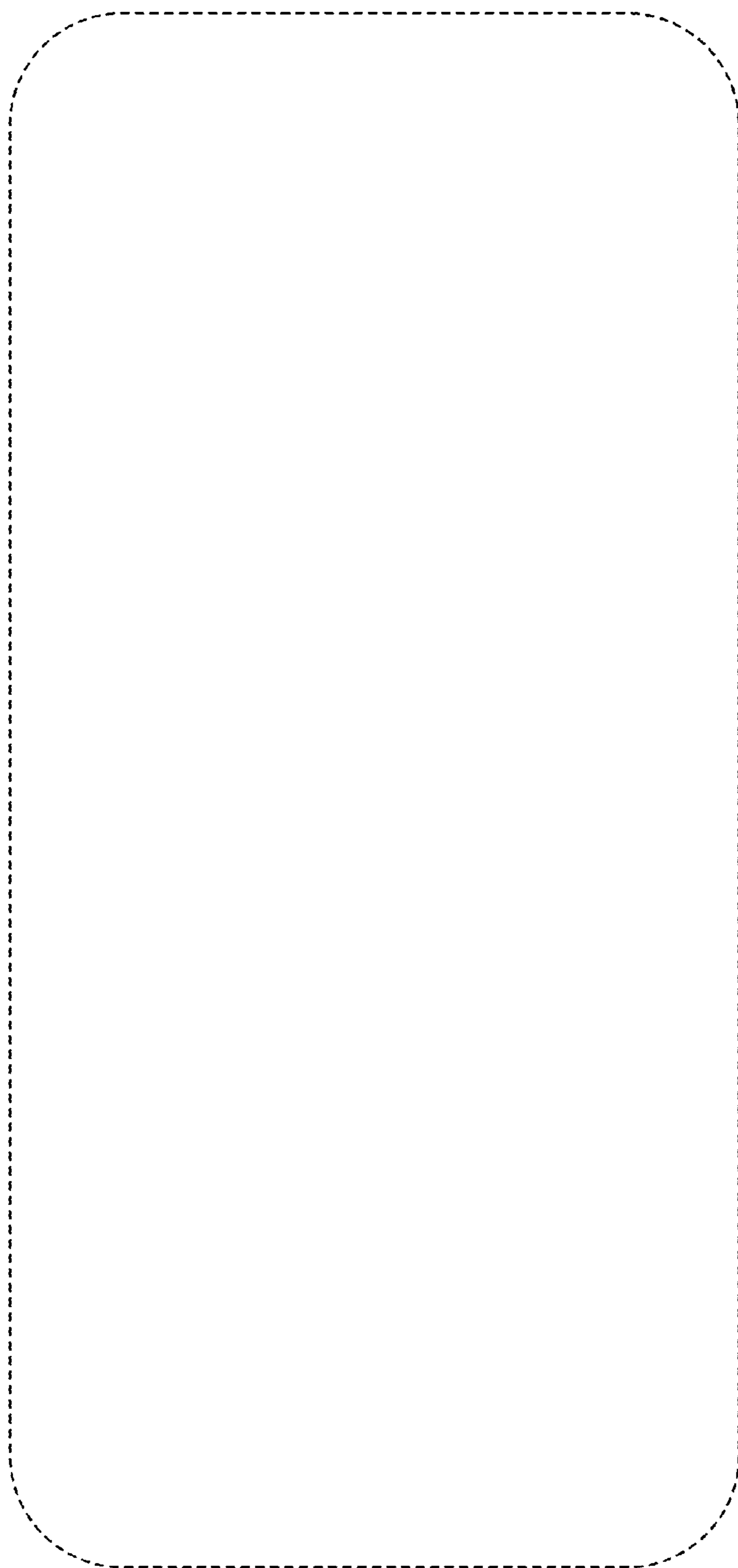

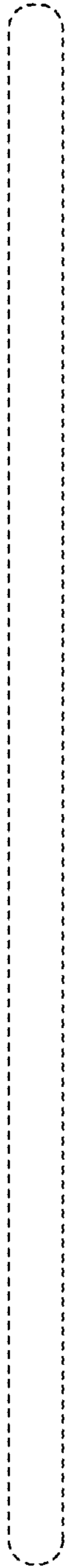
