(57) **CLAIM**

The ornamental design for an integrated supercharger and charge-air cooler system, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a housing of an integrated supercharger and charge-air cooler system in accordance with the present disclosure.

FIG. 2 is a bottom left rear perspective view of the housing of FIG. 1.

FIG. 5 is a front view of the housing of FIG. 1.

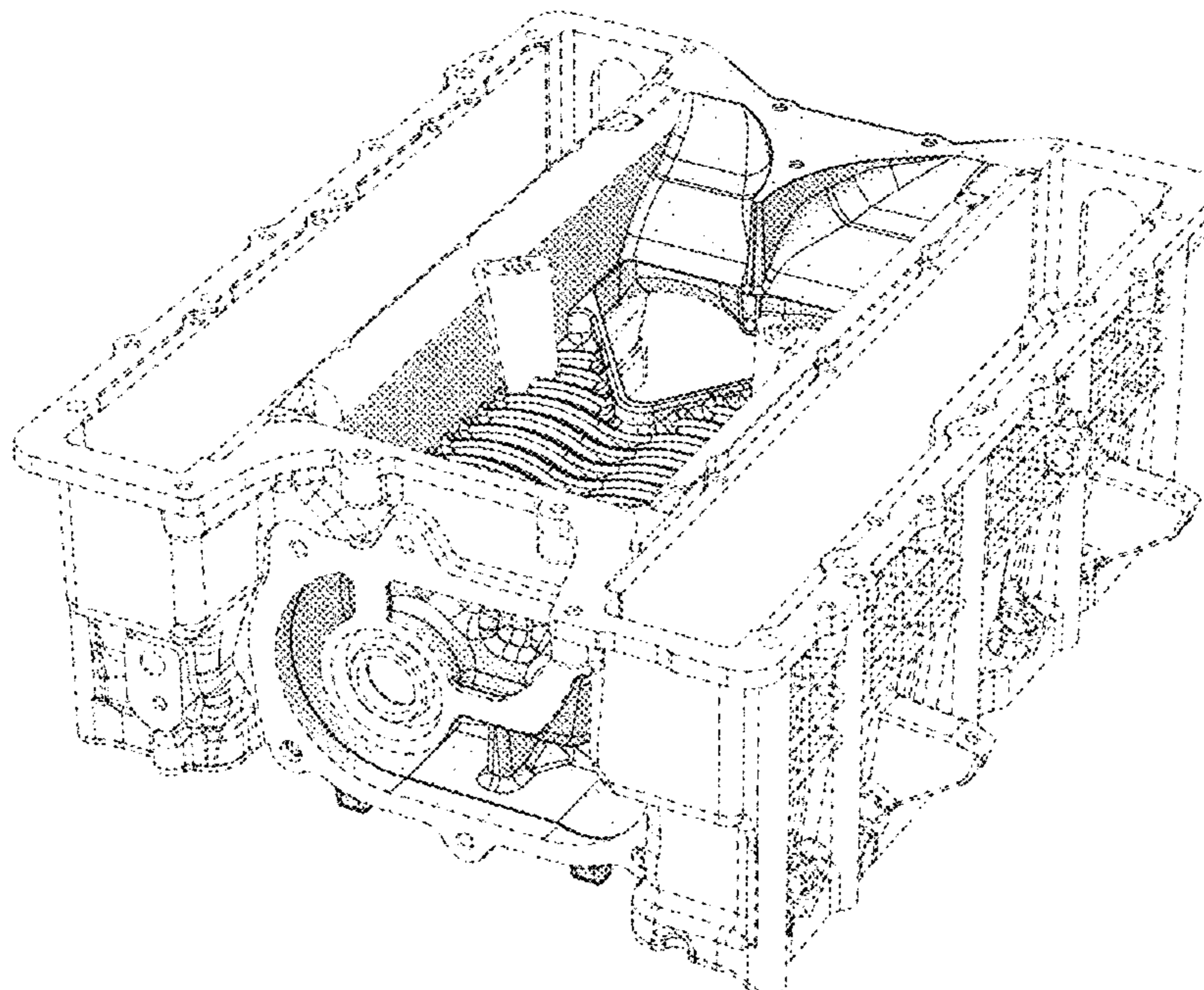
FIG. 6 is a rear view of the housing of FIG. 1.

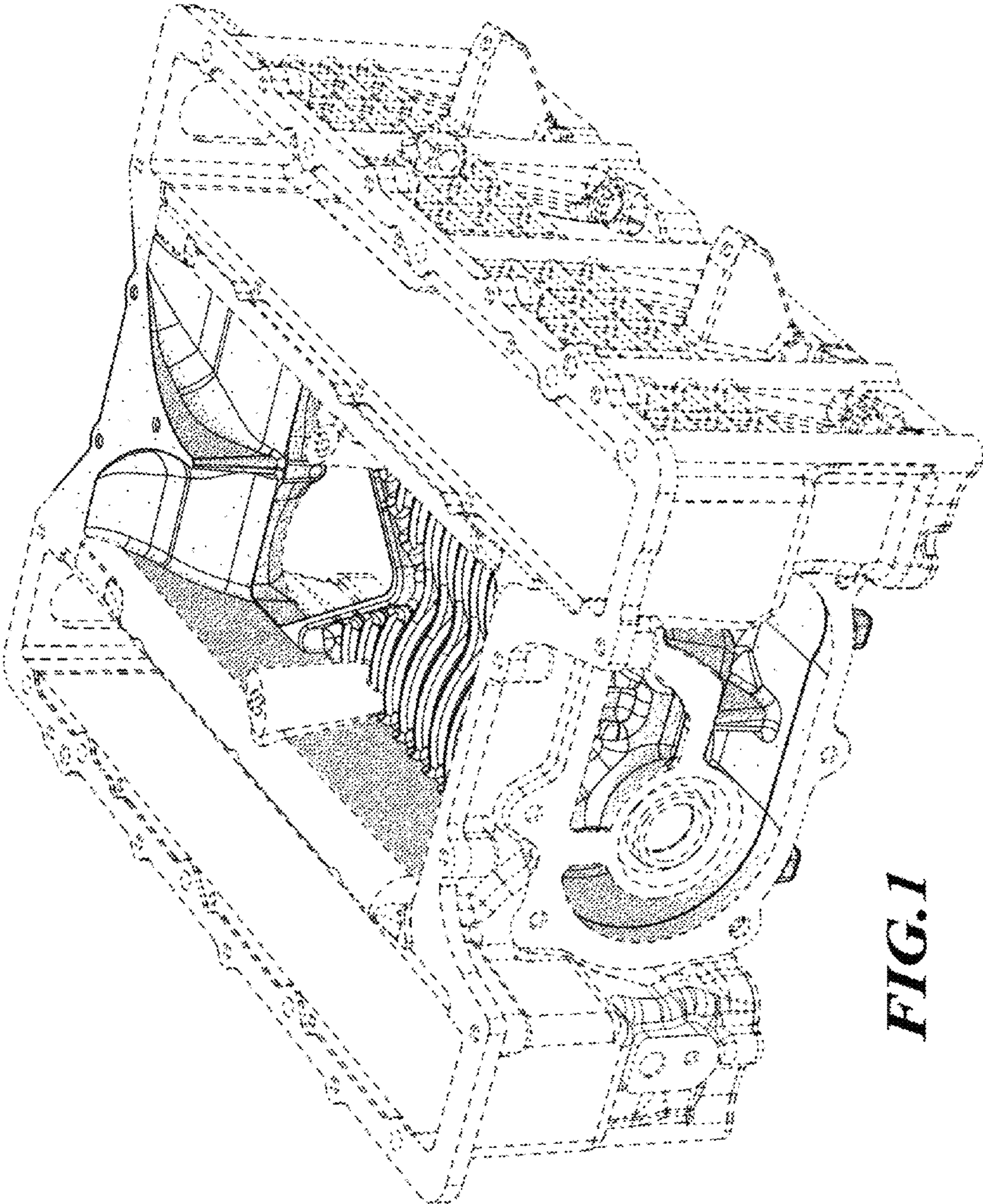

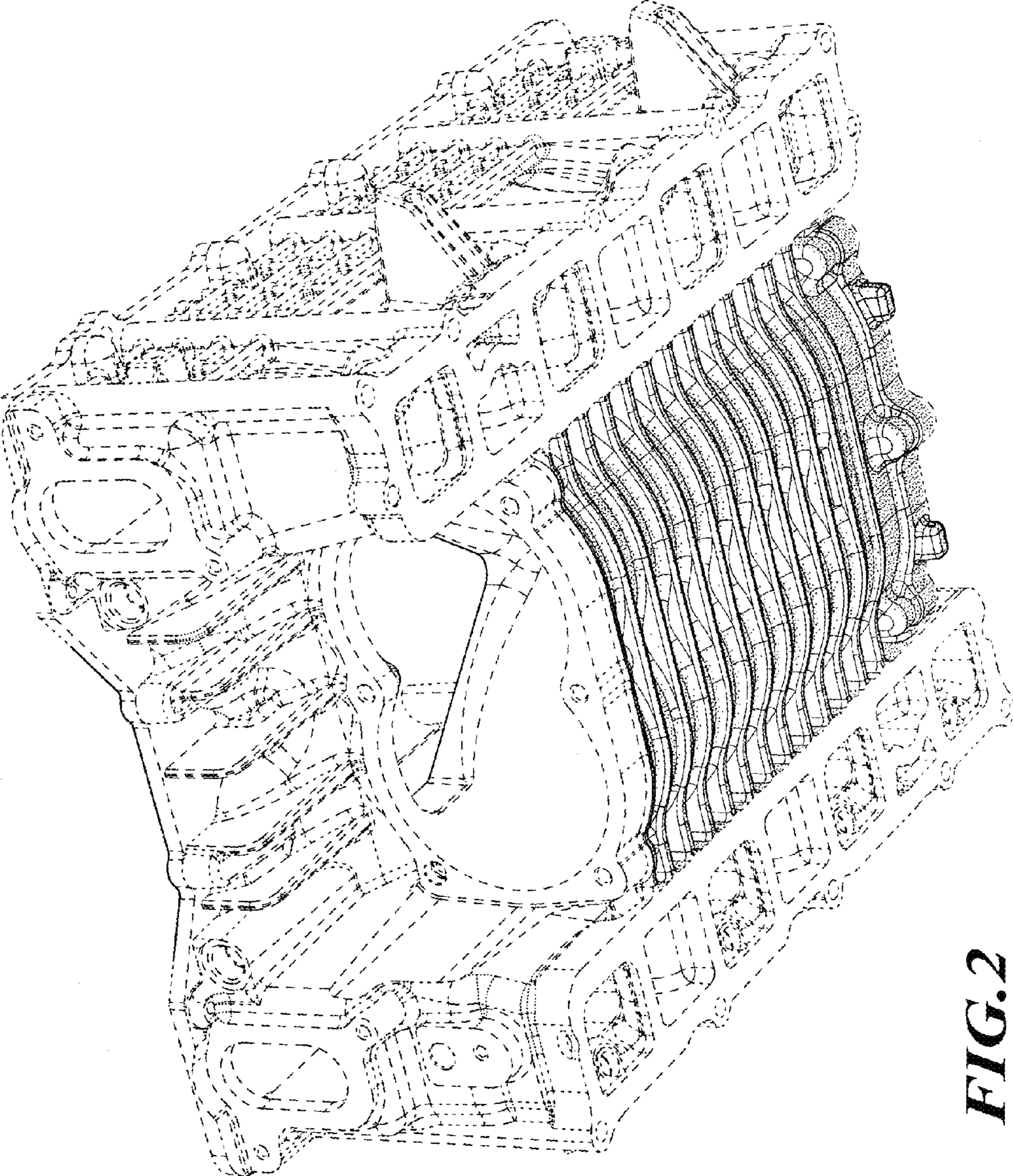

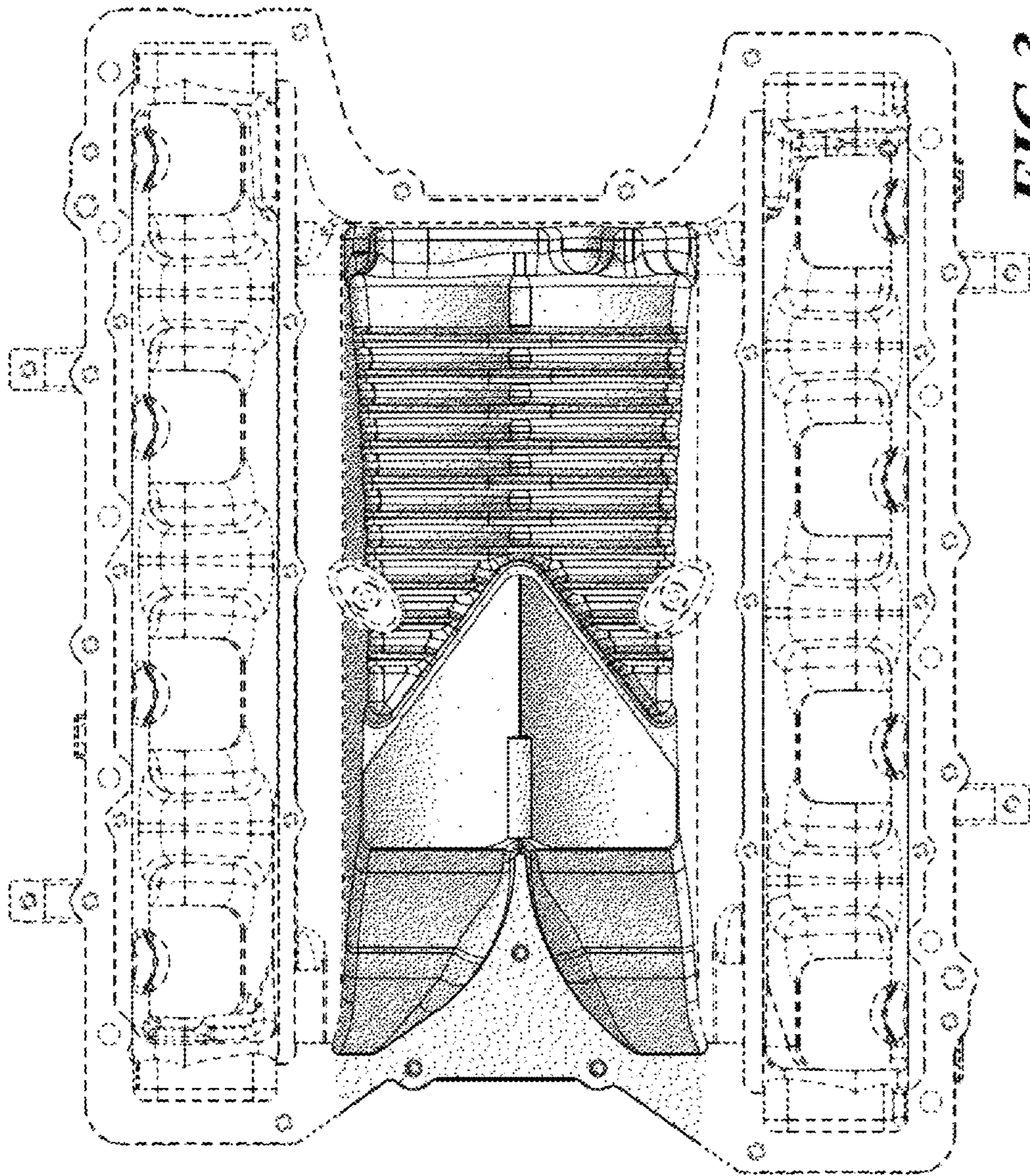

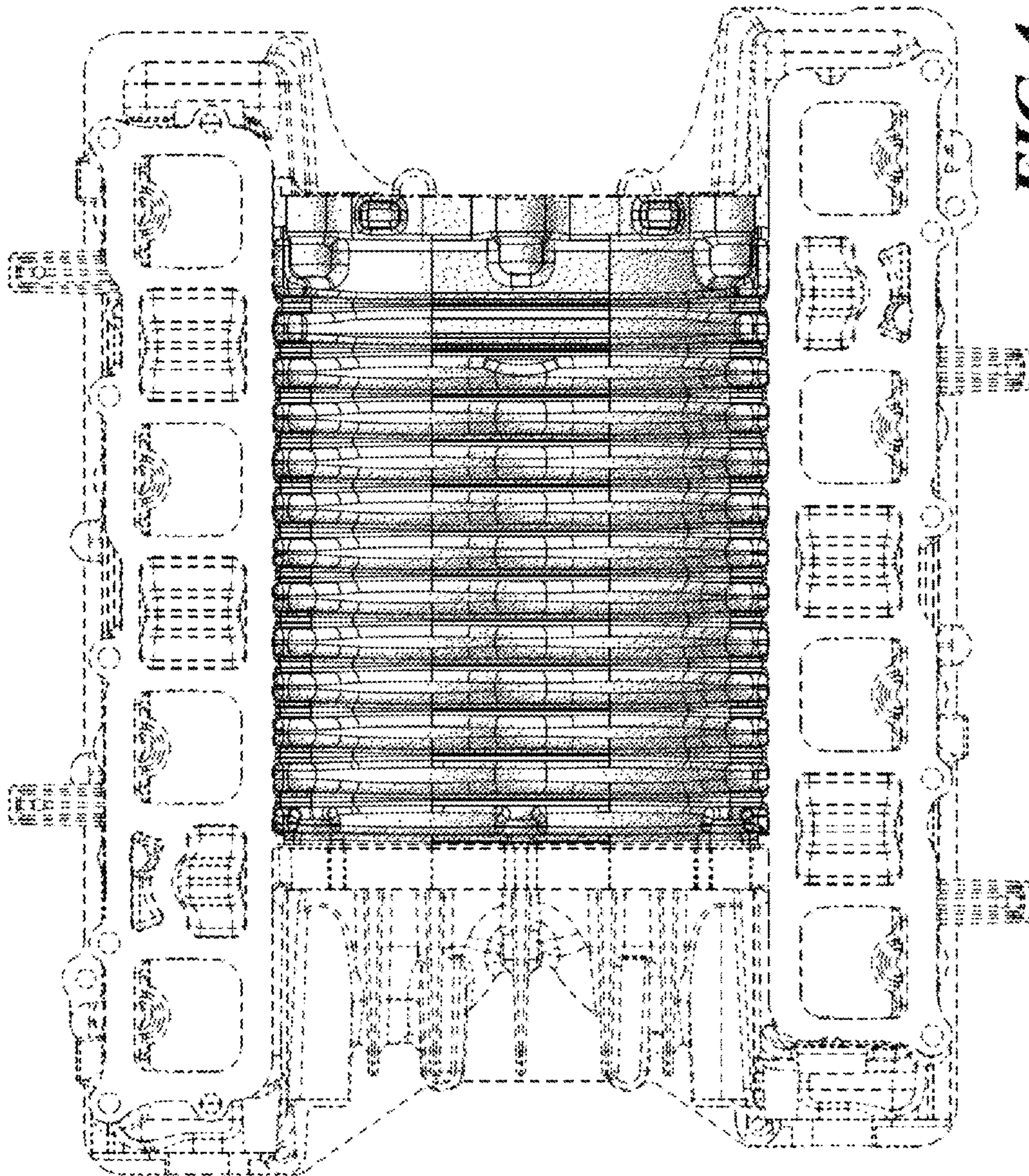

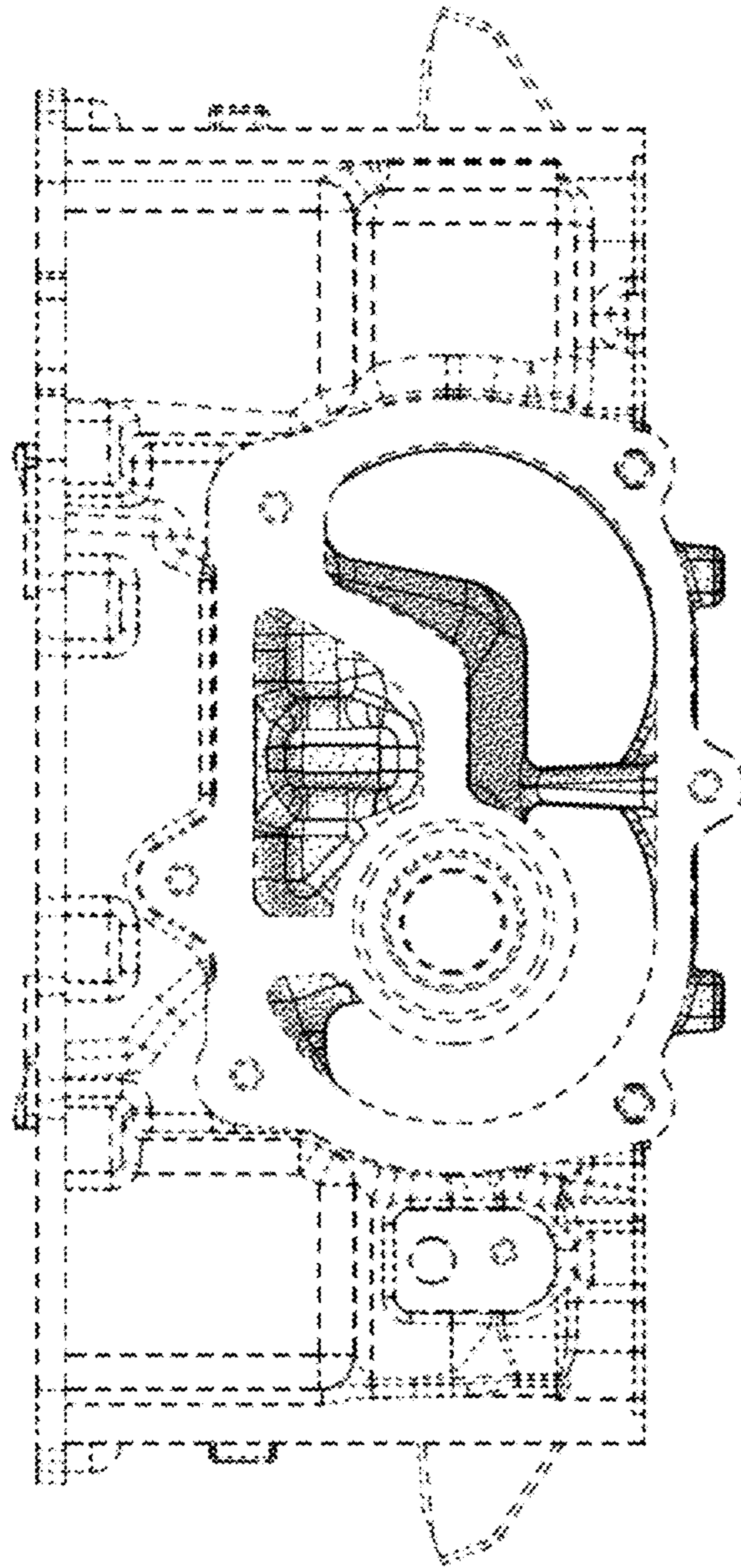

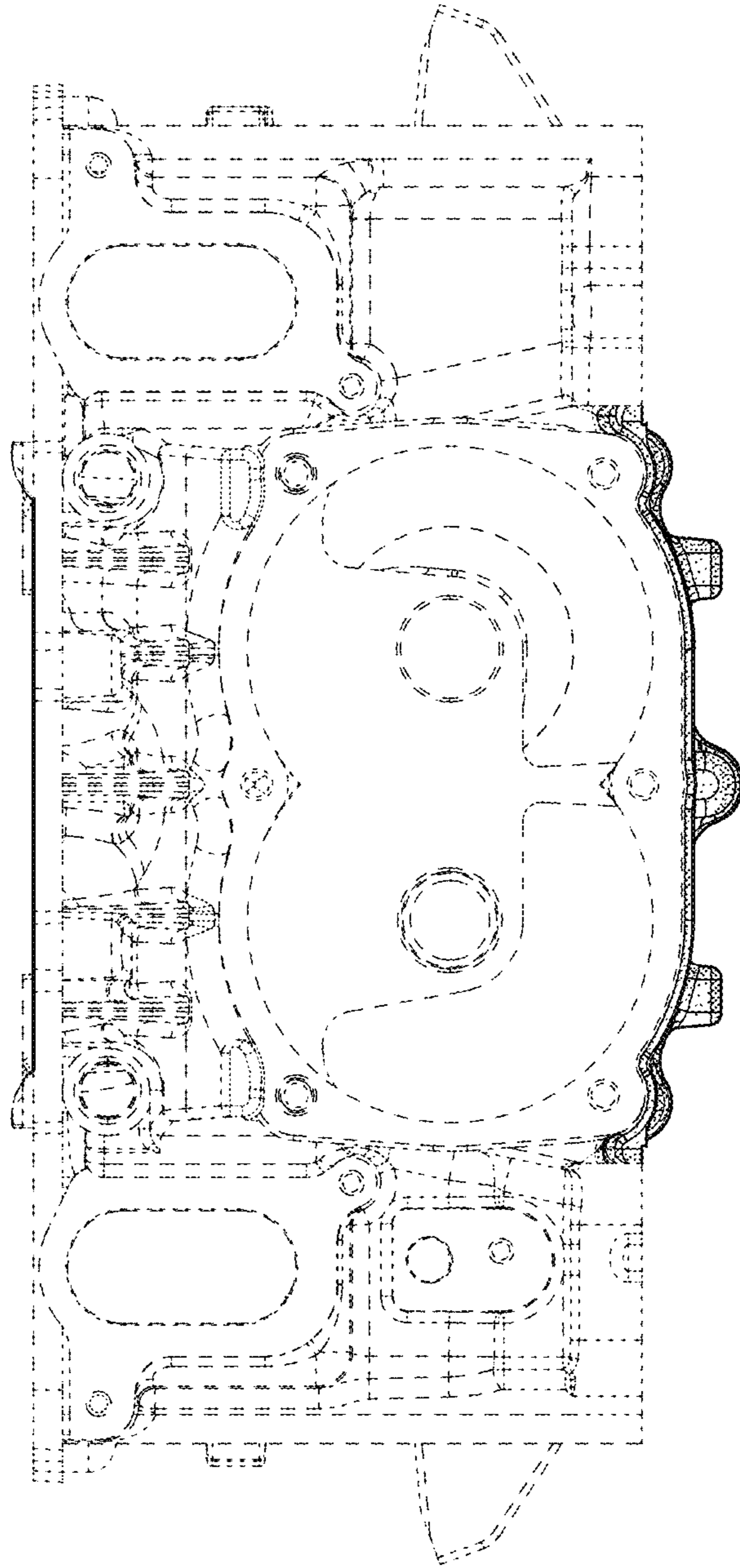

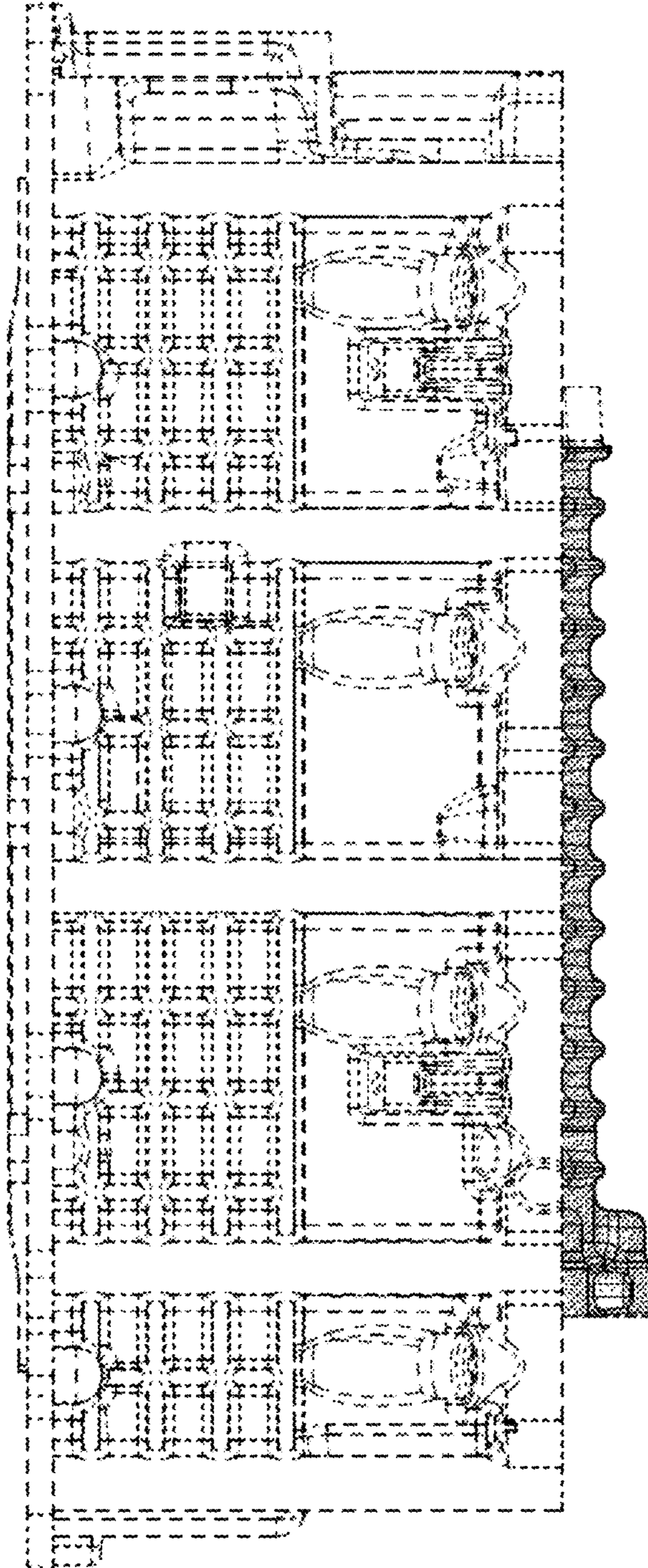

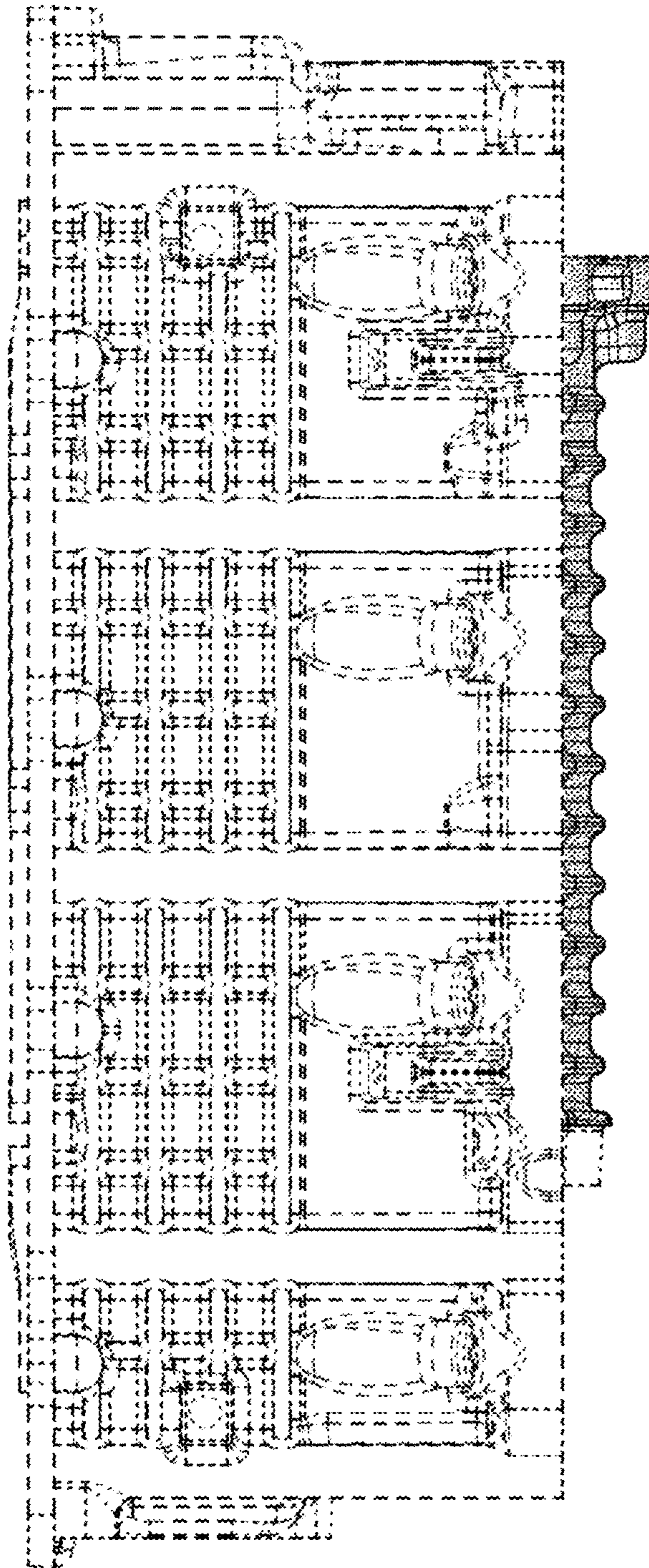
