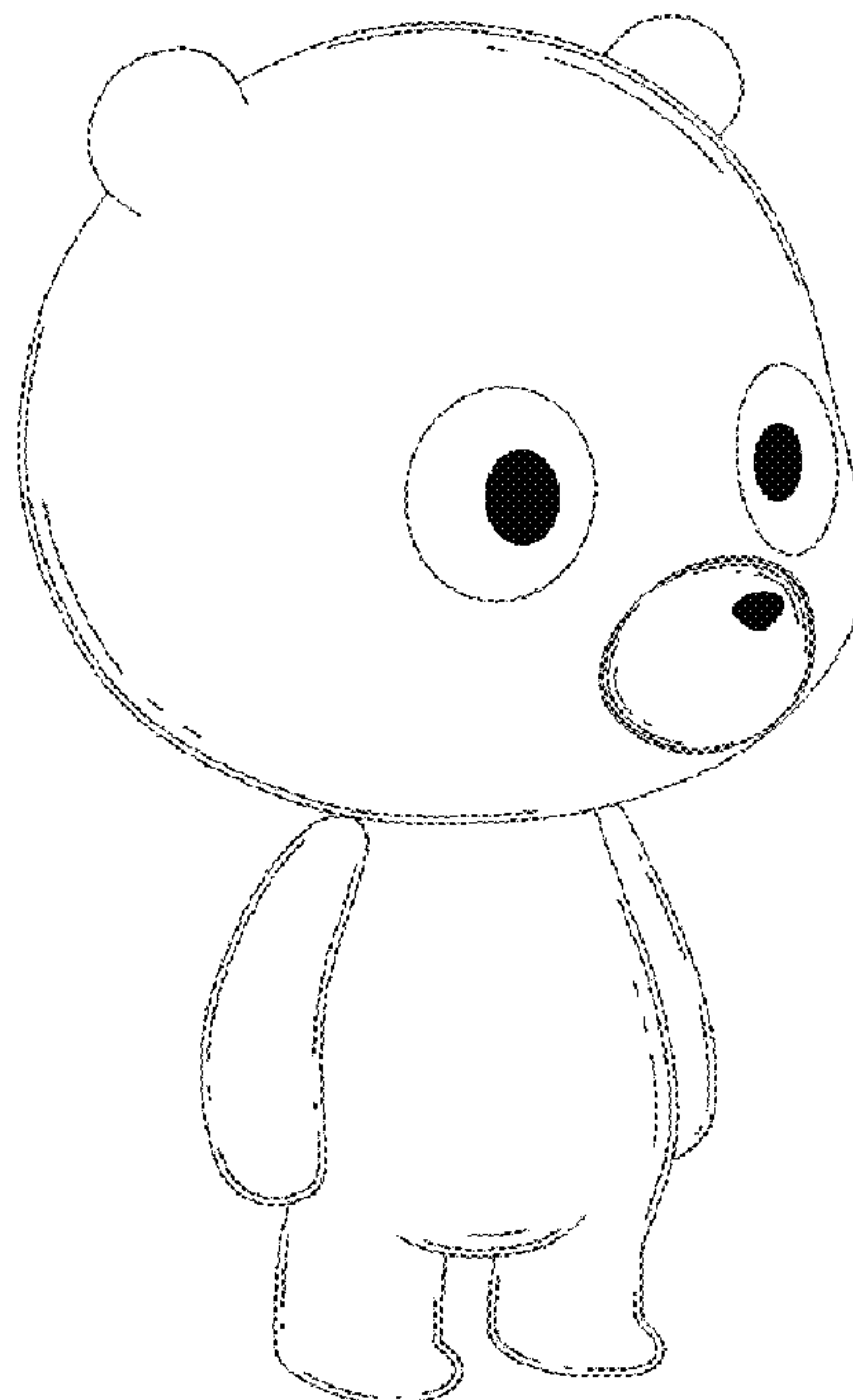
(57) **CLAIM**

The ornamental design for a toy figure, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a toy figure showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a front-left perspective view thereof; and, FIG. 8 is a rear-right perspective view thereof. The black shaded portions represent a color contrast with the adjacent, non-black portions only, and does not represent any particular color, material, texture, or finish.

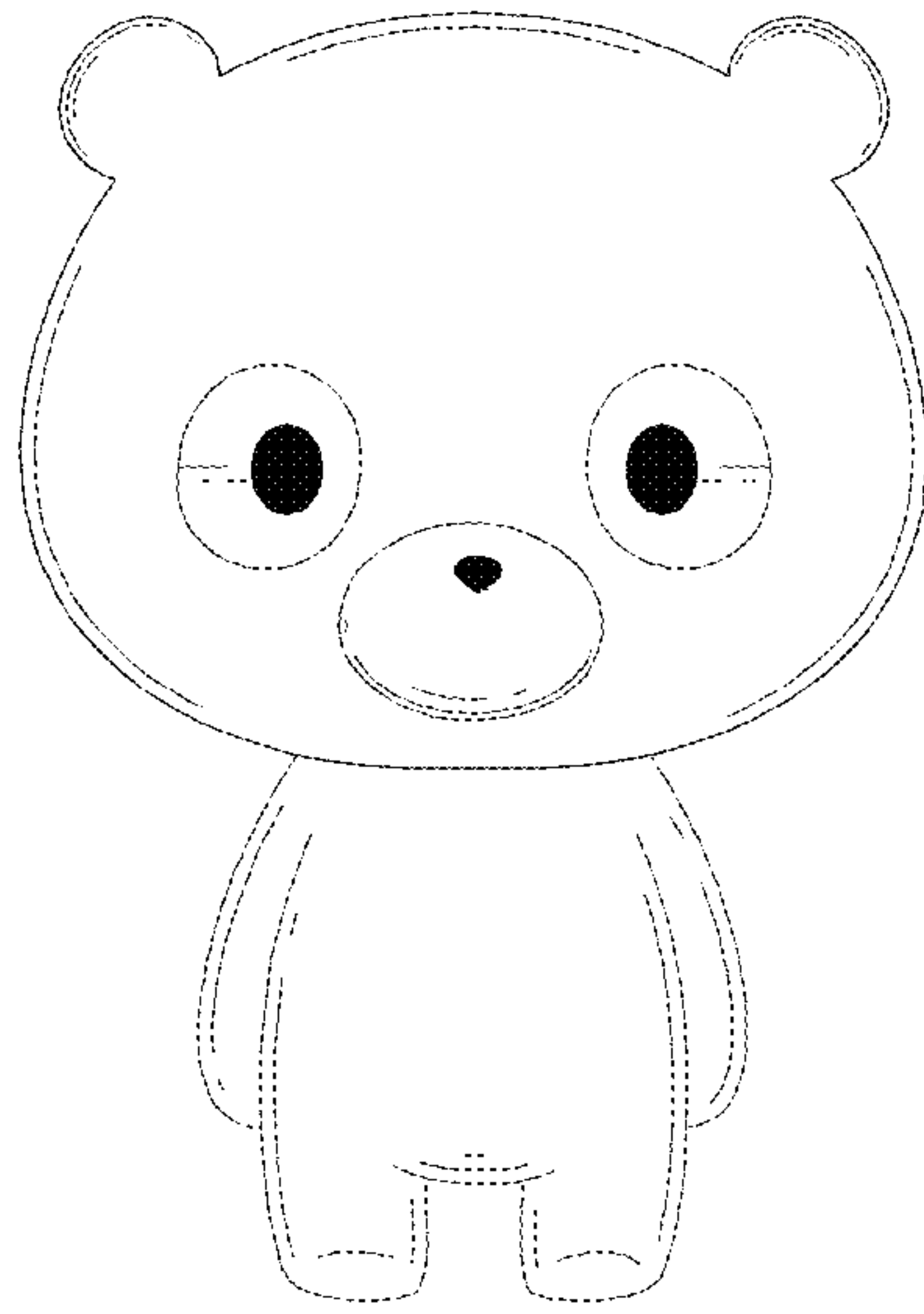

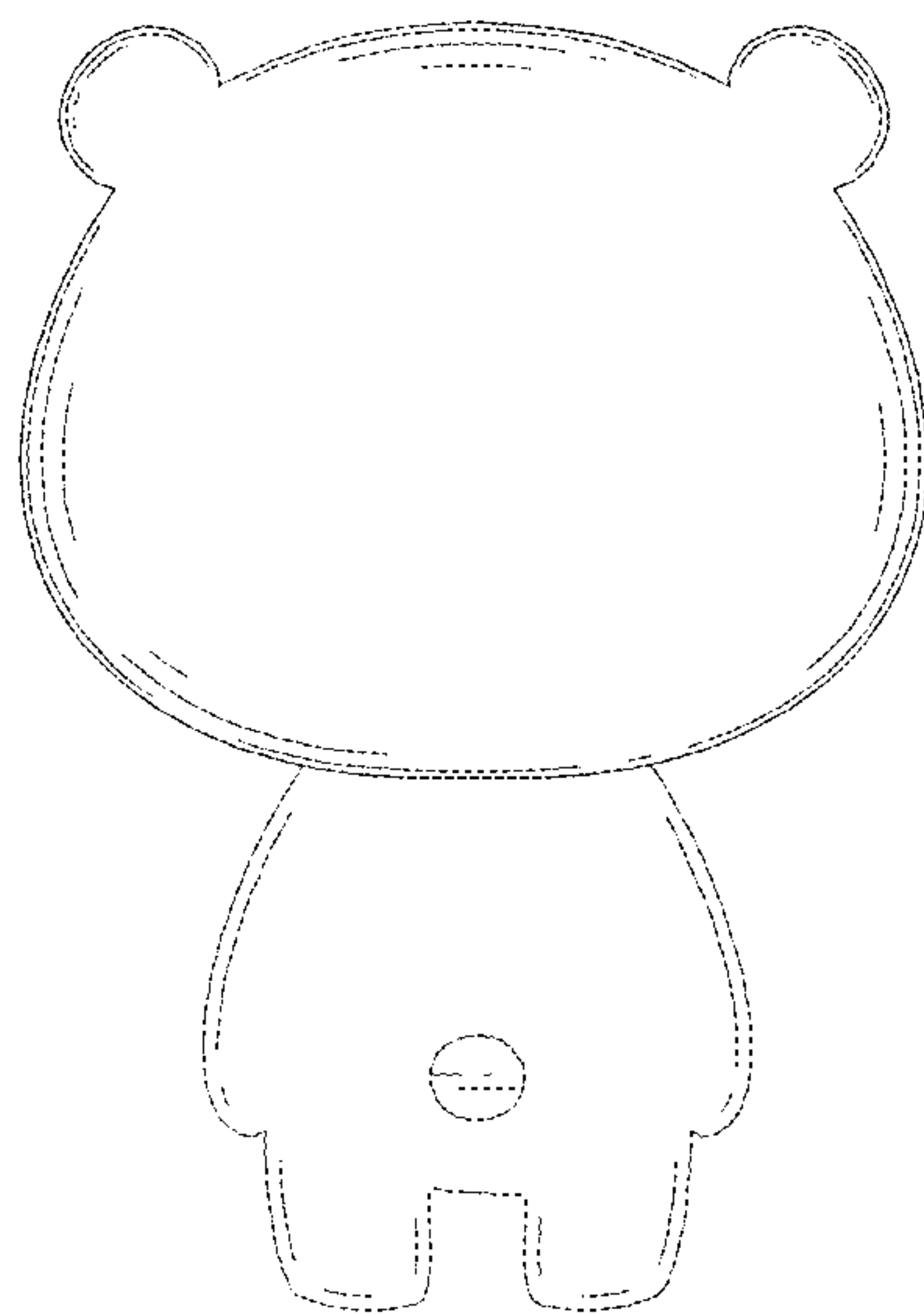

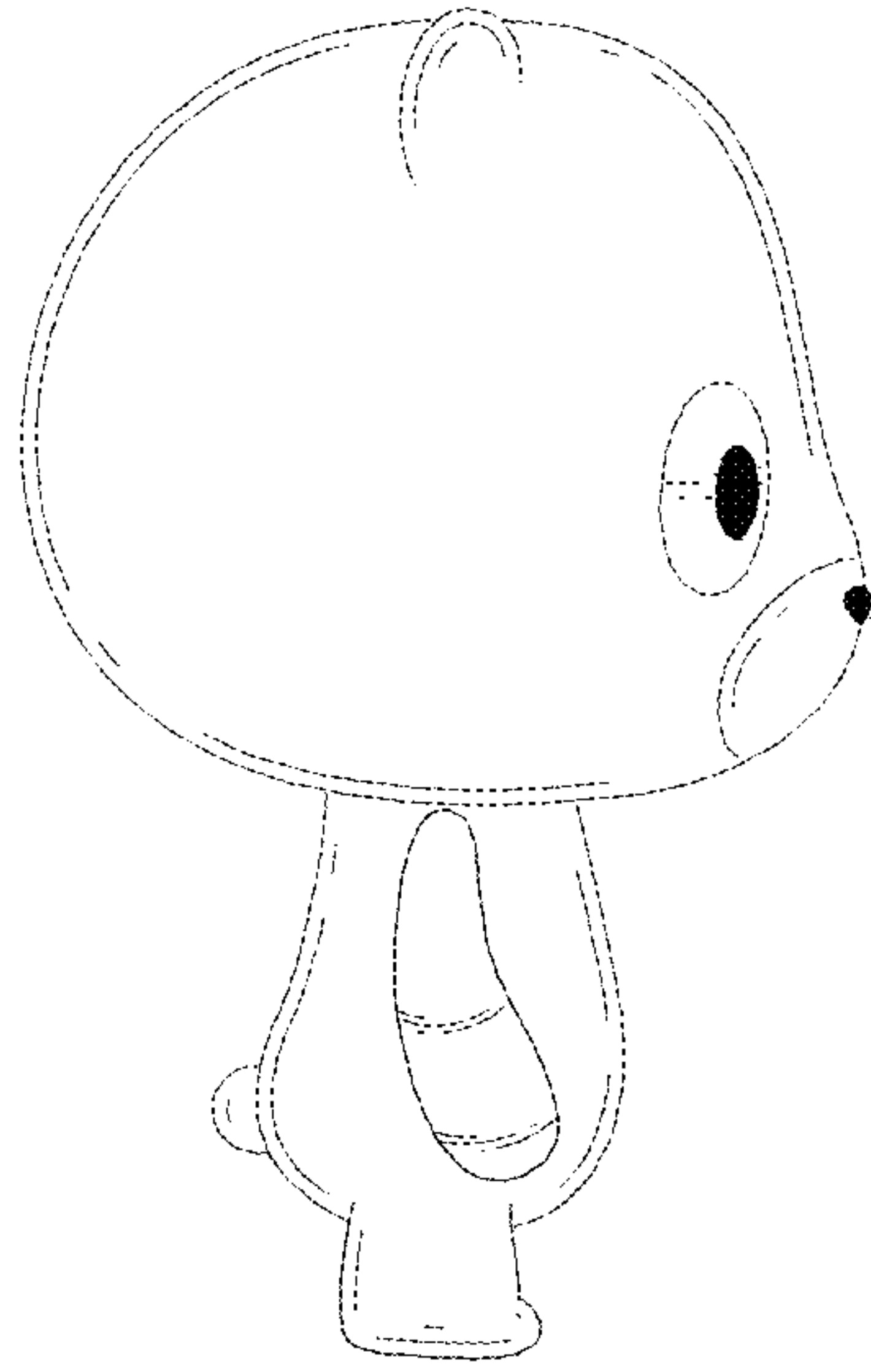

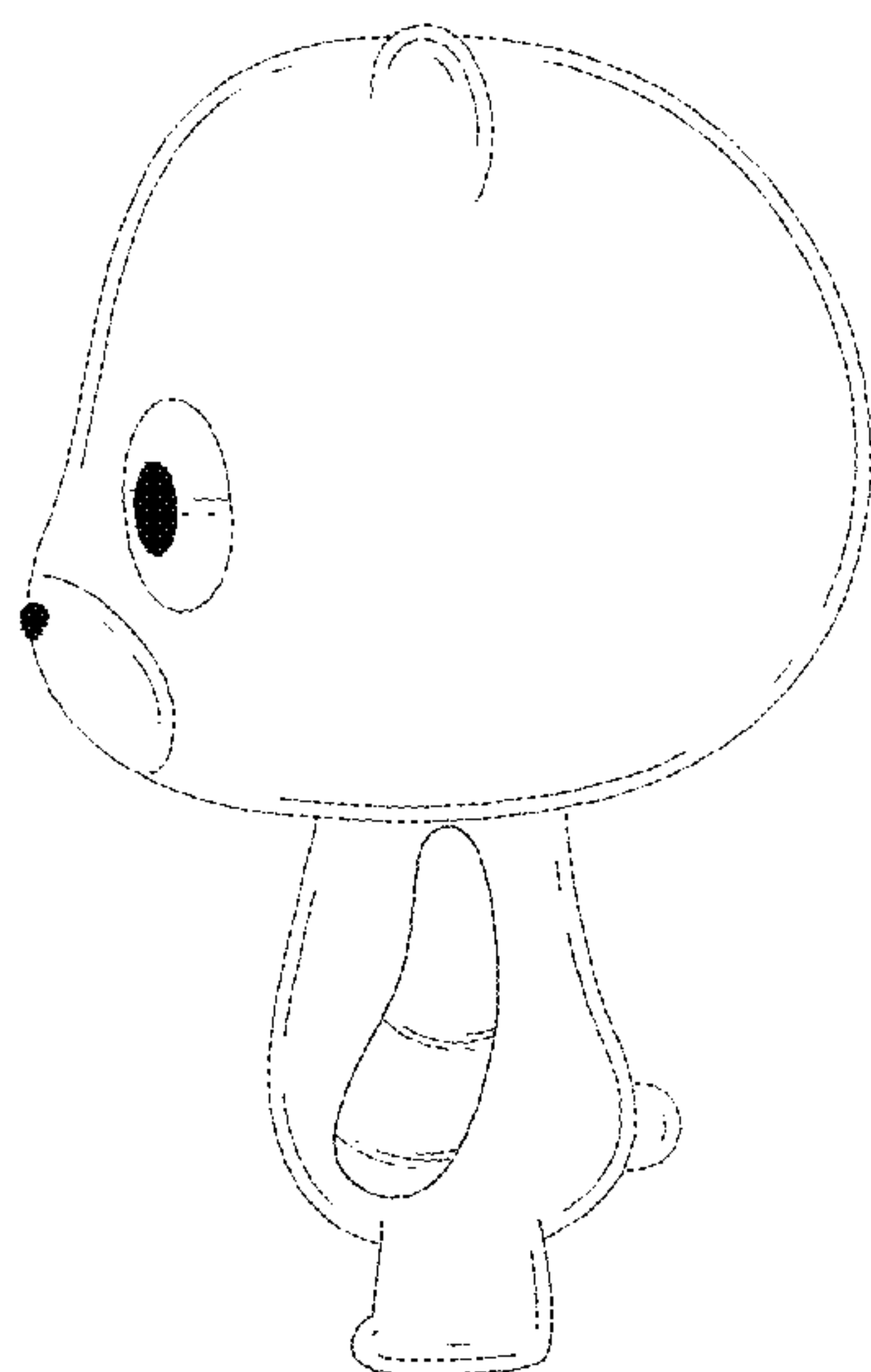

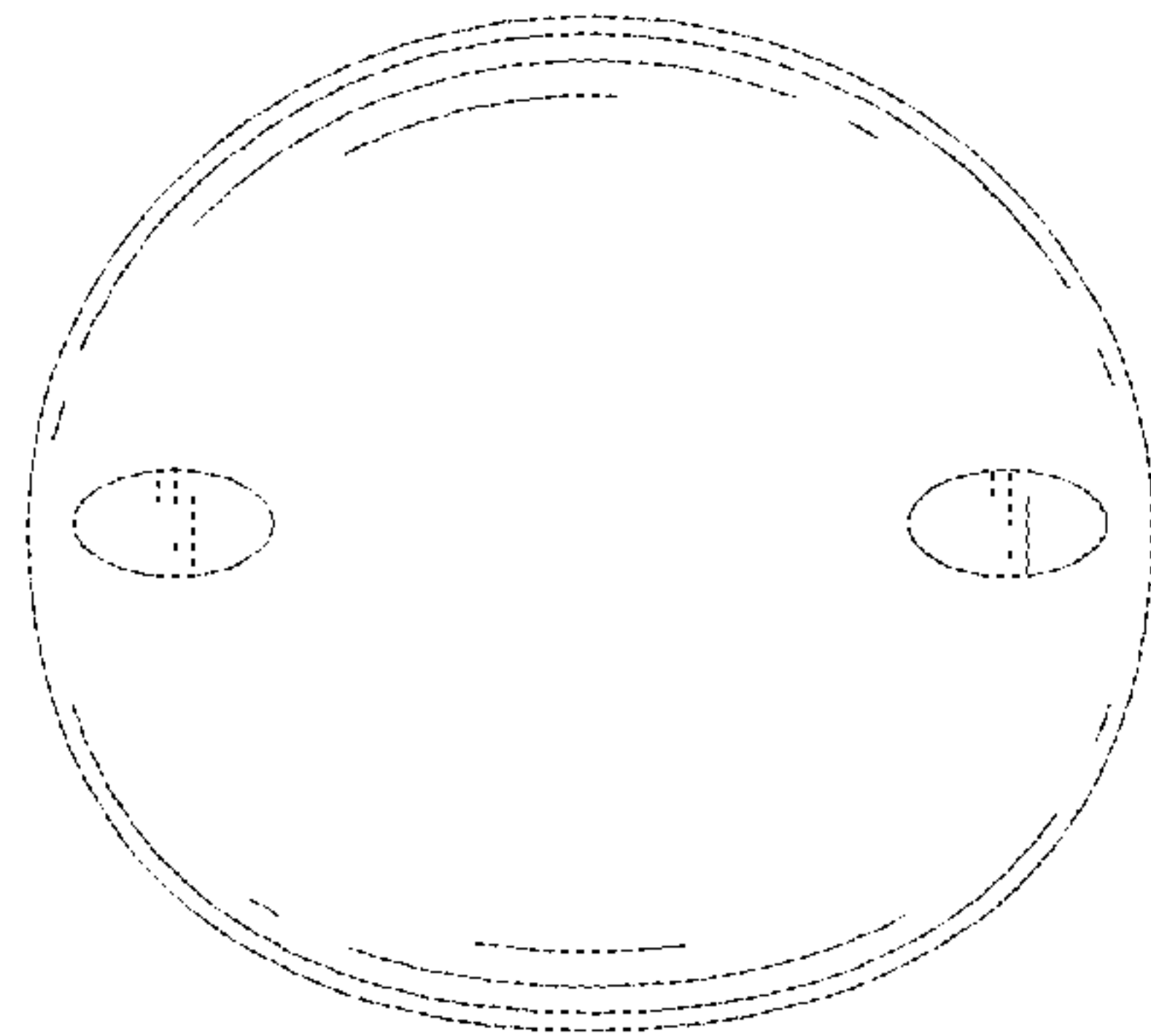

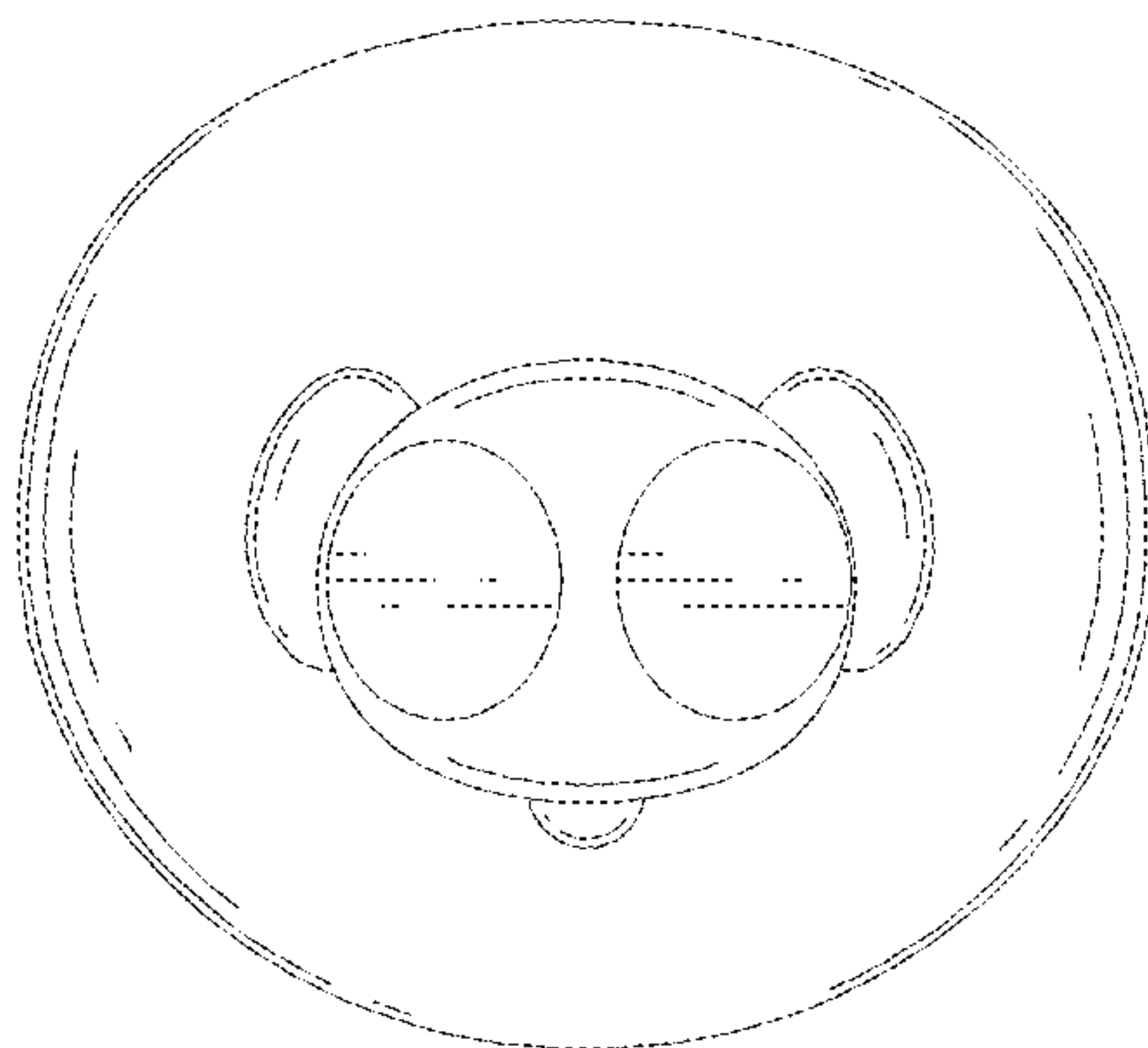

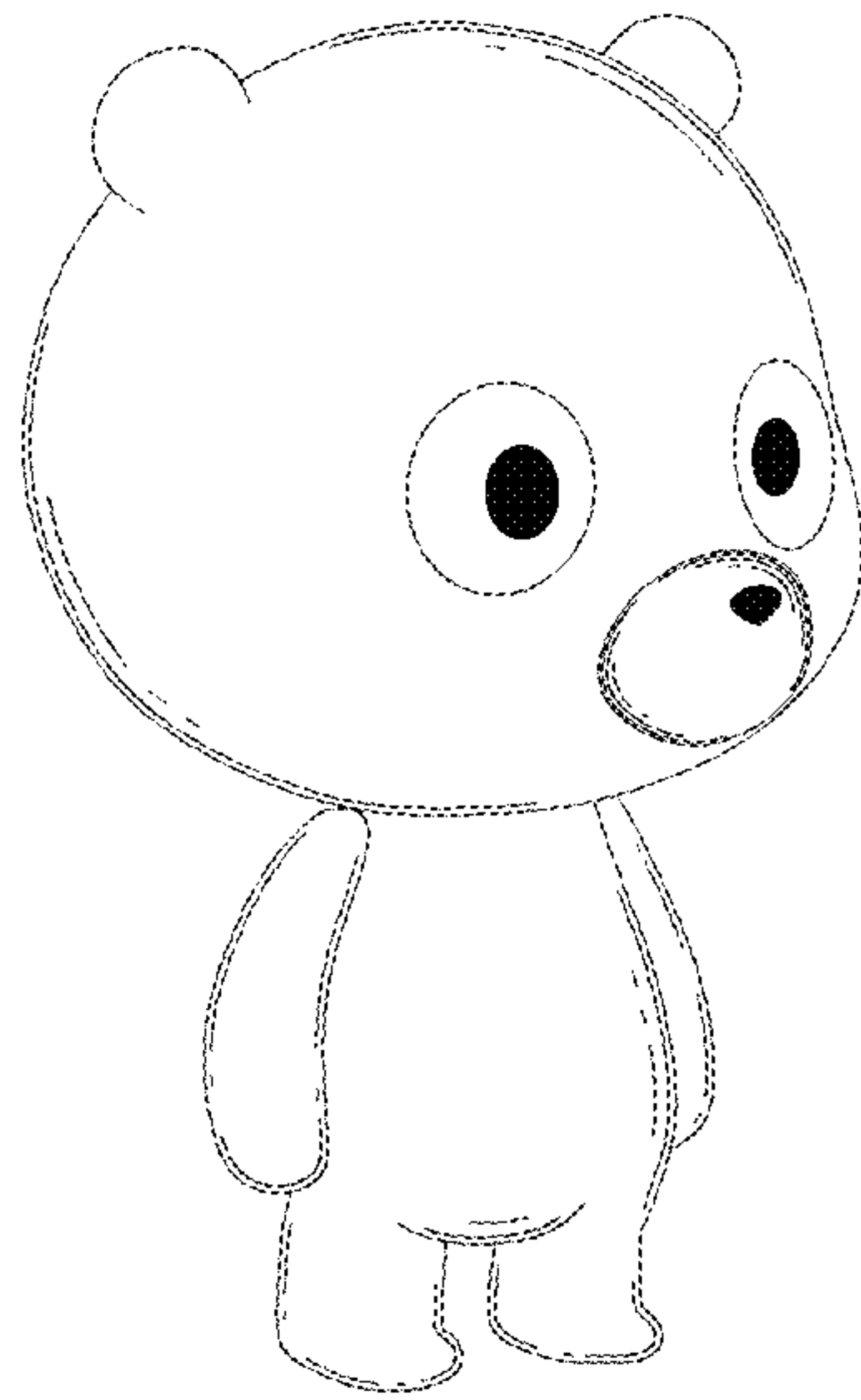

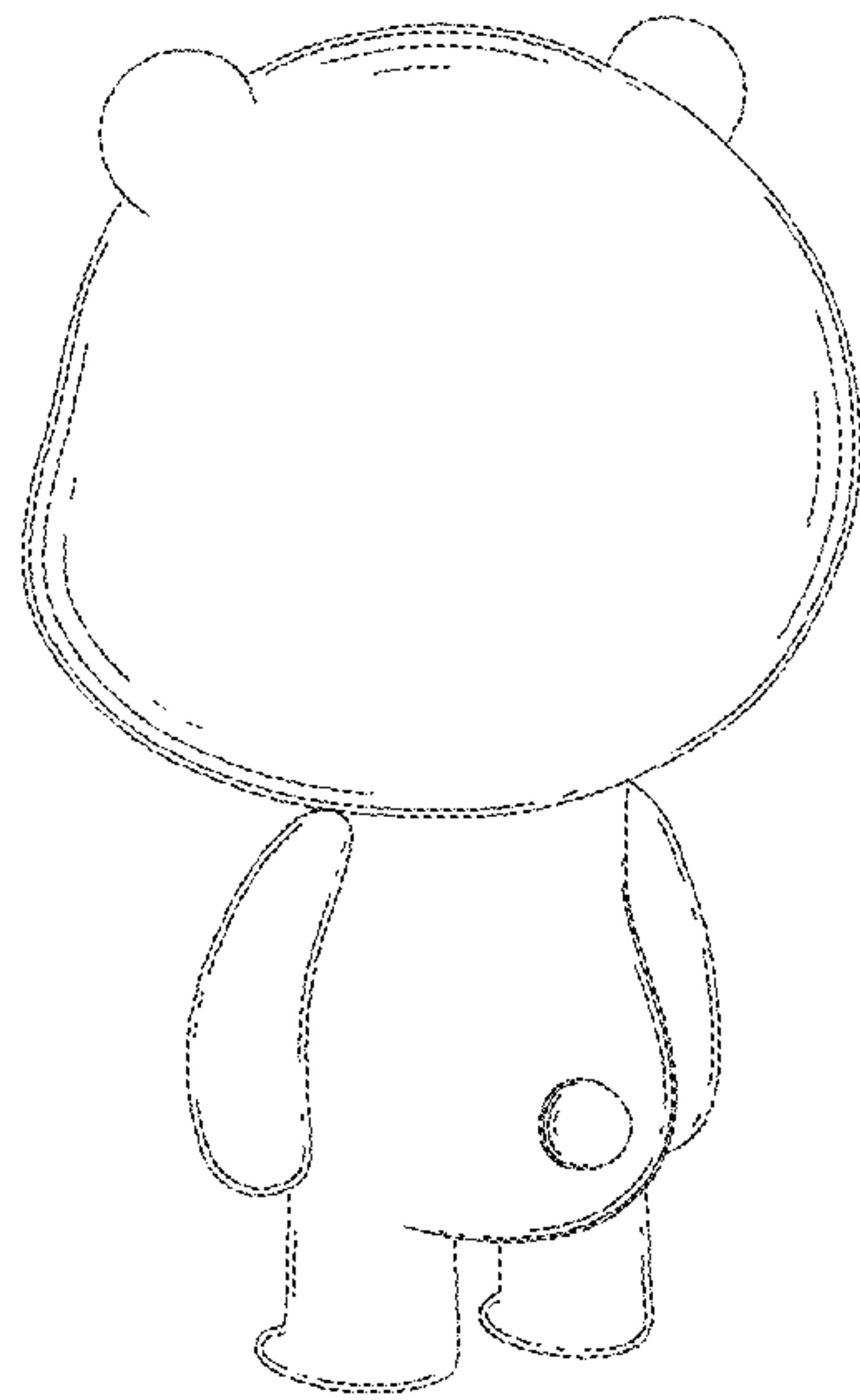
