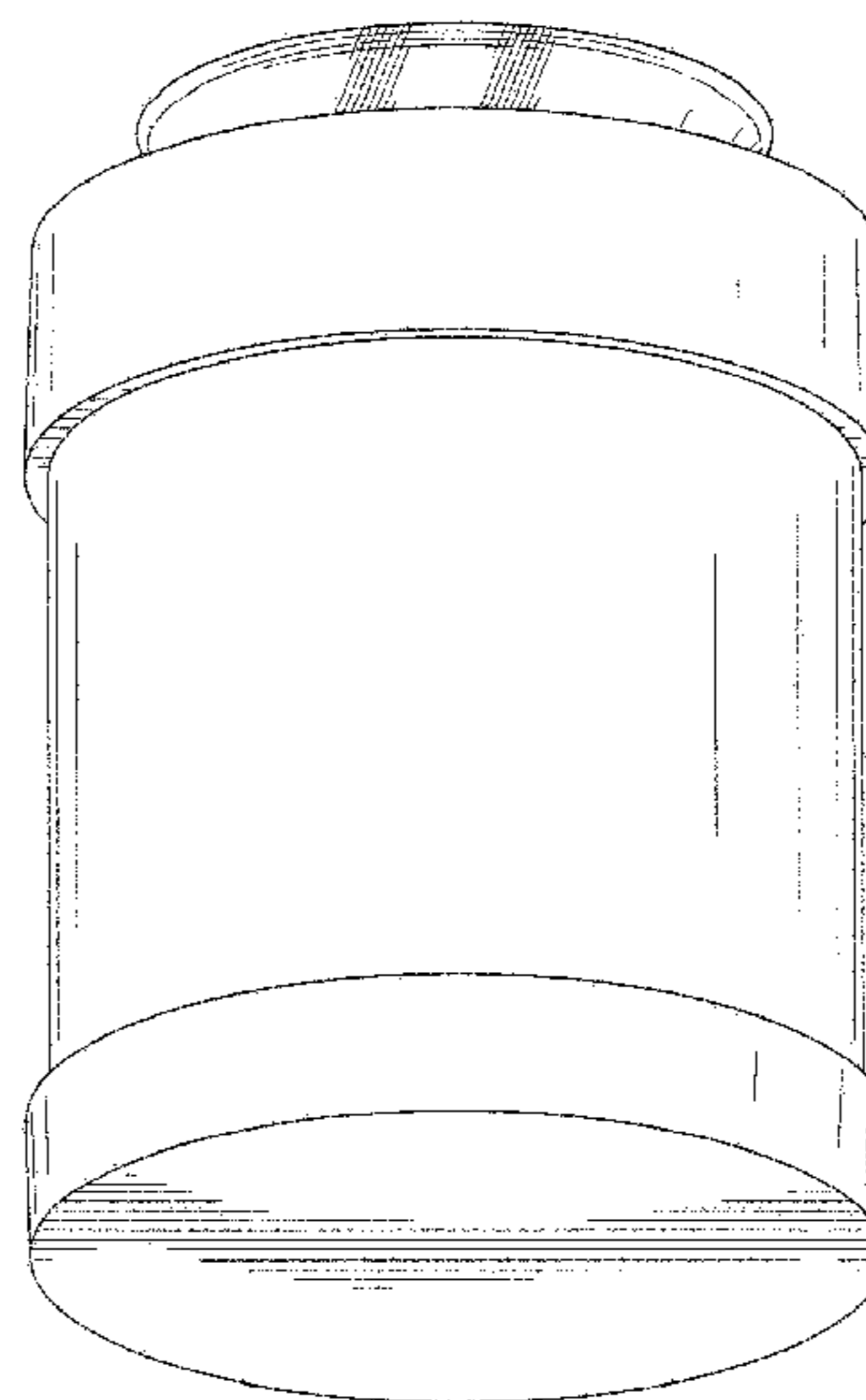
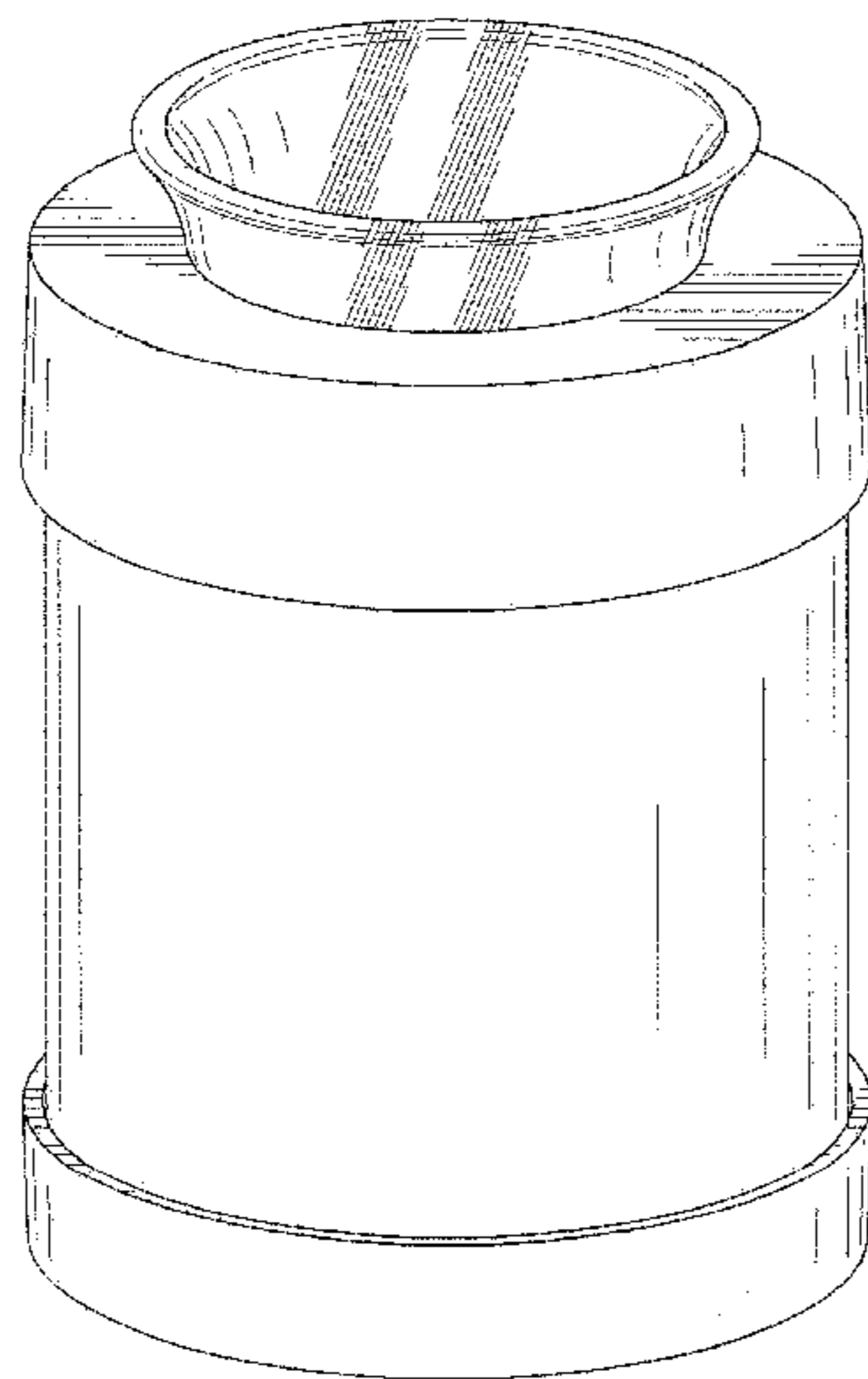
(57) **CLAIM**

The ornamental design for a tea light cremation urn, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of a tea light cremation urn with the right side being a mirror image, showing my new design; FIG. 2 is a top perspective view thereof; FIG. 3 is a bottom perspective view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a left side view thereof, the broken lines depict a pattern that forms no part of the claimed design; FIG. 7 is a left side view thereof, the broken lines depict a pattern that forms no part of the claimed design; FIG. 8 is a left side view thereof, the broken lines depict a pattern that forms no part of the claimed design; and, FIG. 9 is a left side view thereof, the broken lines depict a pattern that forms no part of the claimed design.

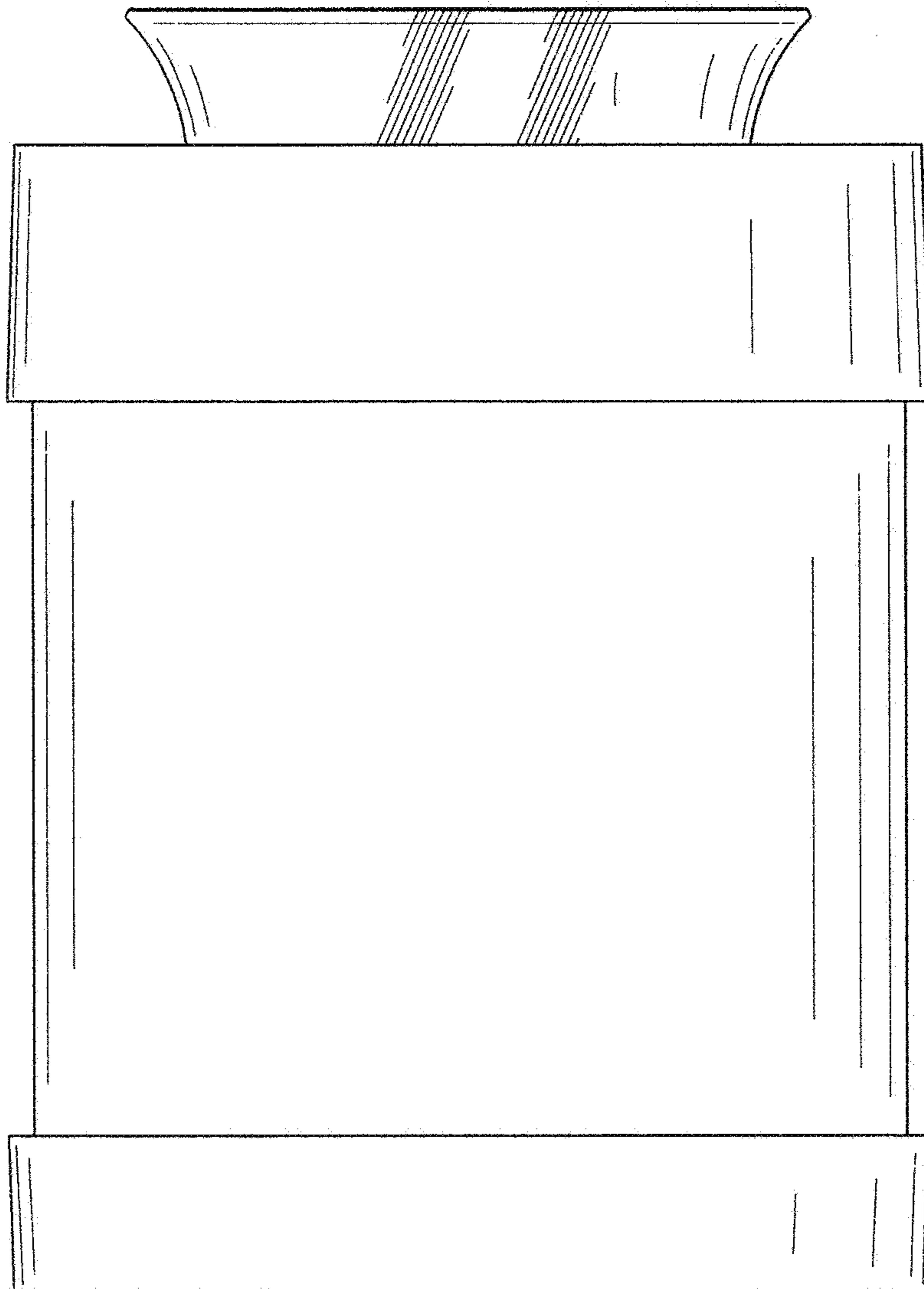

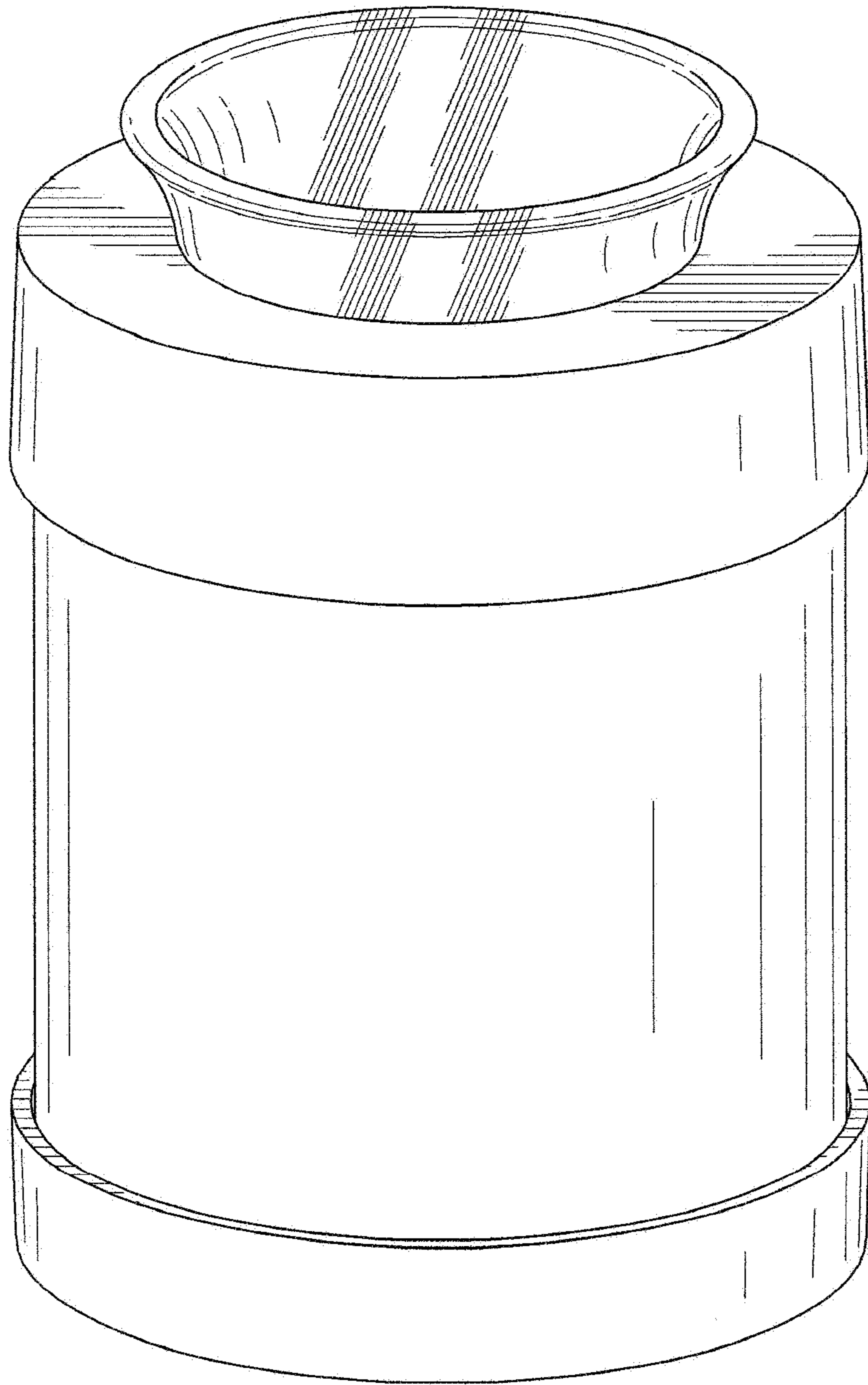

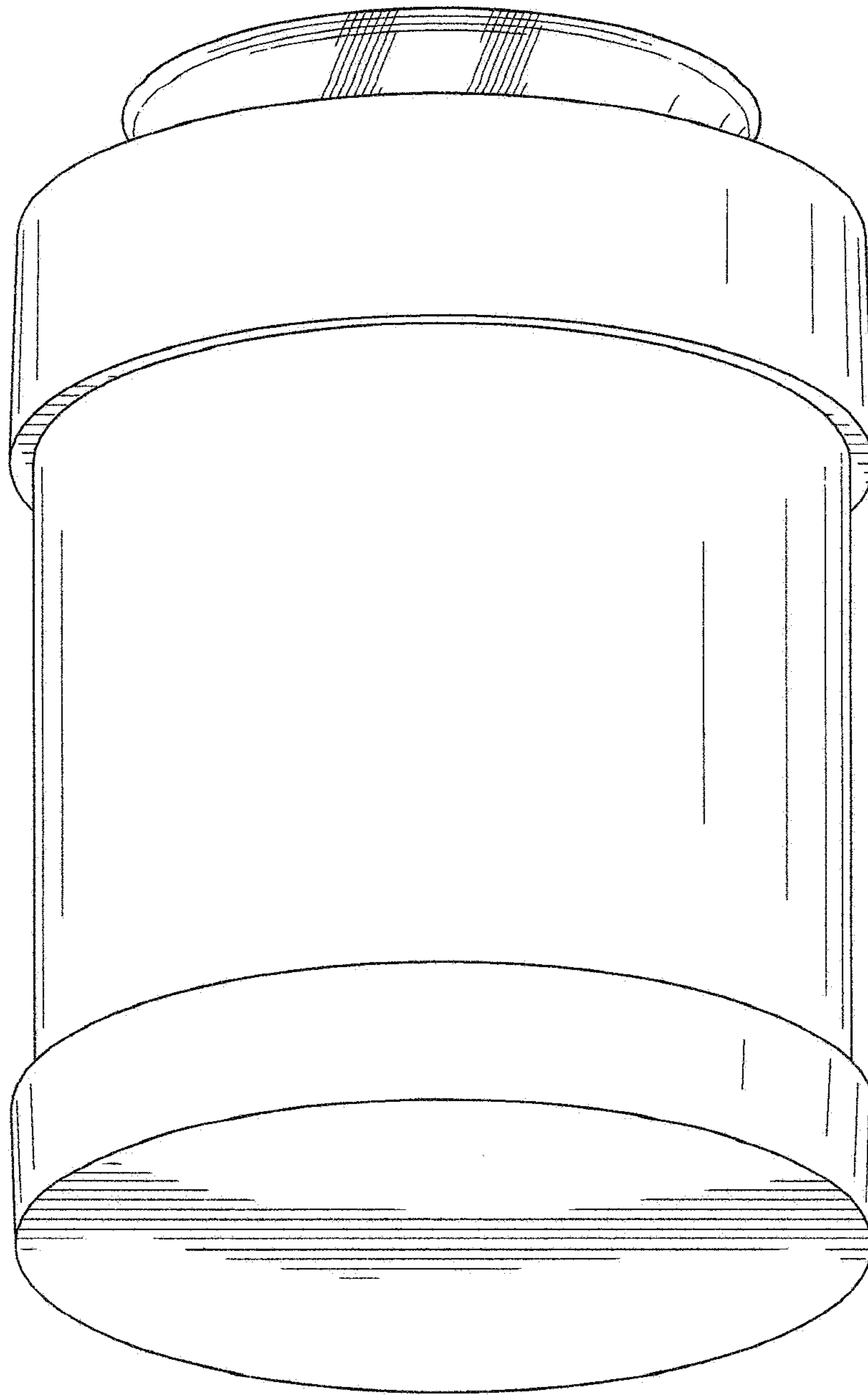

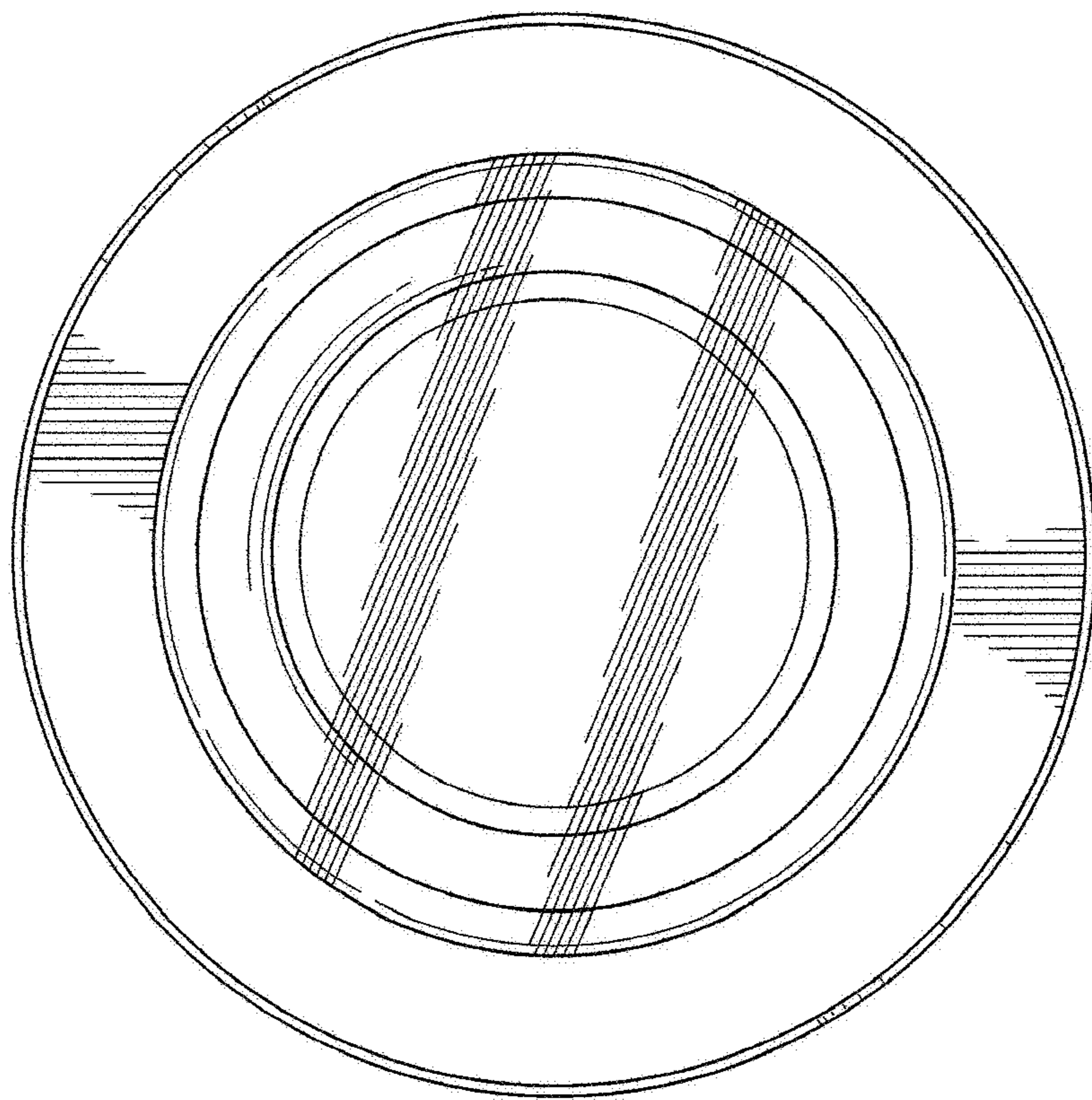

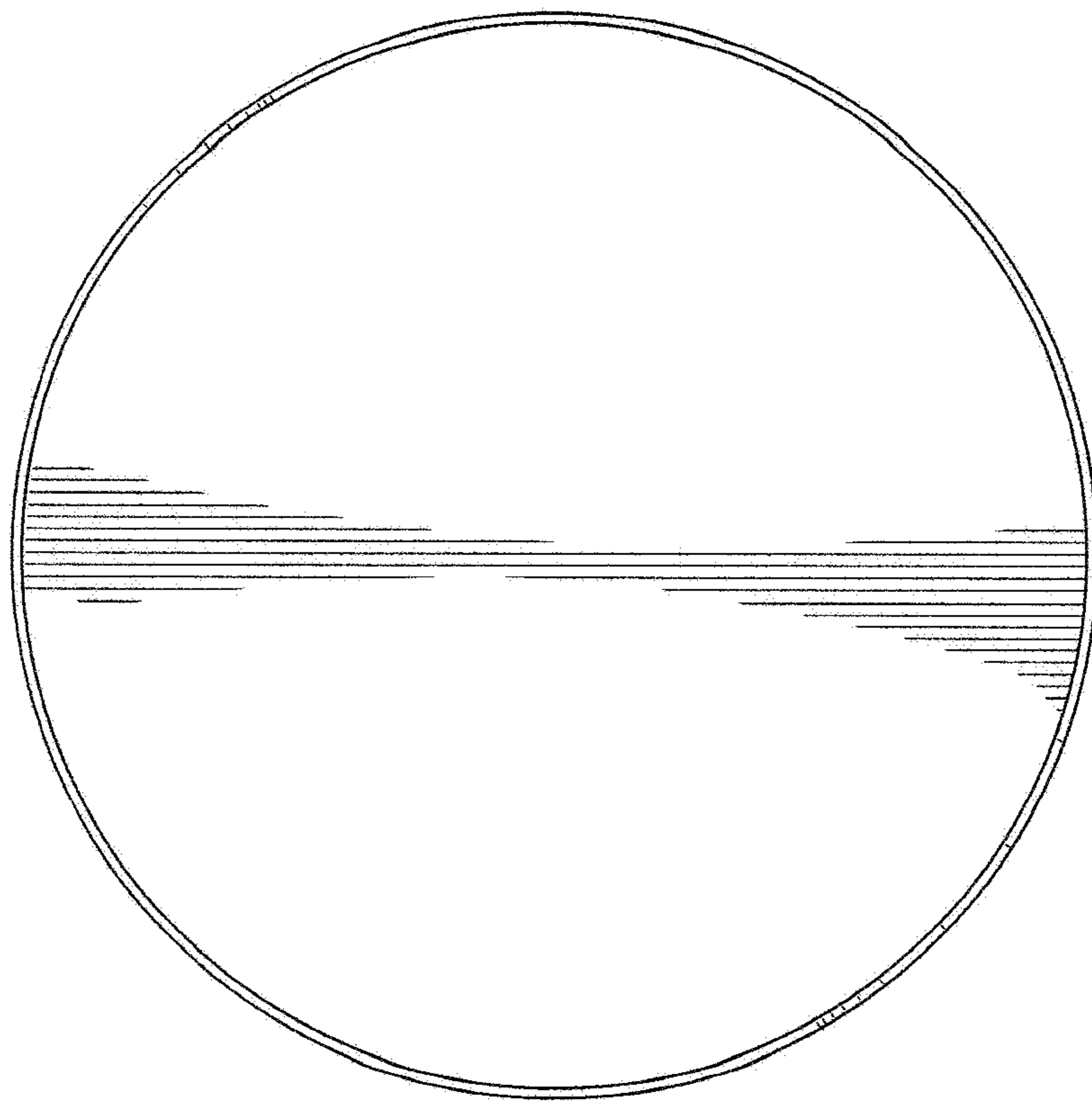

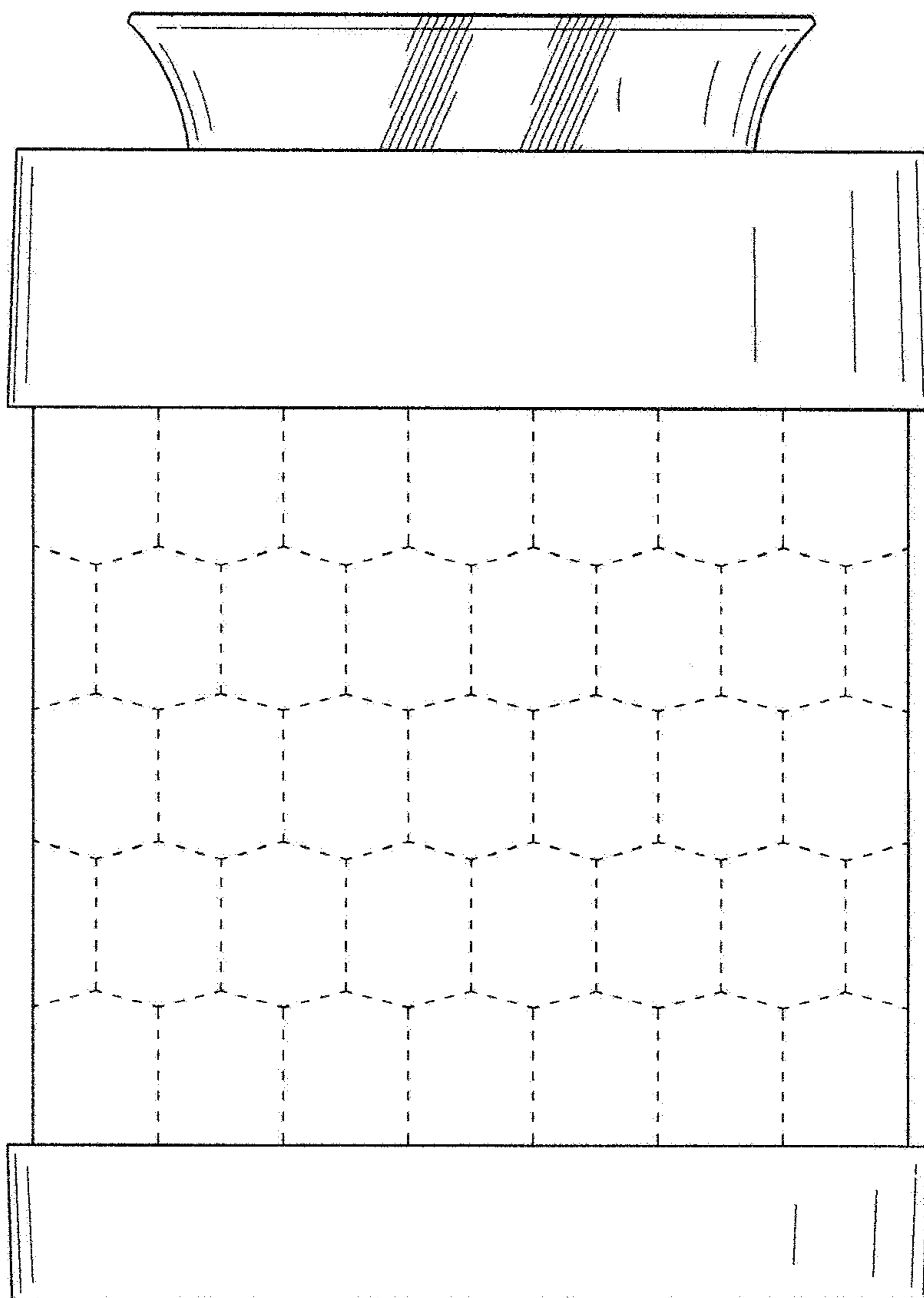

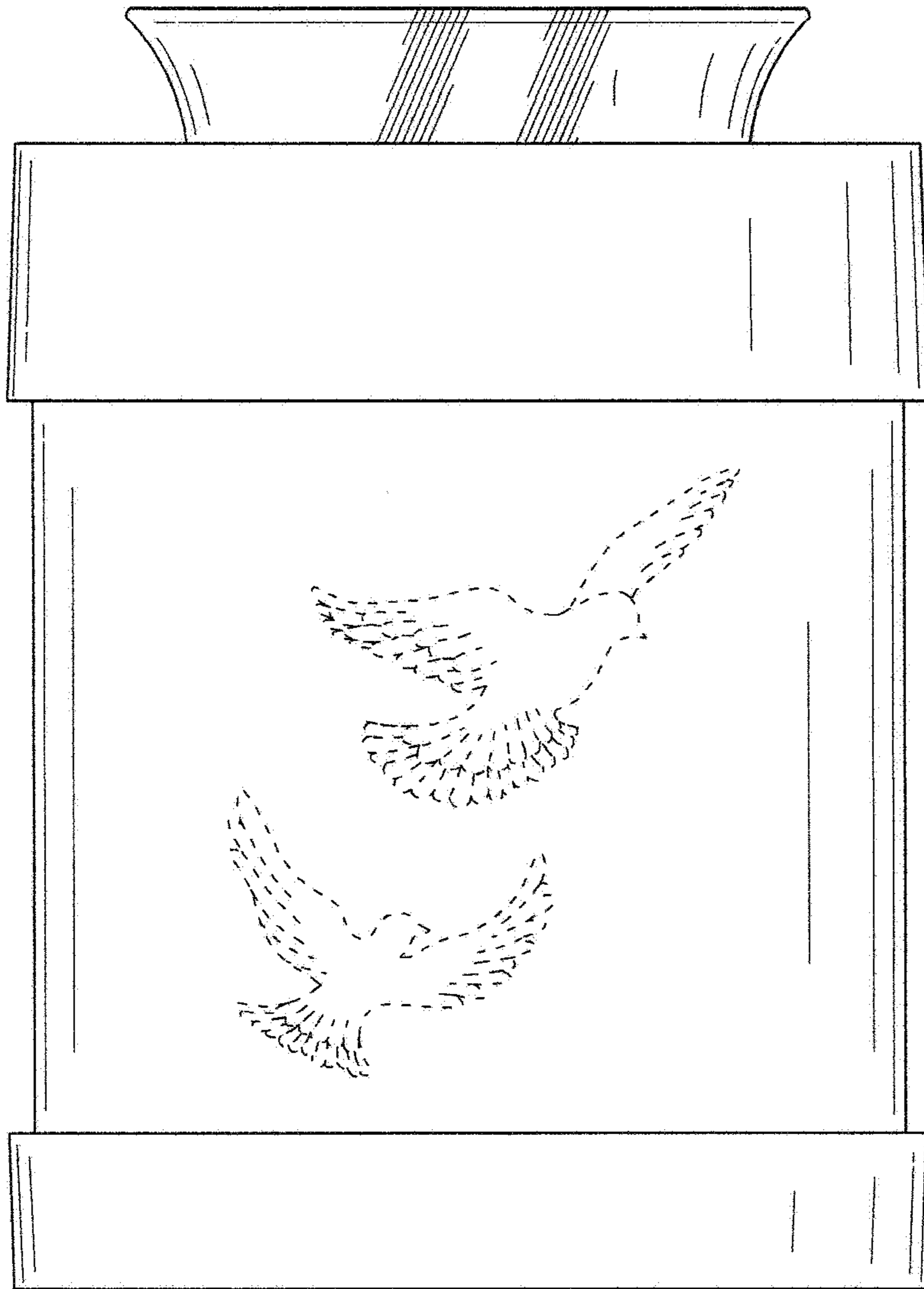

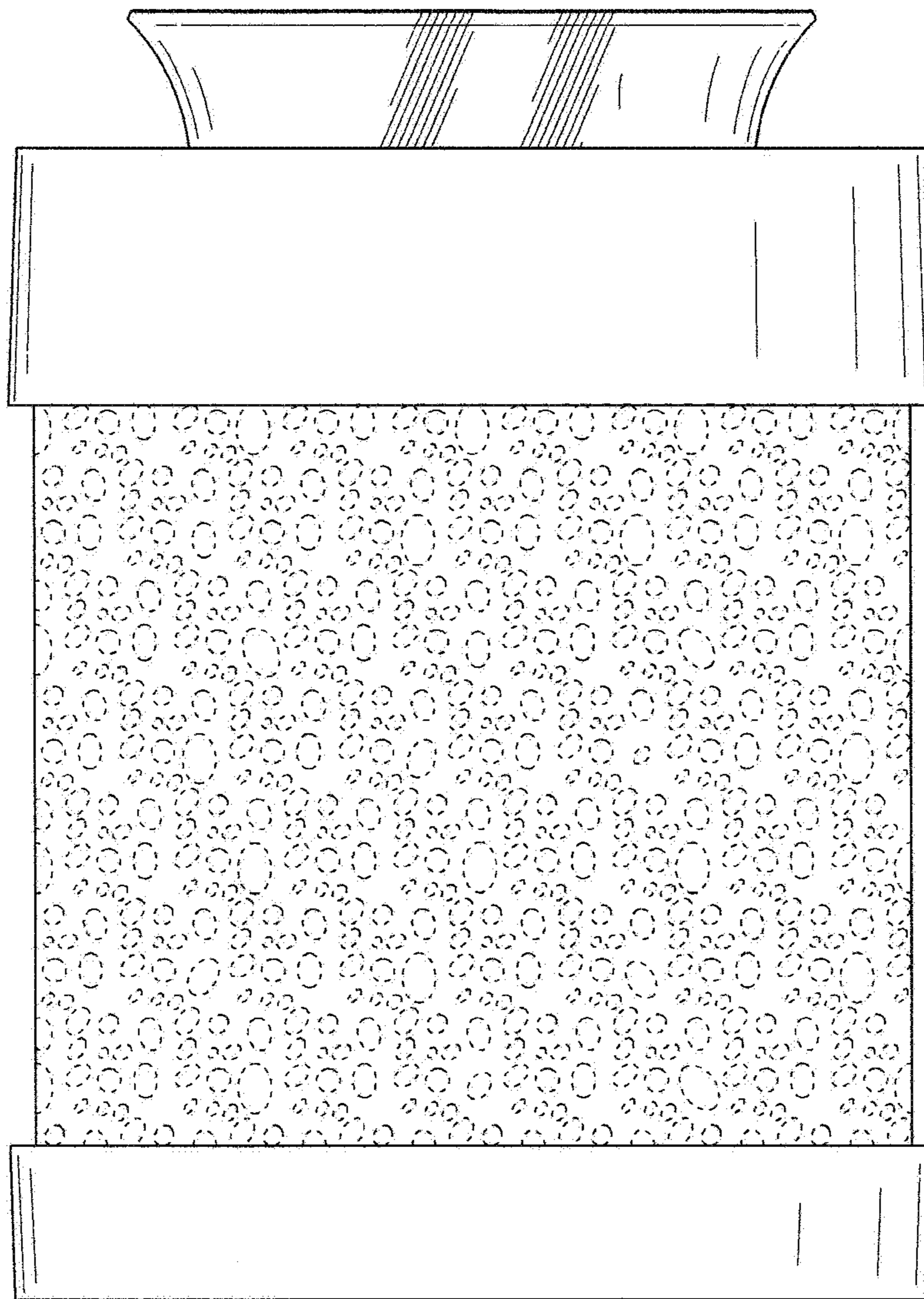

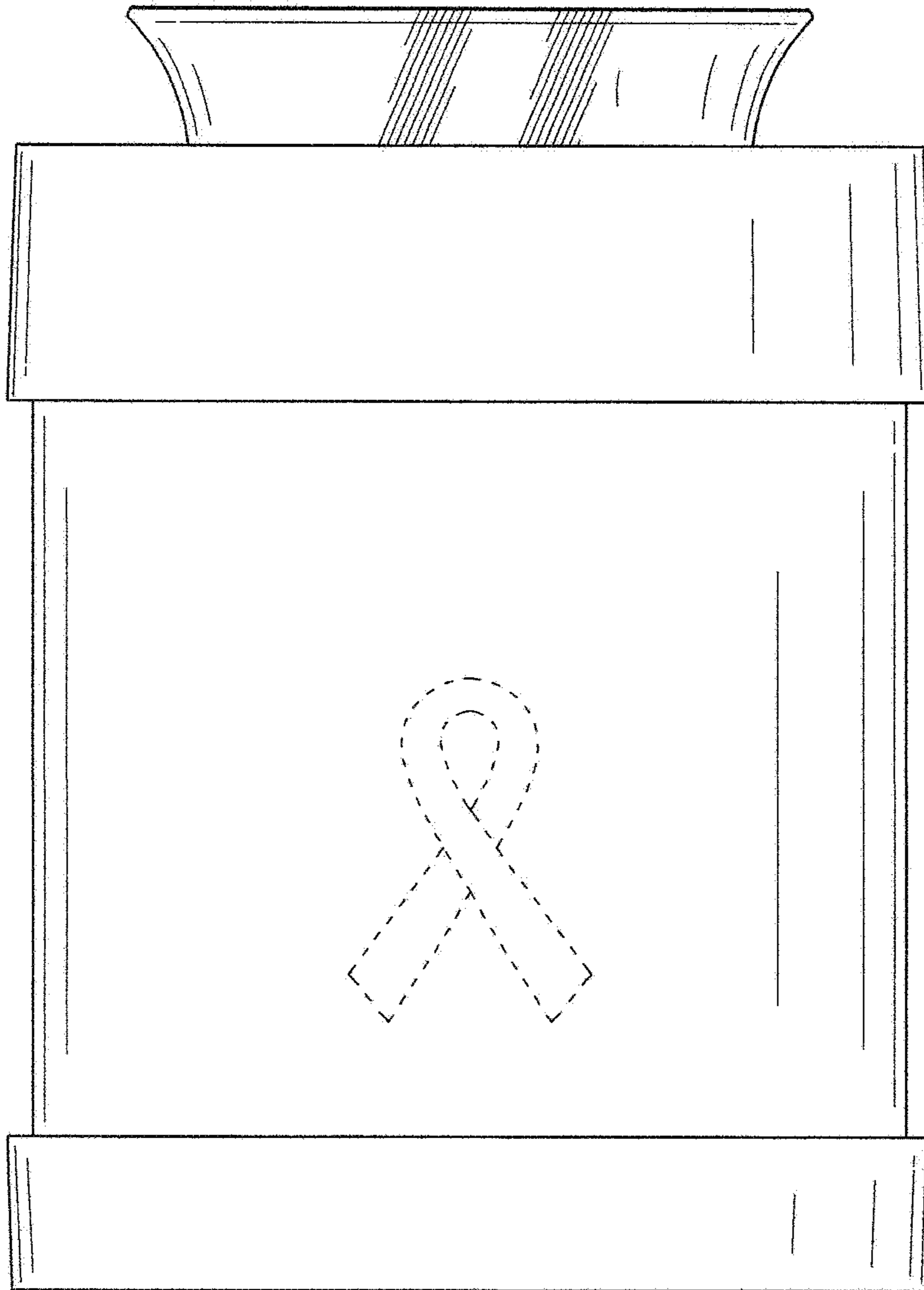
