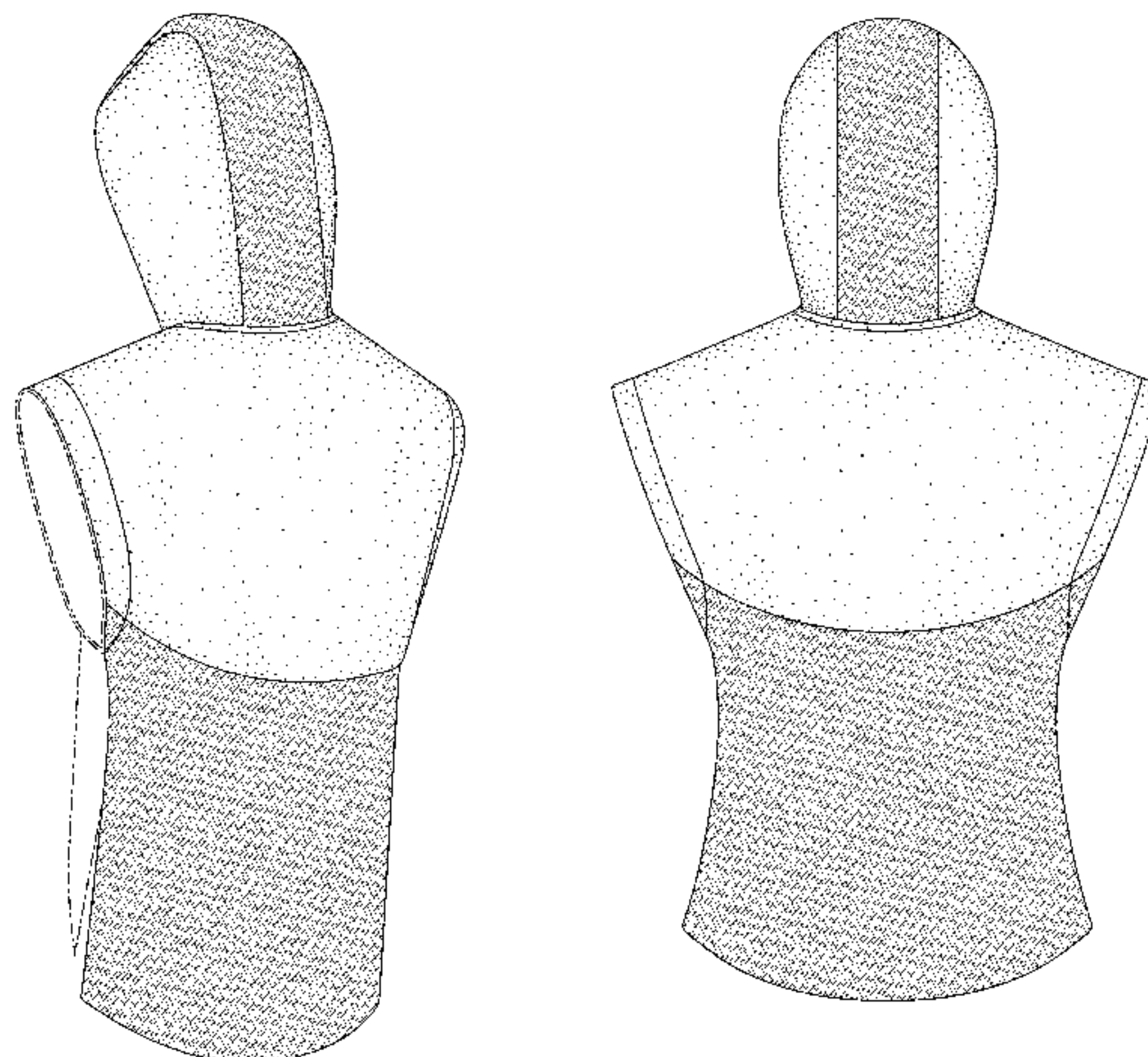
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear perspective view of a garment showing my new design in an in-use configuration;

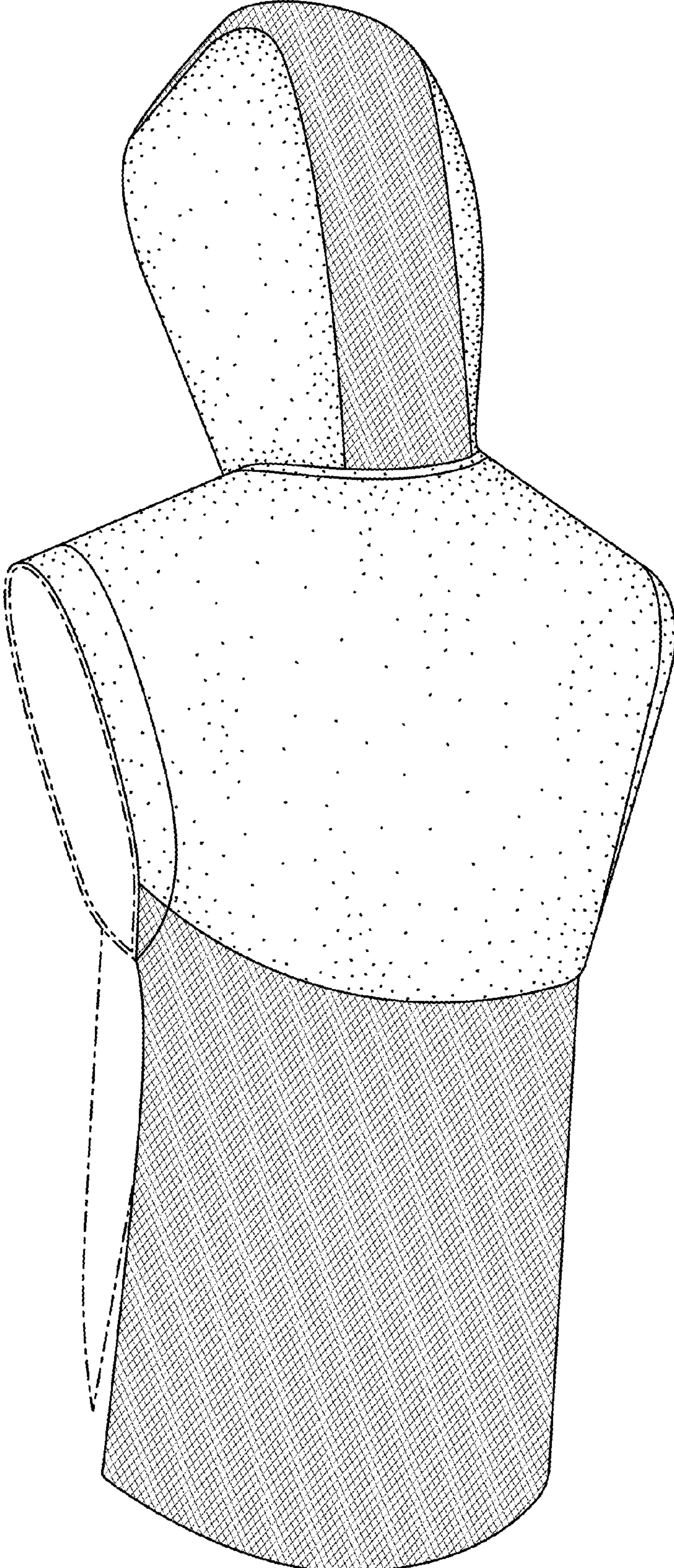

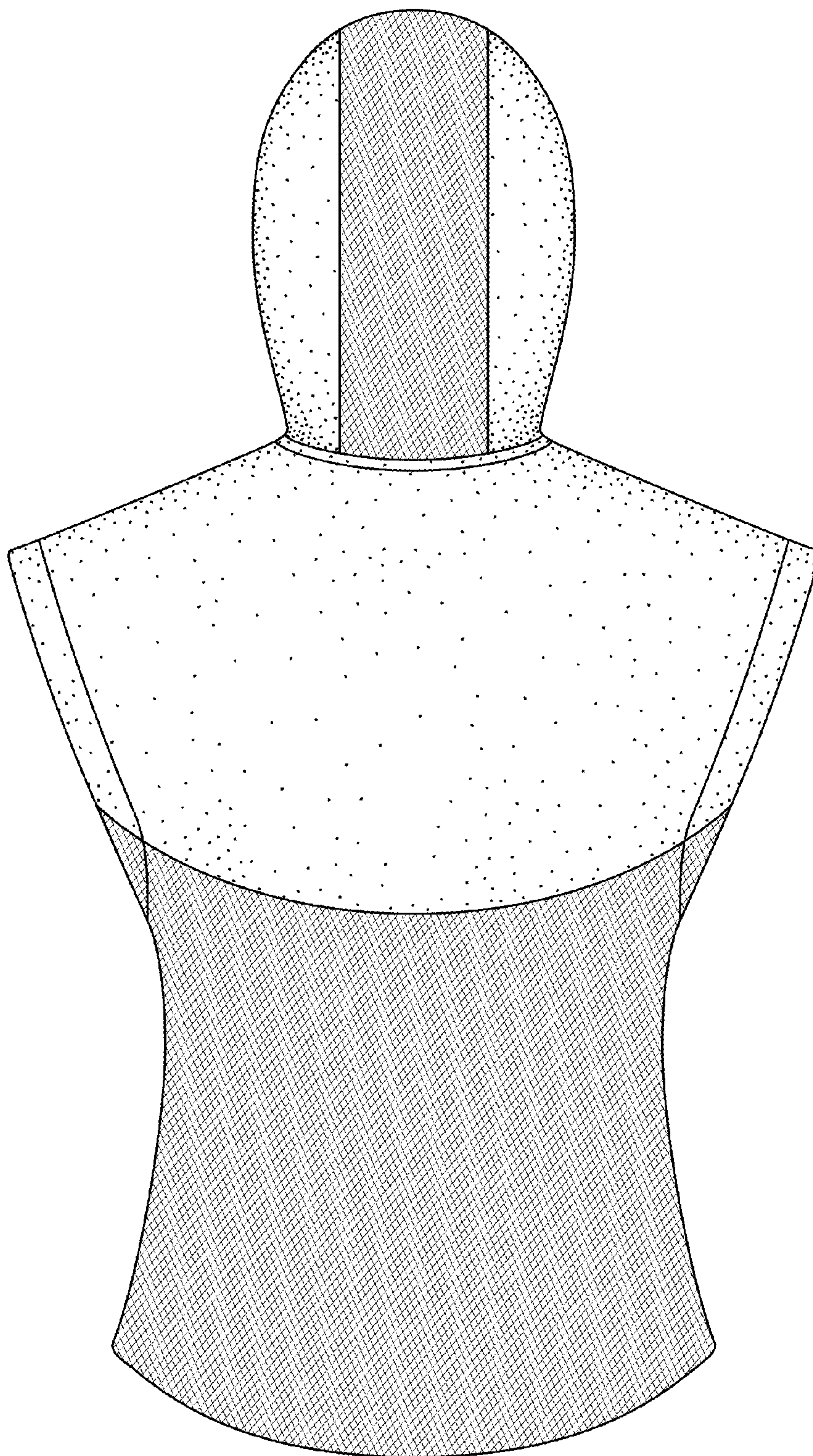

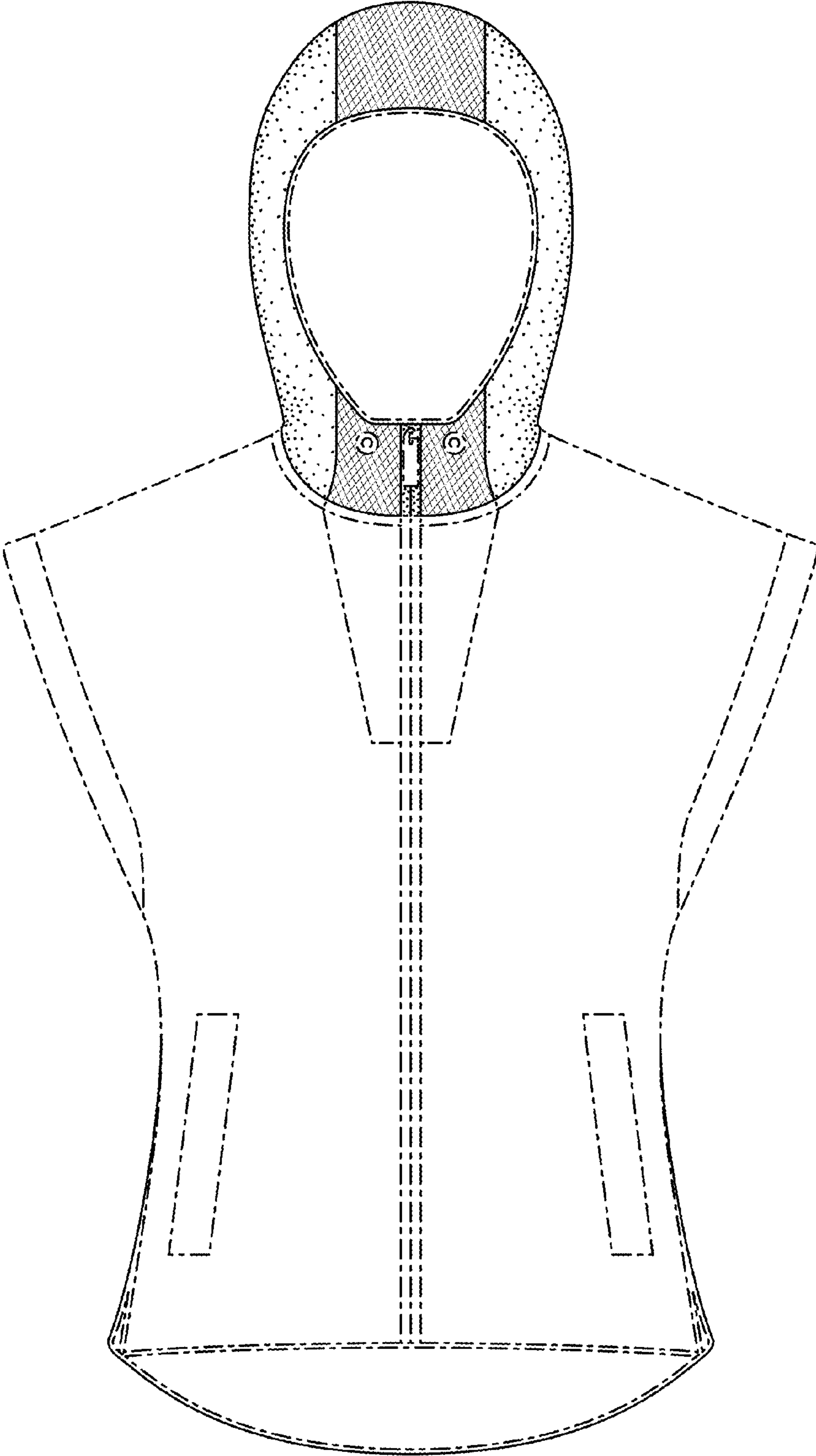

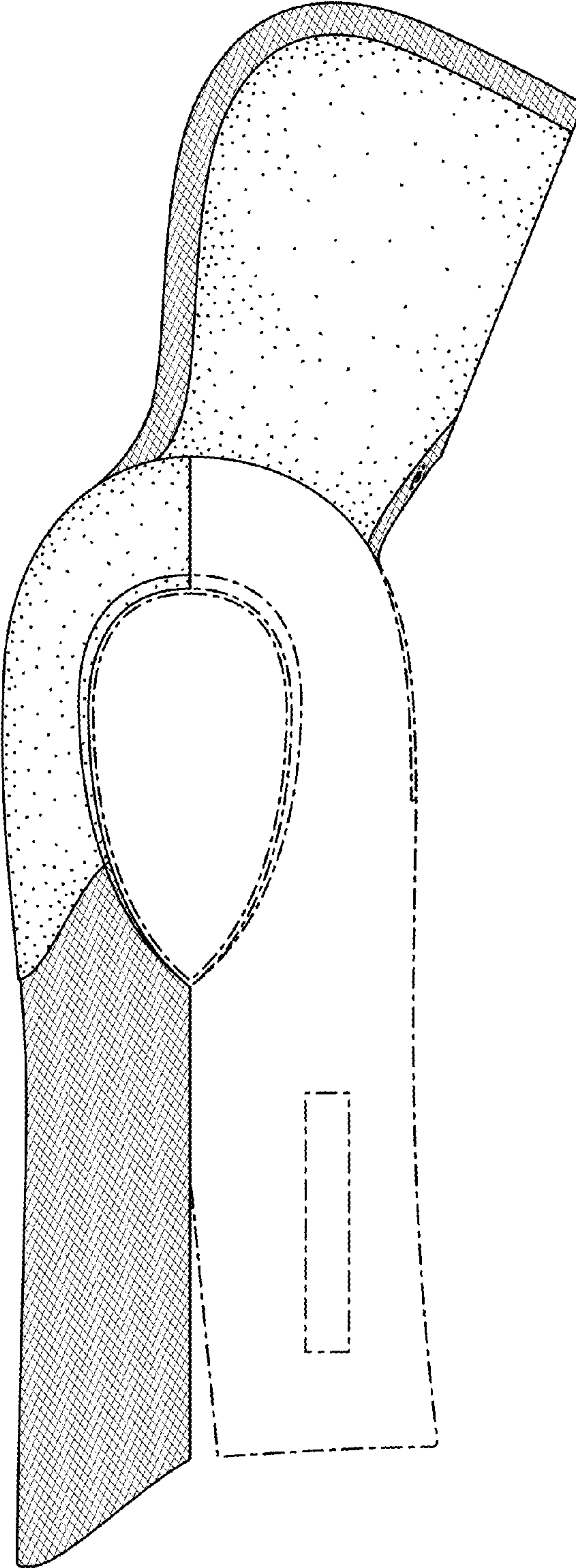

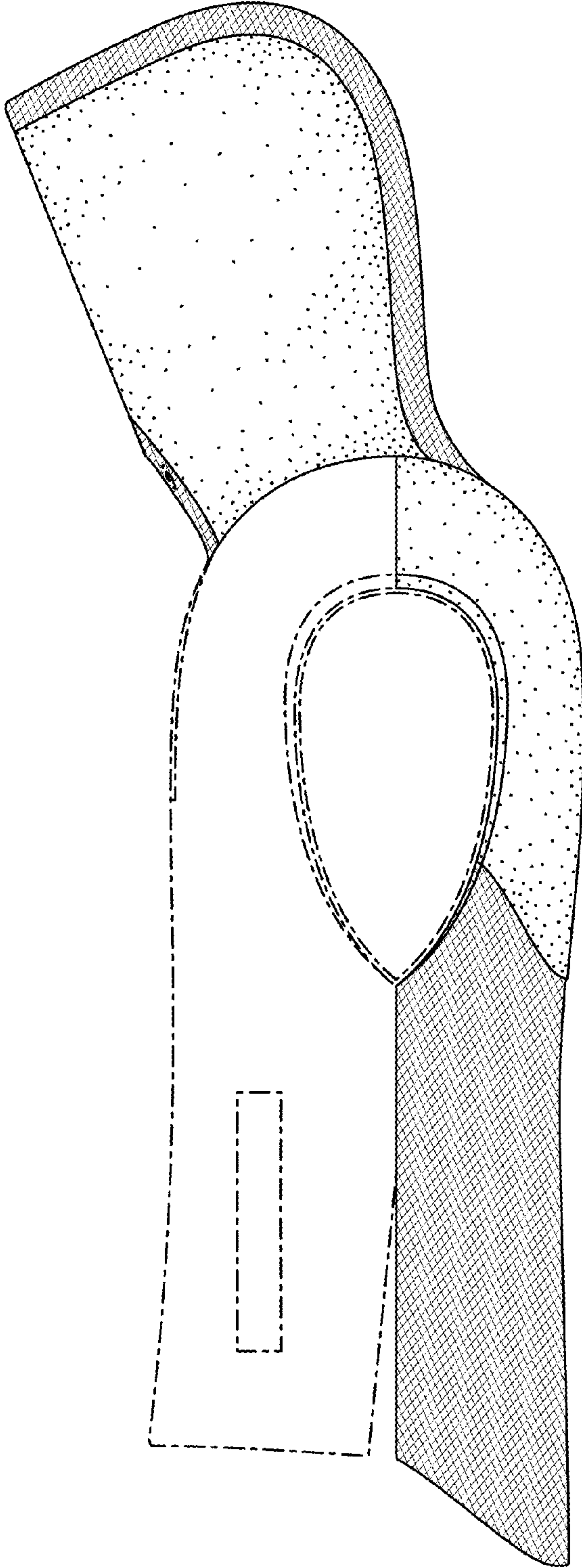

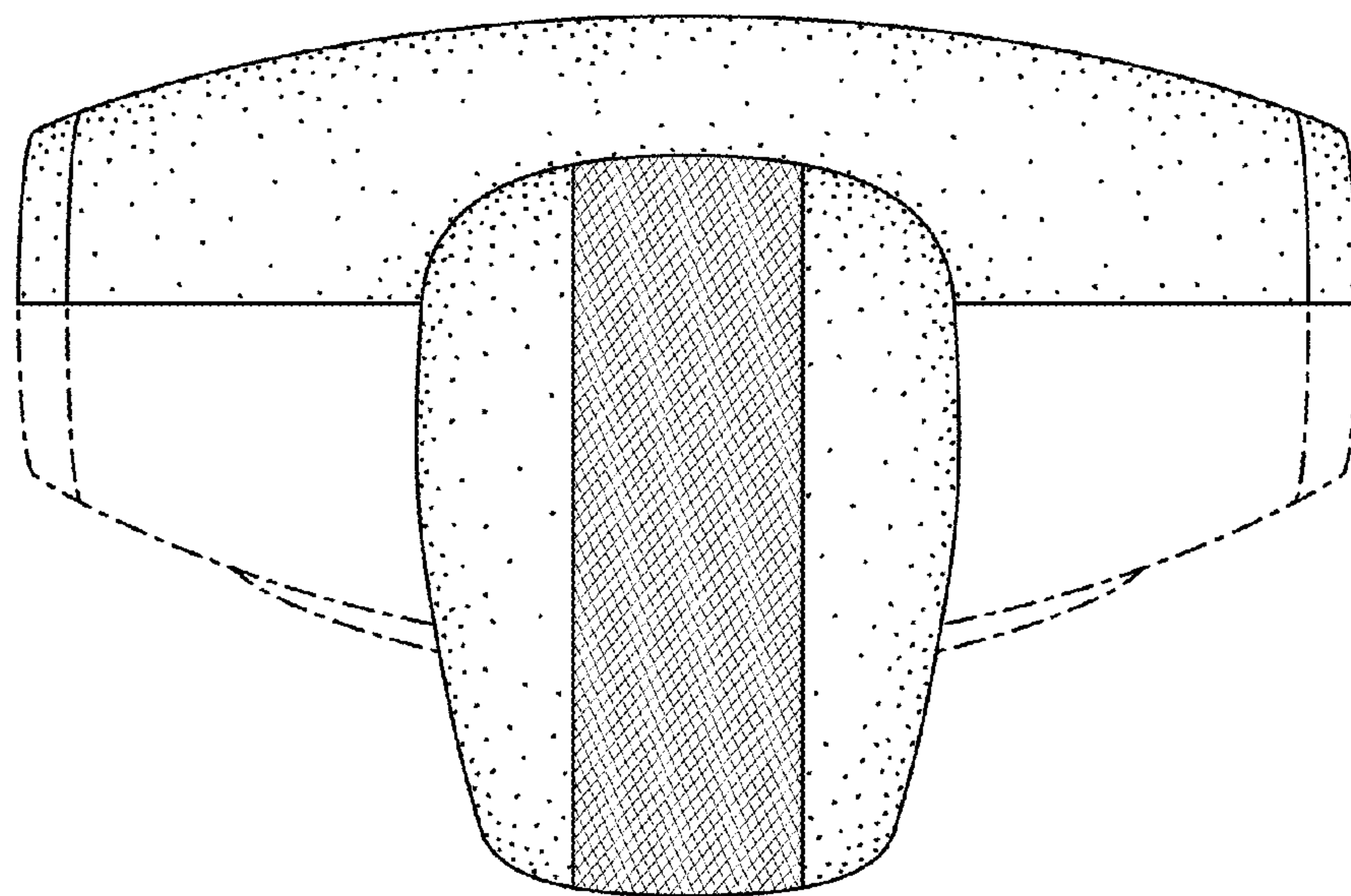

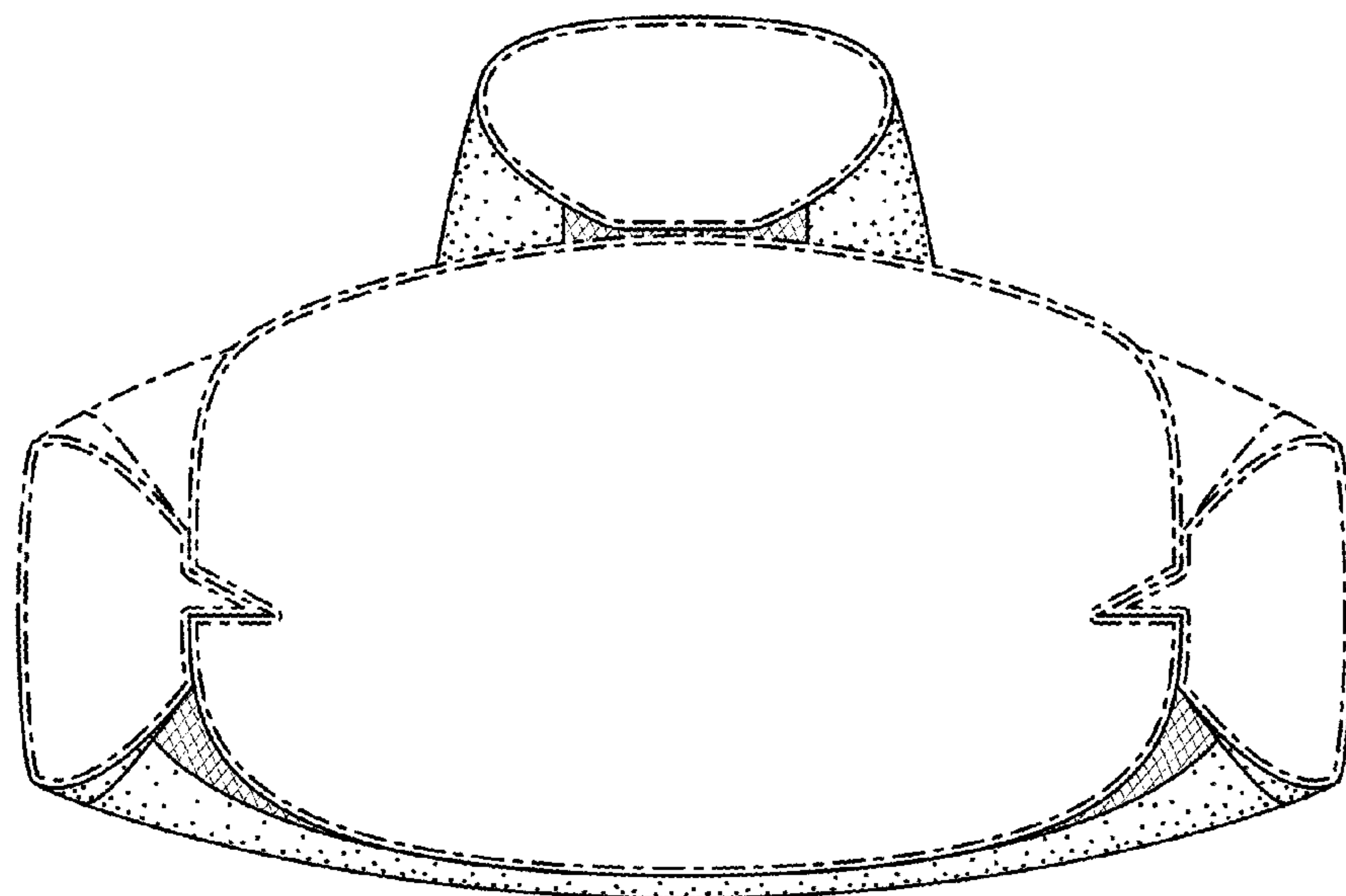
