(57) **CLAIM**

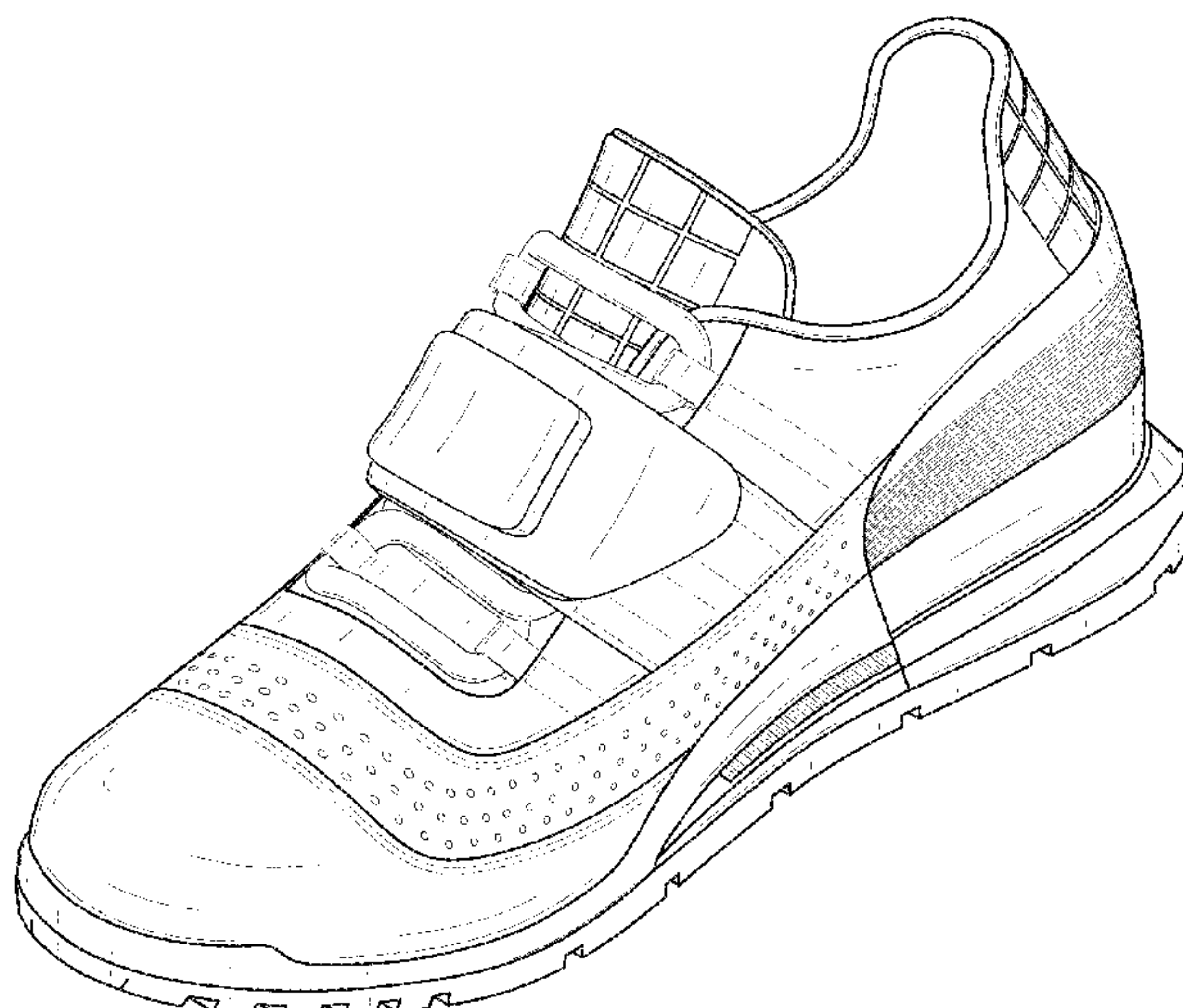
The ornamental design for an article of footwear with integrated sensor, as shown and described.

DESCRIPTION

FIG. 1 is a front, top perspective view of an article of footwear with integrated sensor showing my new design;

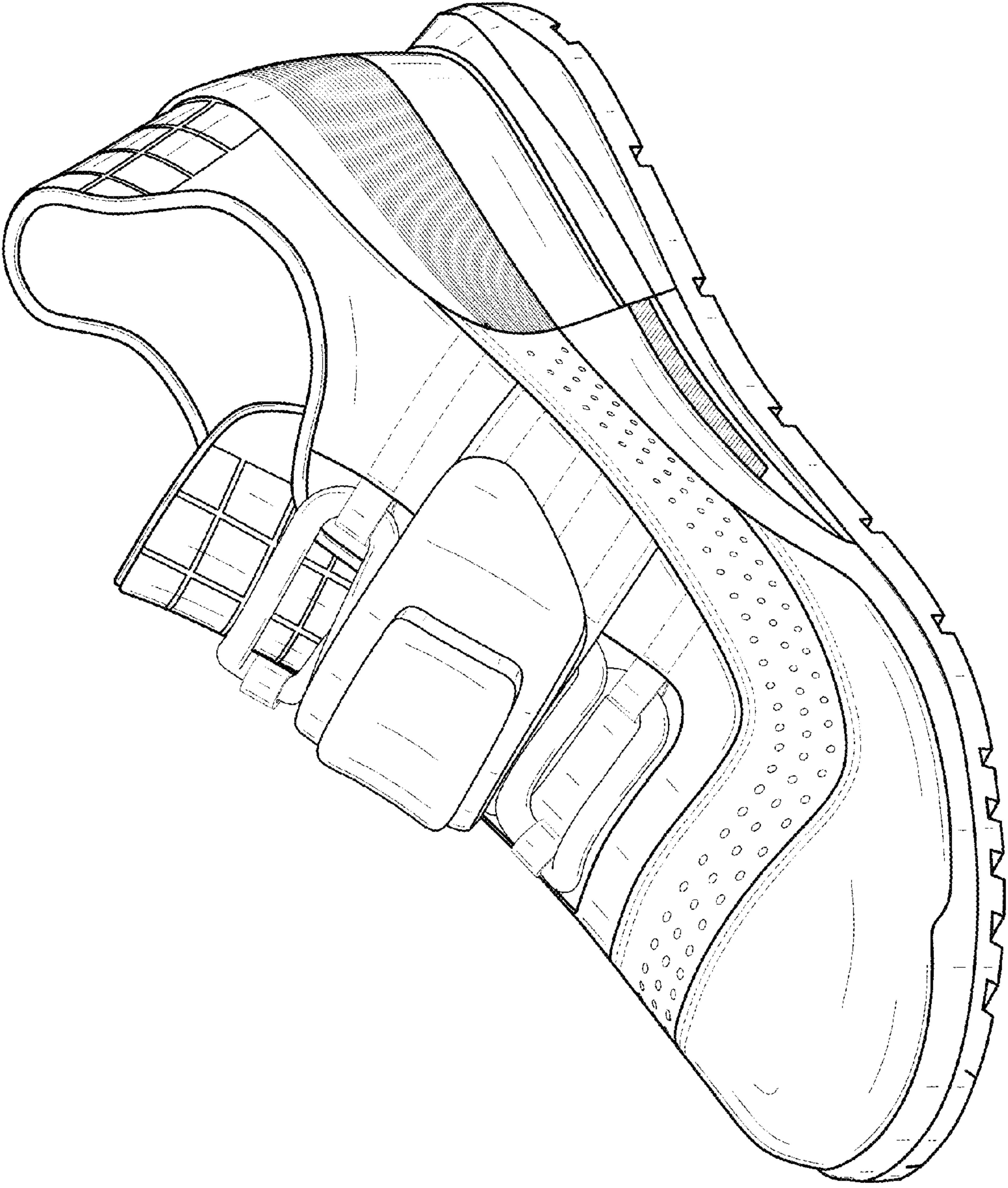

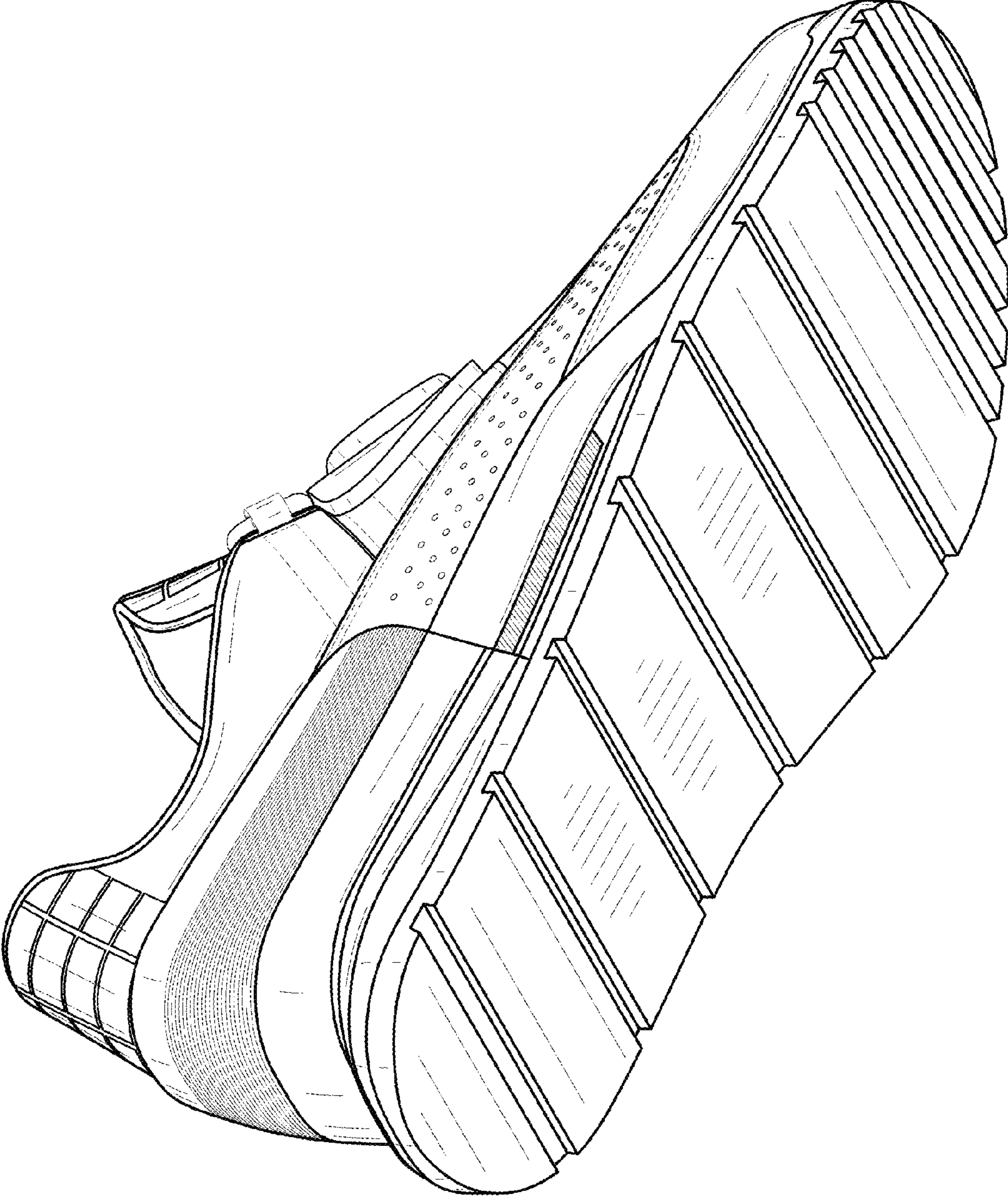

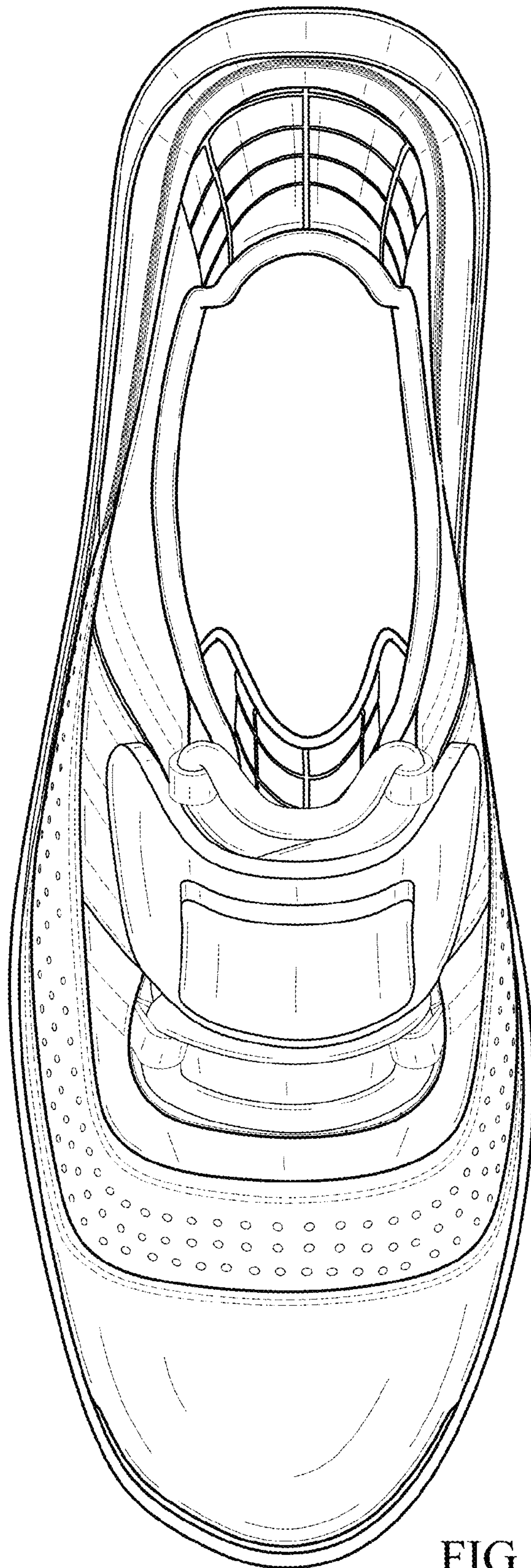

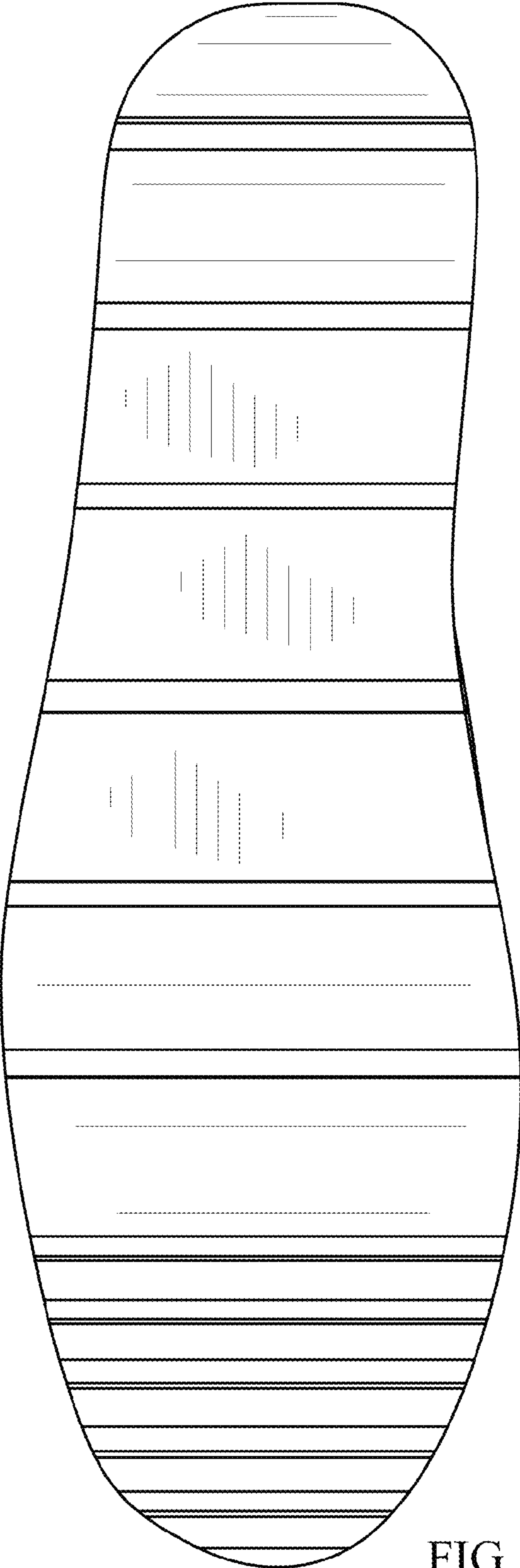

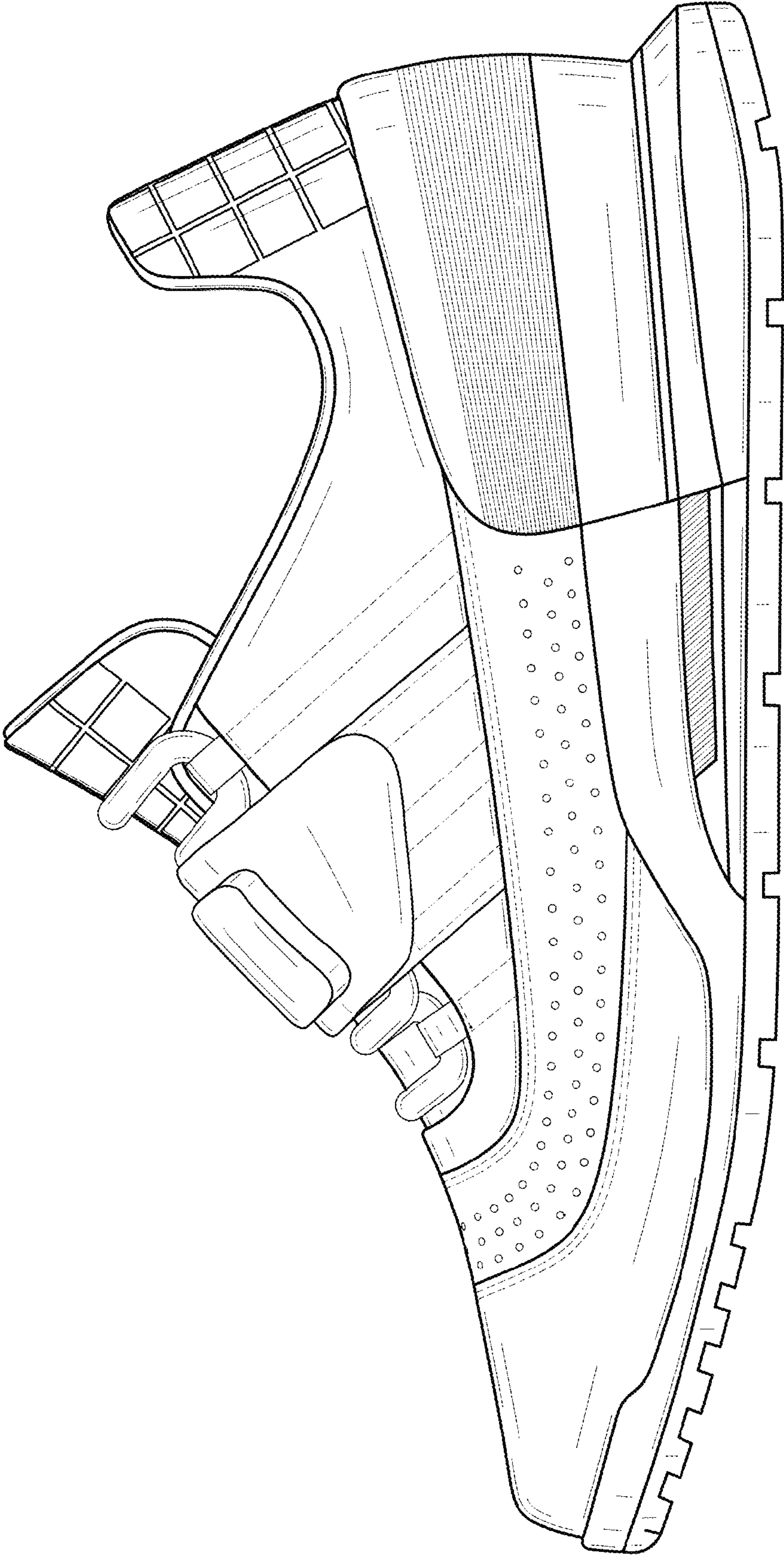

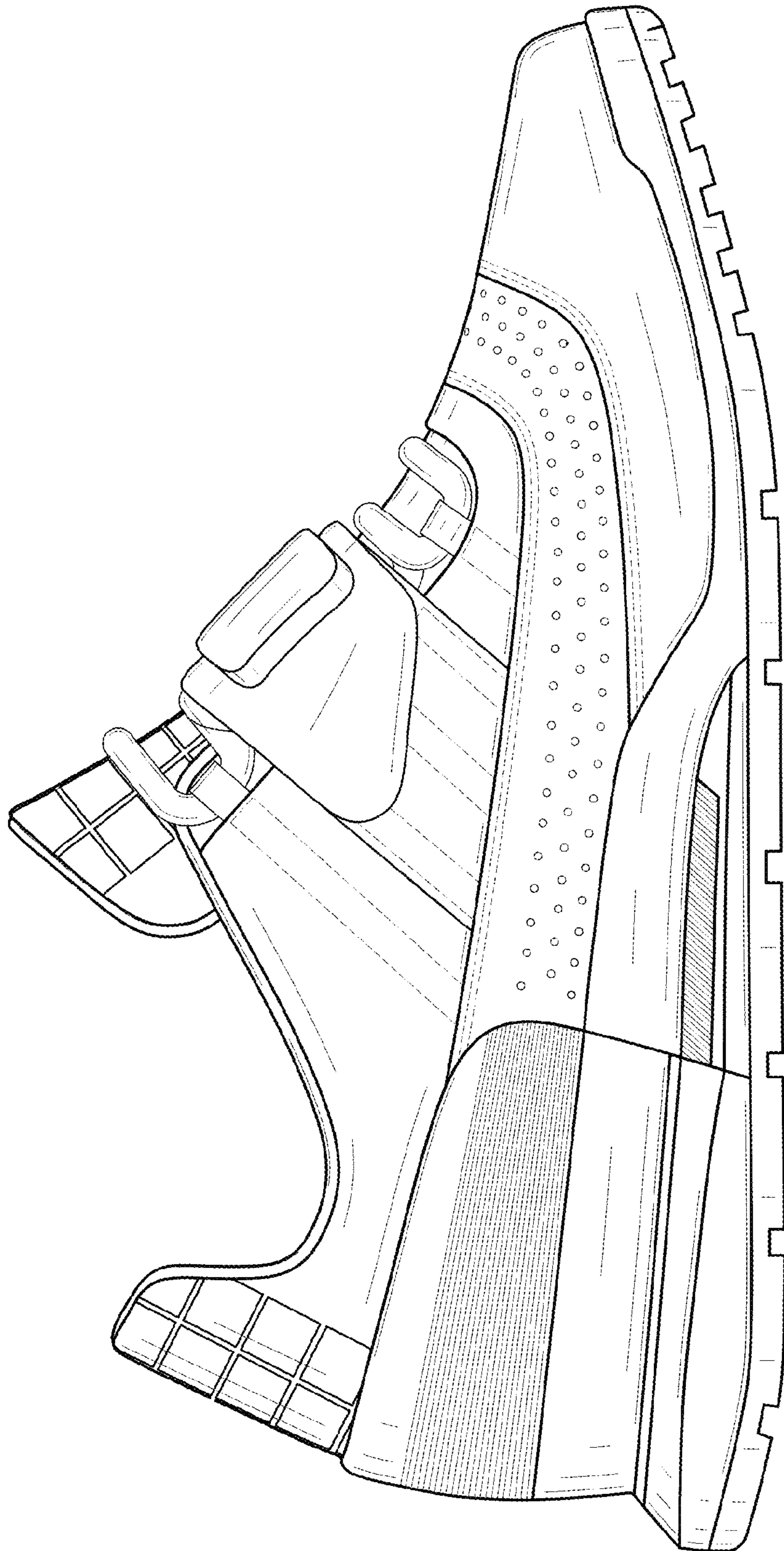

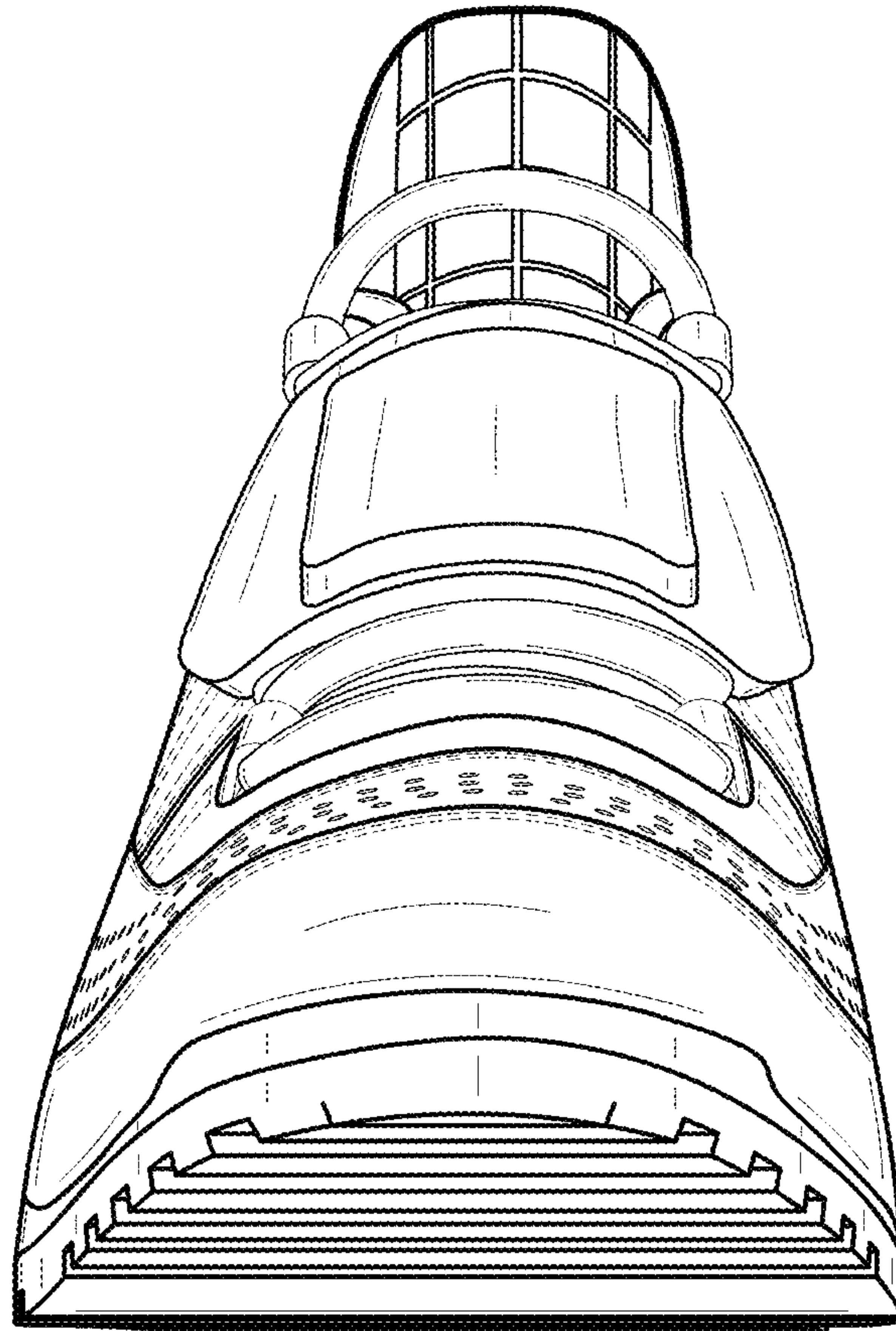

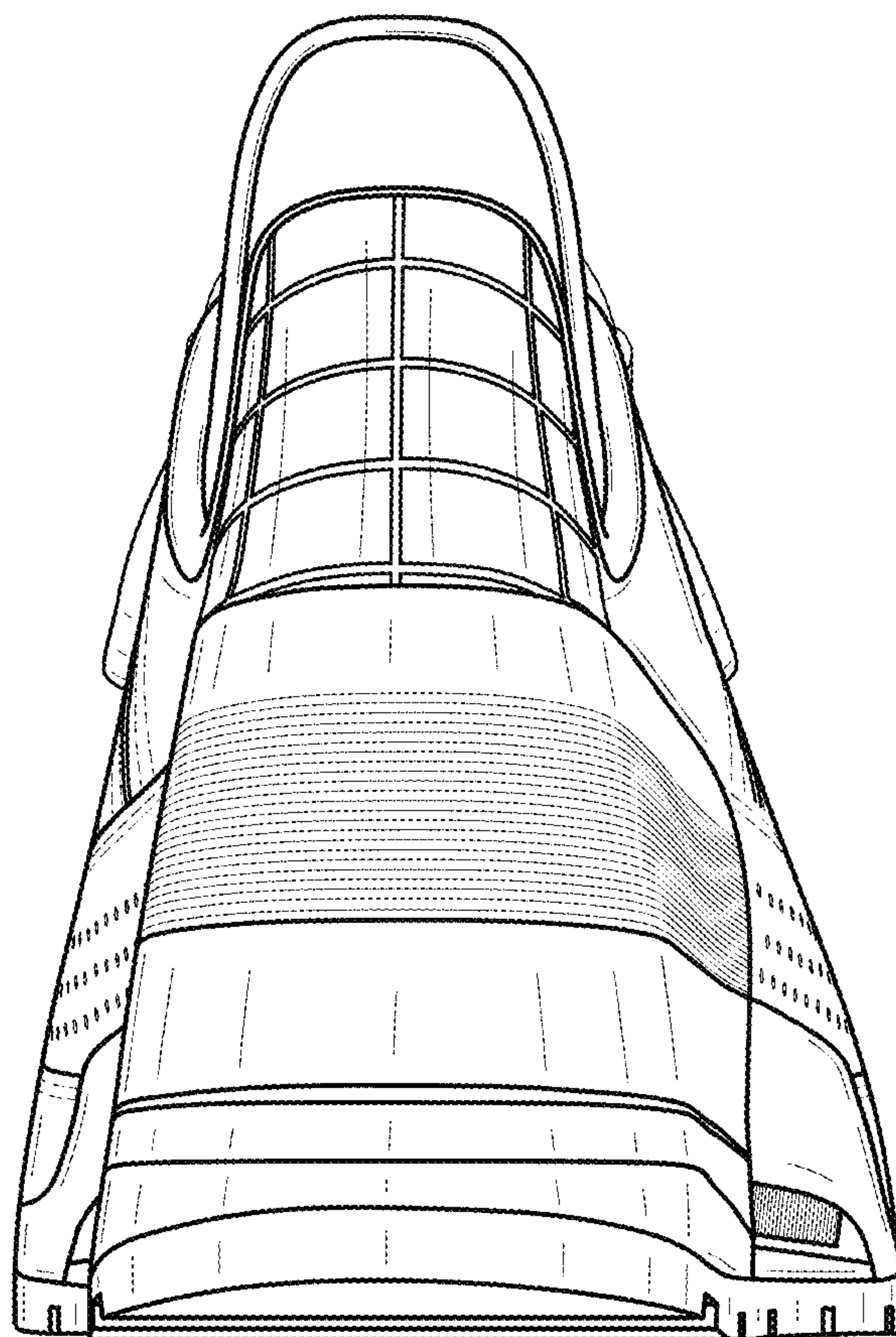
