(57) **CLAIM**

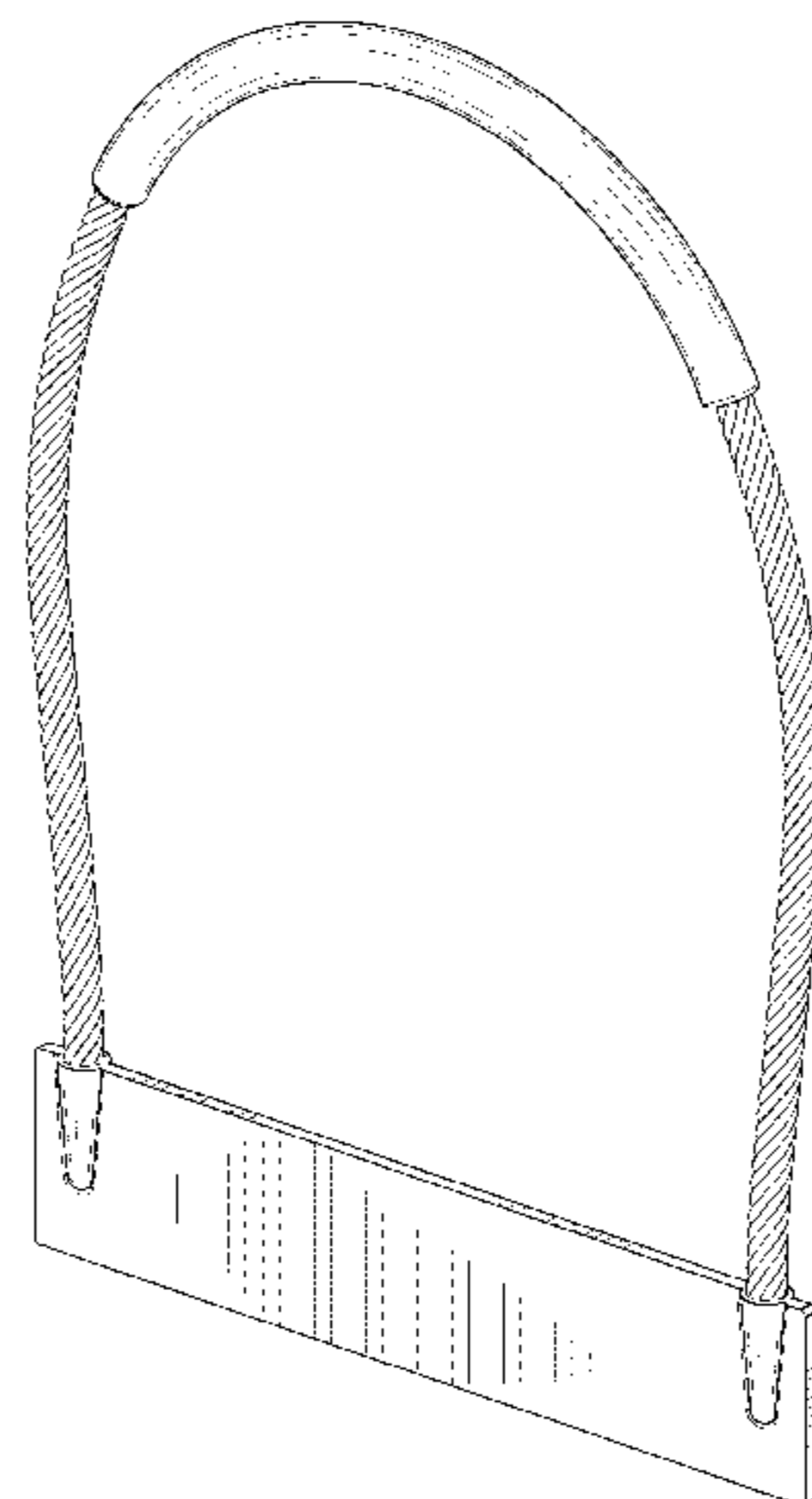
The ornamental design for a handle for handbag, as shown and described.

DESCRIPTION

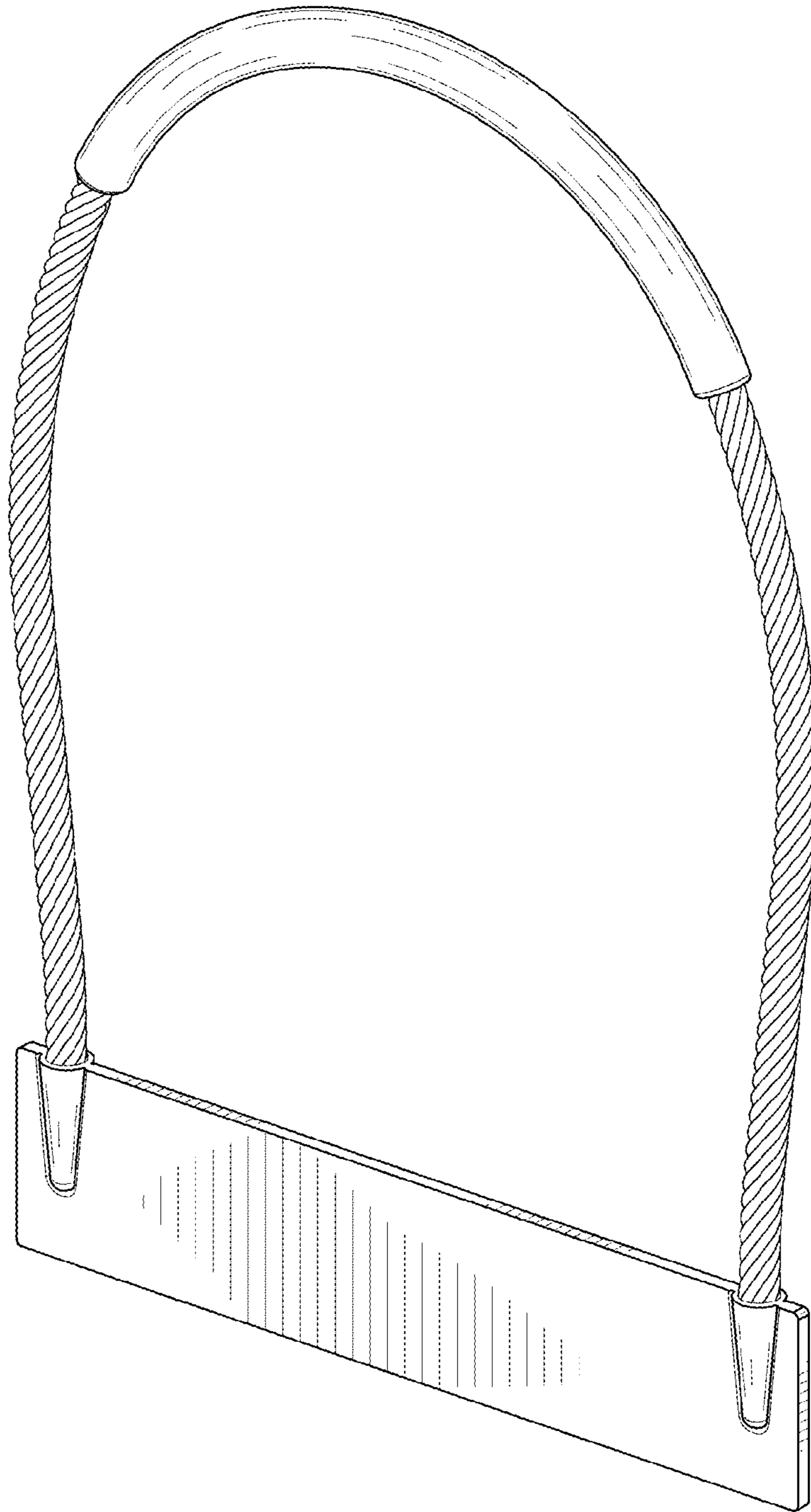

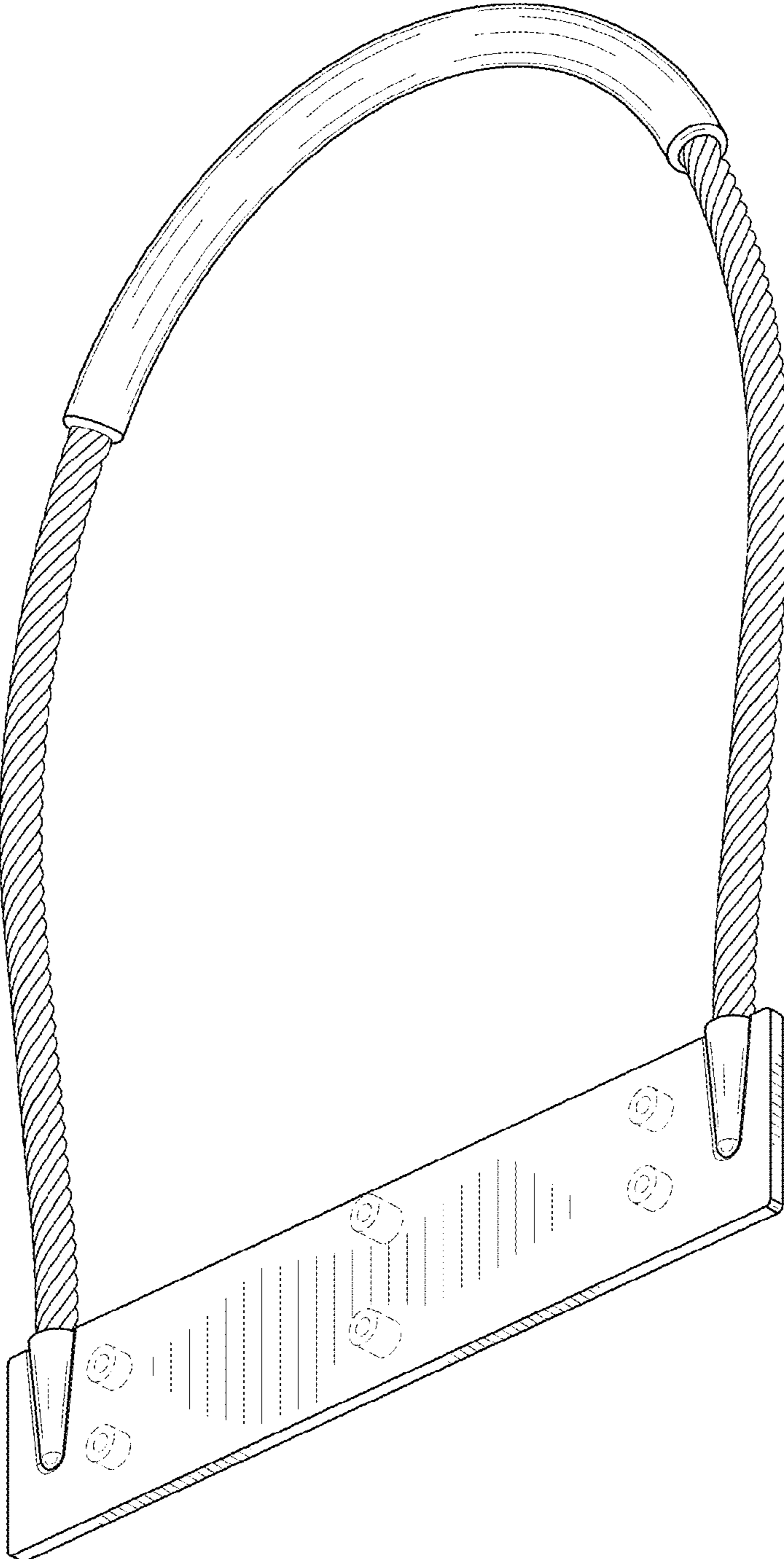

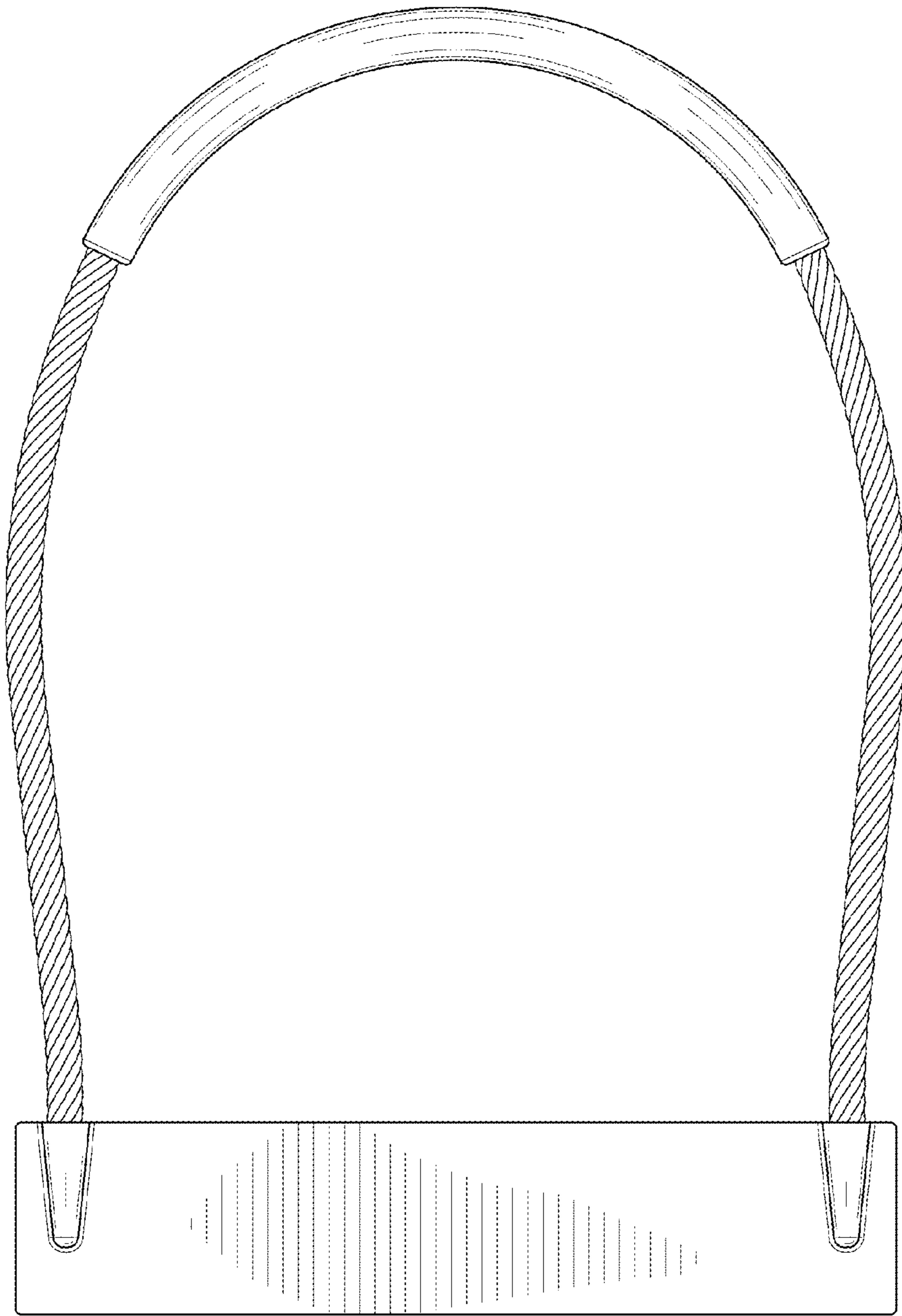

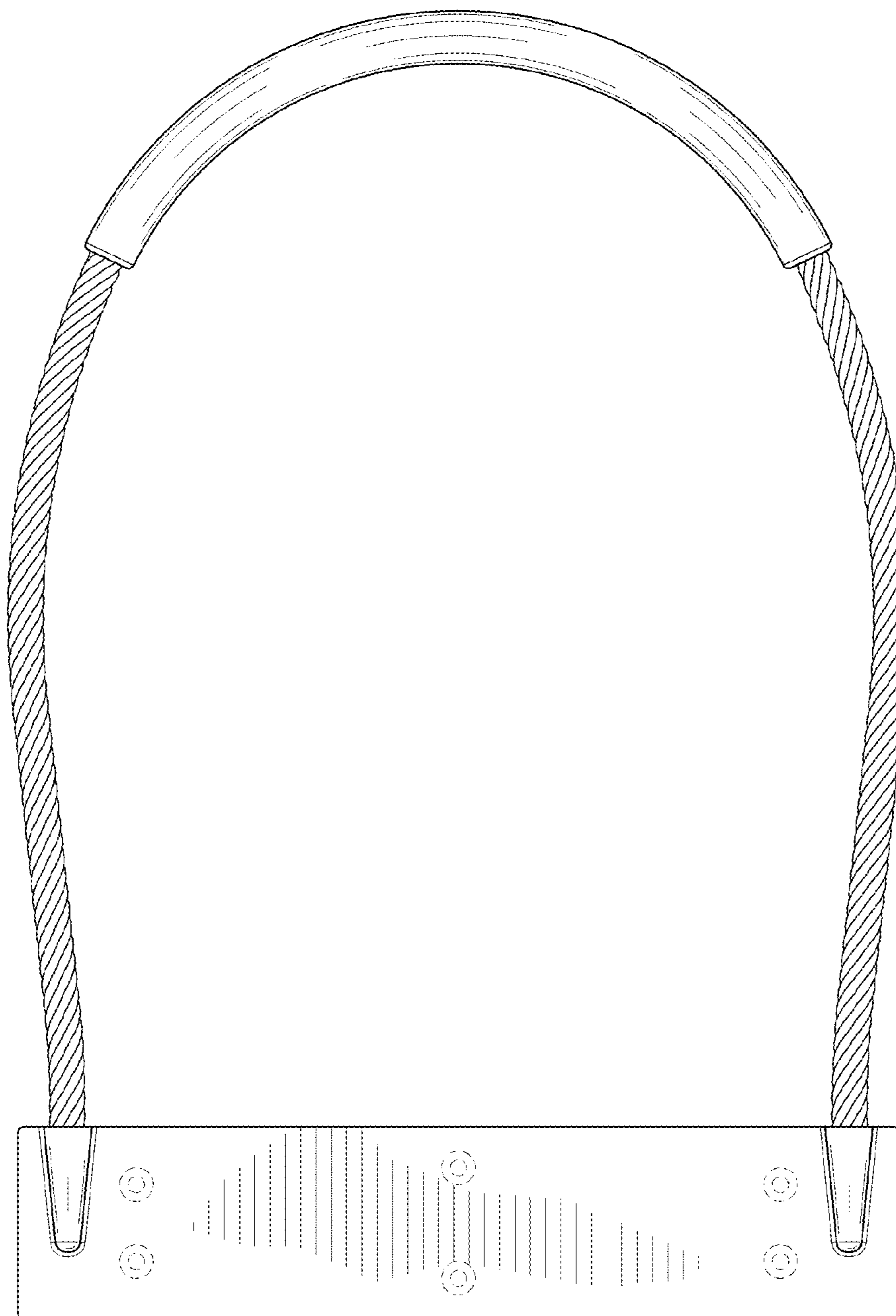

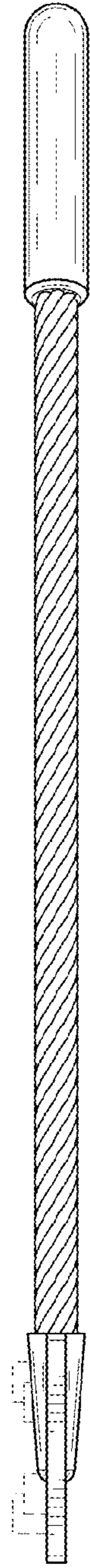

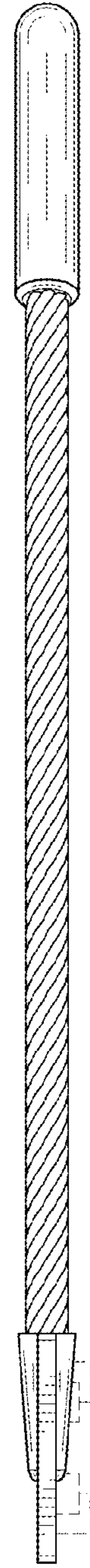

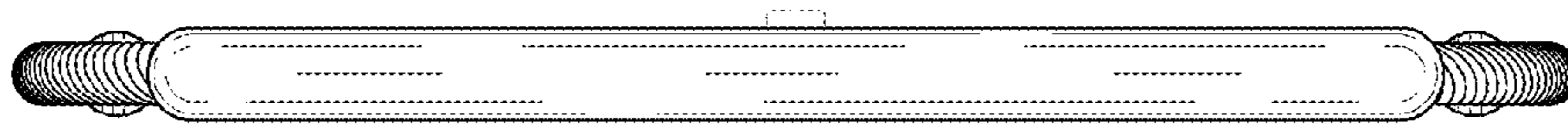

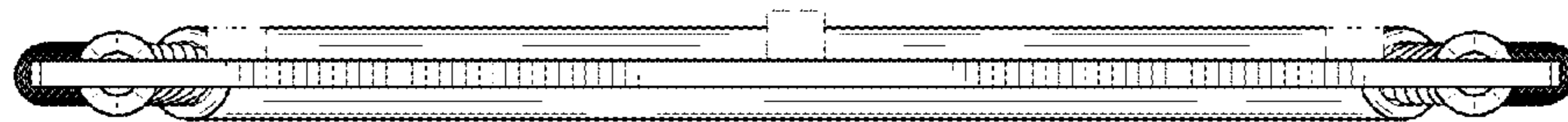
