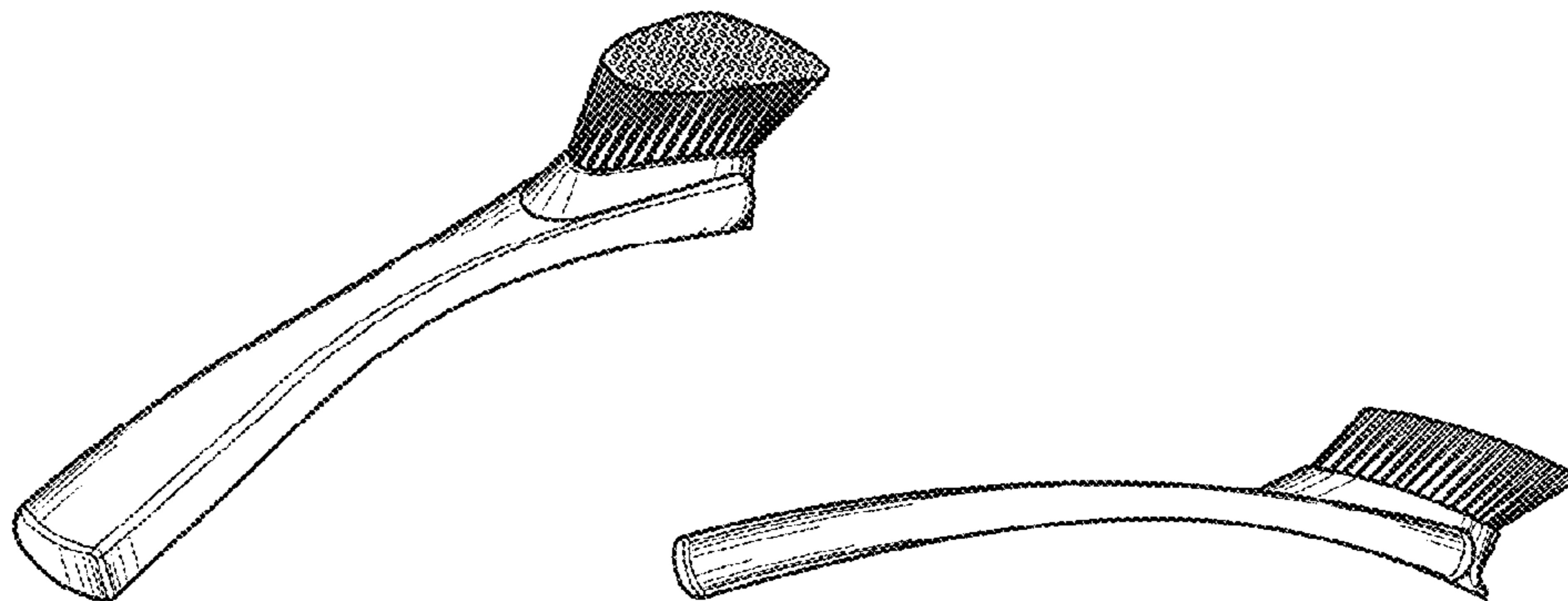

The ornamental design for a laid back brush, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the first embodiment of the laid back brush;  
 FIG. 2 is a right-hand view thereof, the left-hand elevation view being a mirror image thereof;  
 FIG. 3 is a bottom view thereof;  
 FIG. 4 is a top view thereof;  
 FIG. 5 is a front view thereof; and  
 FIG. 6 is back view thereof; and  
 FIG. 7 is a perspective view of the second embodiment of the laid back brush;  
 FIG. 8 is a right-hand view thereof, the left-hand elevation view being a mirror image thereof;  
 FIG. 9 is a bottom view thereof;  
 FIG. 10 is a top view thereof;  
 FIG. 11 is a front view thereof; and,  
 FIG. 12 is back view thereof.

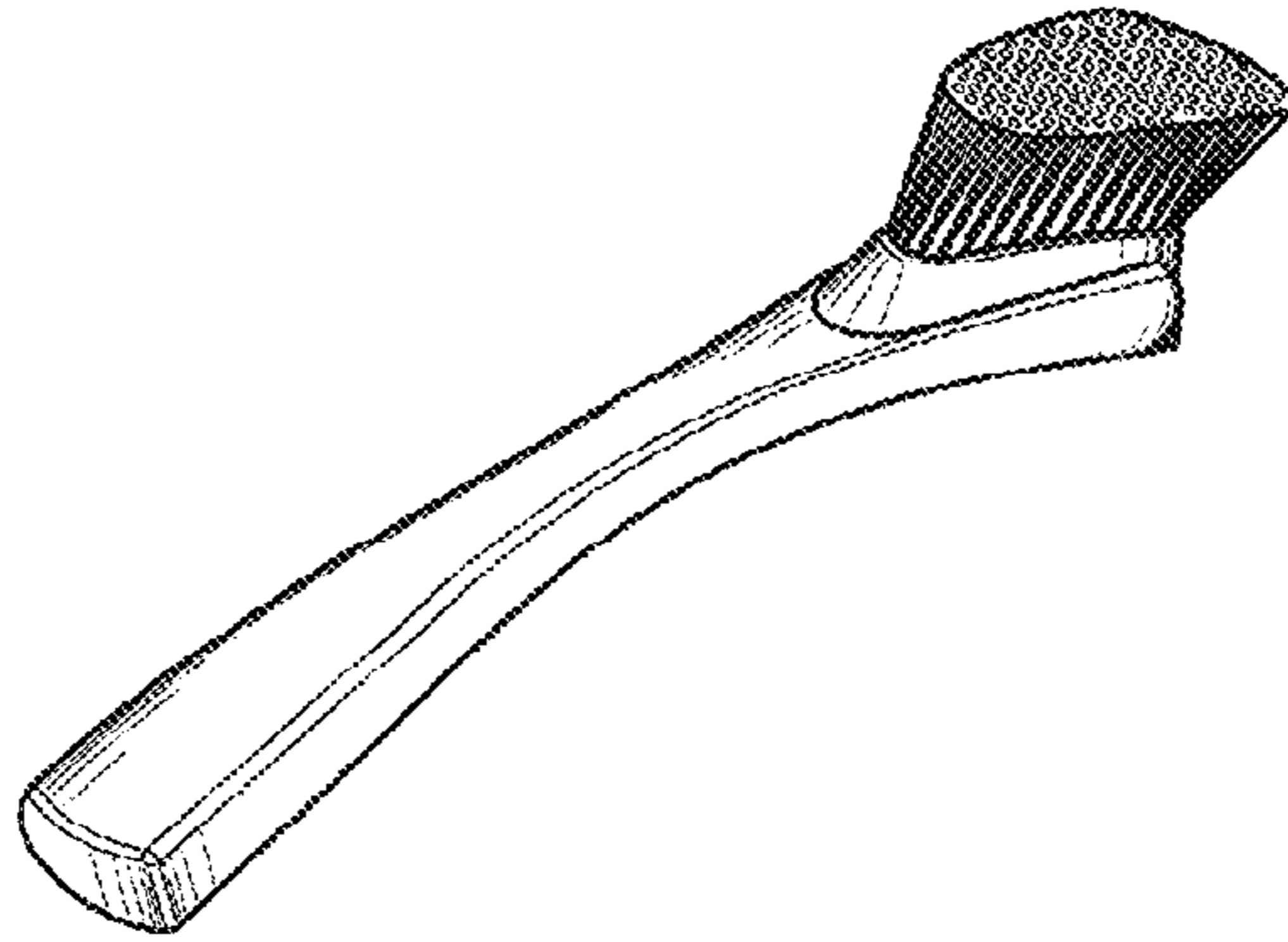

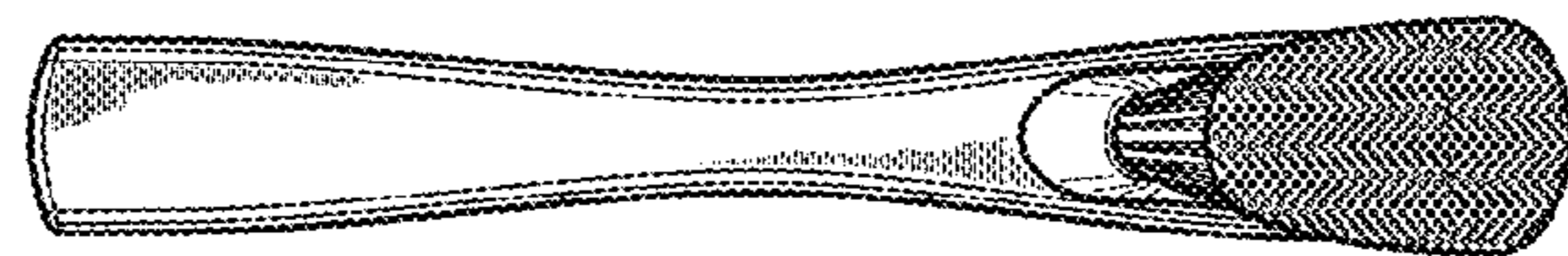

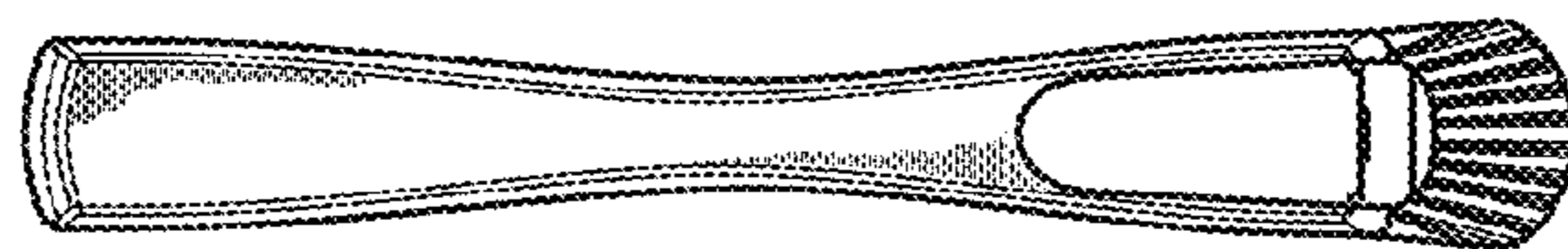

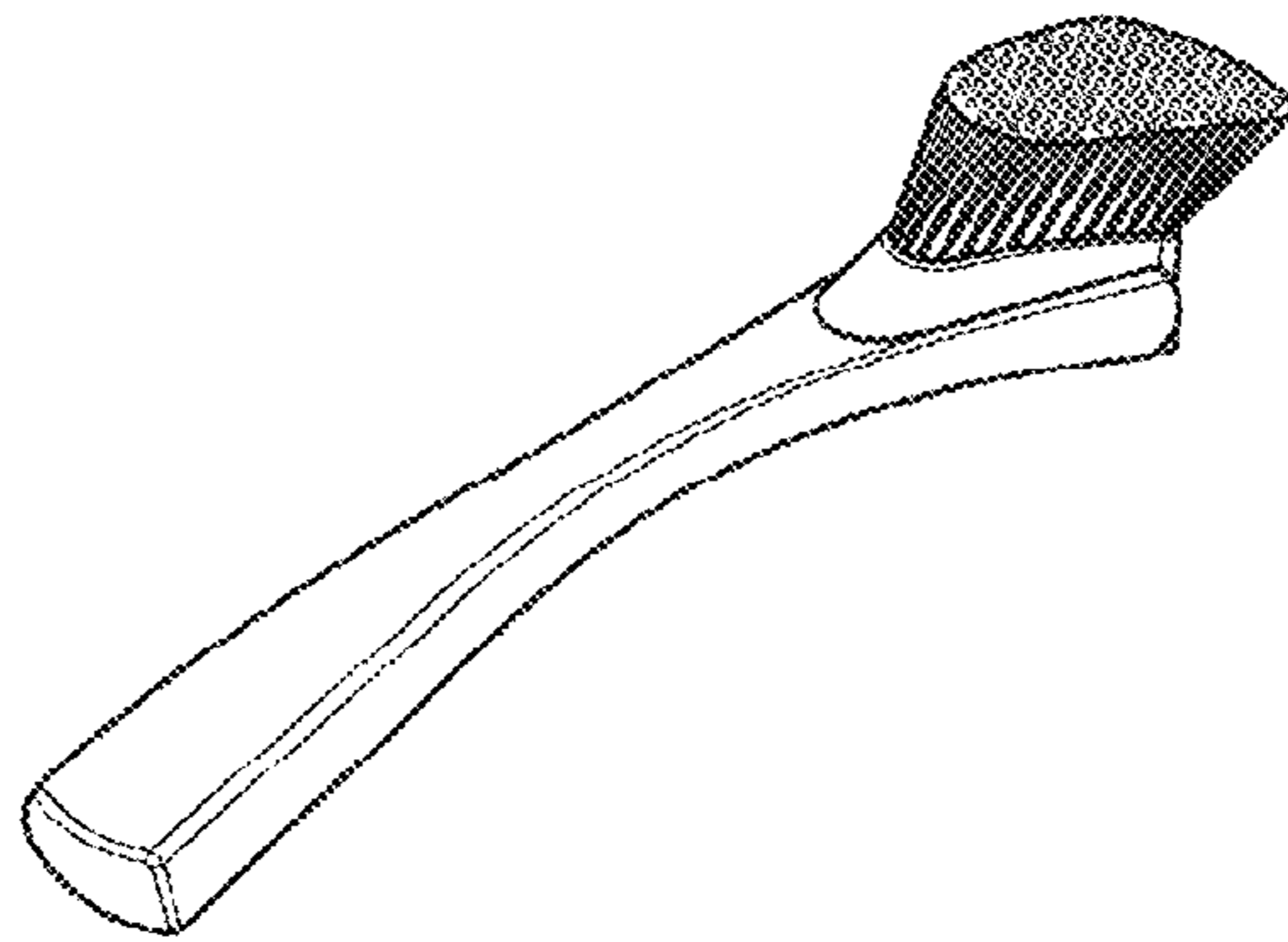

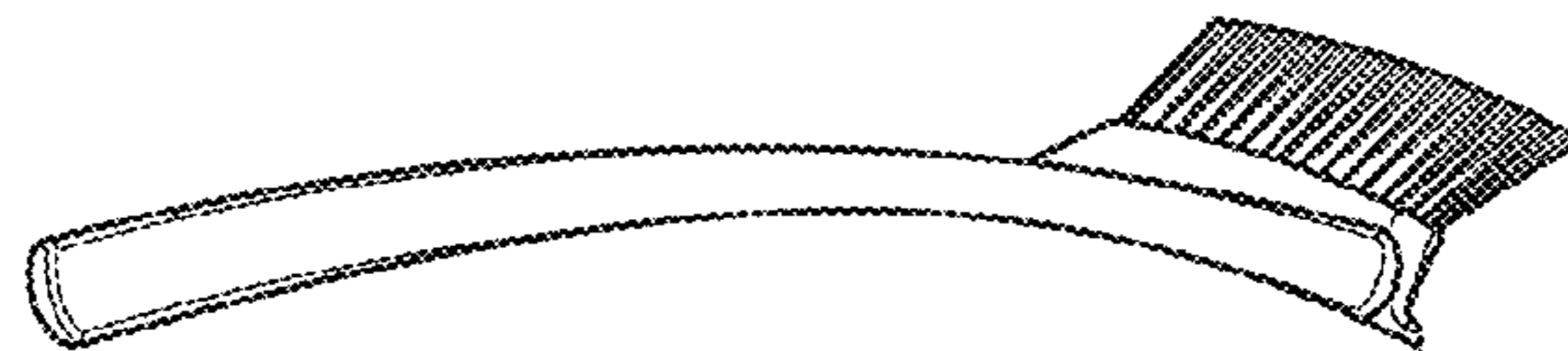

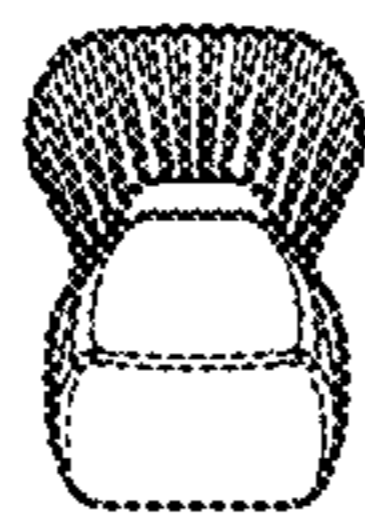

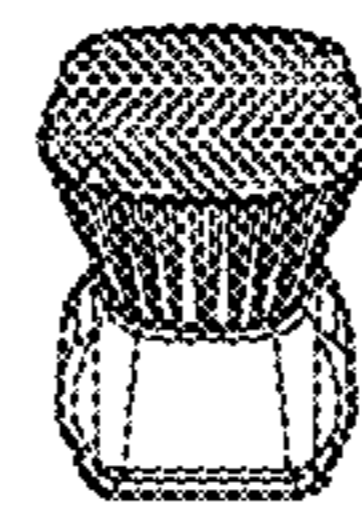

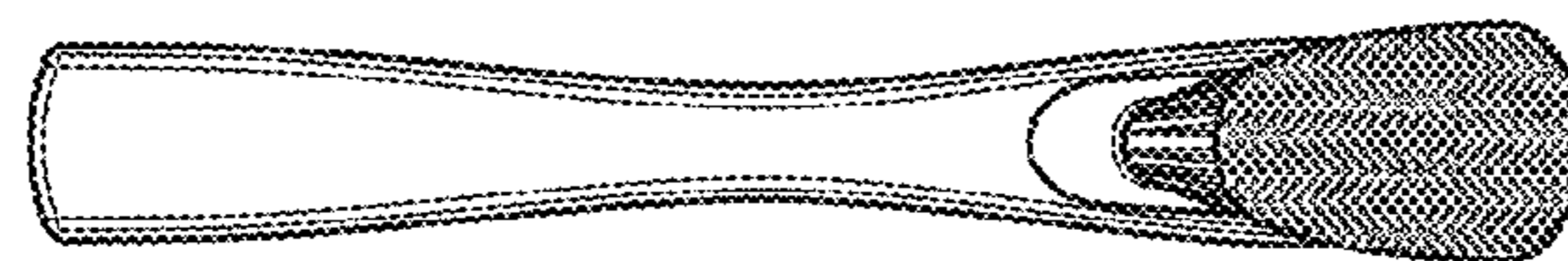

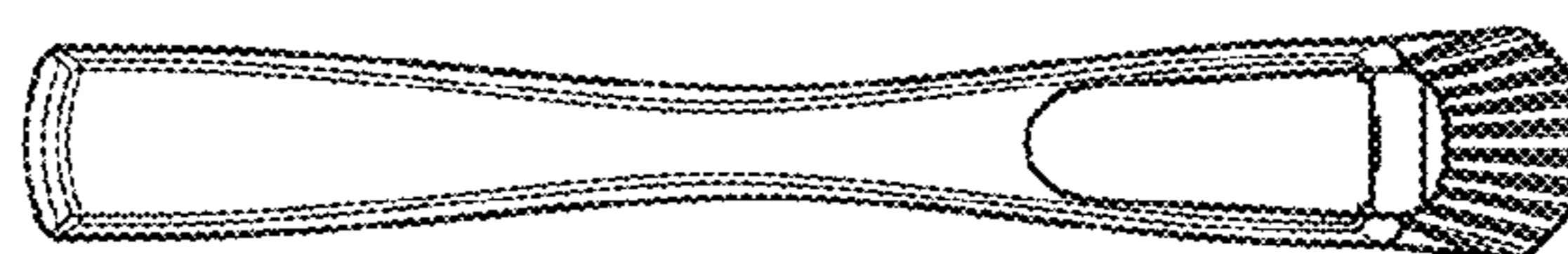
