FIG. 4 is a back view of the foldable padded mat shown in a folded position.

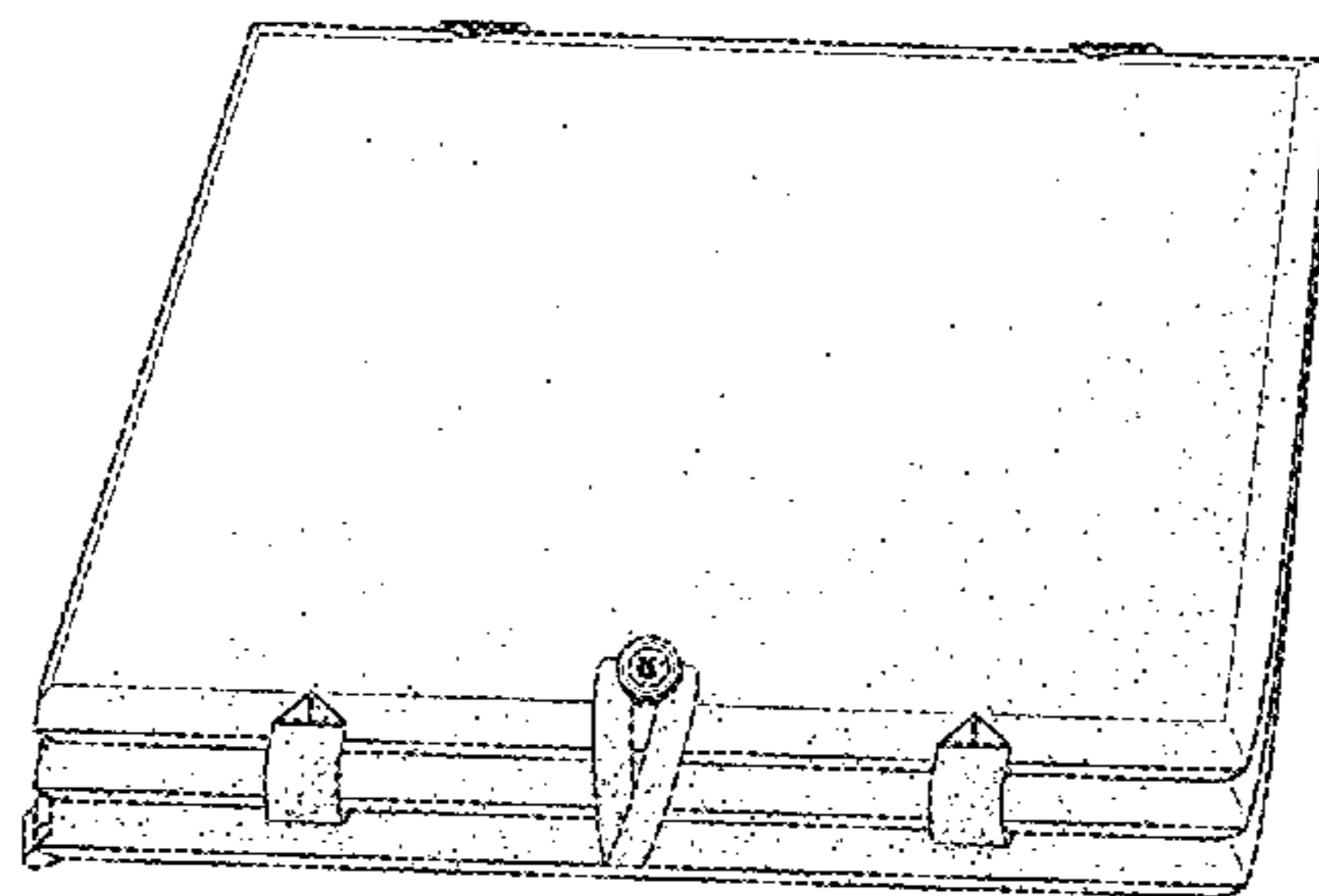


FIG. 5 is a left side view of the foldable padded mat shown in a folded position.

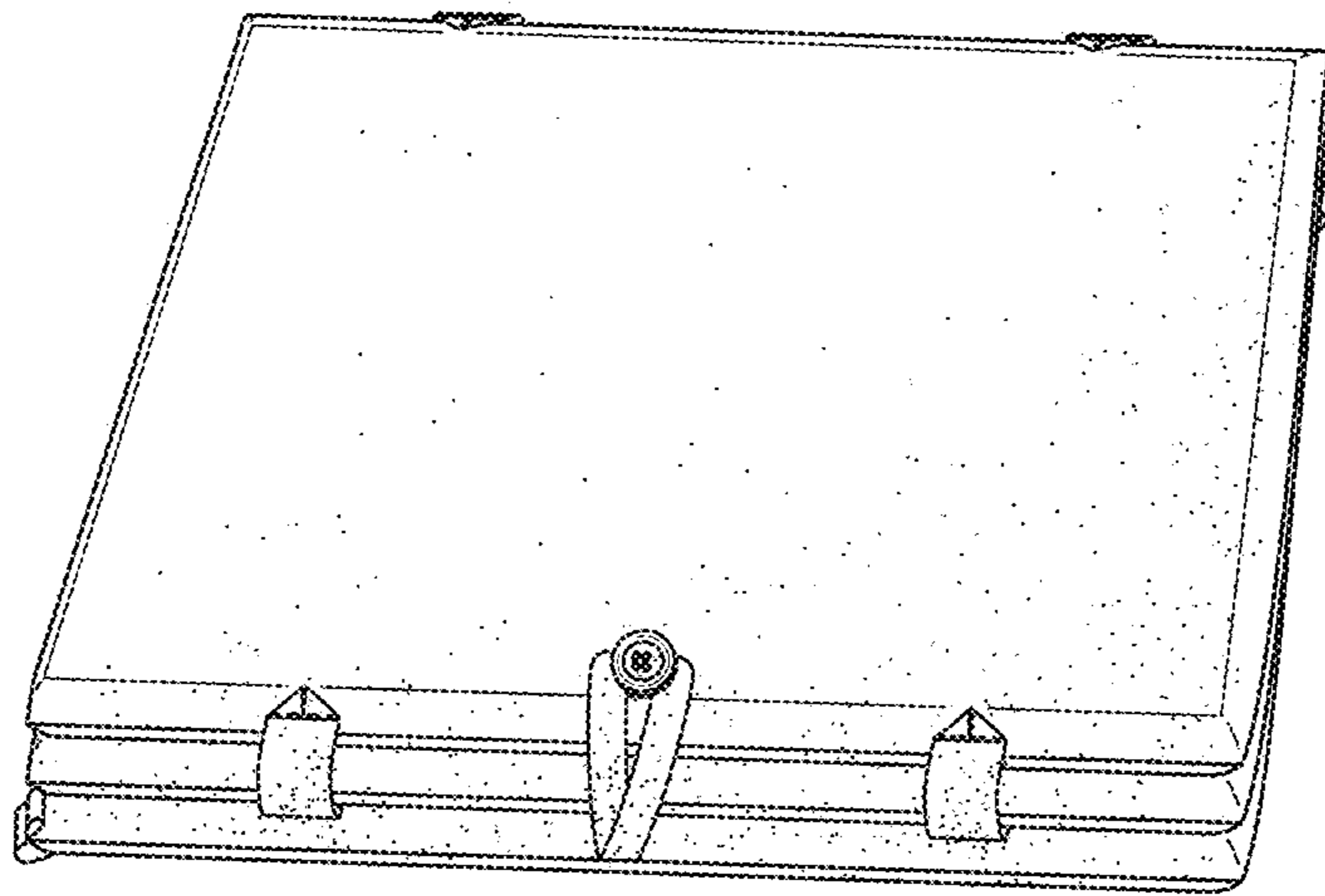

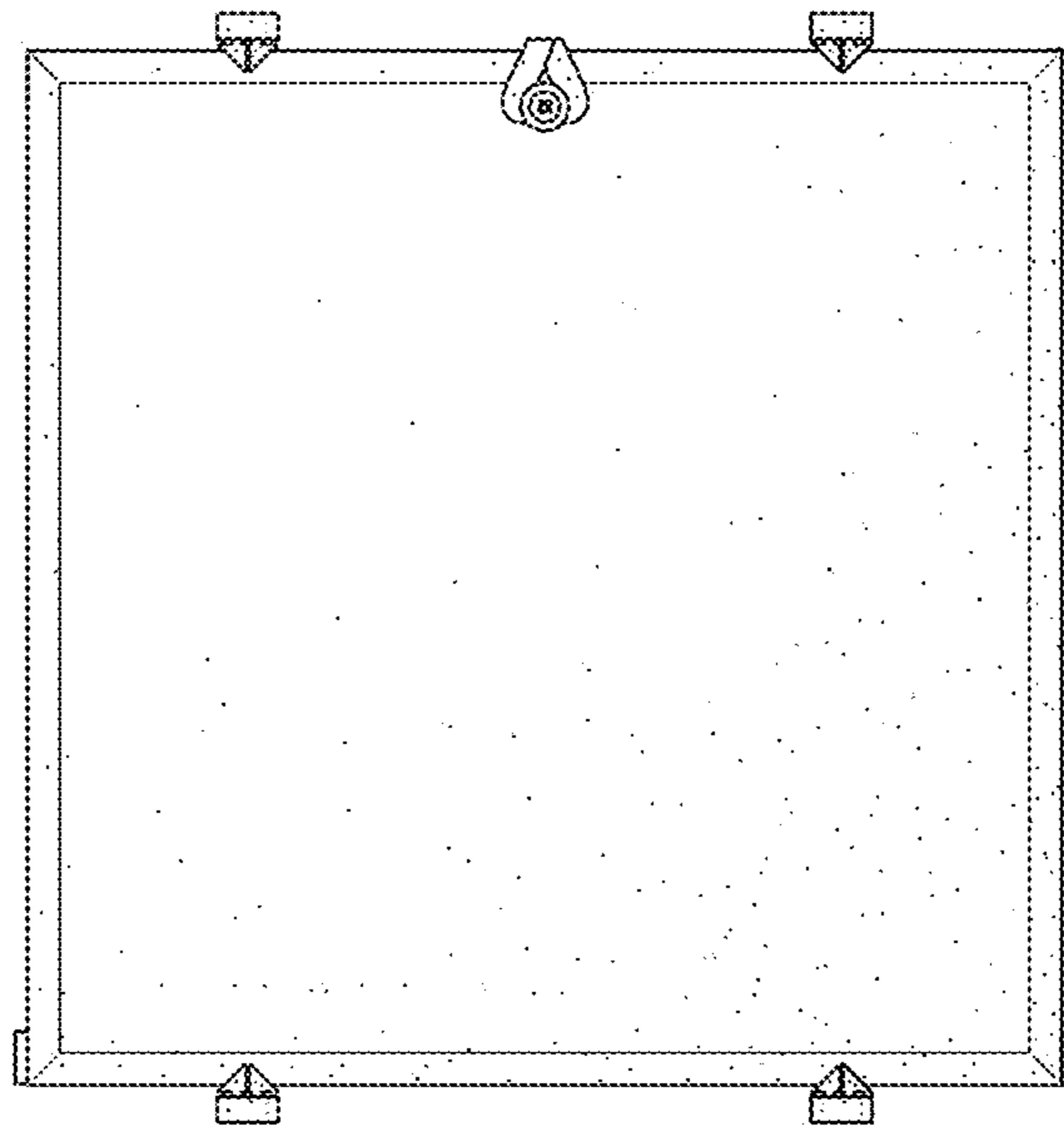

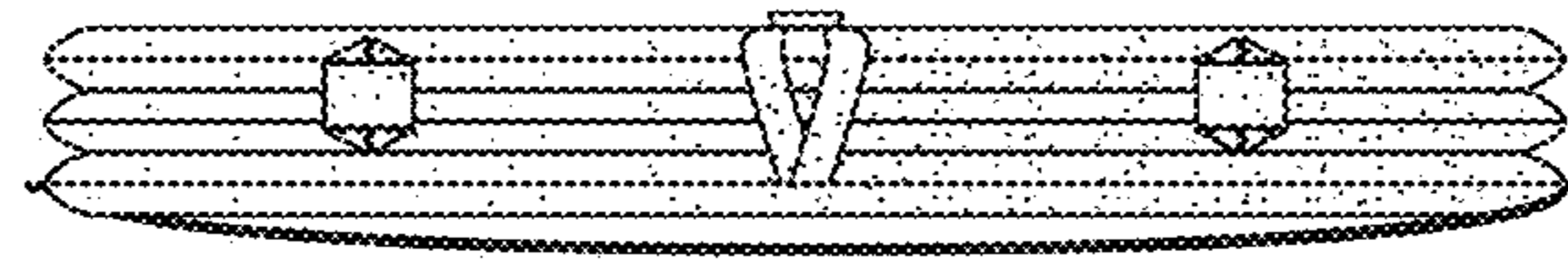

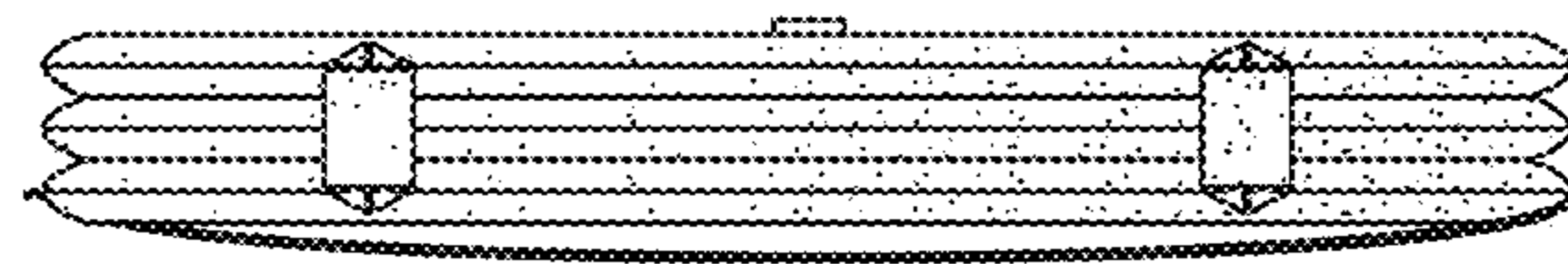

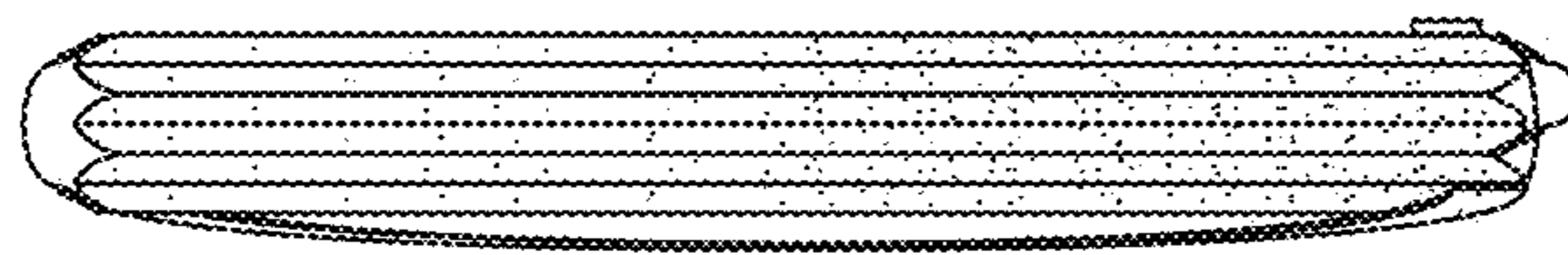

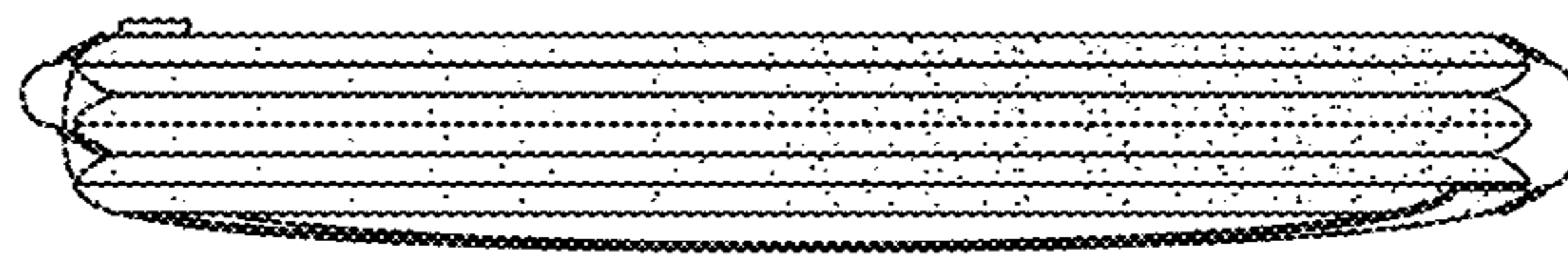

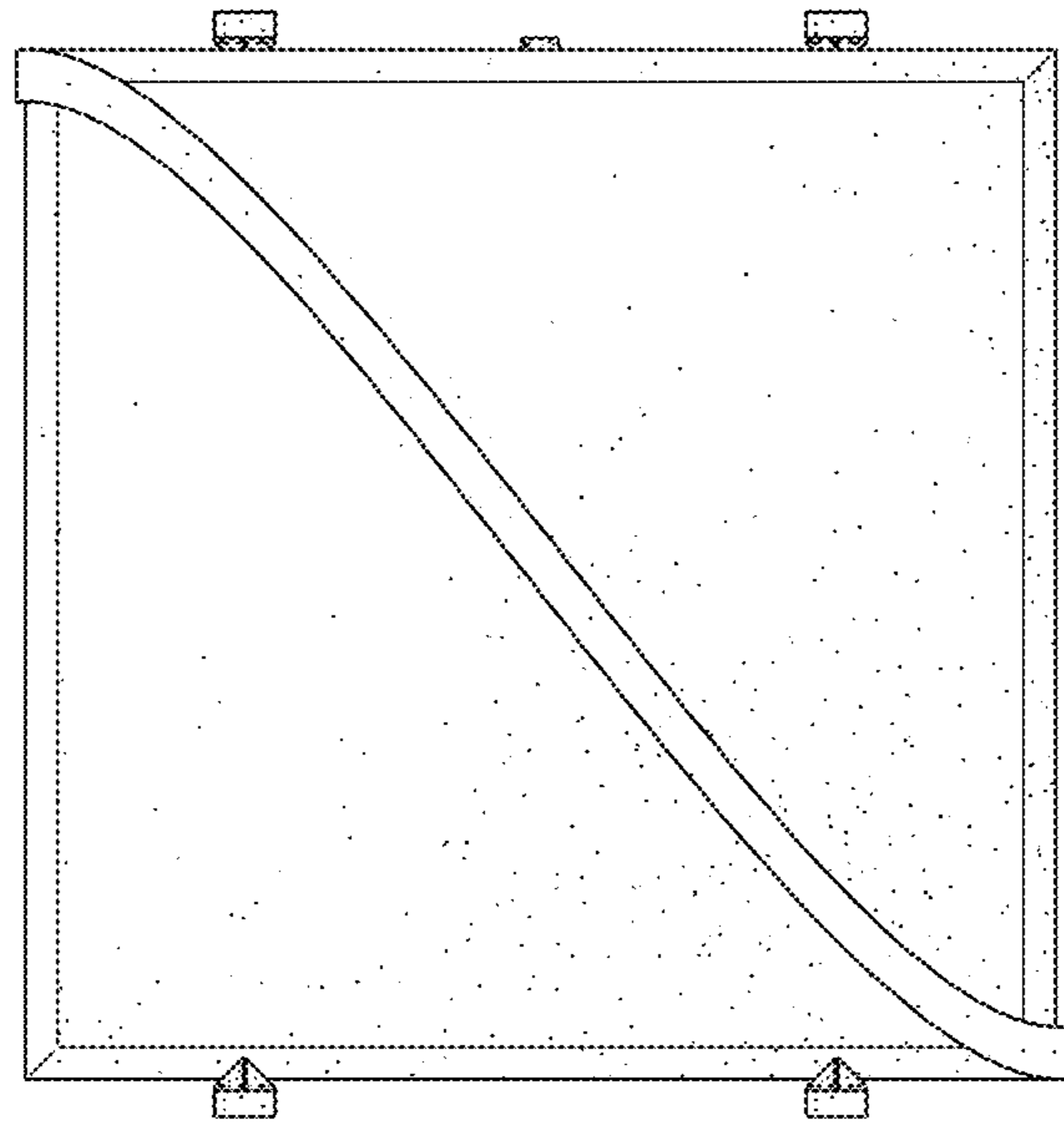

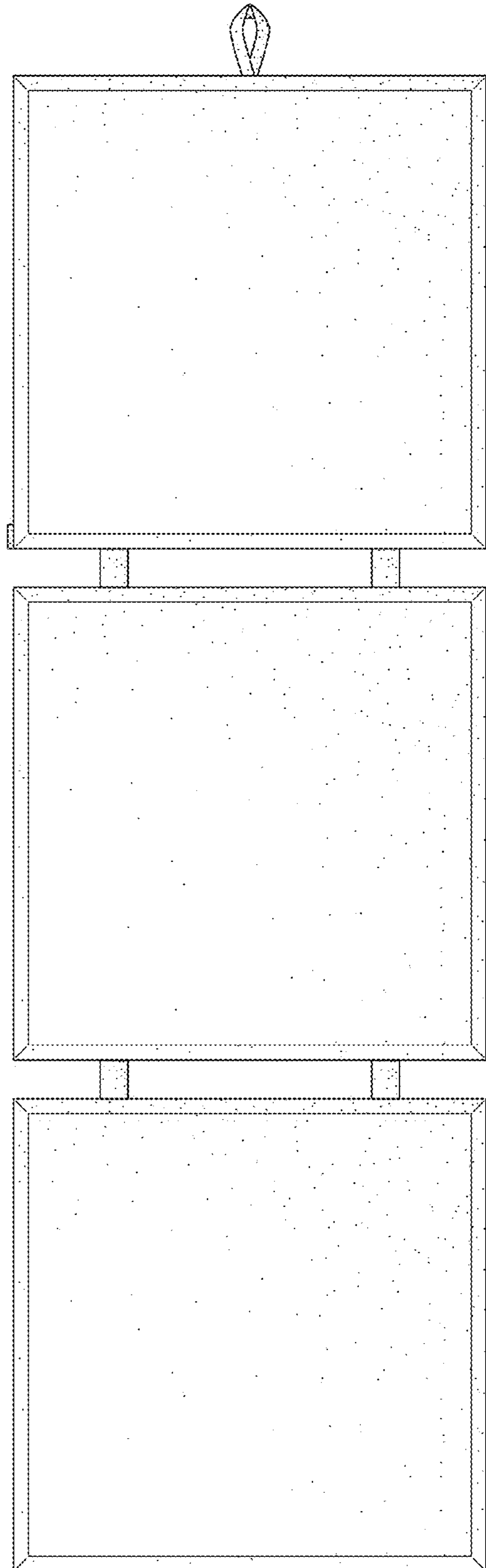

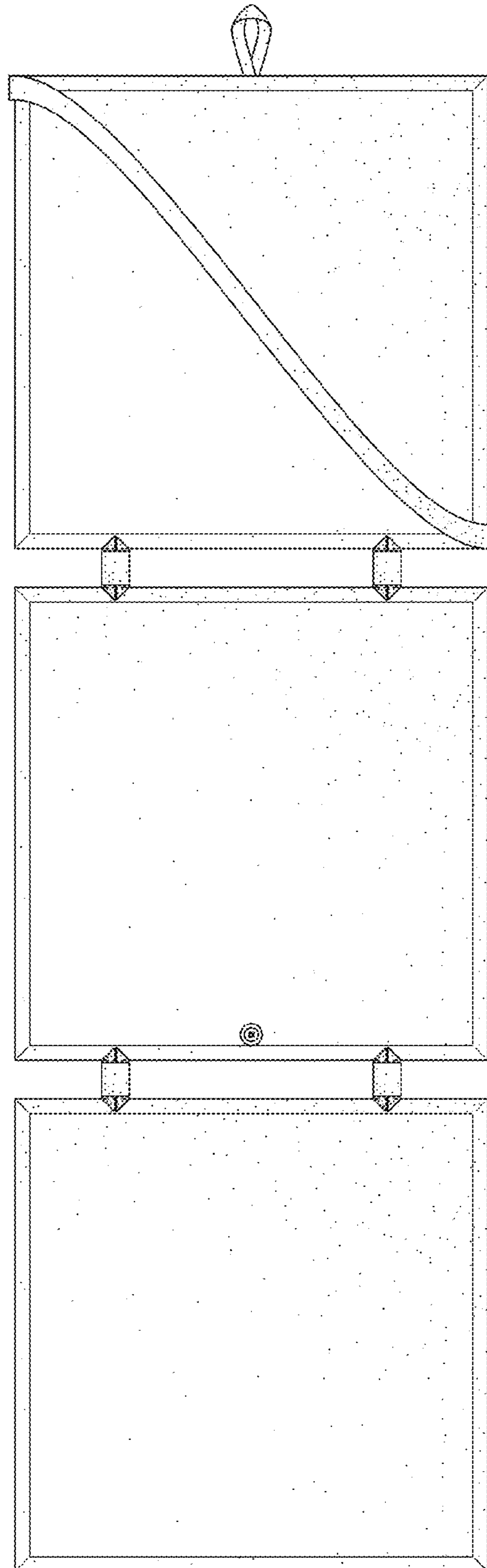

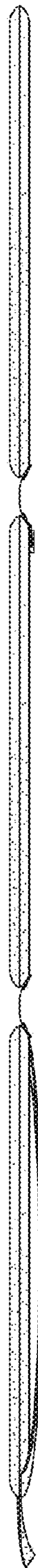

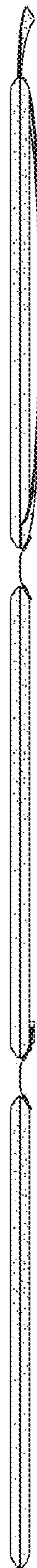

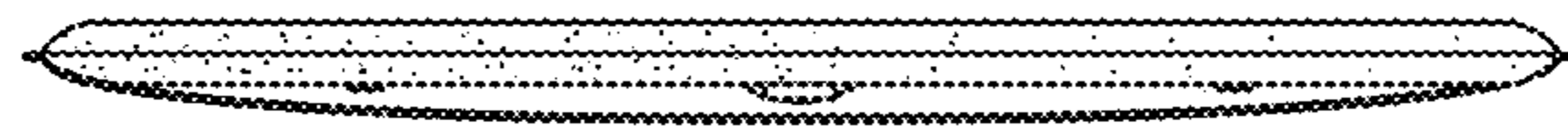

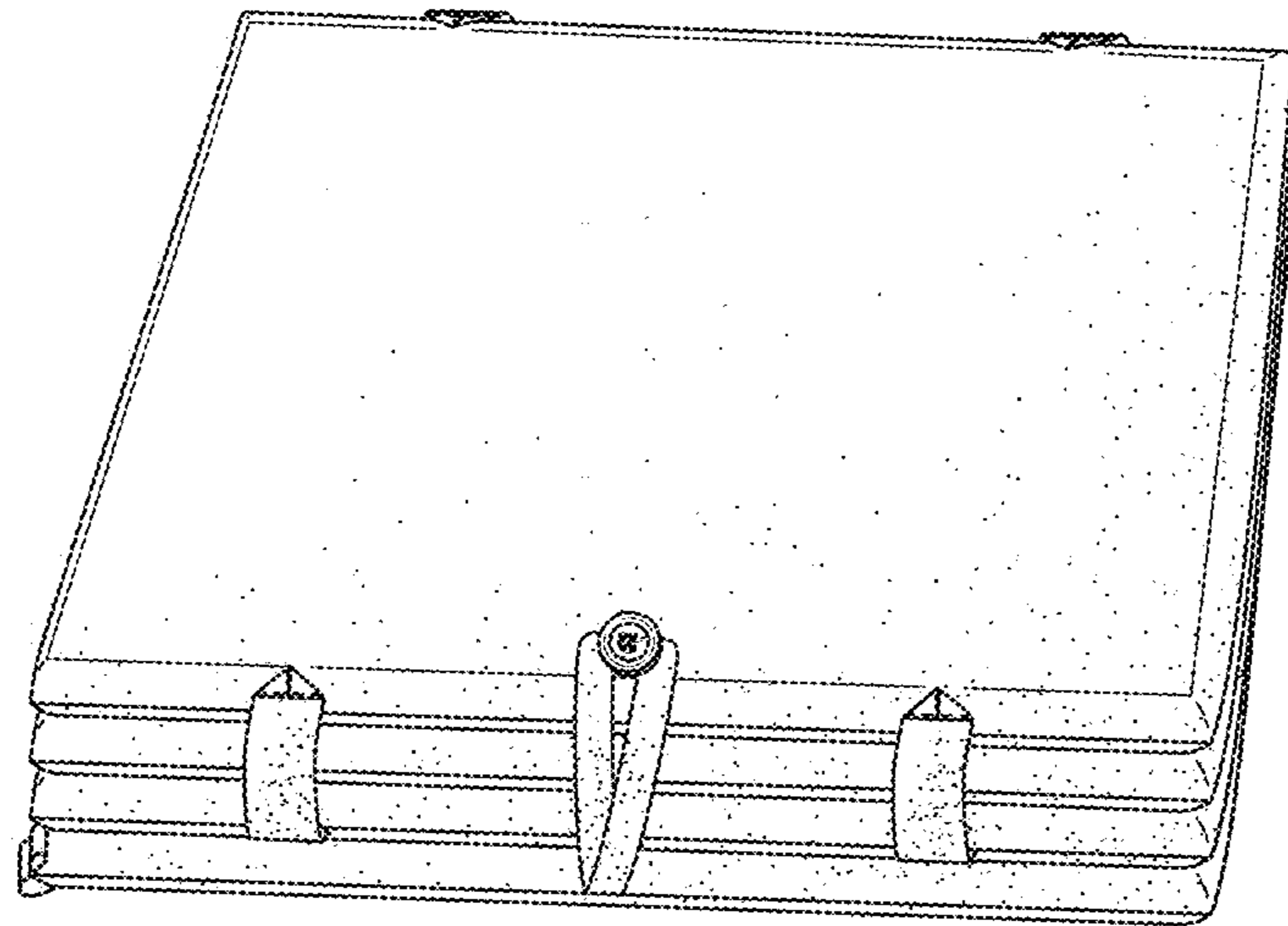

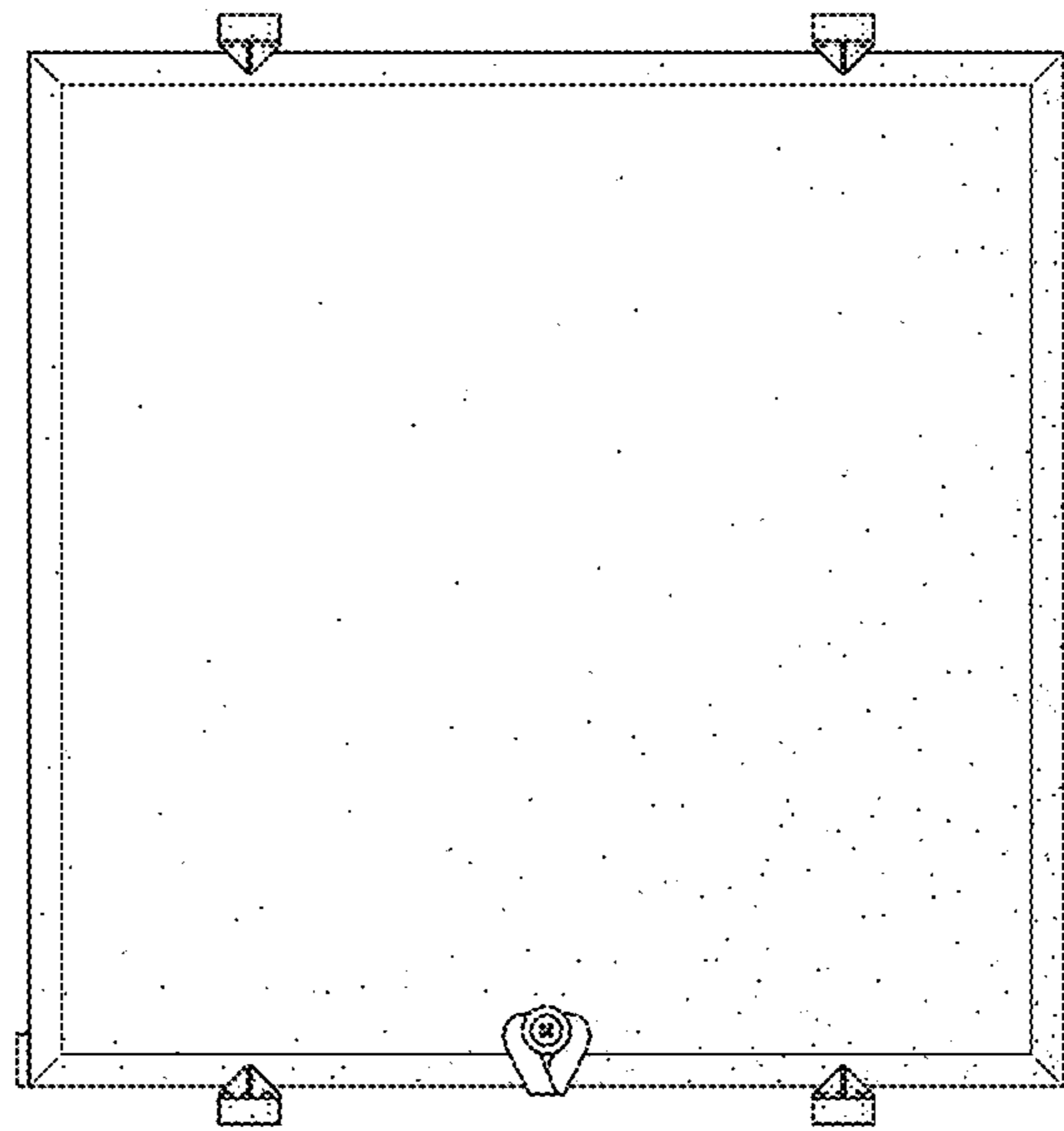

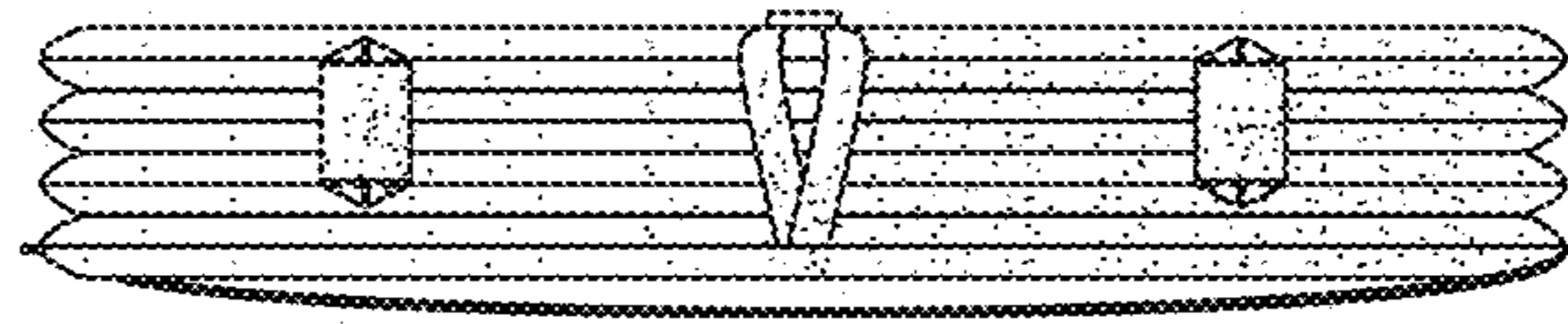

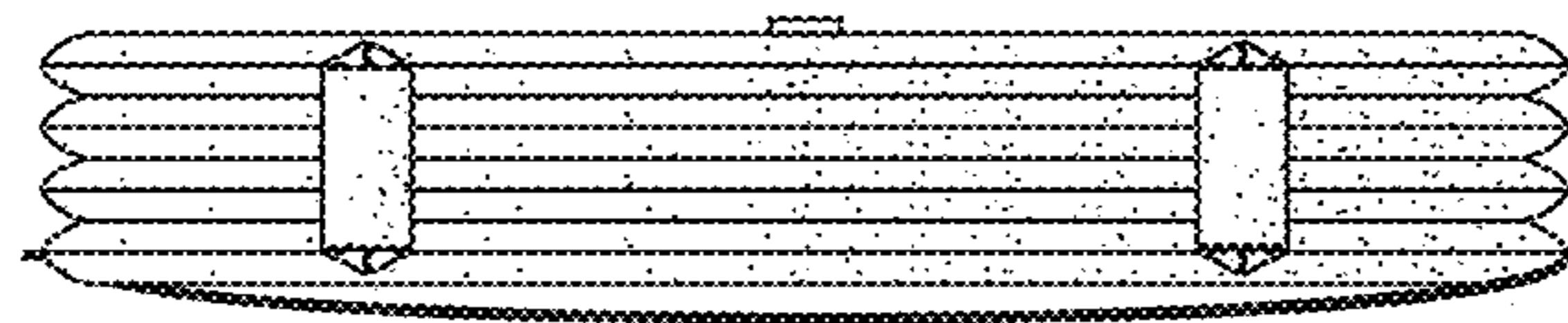

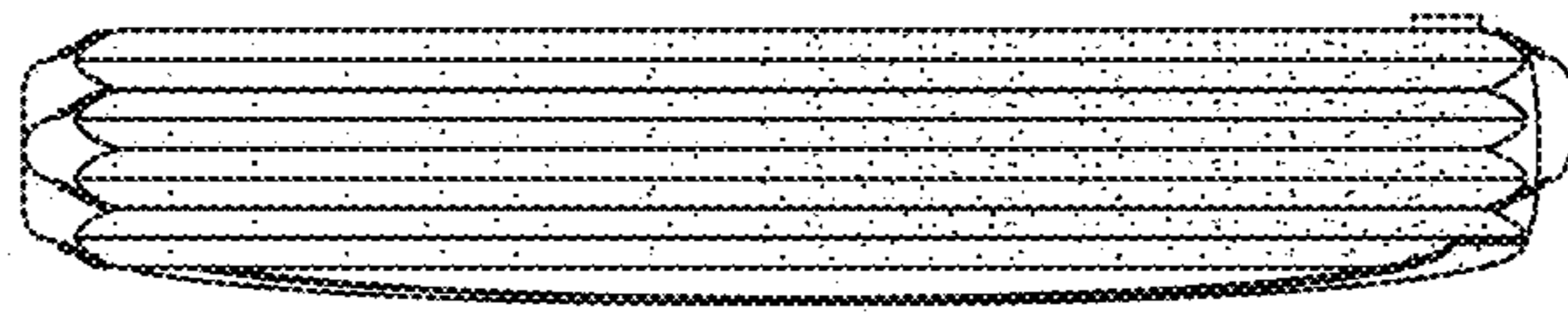

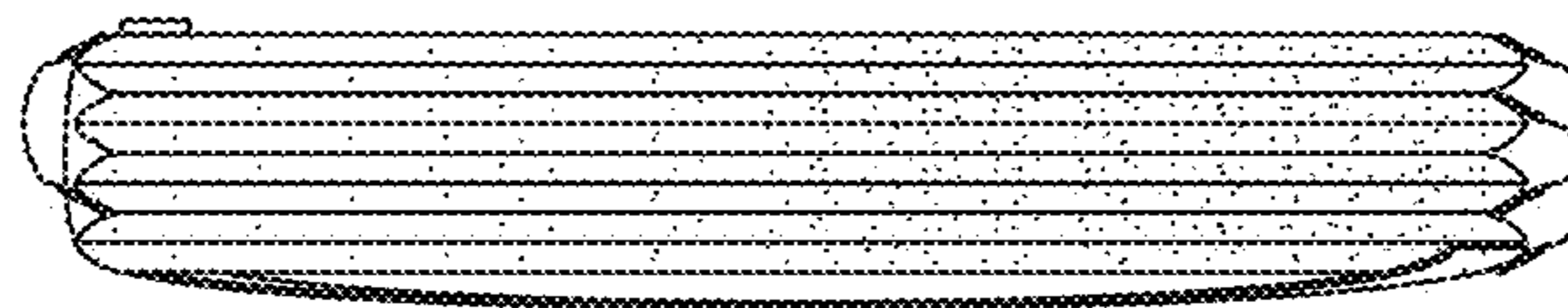

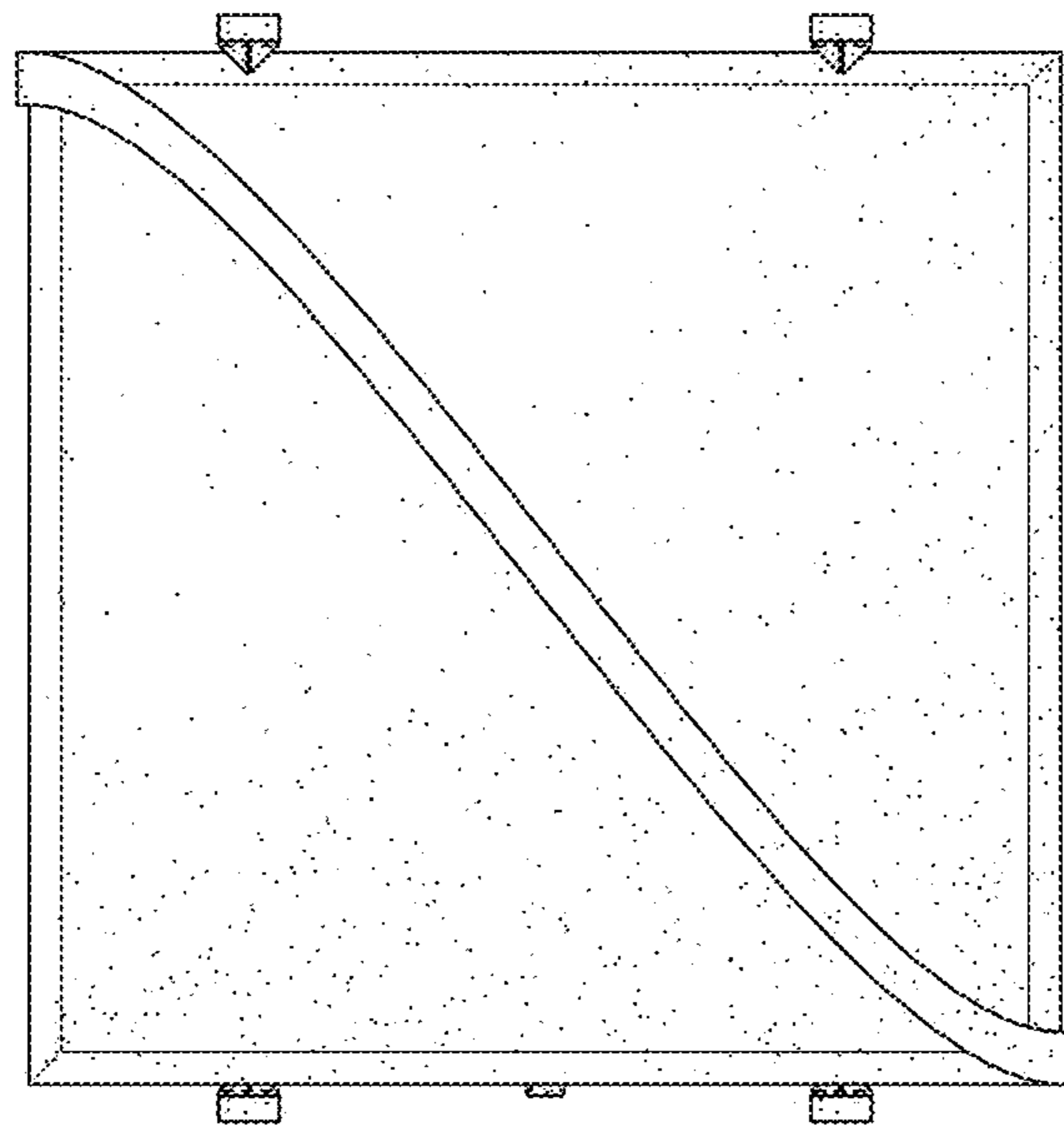

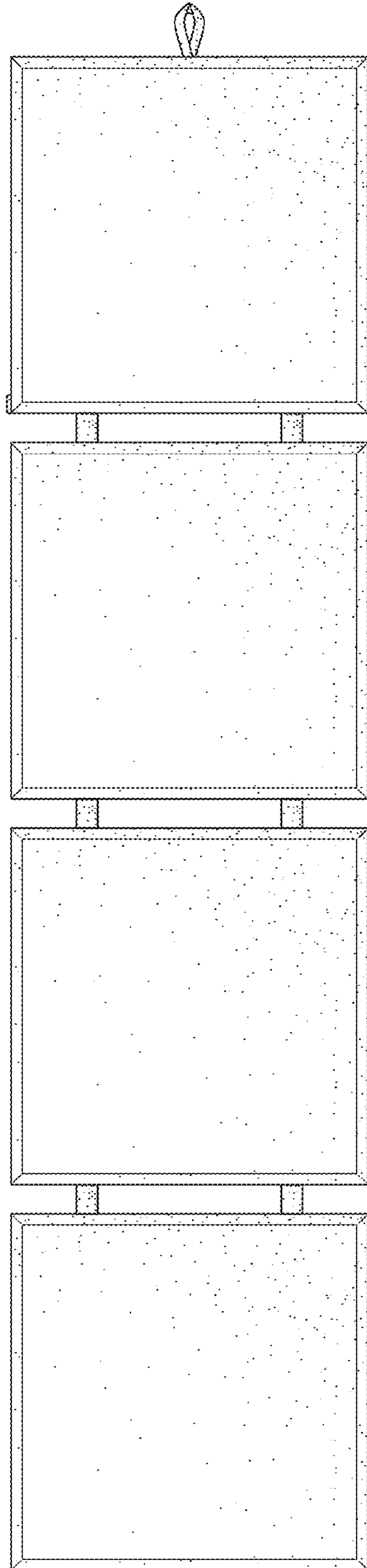

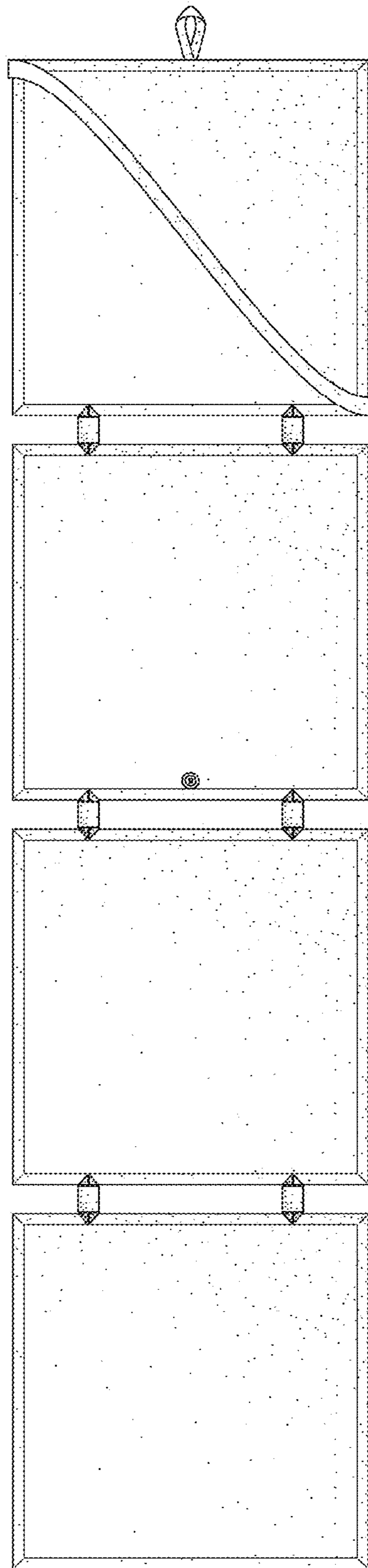

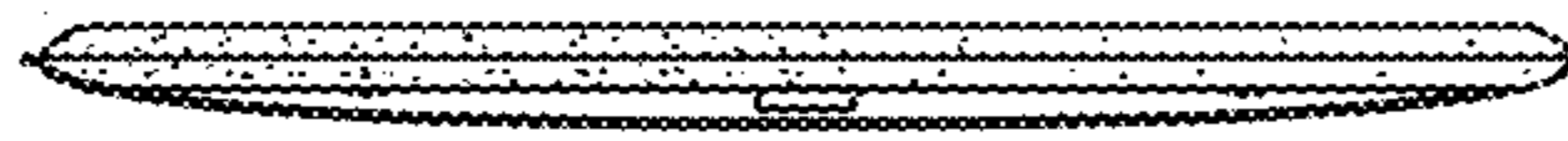
