**DESCRIPTION**

FIG. 1 is a front, left, upper perspective view of a portable electric hammer drill showing our new design;

FIG. 4 is a left side view thereof;

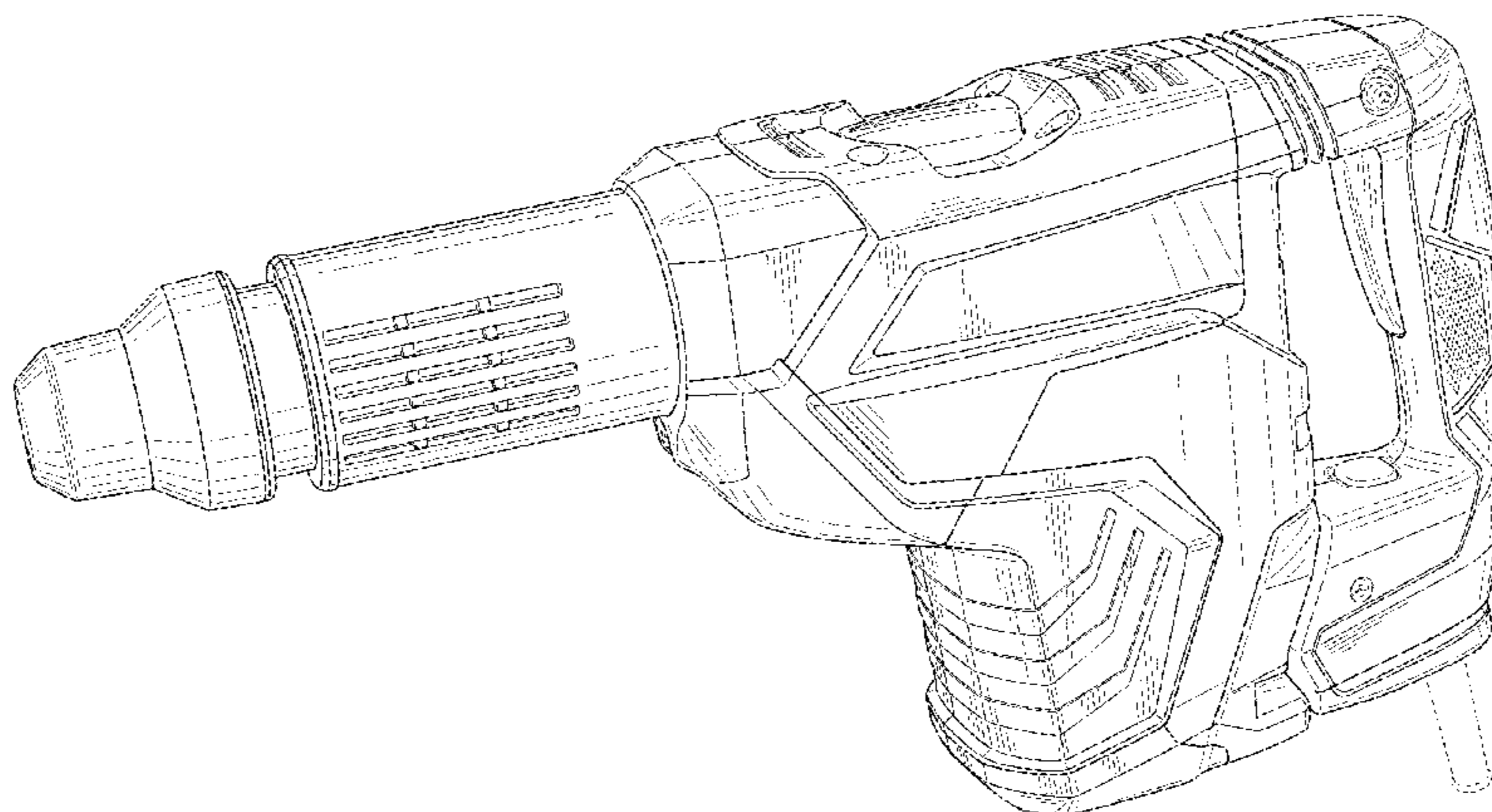
FIG. 5 is a right side view thereof;

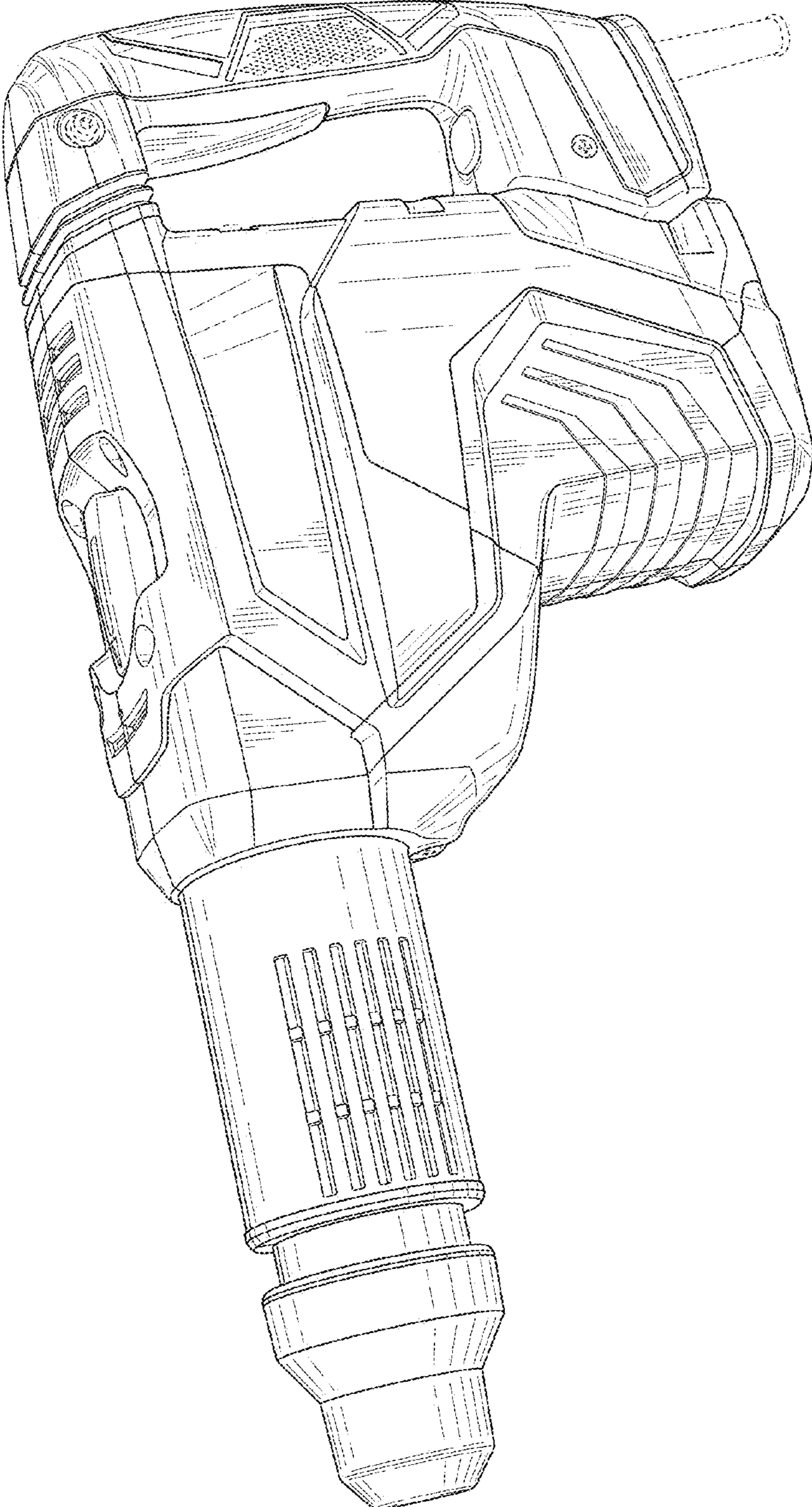

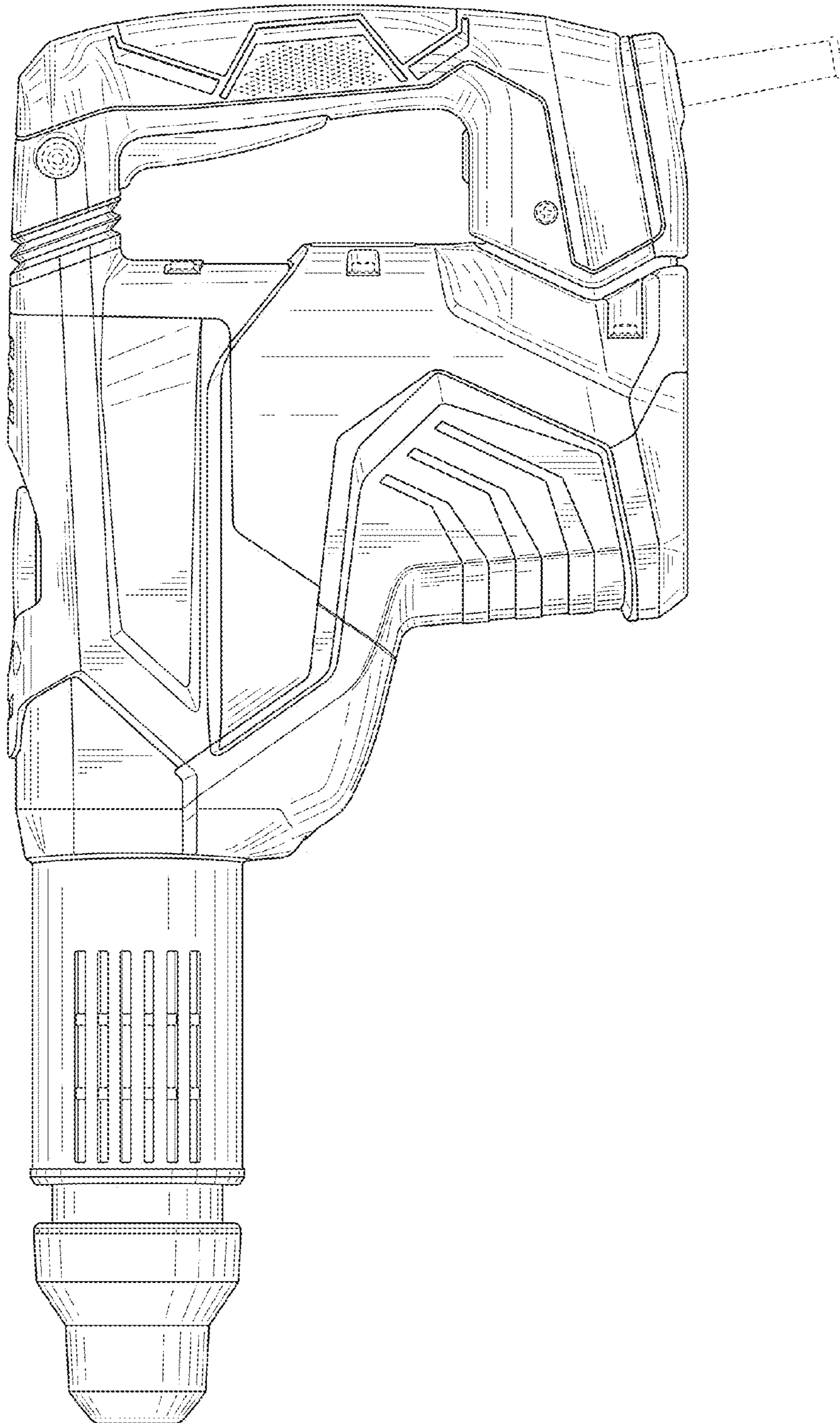

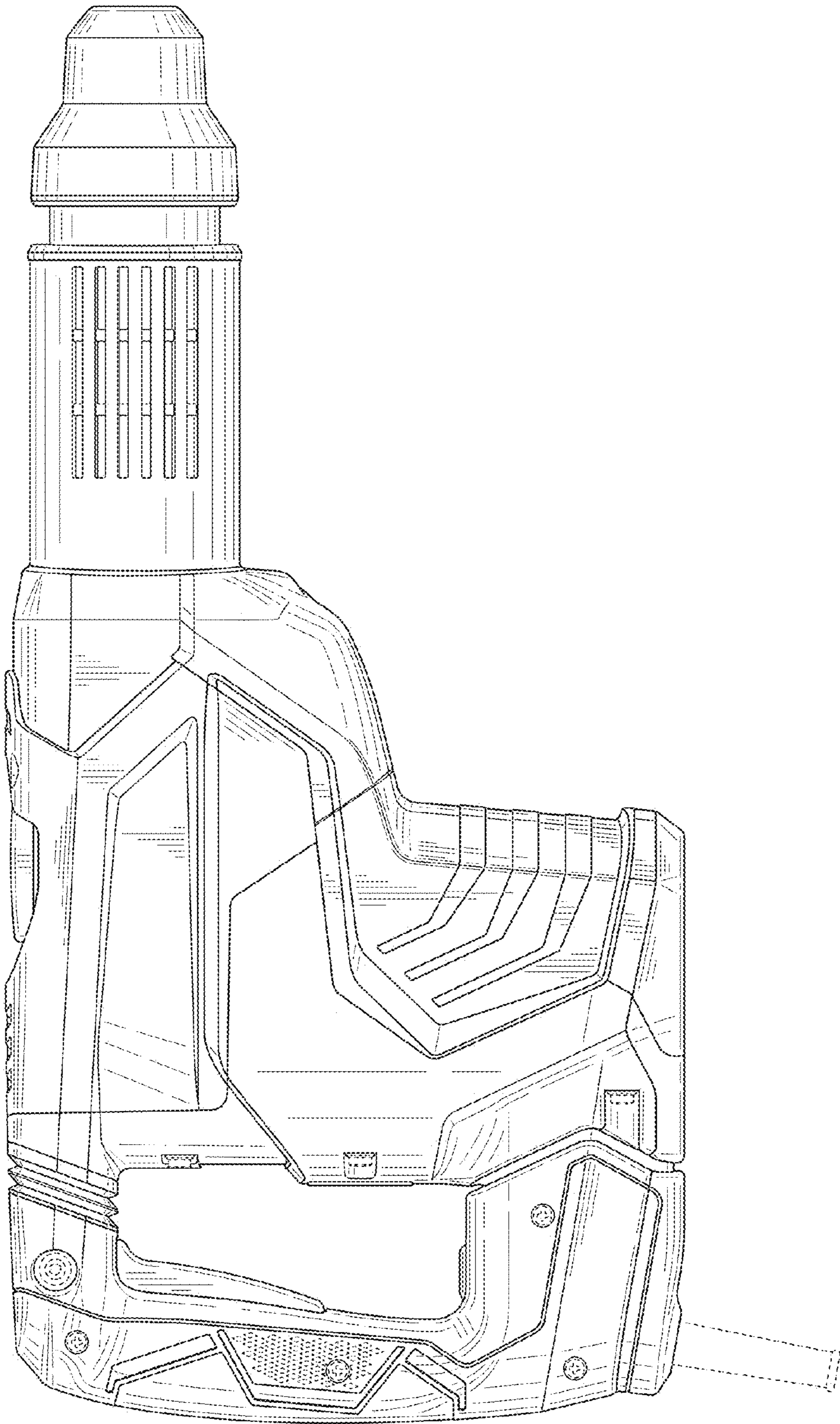

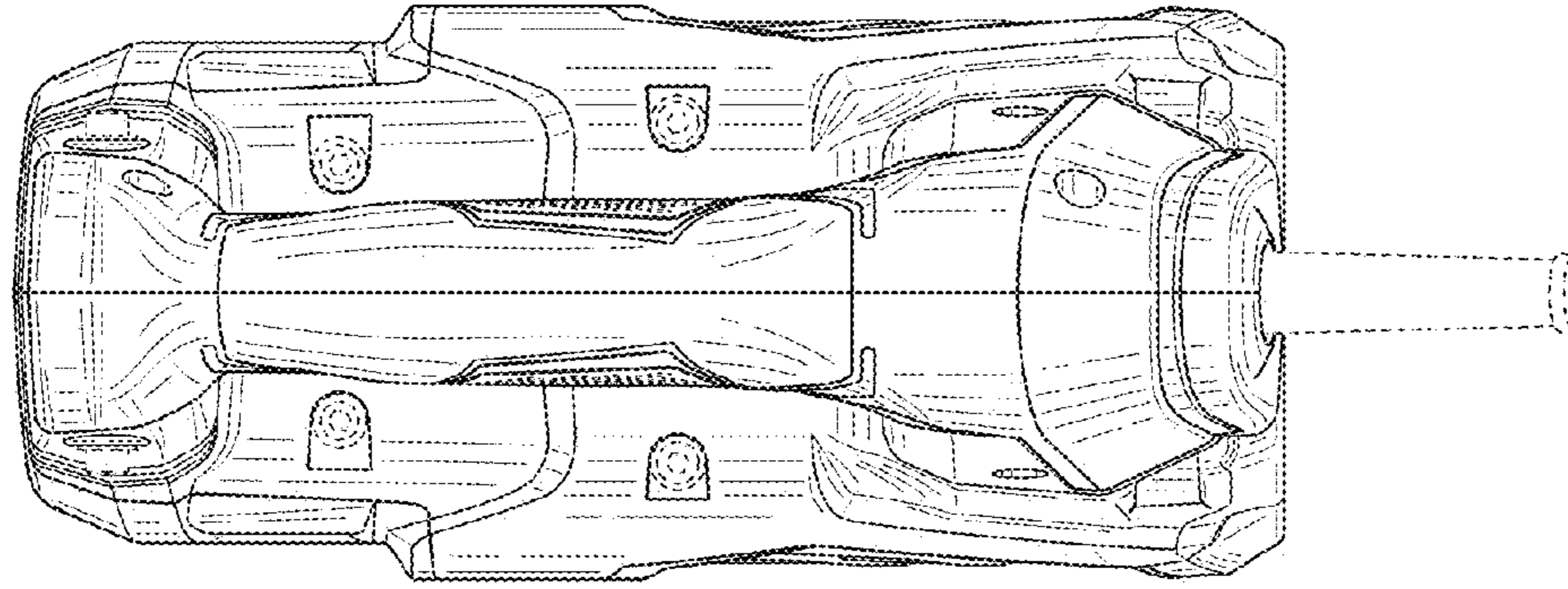

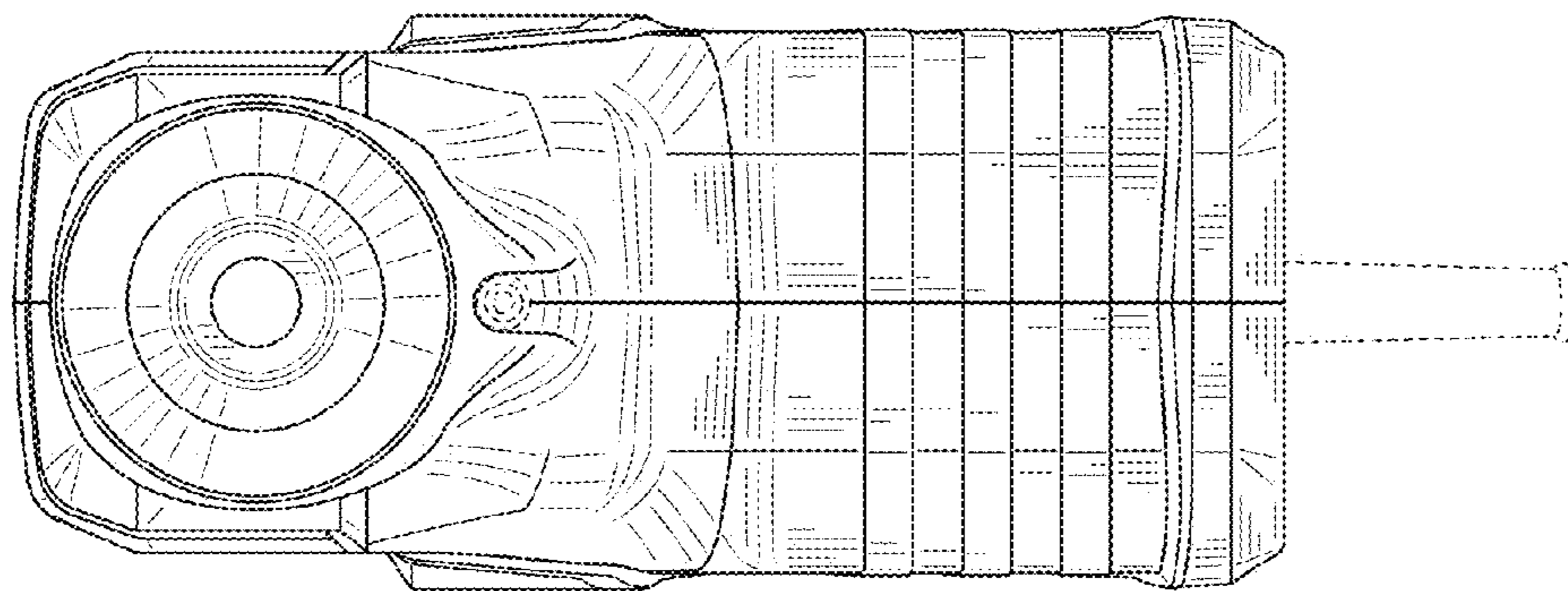

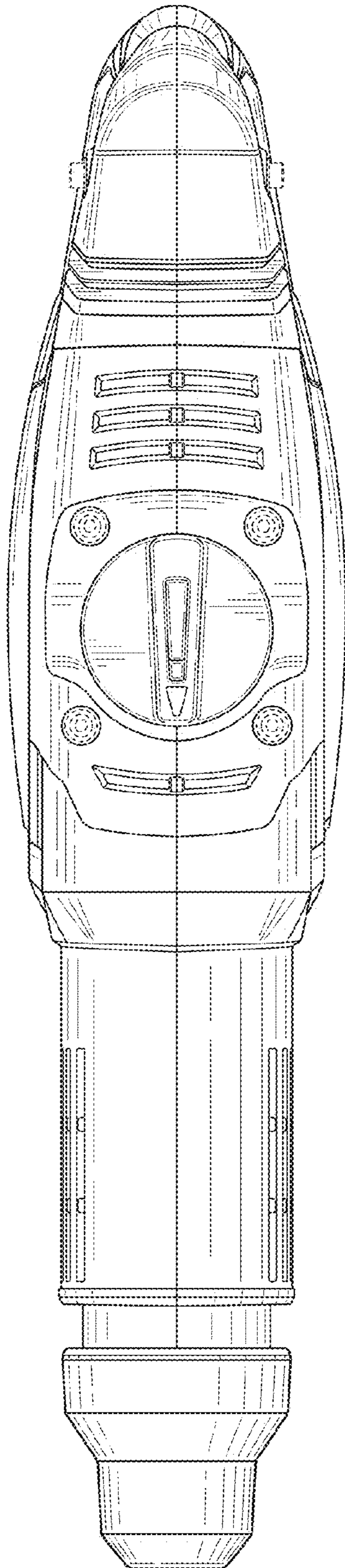

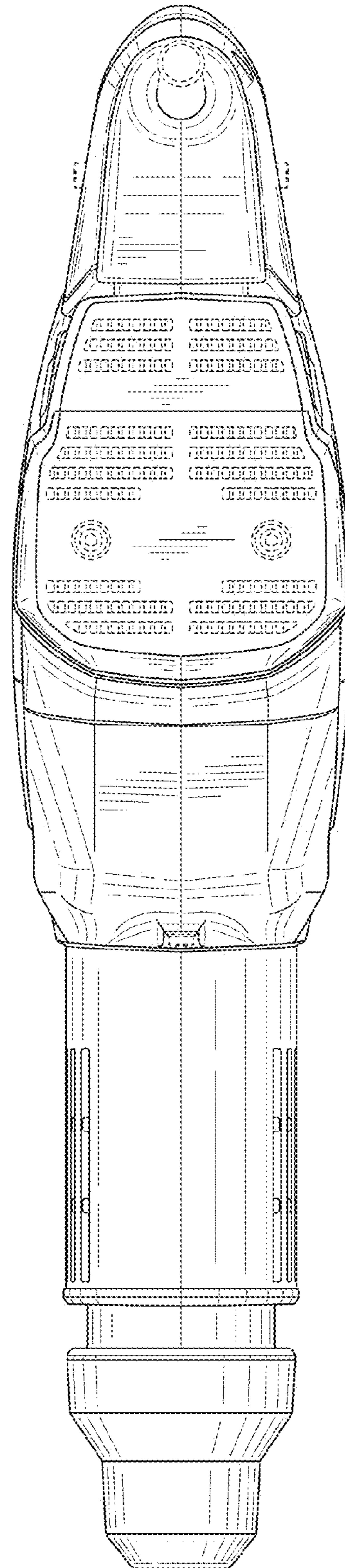
