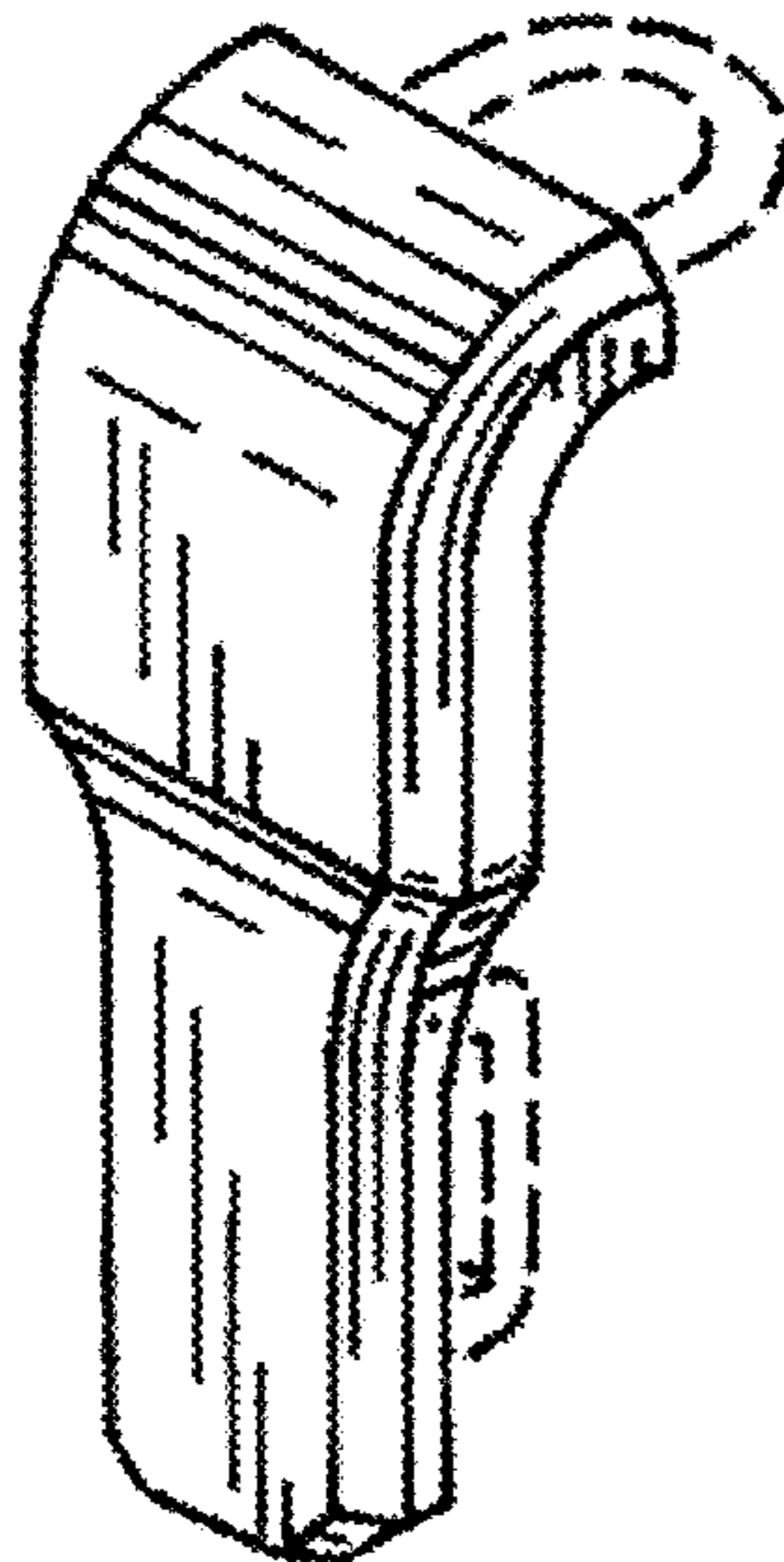
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top front and right perspective view of a lock latch system showing my new design;

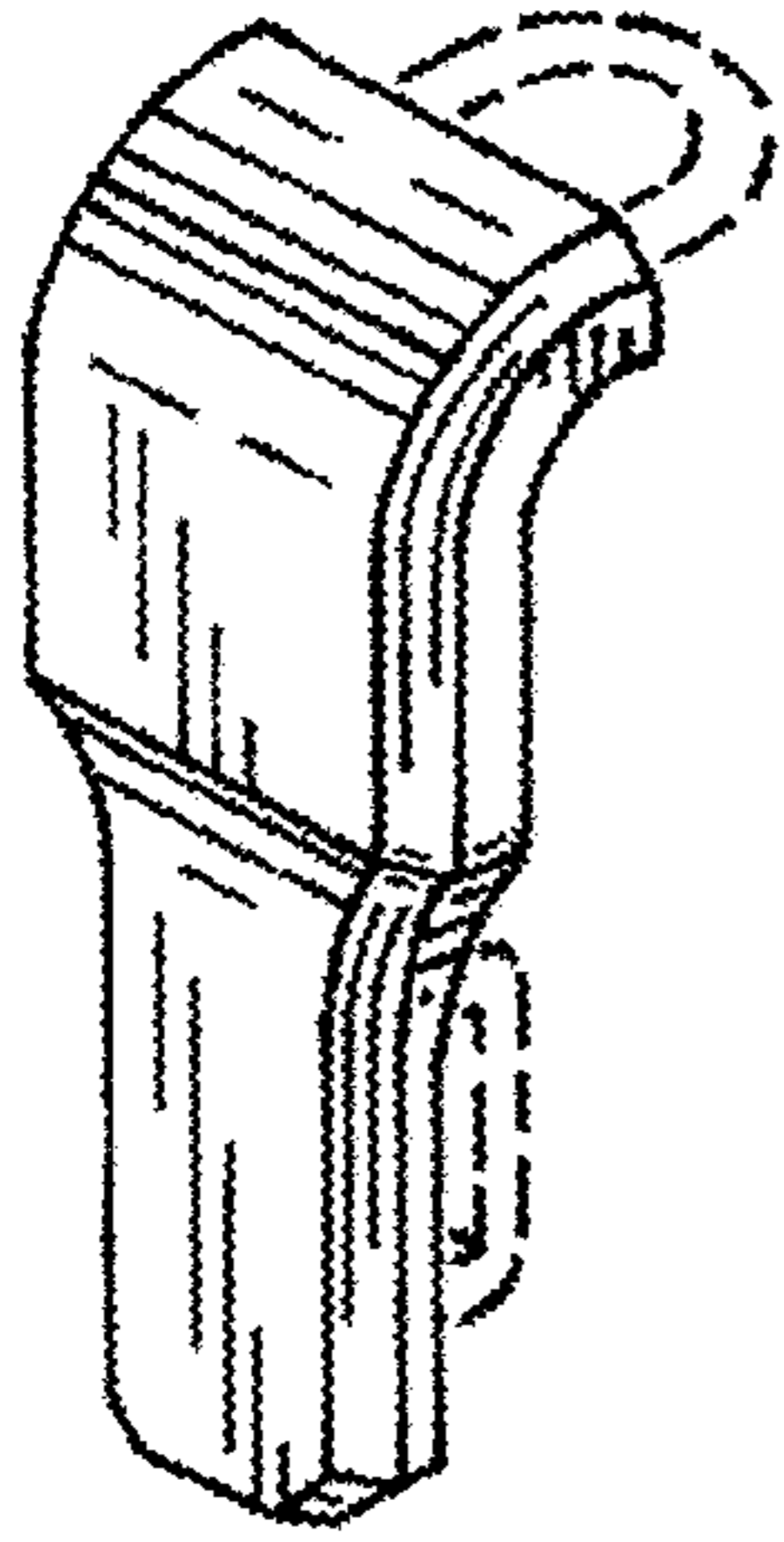

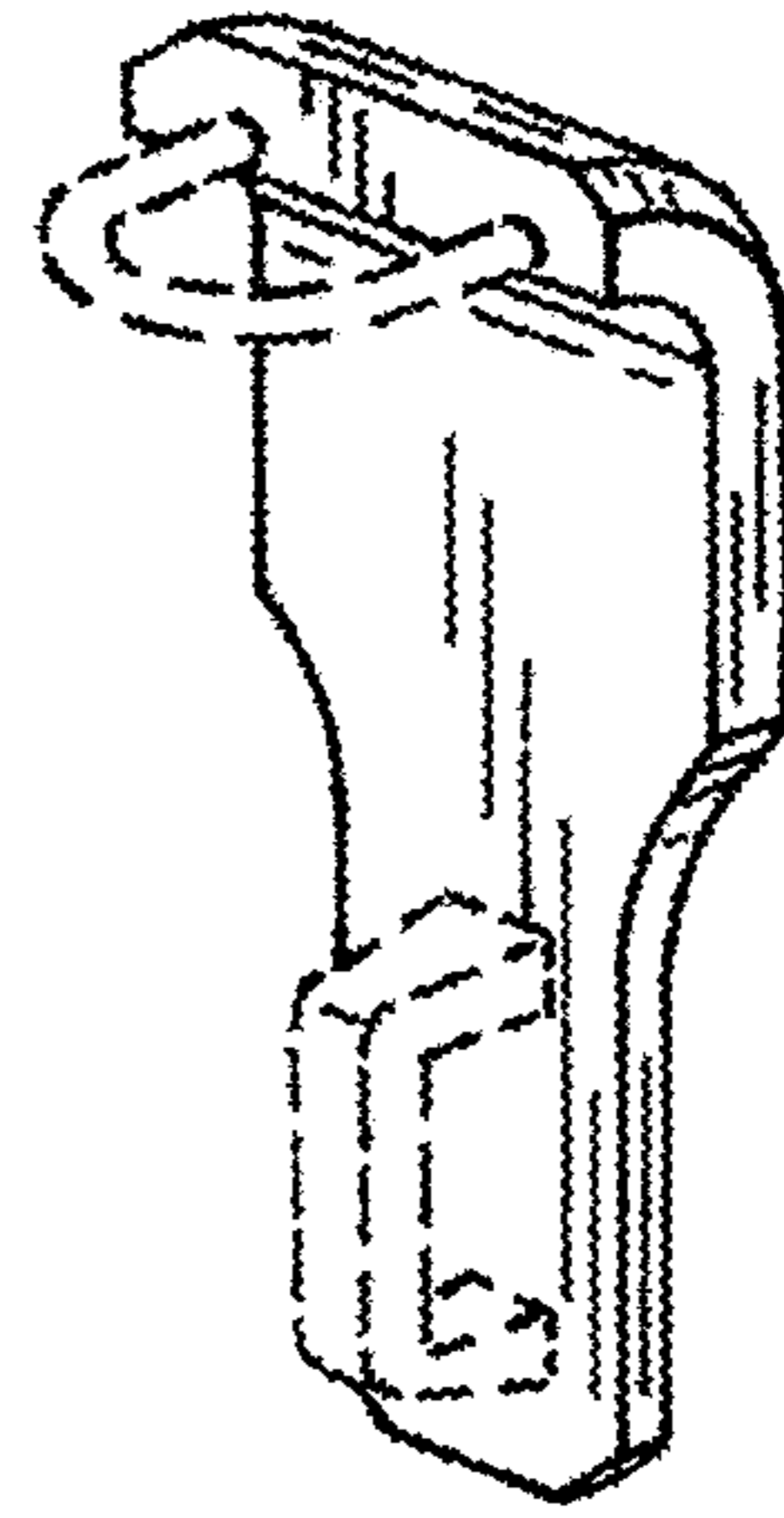

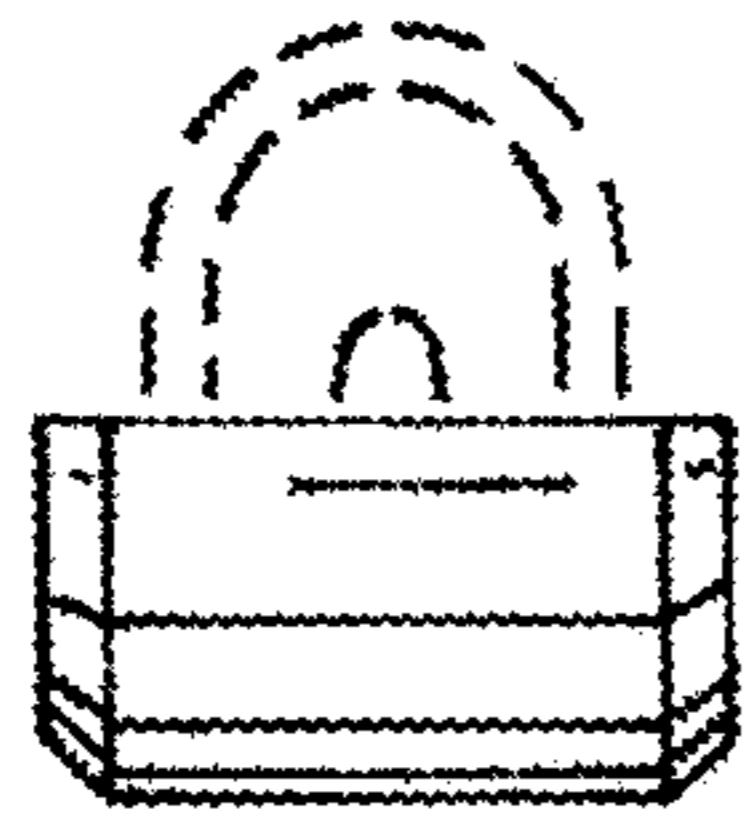

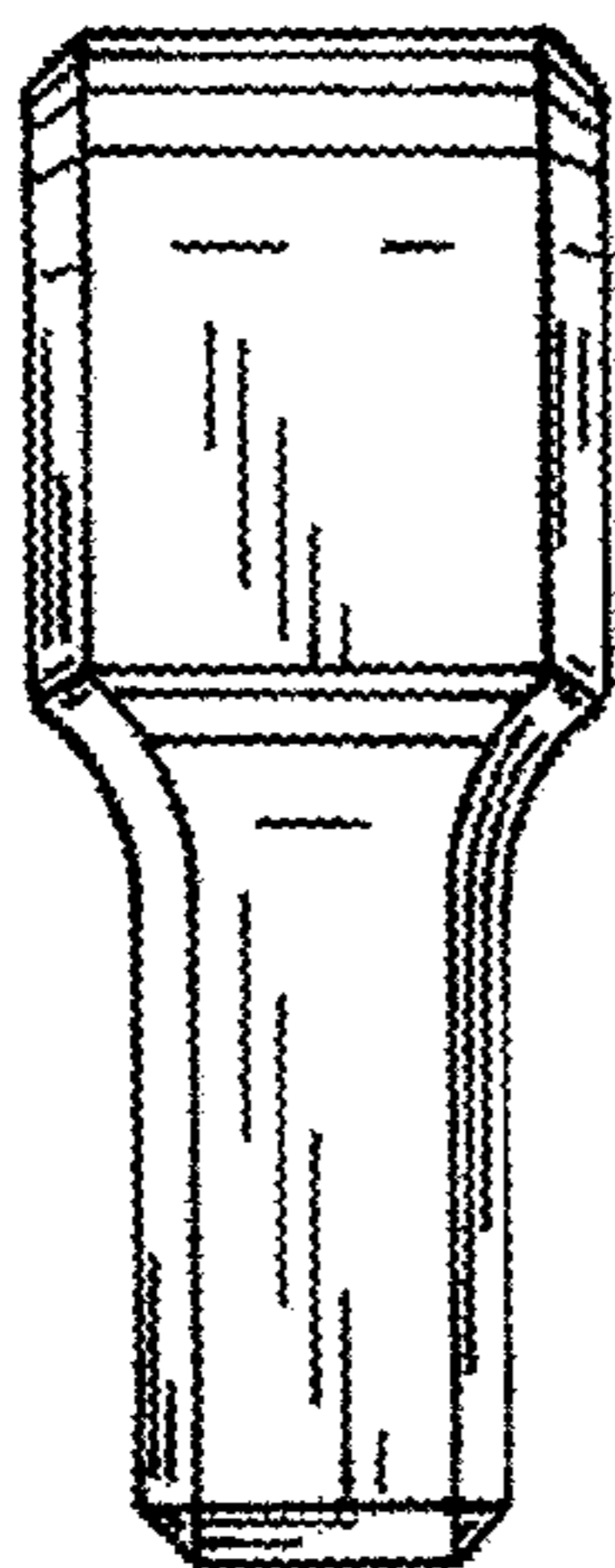

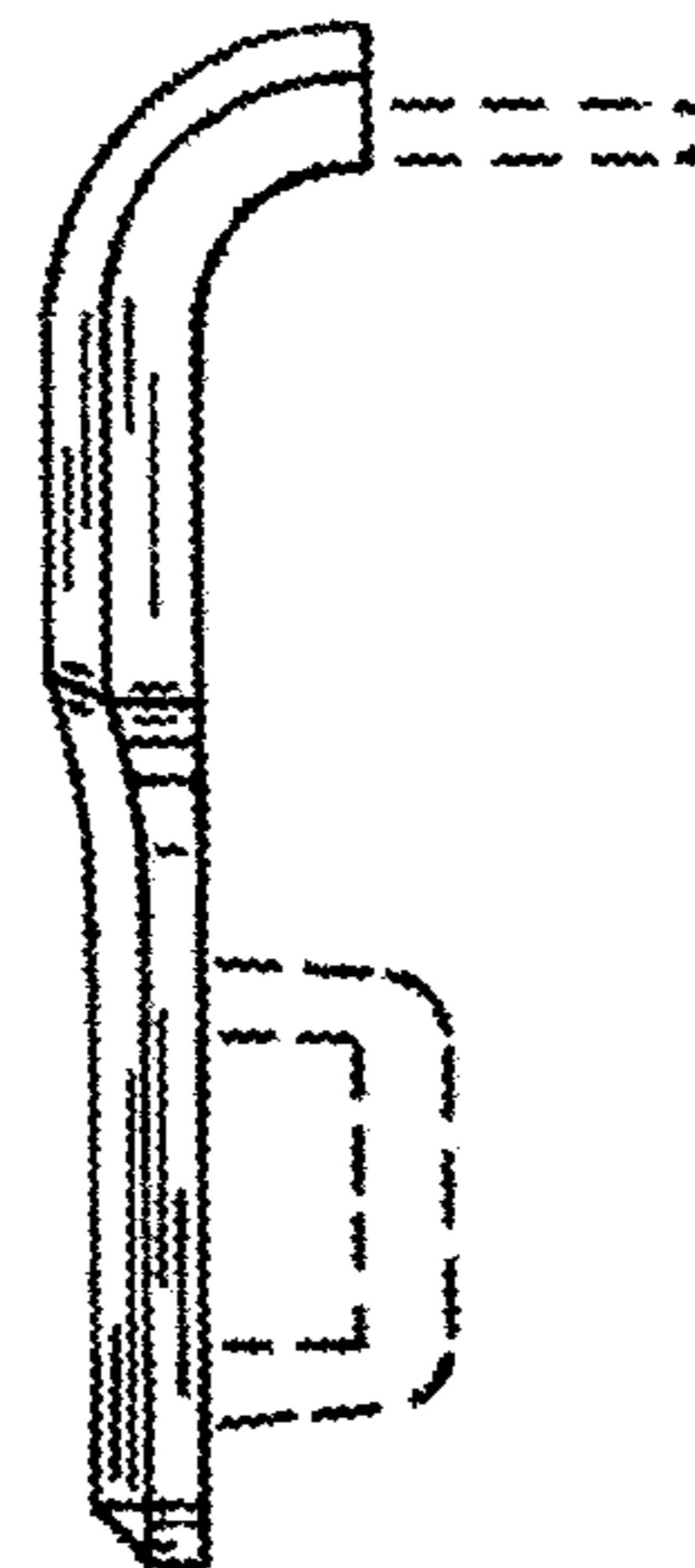
