FIG. 11 is a front elevational view thereof.

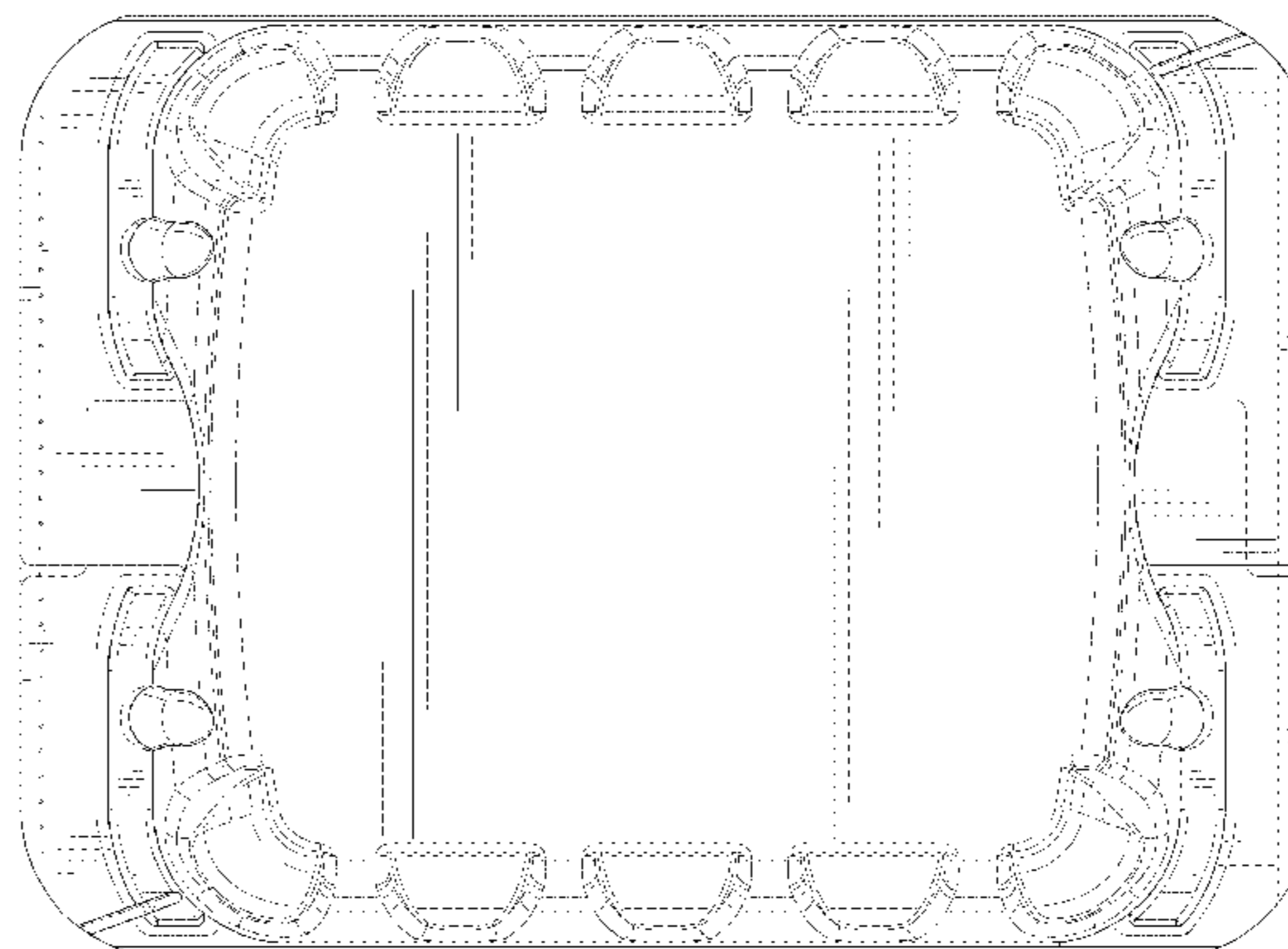
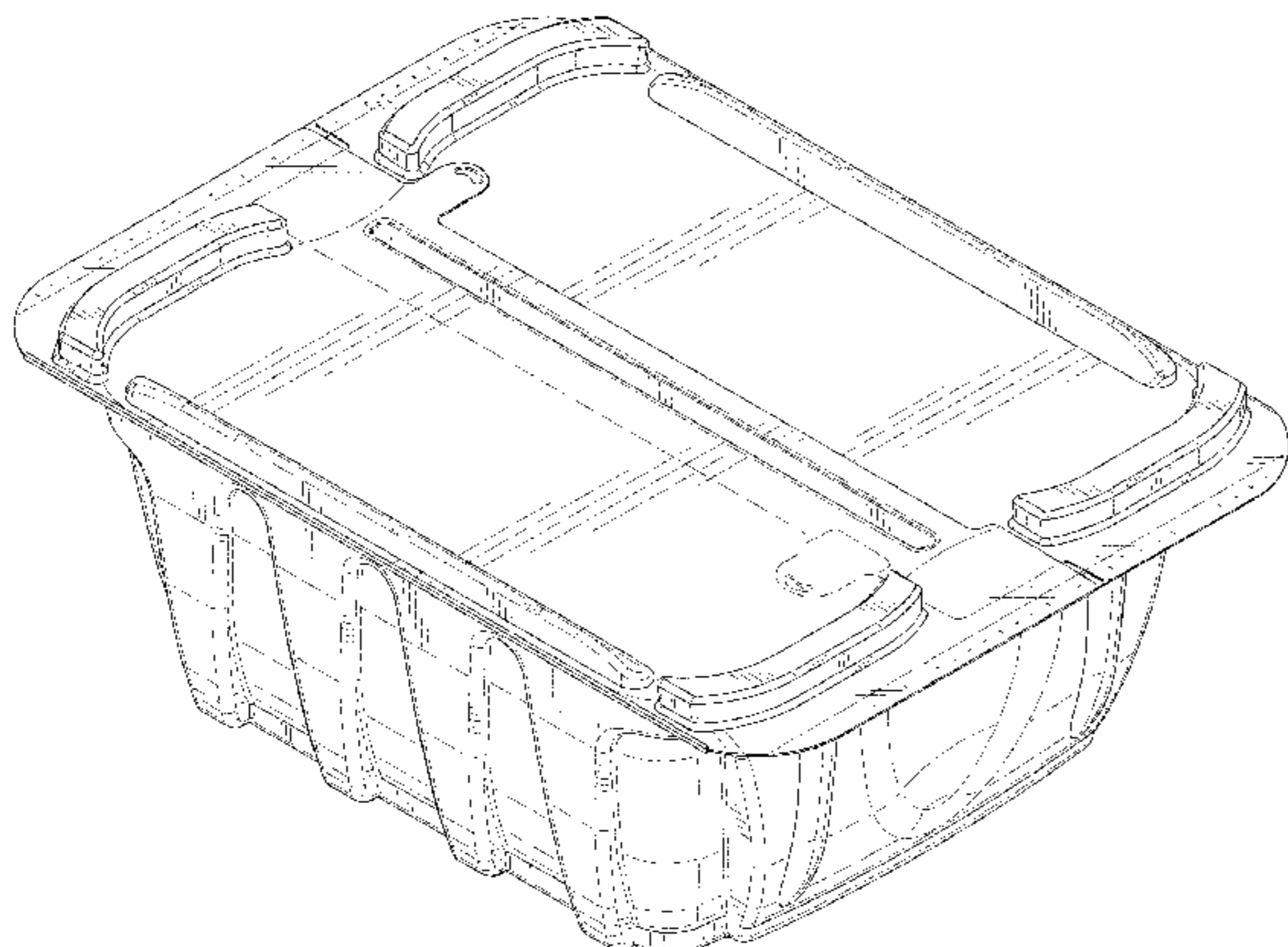
FIG. 12 is a rear elevational view thereof.

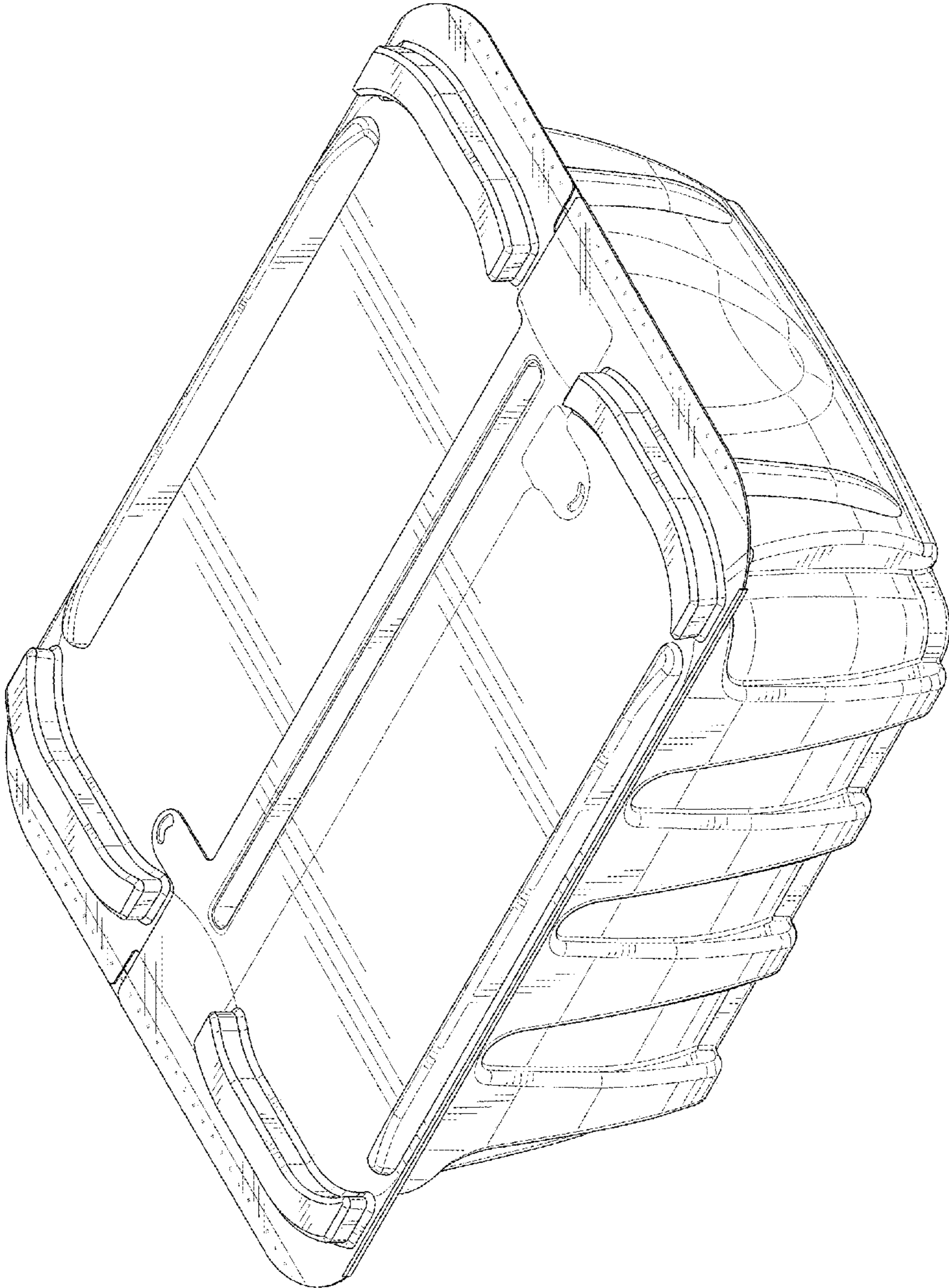

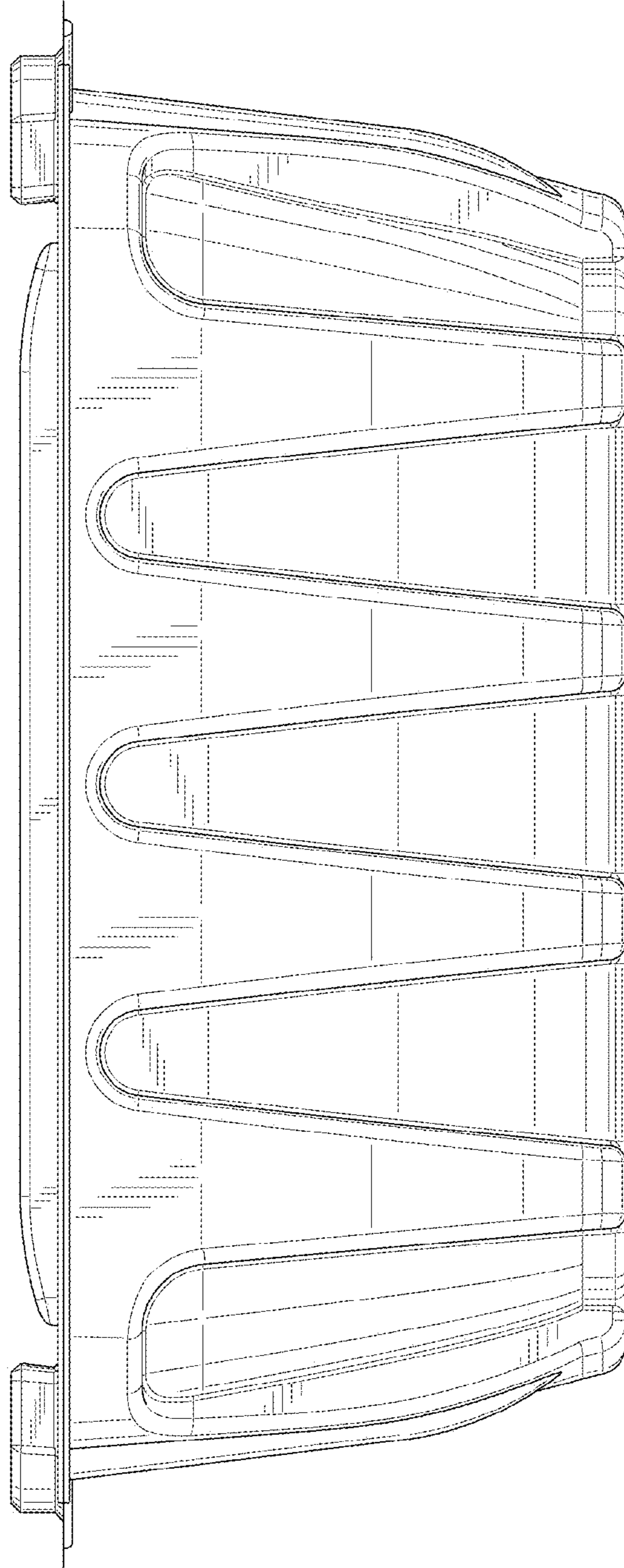

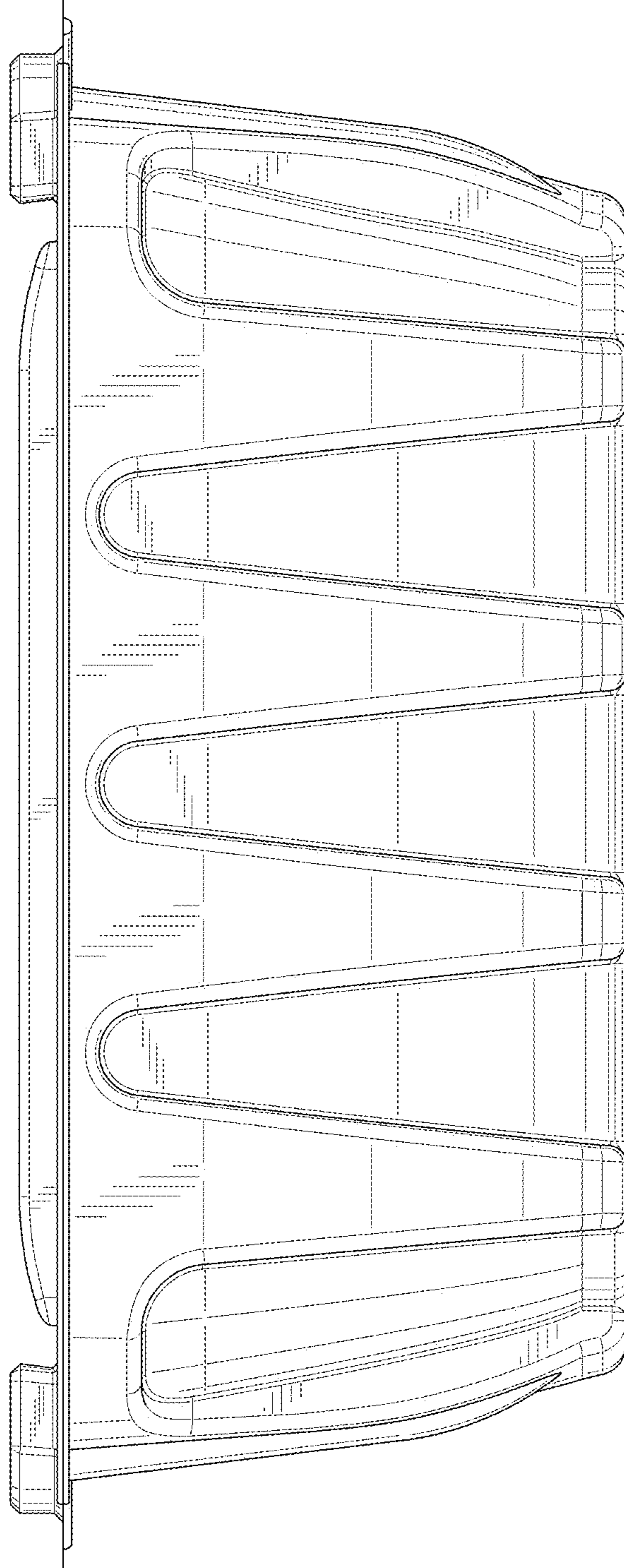

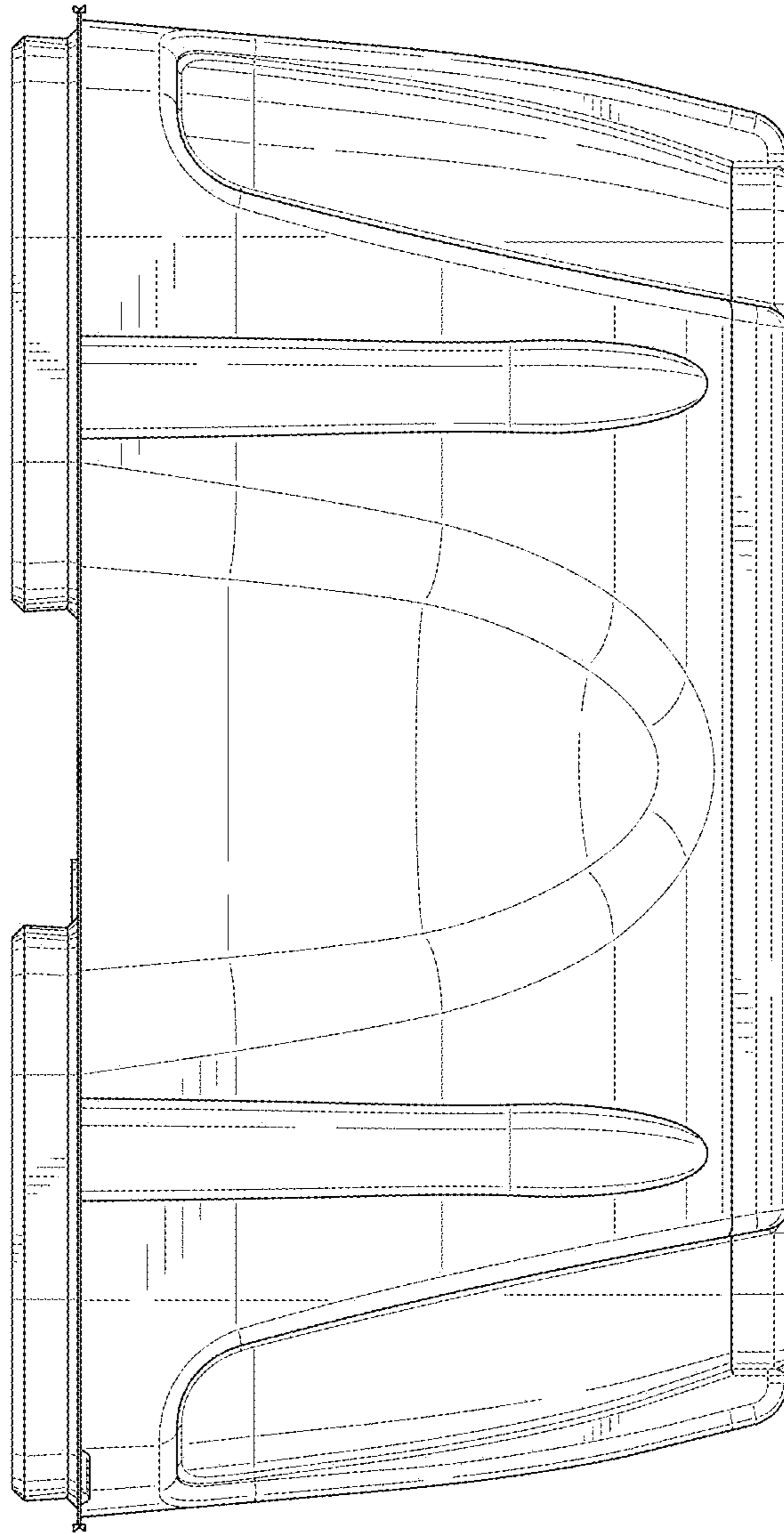

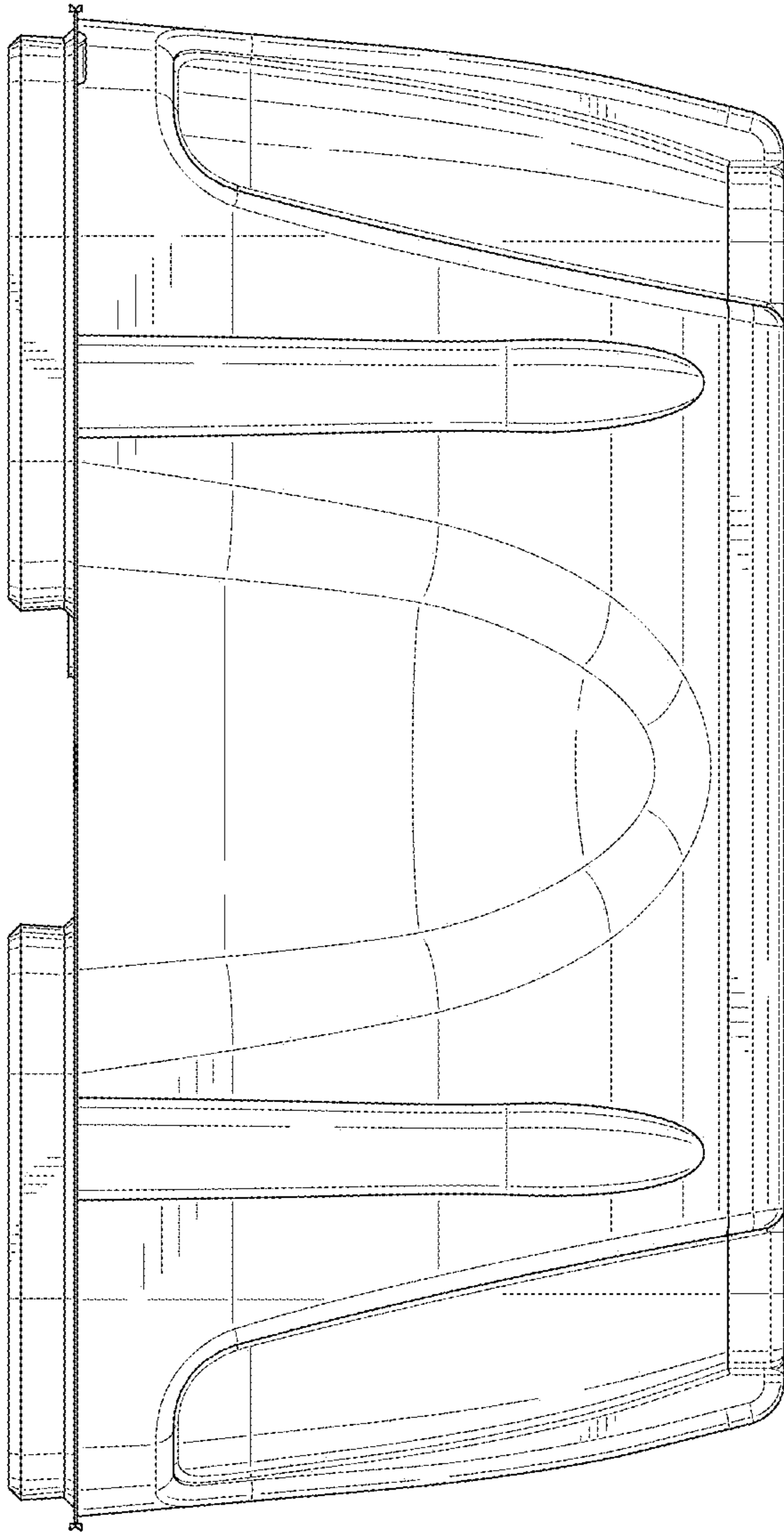

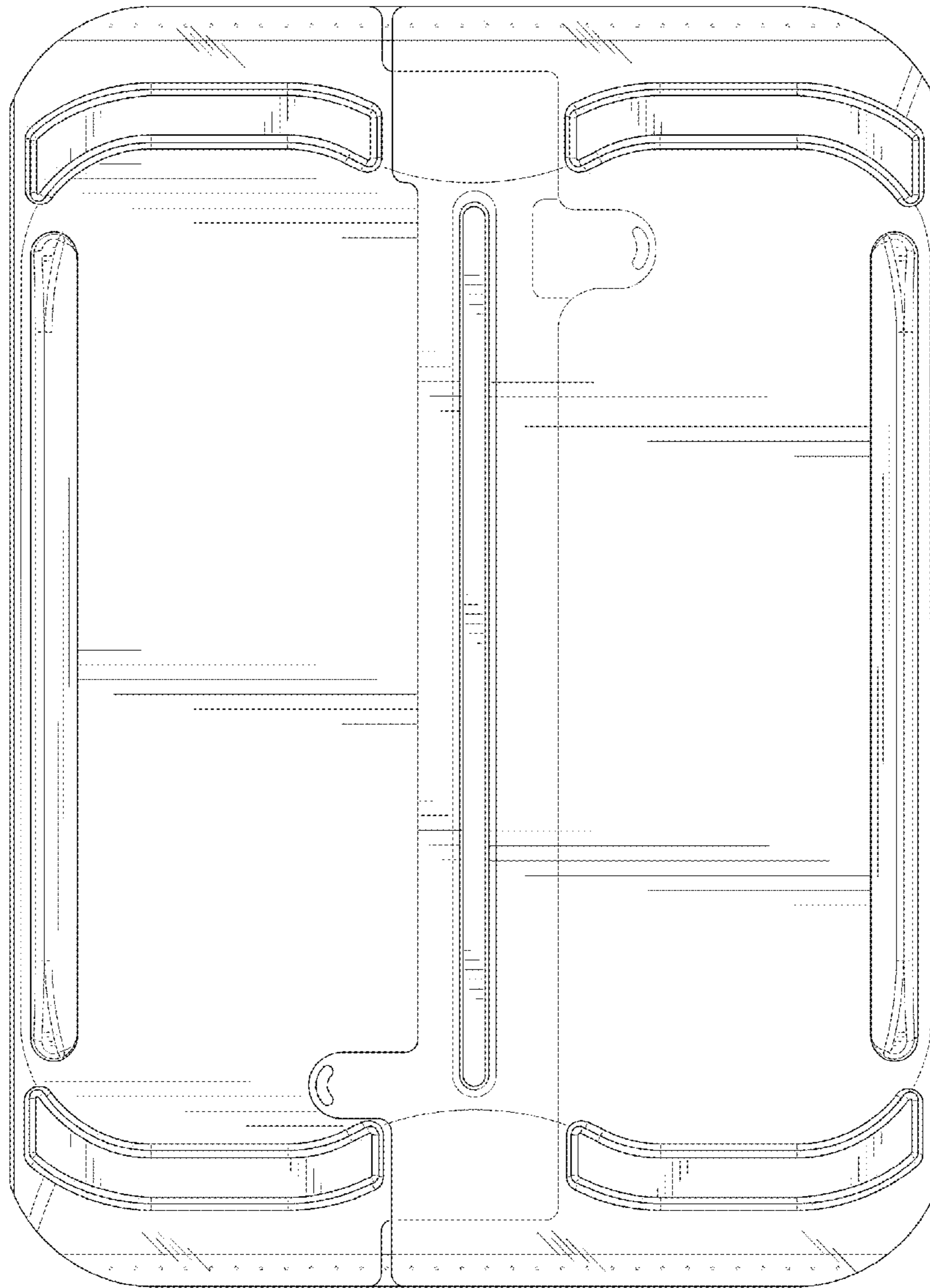

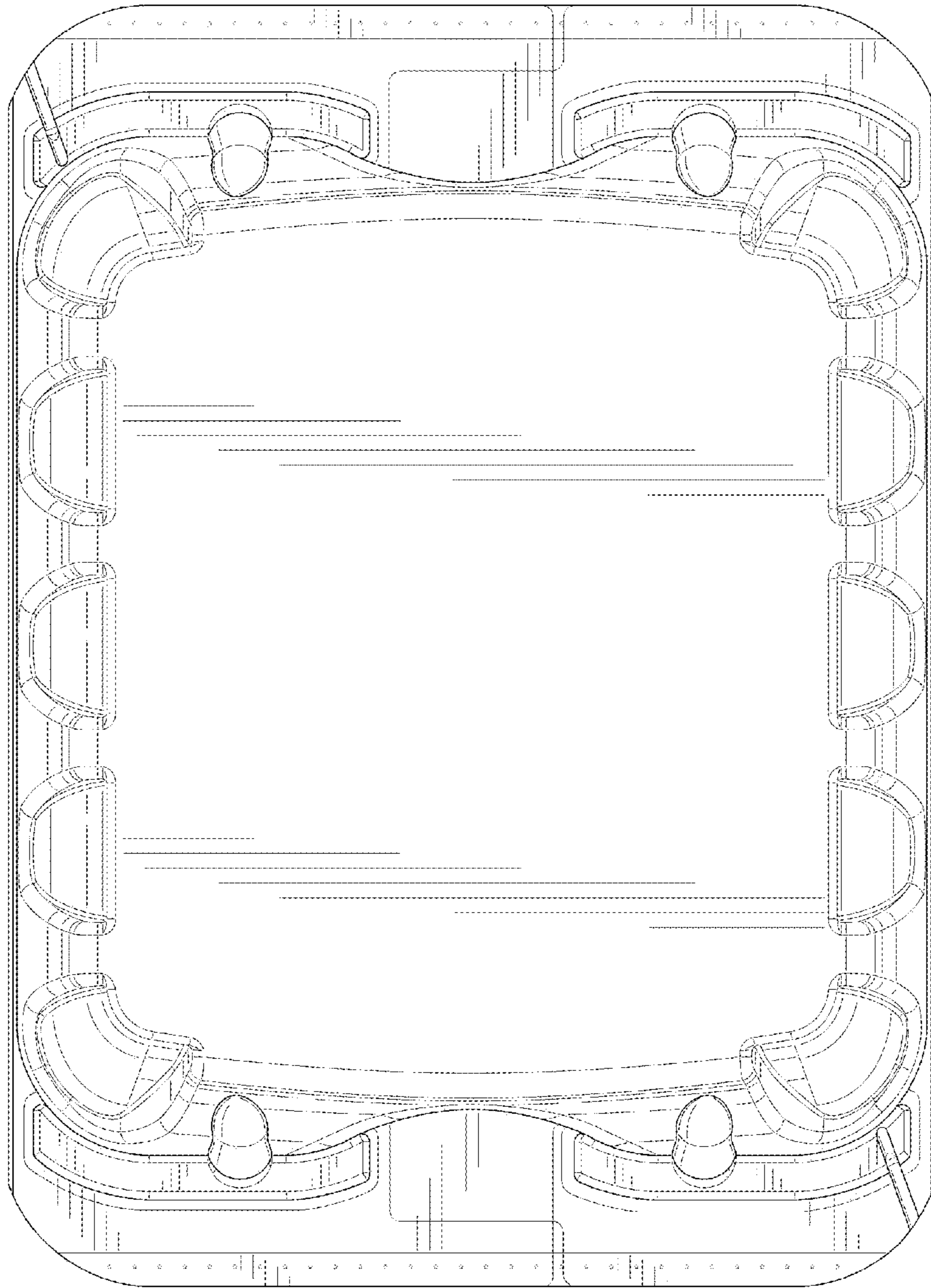

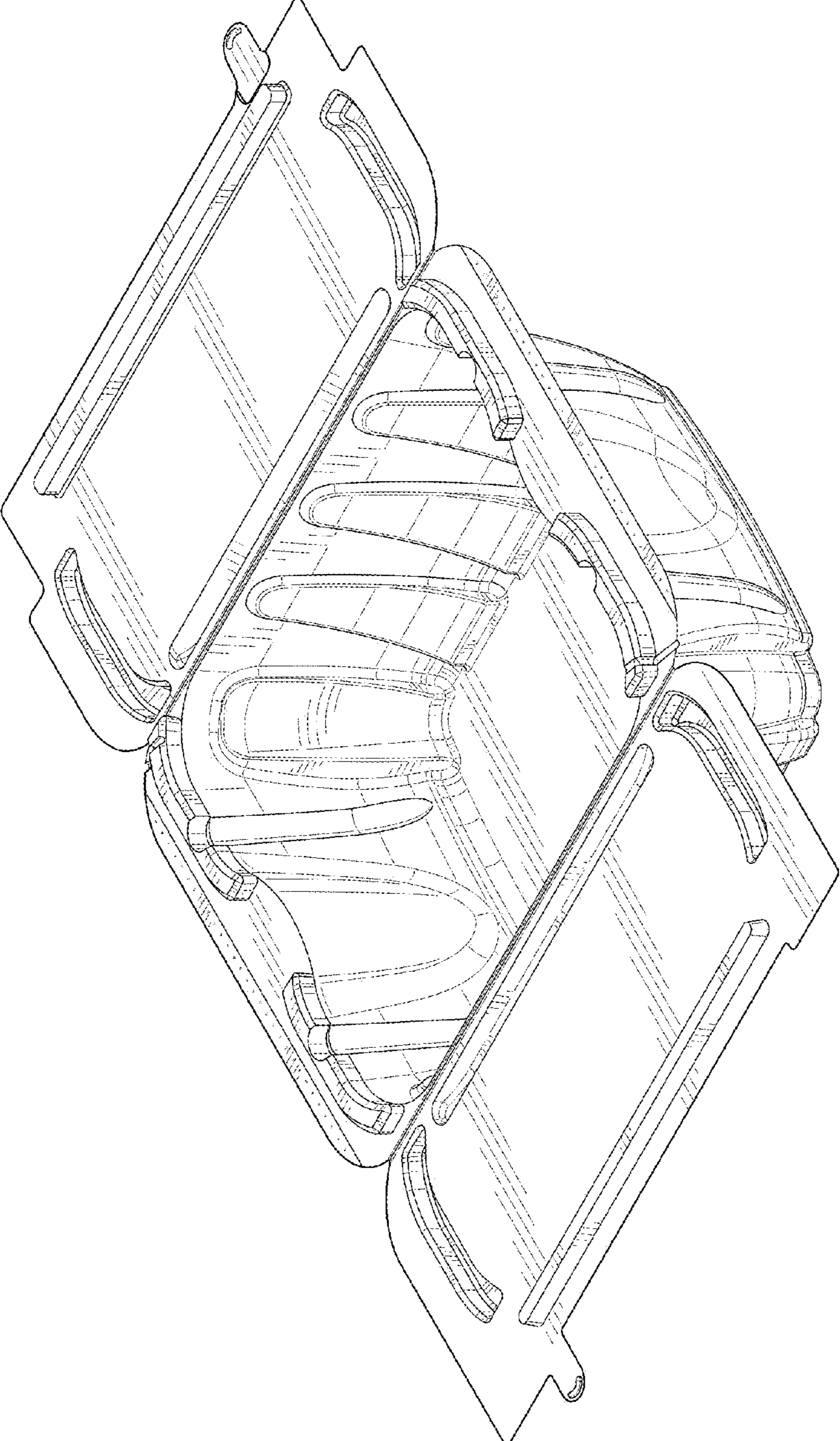

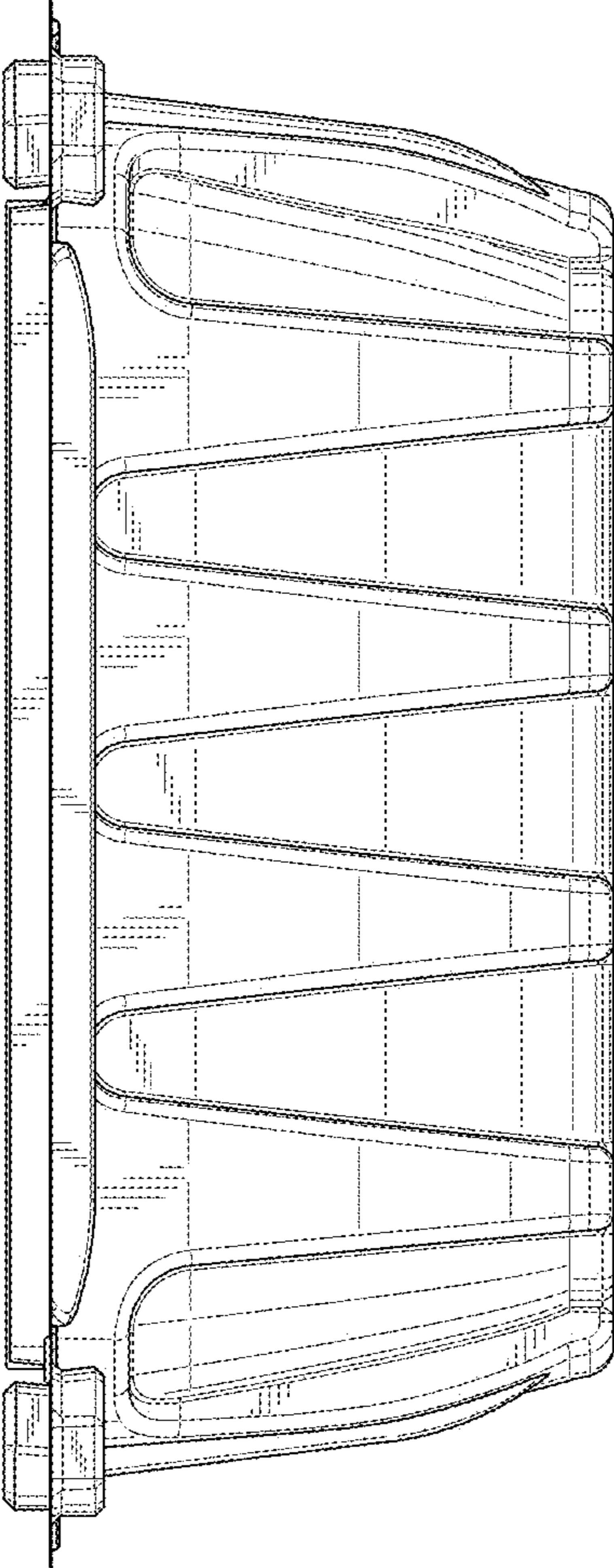

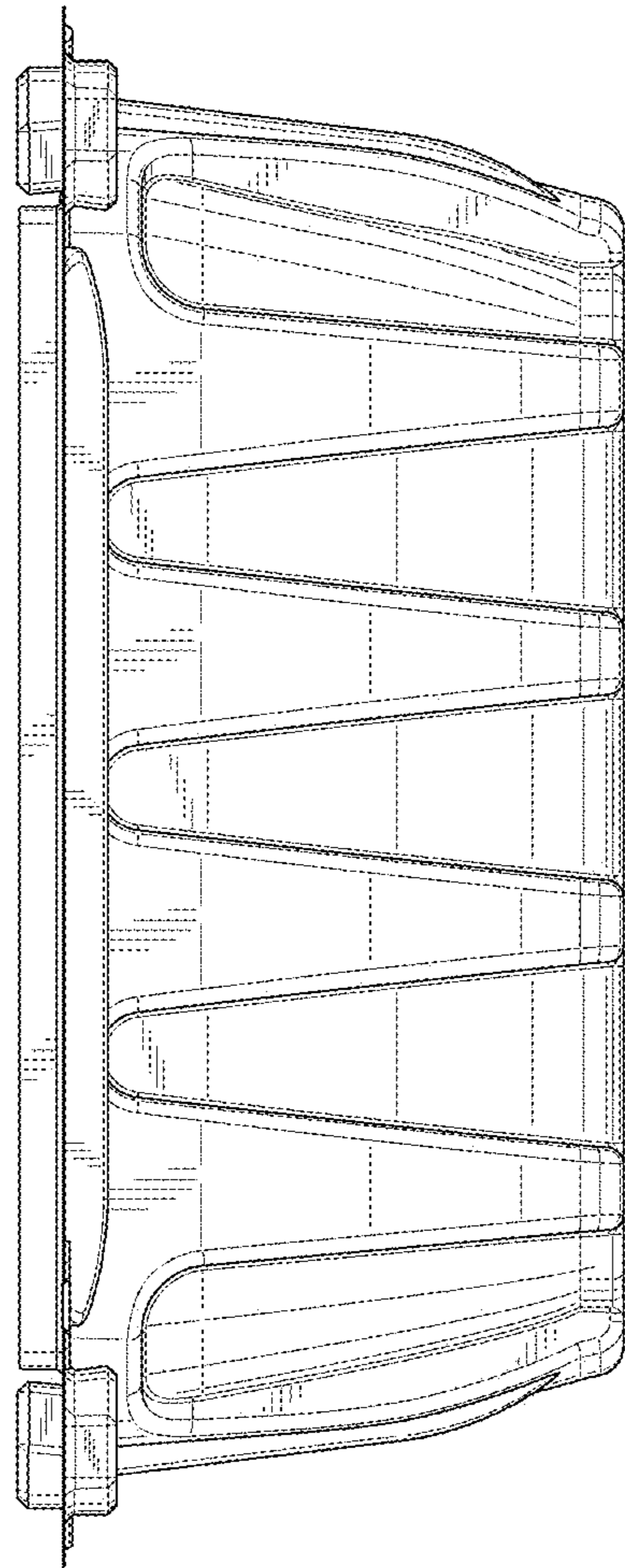

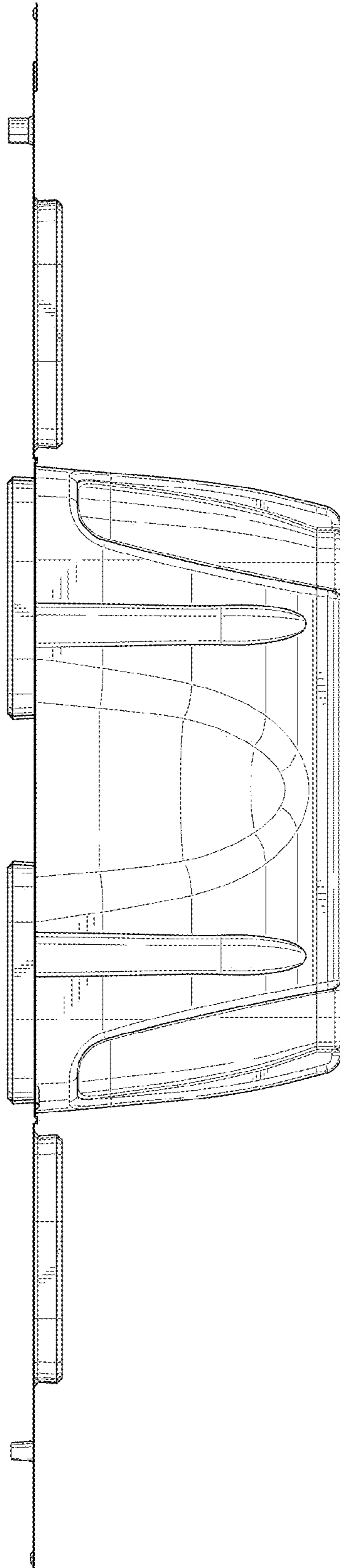

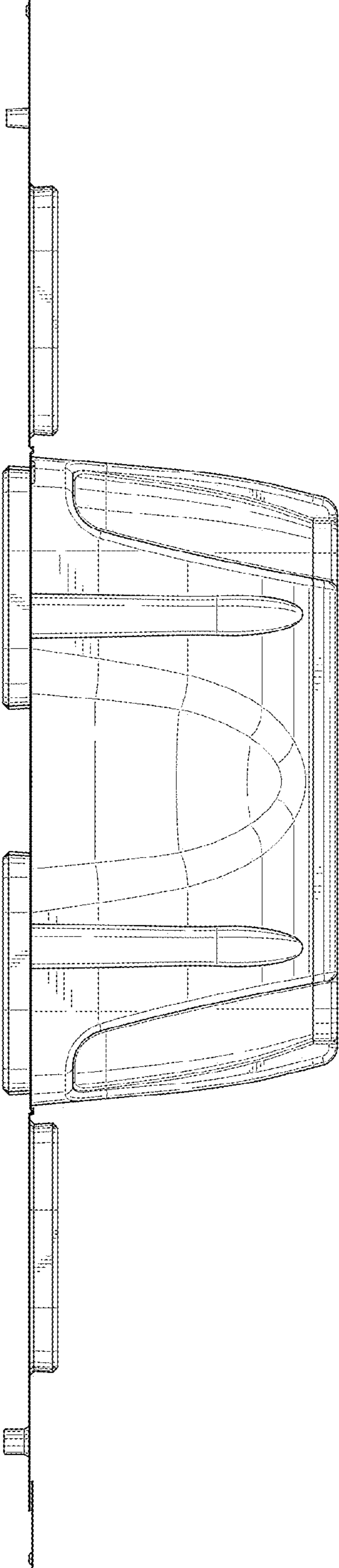

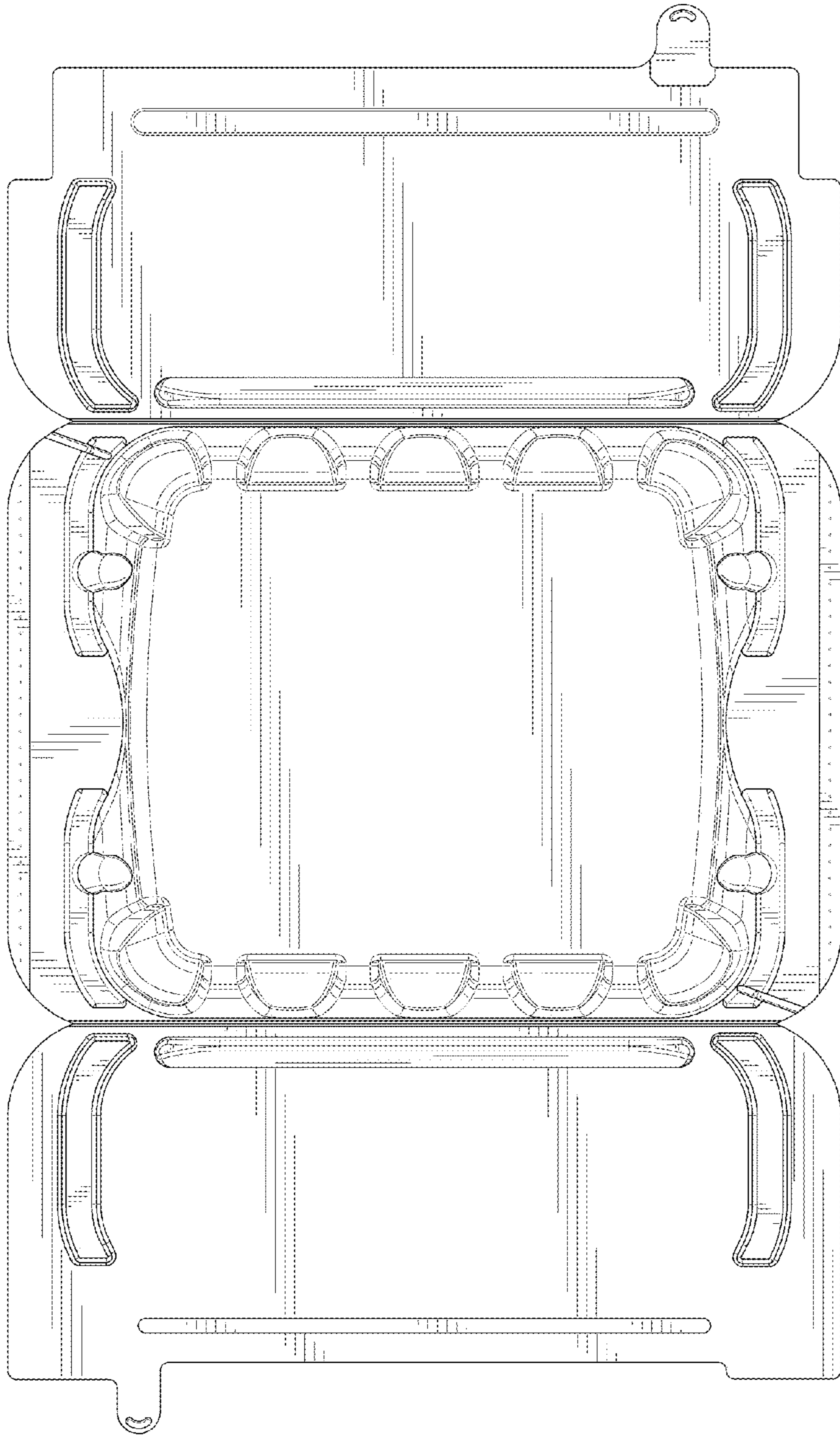

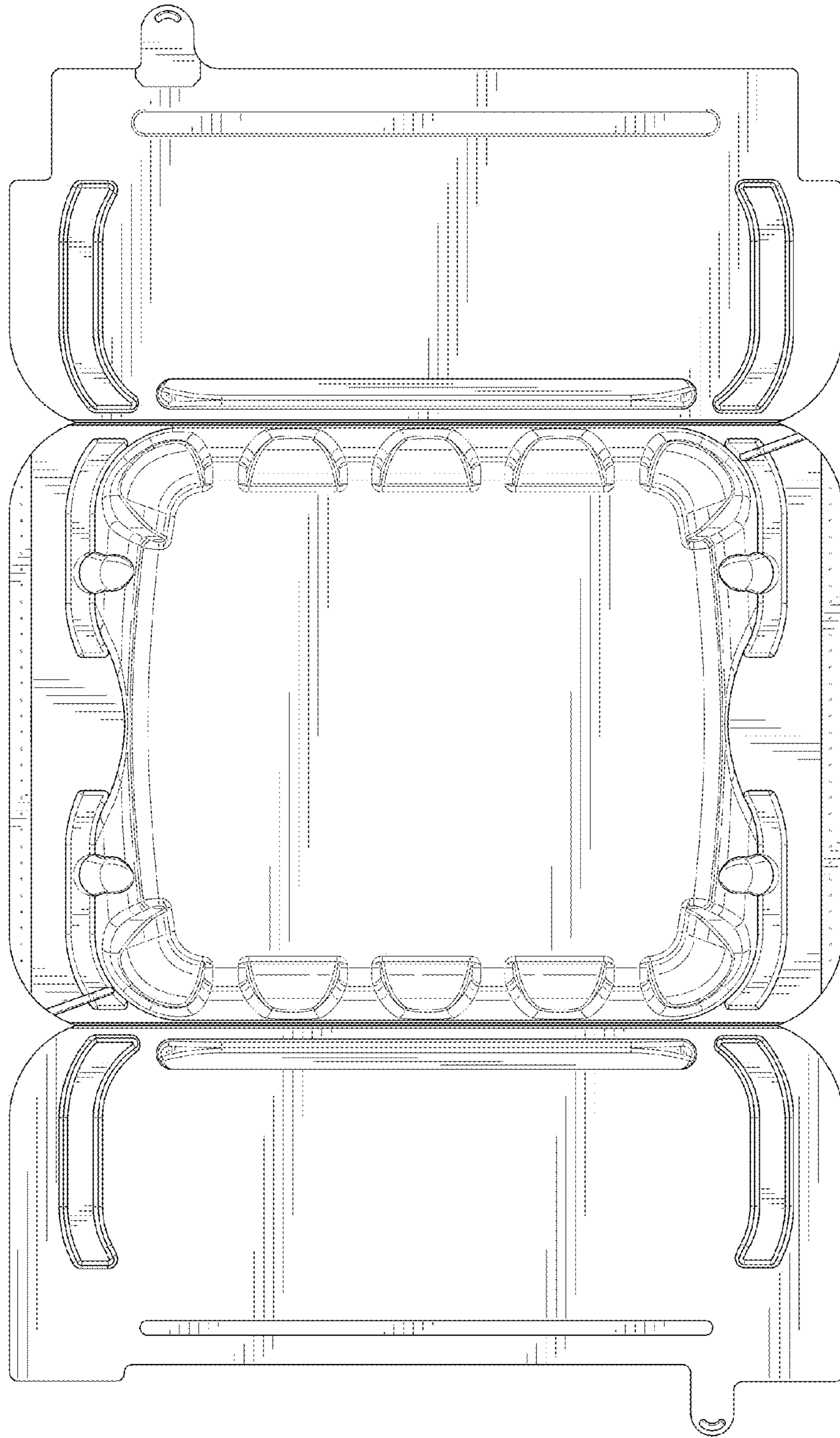
