(57) **CLAIM**

We claim the ornamental design for a temperature adjuster, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a temperature adjuster showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a back view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a side view thereof;

FIG. 7 is a side view of the opposite side of FIG. 6;

FIG. 8 is a front view thereof, showing LCD during operation;

FIG. 9 is a front view thereof, showing LCD portion as a shaded area; and,

FIG. 10 is a partial expanded view of FIG. 6 (A-A portion).

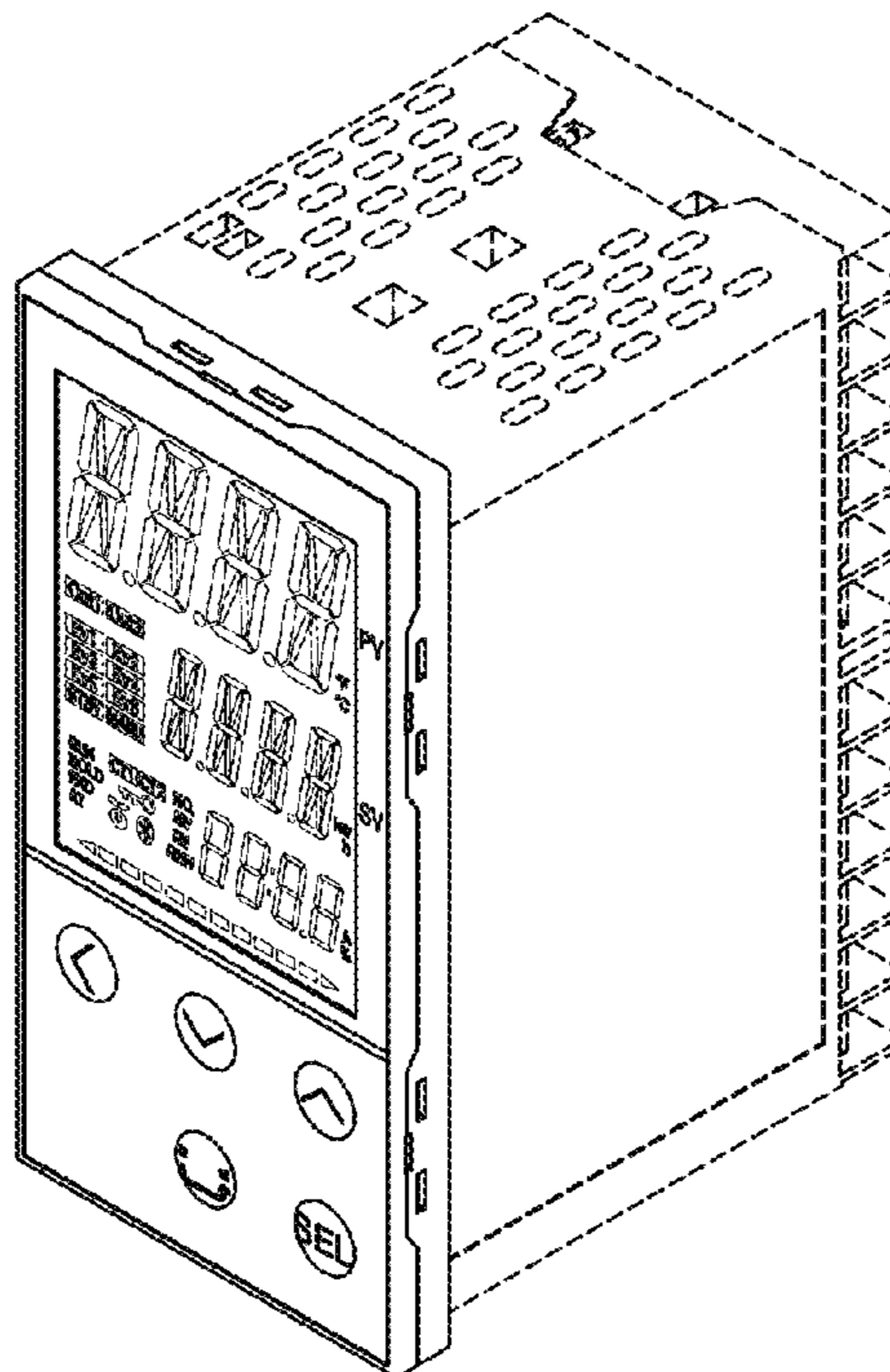

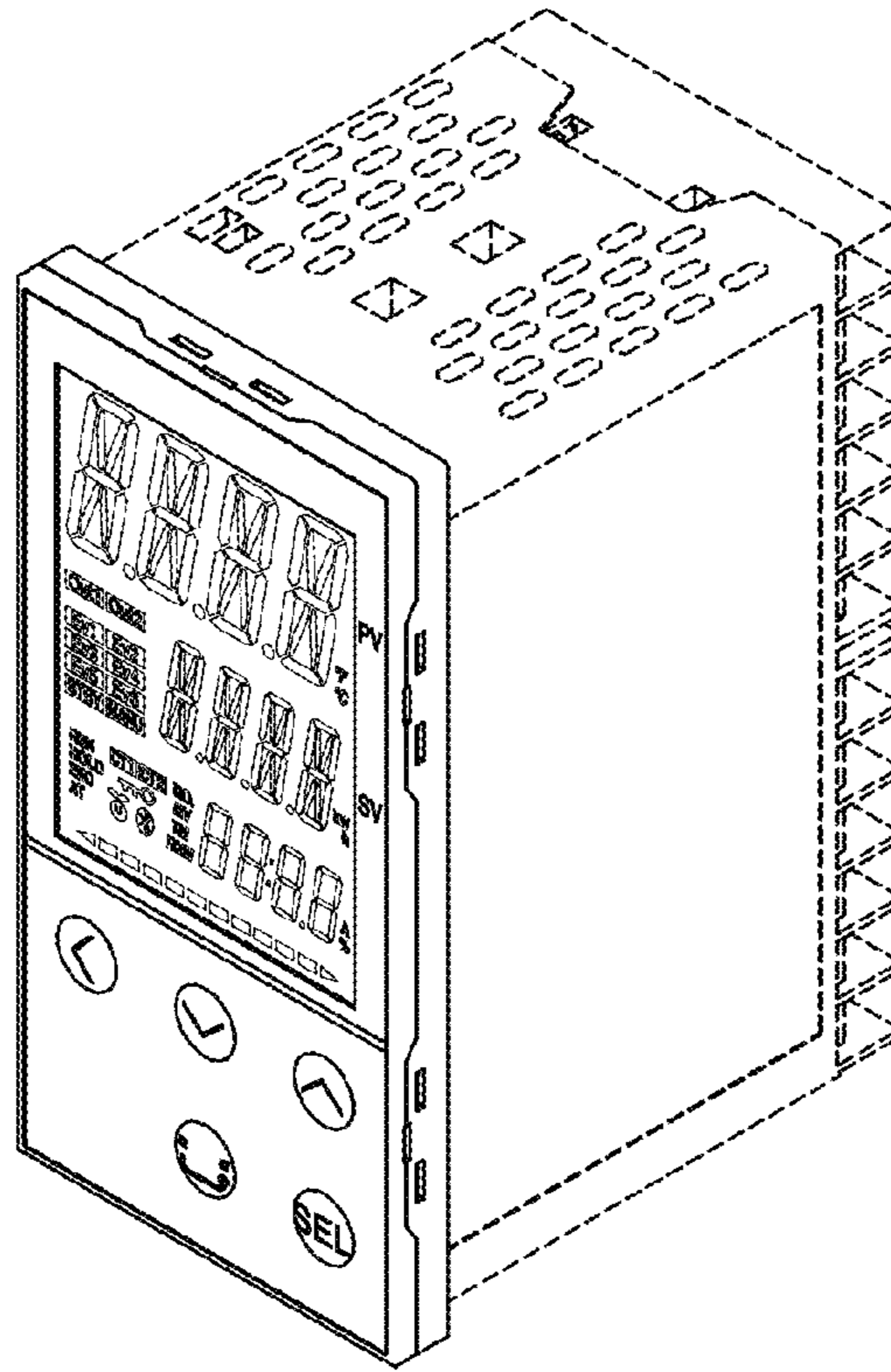

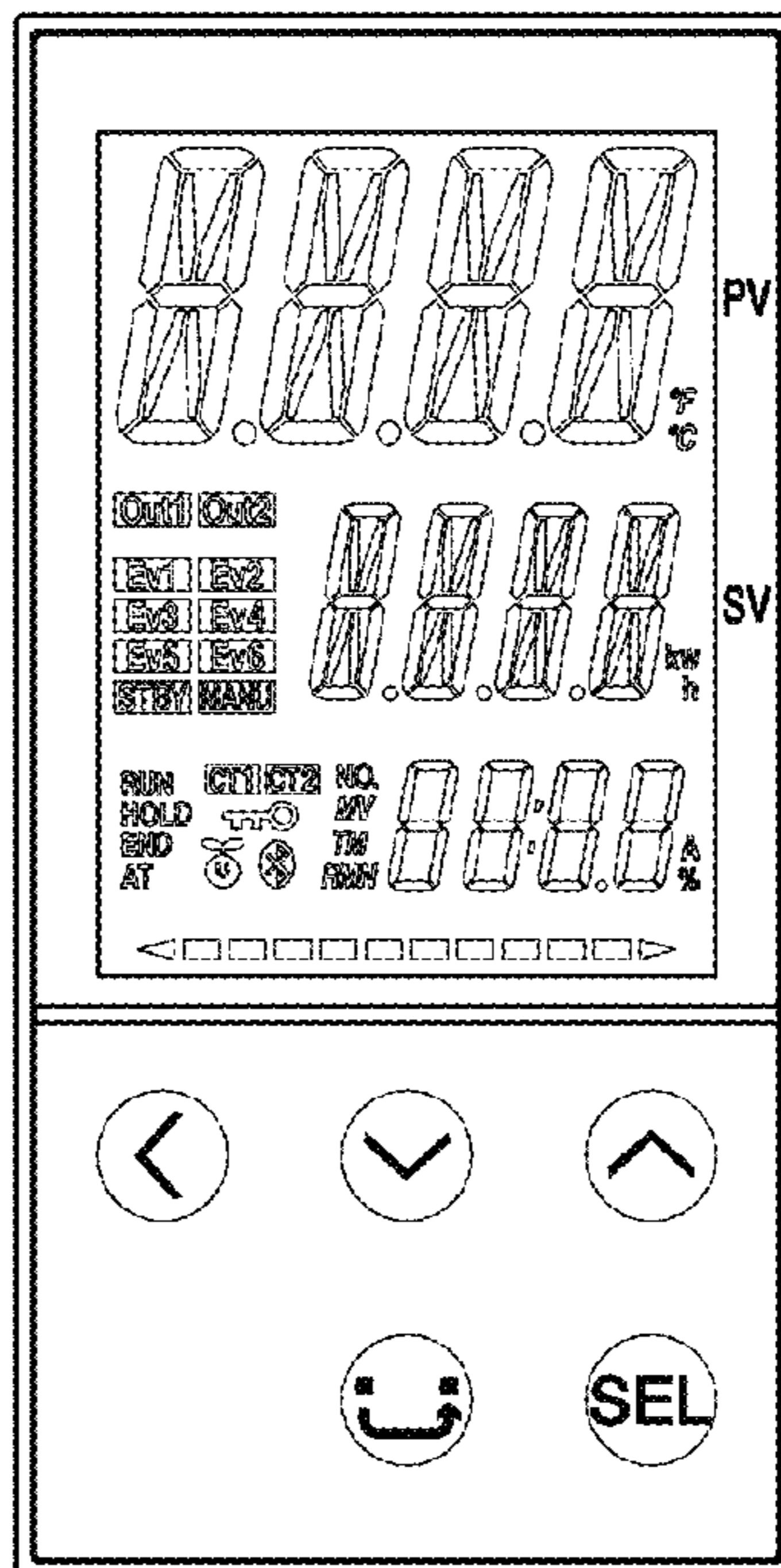

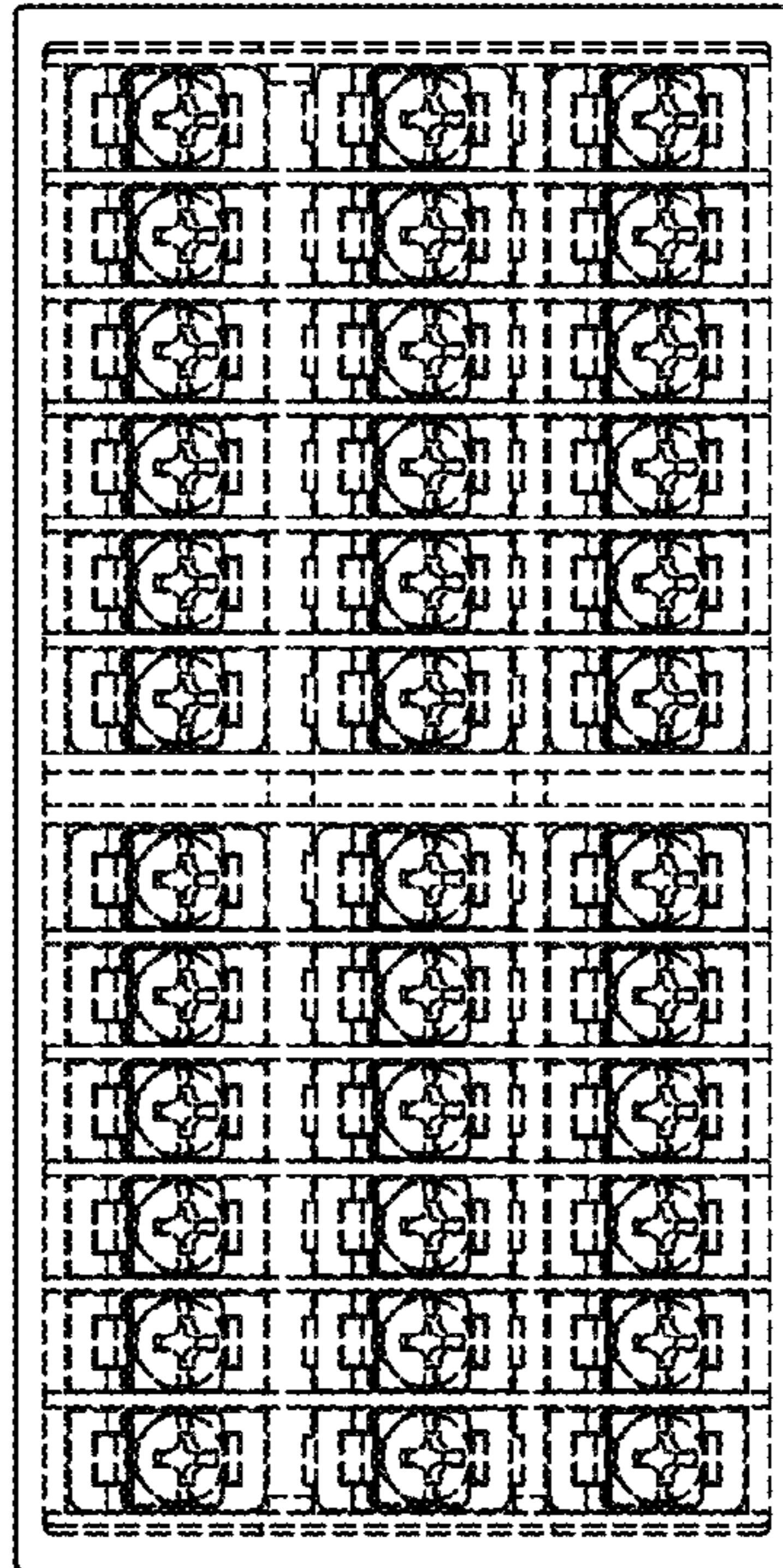

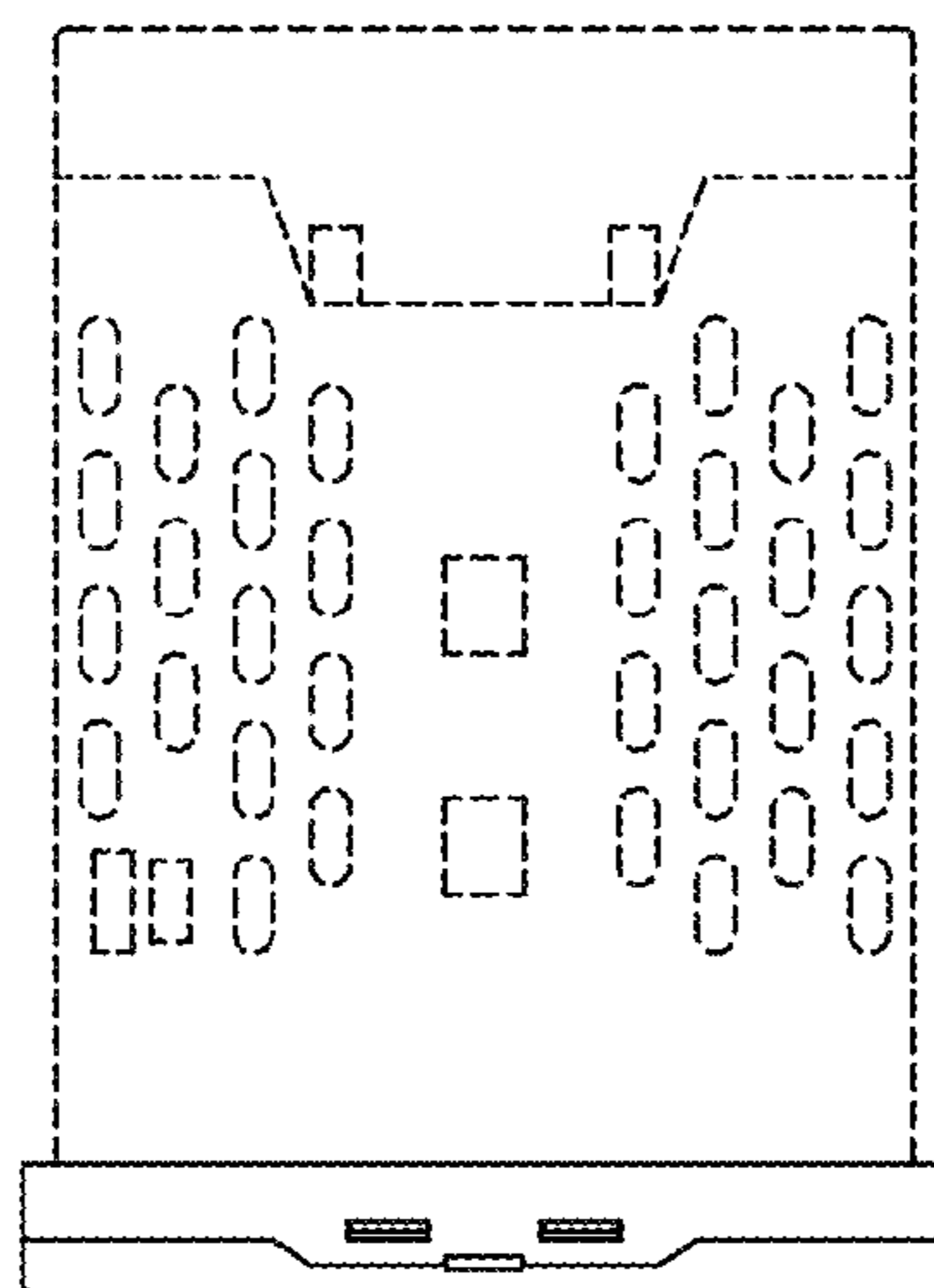

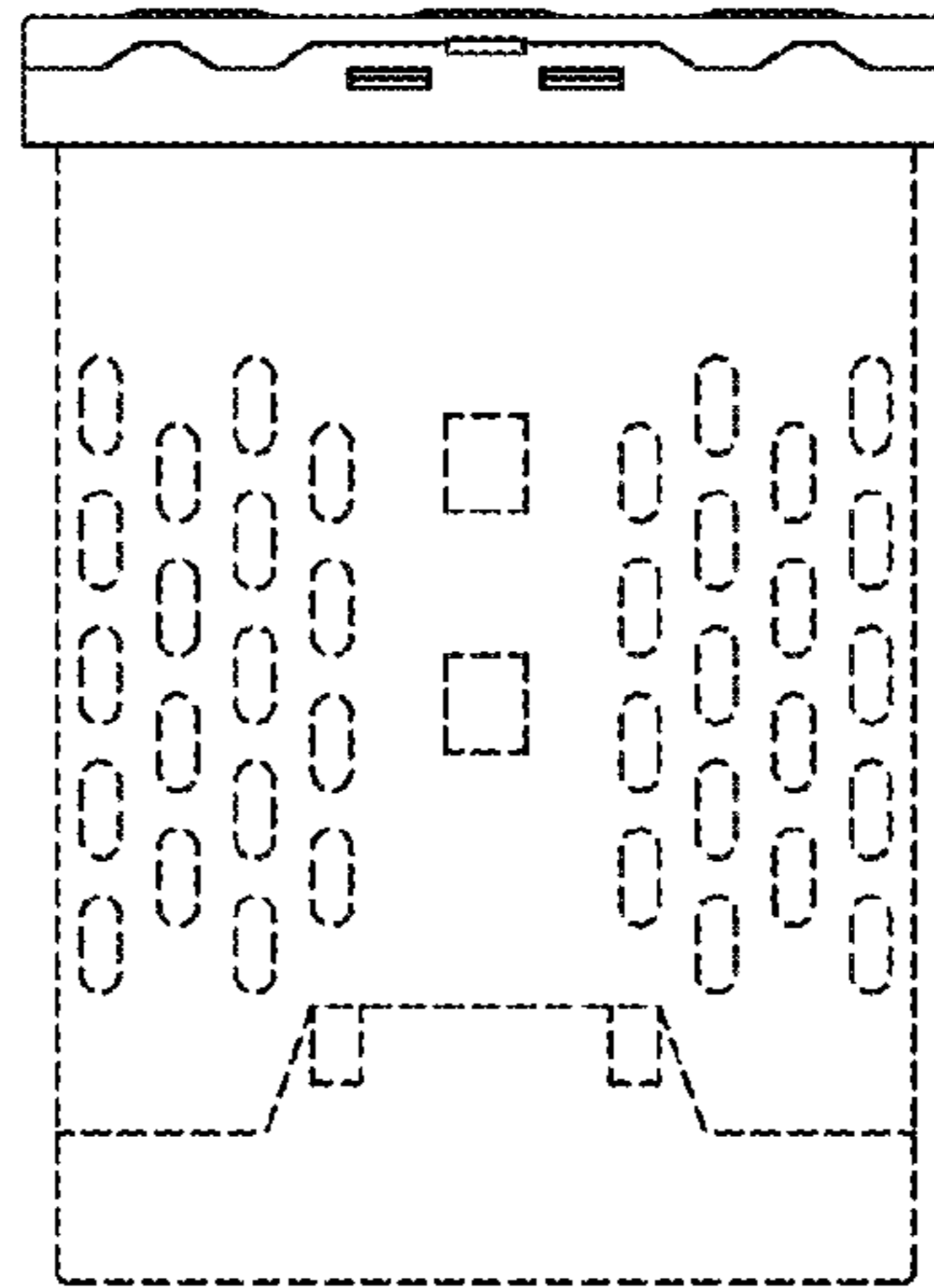

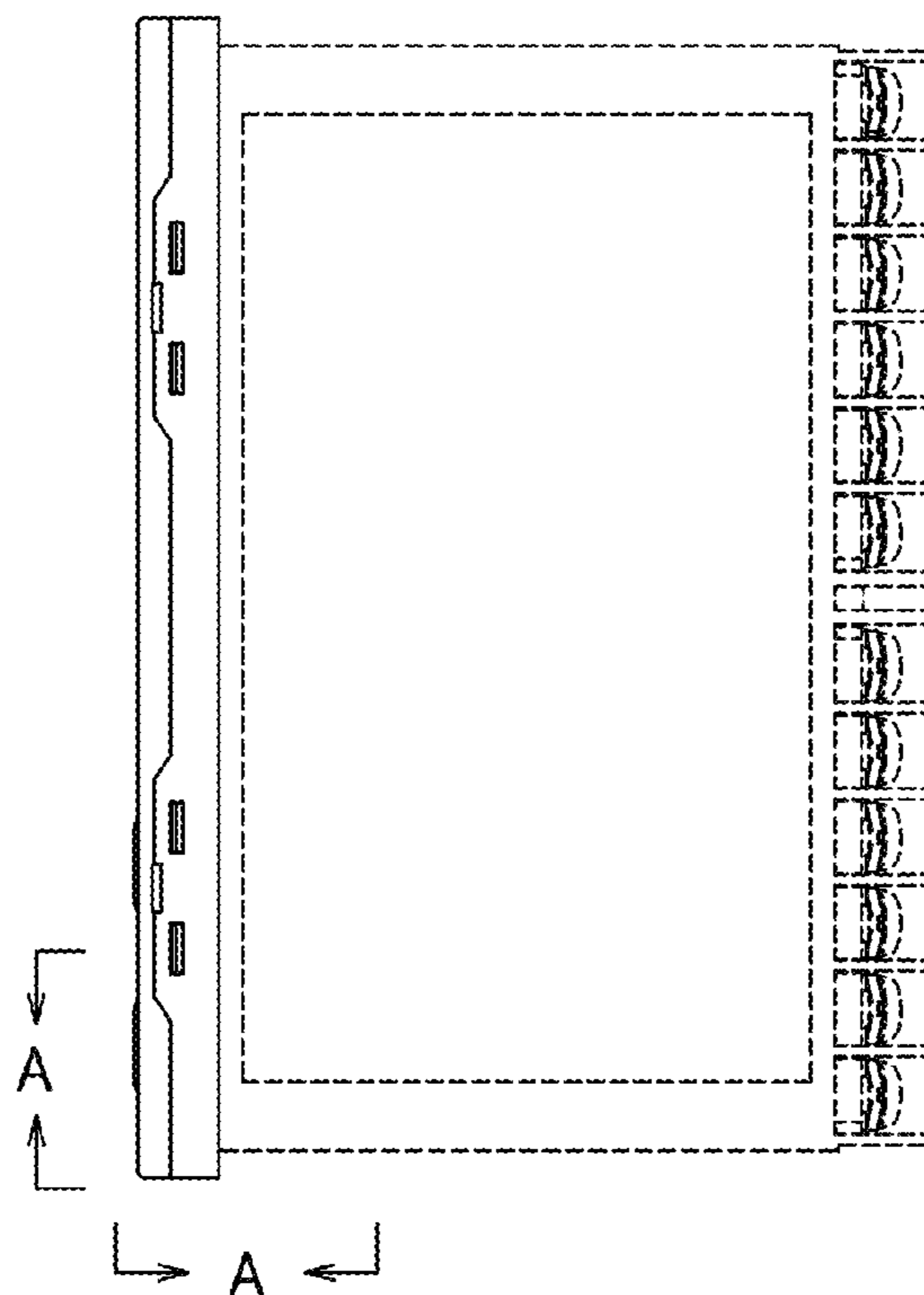

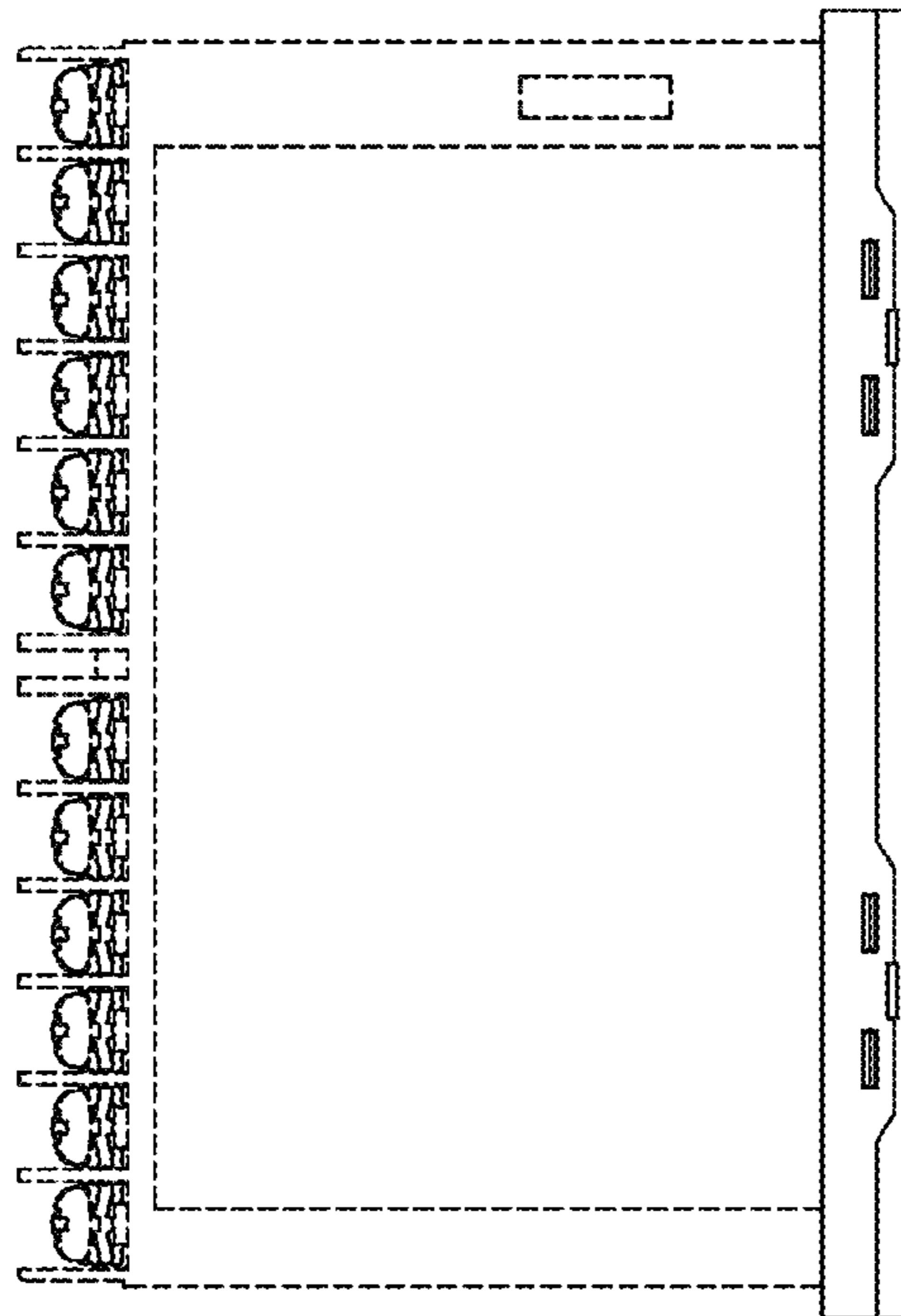

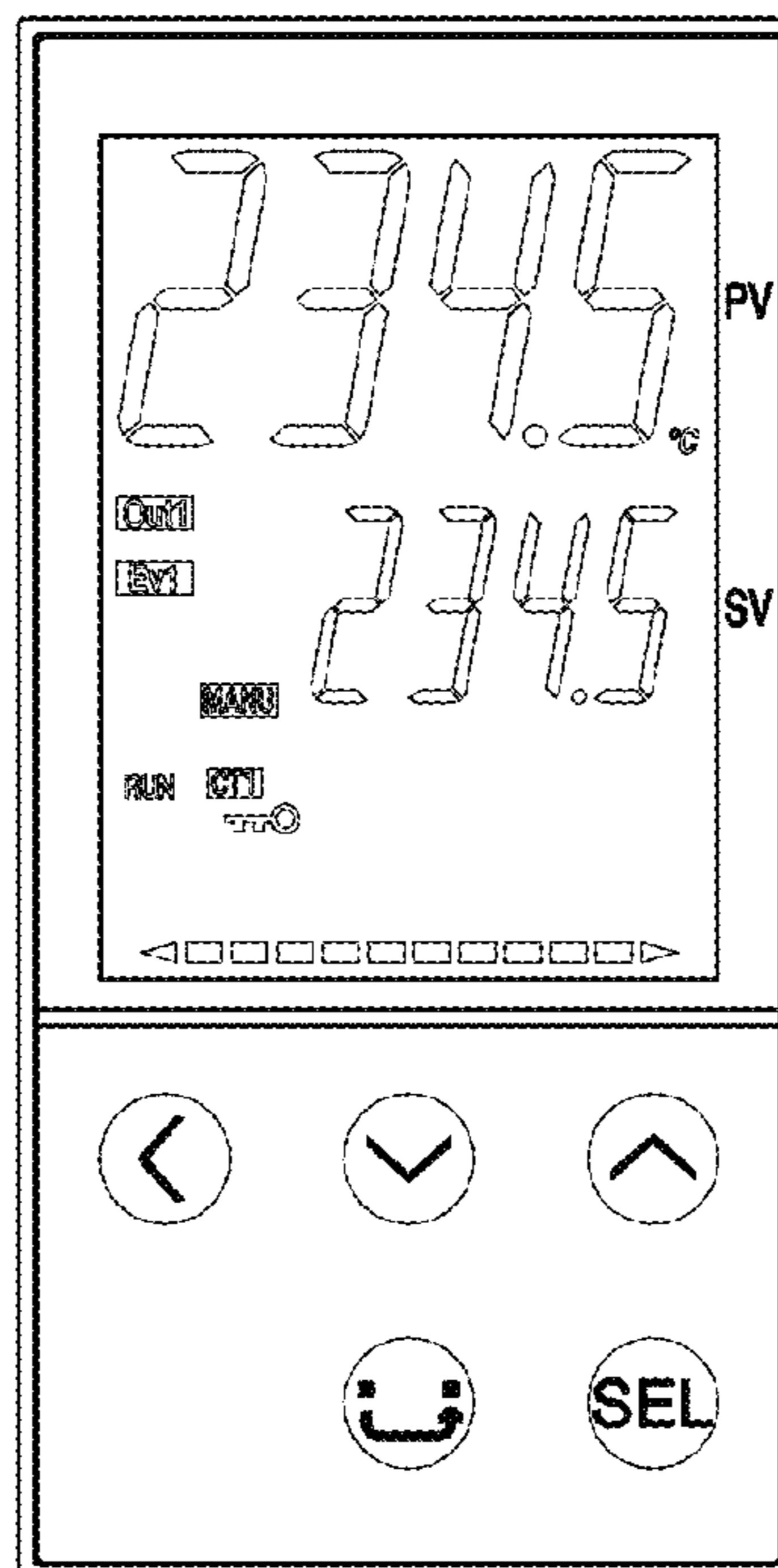

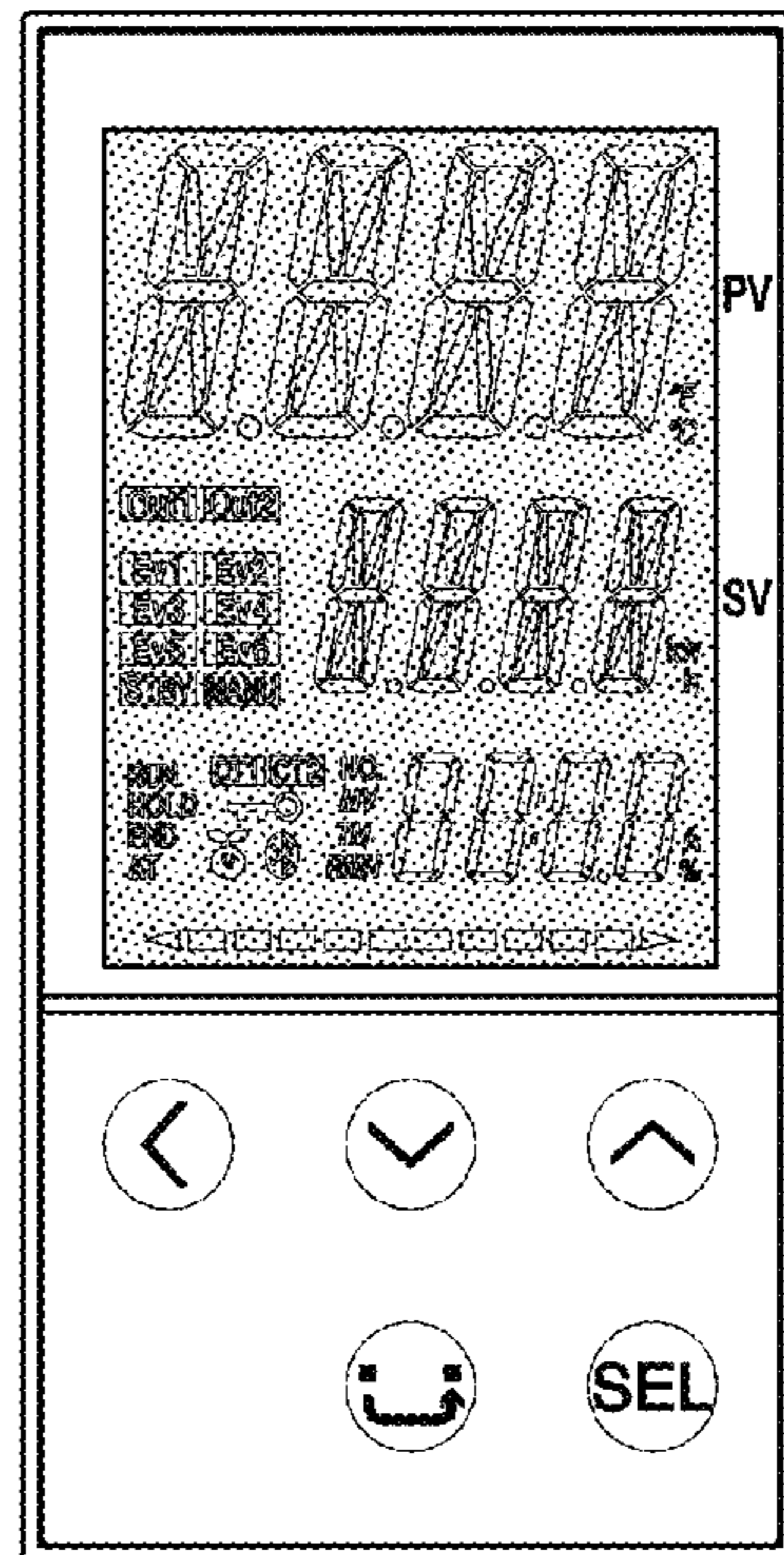
