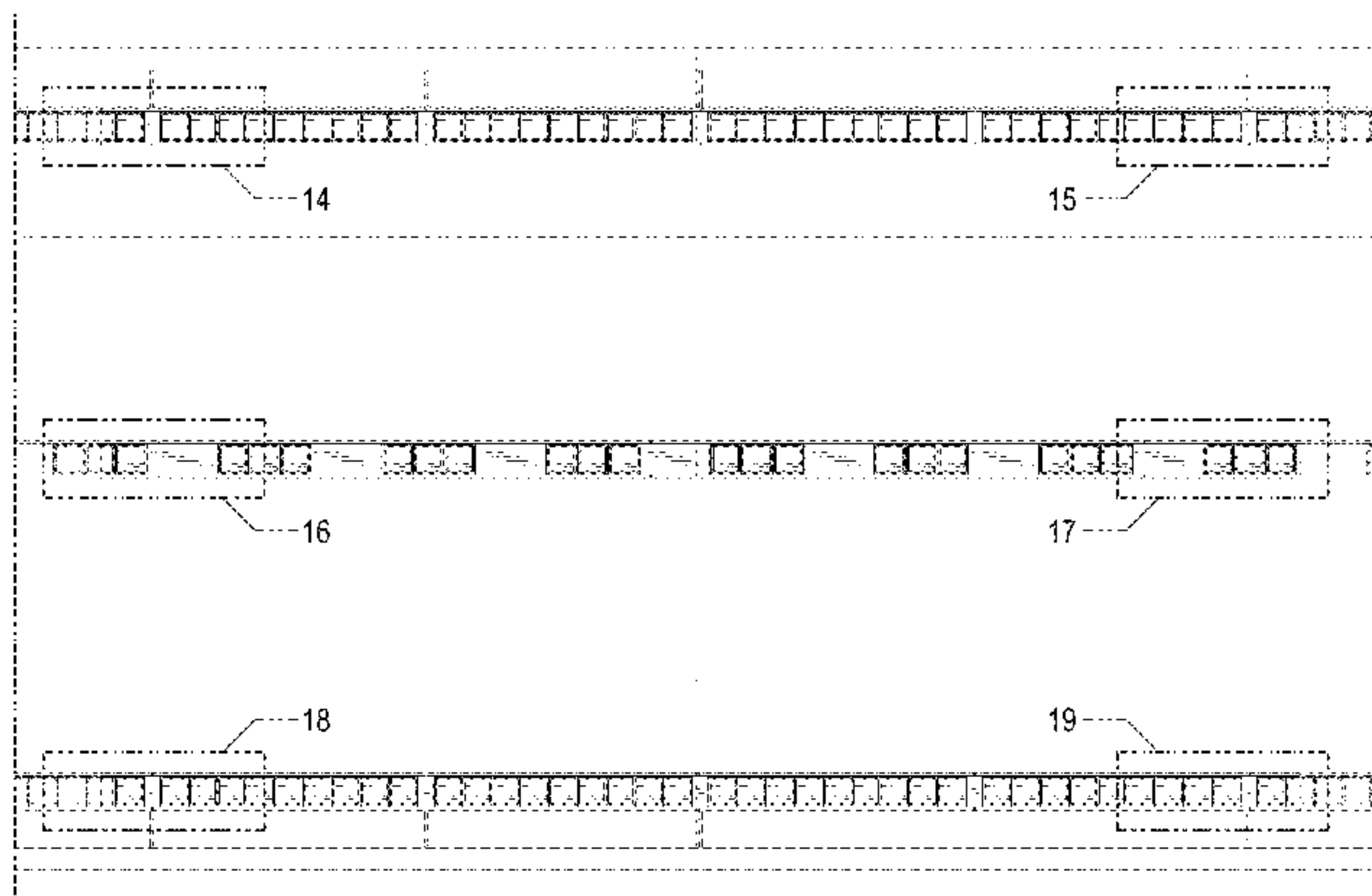
(57) **CLAIM**

The ornamental design for a lighting fixture for a passenger carrying car, as shown and described.

**DESCRIPTION**

FIG. 1 is a right-side elevational reference view of a representative rail car which indicates the locations subsequent views;  
 FIG. 2 is top plan reference view of the representative rail car and which indicates the locations subsequent views;  
 FIG. 3 is a cross-sectional view along line 3 in FIG. 1 showing the lighting fixture for a passenger carrying car;  
 FIG. 4 is an enlarged view of the area 4 in FIG. 3;  
 FIG. 5 is an enlarged view of the area 5 in FIG. 3;  
 FIG. 6 is an enlarged view of the area 6 in FIG. 3;

 FIG. 13 is a cross-sectional view along line 13 in FIG. 3;  
 FIG. 14 is an enlarged view of the area 14 in FIG. 13;  
 FIG. 15 is an enlarged view of the area 15 in FIG. 13;  
 FIG. 16 is an enlarged view of the area 16 in FIG. 13;  
 FIG. 17 is an enlarged view of the area 17 in FIG. 13;  
 FIG. 18 is an enlarged view of the area 18 in FIG. 13; and,  
 FIG. 19 is an enlarged view of the area 19 in FIG. 13.  
 The broken lines depict environmental subject matter only and form no part of the claimed design. The dot-dash chain lines indicate boundaries of the claimed subject matter and form no part of the claimed design. The dot-dot-dash chain lines indicate enlargement areas and form no part of the claimed design.

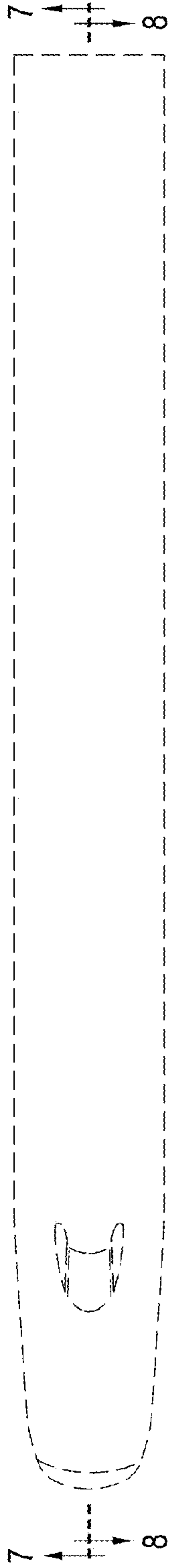

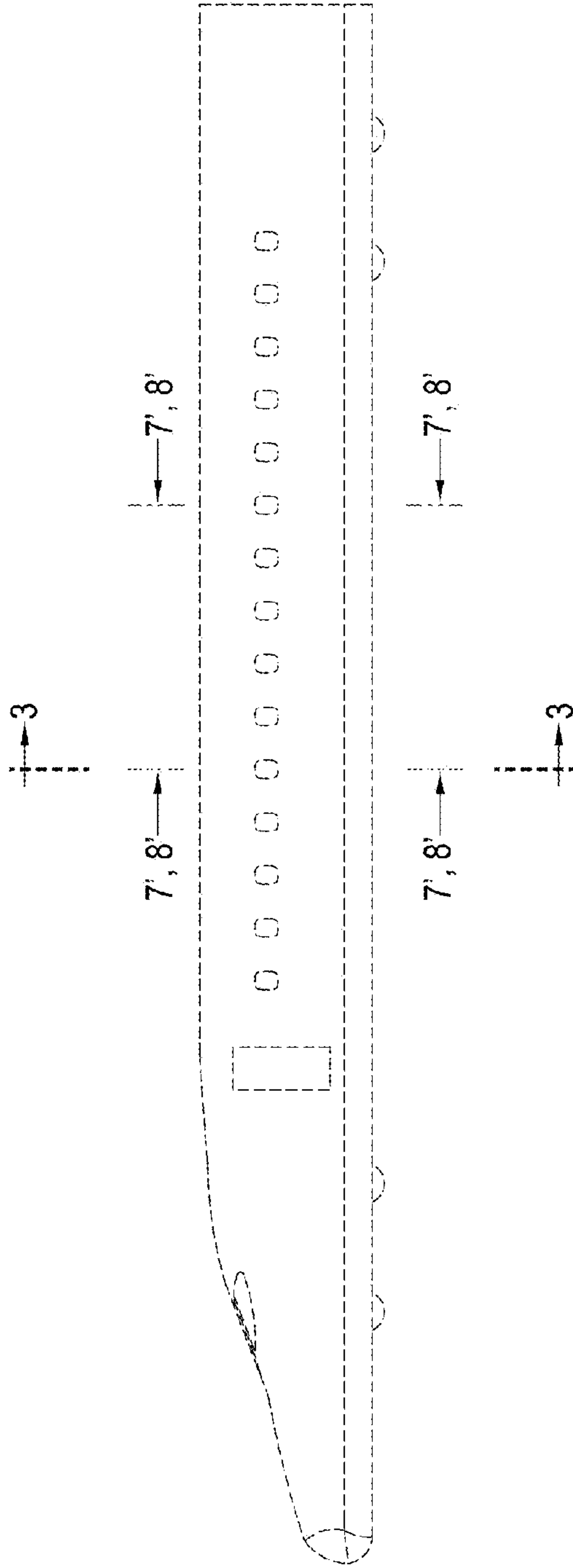

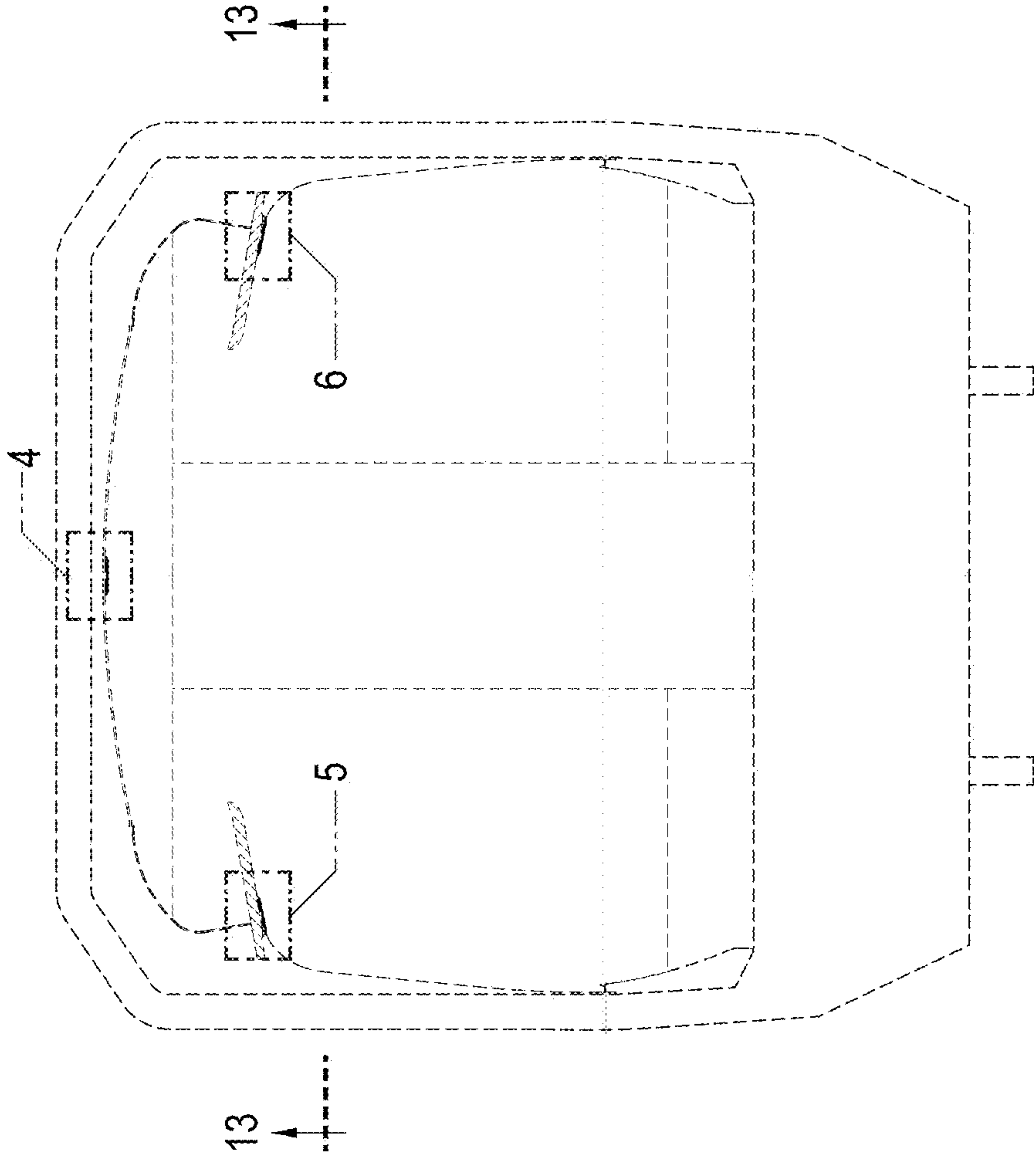

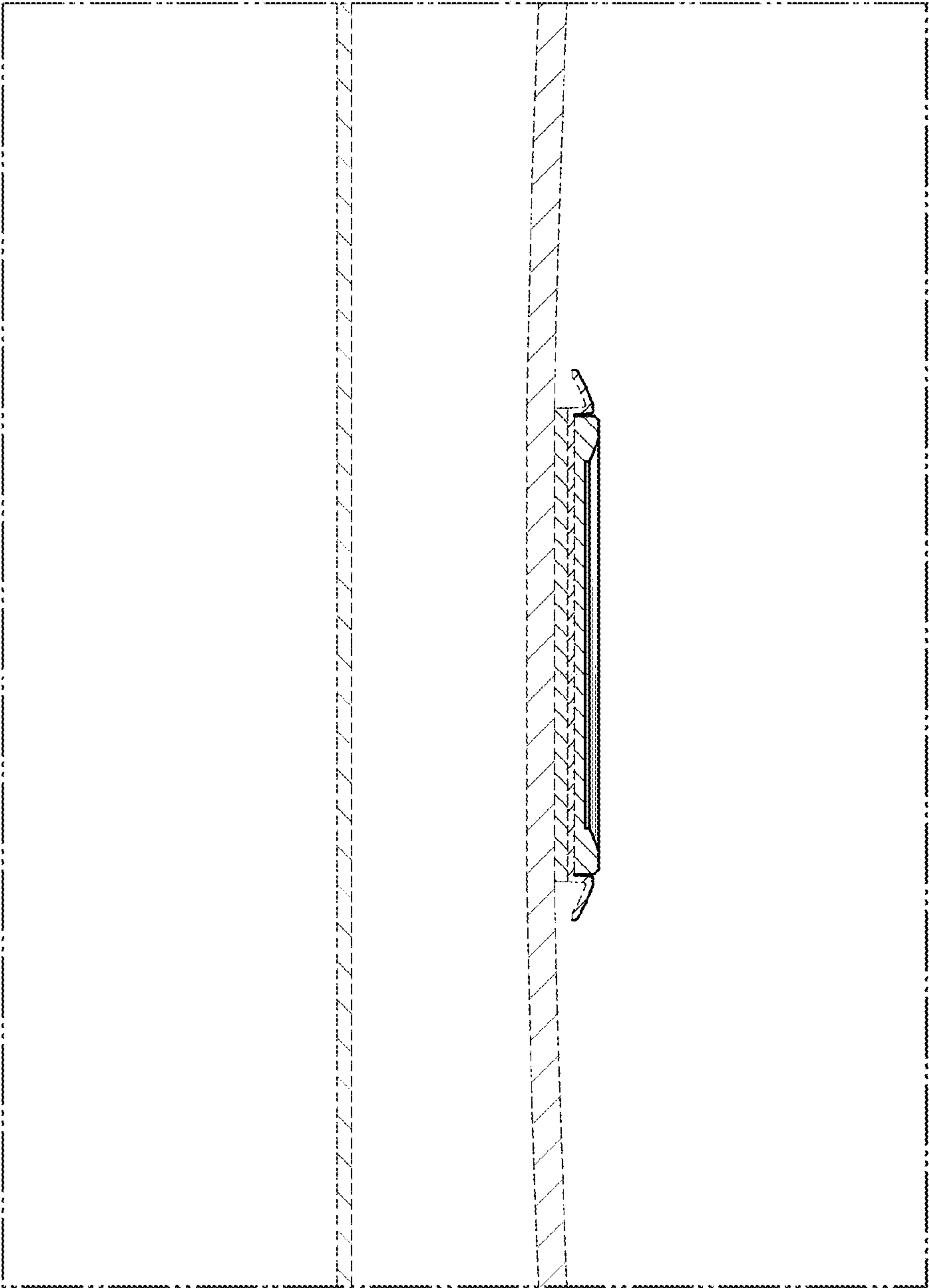

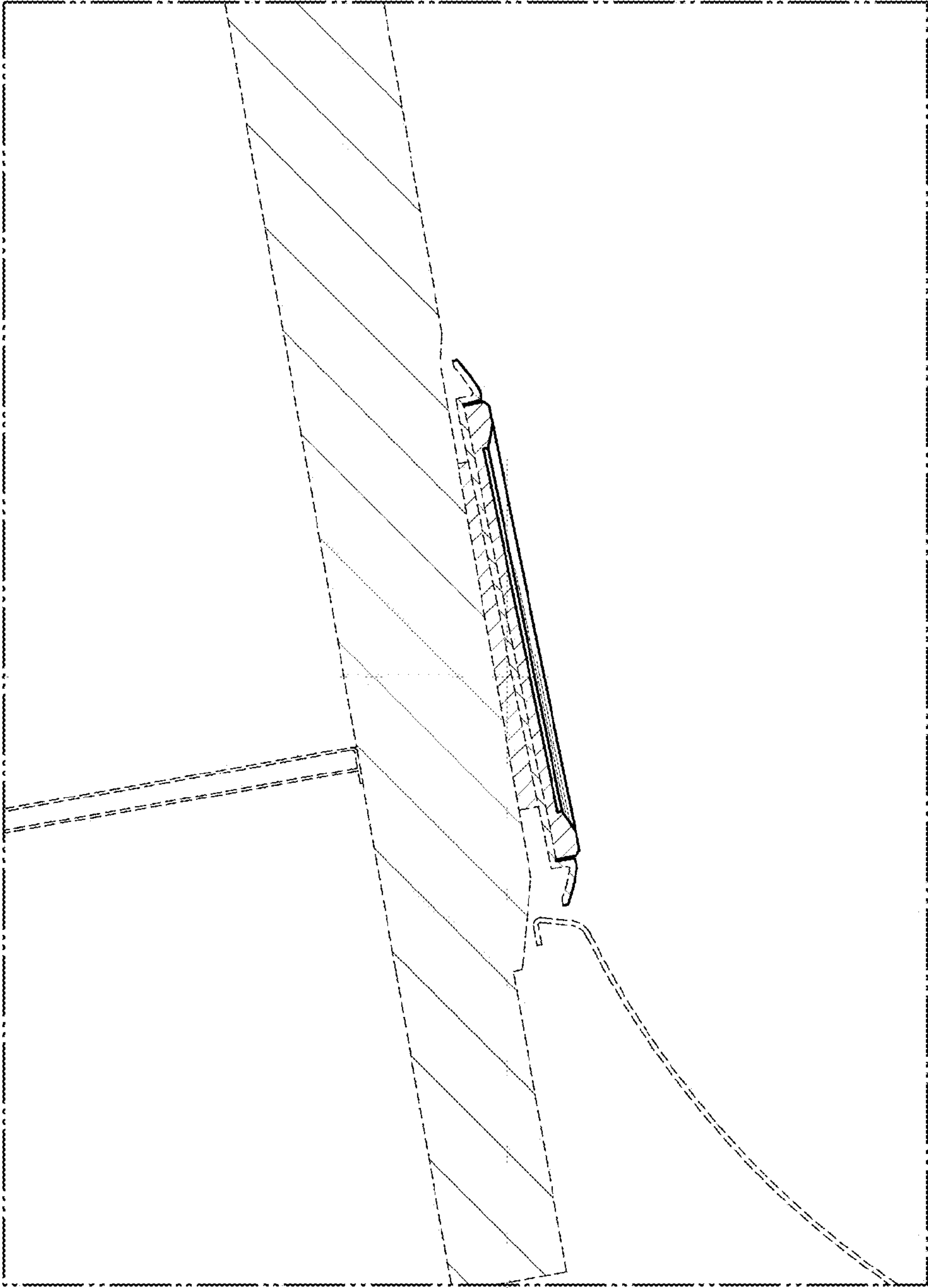

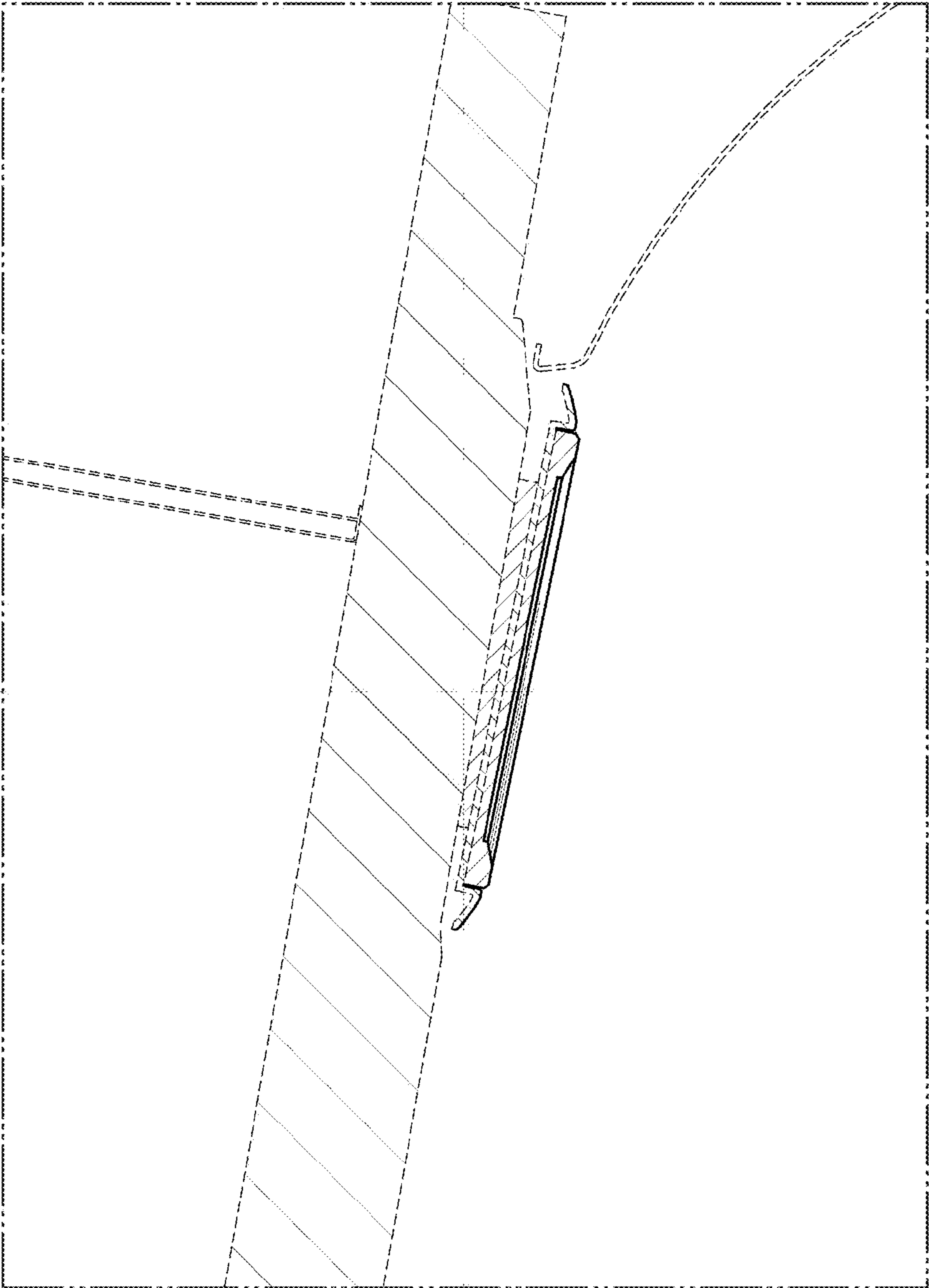

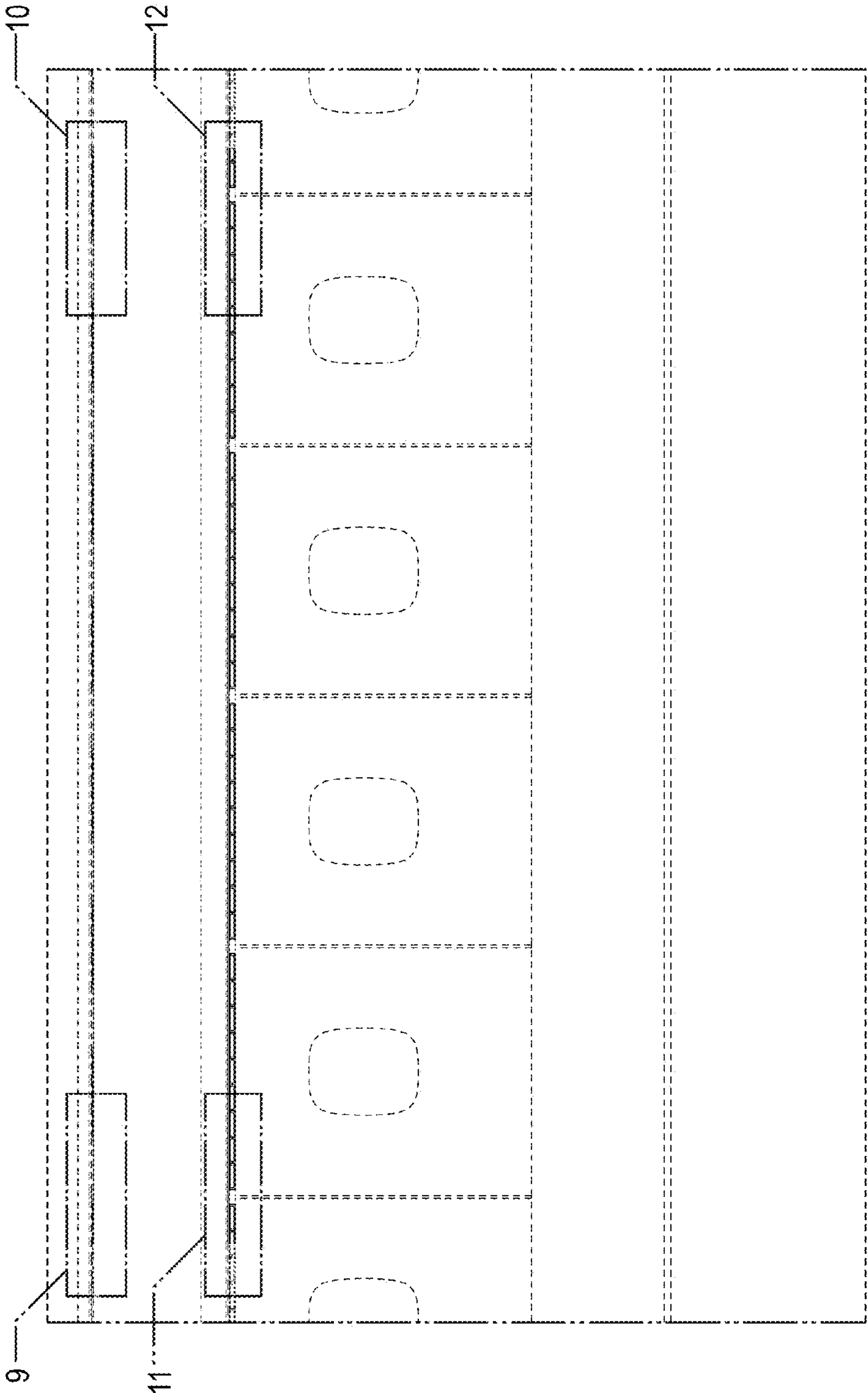

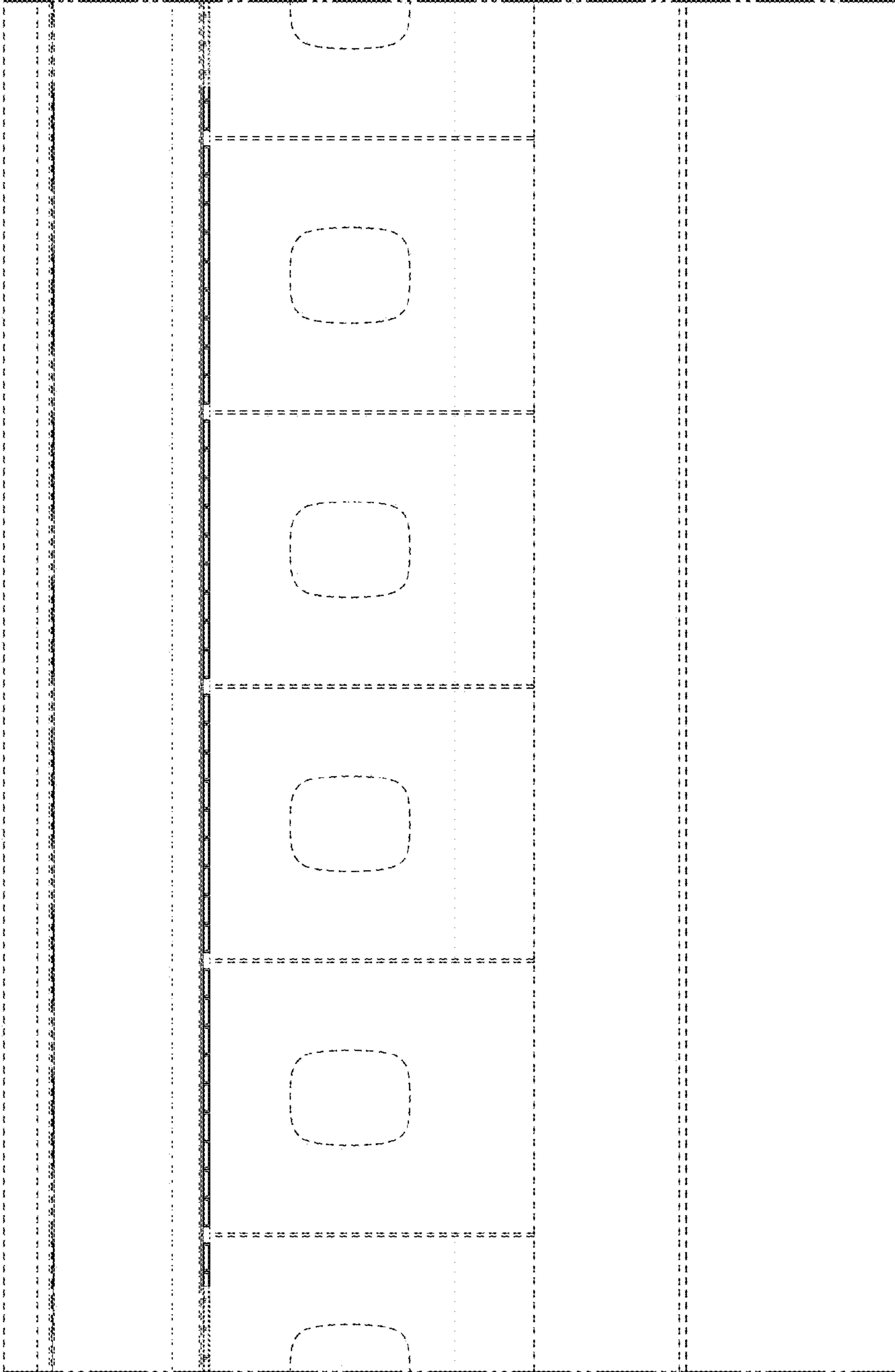

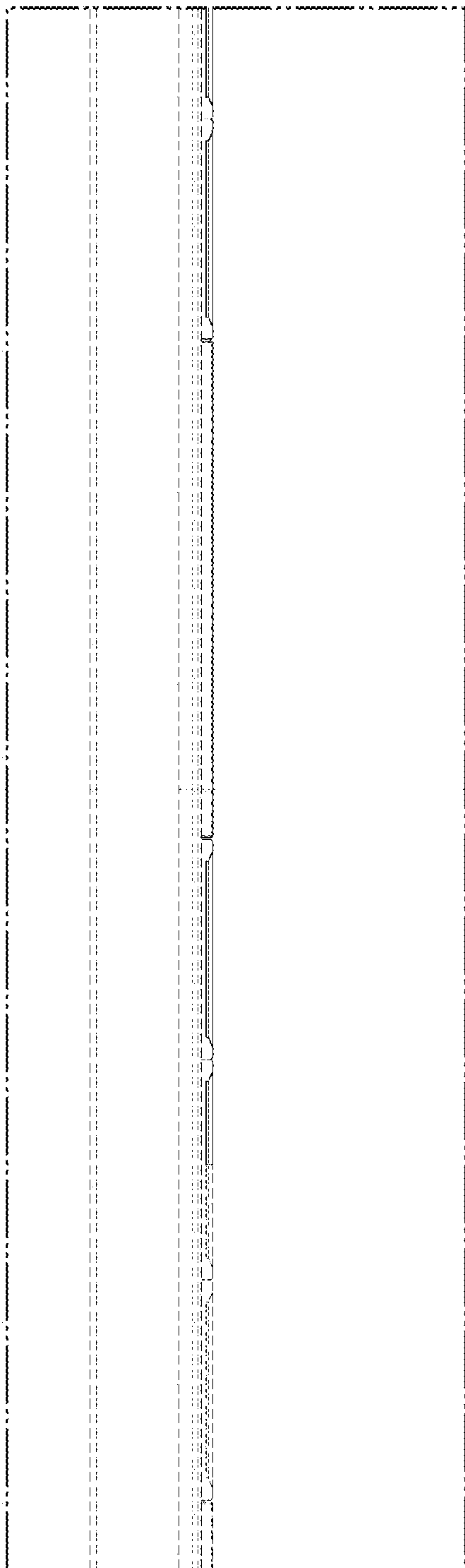

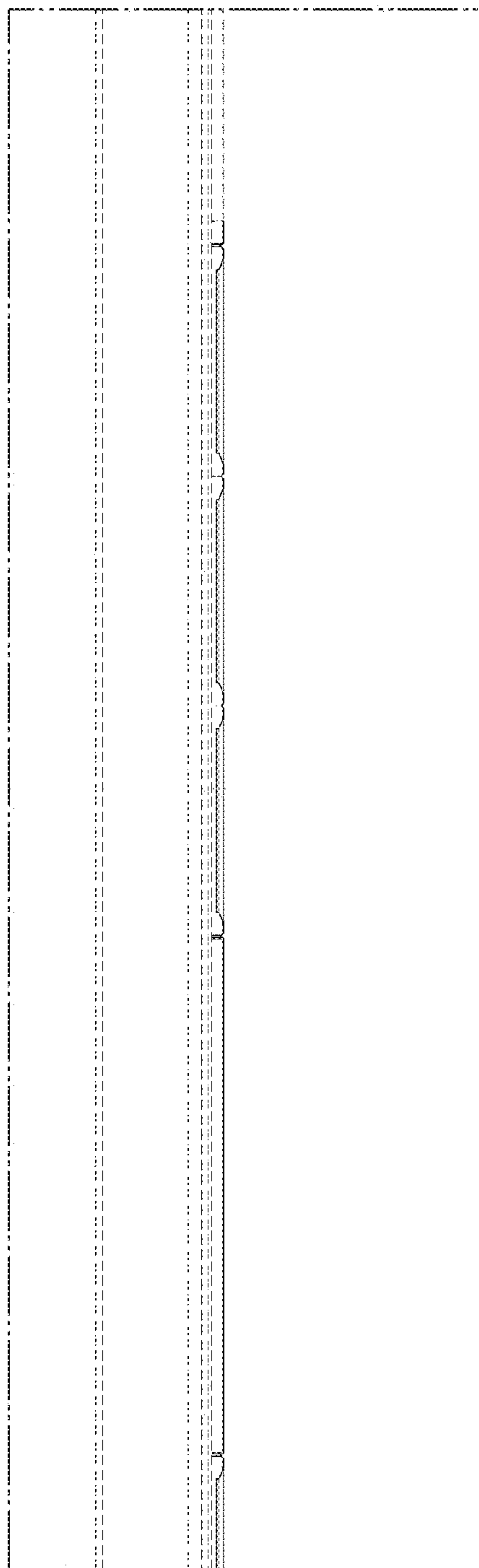

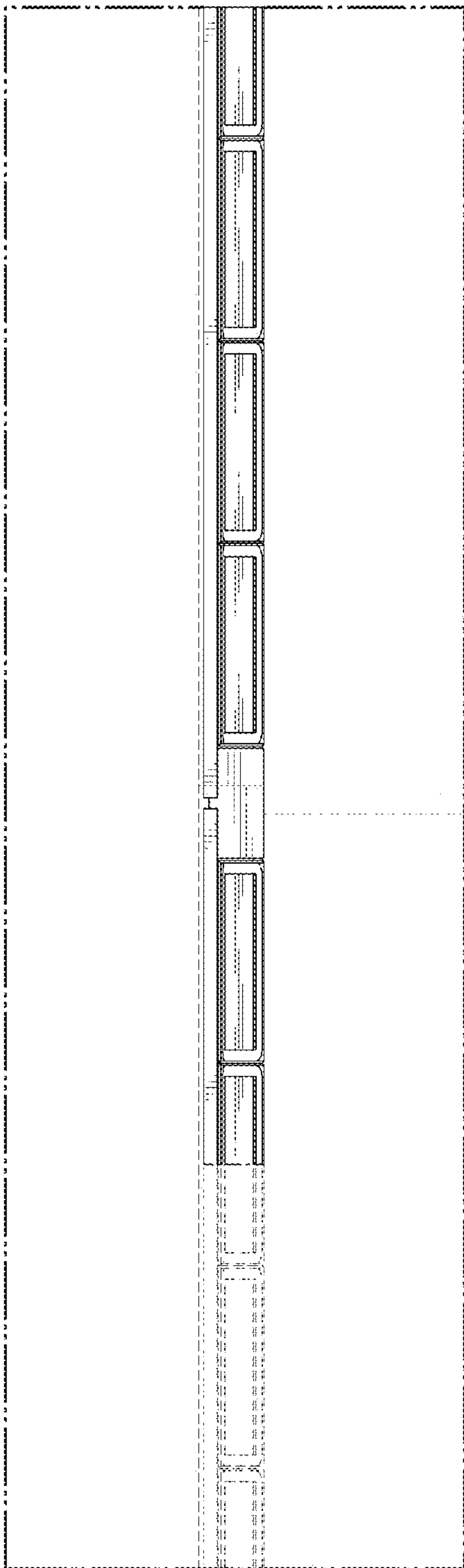

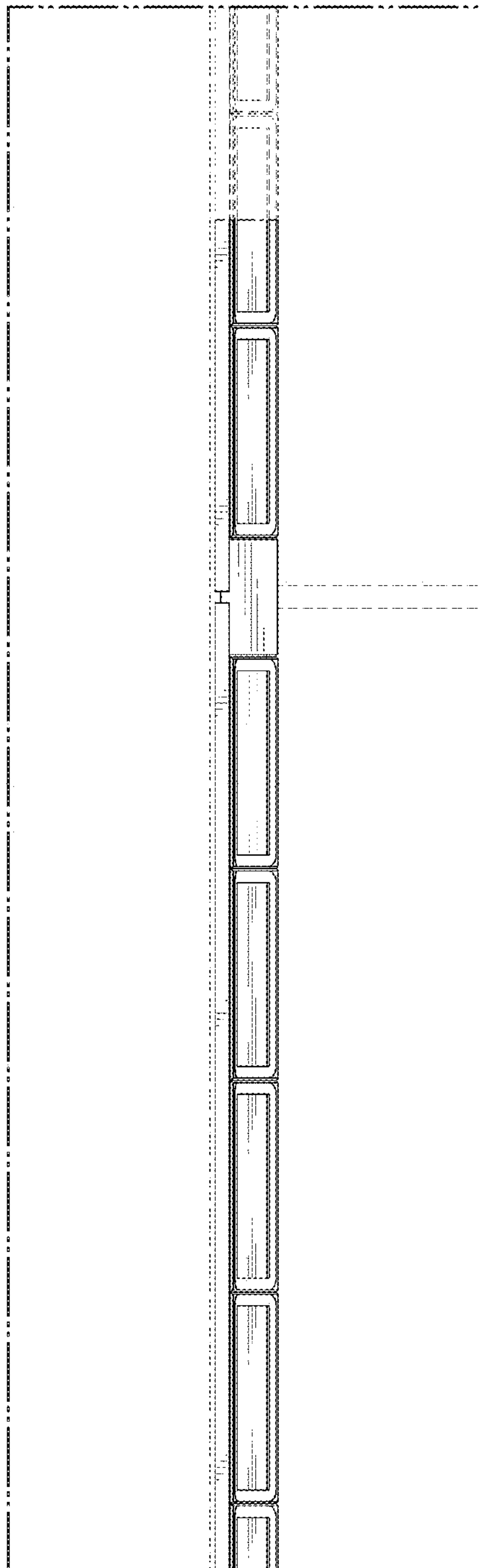

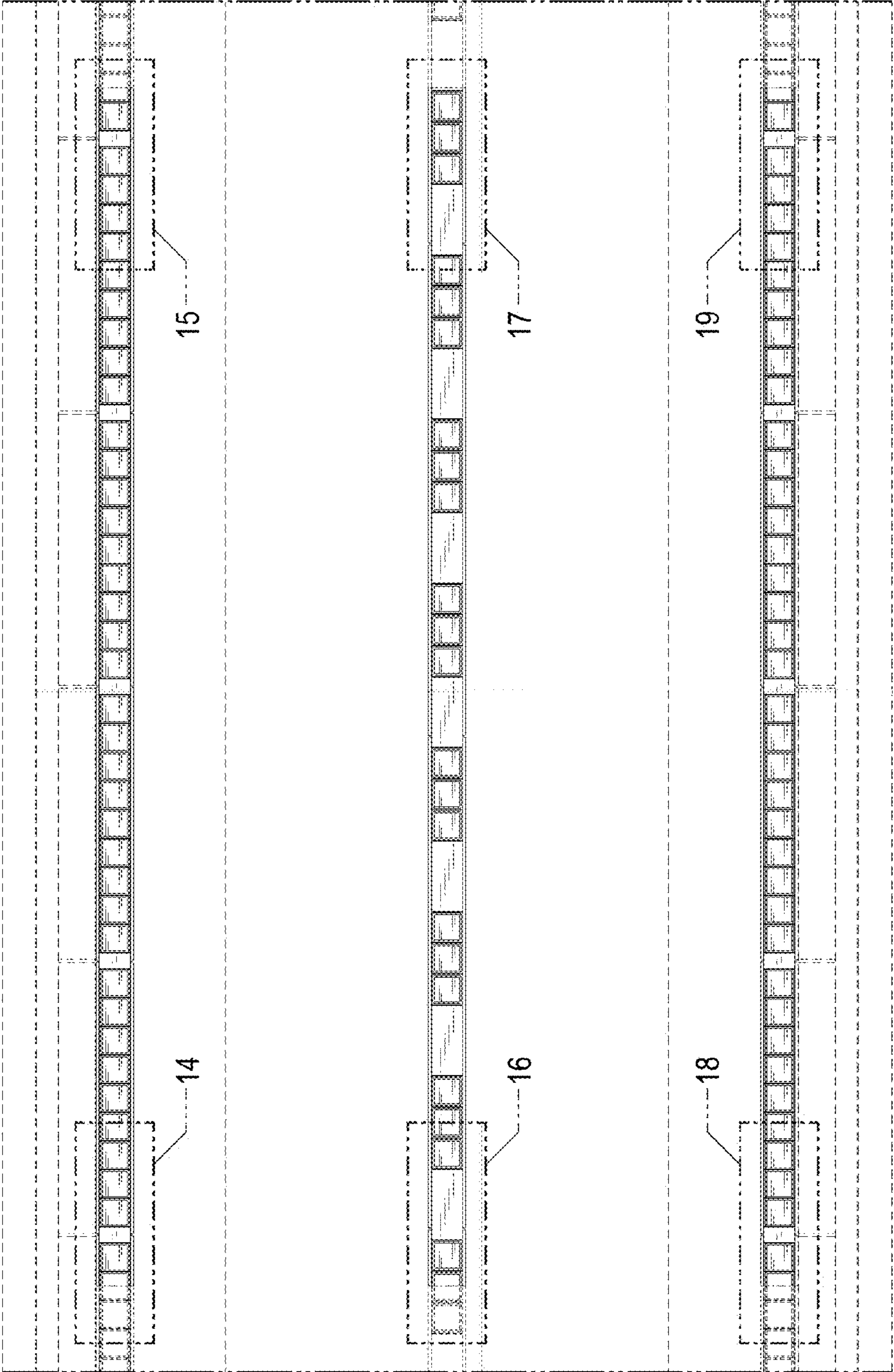

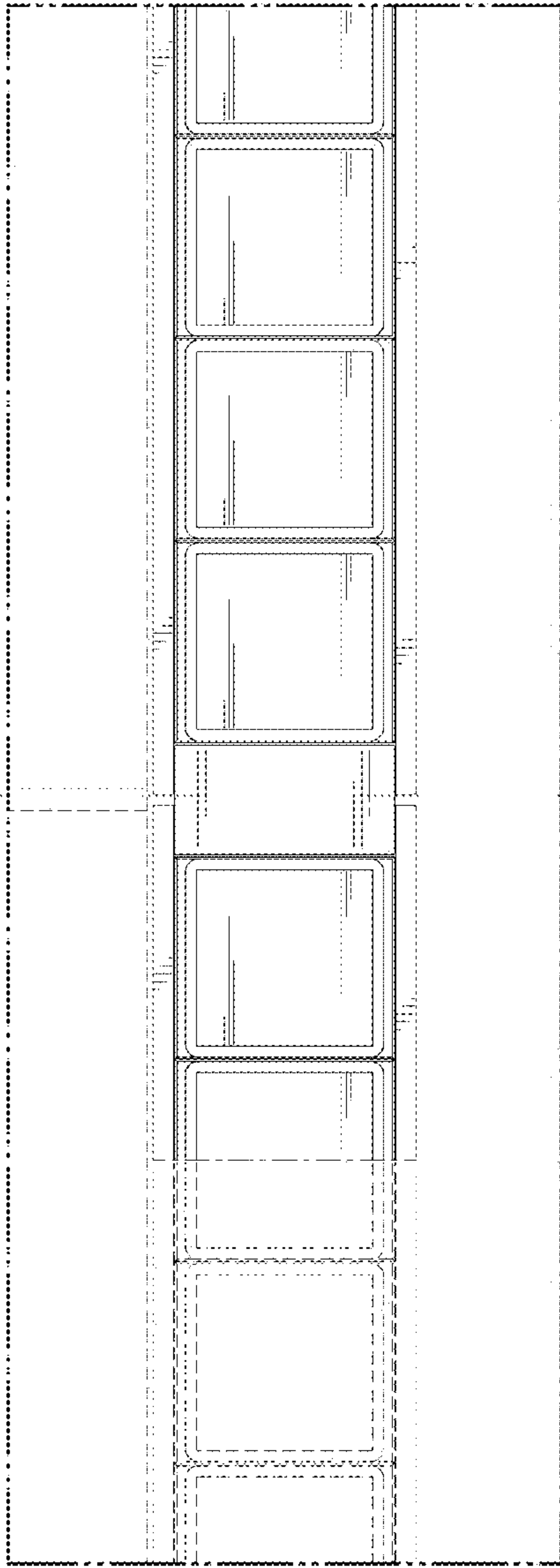

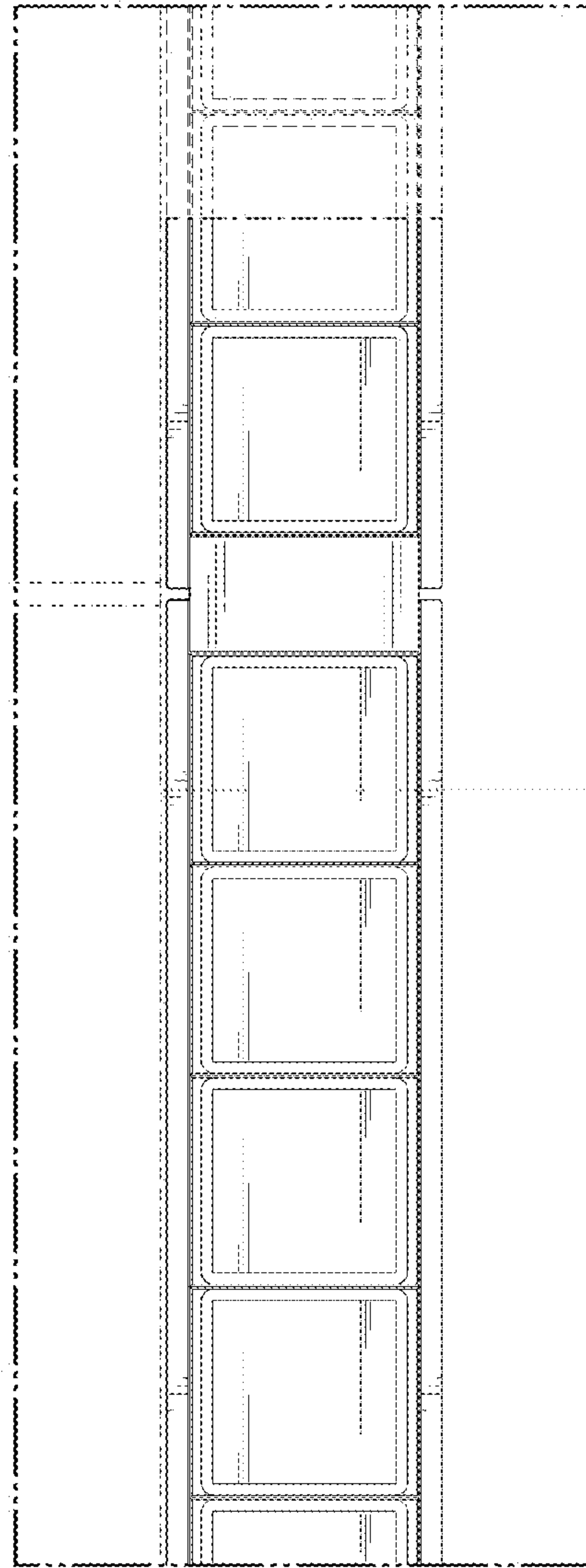

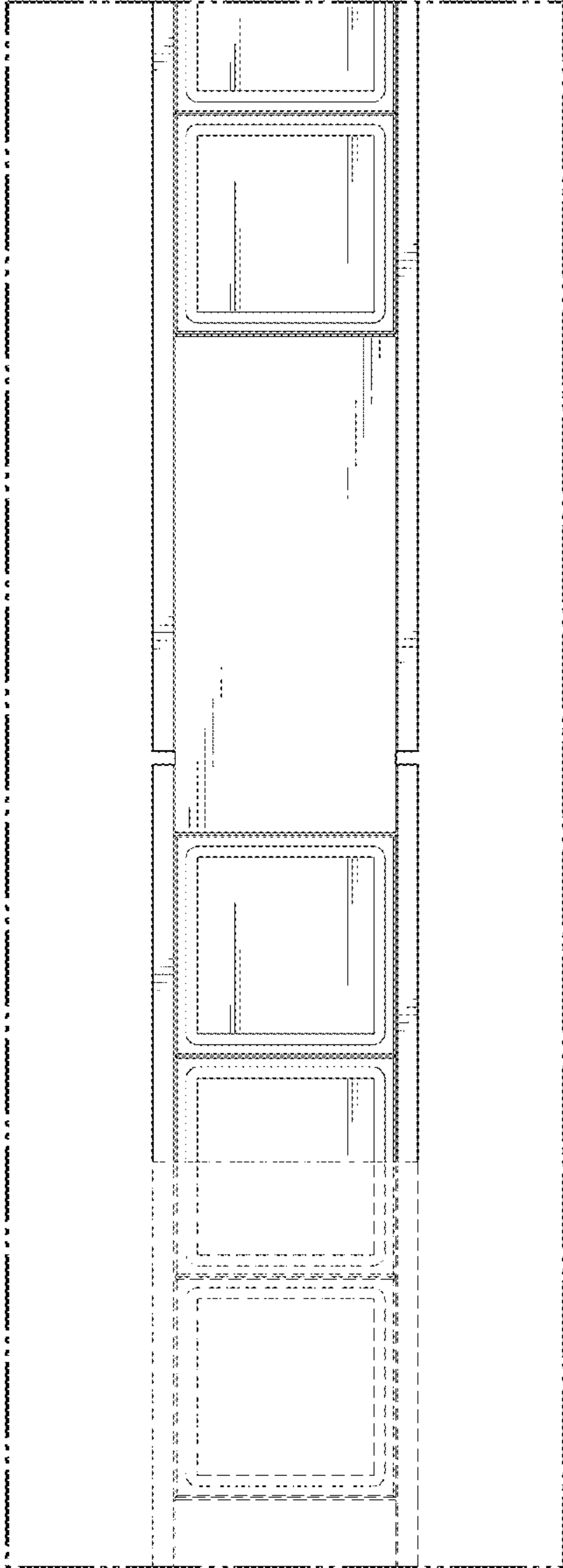

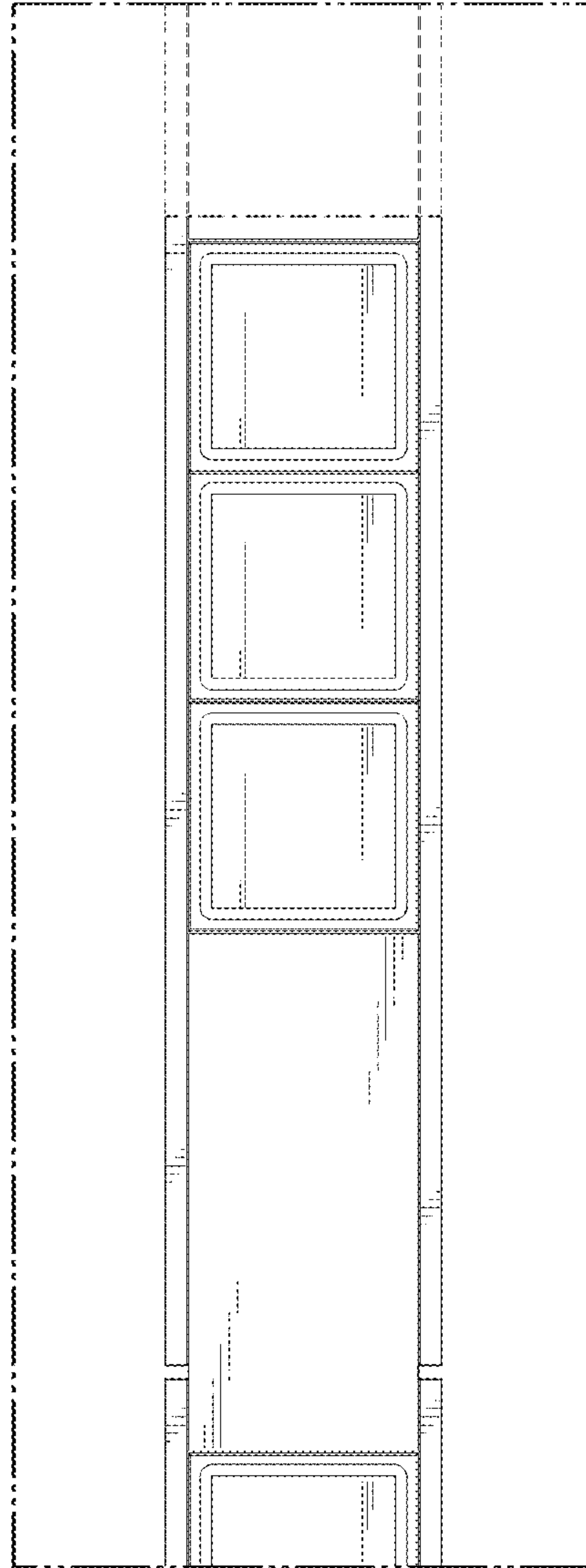

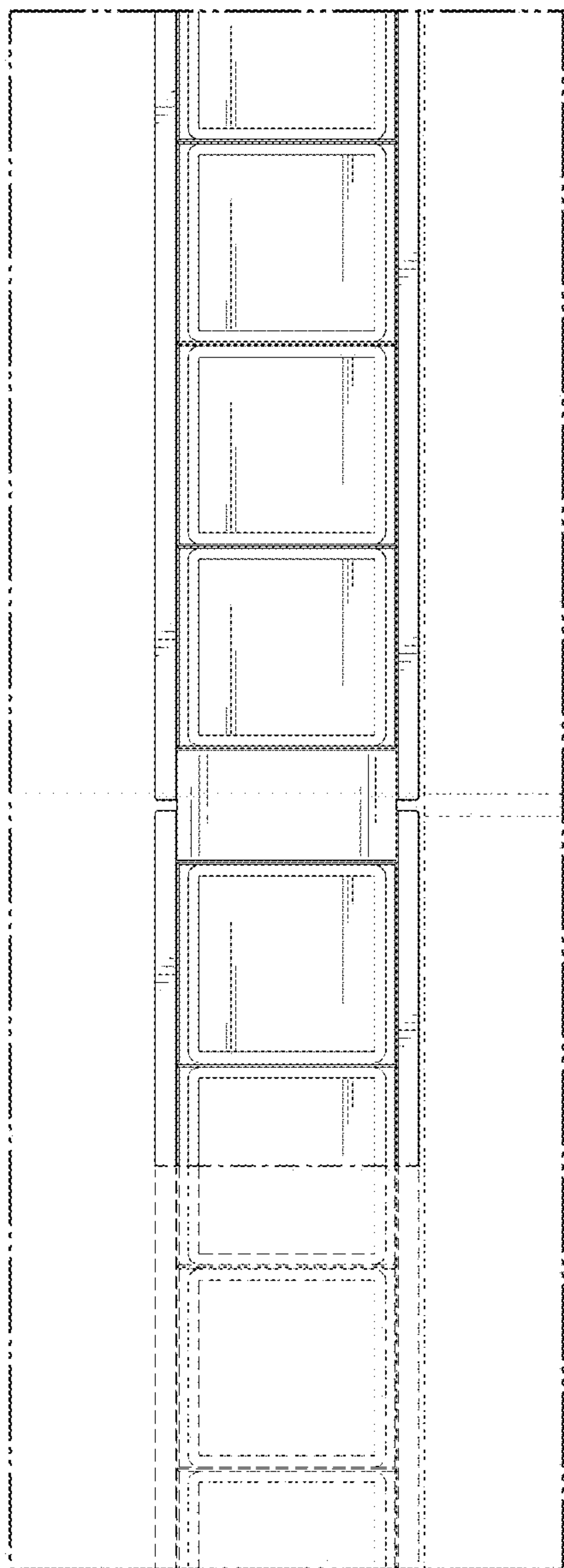

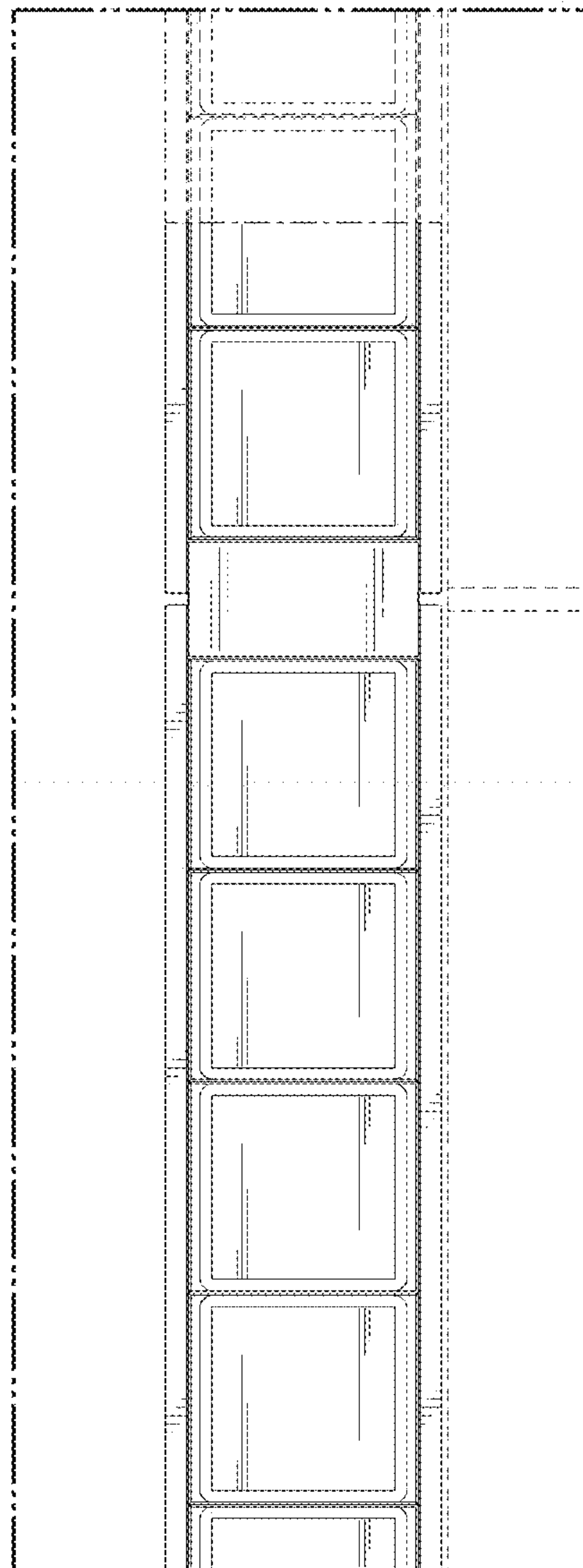
