**DESCRIPTION**

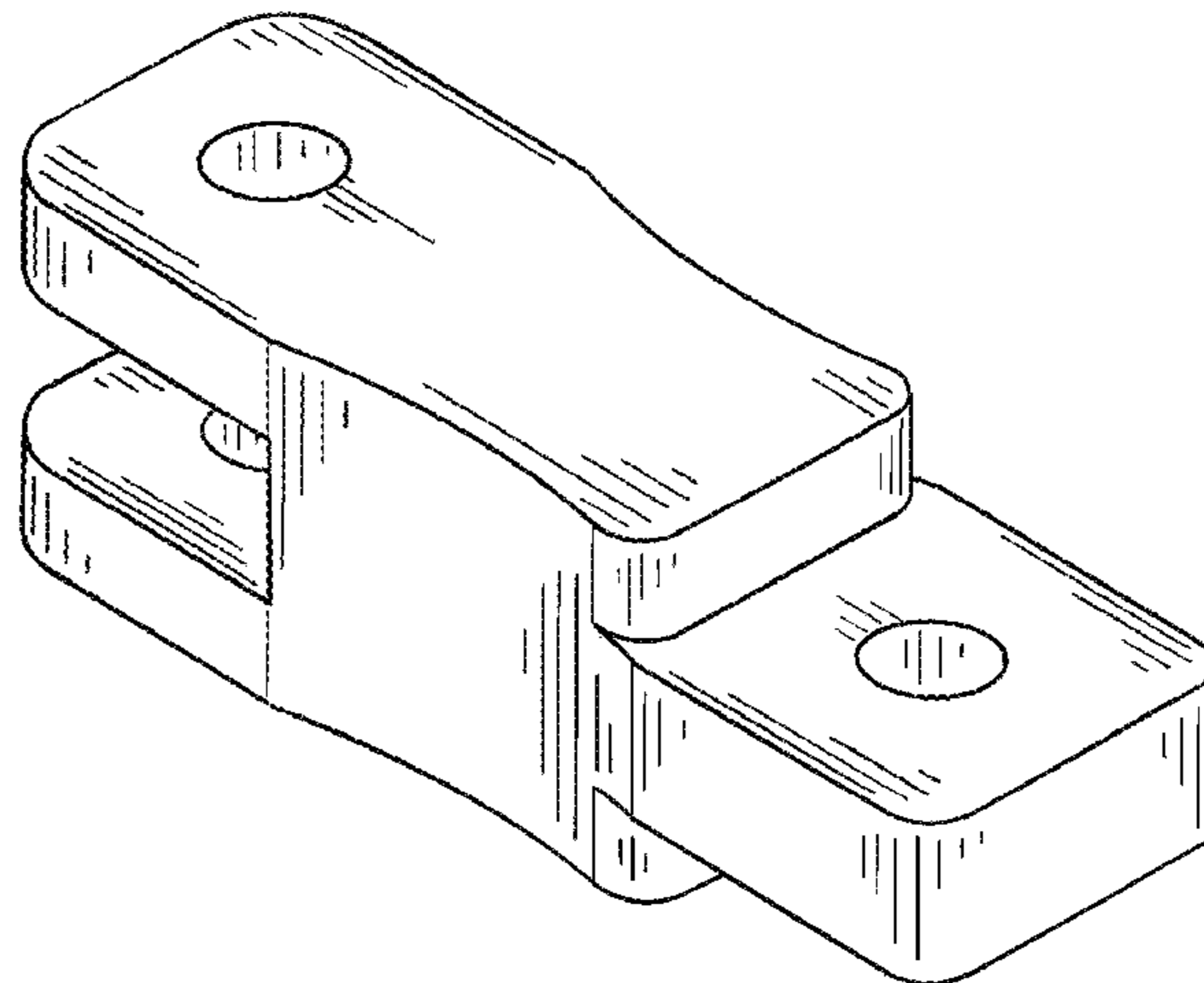
FIG. 1 is a top, front, and left side perspective view of the clutch extender showing our new design;

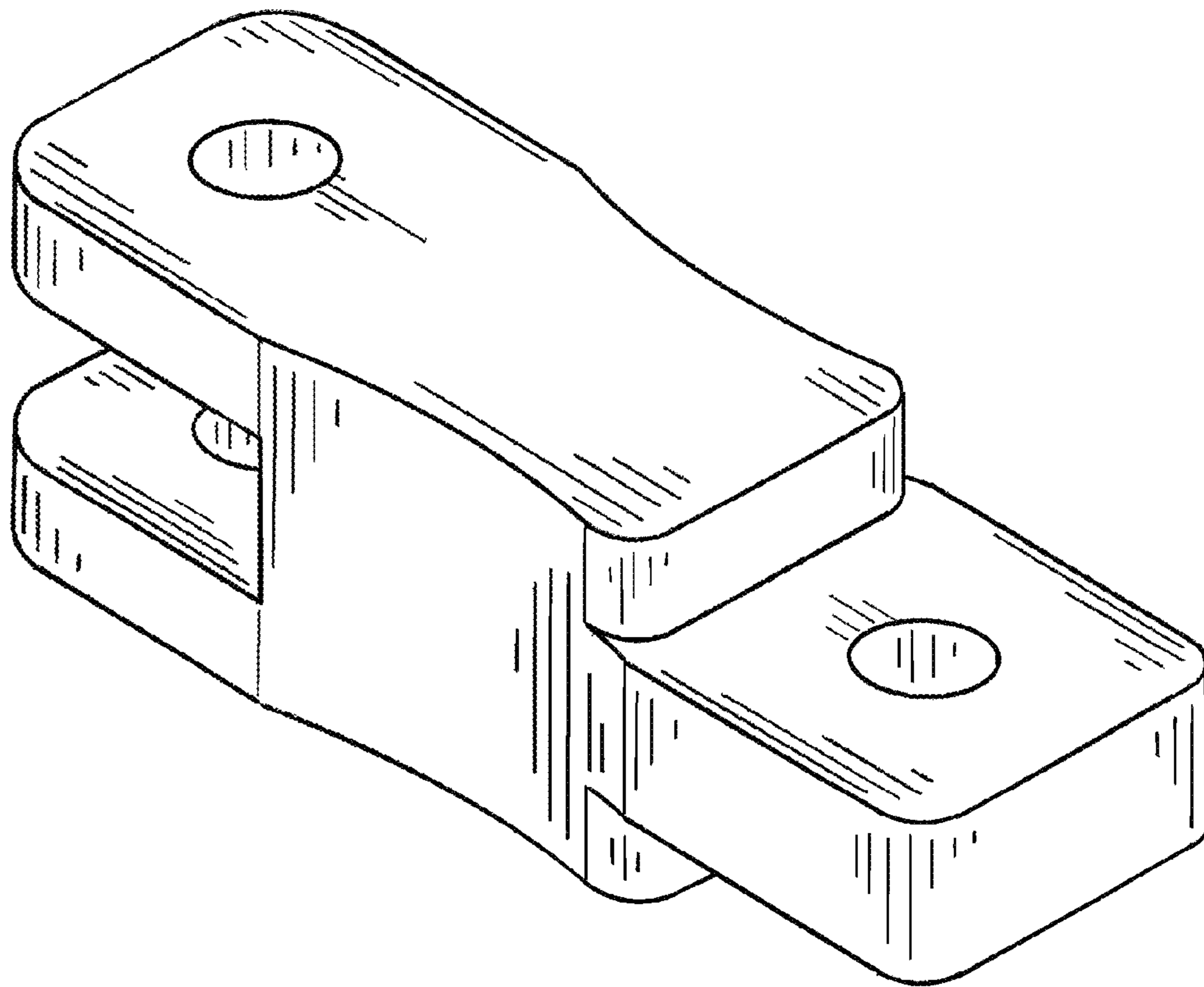

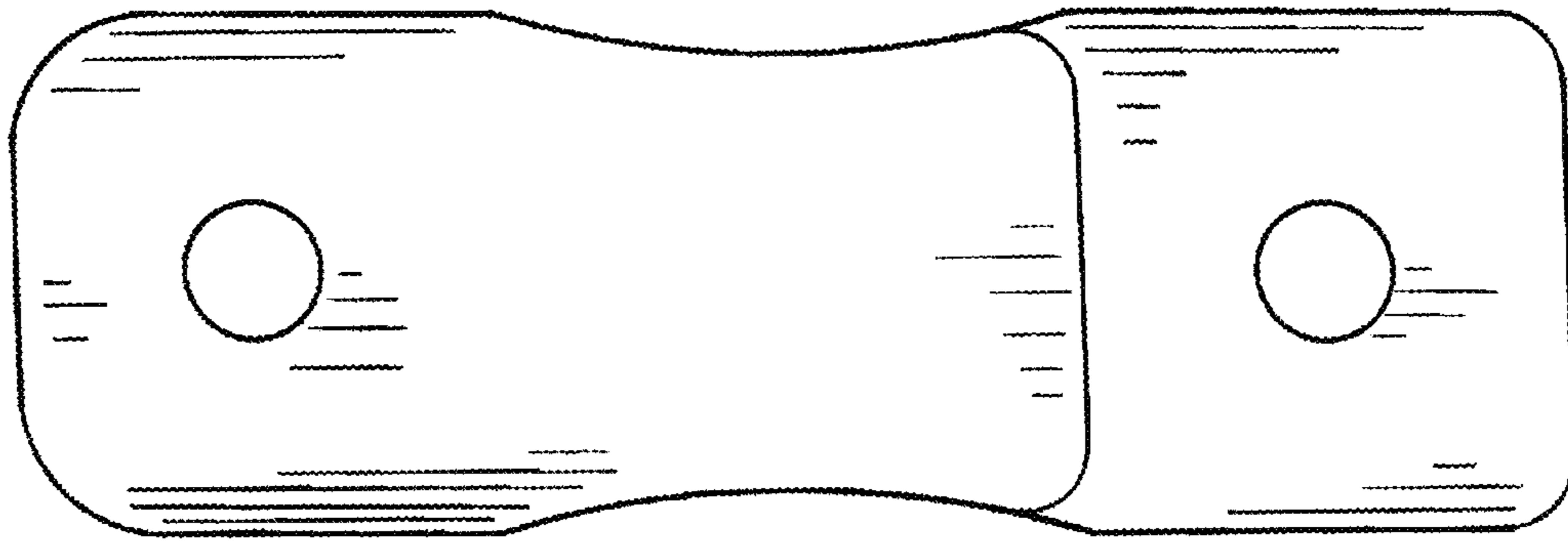

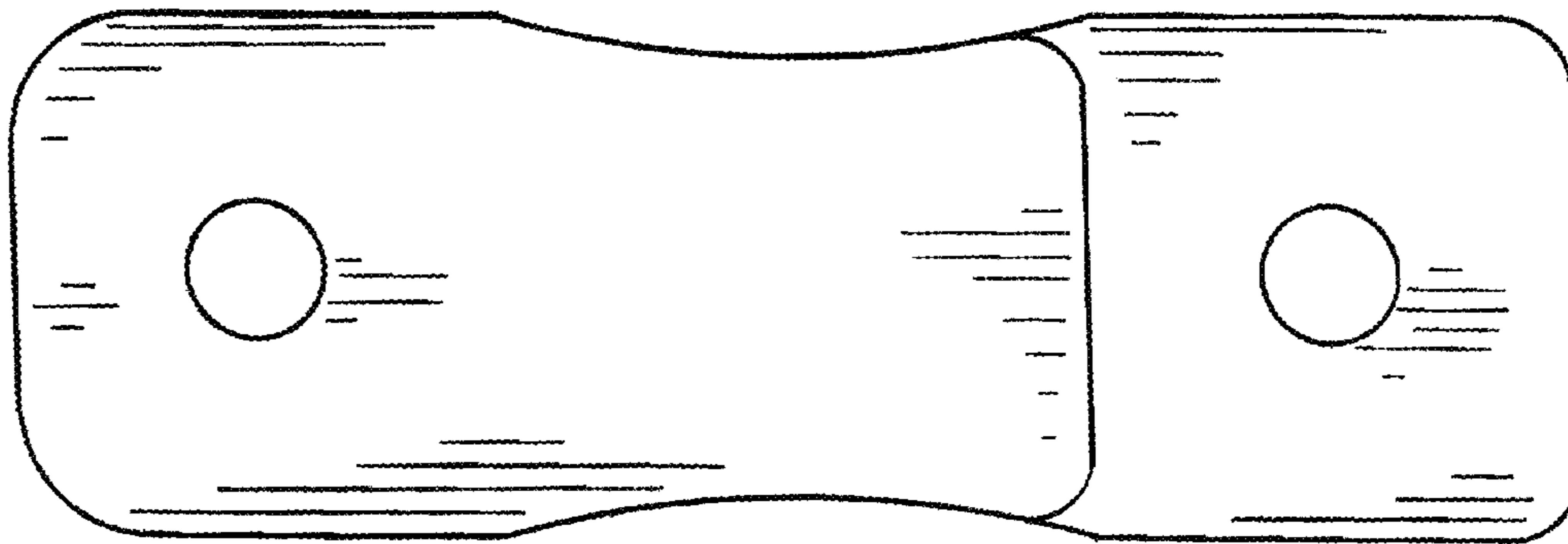

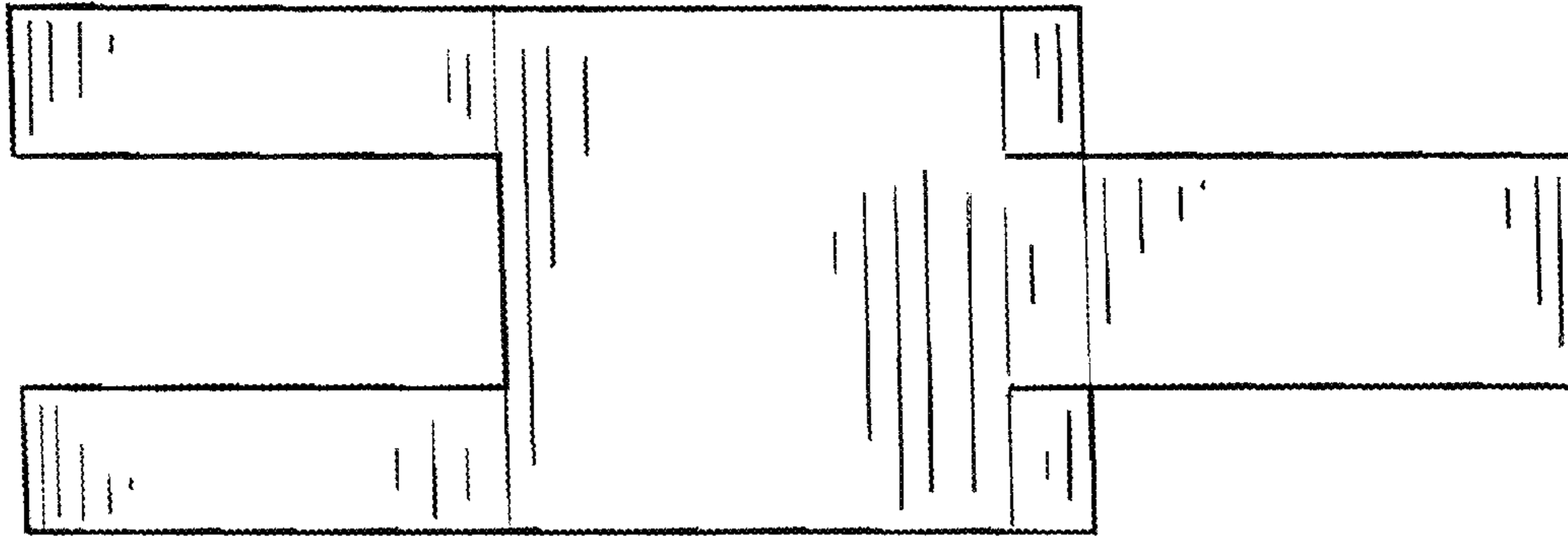

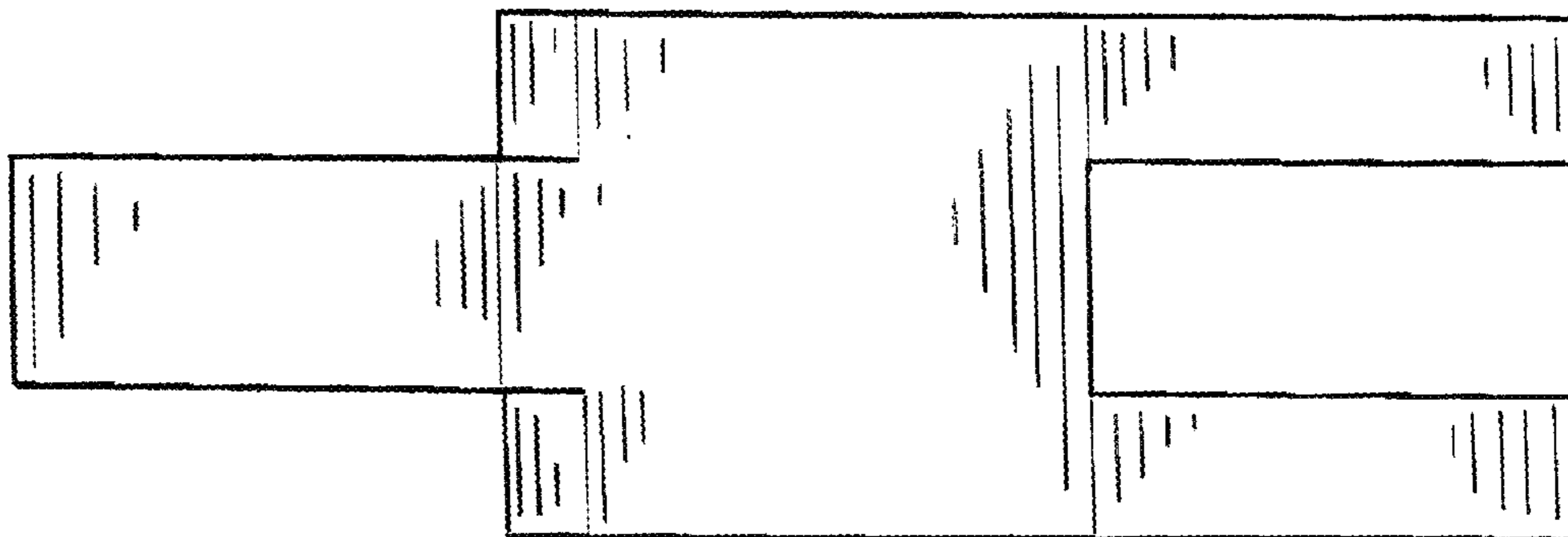

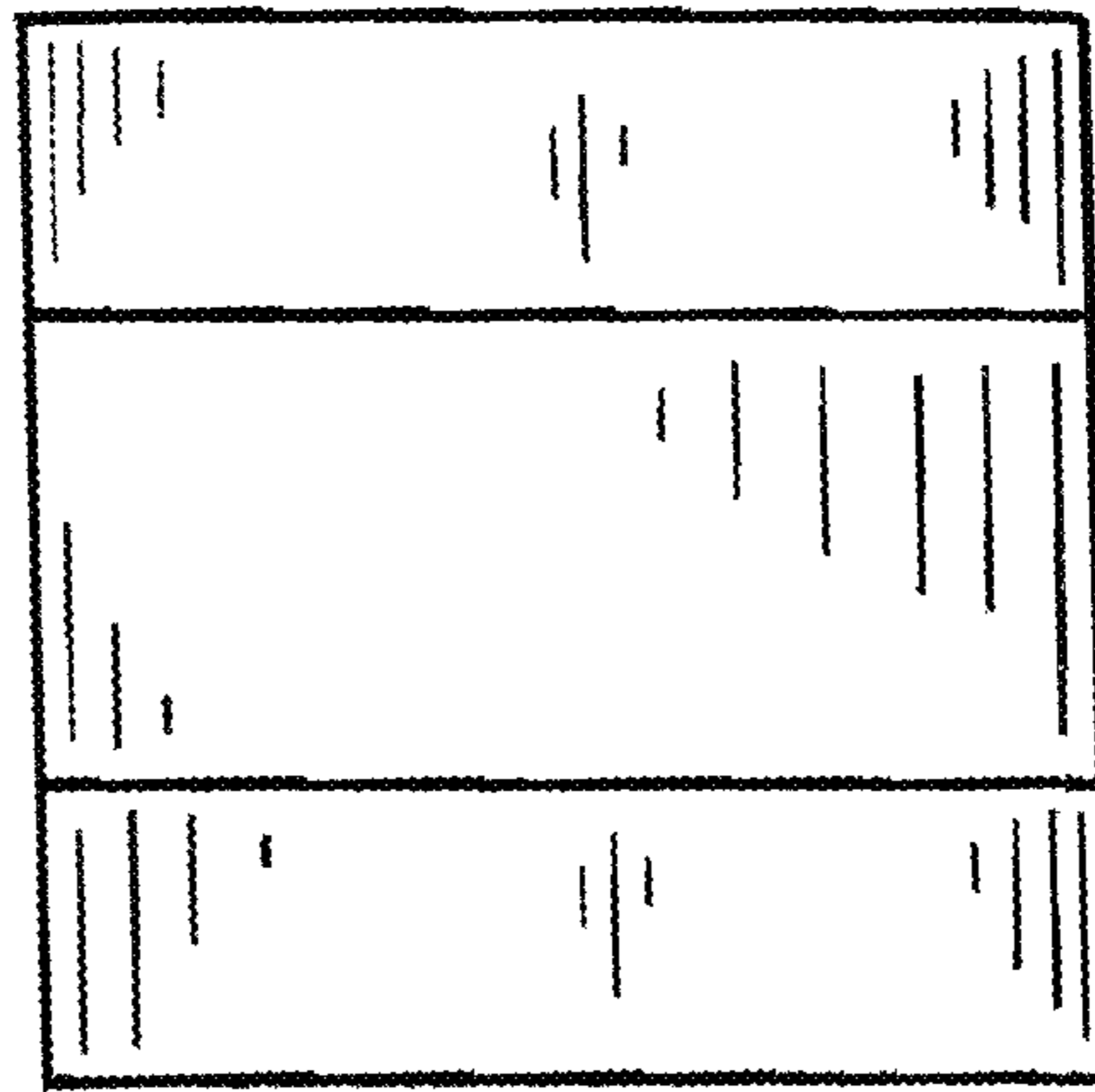

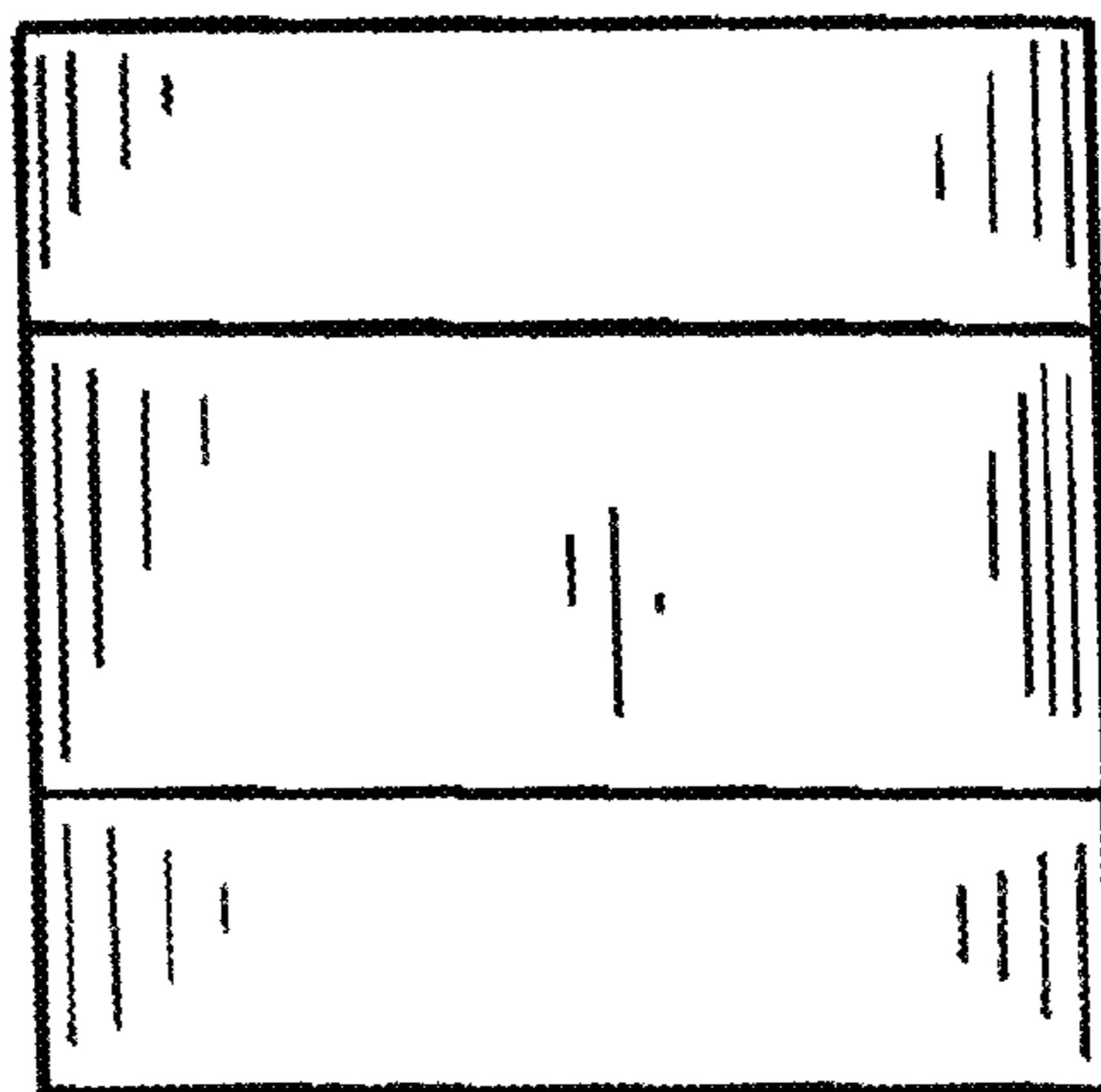
