DESCRIPTION

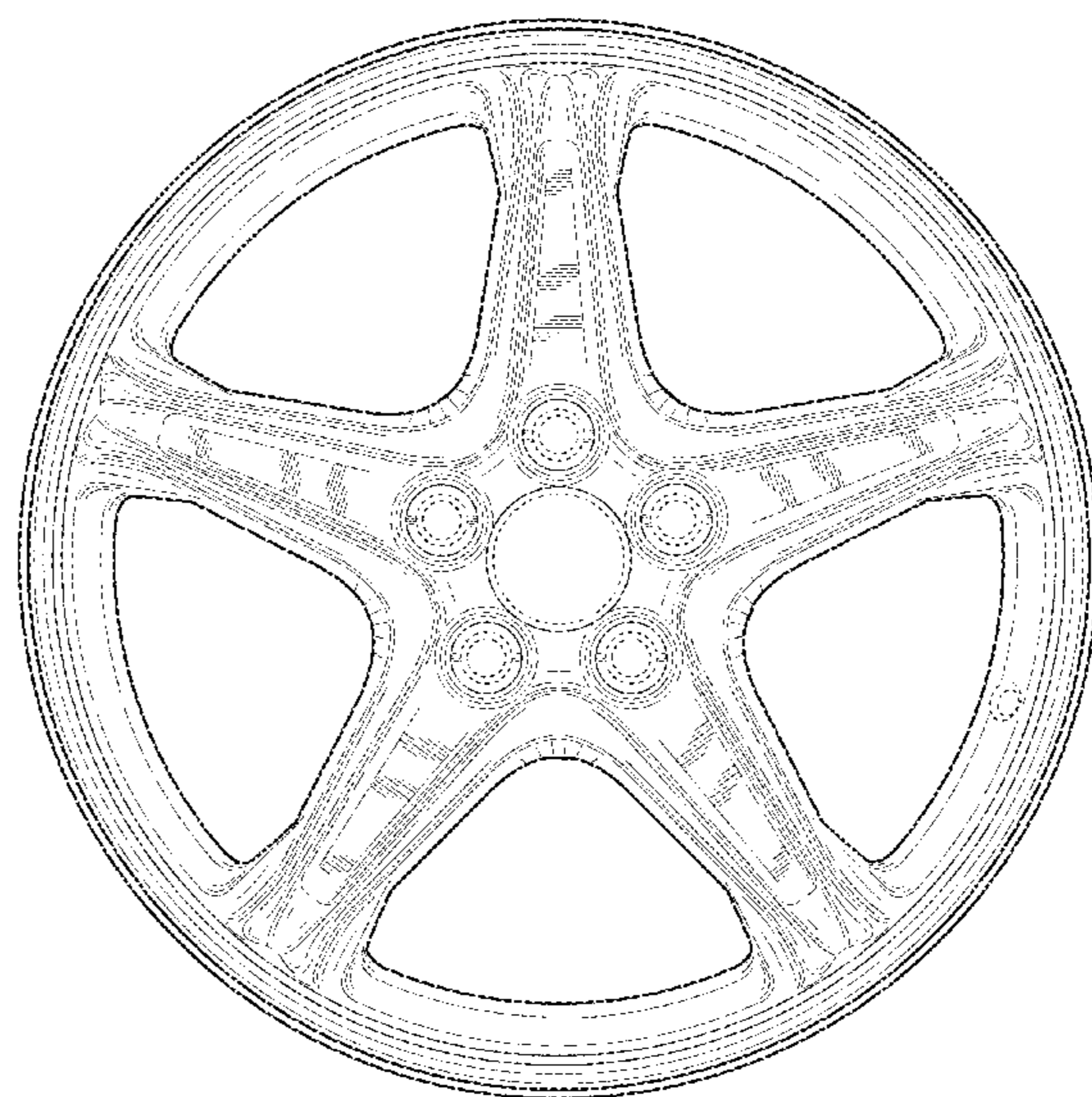
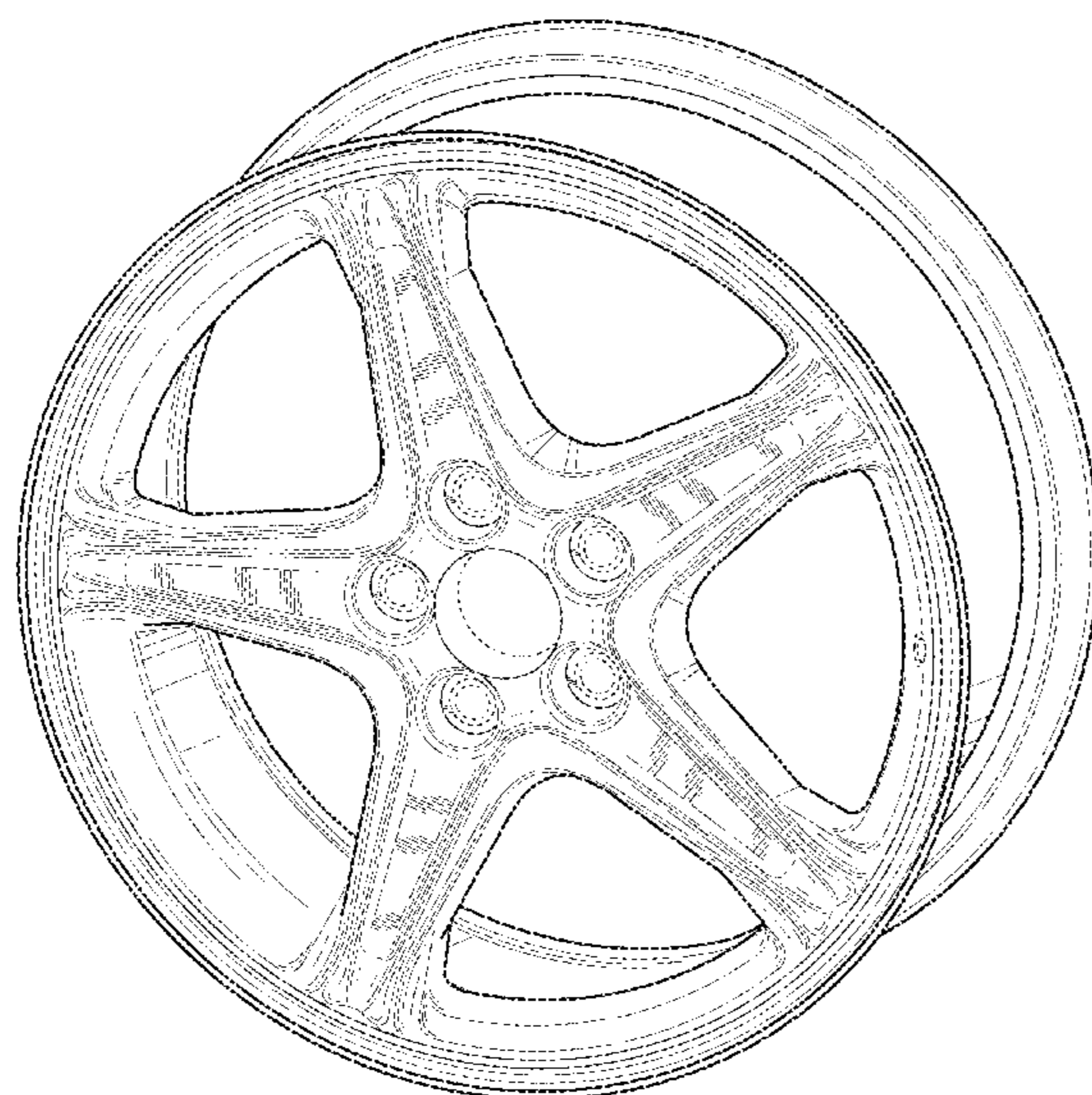
FIG. 1 is a perspective view of a vehicle wheel, showing my new design;

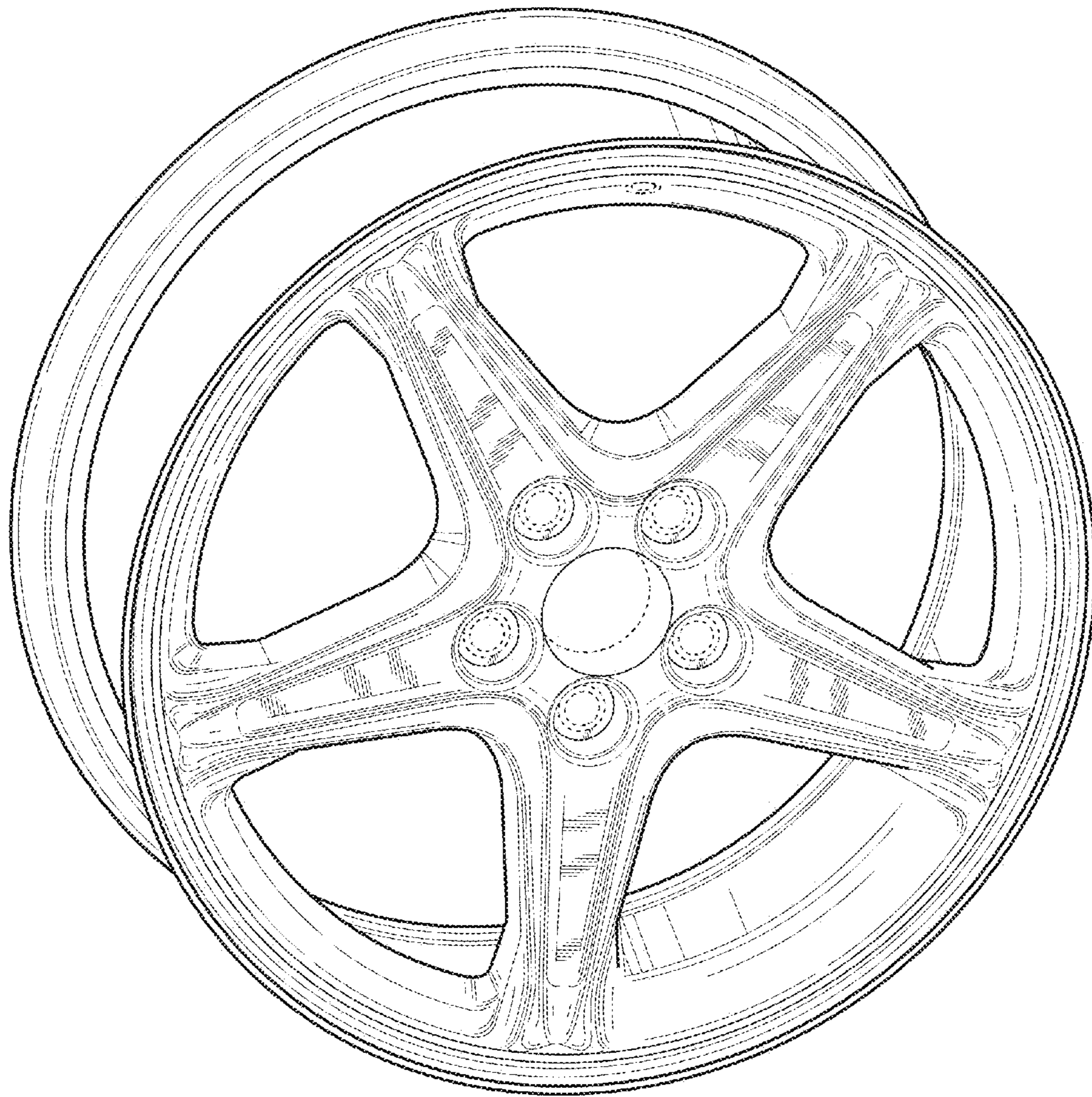

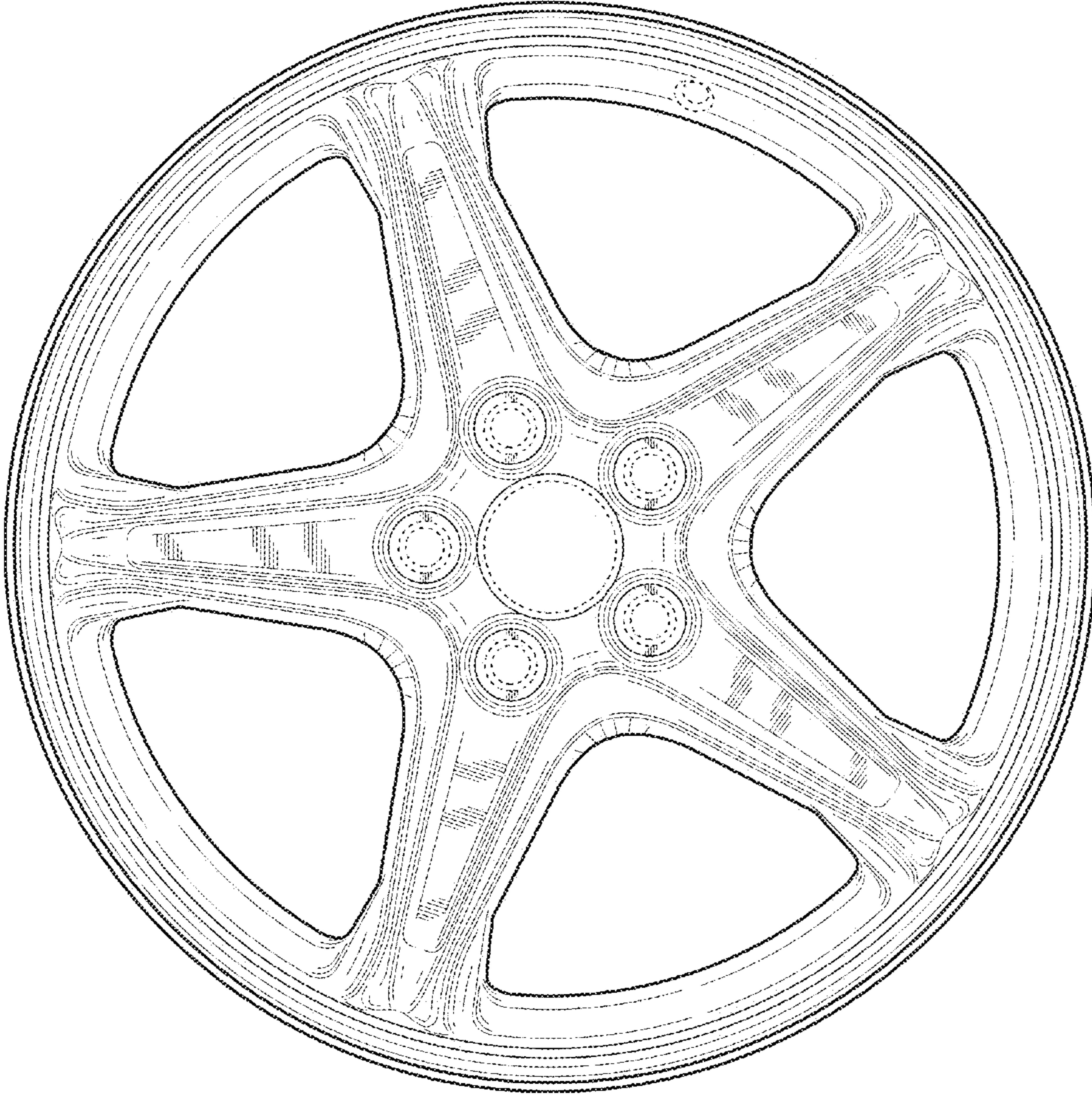

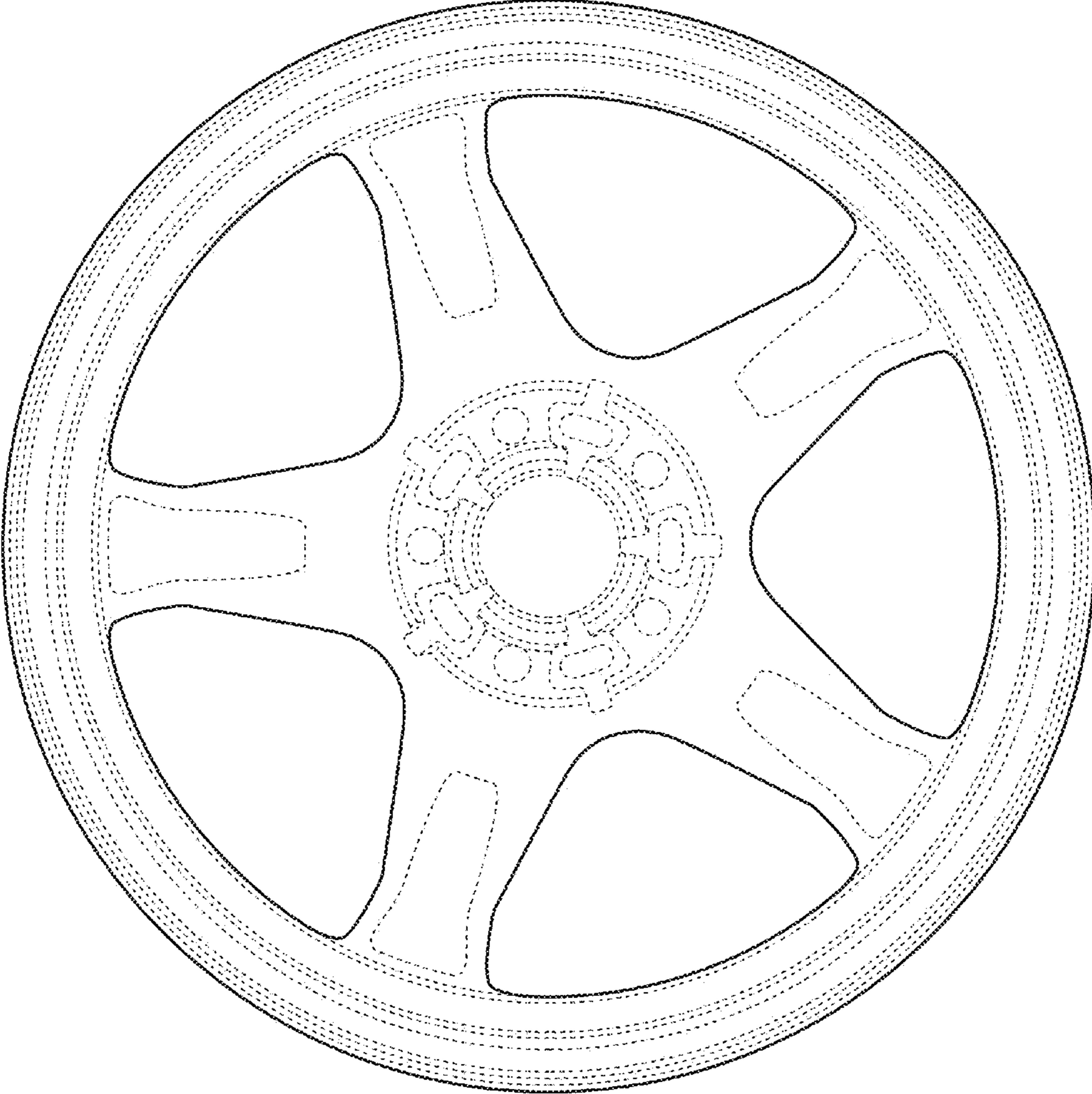
