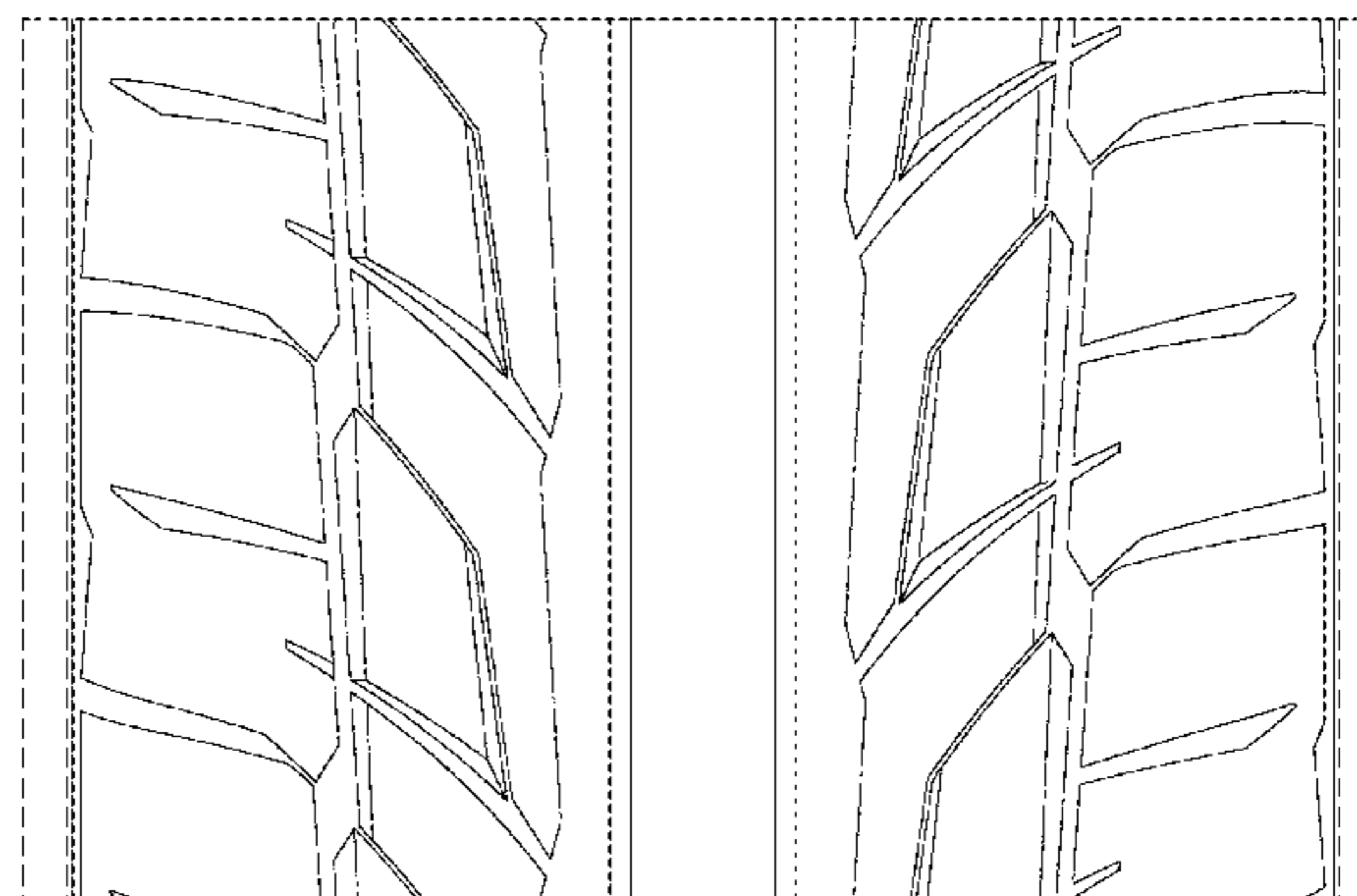
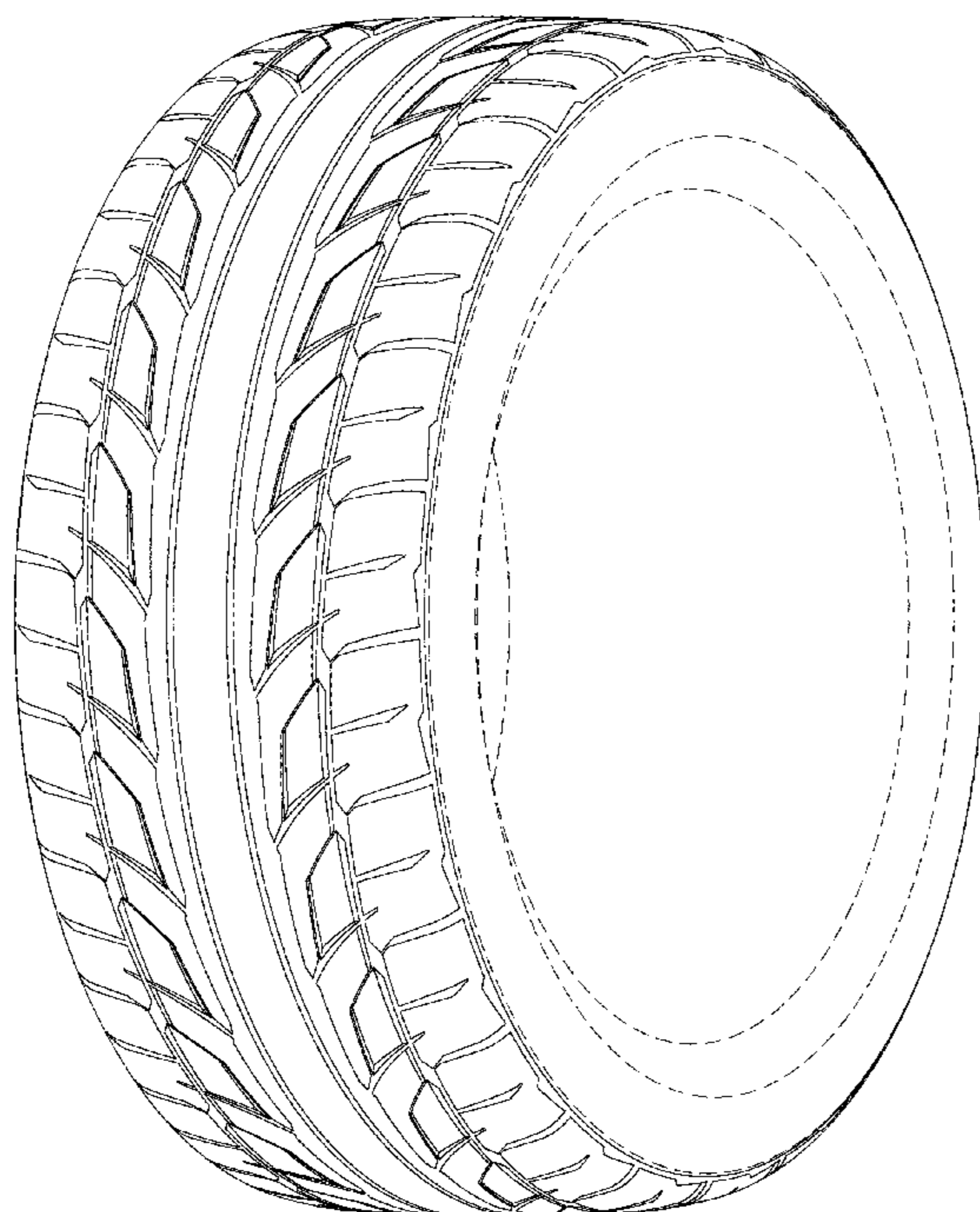
The ornamental design for a tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tire showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a top plan view thereof, the bottom plan view being  
the same;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a left side view thereof;  
FIG. 7 is an enlarged view taken along lines 7-7 and 7'-7' in  
FIG. 2; and,  
FIG. 8 is an enlarged cross-sectional view taken along line 8-8  
in FIG. 2 and line 8'-8' in FIG. 5.

In the drawings, the broken lines defining the sidewall, inner  
bead and the peripheral boundary between the claimed tire  
tread and the unclaimed sidewall depict environmental sub-  
ject matter that forms no part of the claimed design.

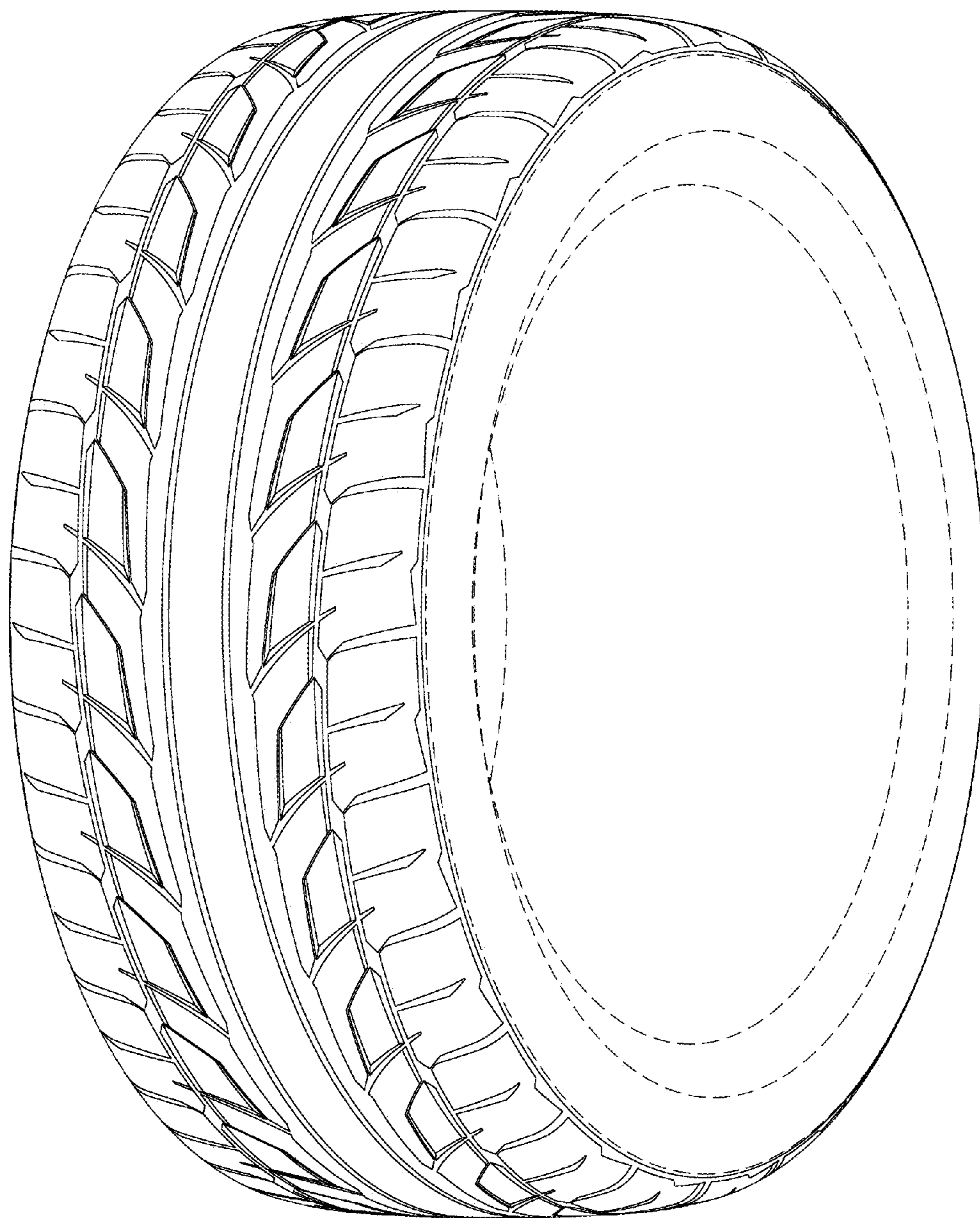

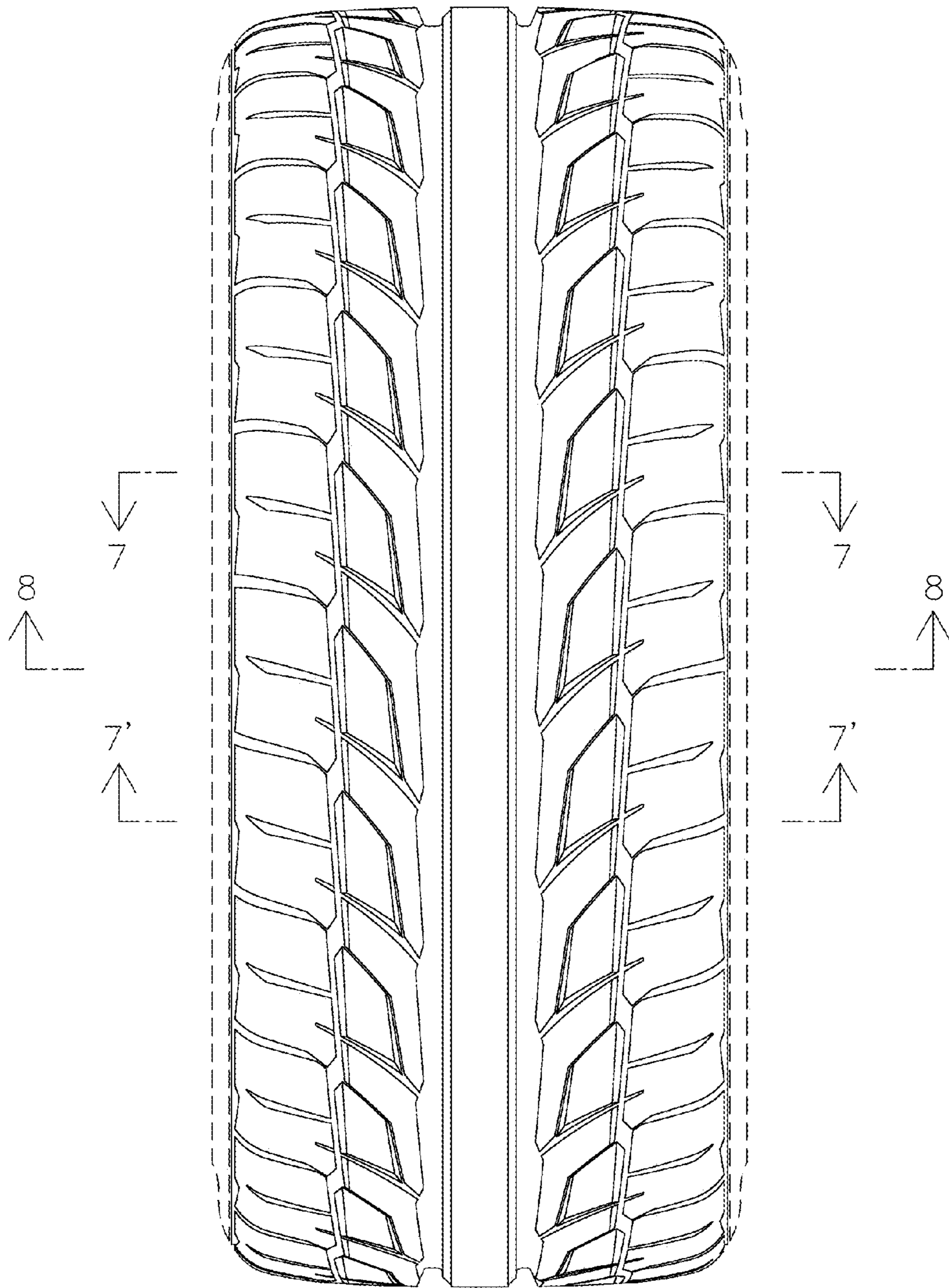

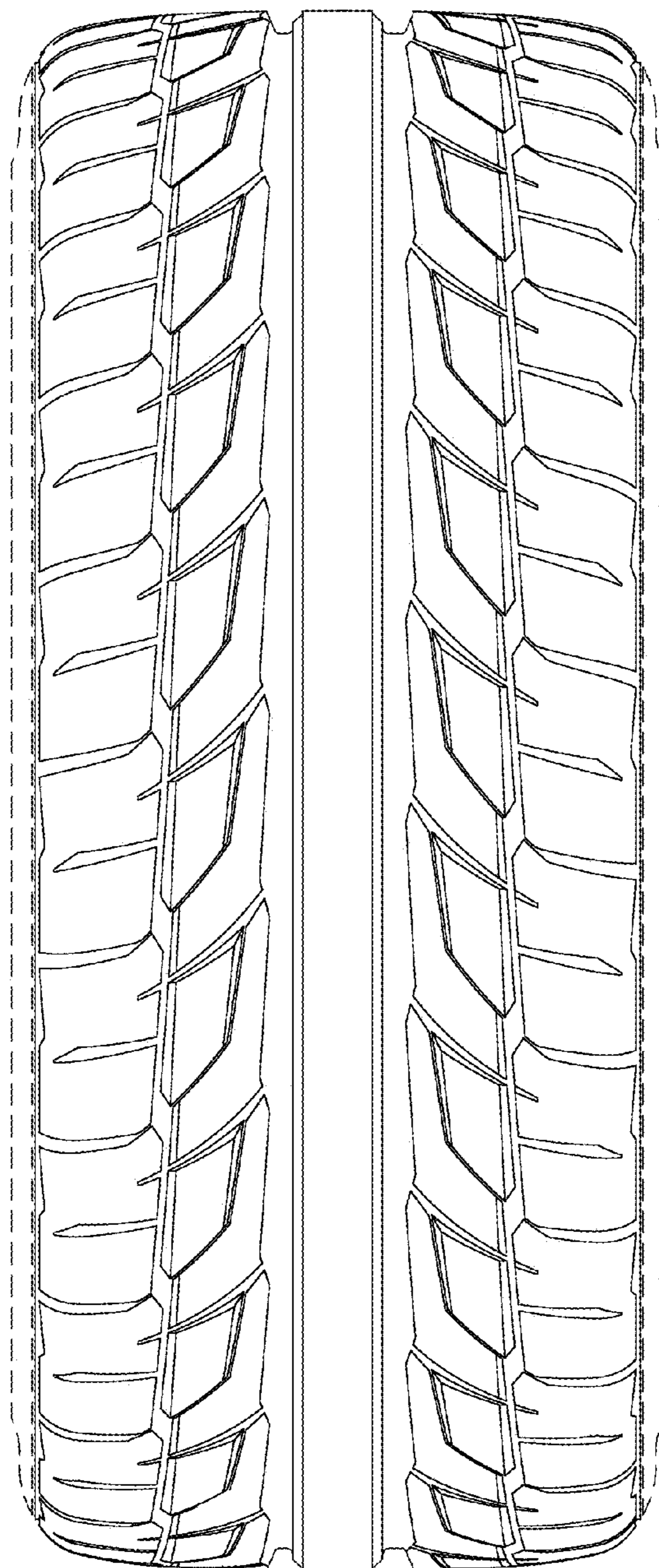

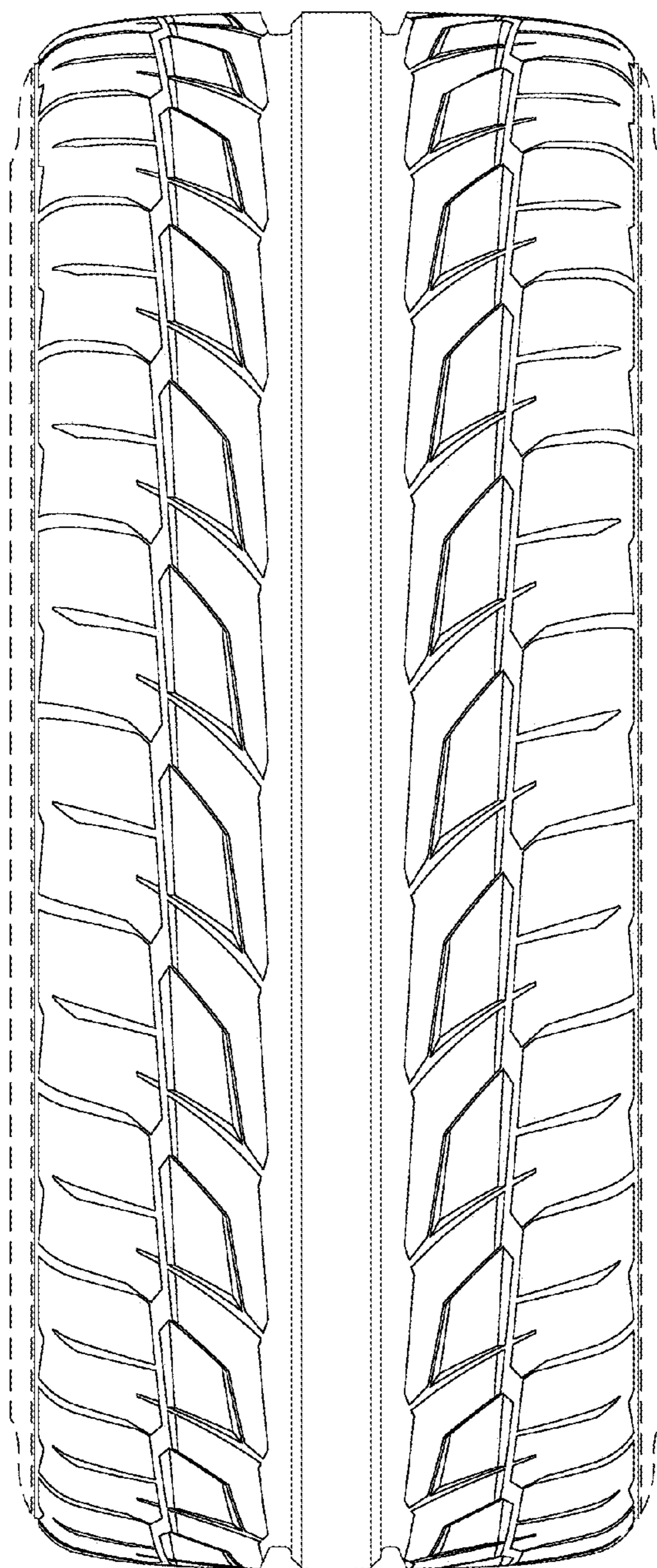

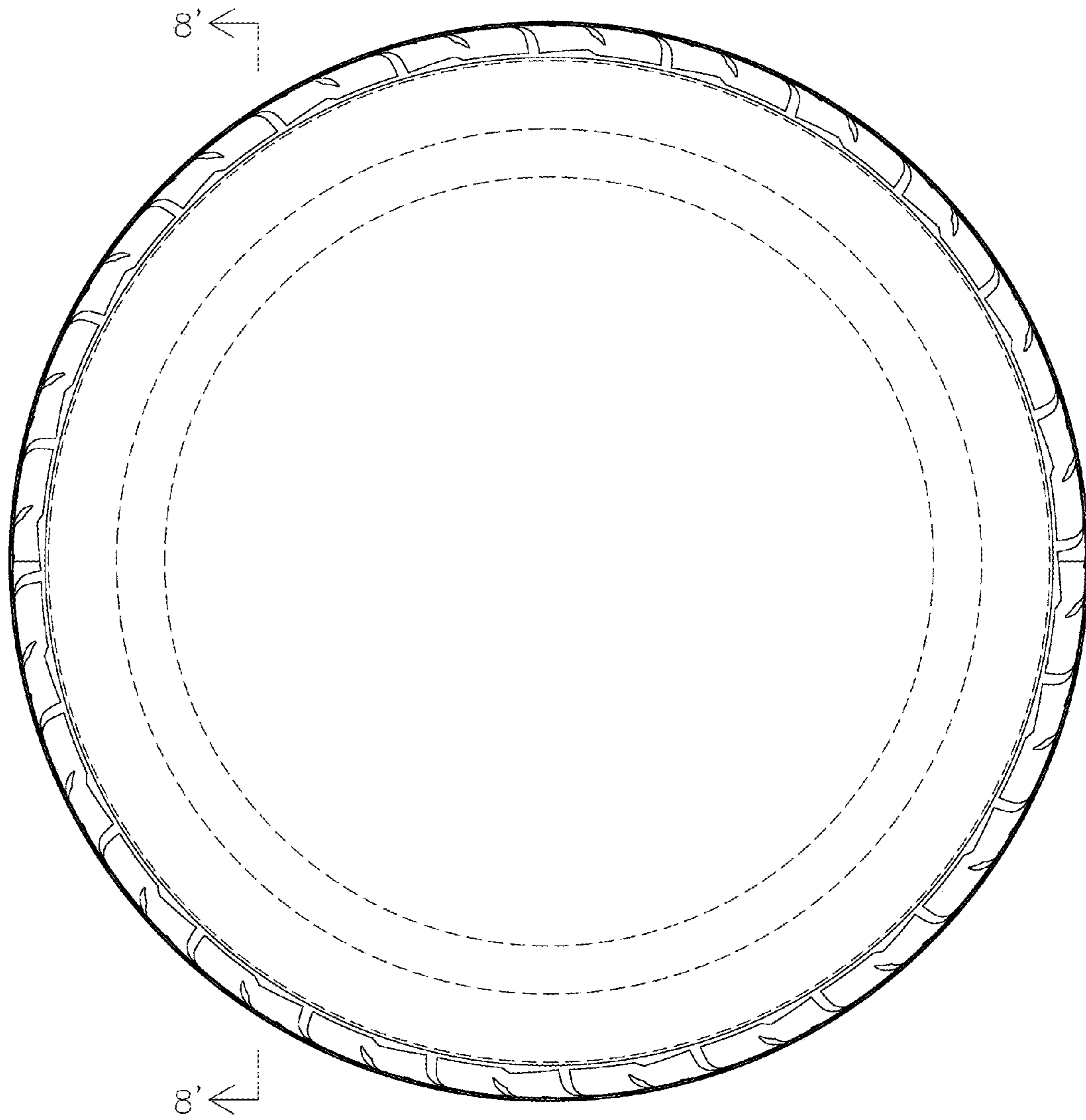

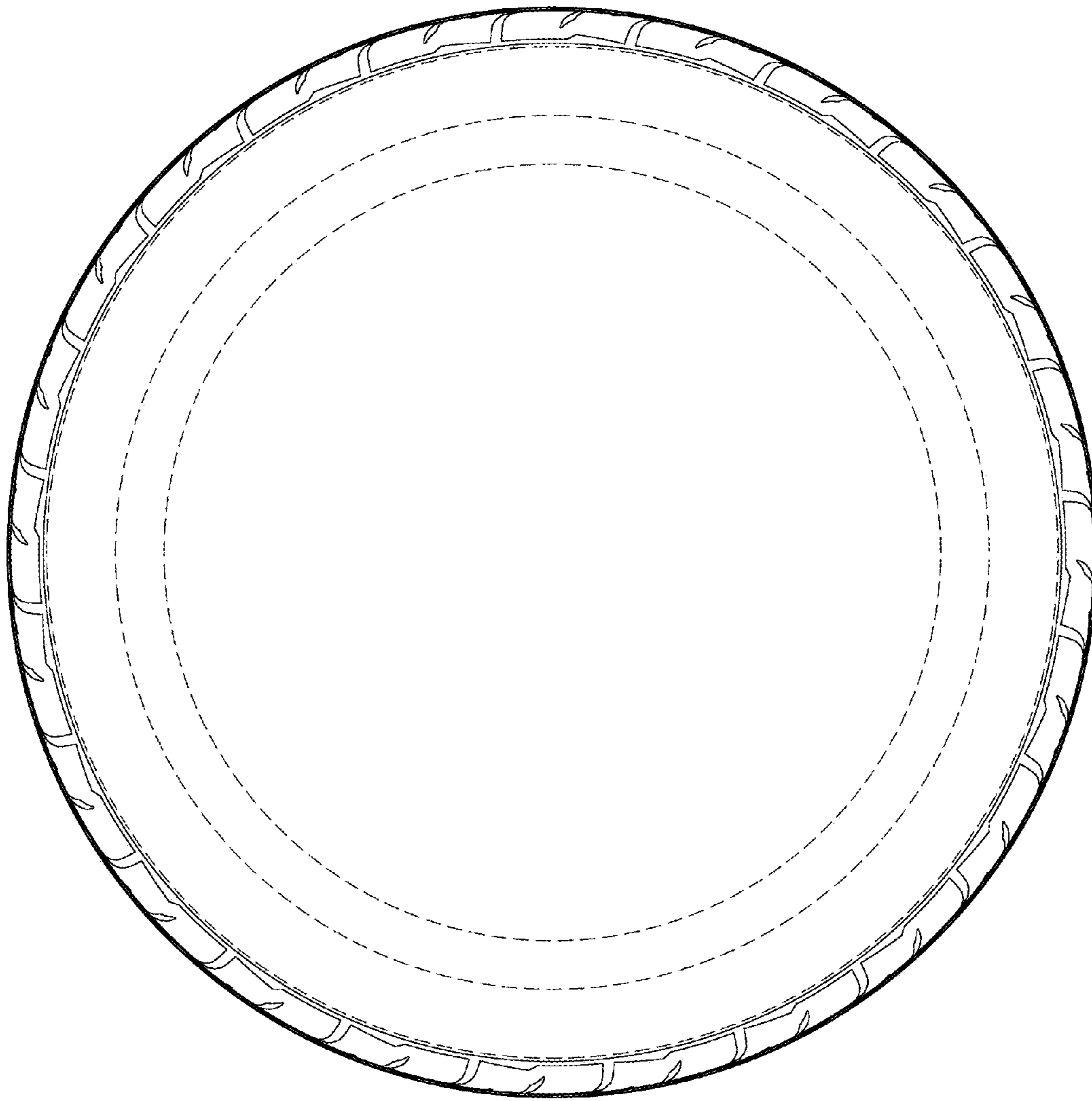

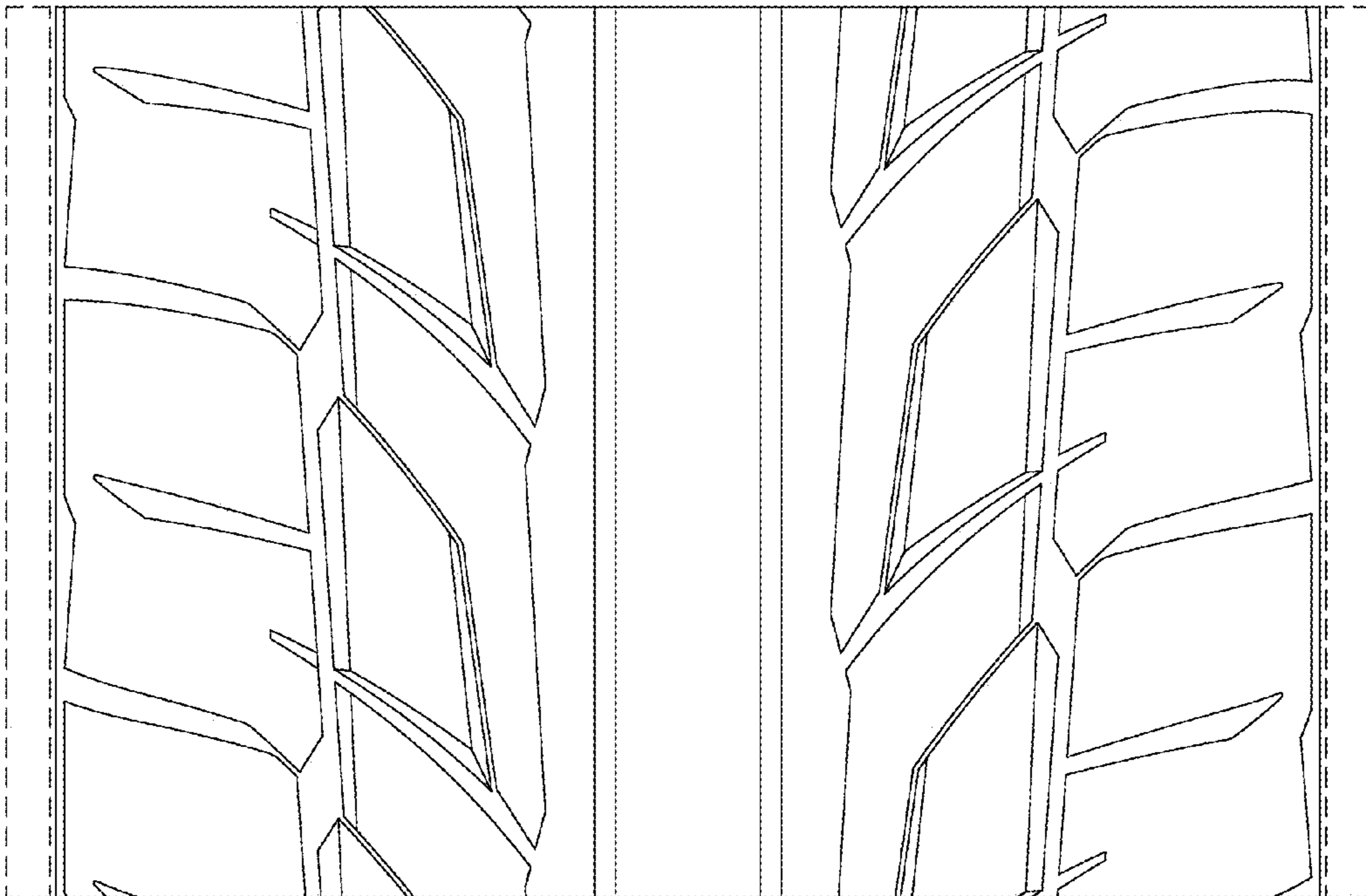

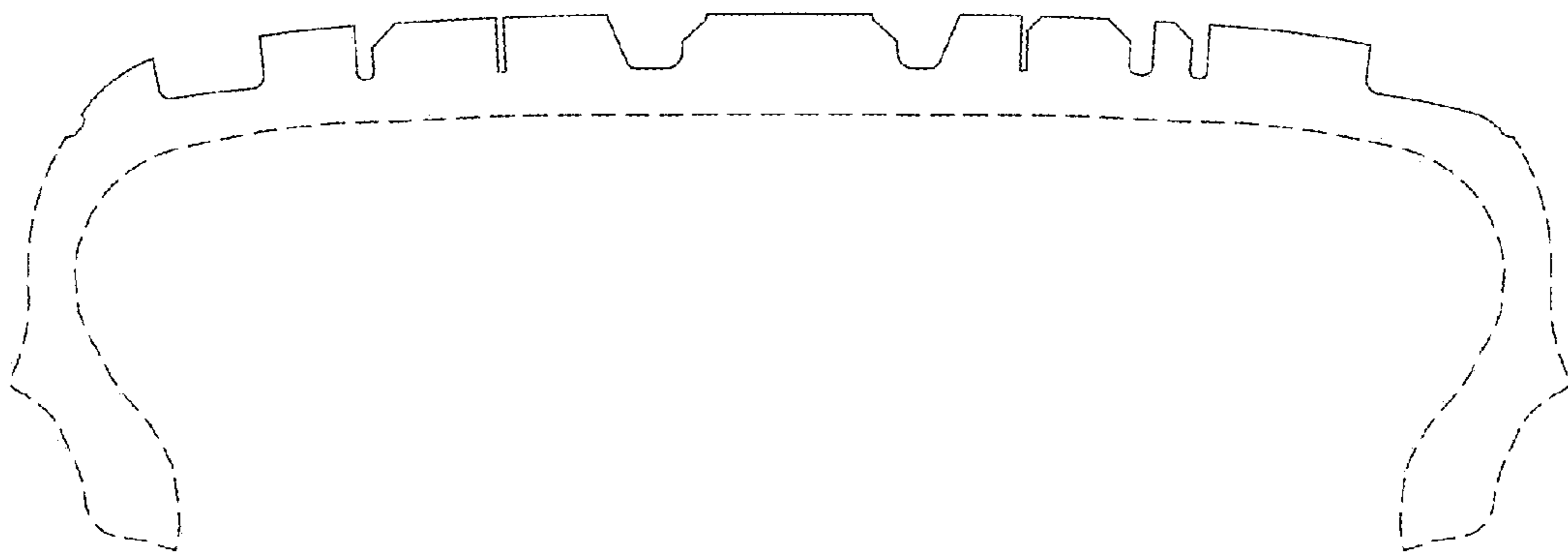
