(57) **CLAIM**

We claim the ornamental design for a cover for electronic device with display, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cover for electronic device with display showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left-side elevation view thereof; FIG. 5 is a right-side elevation view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a rear perspective view thereof; and, FIG. 9 is a front perspective view of the cover for electronic device with display shown in an example environment. The broken lines in the drawings depict environmental structure that forms no part of the claimed design.

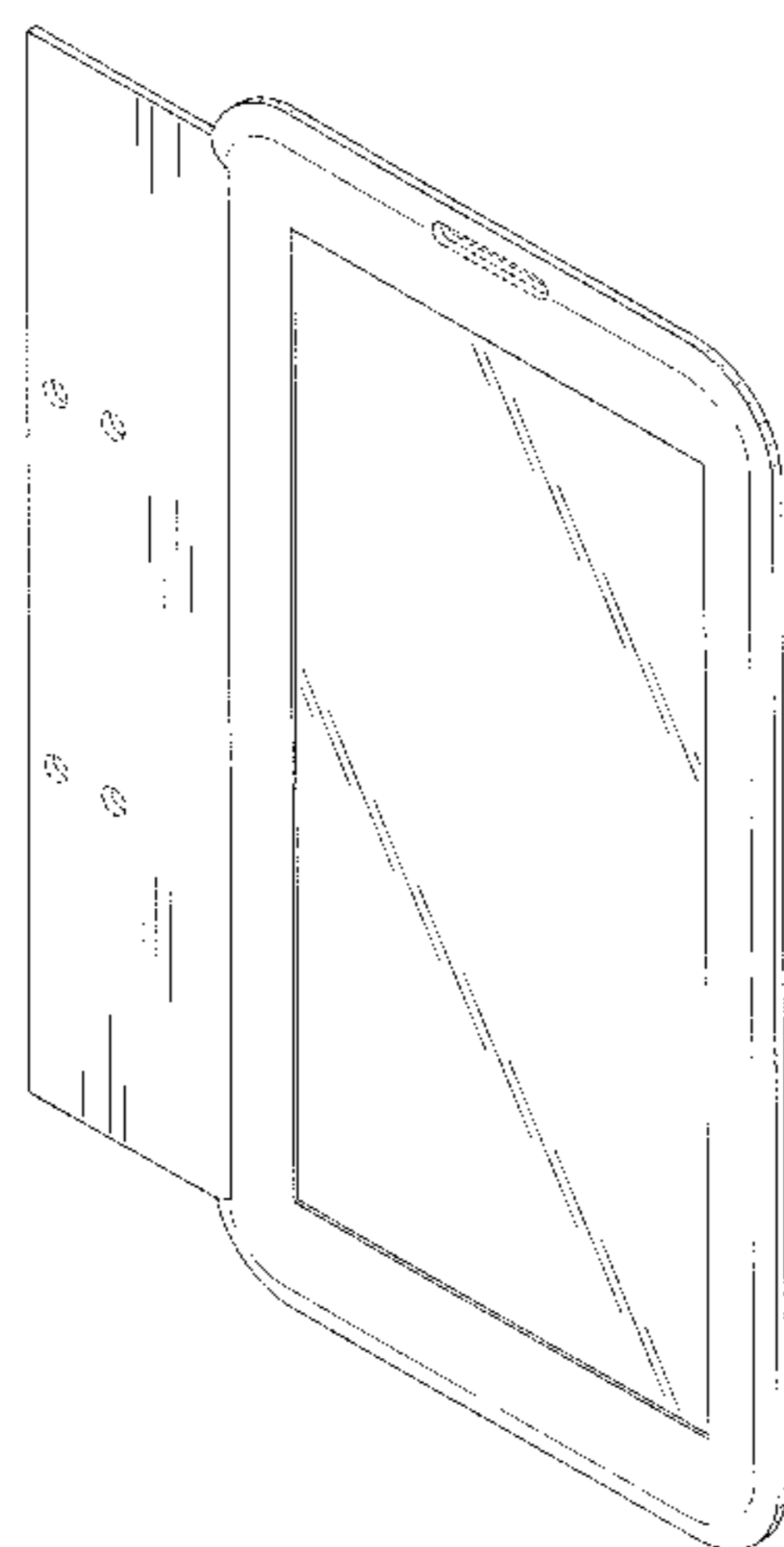

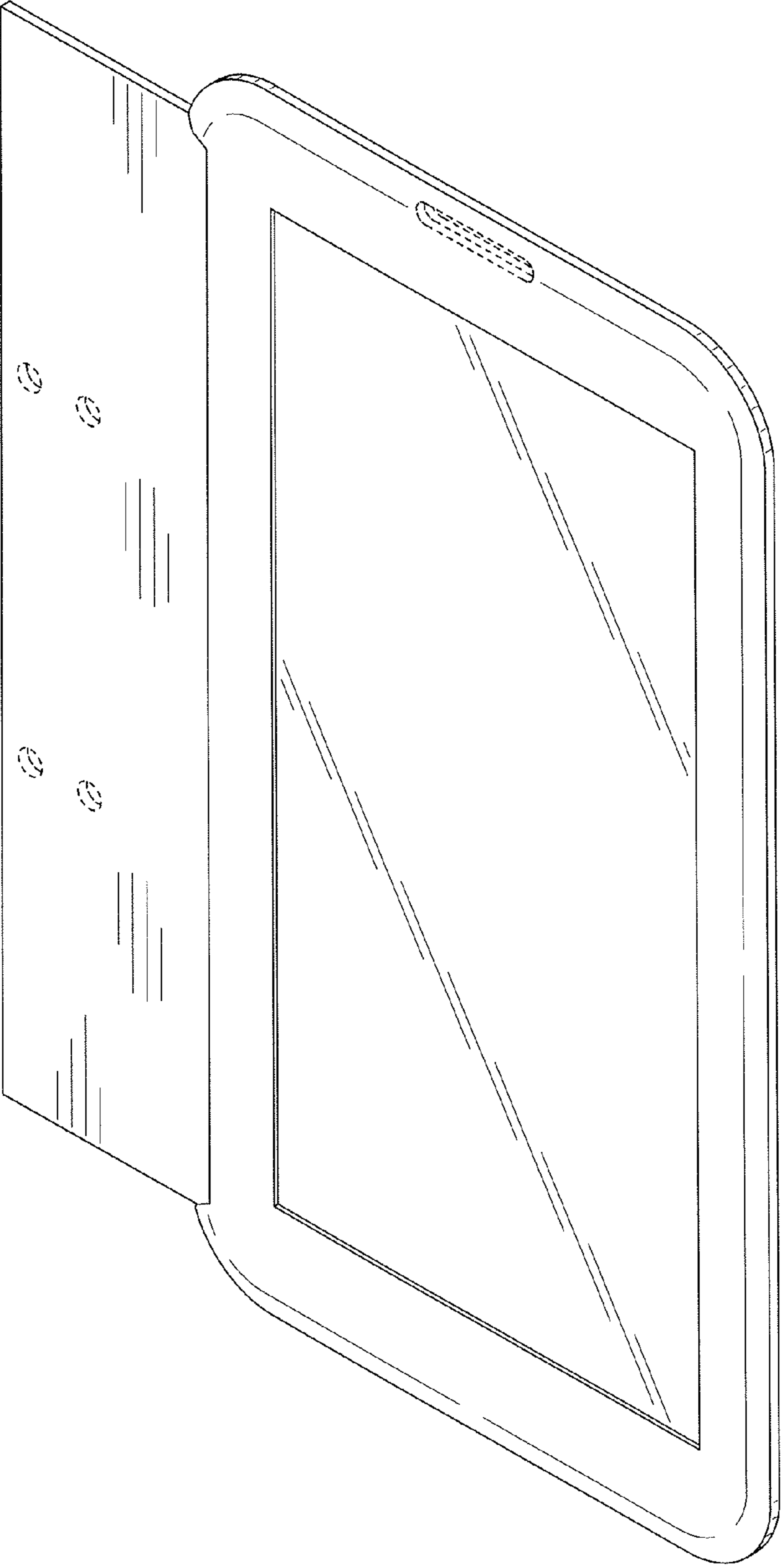

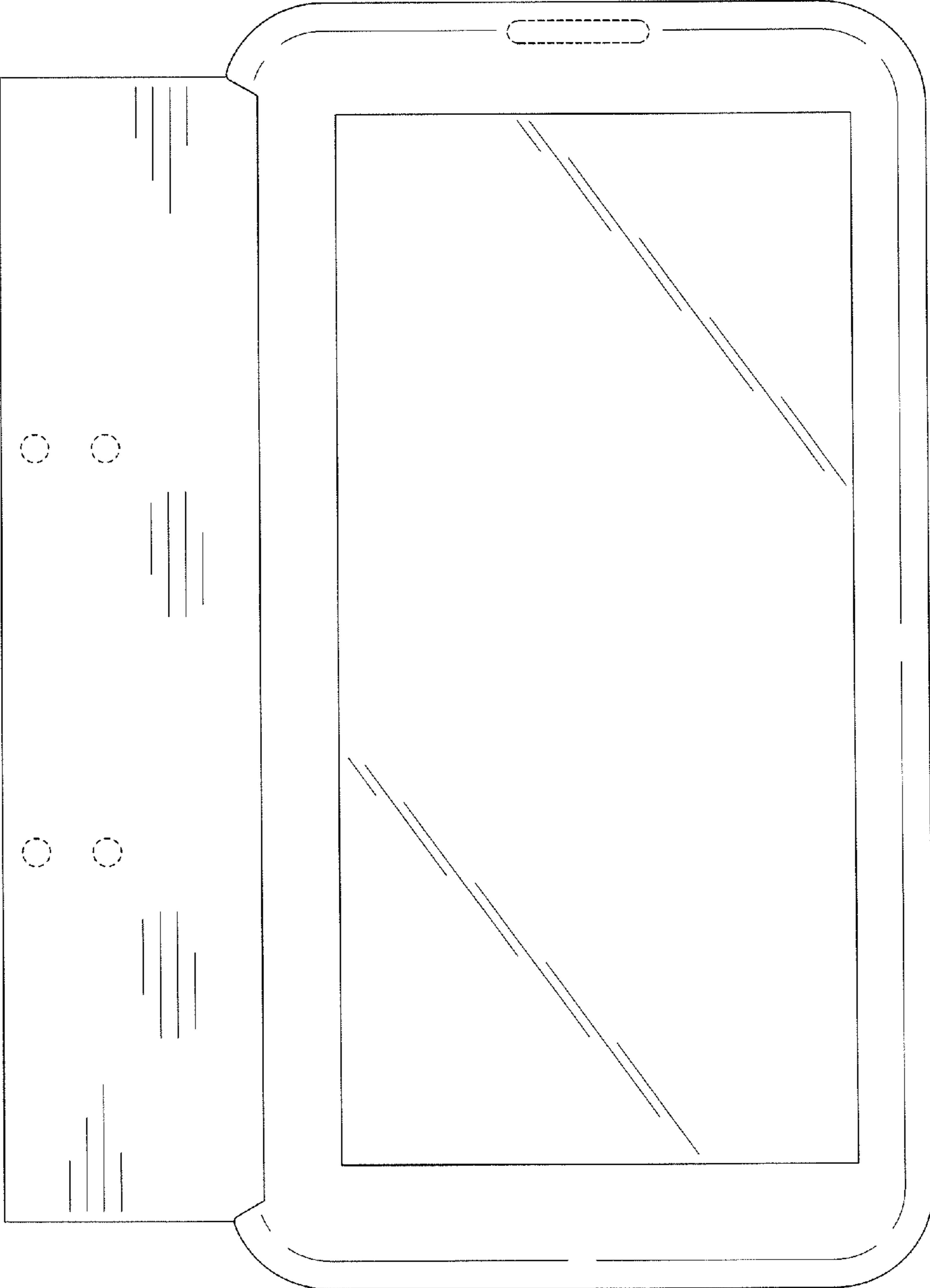

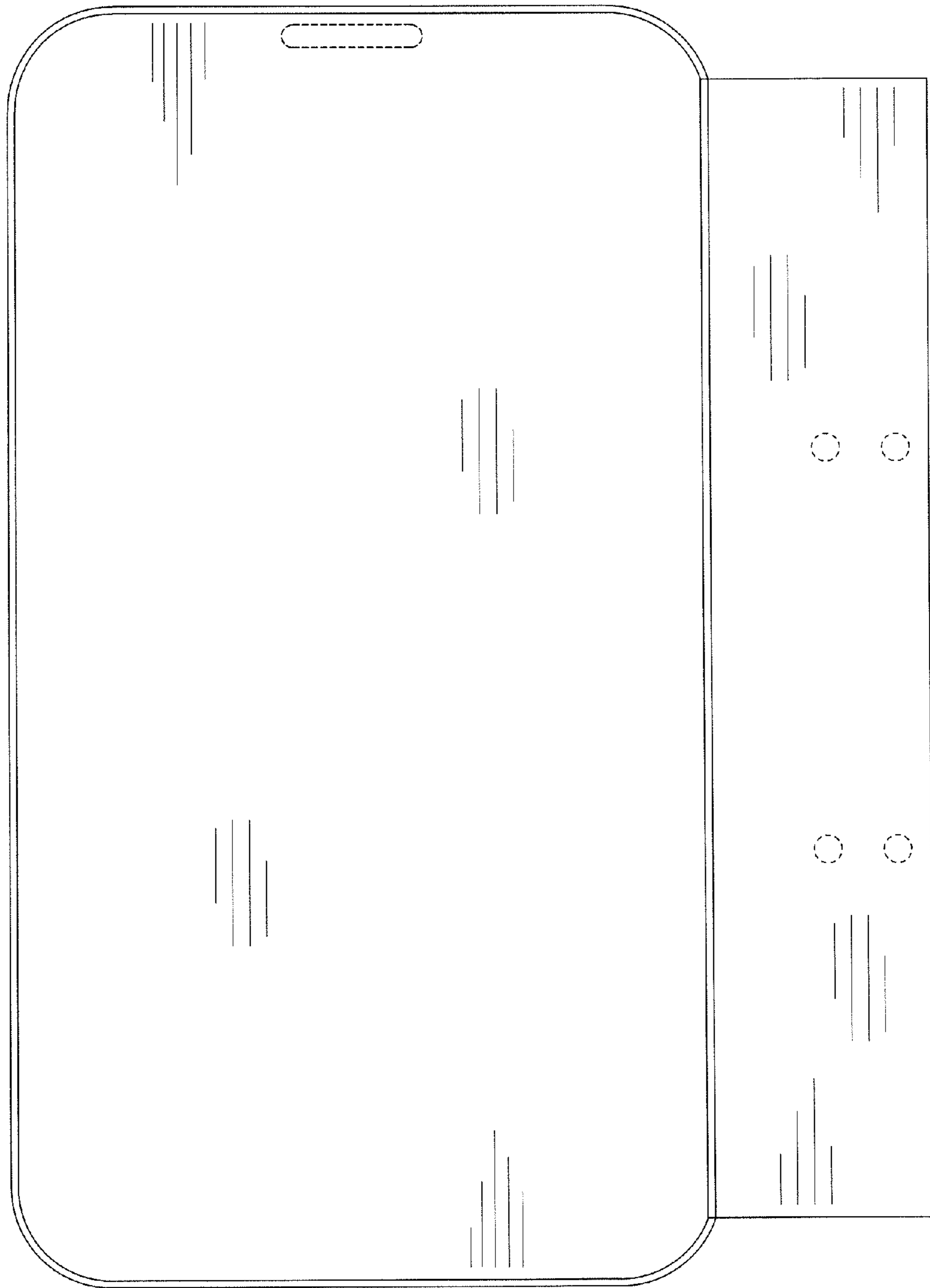

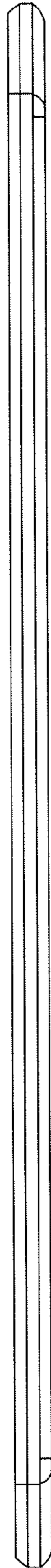

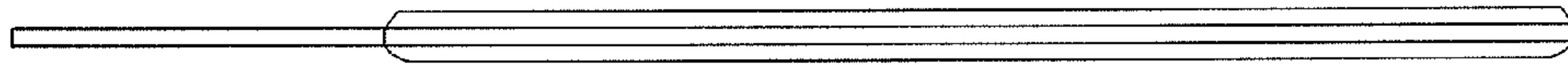

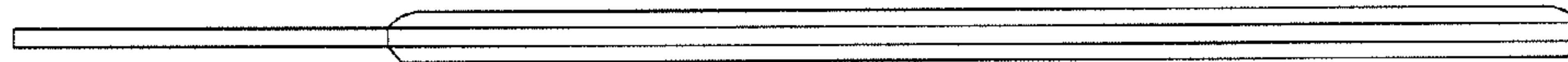

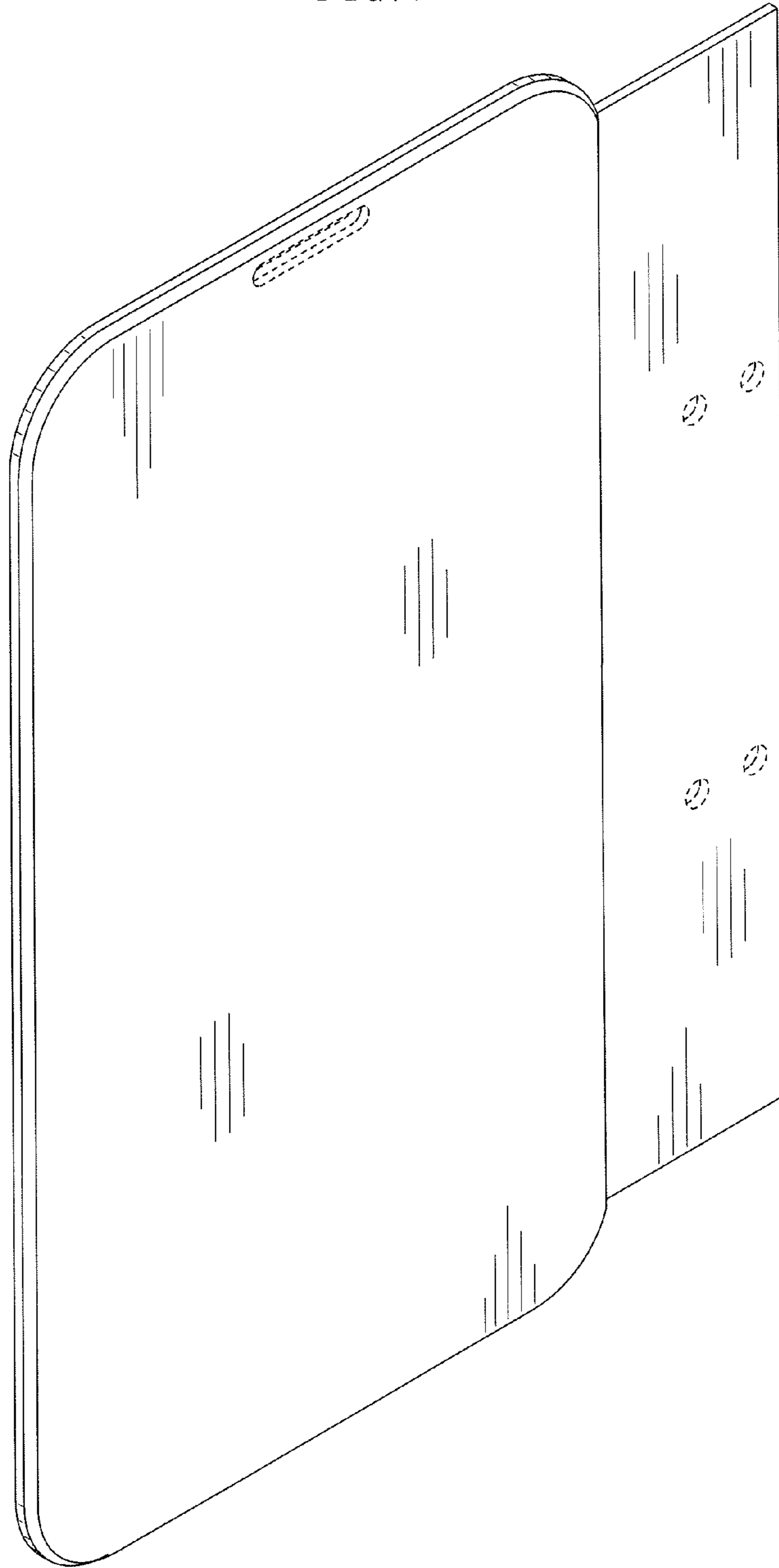
