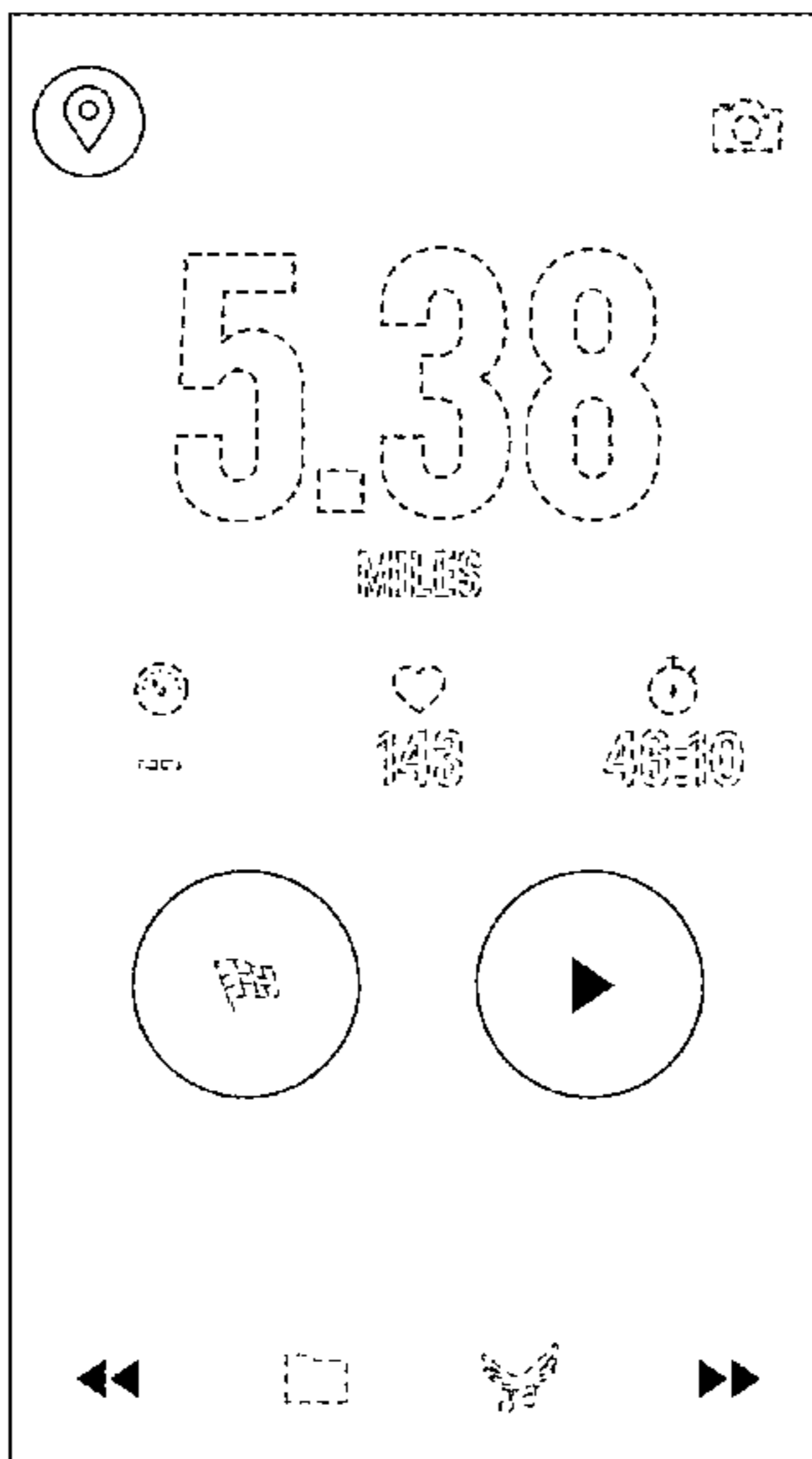
(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with graphical user interface showing the new design; and, FIG. 2 is an alternate view thereof; shown on a device. The broken lines showing text, numbers, and symbols illustrate portions of the article, and the device shown in broken lines in FIG. 2 illustrates environmental subject matter. None of the broken lines form part of the claimed design.

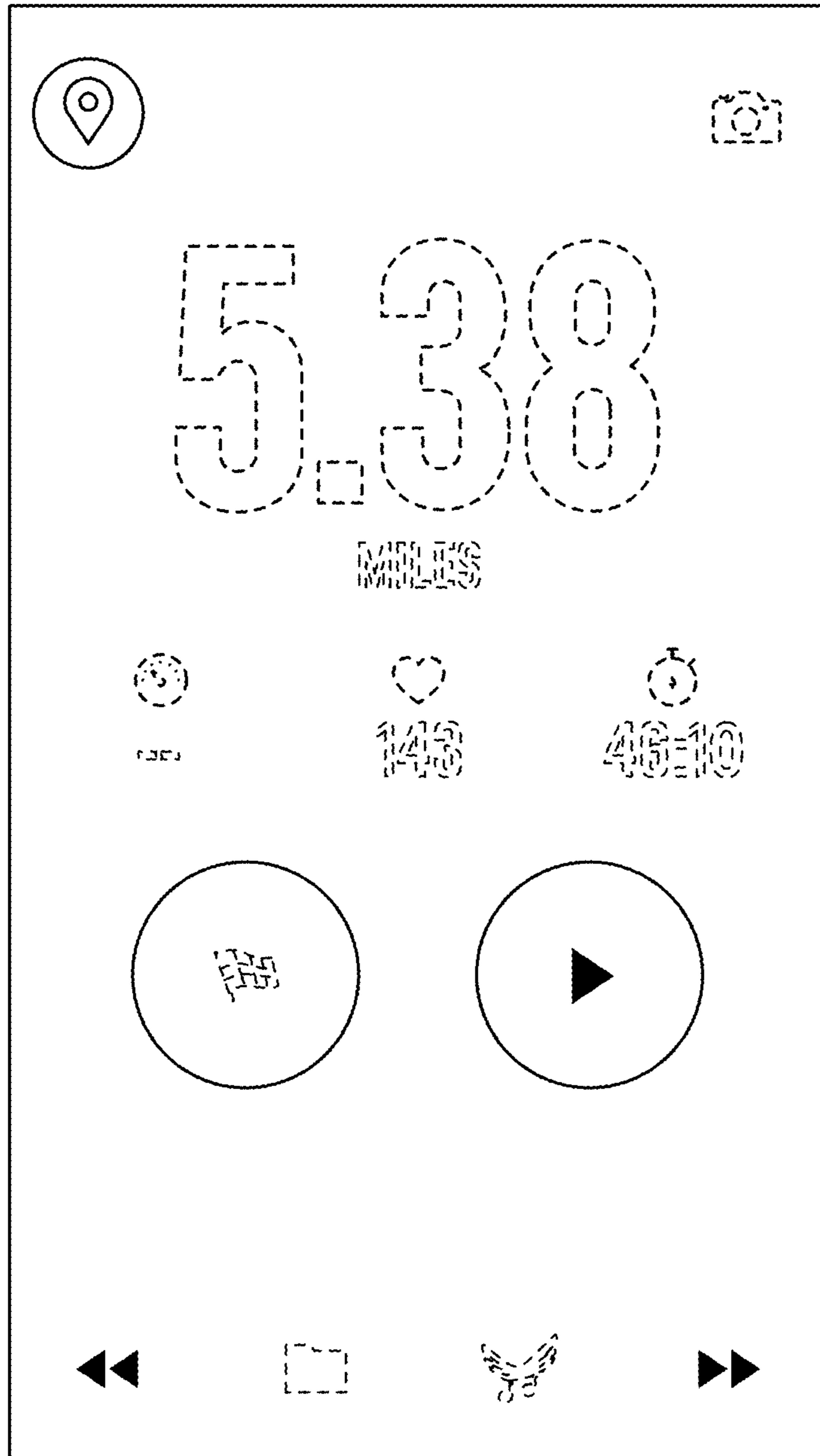

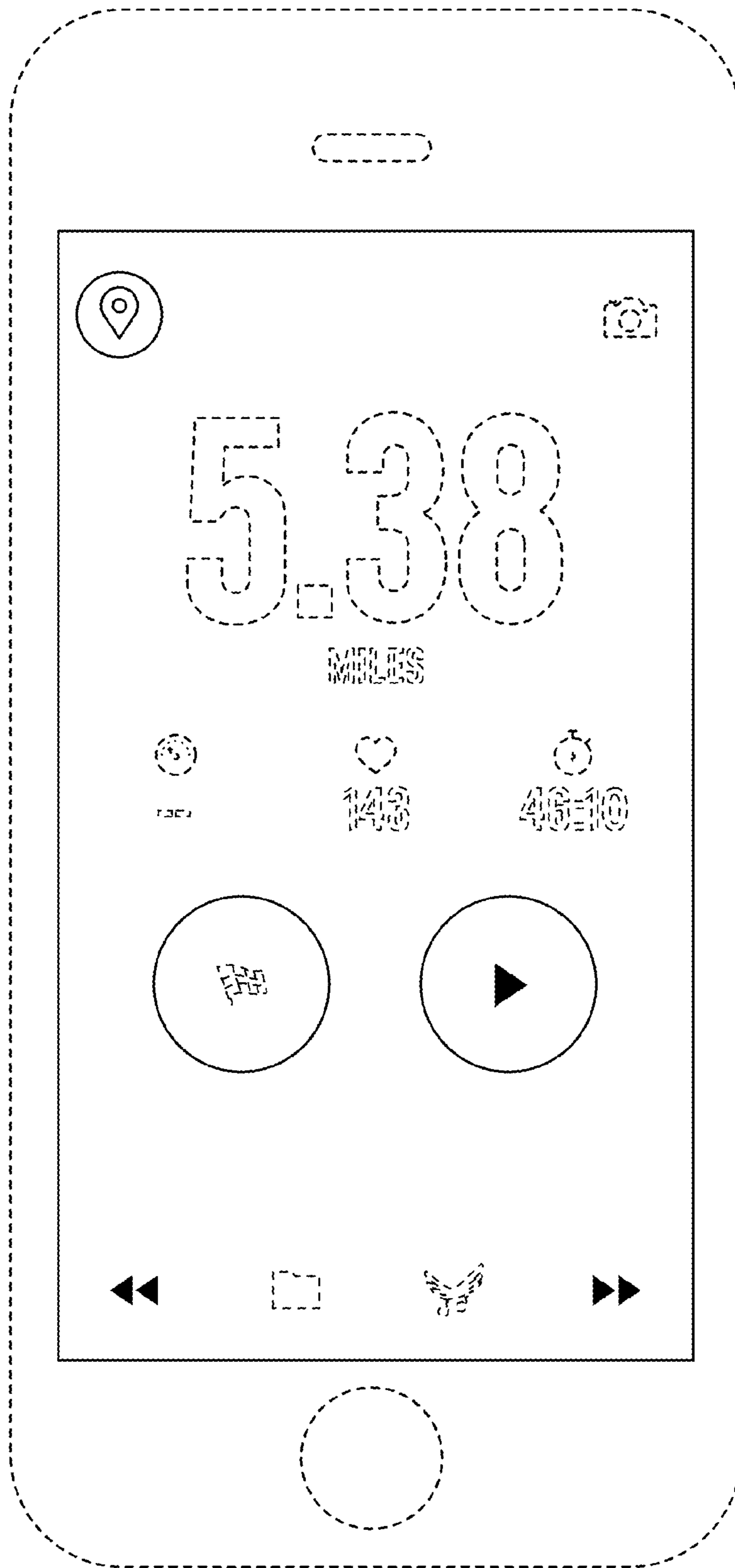
