FIG. 2 is another embodiment thereof.

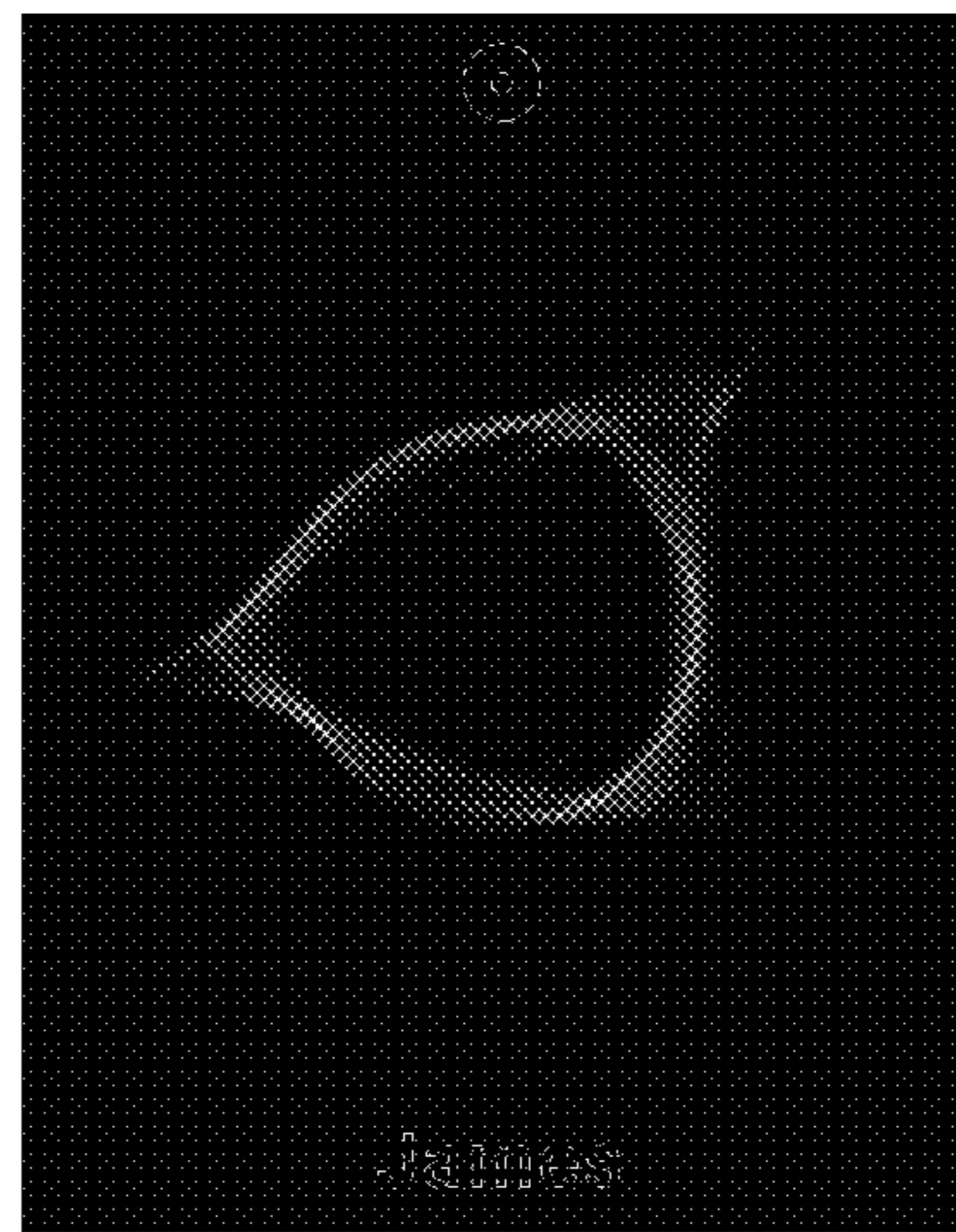
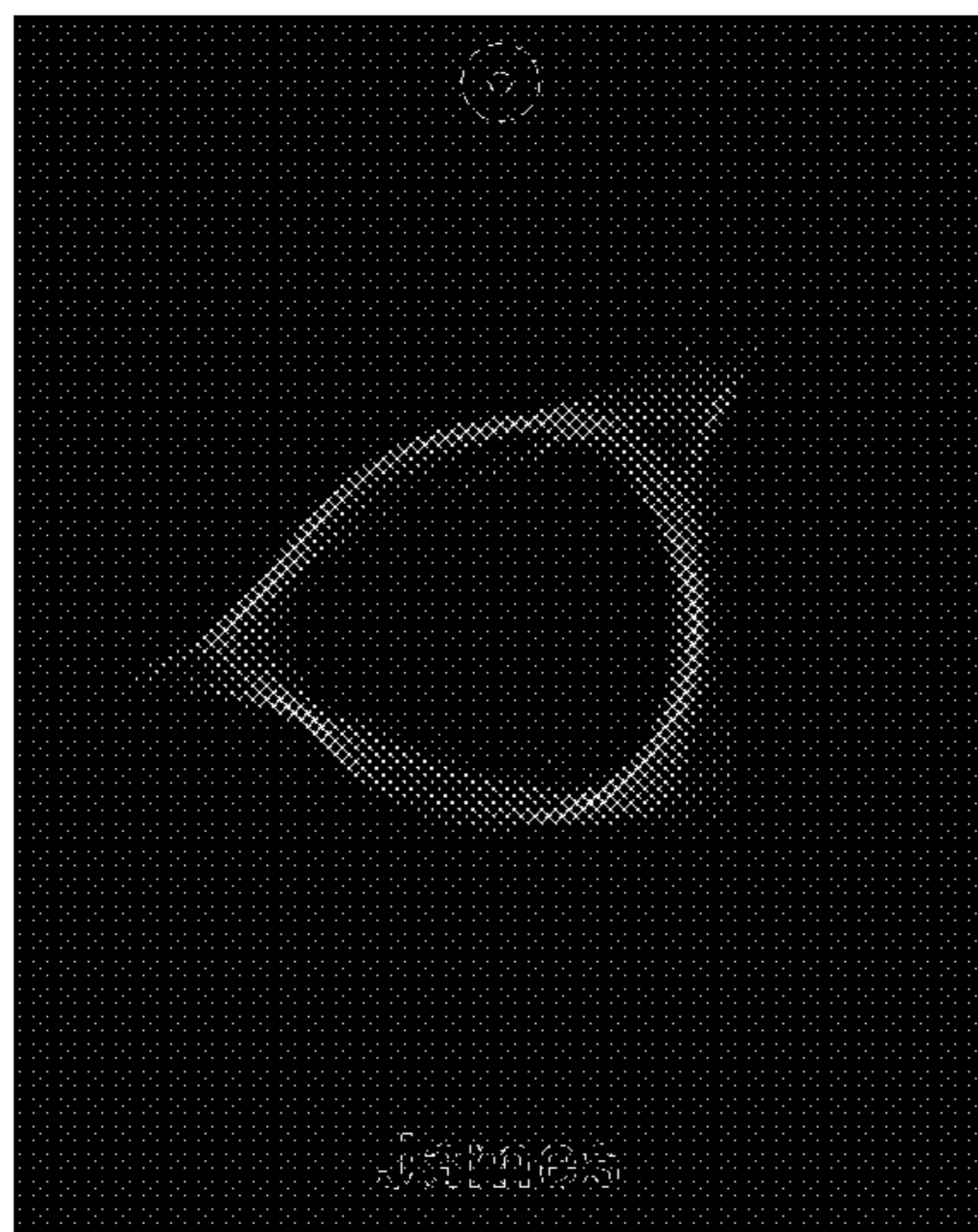

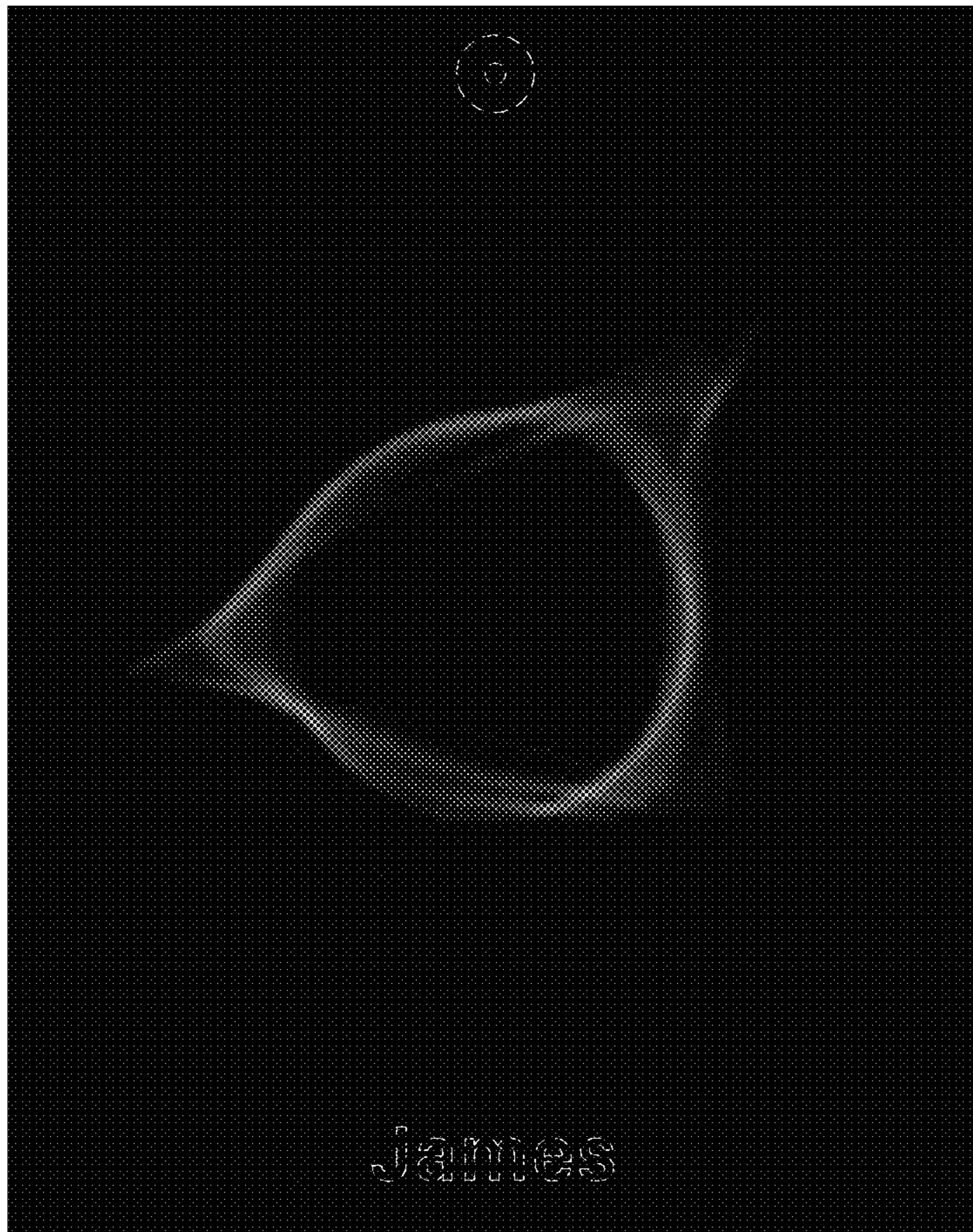

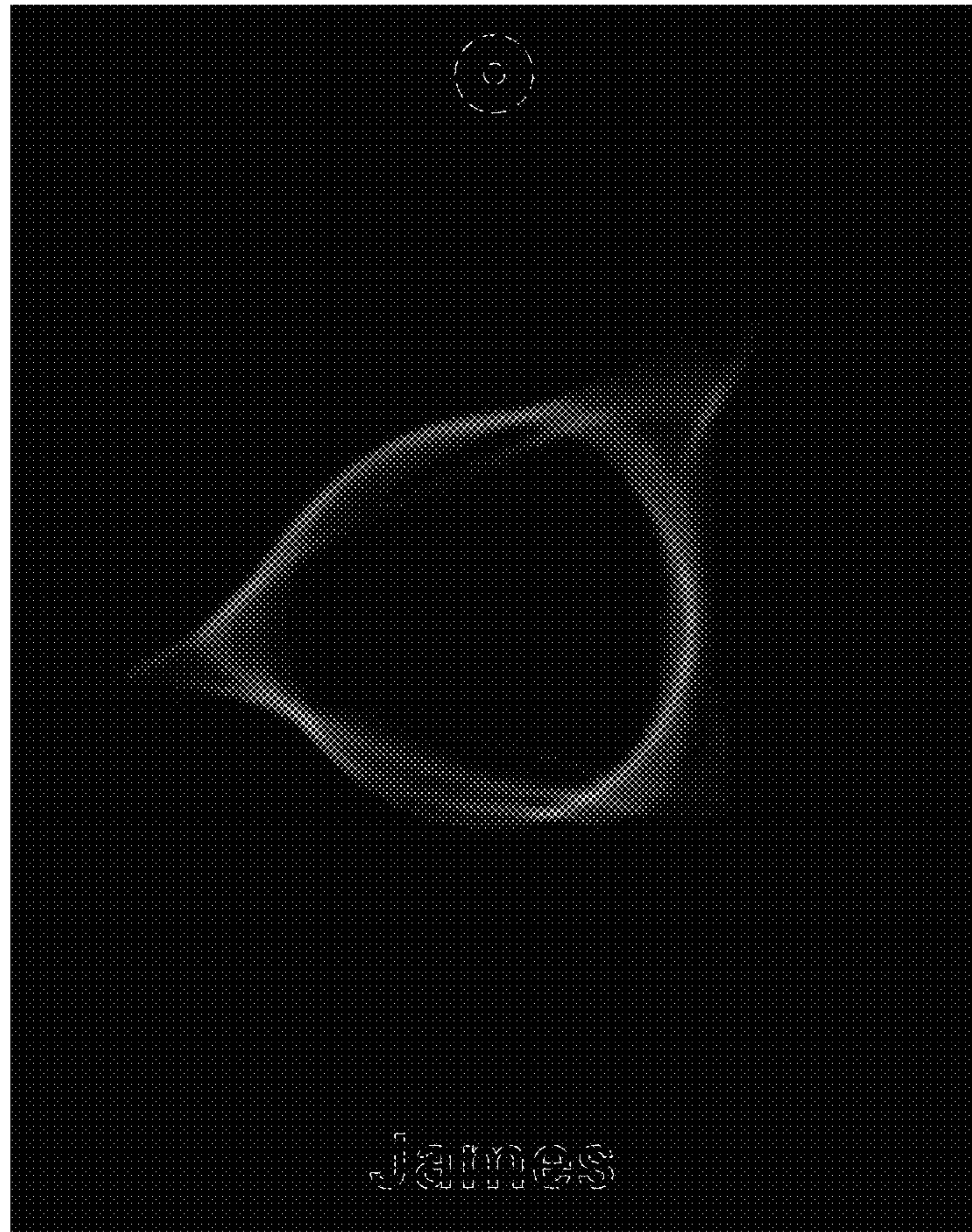
