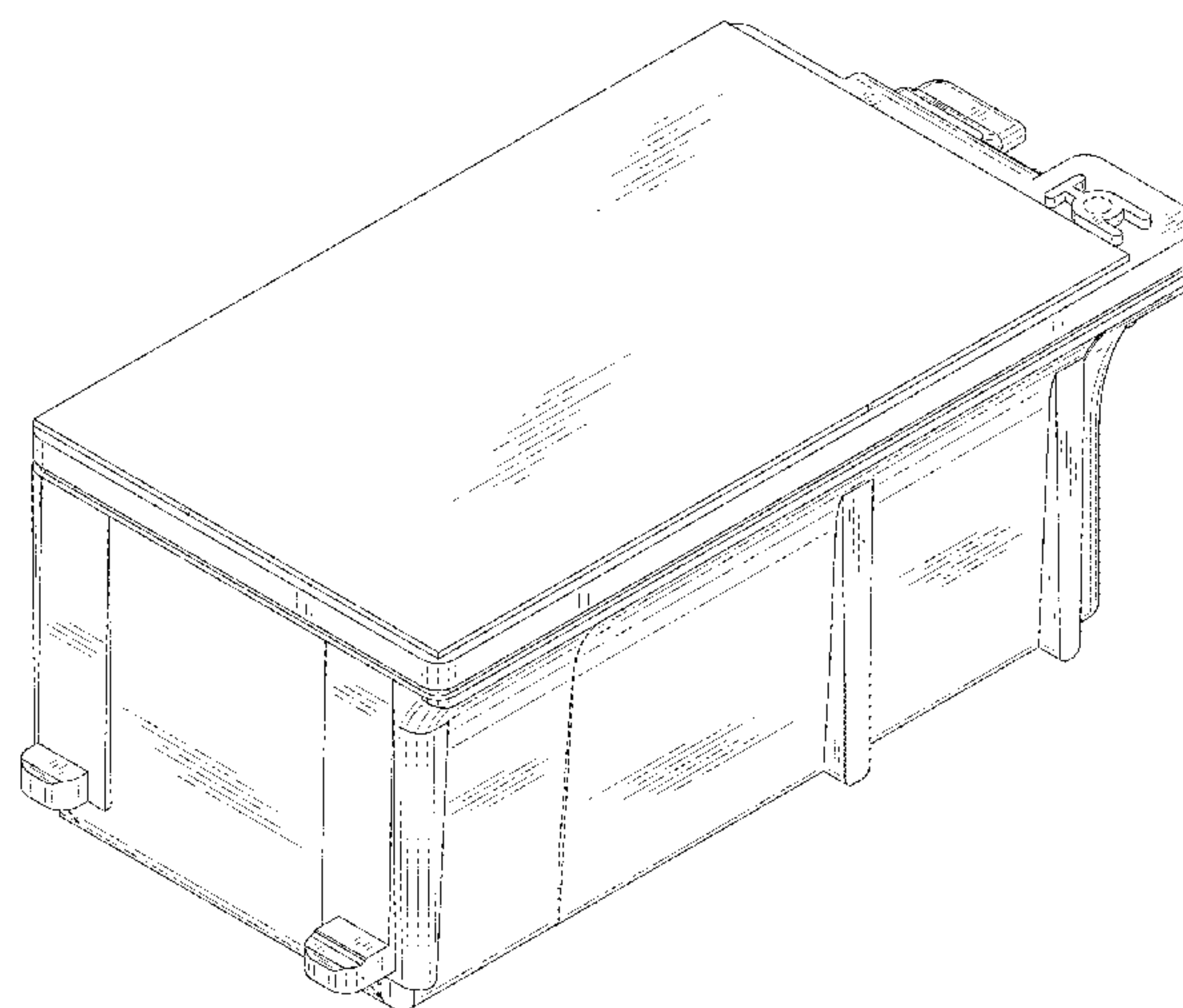
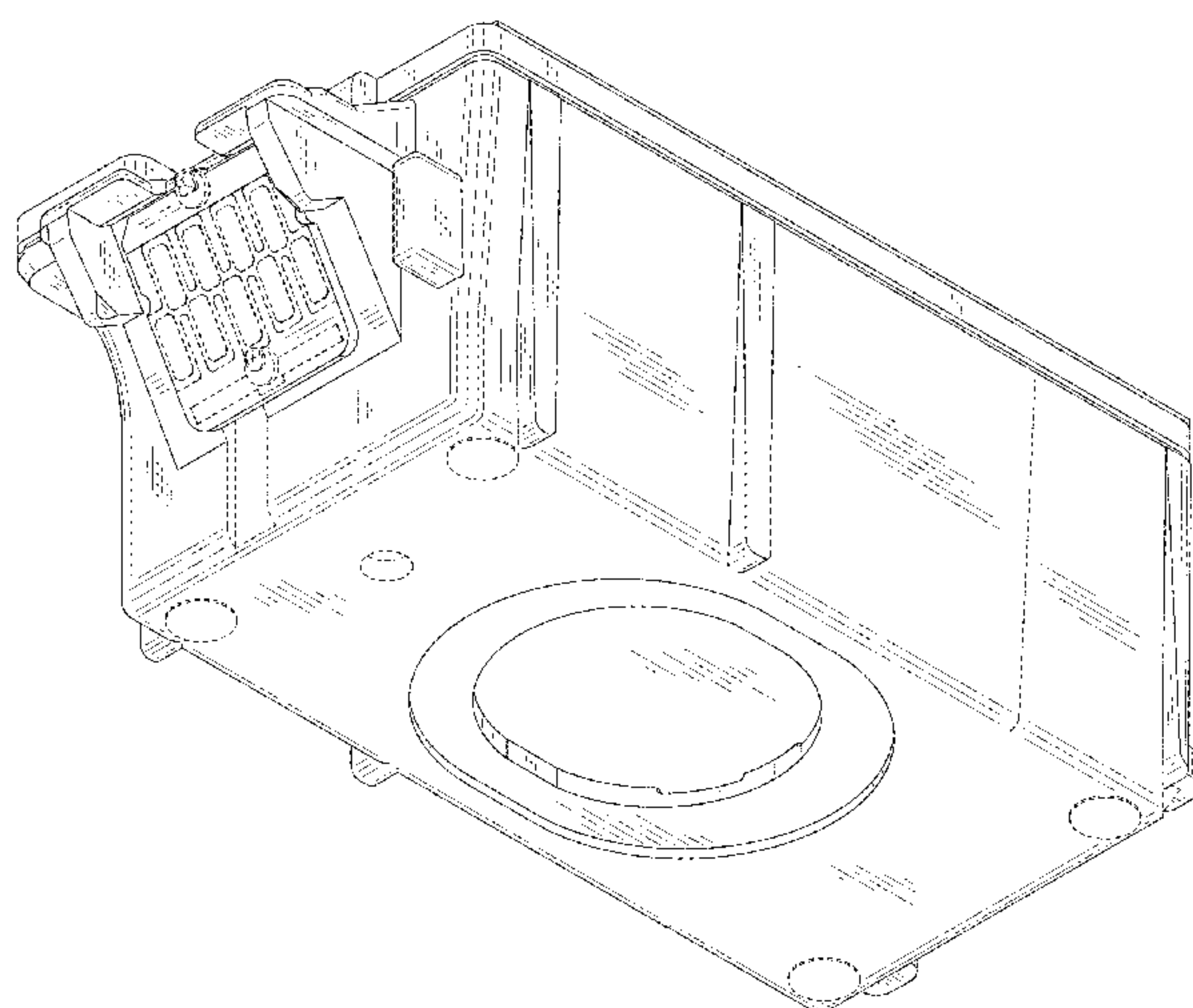
The ornamental design for an ink cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and right side perspective view of an ink cartridge showing our new design;

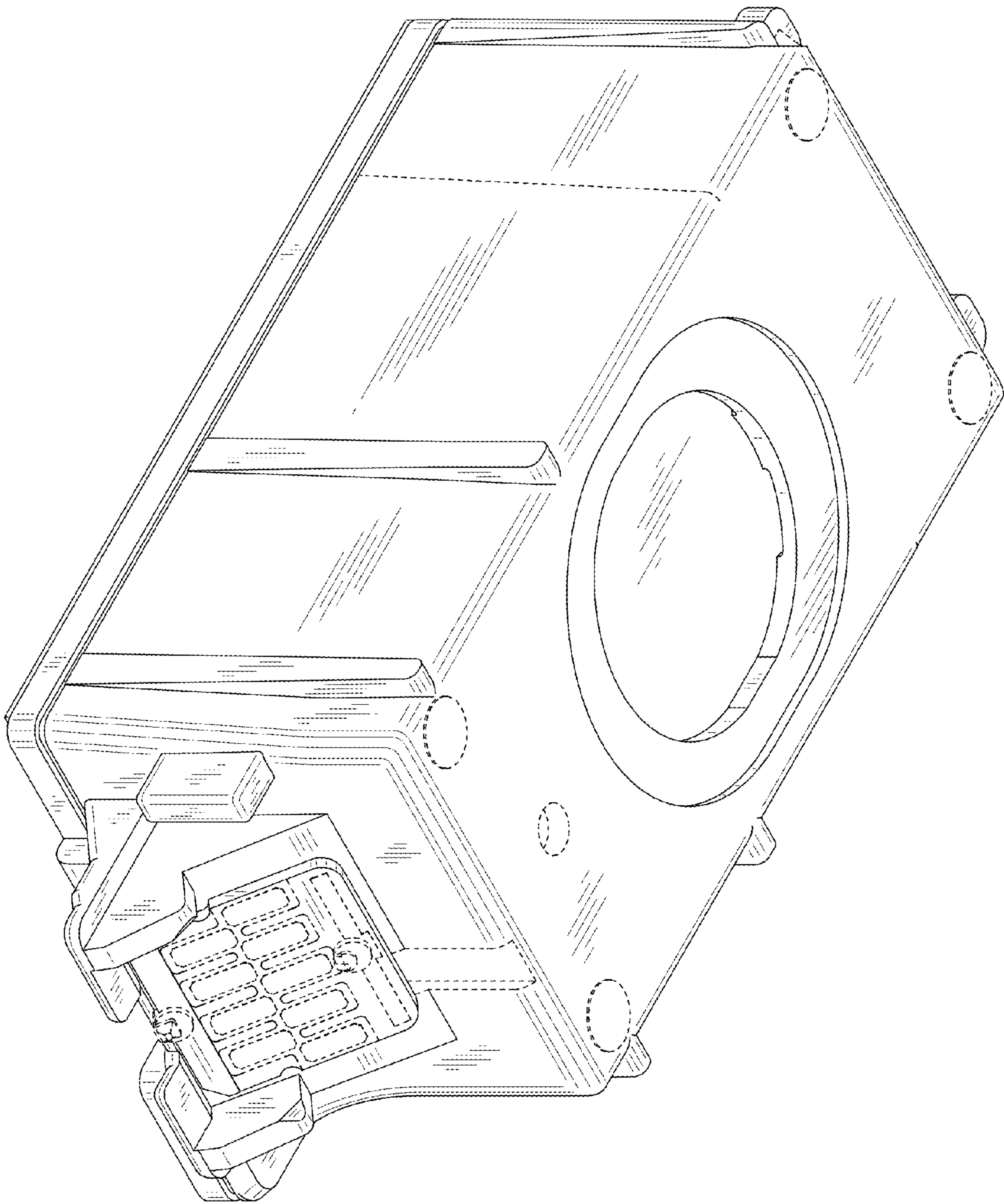

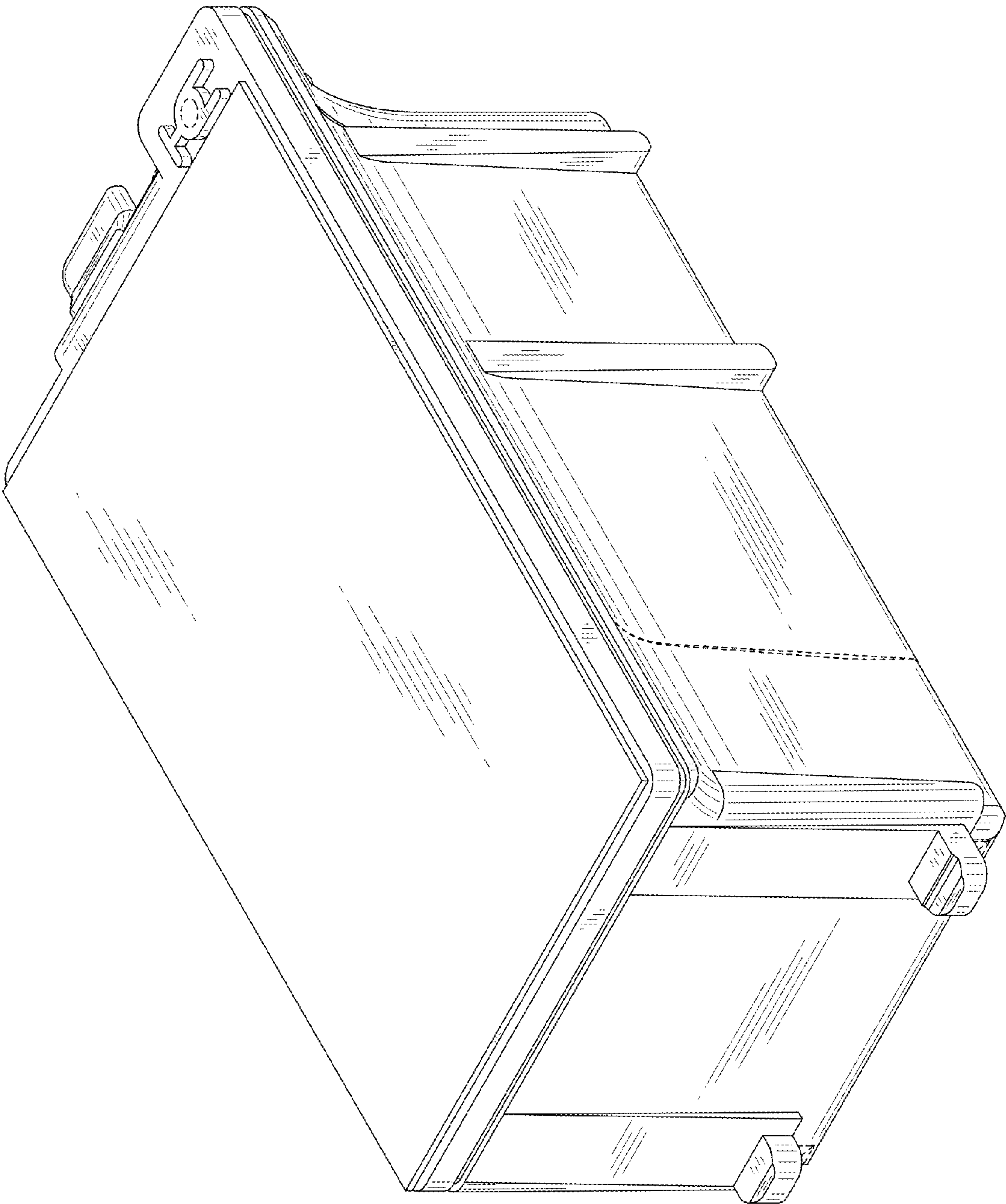

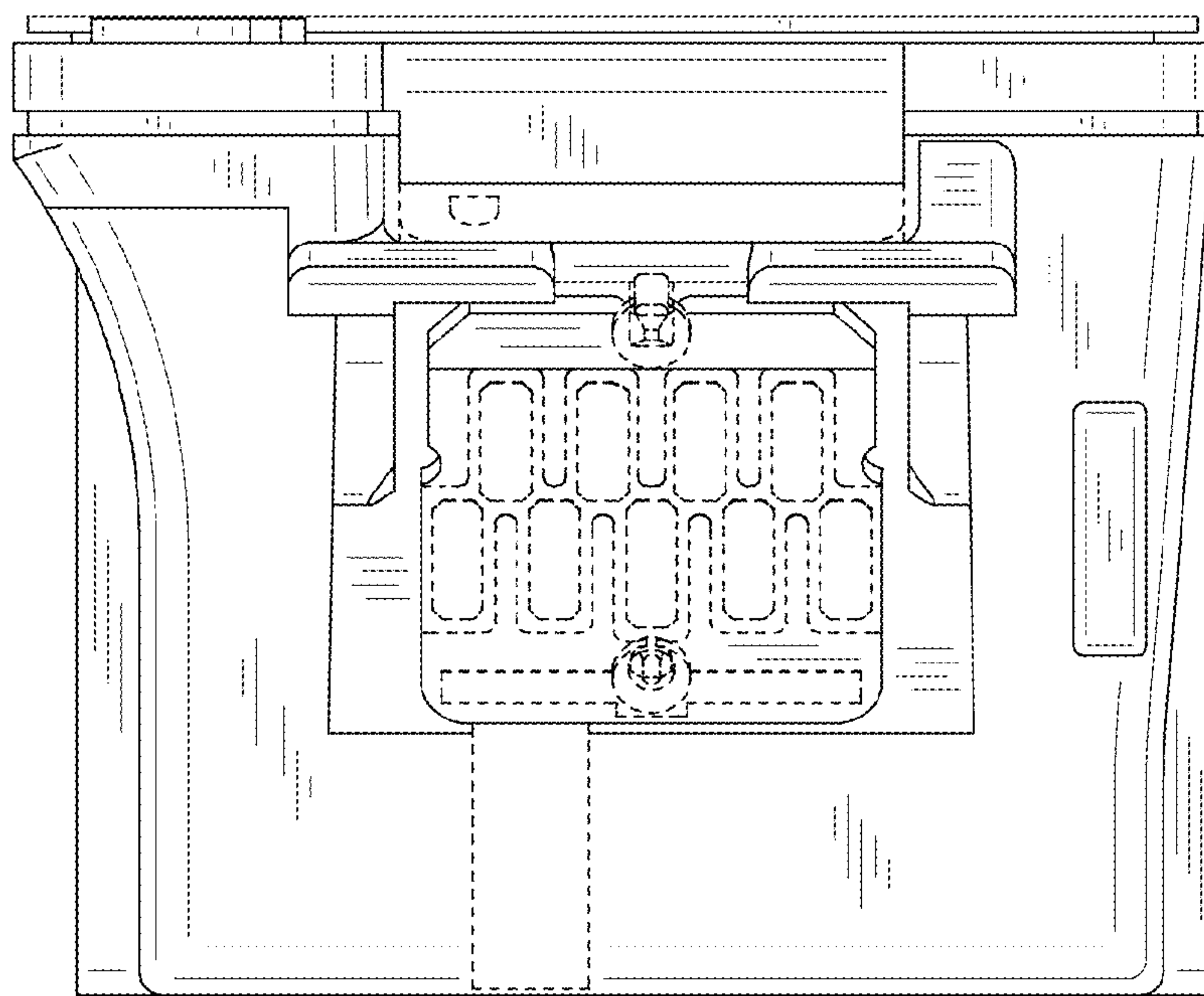

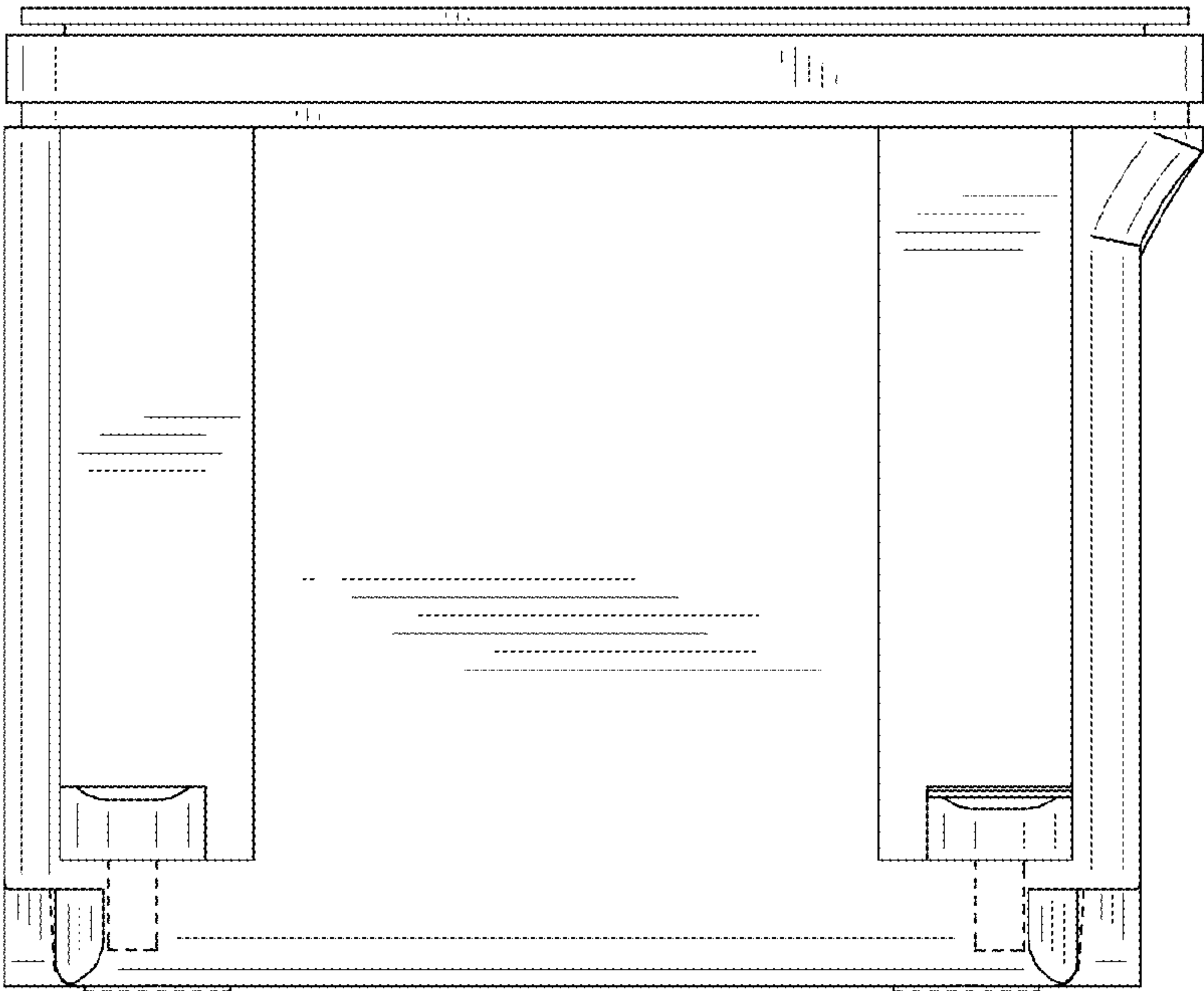

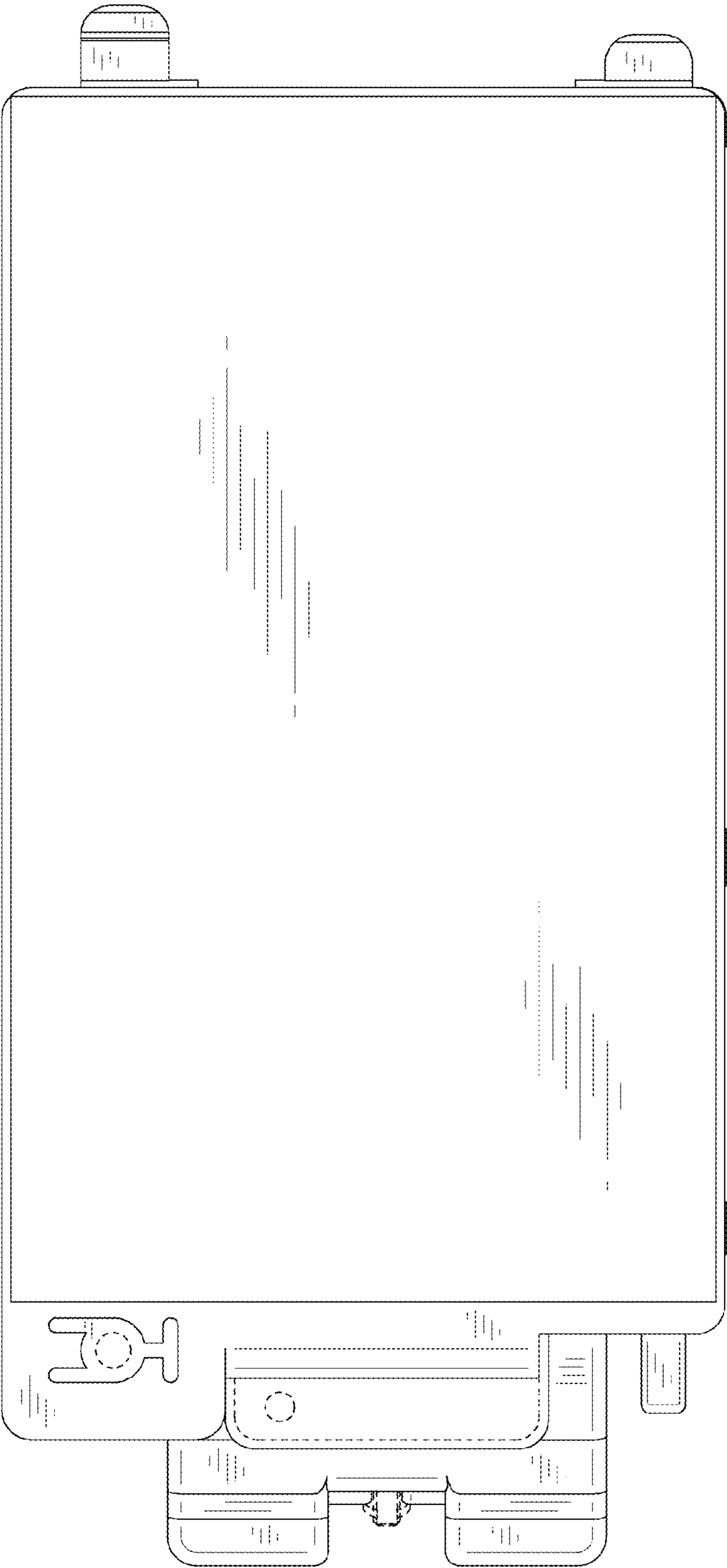

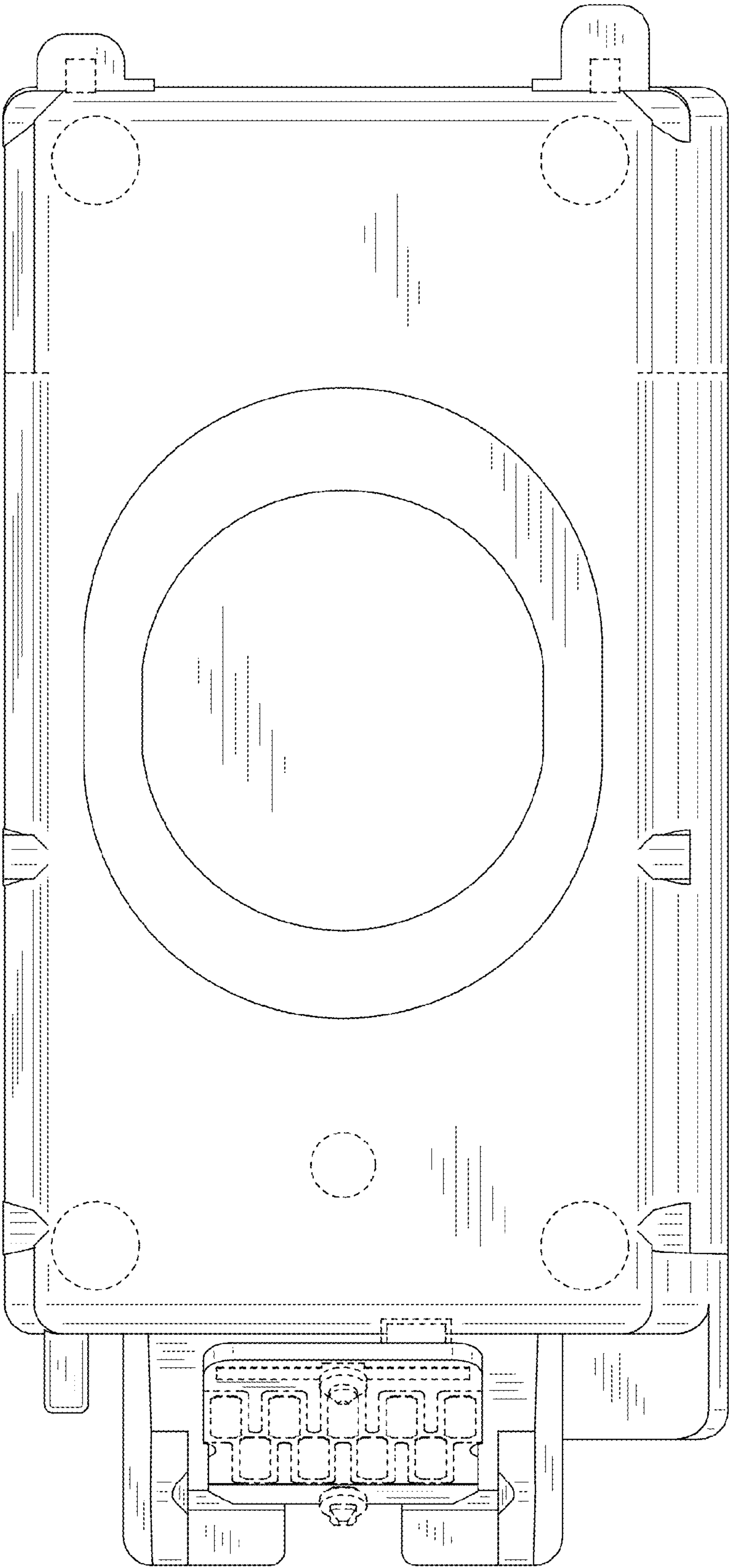

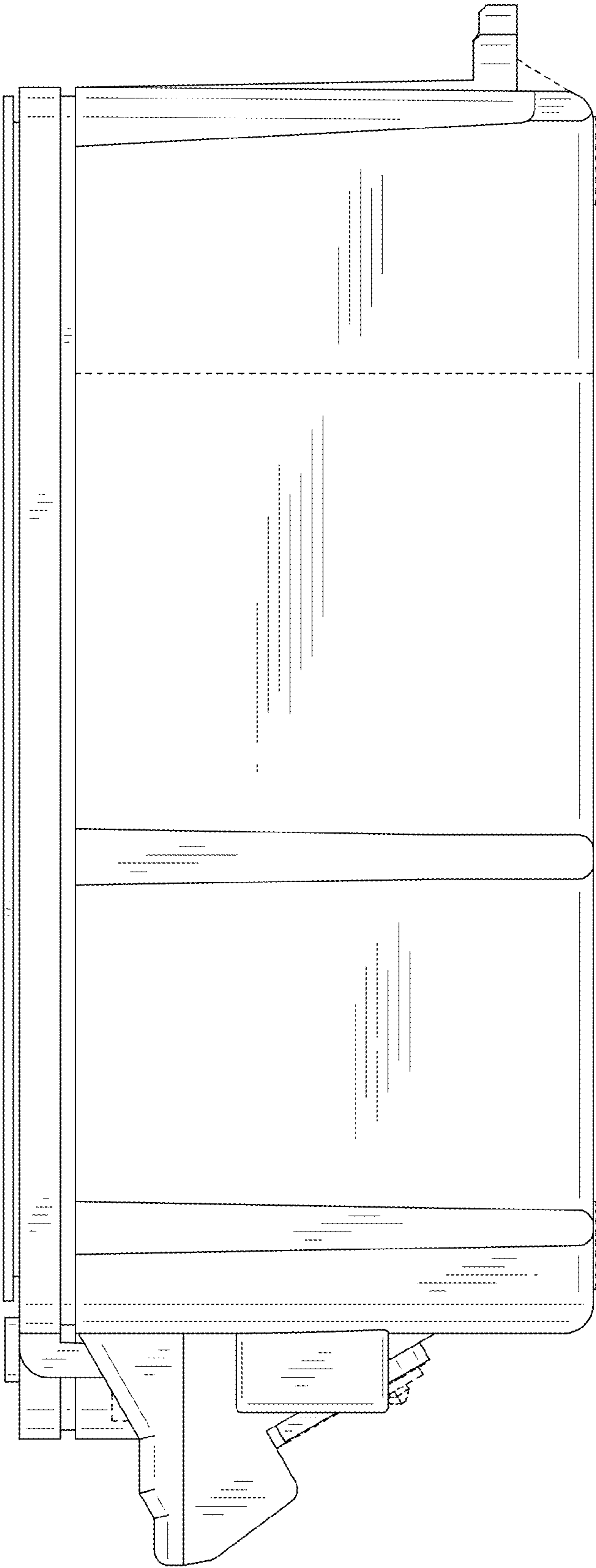
