FIG. 3 is a top plan view of the inflatable dojo training facility of FIG. 1;

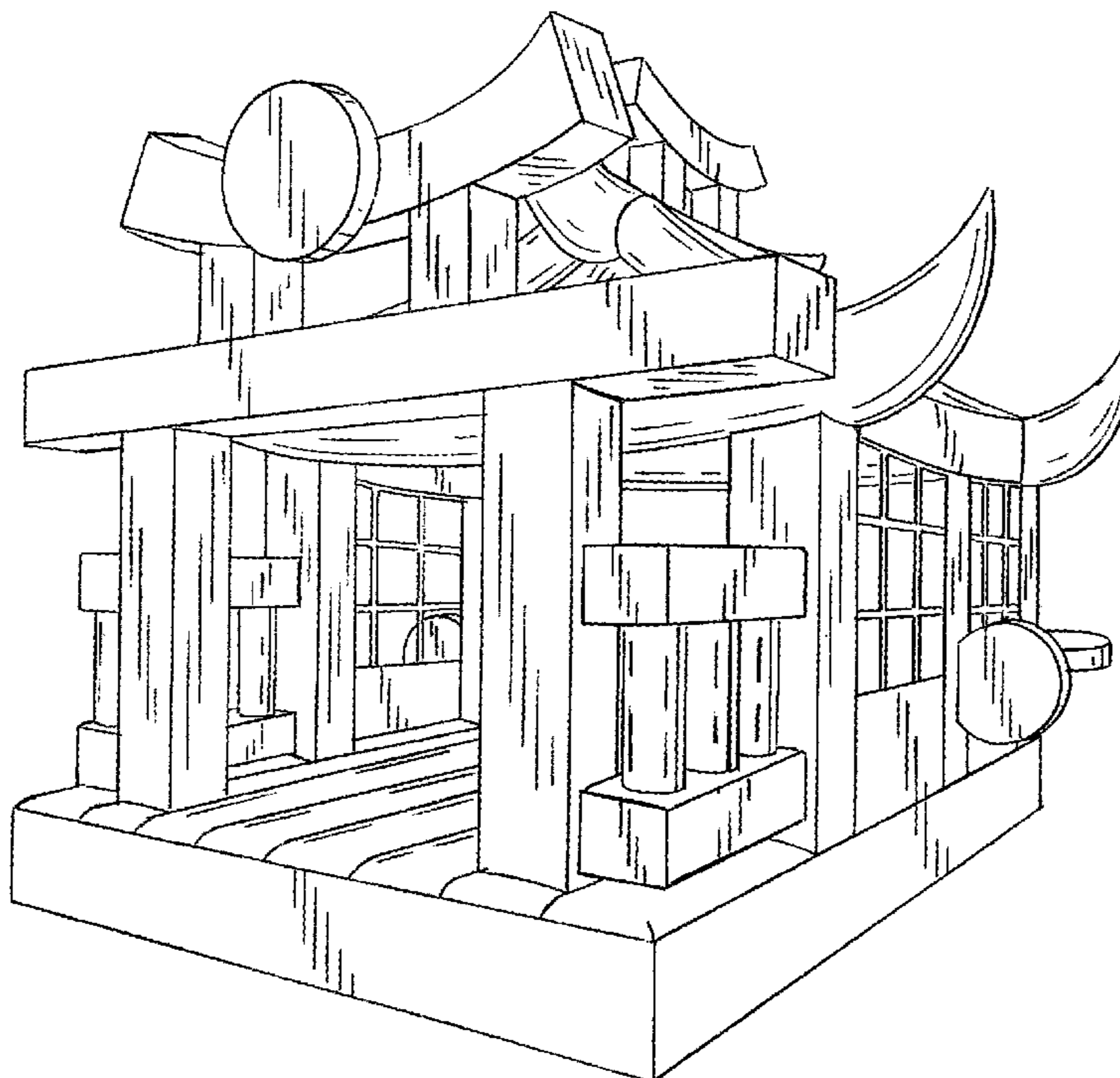
FIG. 4 is a side view of the inflatable dojo training facility showing my new design;

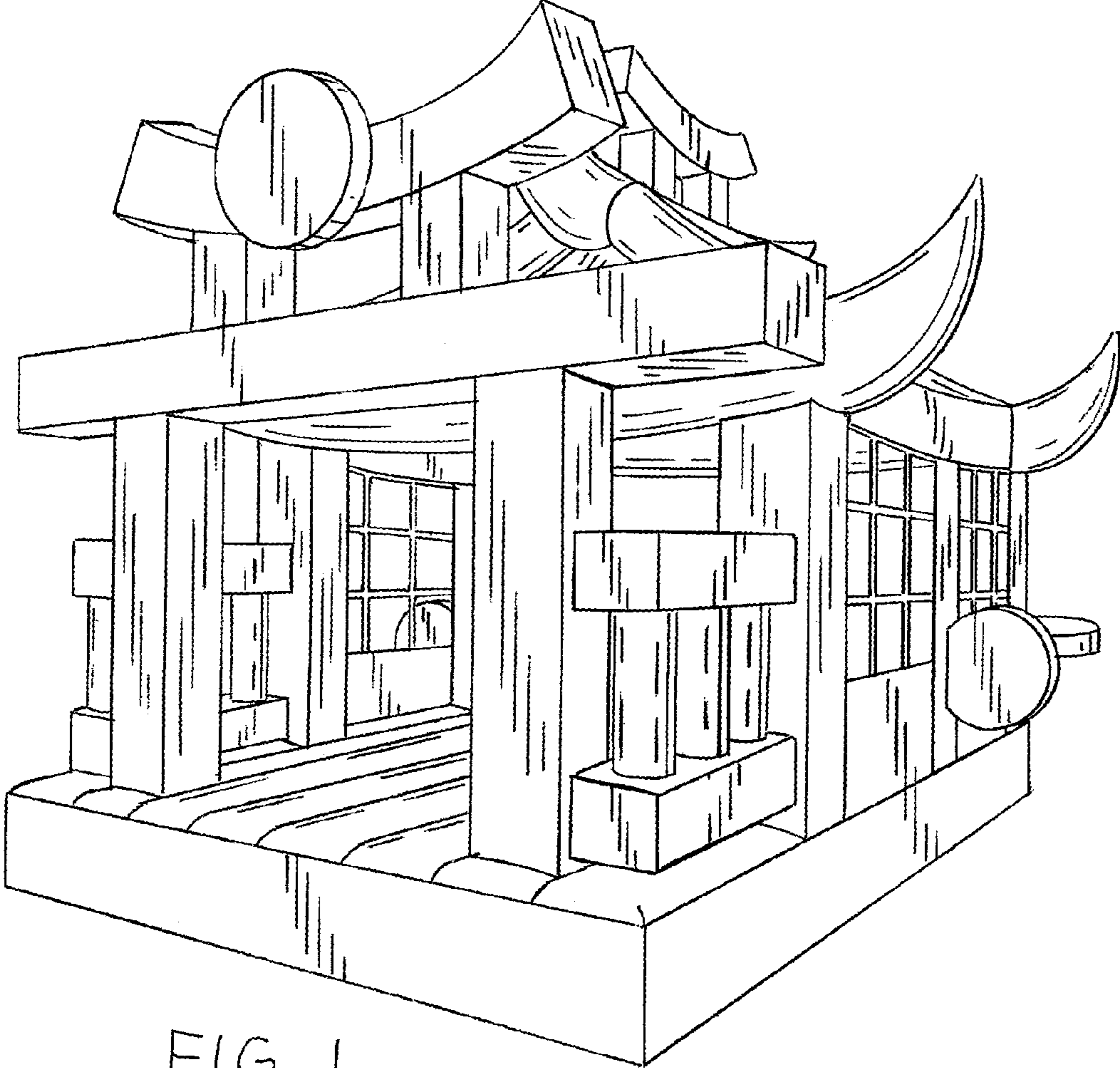

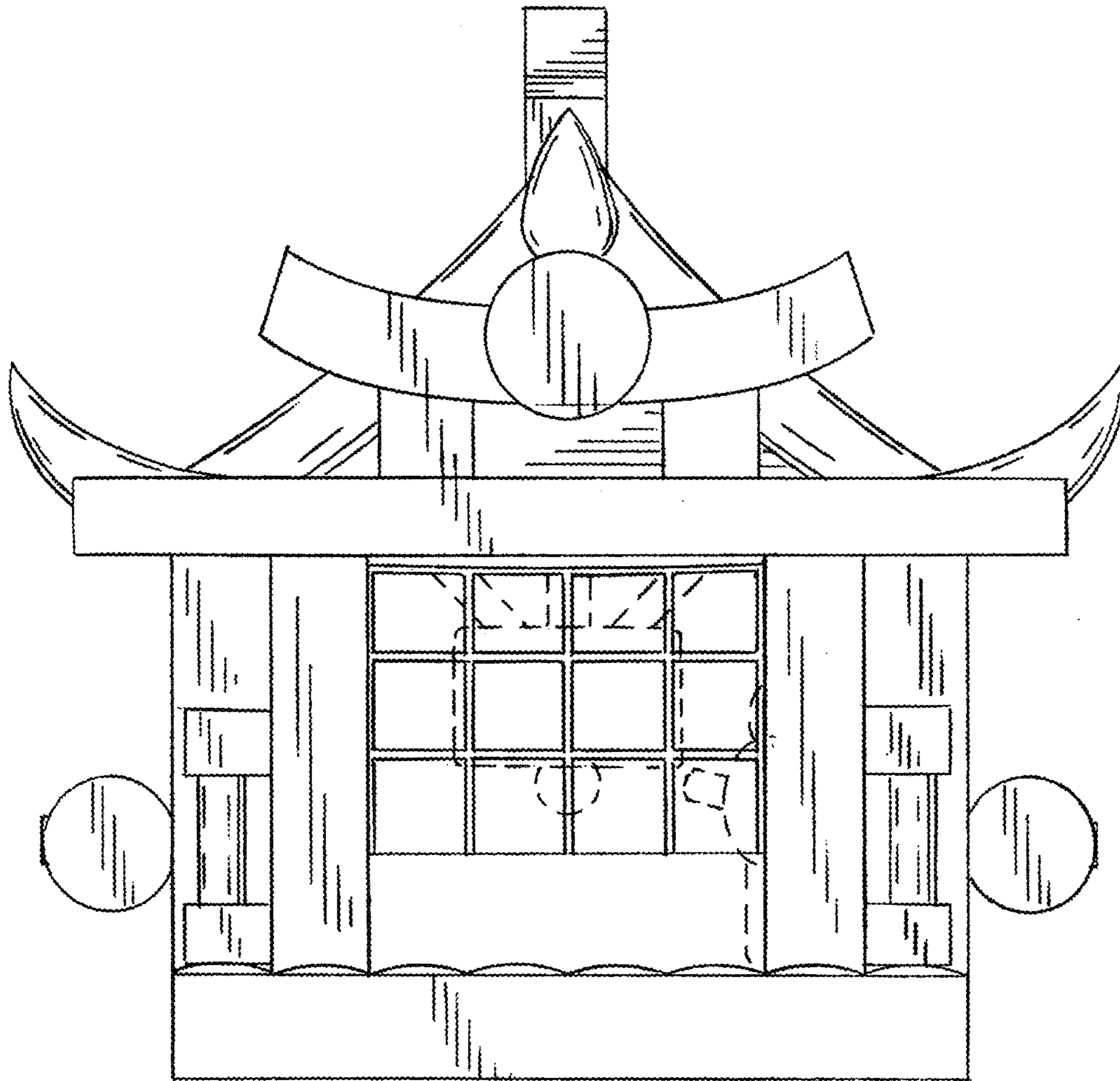

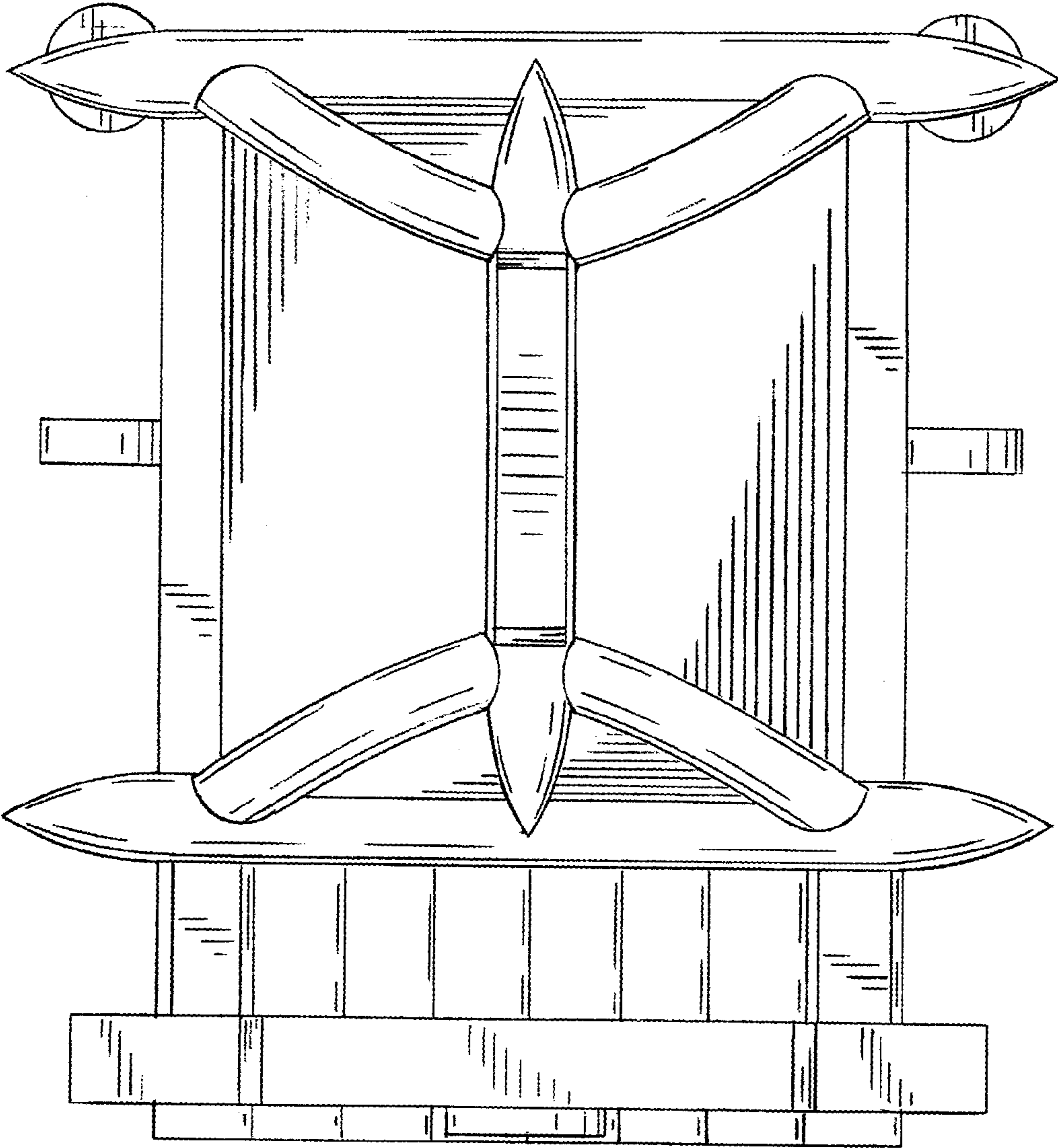

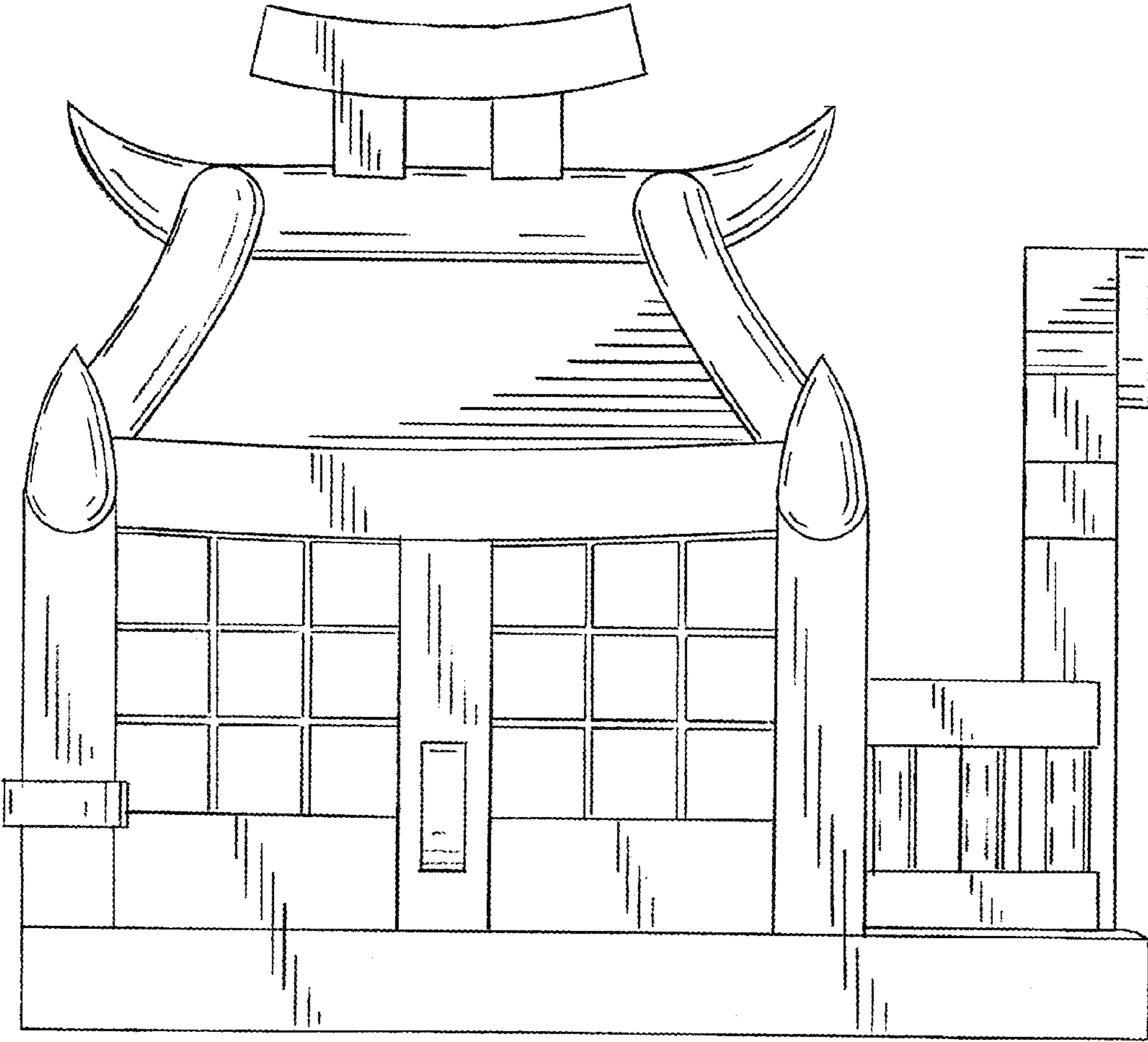

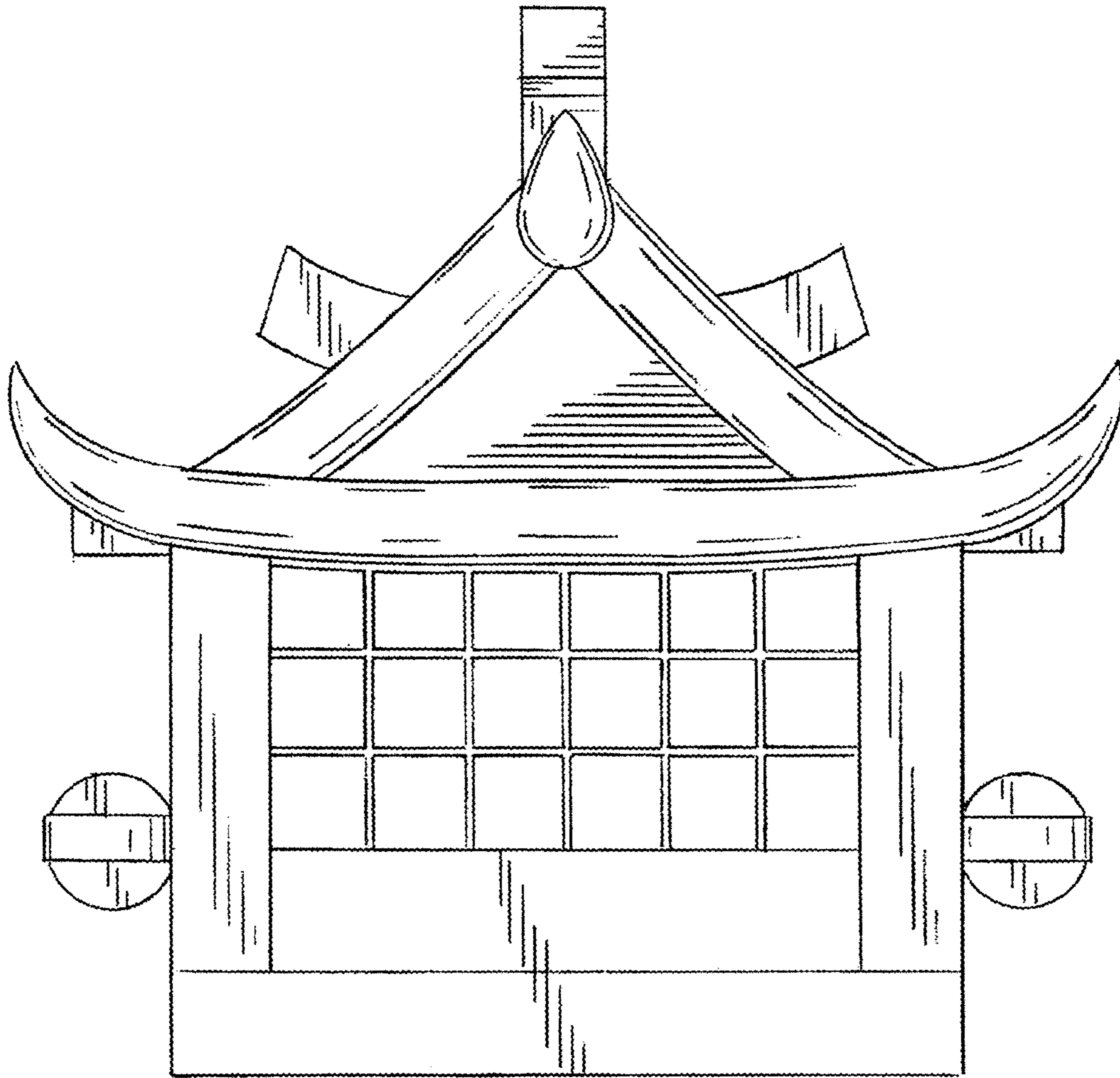

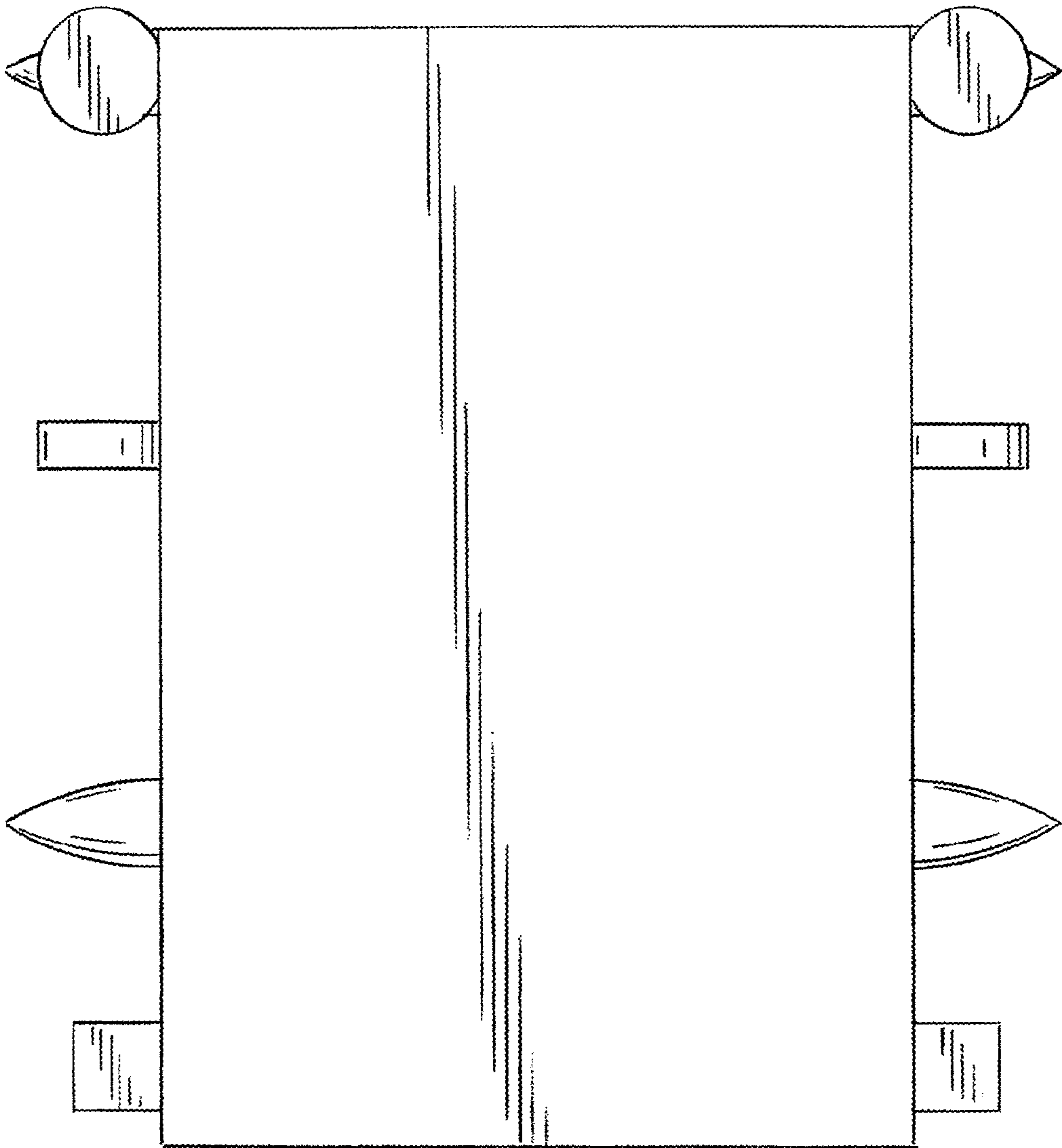
