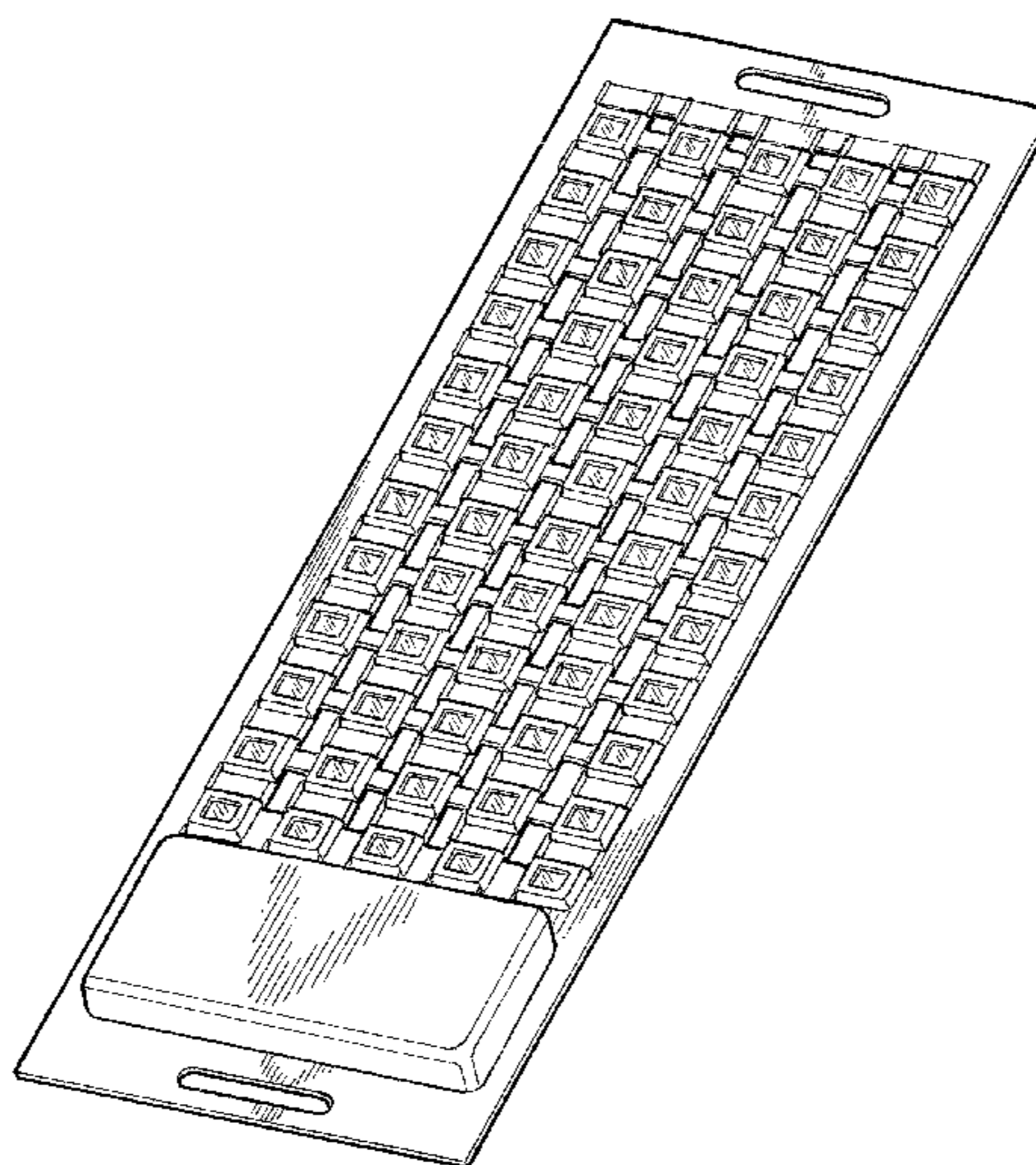
(57) **CLAIM**

The ornamental design for an LED light therapy tape, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of an LED light therapy tape;  
 FIG. 2 is a top plan view of an embodiment thereof;  
 FIG. 3 is a left side elevation view of an embodiment thereof;  
 FIG. 4 is a right side elevation view of an embodiment thereof; and,  
 FIG. 5 is a bottom plan view of an embodiment thereof.

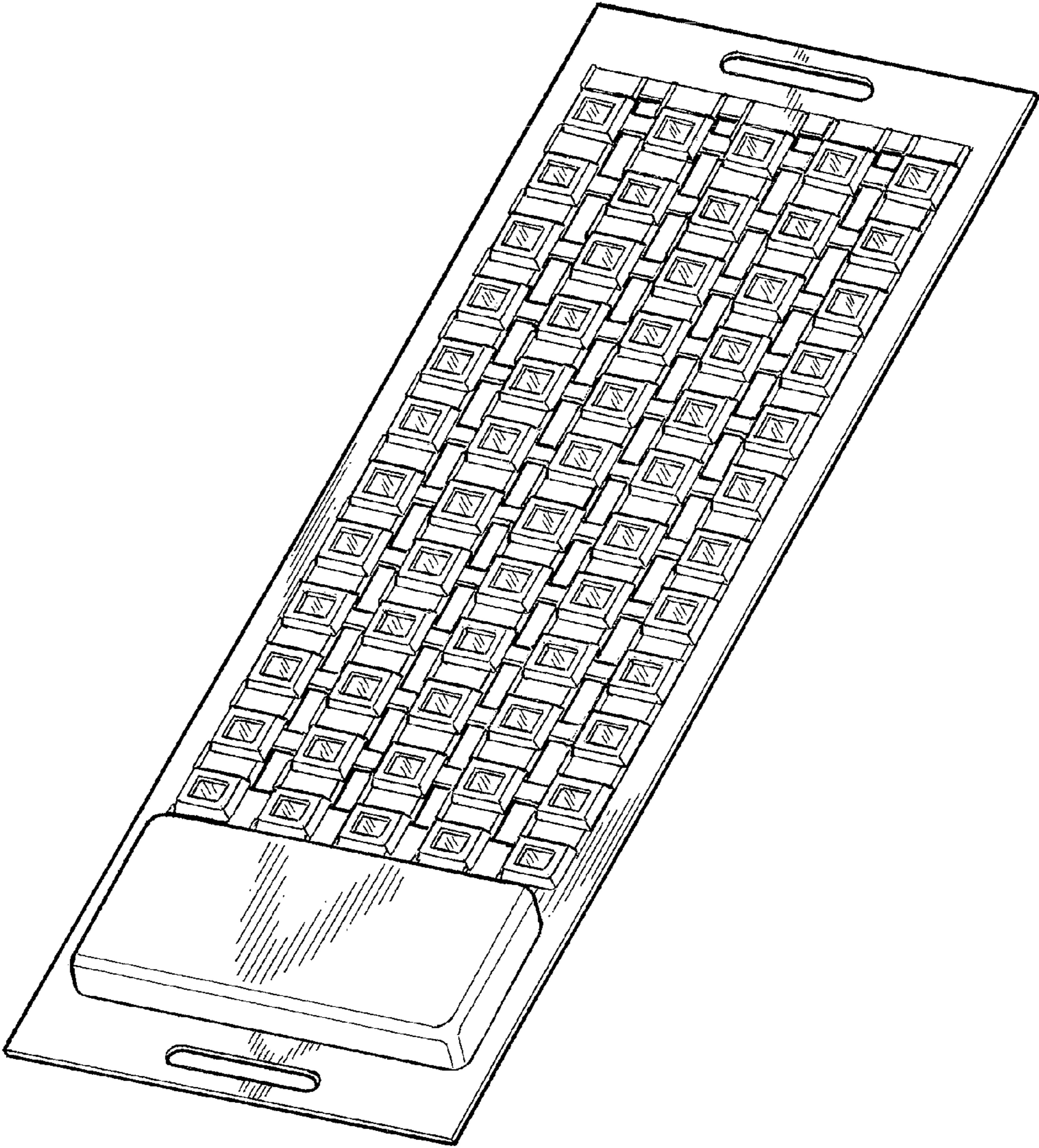

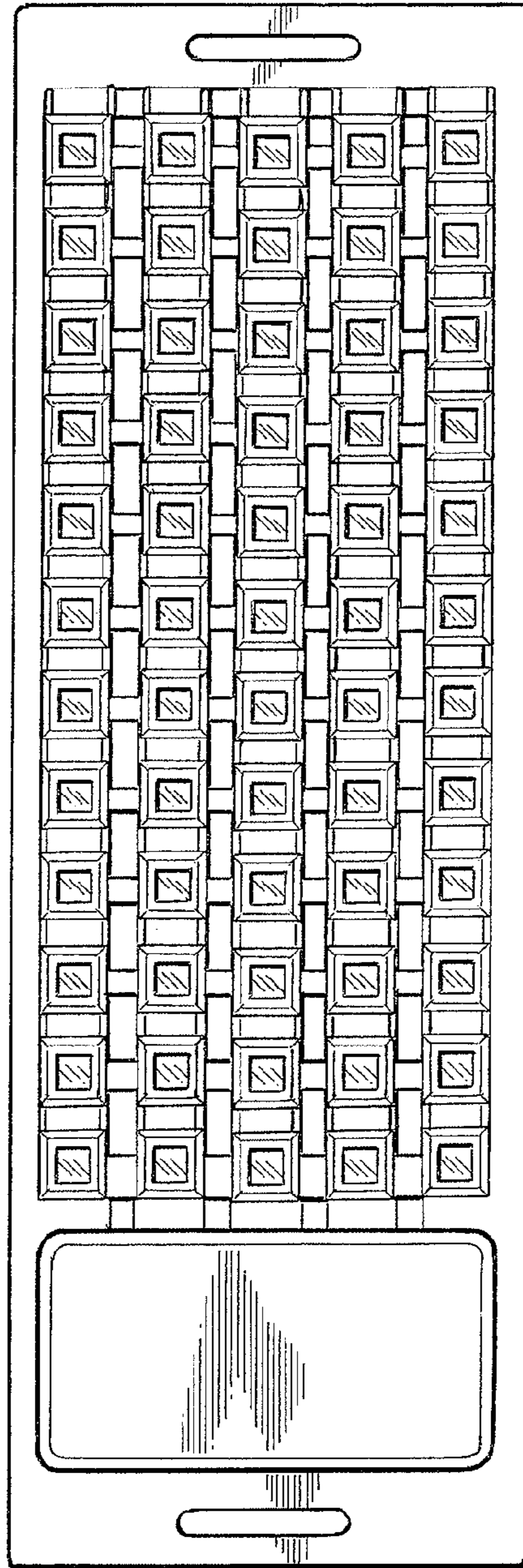

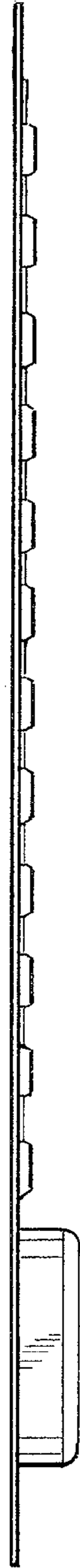

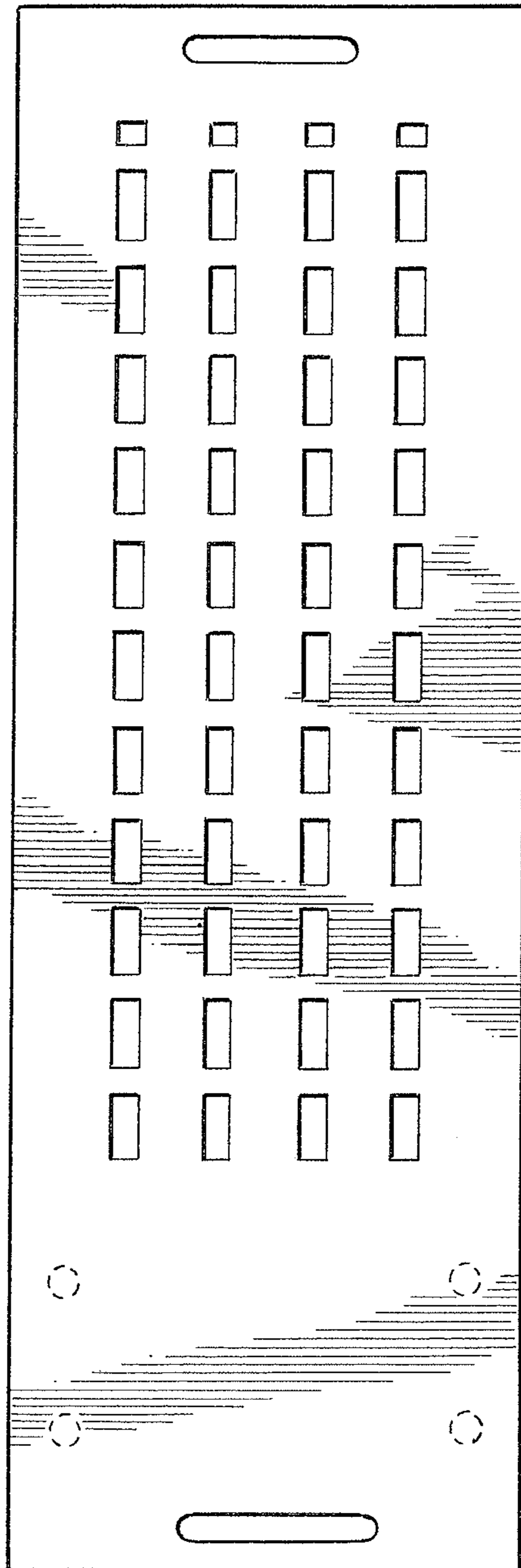
