(57) **CLAIM**

The ornamental design for a mounting bracket for supporting a luminaire, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a mounting bracket for supporting a luminaire;

FIG. 2 is an elevation view of the mounting bracket for supporting a luminaire of FIG. 1;

FIG. 3 is a side elevation view of the mounting bracket for supporting a luminaire of FIG. 1;

FIG. 4 is a side elevation view of the mounting bracket for supporting a luminaire of FIG. 1, opposite the side elevation view of FIG. 3;

FIG. 5 is a plan view of the mounting bracket for supporting a luminaire of FIG. 1;

FIG. 6 is a plan view of the mounting bracket for supporting a luminaire of FIG. 1, opposite the plan view of FIG. 5;

FIG. 7 is a perspective view of a mounting bracket for supporting a luminaire according to another embodiment;

FIG. 8 is an elevation view of the mounting bracket for supporting a luminaire of FIG. 7;

FIG. 9 is a side elevation view of the mounting bracket for supporting a luminaire of FIG. 7;

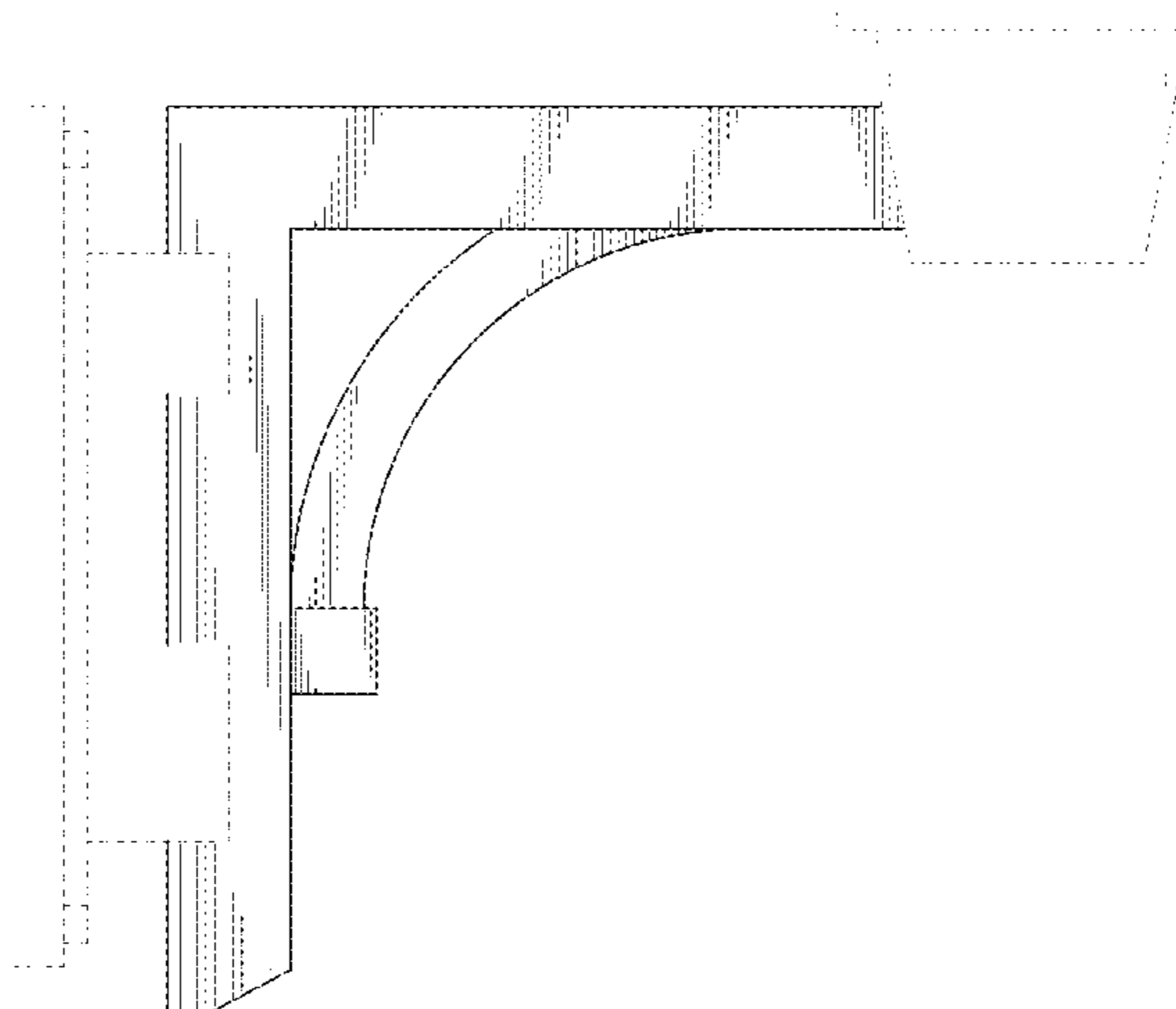
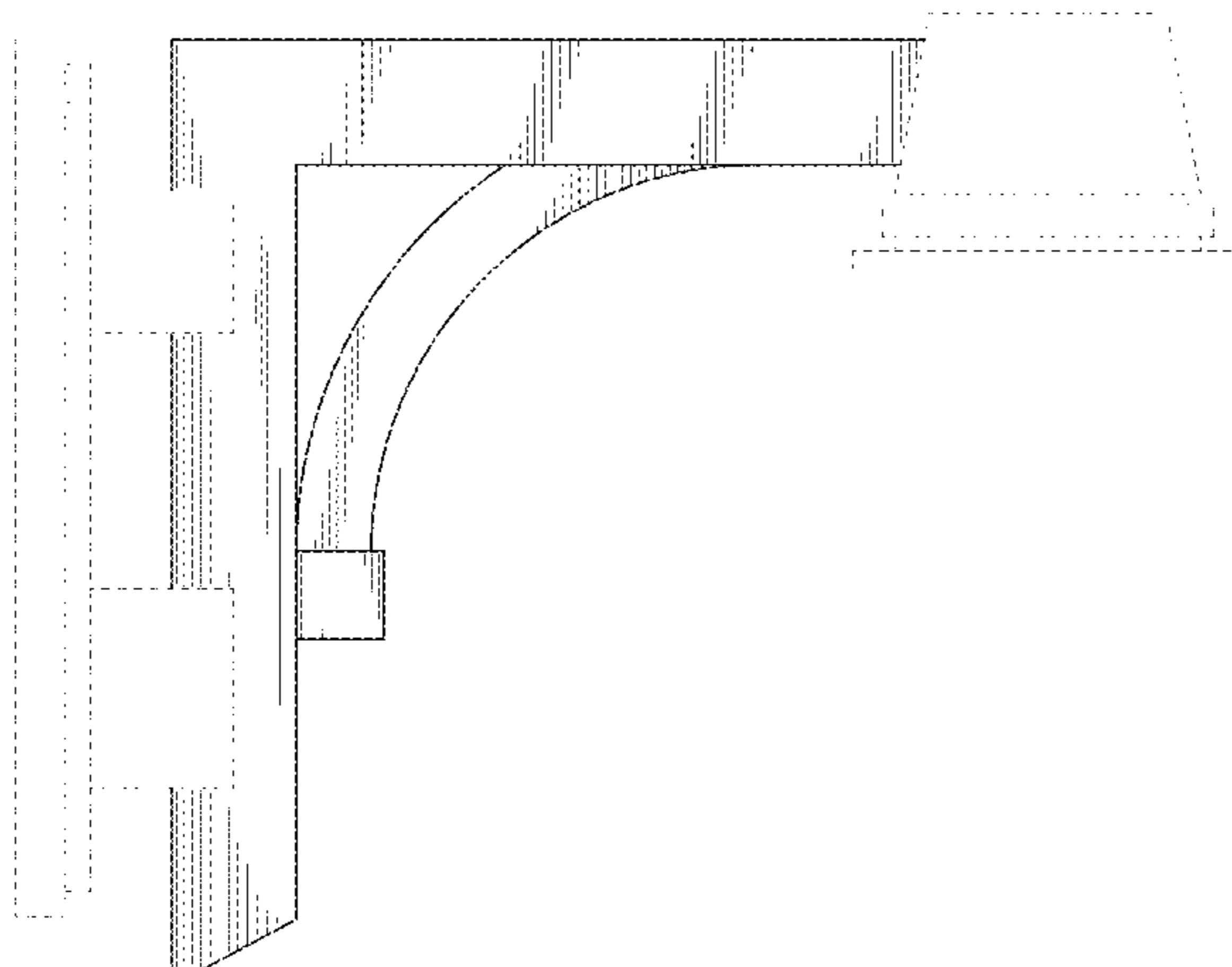
FIG. 10 is a side elevation view of the mounting bracket for supporting a luminaire of FIG. 7, opposite the side elevation view of FIG. 9;

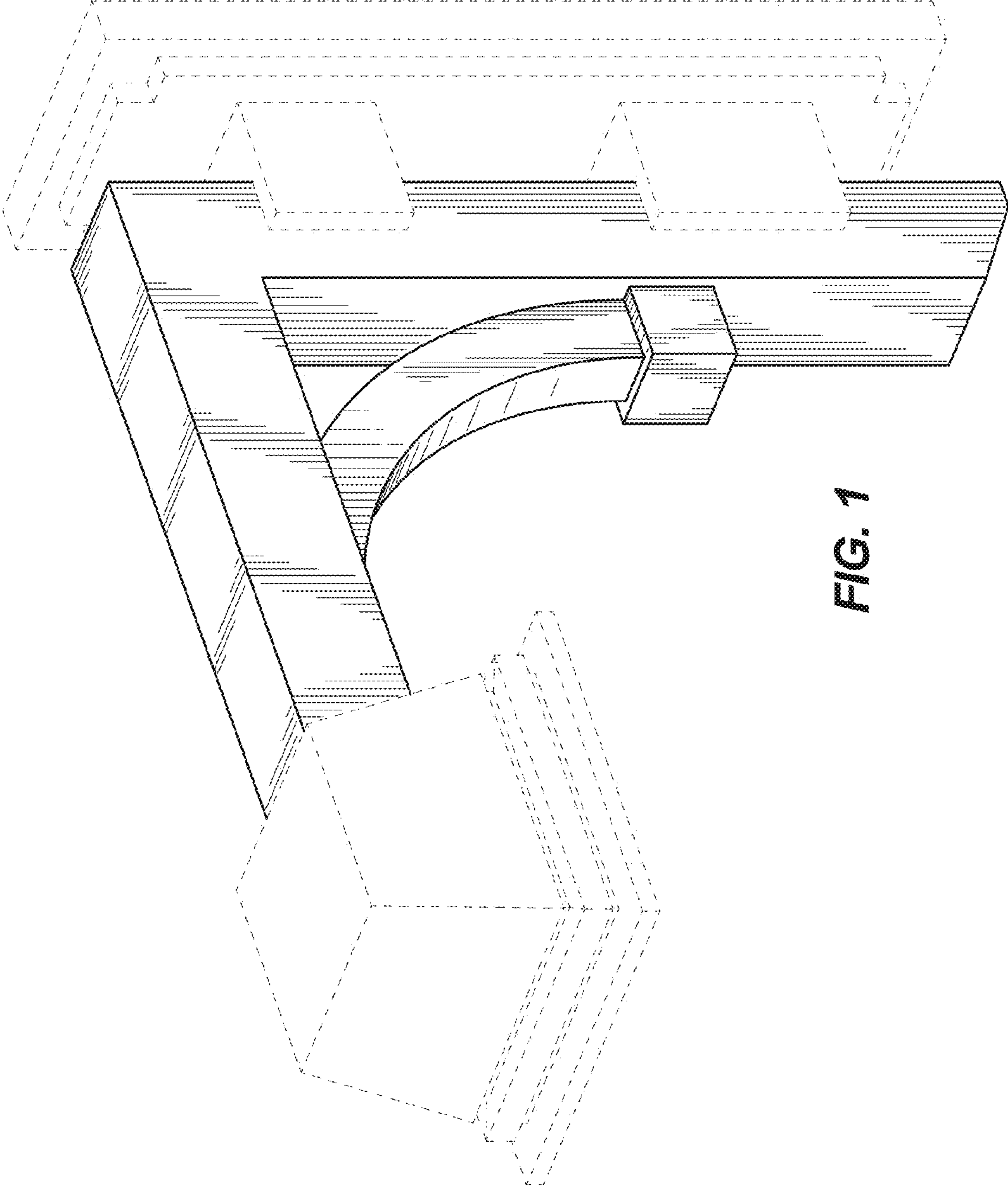
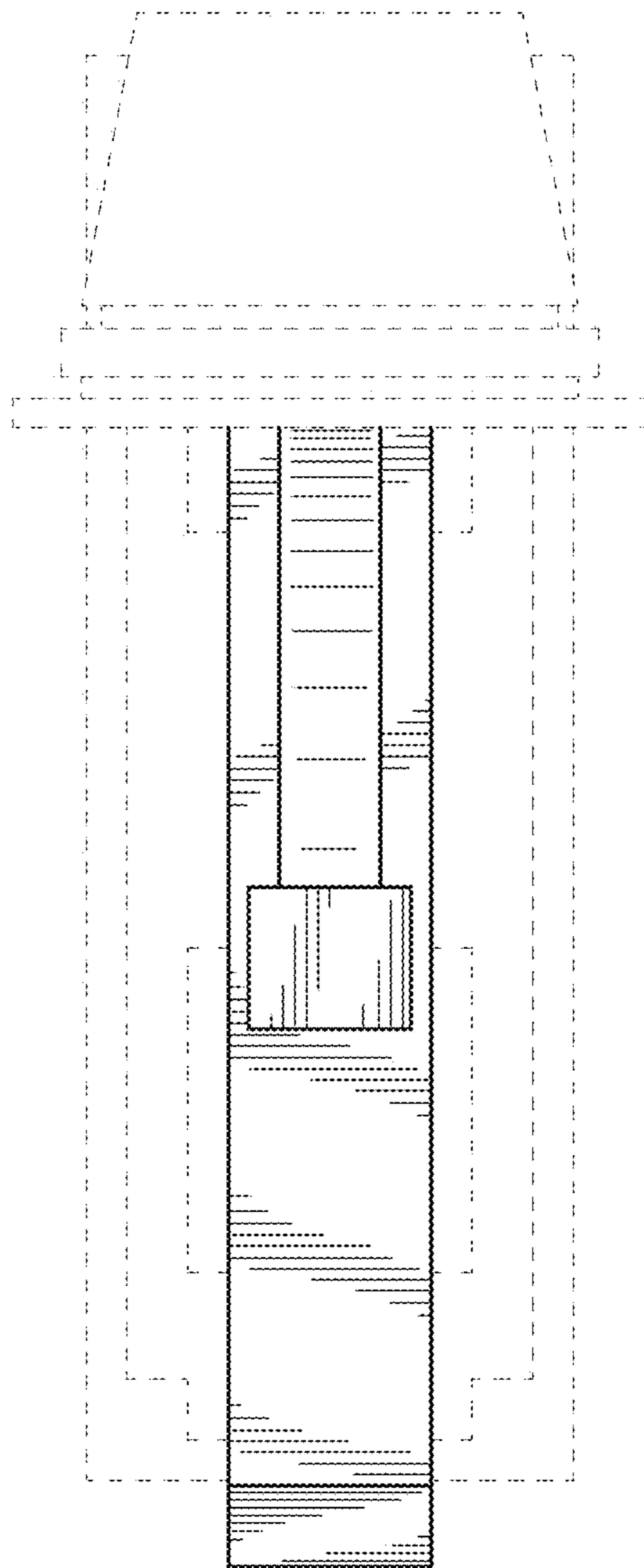
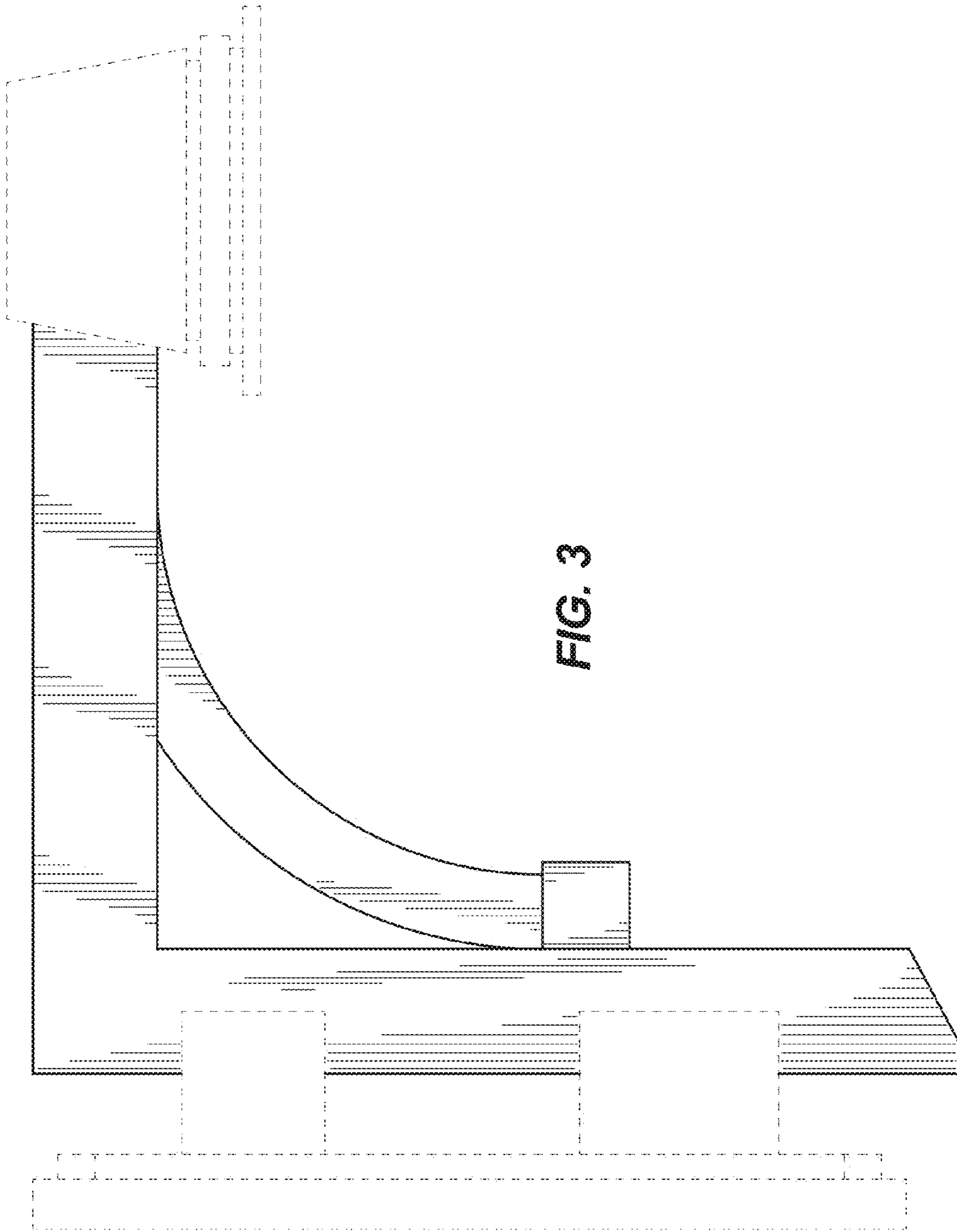

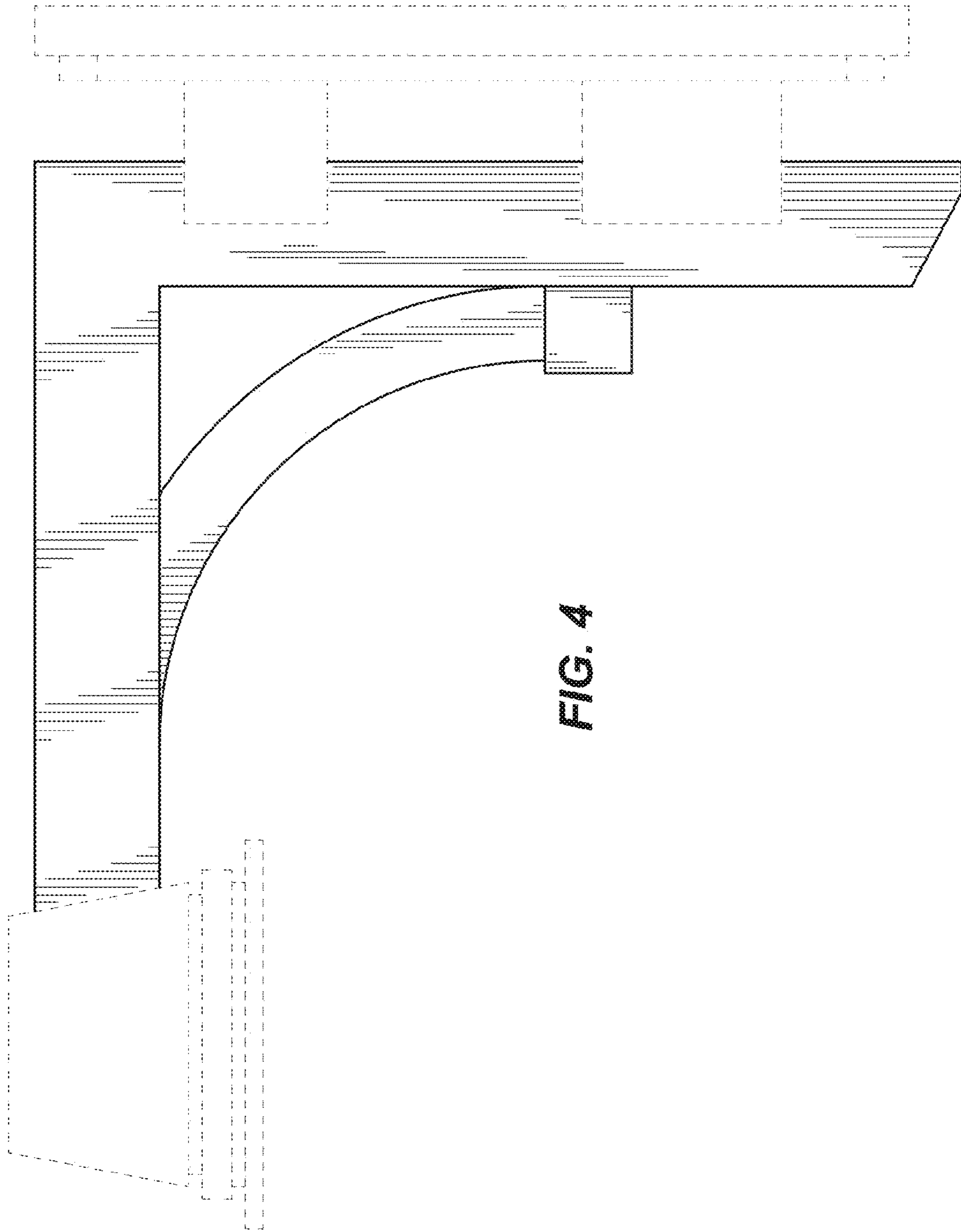
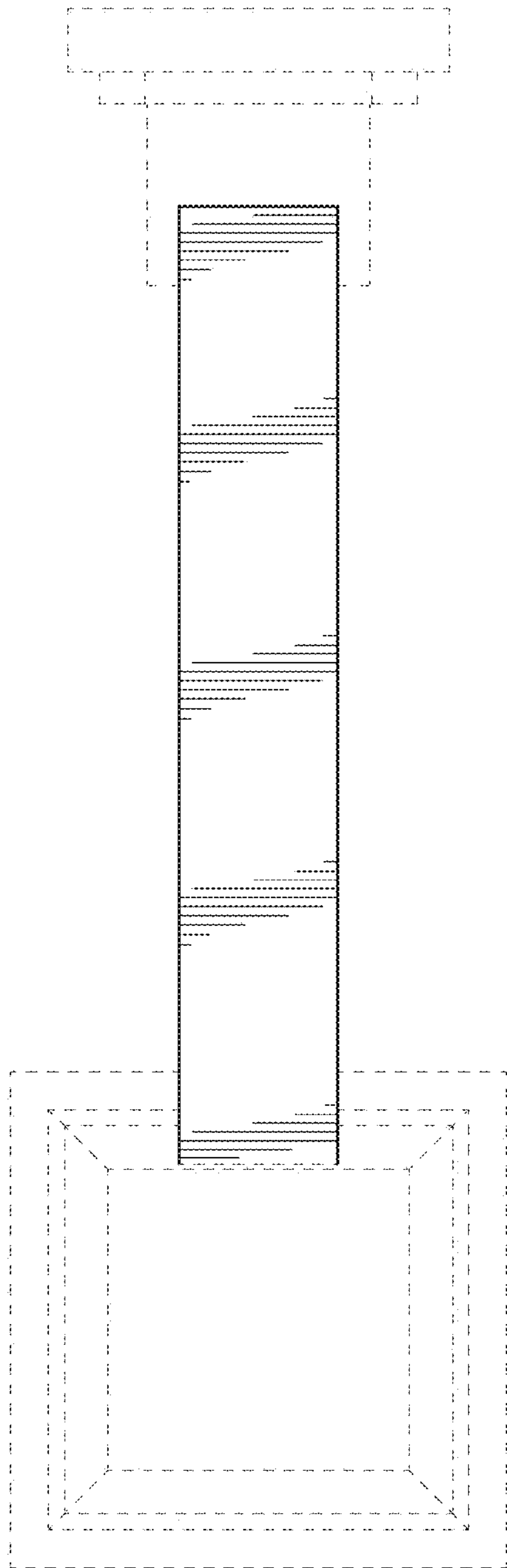
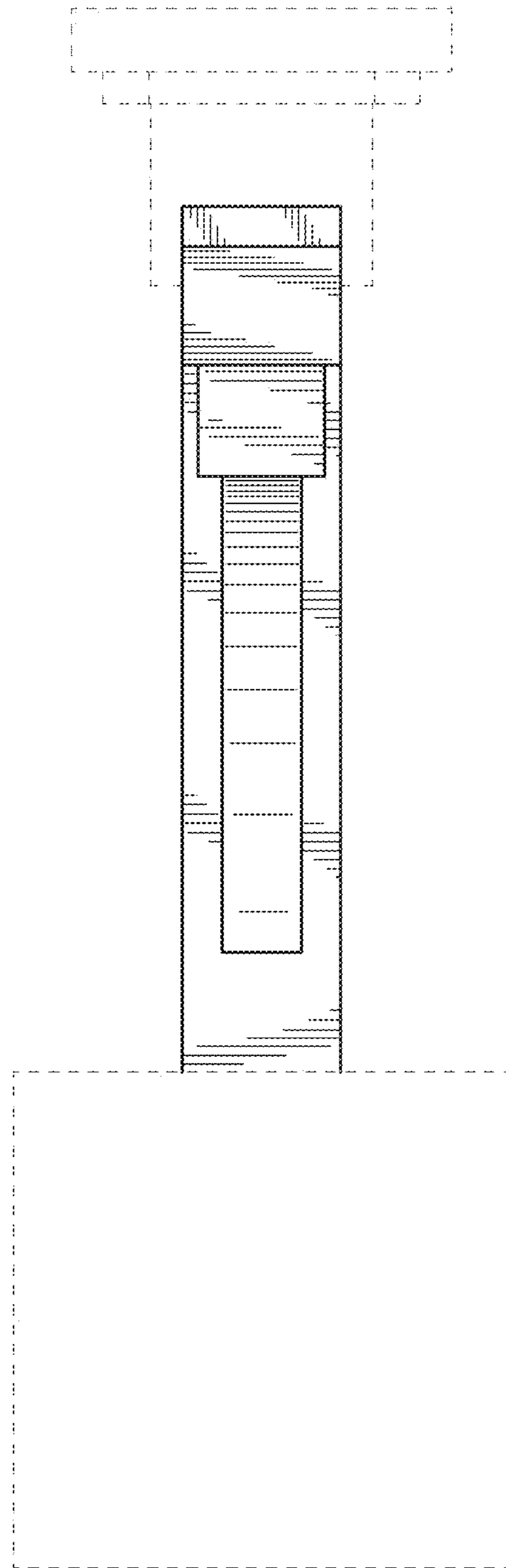

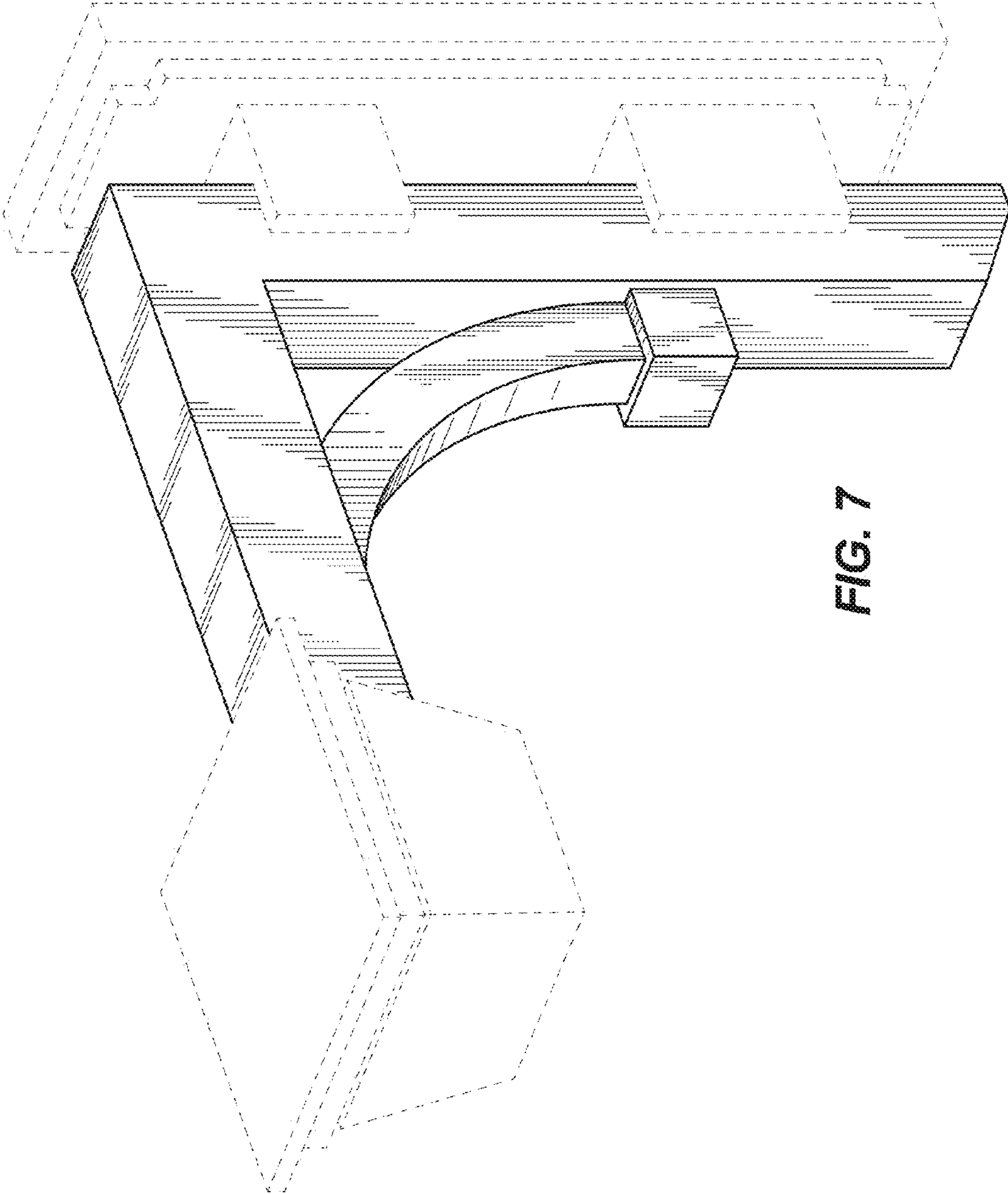
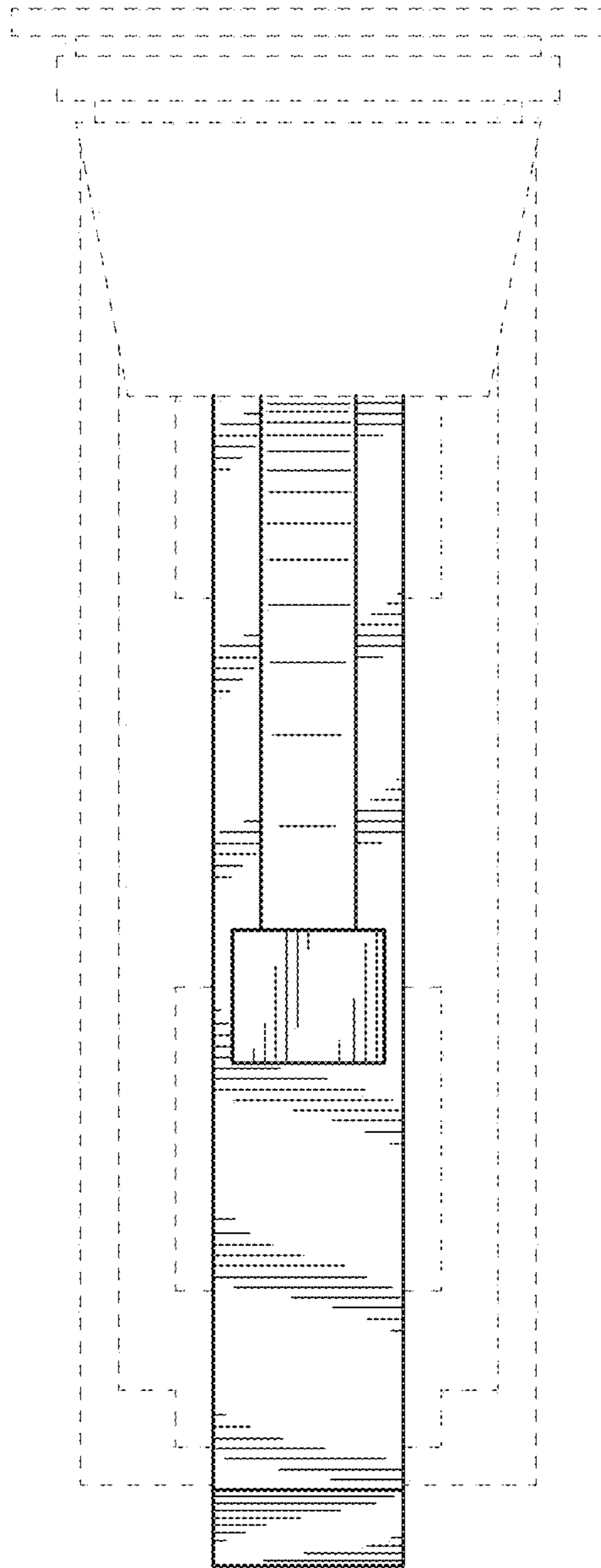

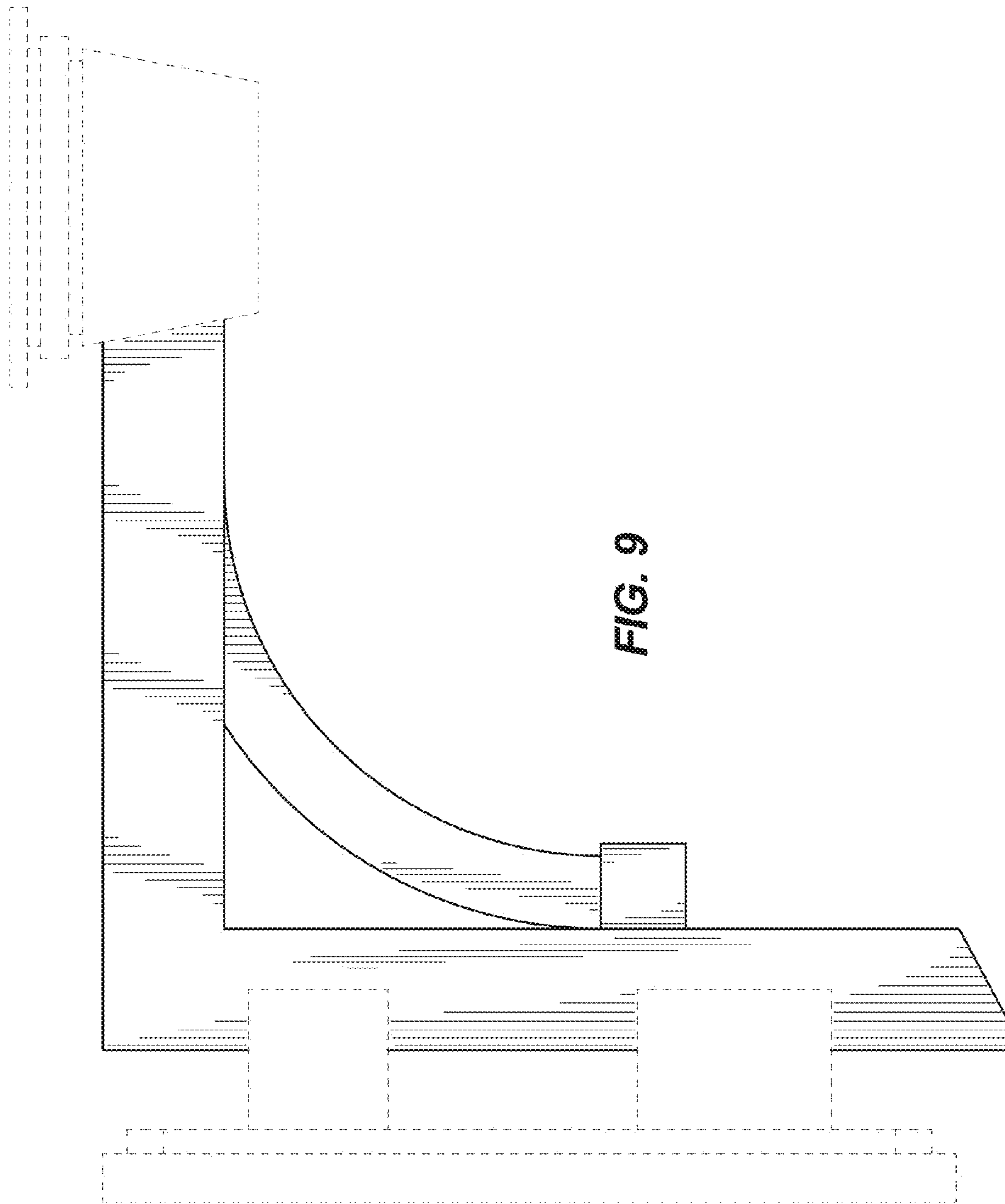

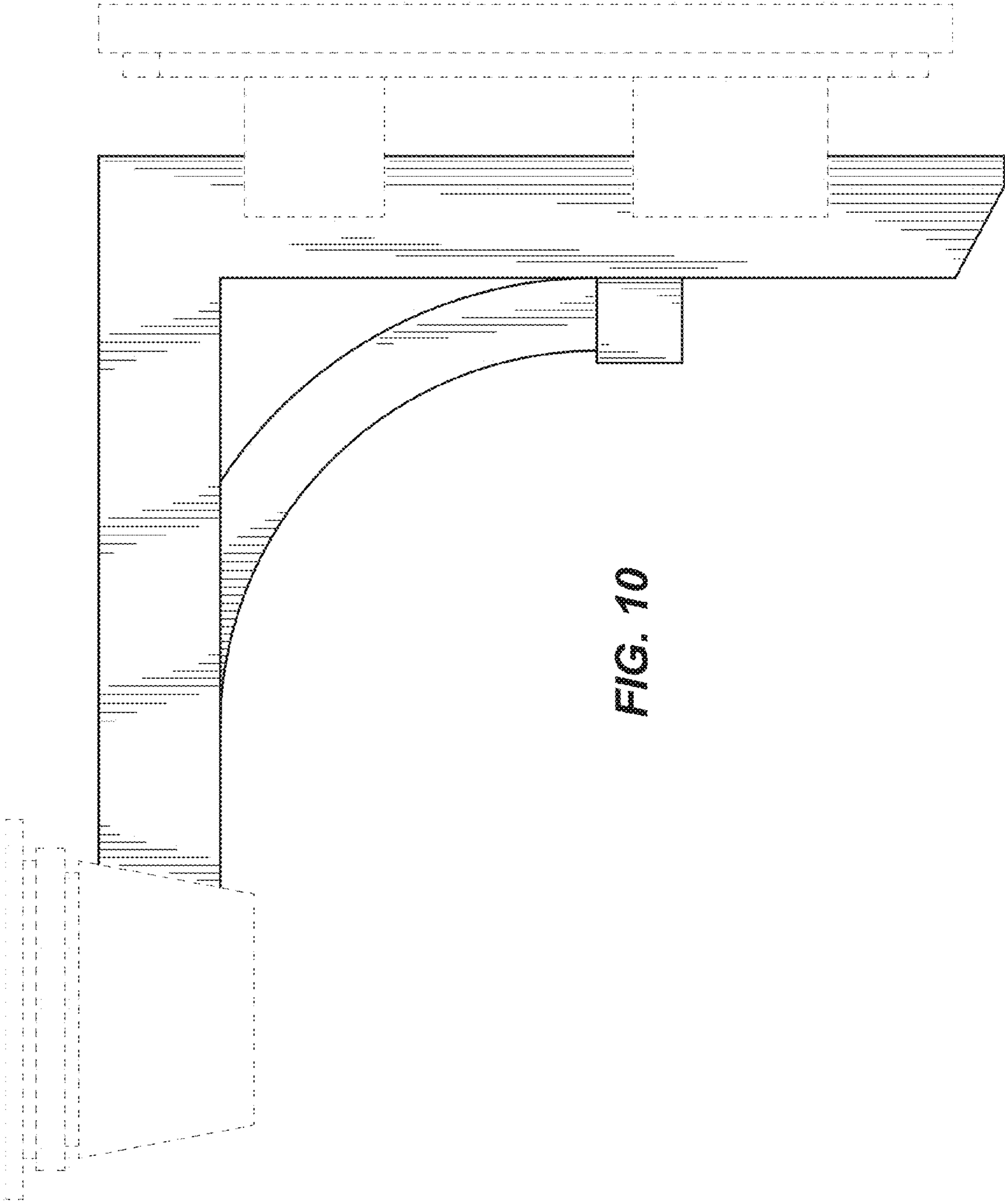
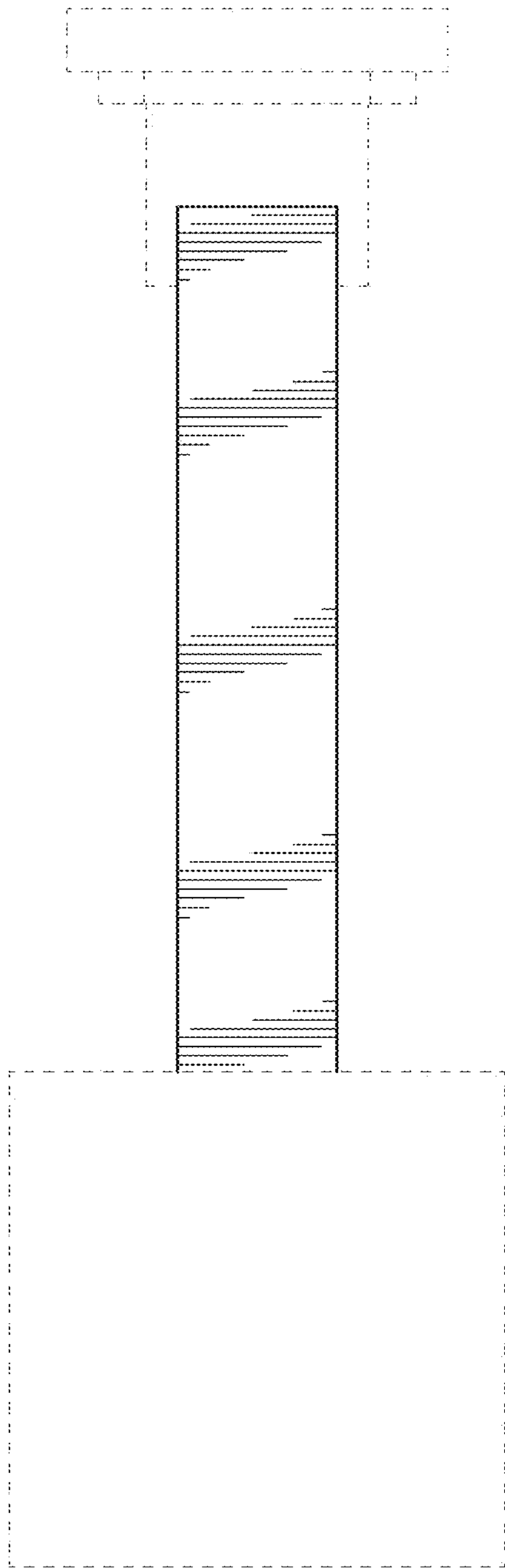
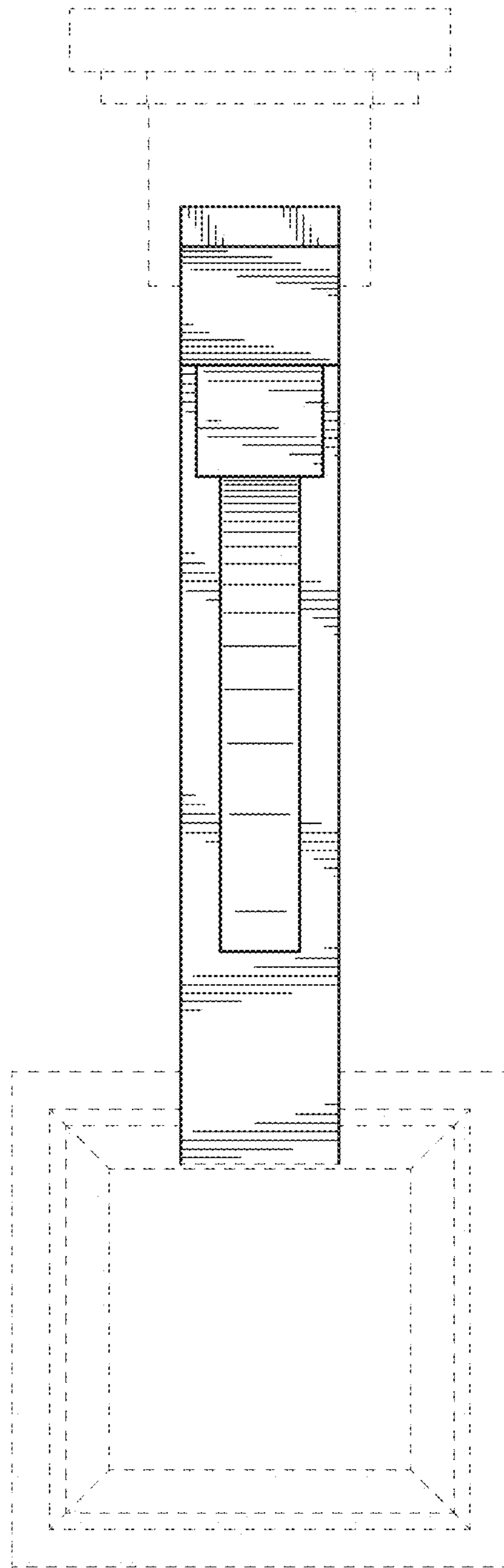
