DESCRIPTION

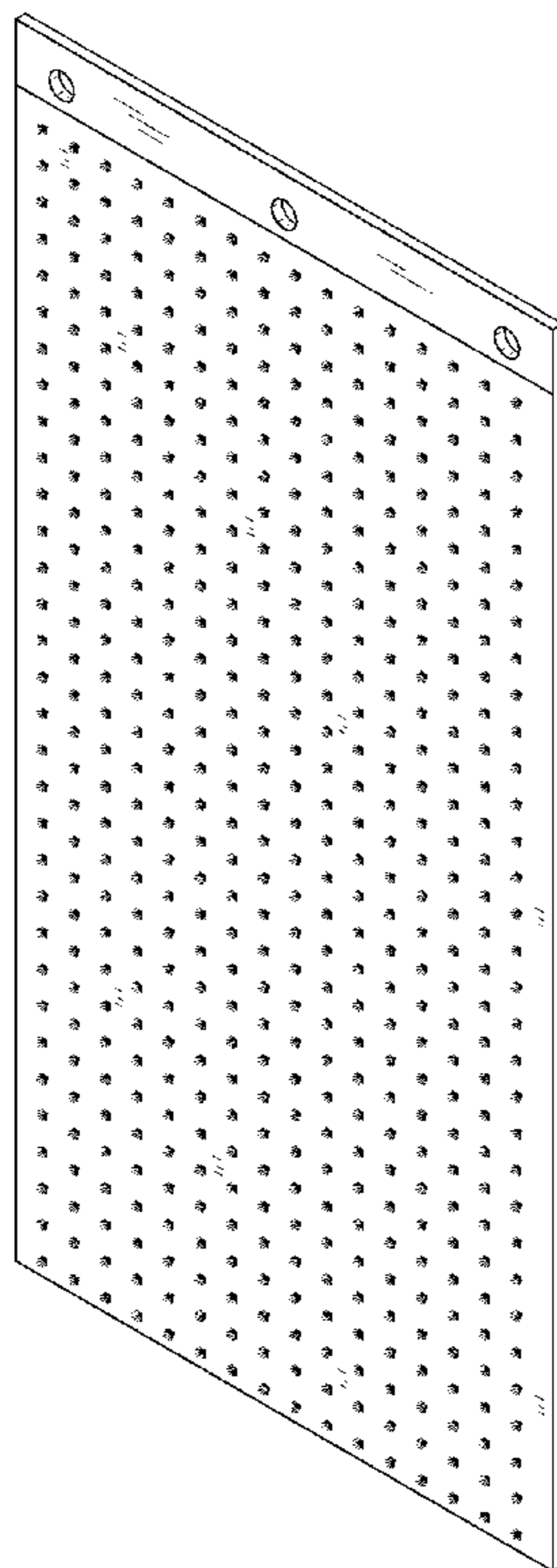
FIG. 1 is a front view of a back scrubber showing my new design;

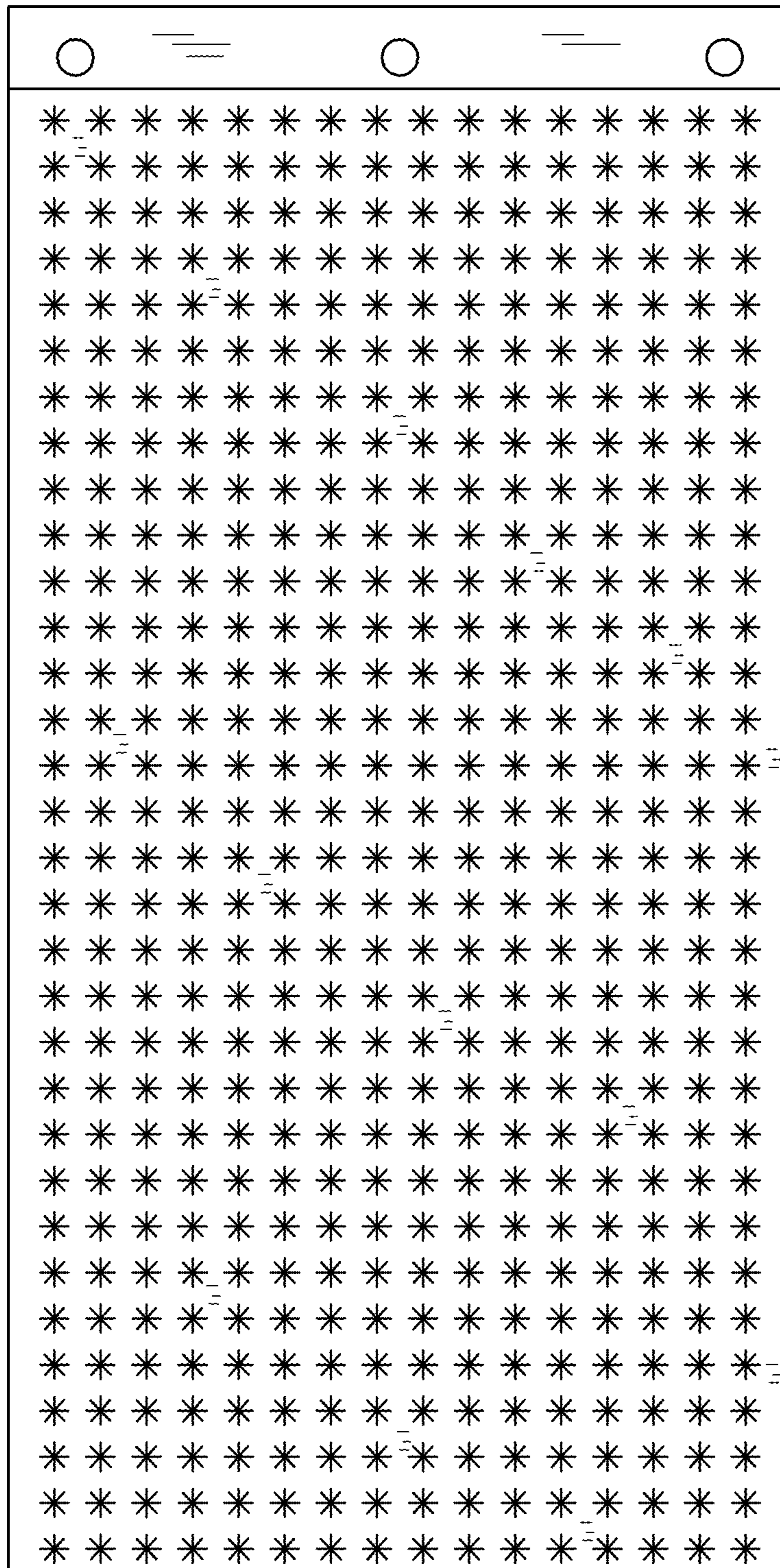

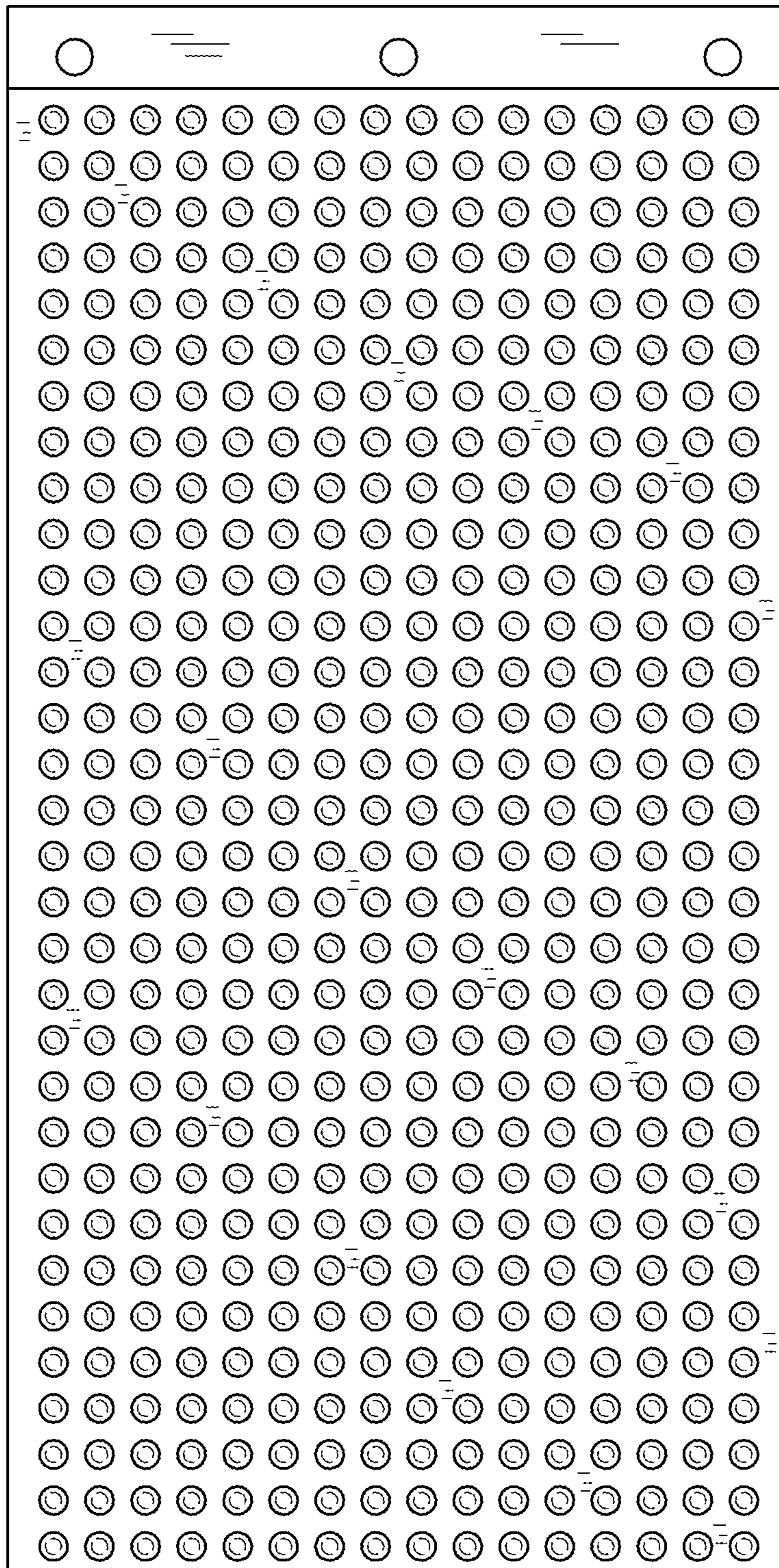

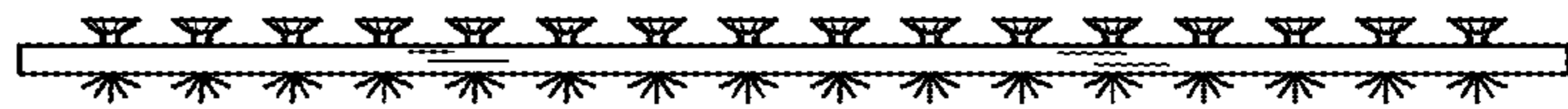

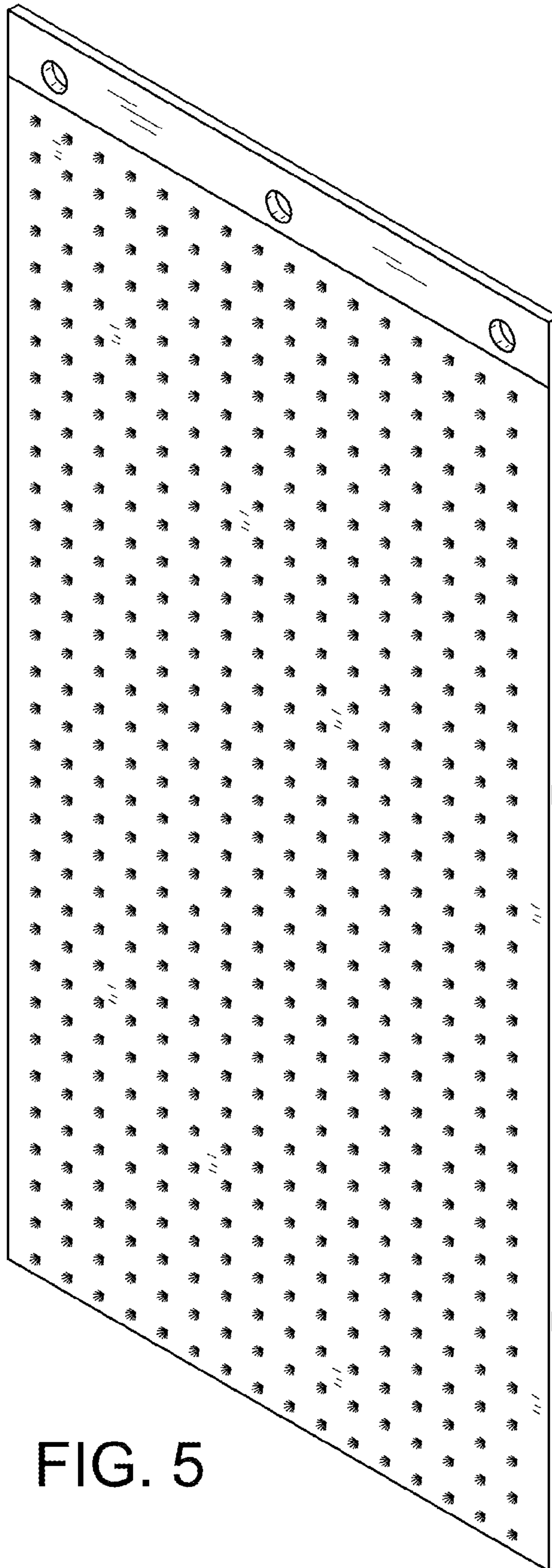
