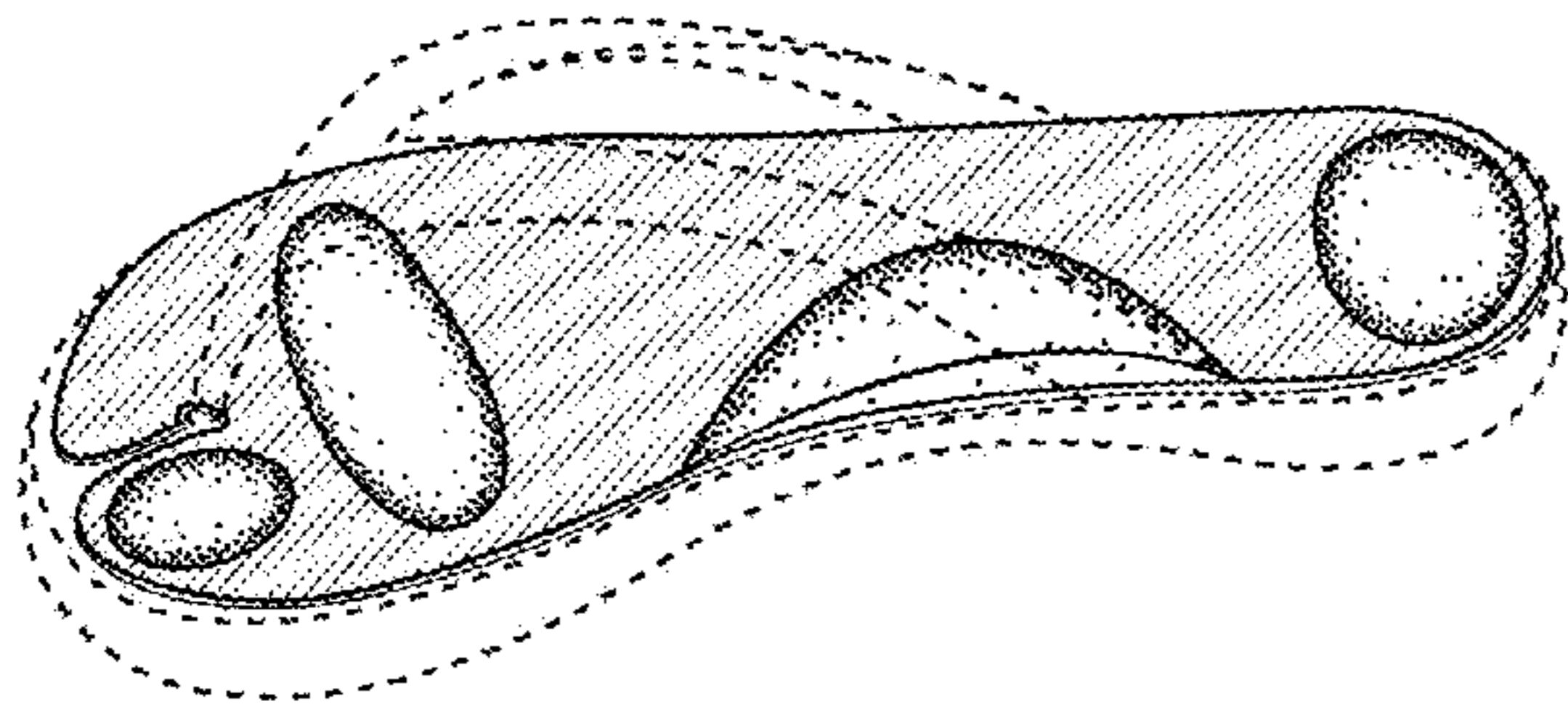

(57) **CLAIM**

The ornamental design for a replaceable arch-supportive sandal insole, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a first embodiment of a replaceable arch-supportive sandal insole showing my new design, shown in a used condition with a thong sandal shown in broken lines;

FIG. 2 is a right side view thereof, shown in a used condition with a thong sandal shown in broken lines, left side view being a mirror image thereof;

FIG. 3 is an isometric view of a second embodiment of a replaceable arch-supportive sandal insole showing my new design;

FIG. 4 is an isometric view of a third embodiment of a replaceable arch-supportive sandal insole showing my new design;

FIG. 5 is an isometric view of a fourth embodiment of a replaceable arch-supportive sandal insole showing my new design;

FIG. 6 is an isometric view of a fifth embodiment of a replaceable arch-supportive sandal insole showing my new design;

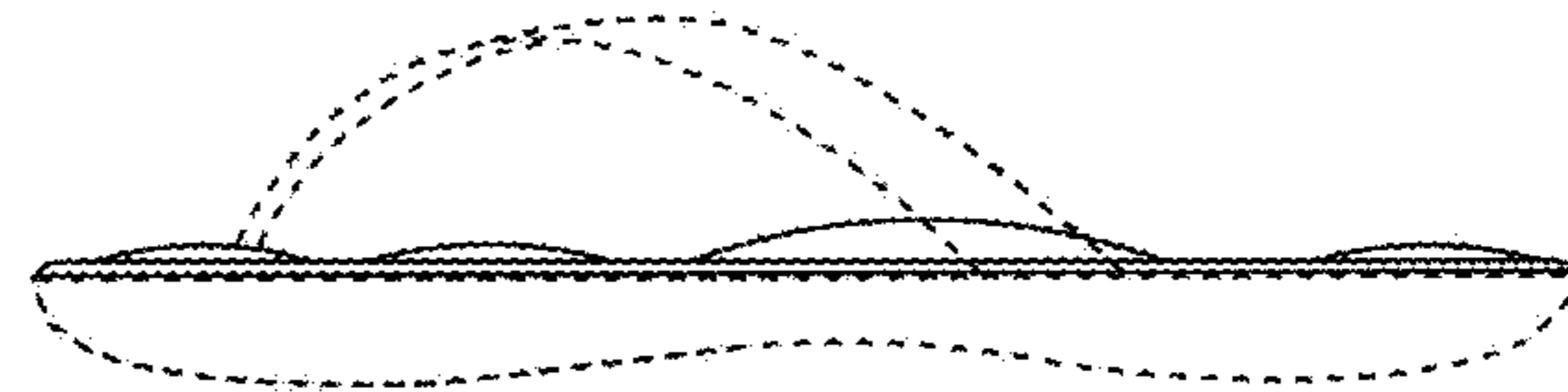
FIG. 7 is an isometric view of a sixth embodiment of a replaceable arch-supportive sandal insole showing my new design;

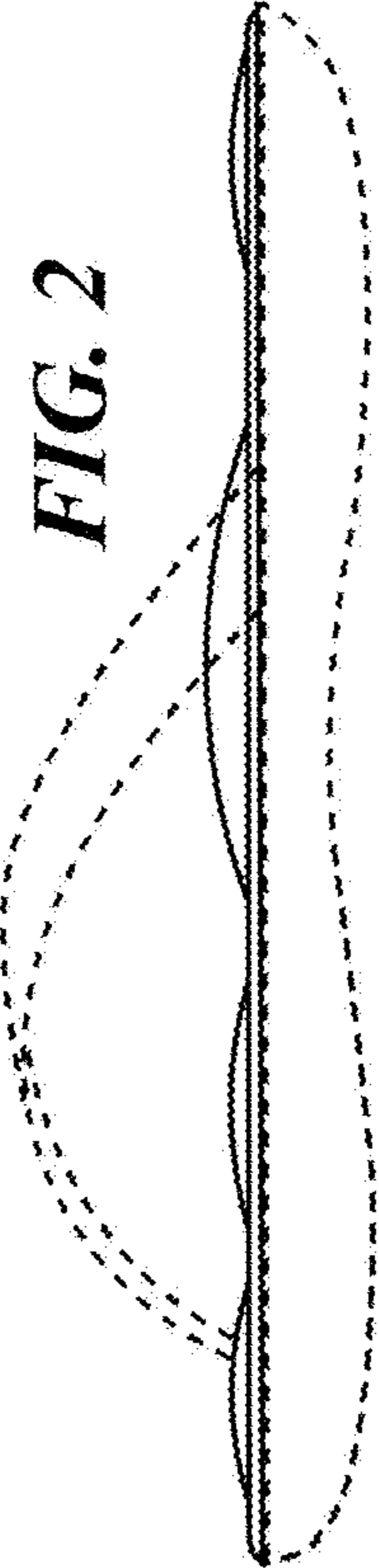
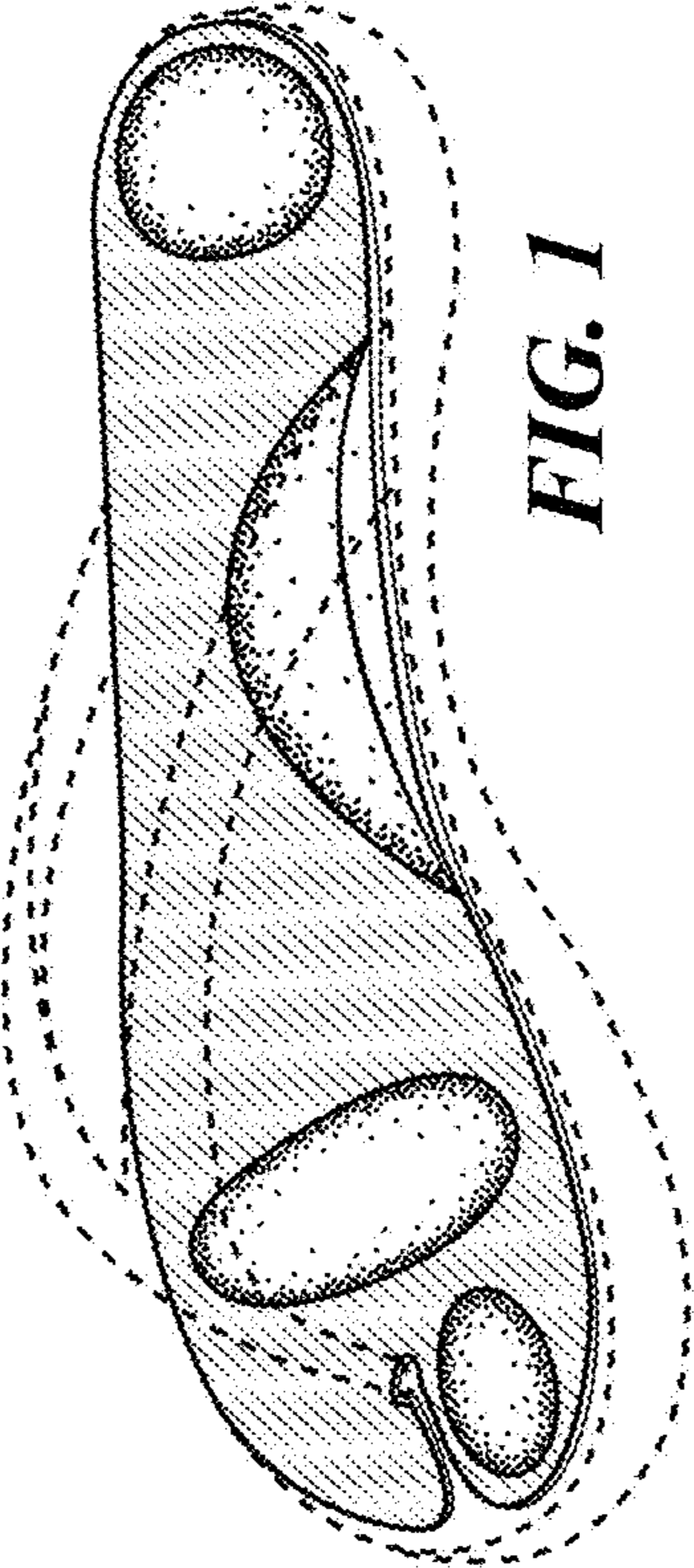

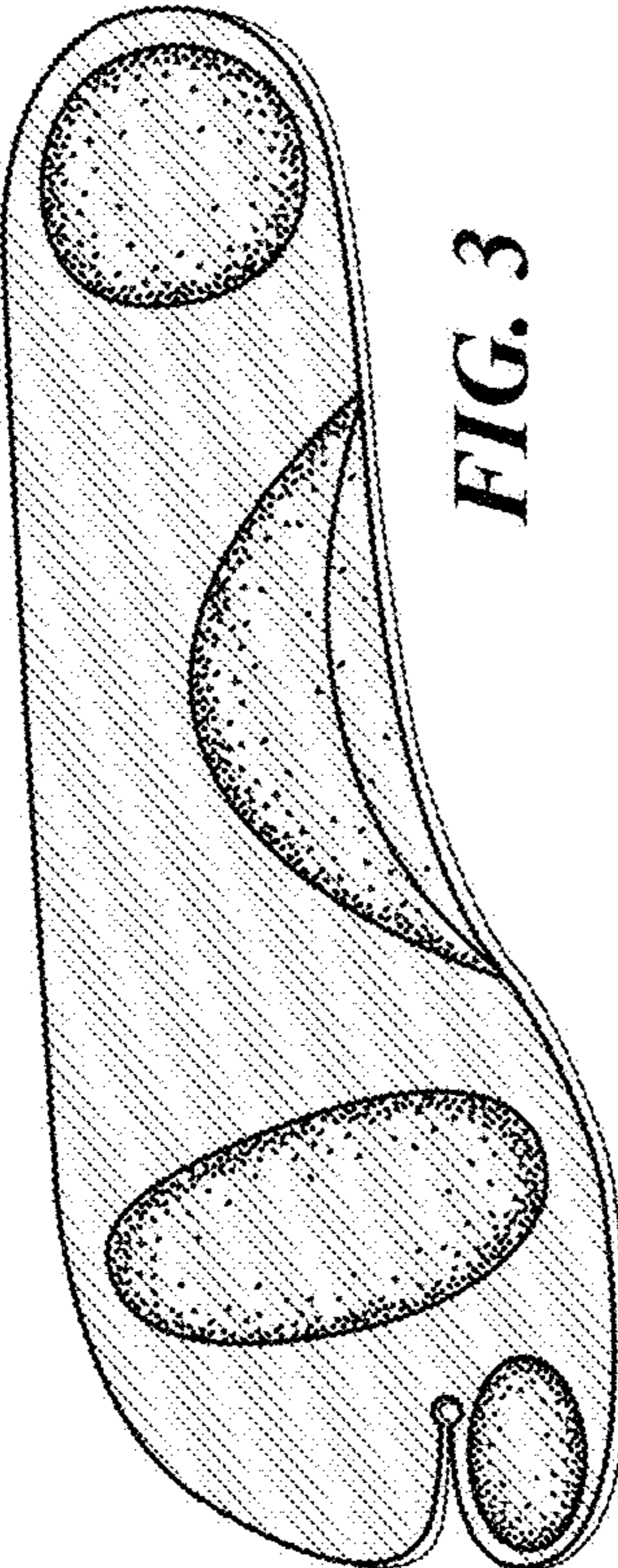
