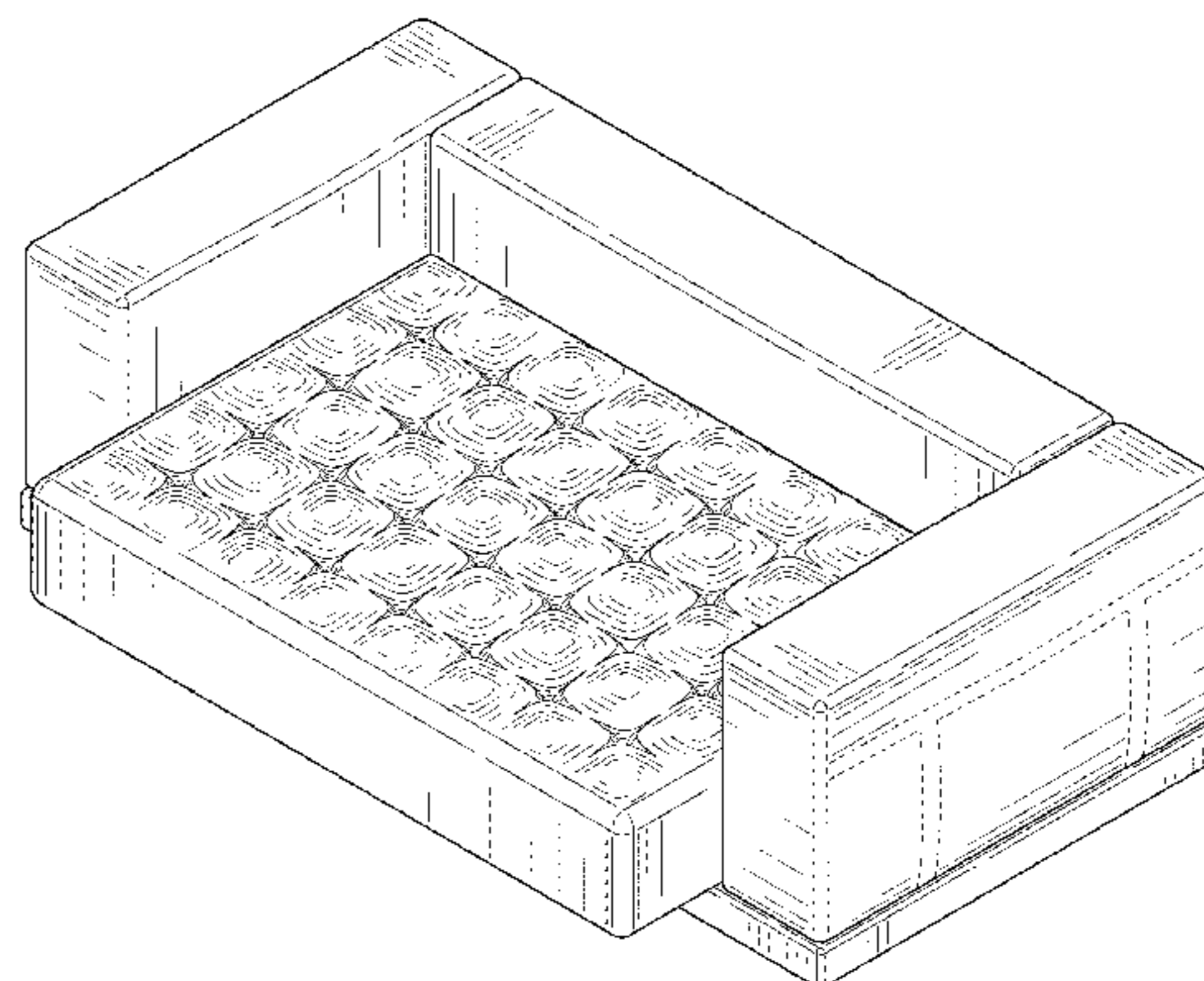
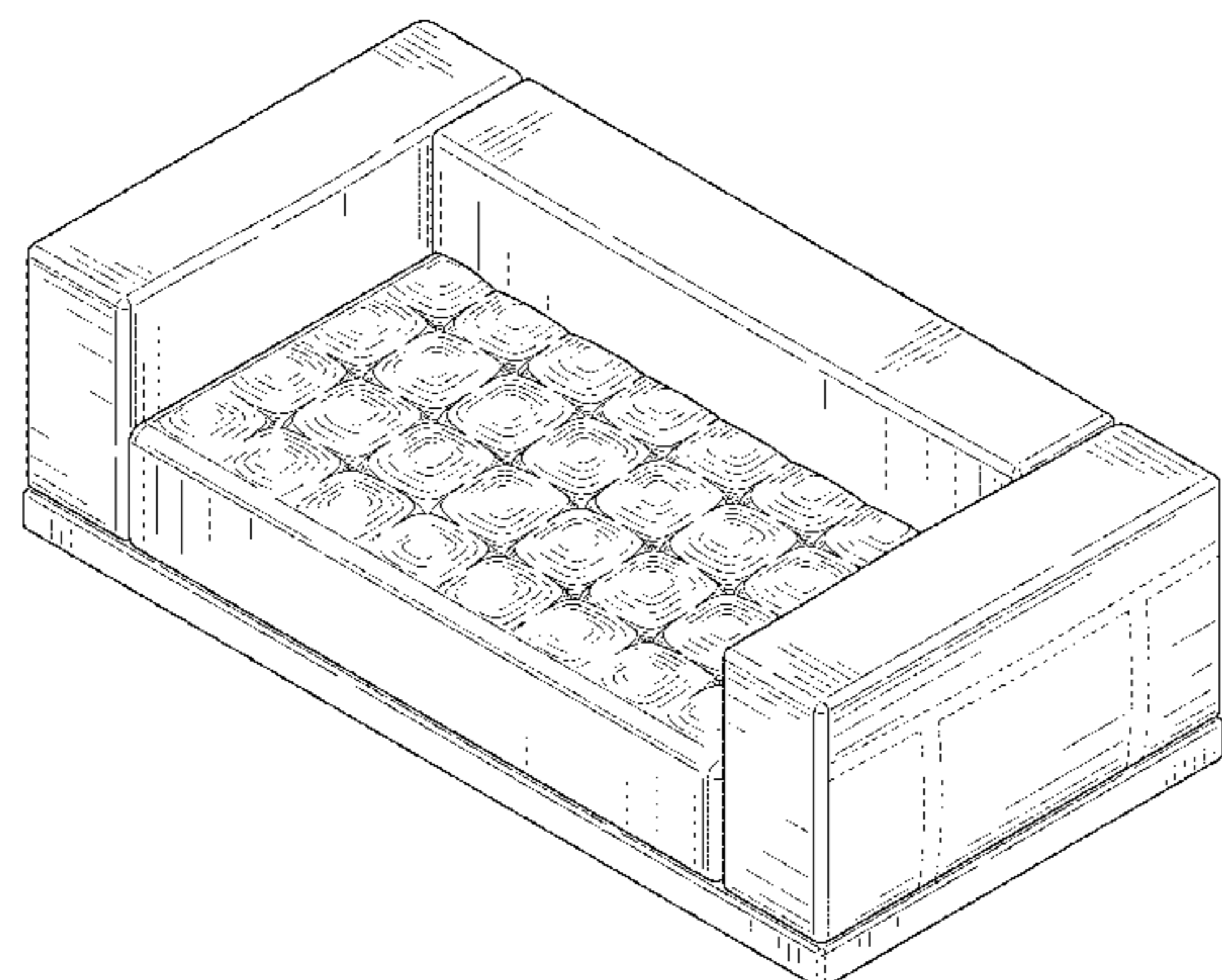
(57) **CLAIM**

The ornamental design for seating furniture, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment for seating furniture with a seat cushion shown in a retracted position; FIG. 2 is a perspective view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a top plan view of the second embodiment with the seat cushion in an extended position; FIG. 8 is a perspective view thereof; FIG. 9 is a left side thereof; FIG. 10 is a front view thereof; FIG. 11 is a right side view thereof; and, FIG. 12 is a rear view thereof. The broken line showings in FIGS. 2-3, 5-6, 8-9, and 11-12 represent disclaimed subject matter and form no part of the claimed design.

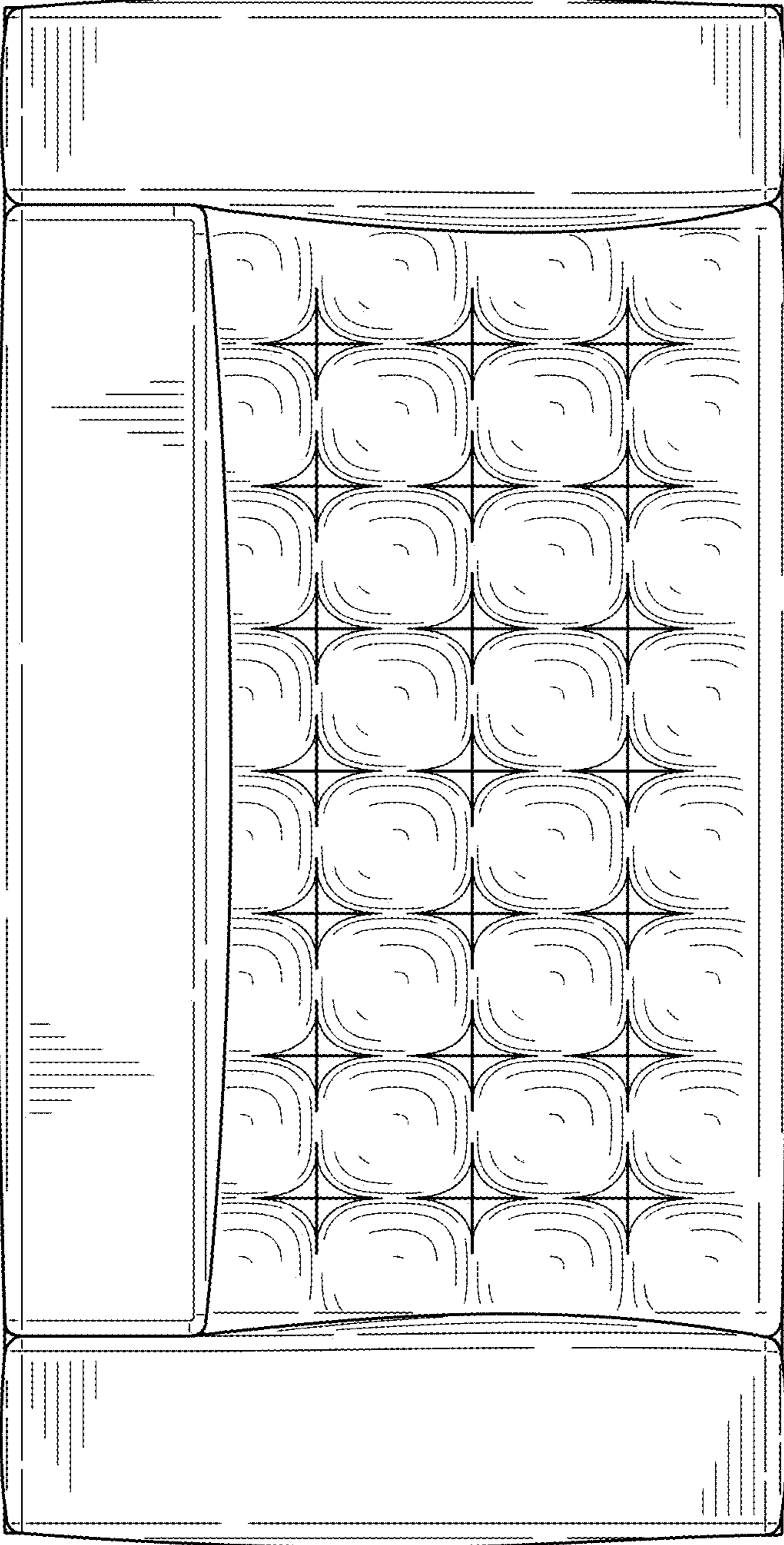

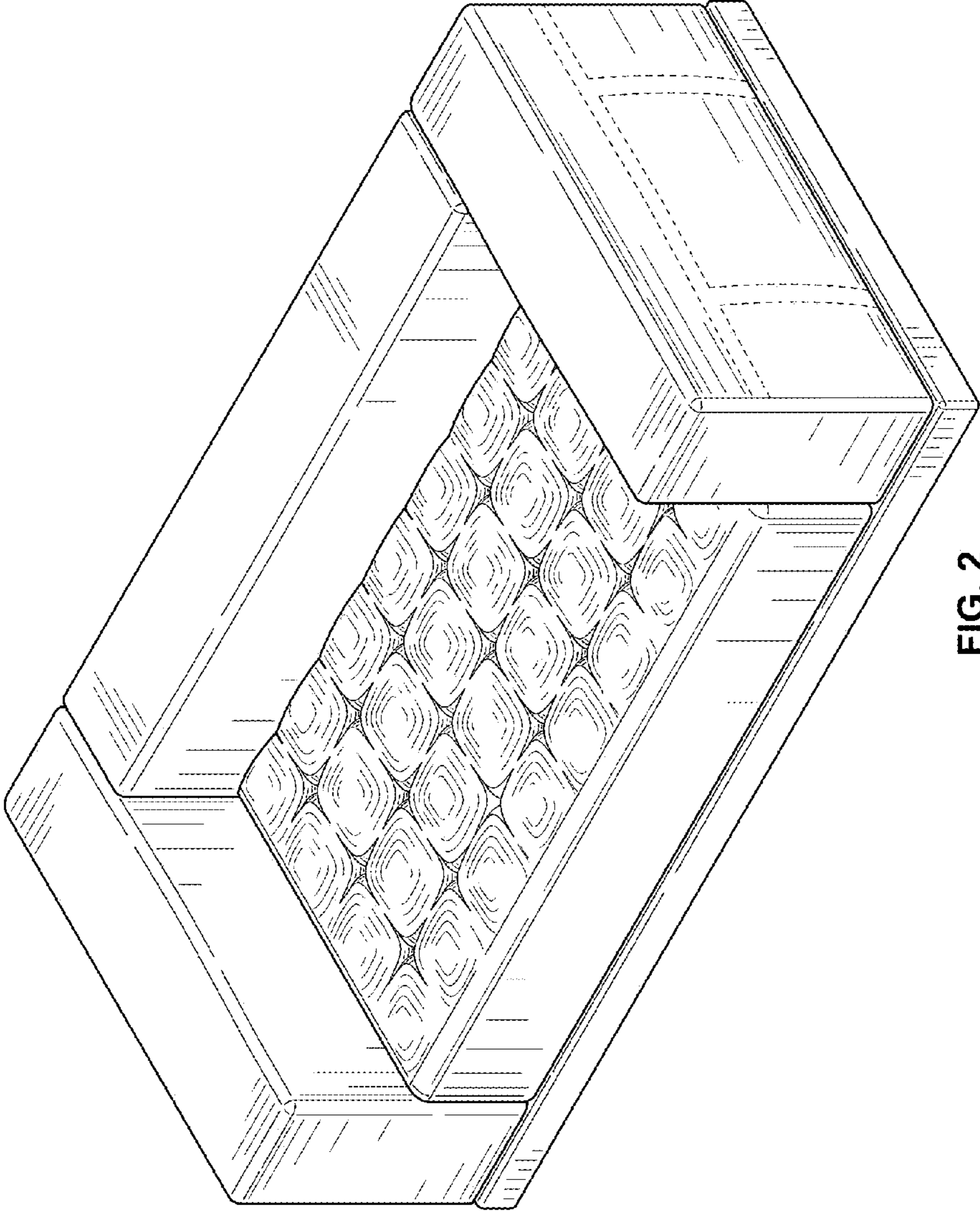

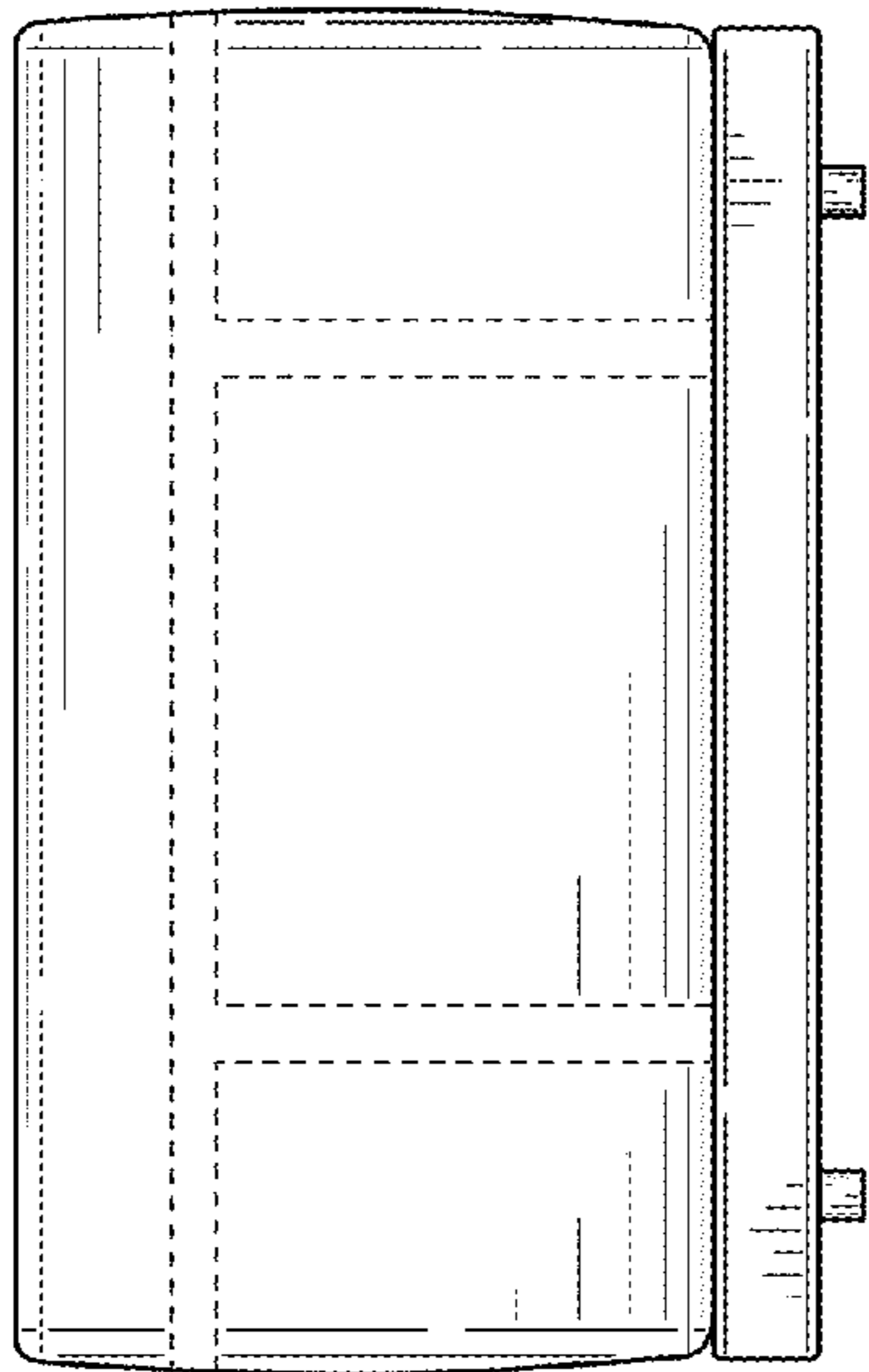

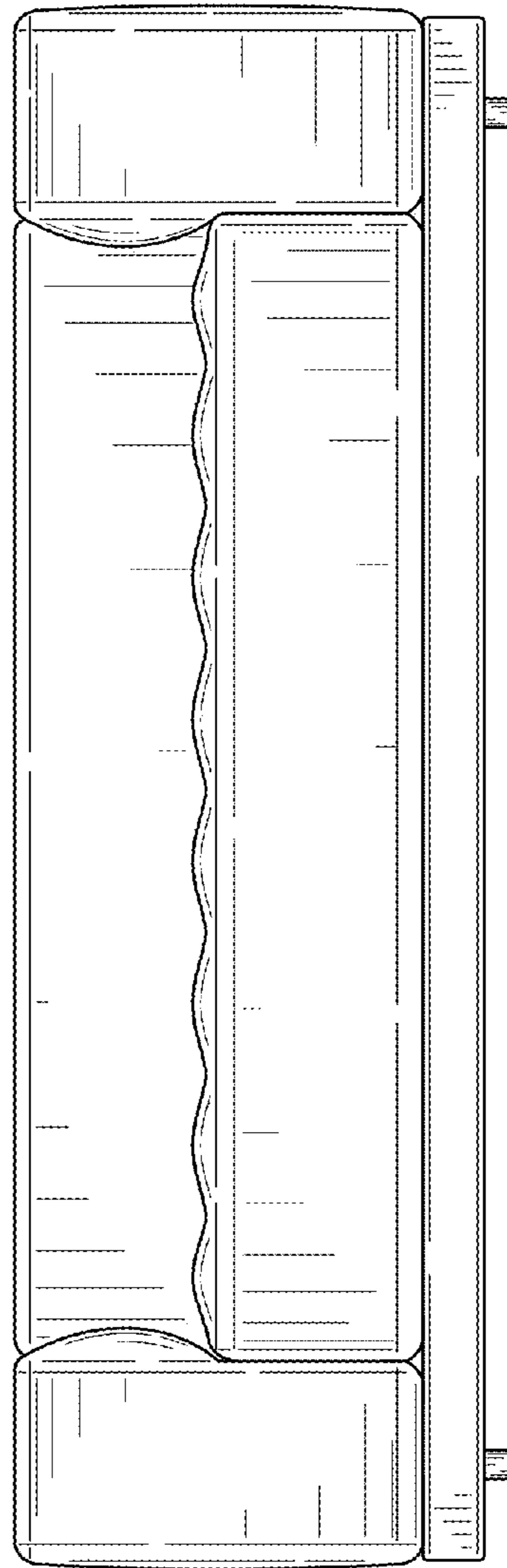

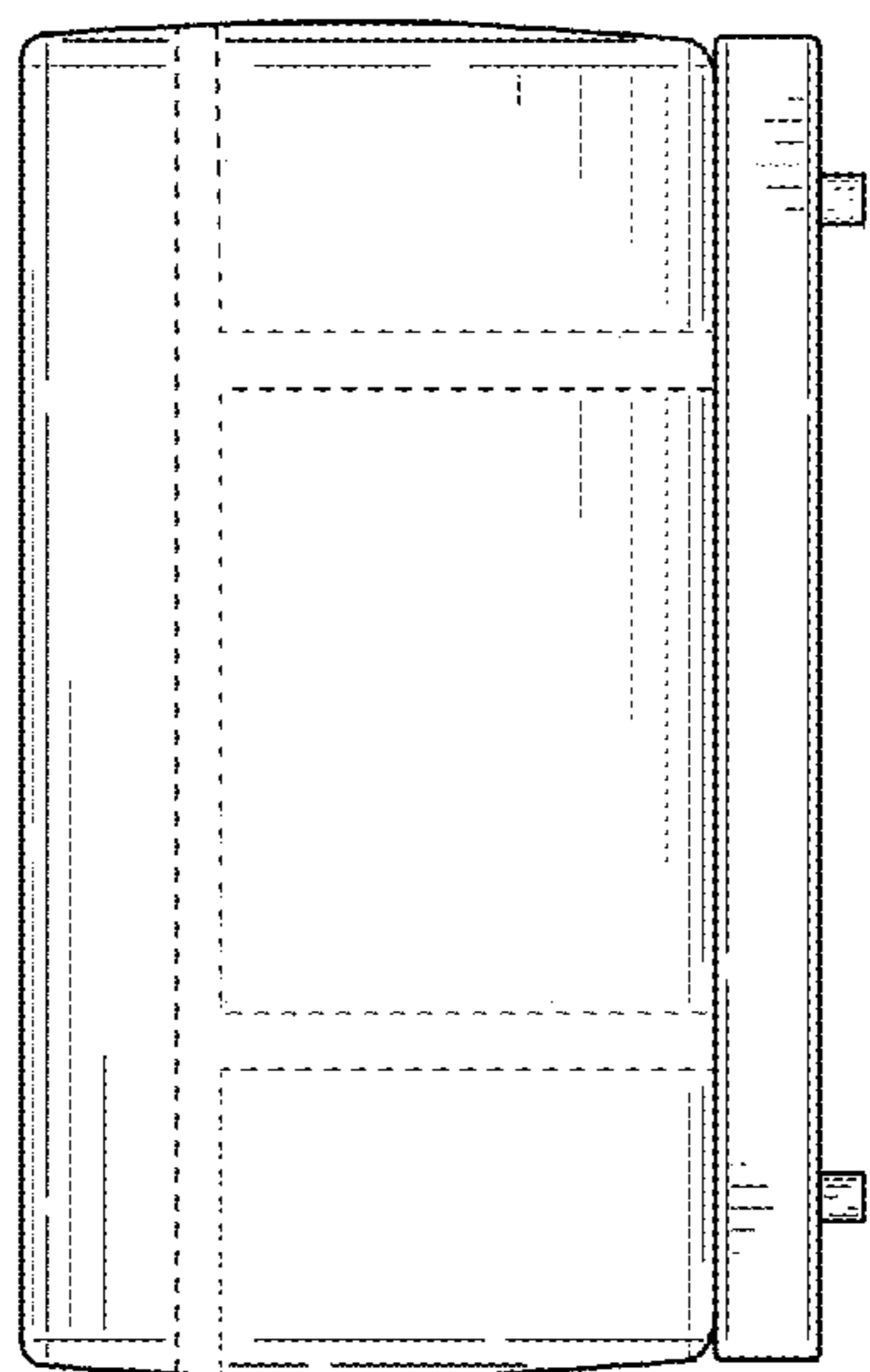

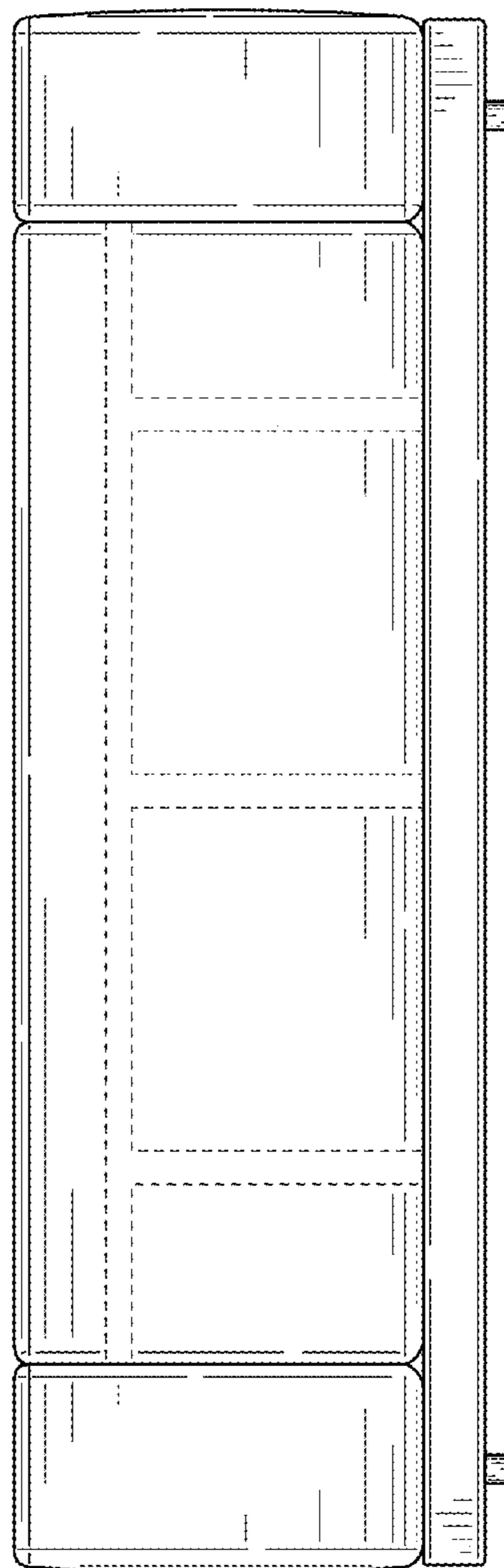

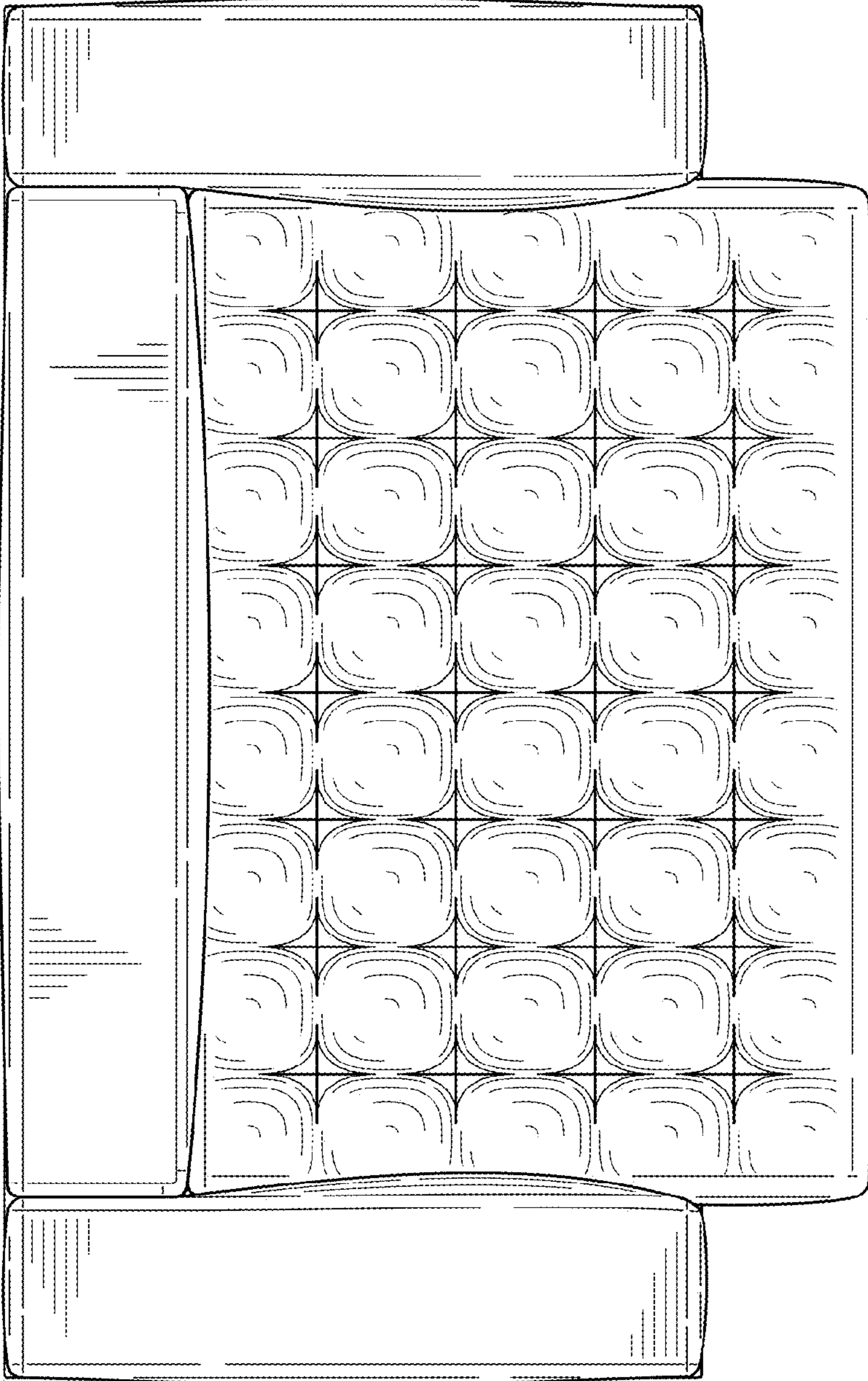

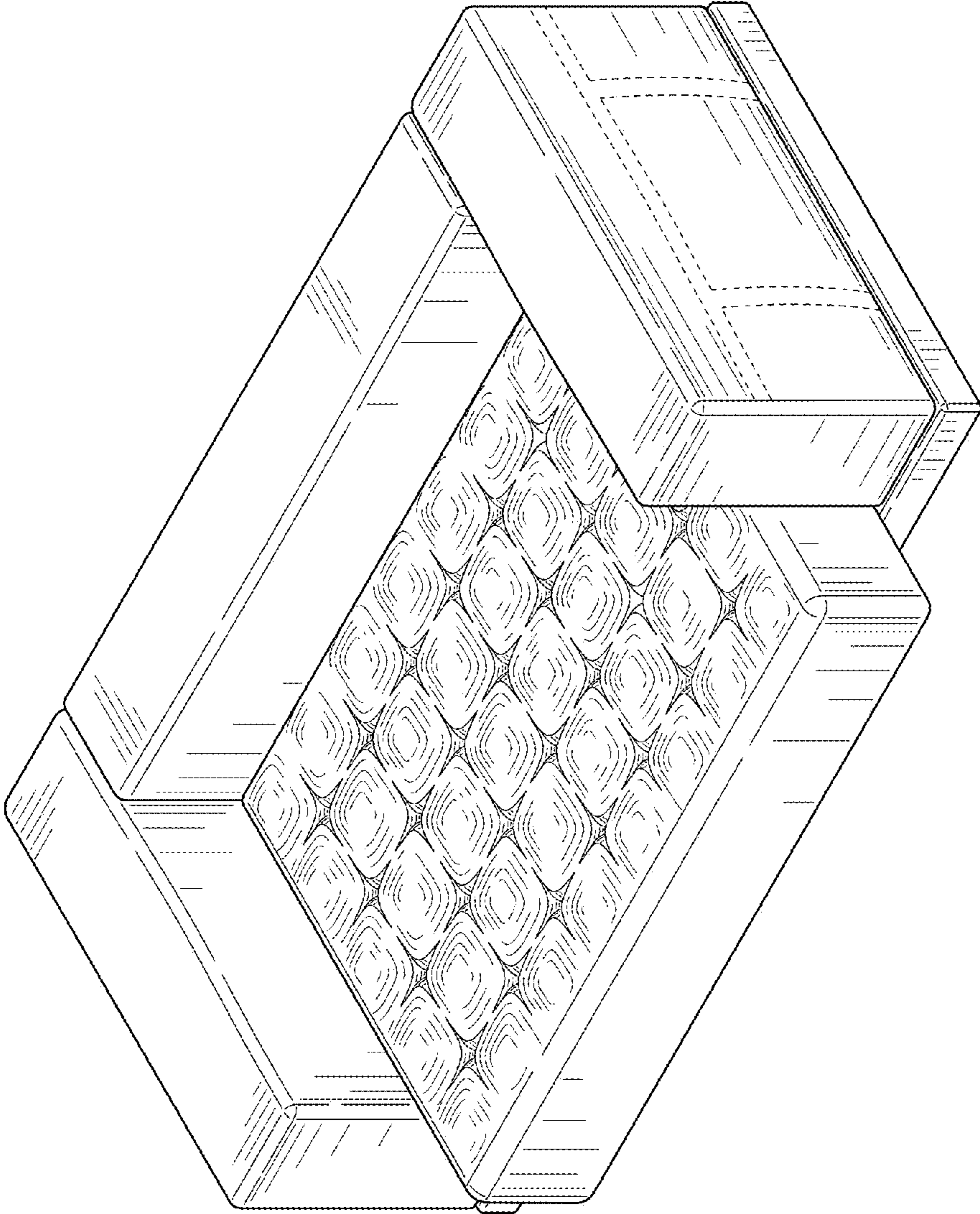

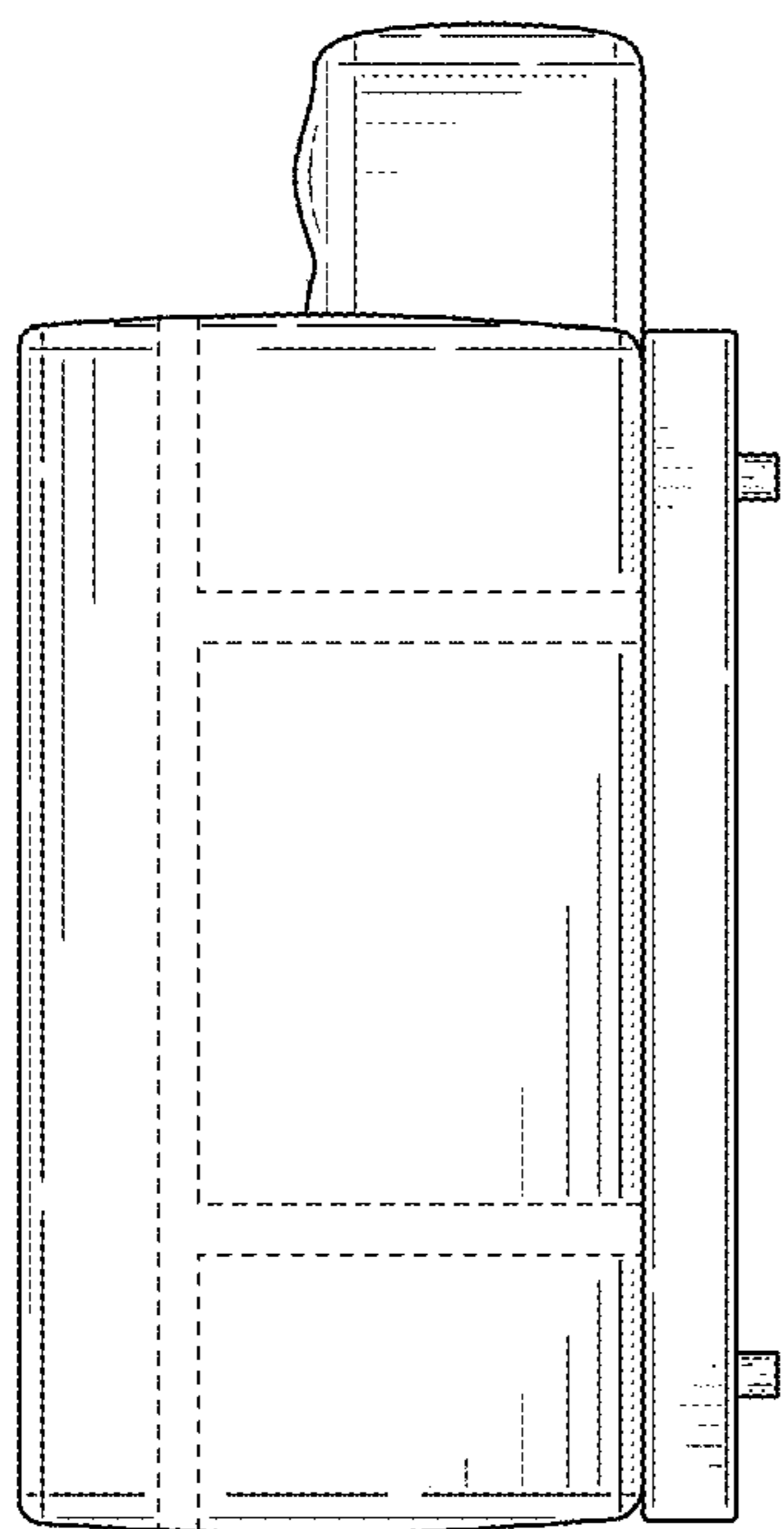

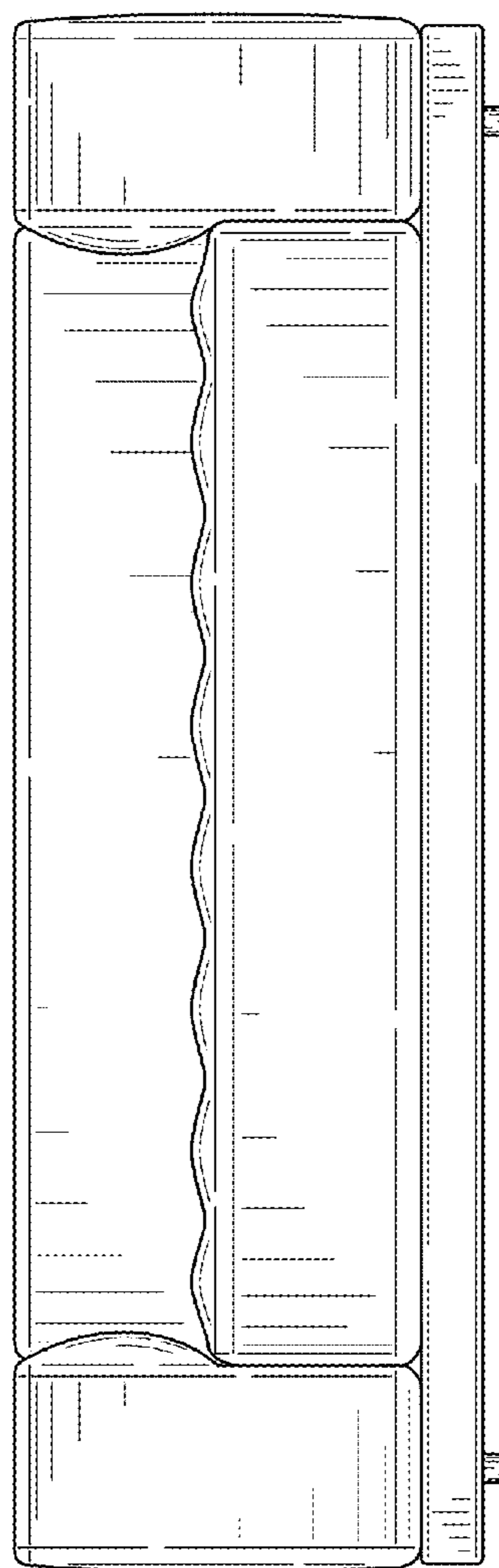

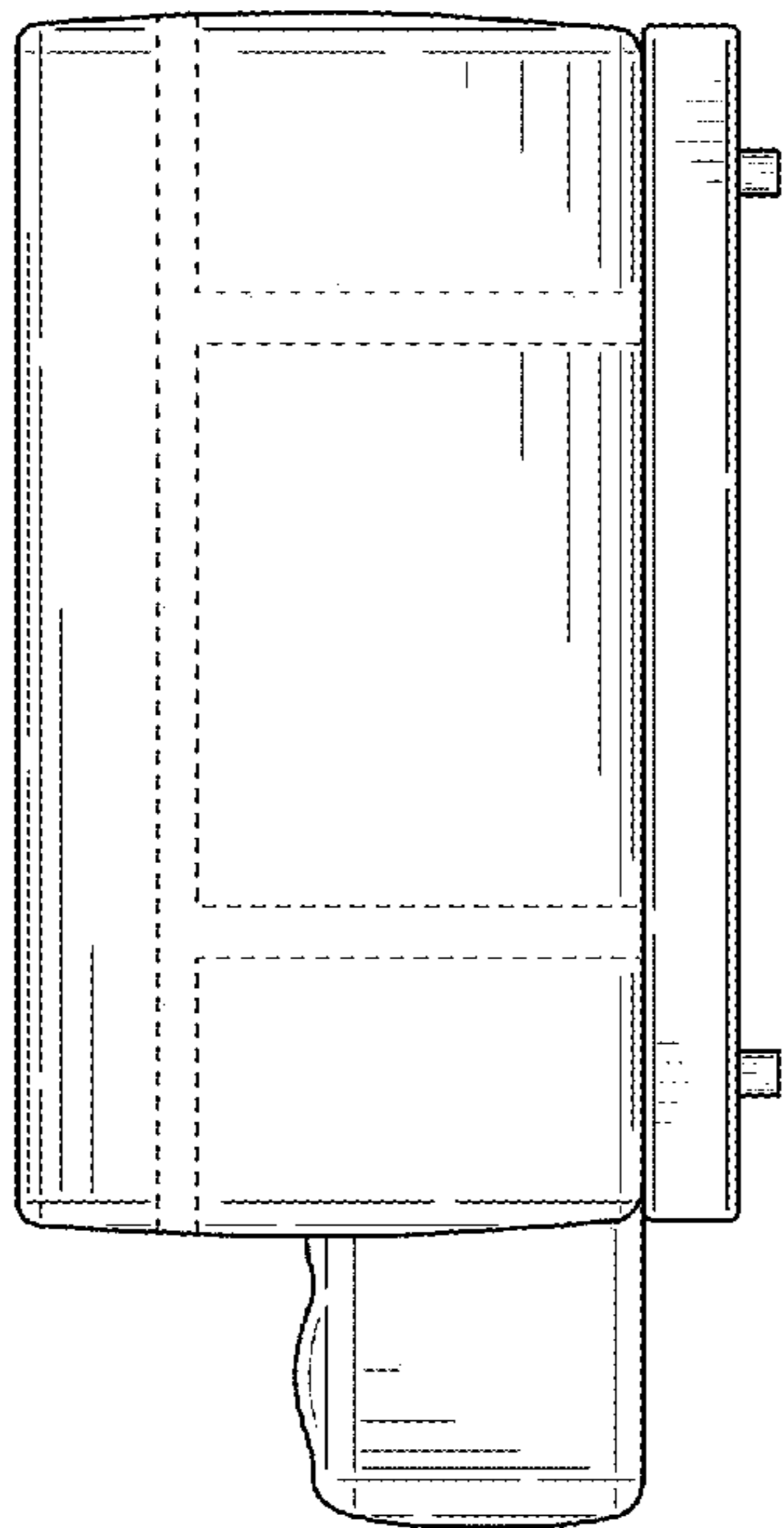

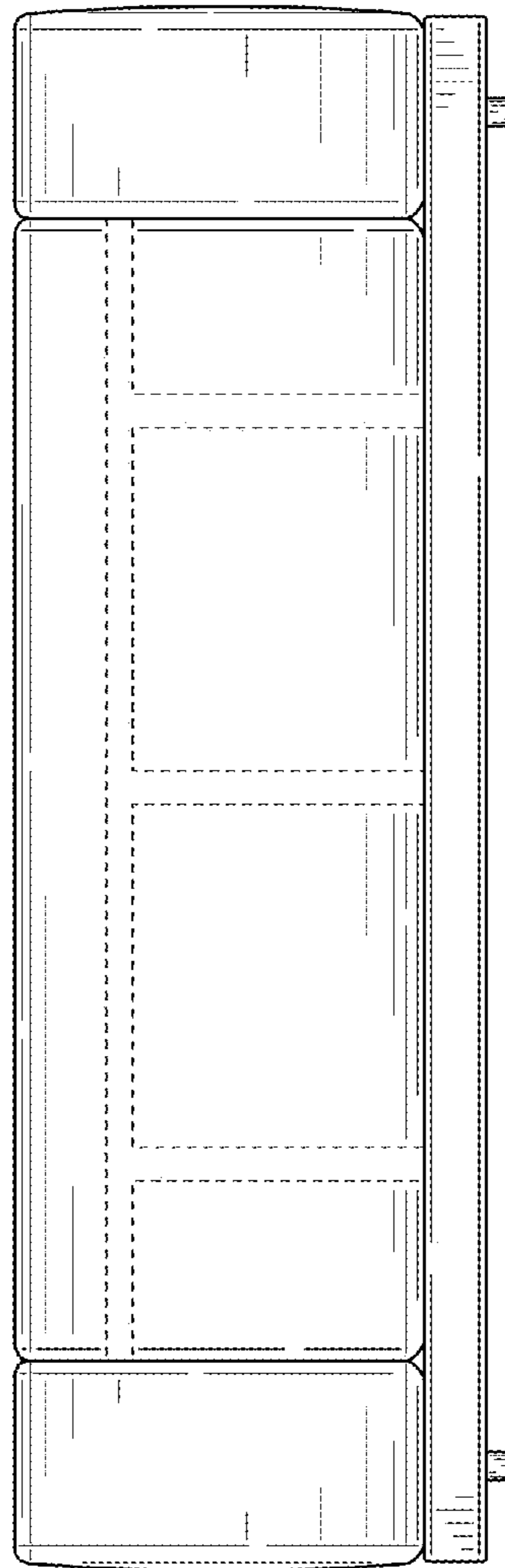
