FIG. 7 is a left side view of the shelving apparatus.

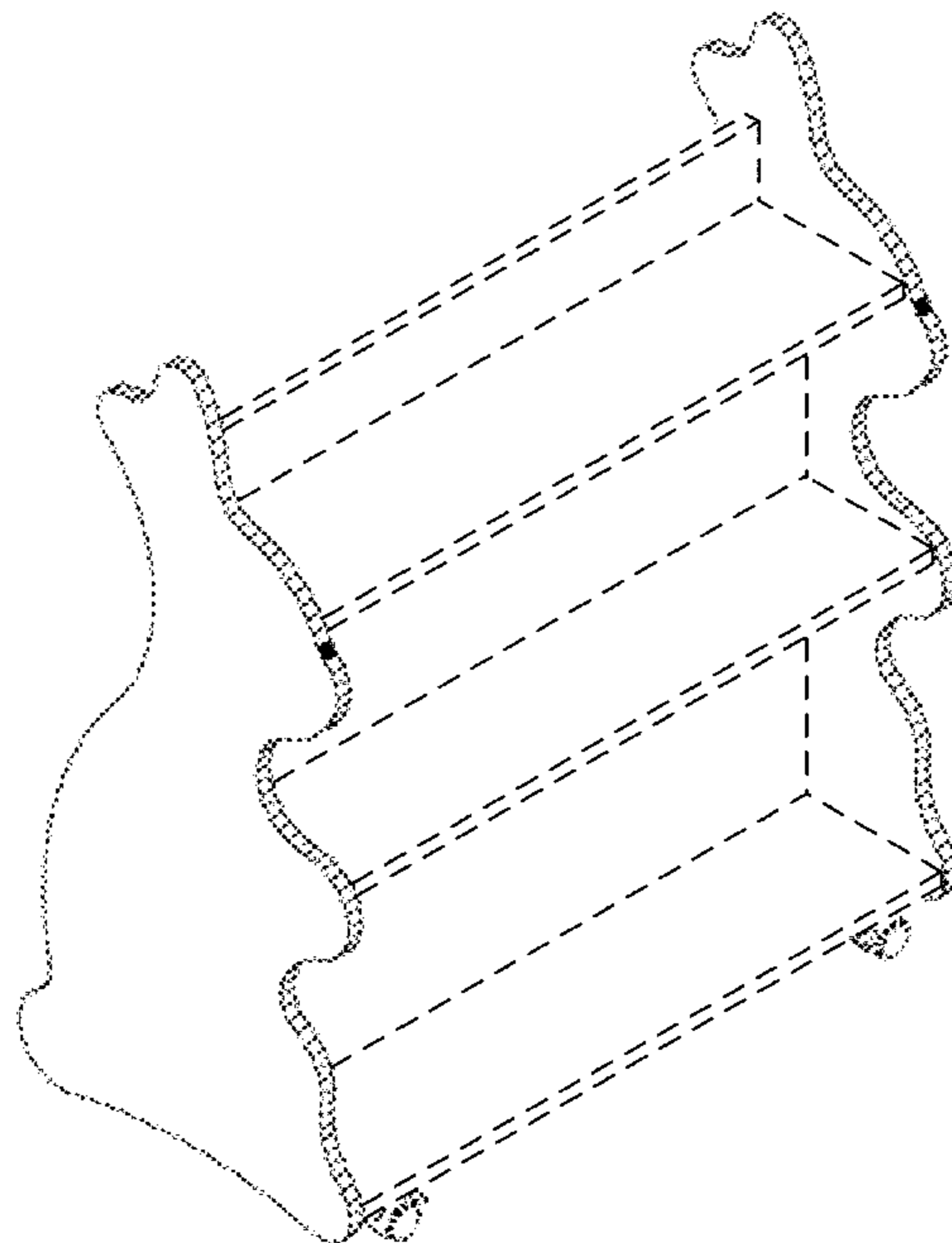
FIG. 8 is a right side view of the shelving apparatus.

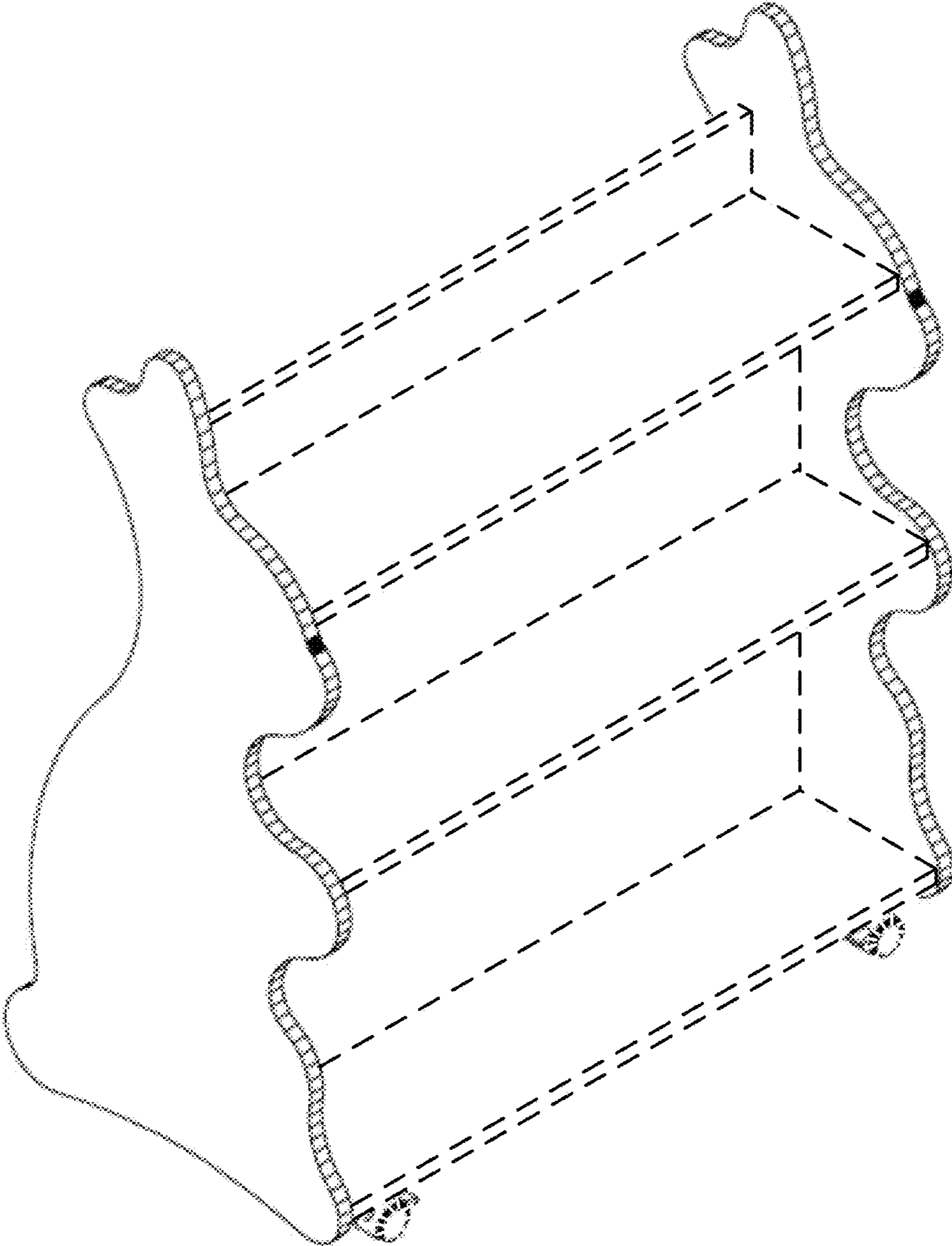

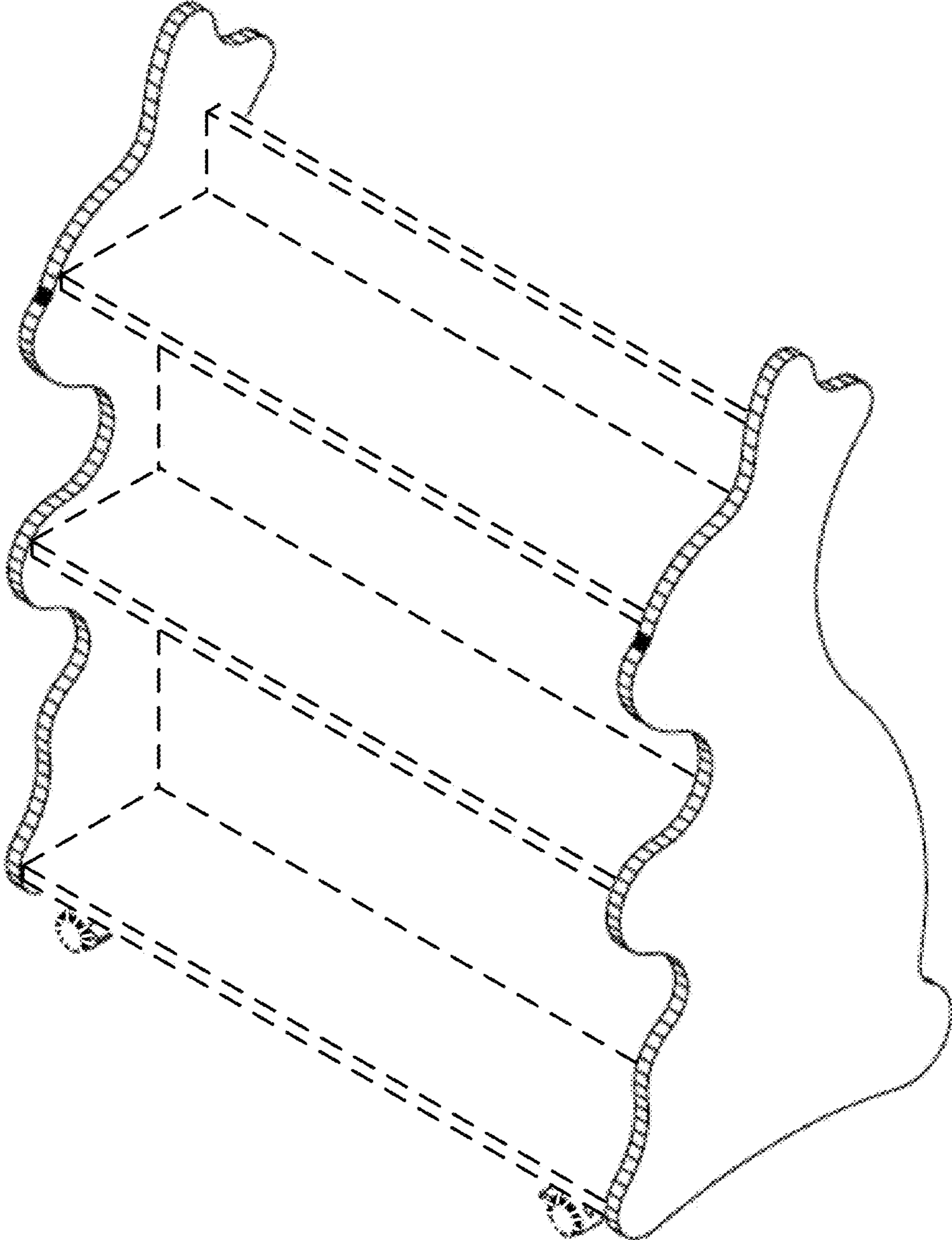

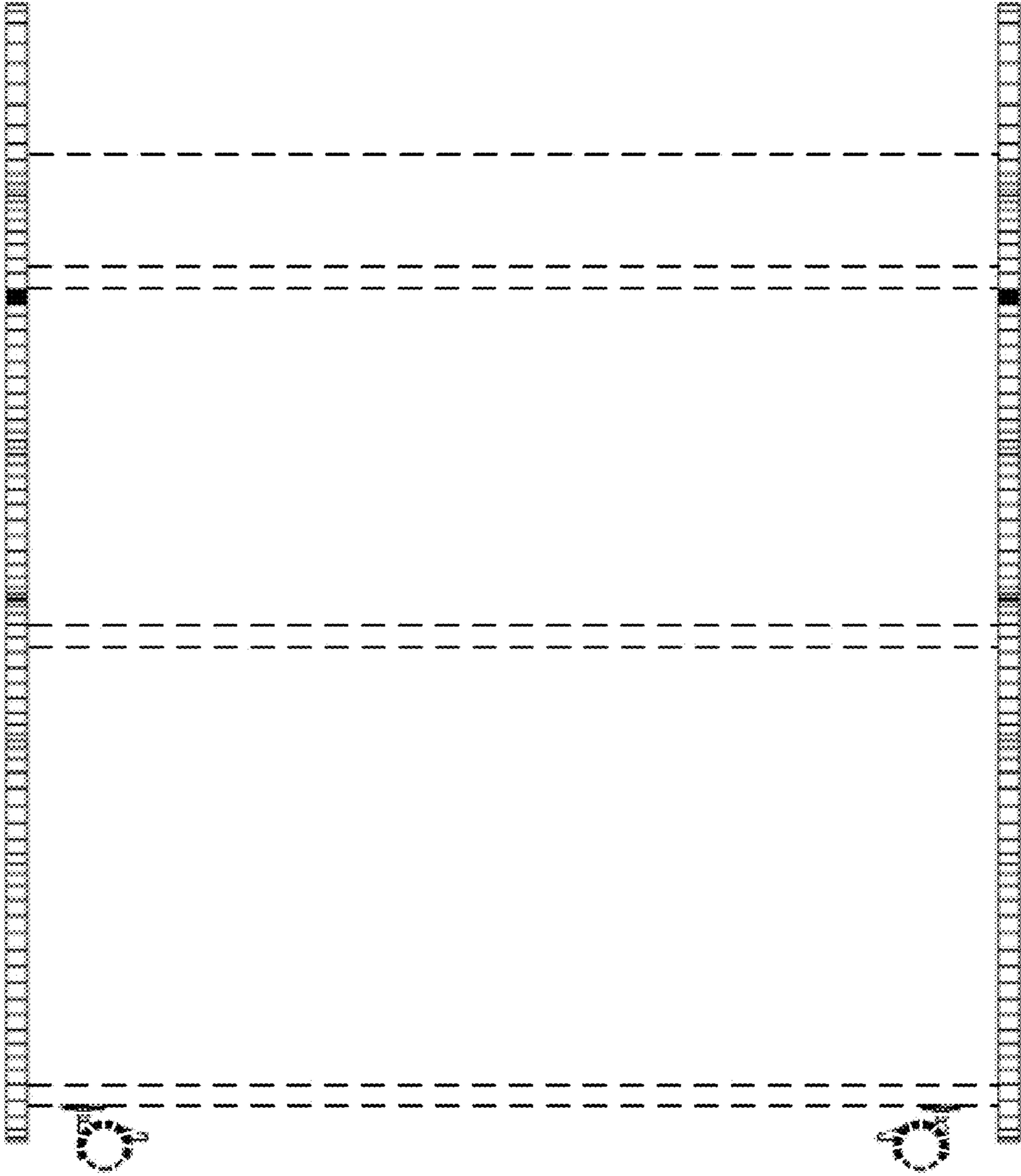

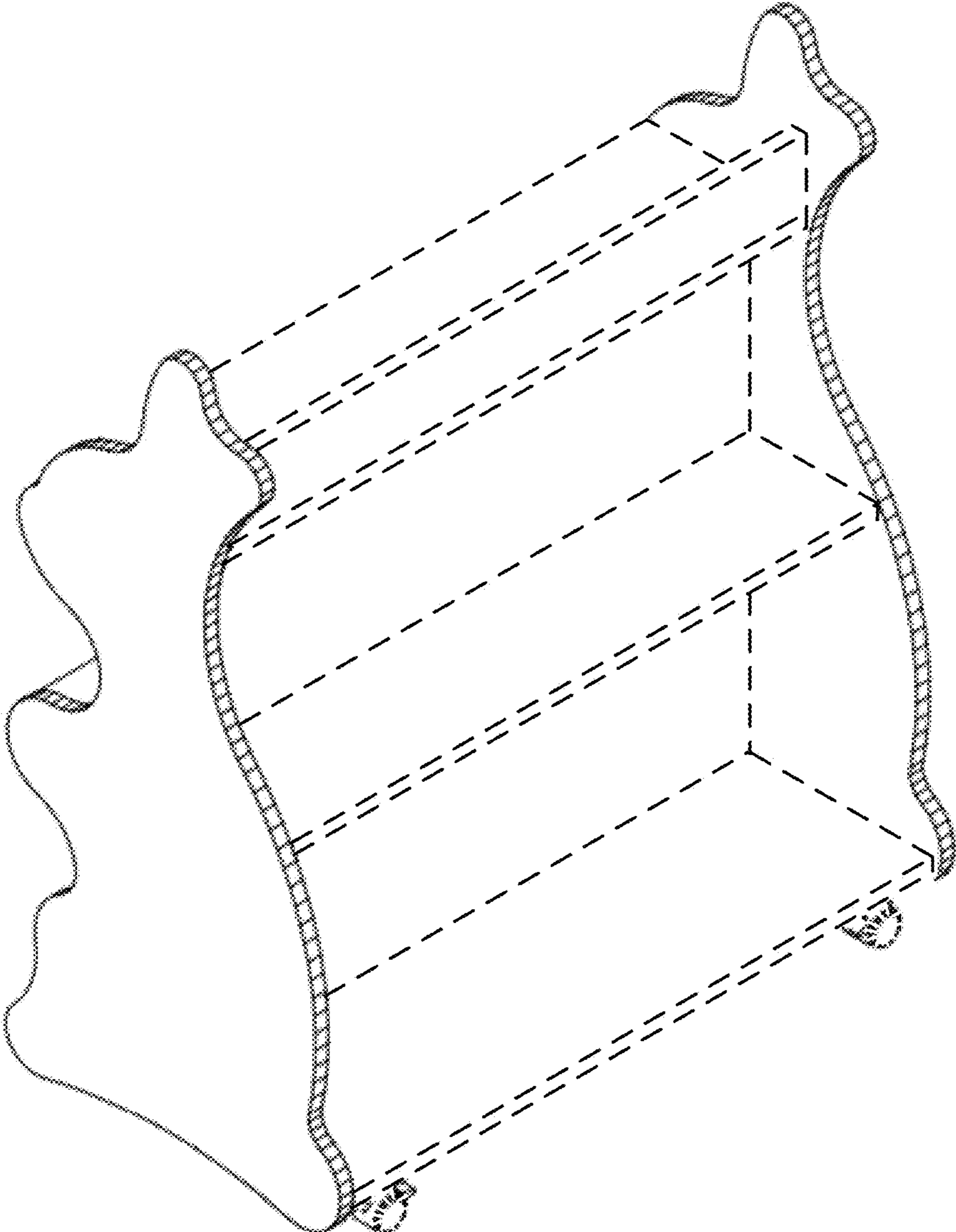

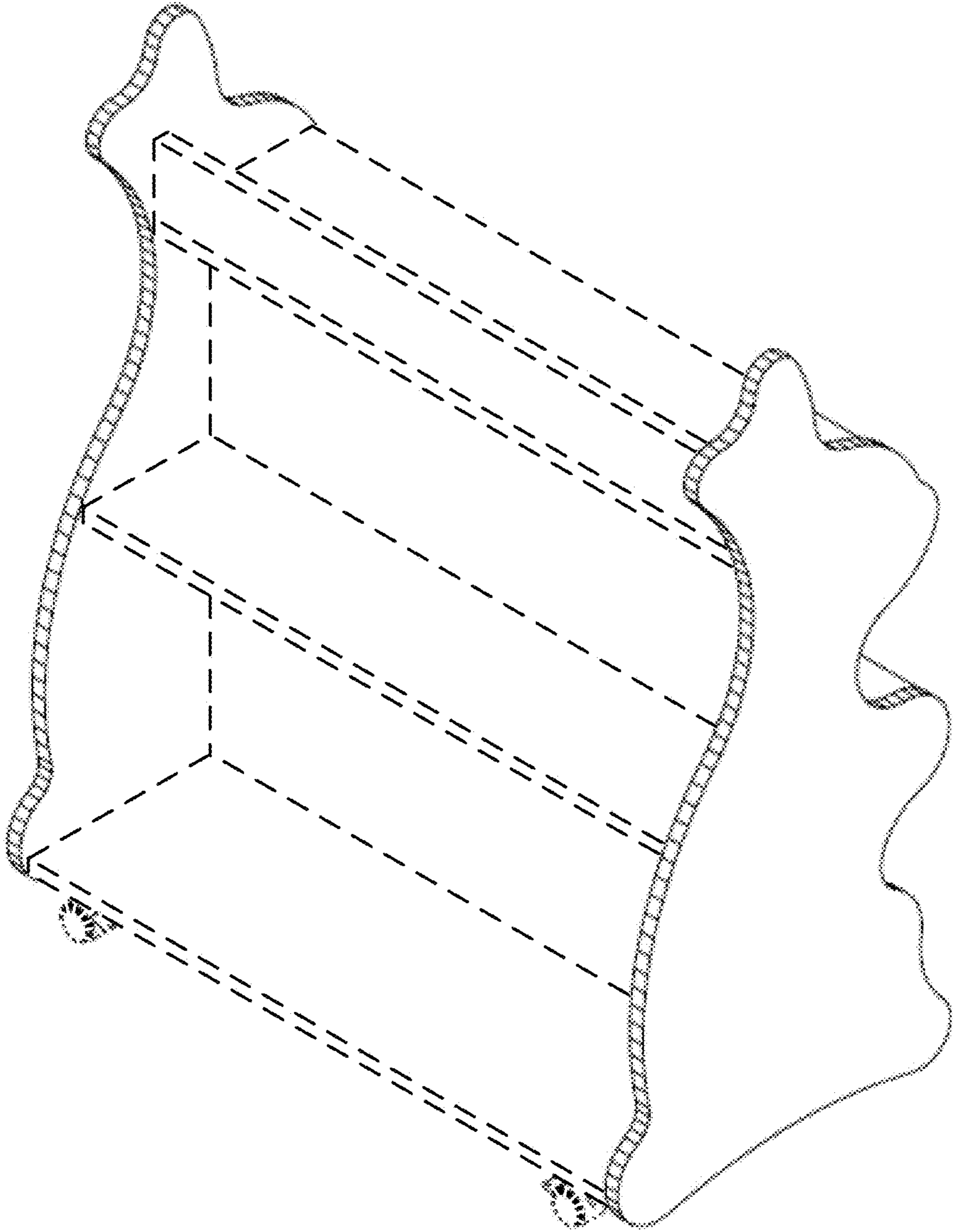

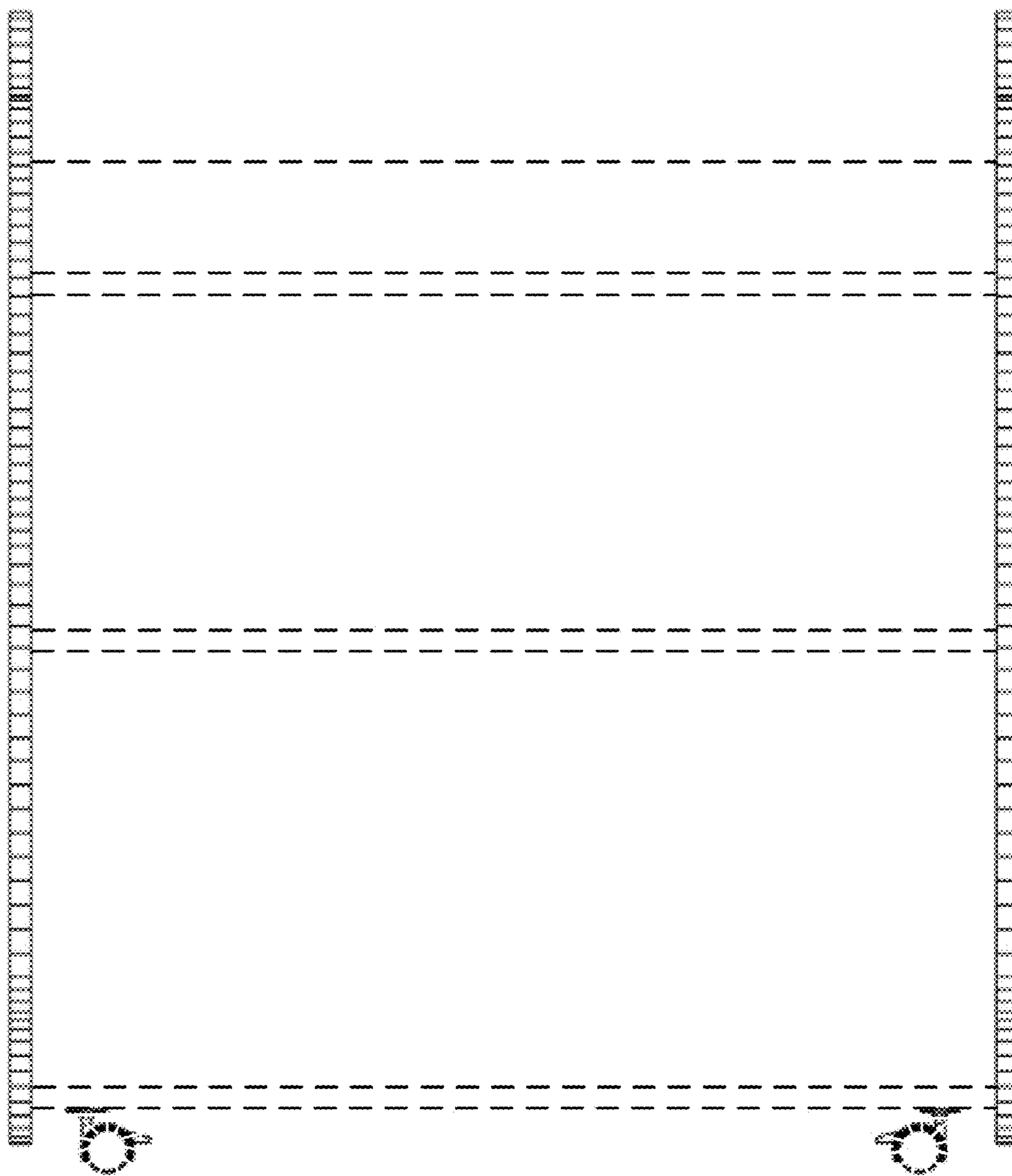

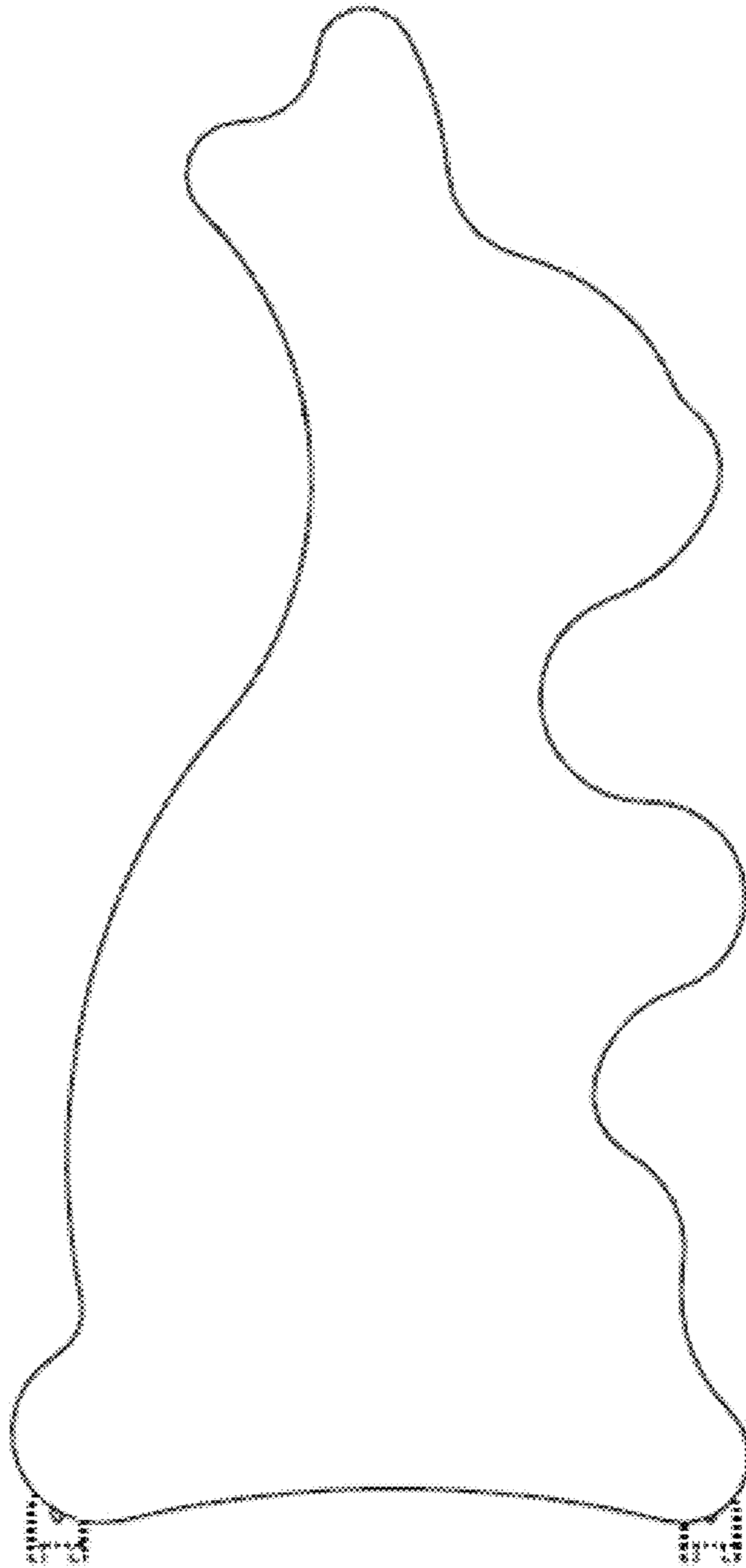

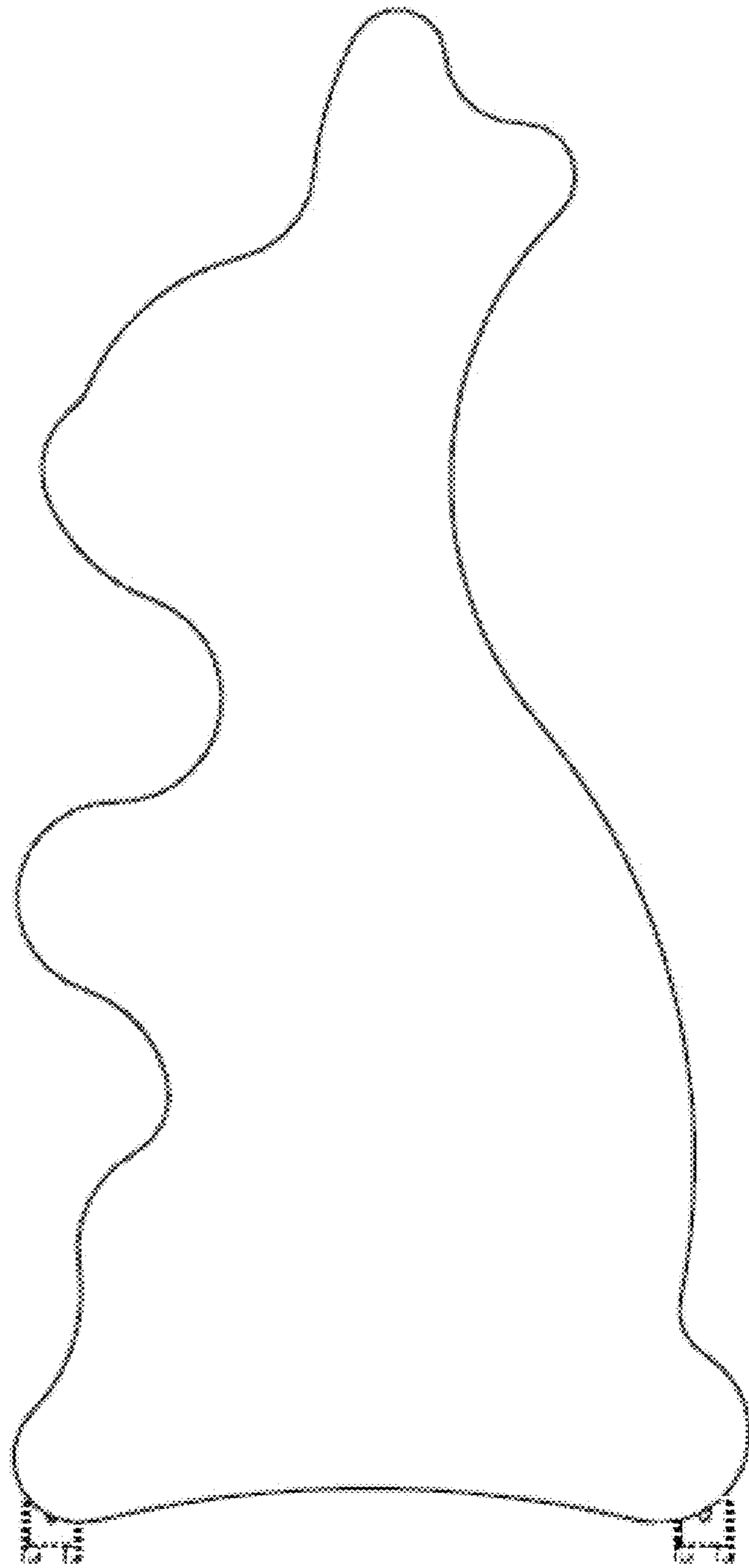

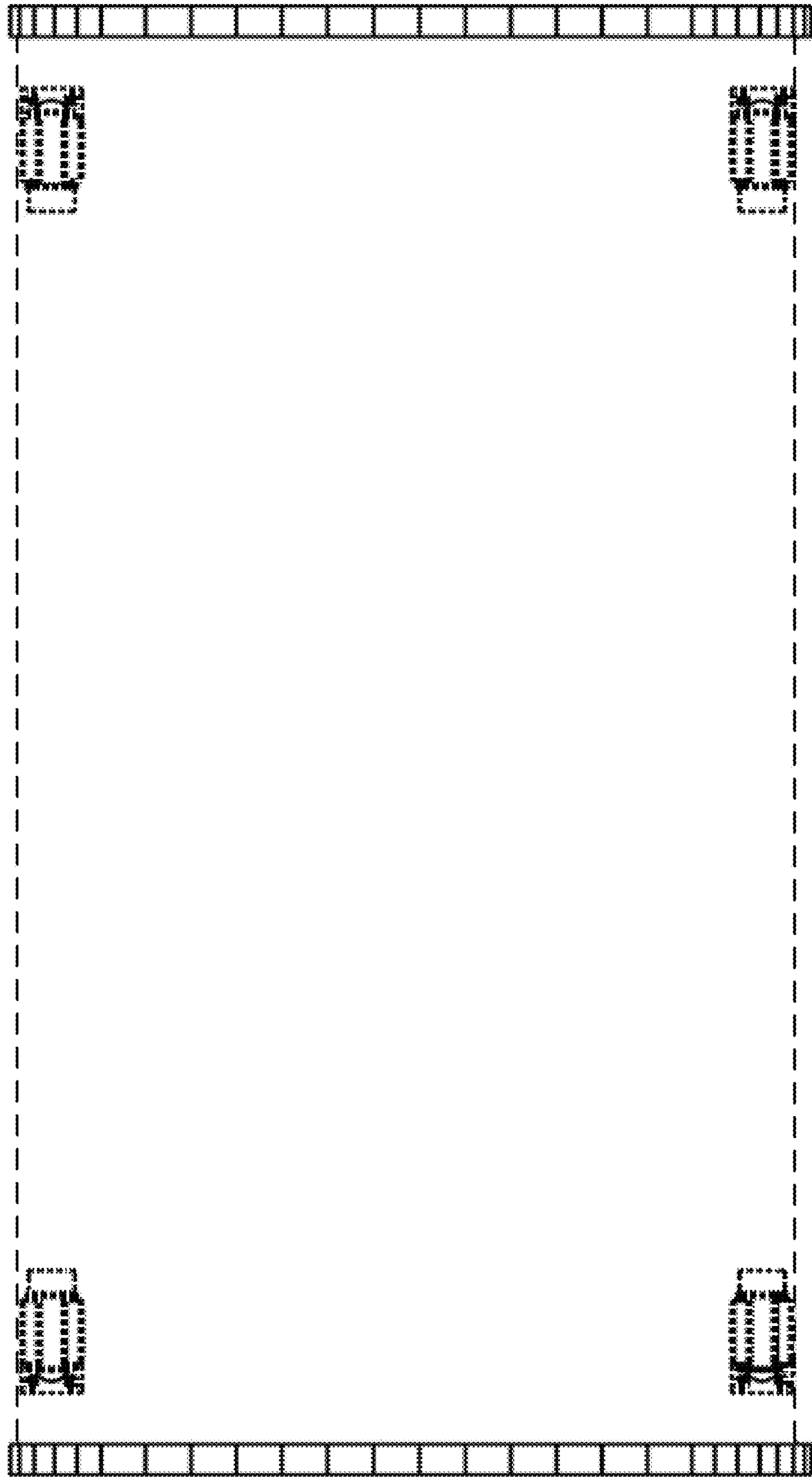

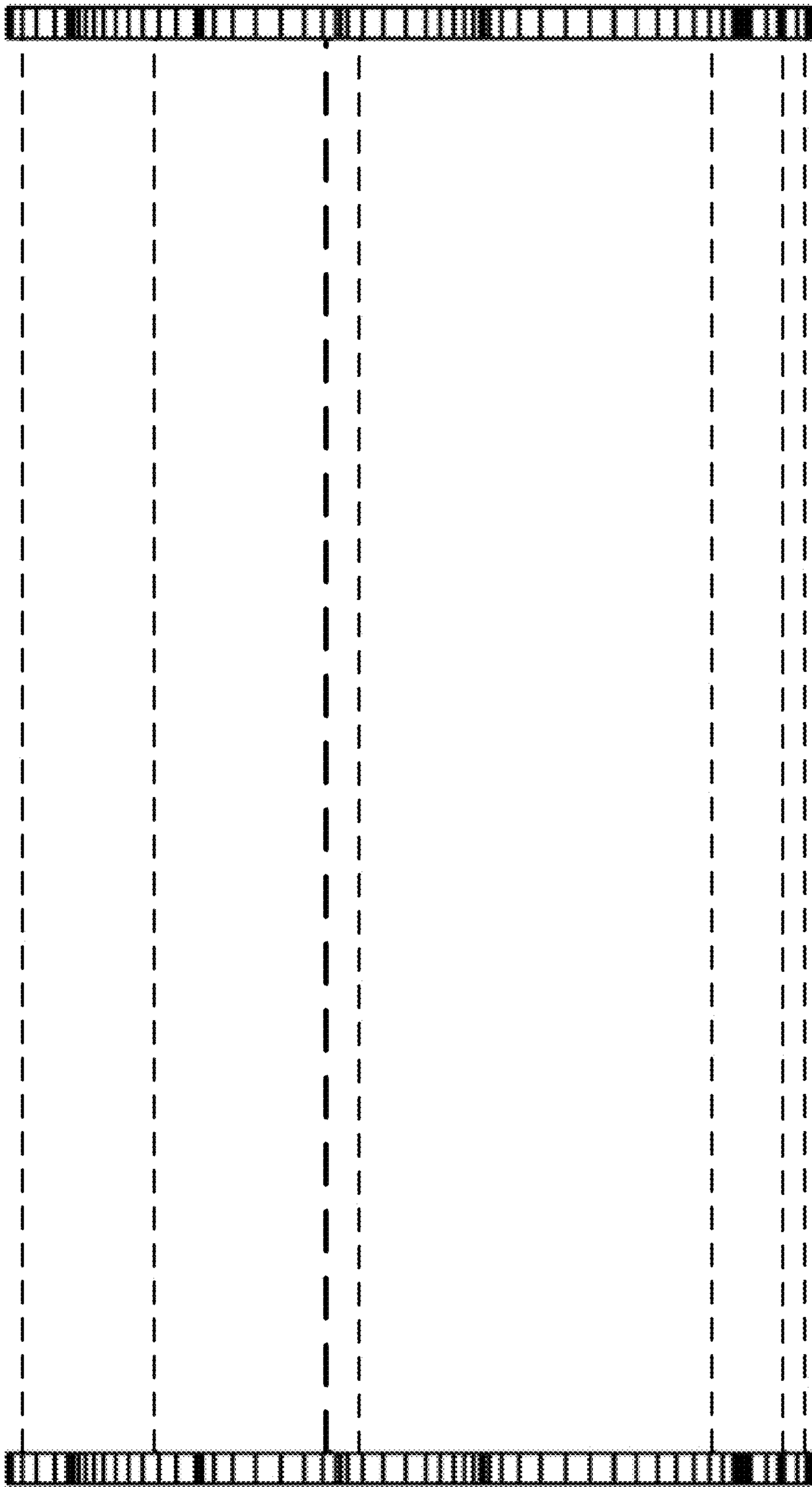
