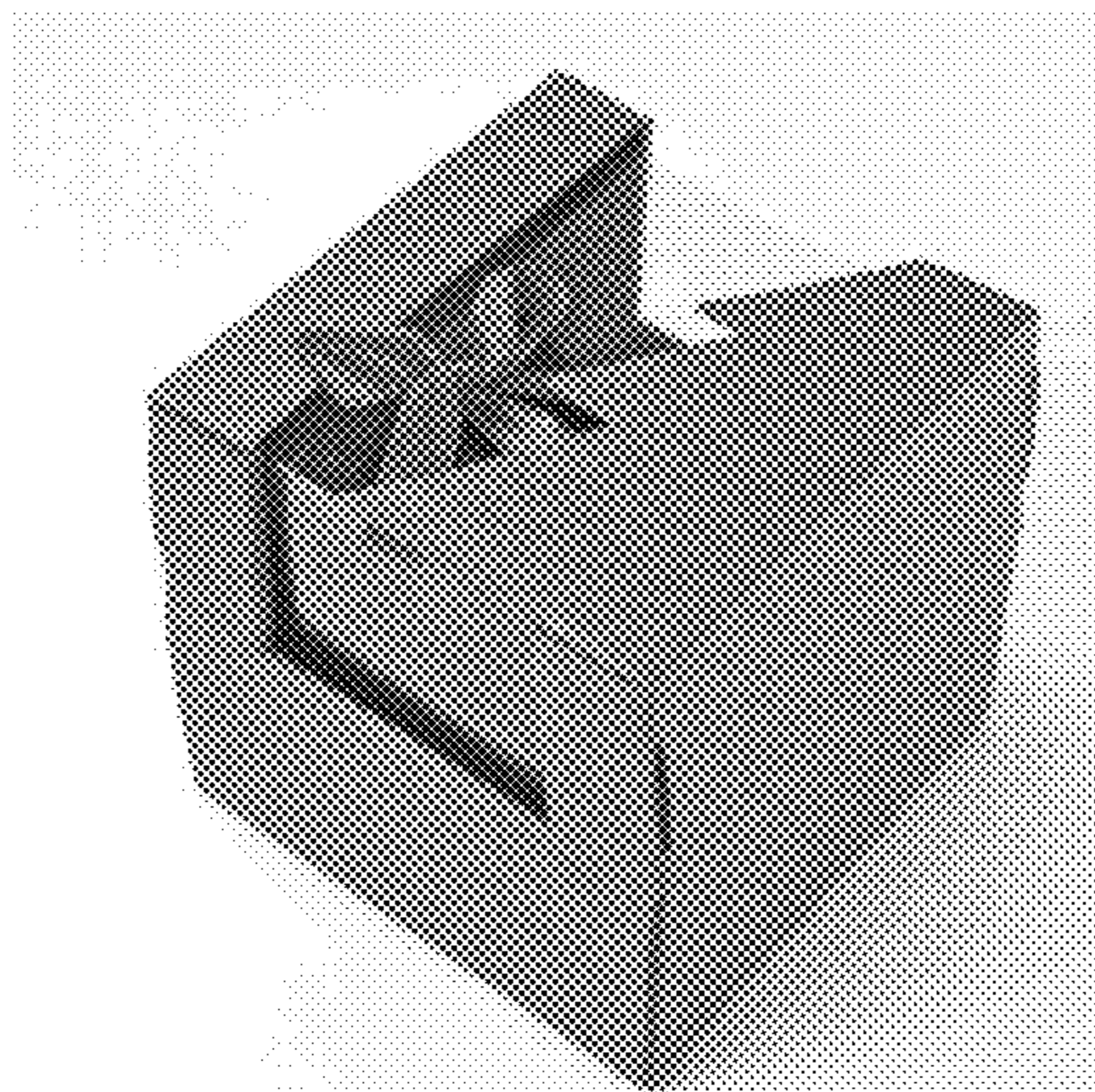
(57) **CLAIM**

The ornamental design for a gift box, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a gift box, showing my design in the closed configuration;
FIG. 2 is a perspective view of the gift box of FIG. 1, showing my design in the partially opened configuration; and,
FIG. 3 is a perspective view of the gift box of FIG. 1, showing my design in the fully opened configuration.

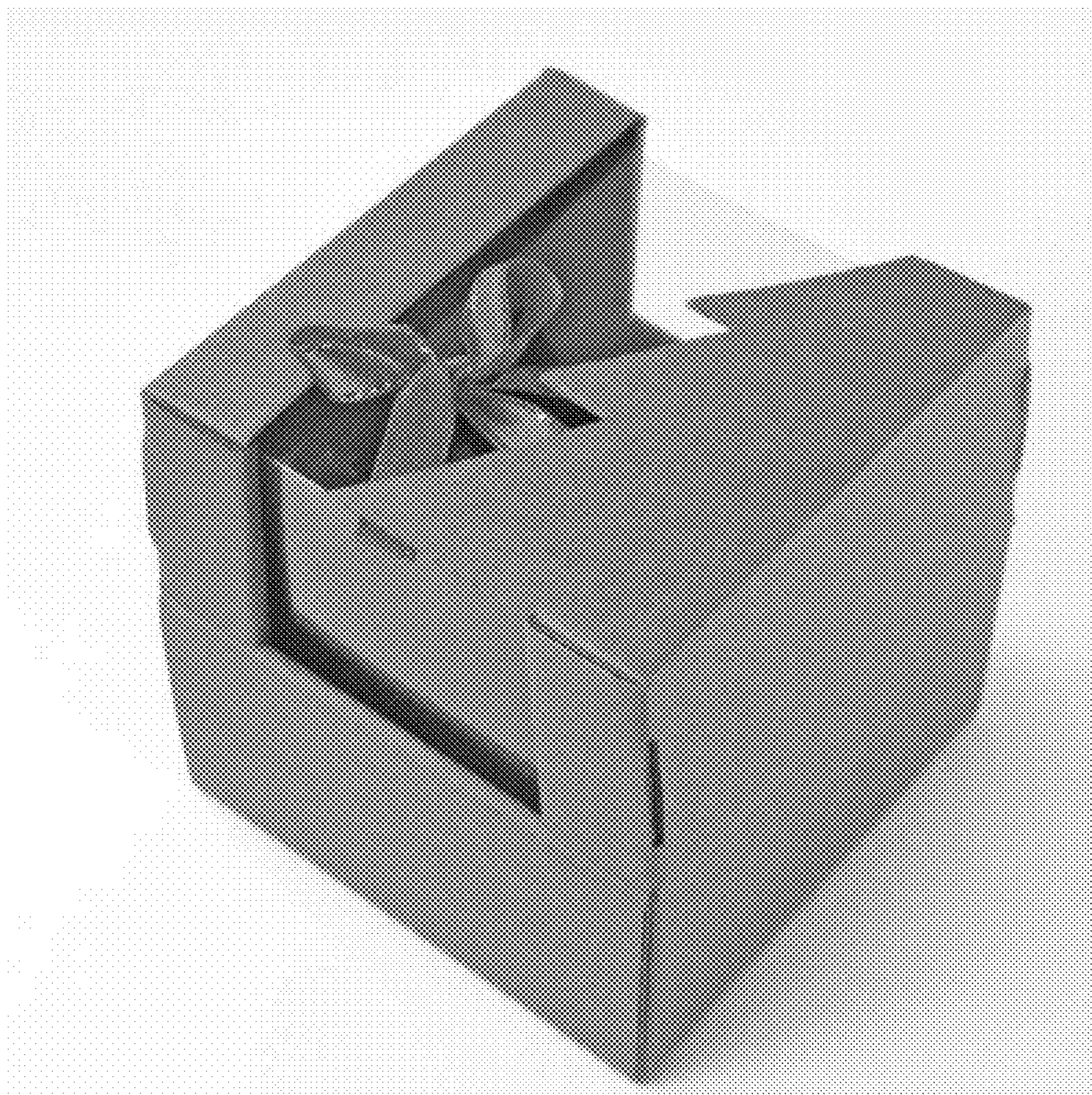

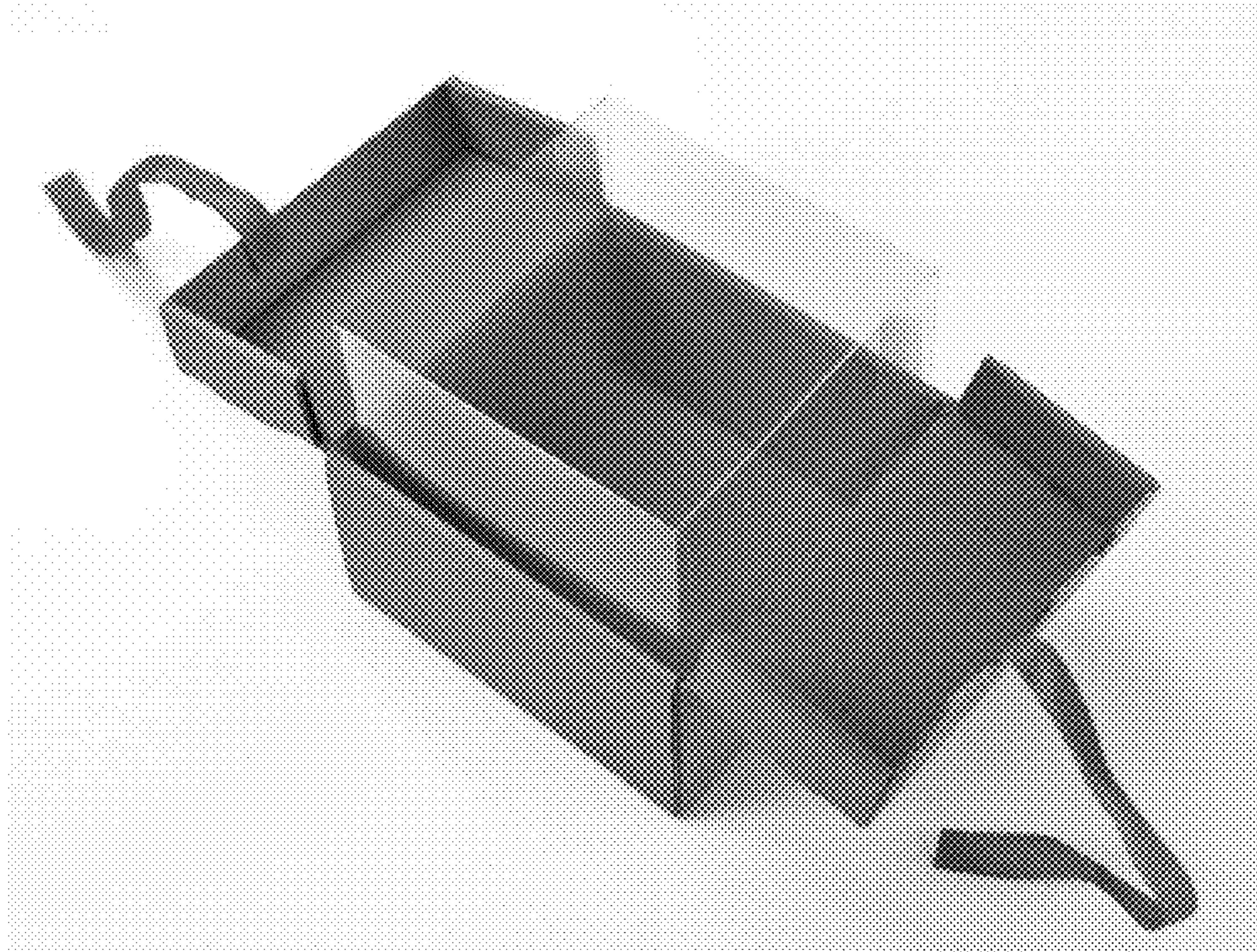

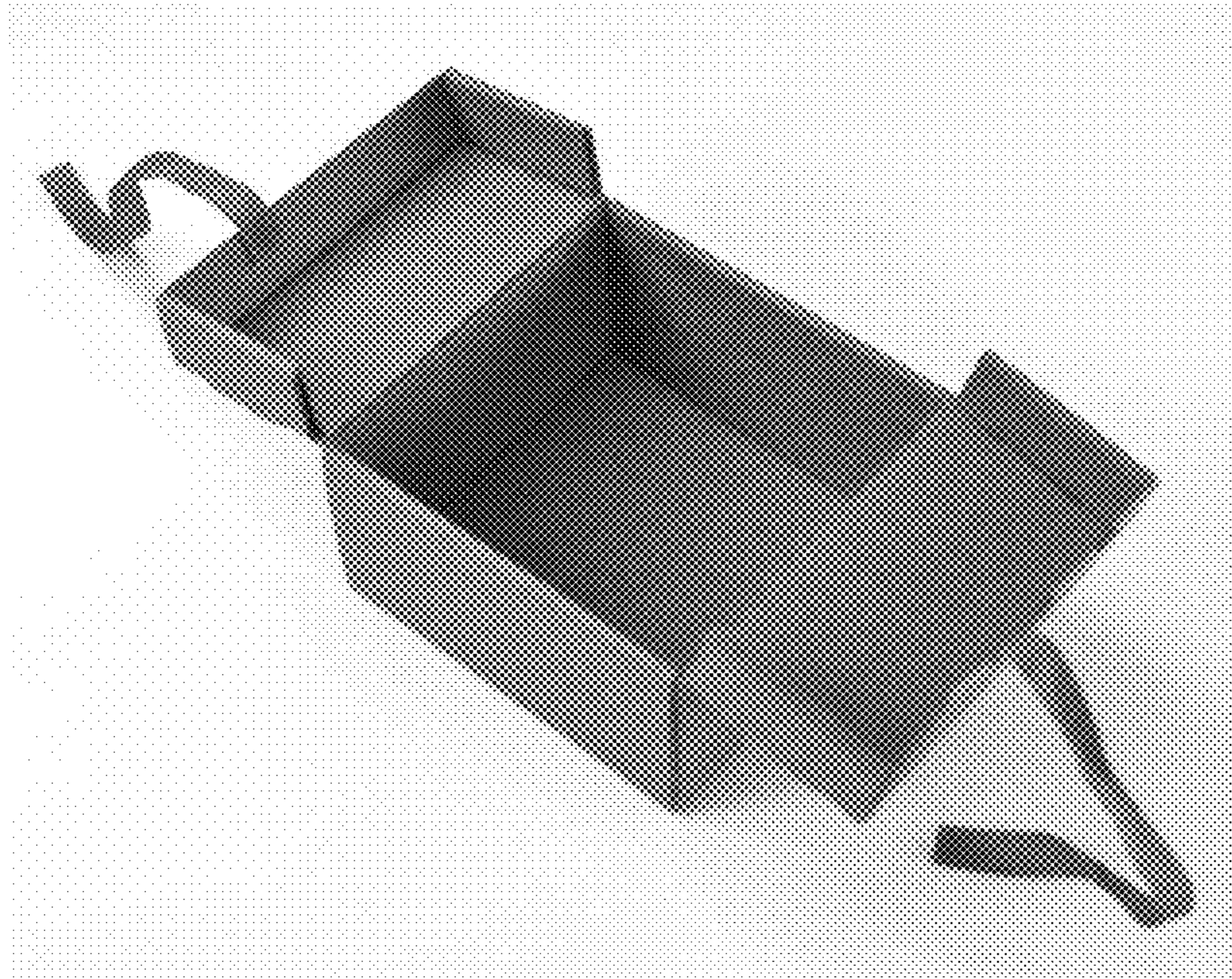
