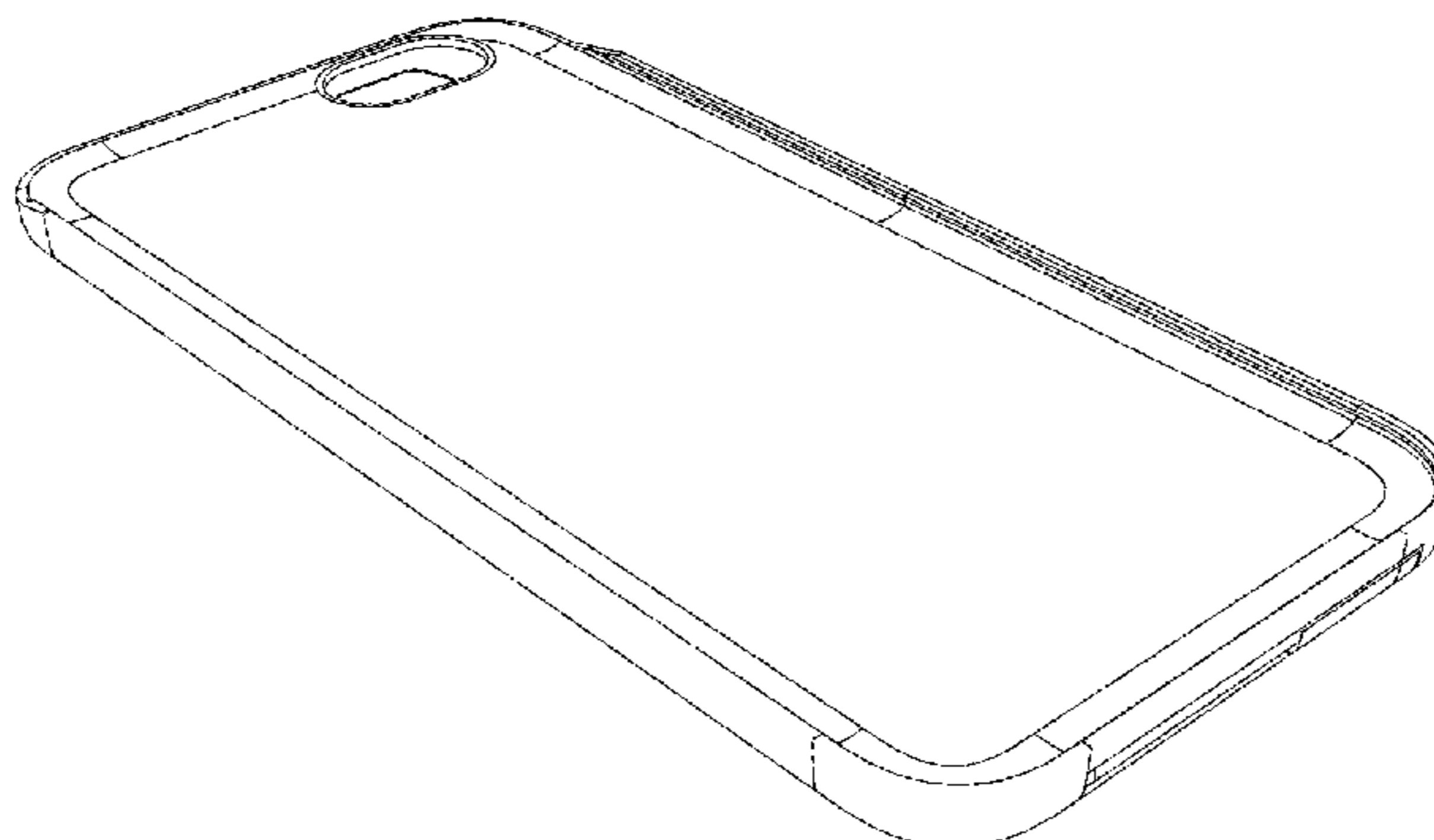

(57) **CLAIM**
I claim an ornamental design for a smartphone battery, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a smartphone battery;
FIG. 2 is a front view of a smartphone battery;
FIG. 3 is a back view of a smartphone battery;
FIG. 4 is a top view of a smartphone battery;
FIG. 5 is a bottom view of a smartphone battery;
FIG. 6 is a side view of a smartphone battery; and,
FIG. 7 is another side view of a smartphone battery.

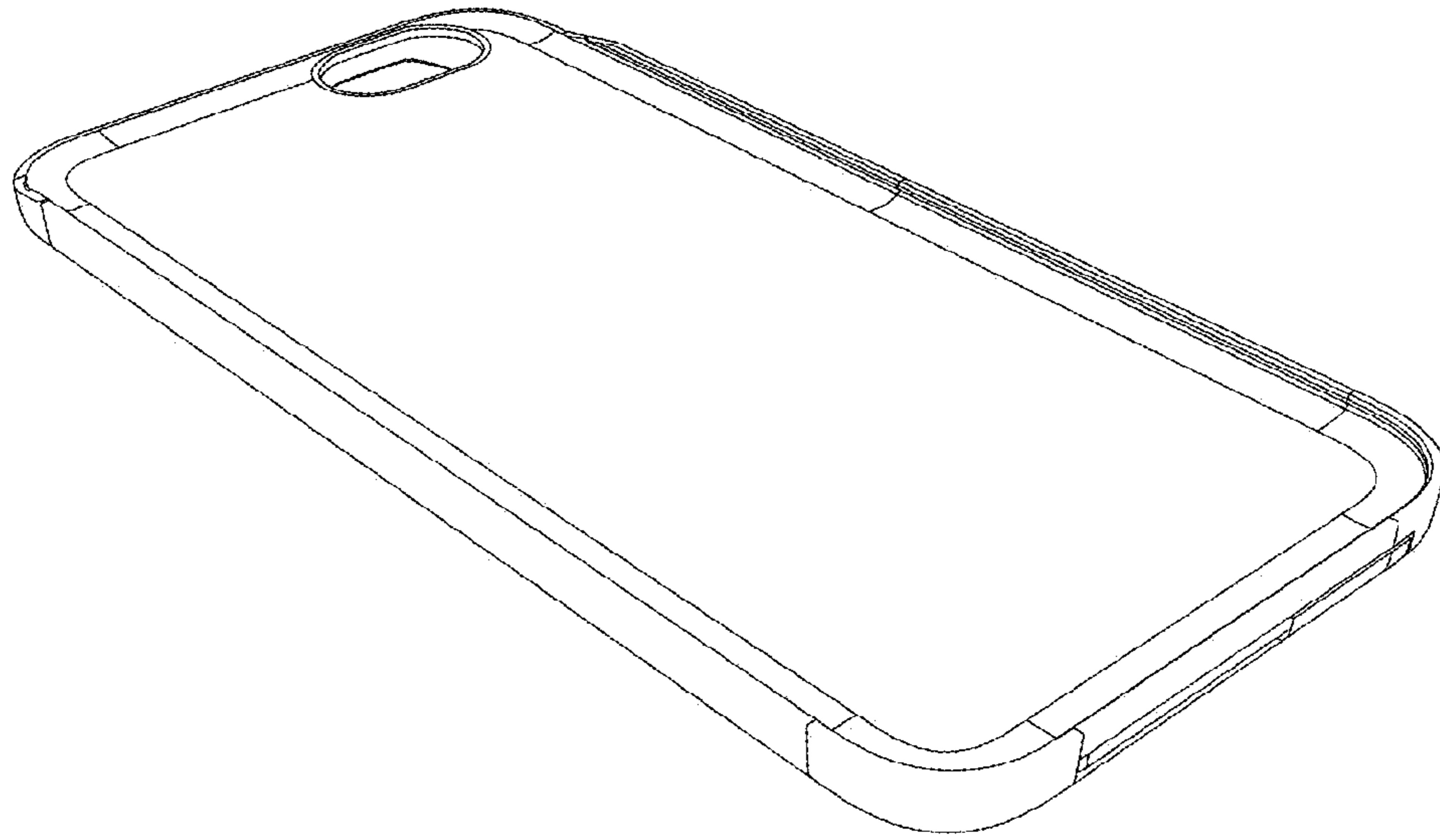

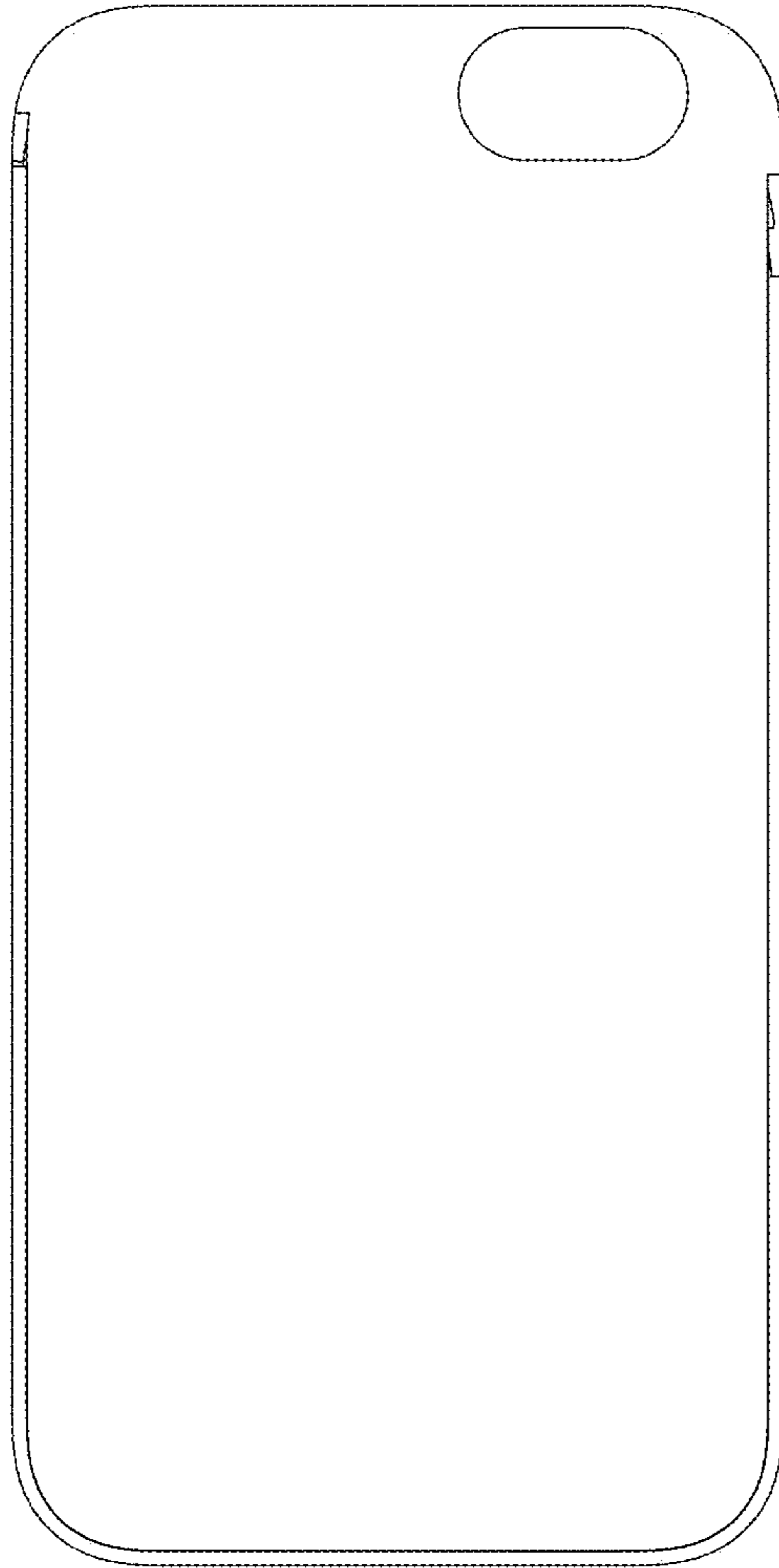

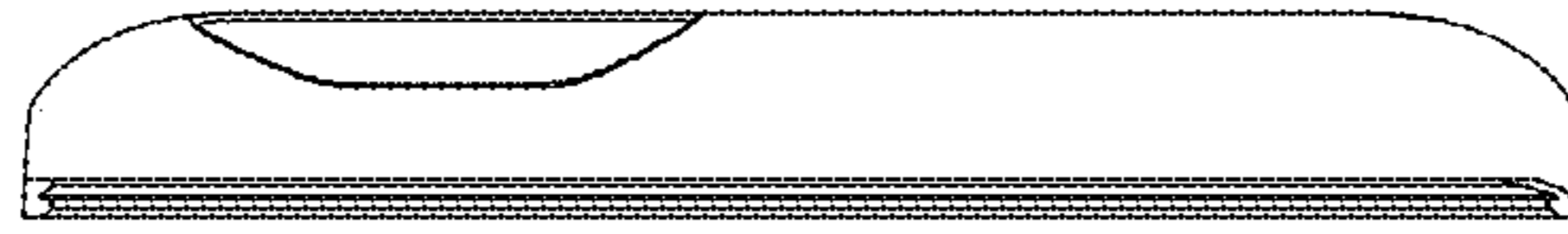

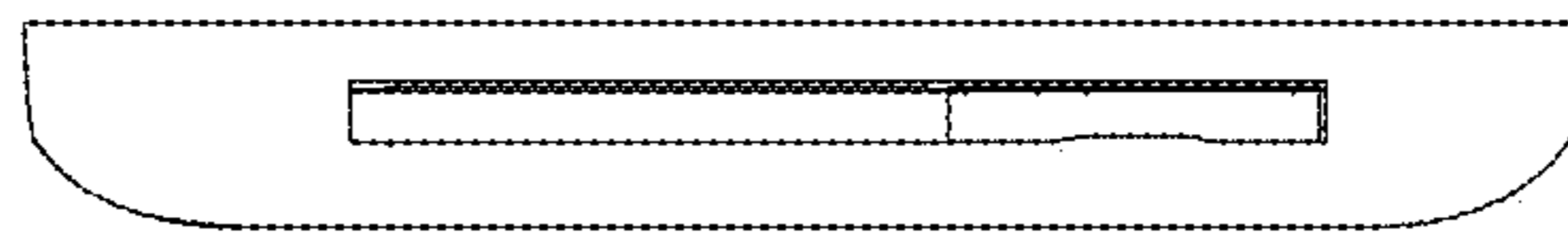
