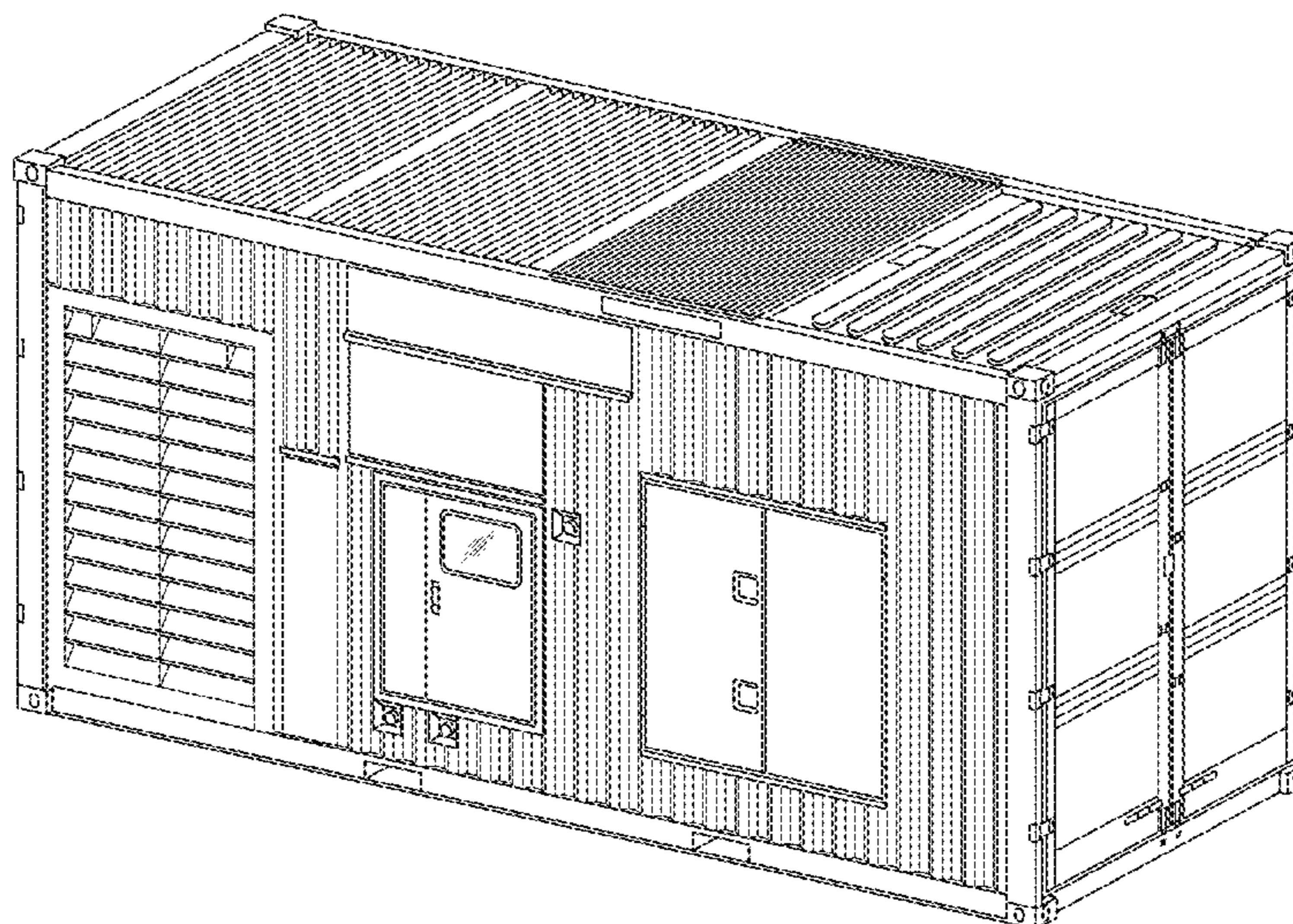
FIG. 1 is a first perspective view of a genset enclosure.

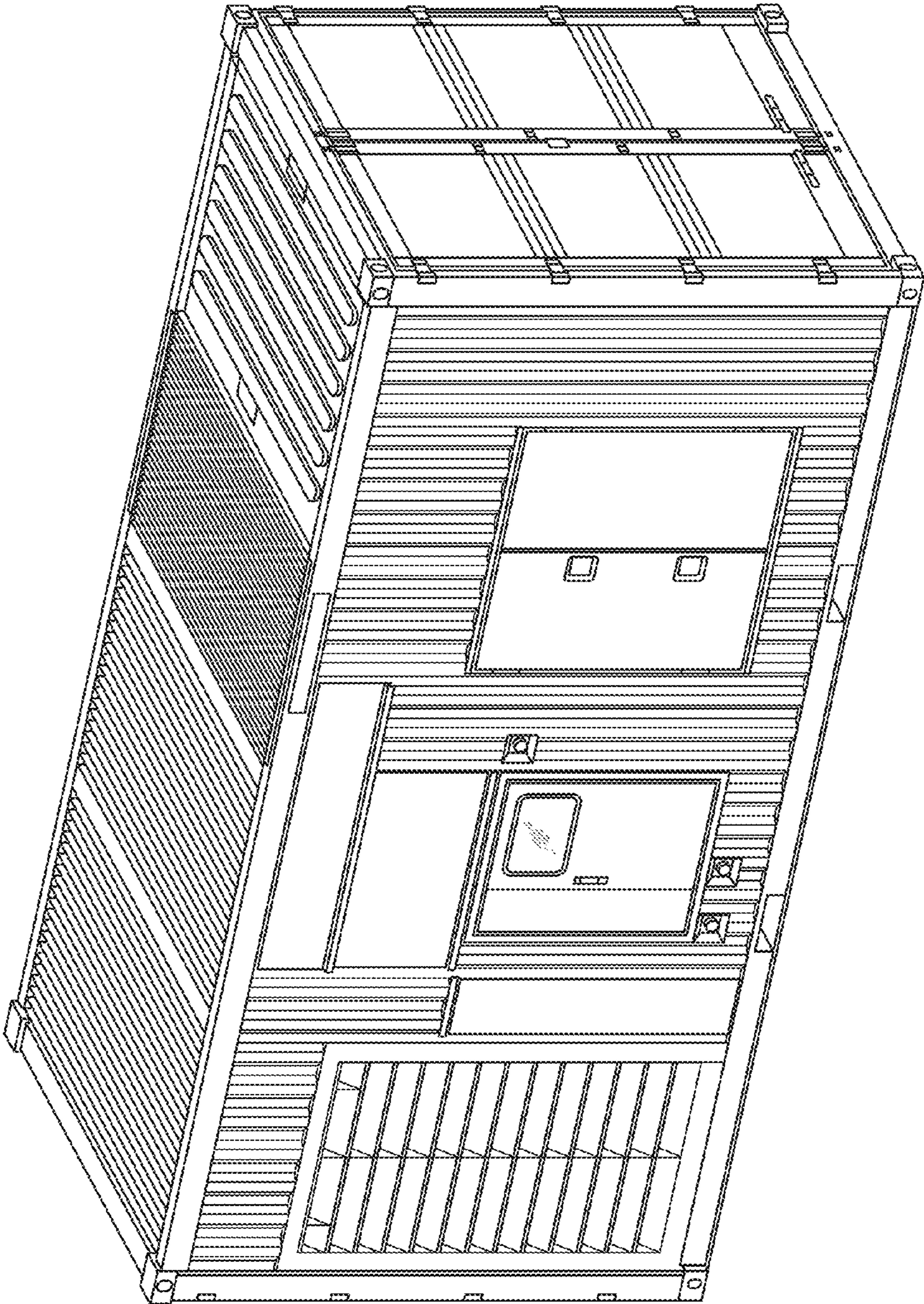

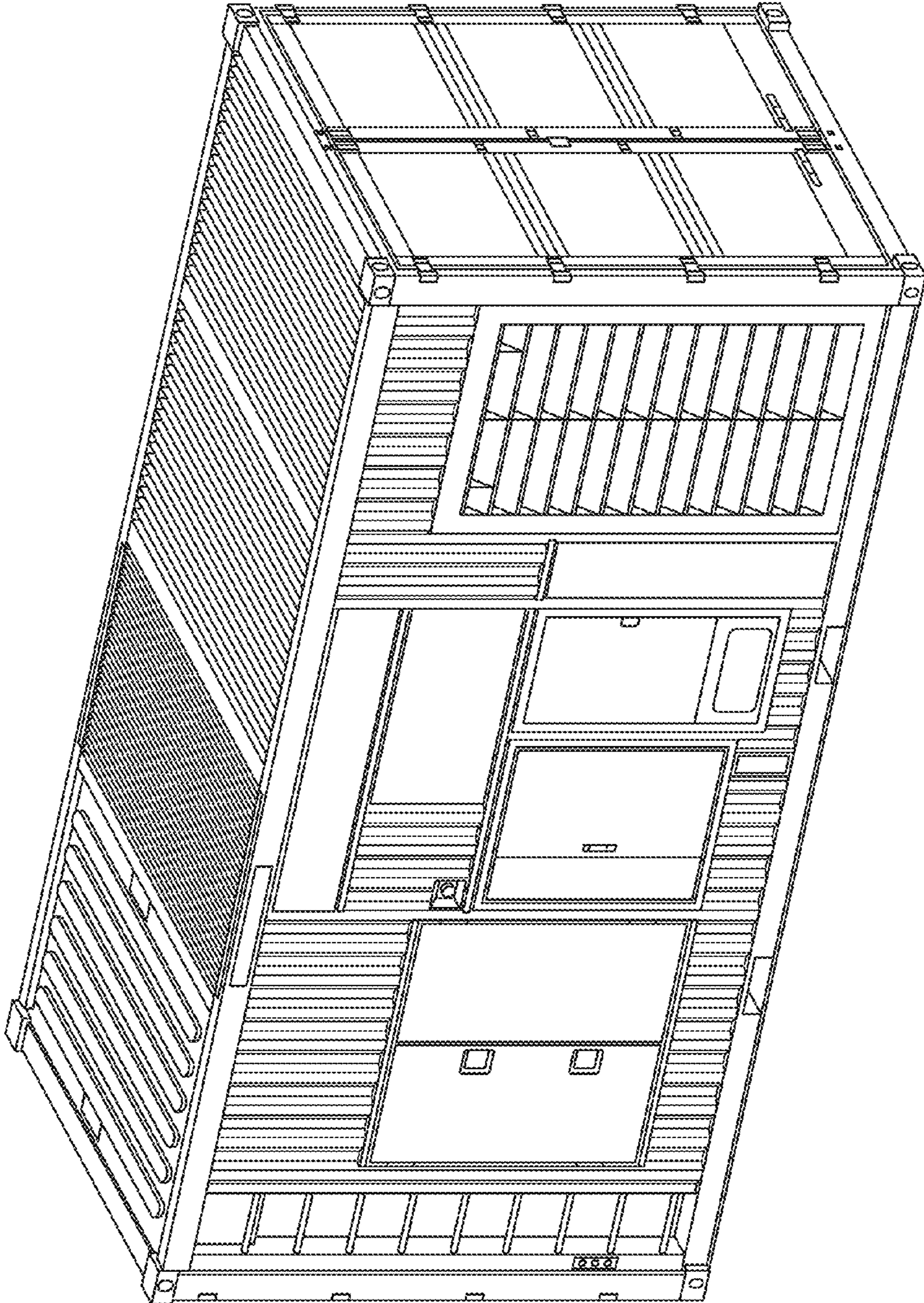

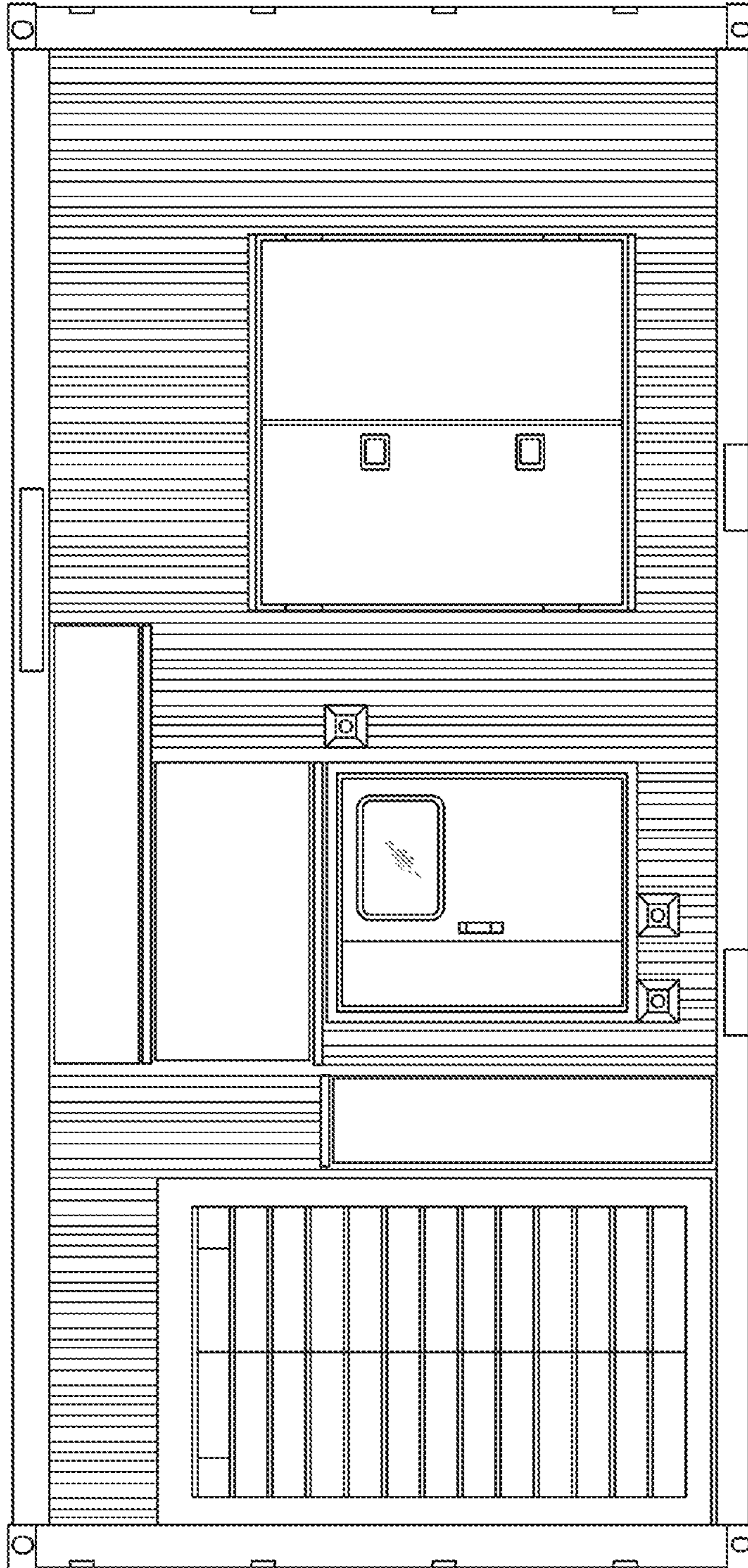

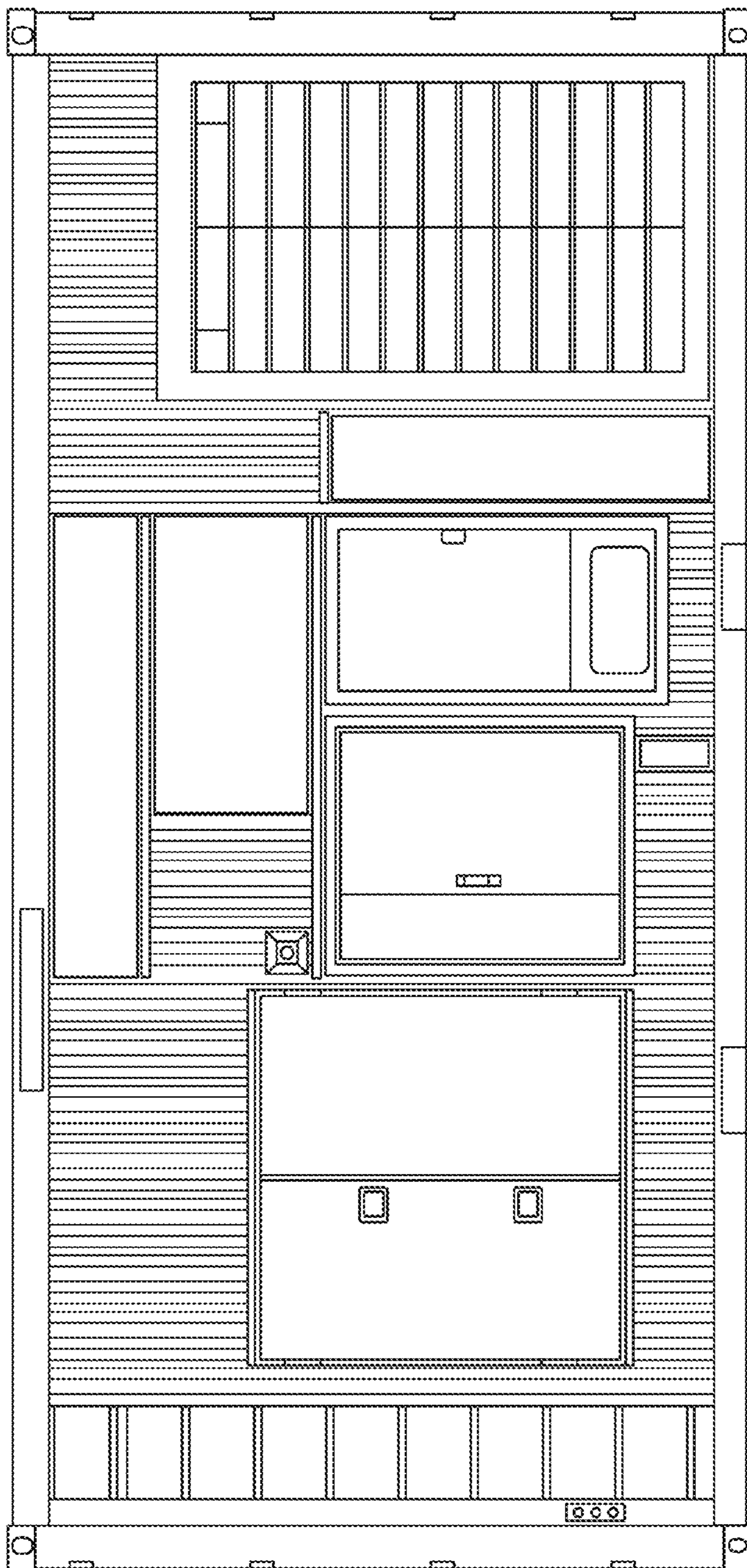

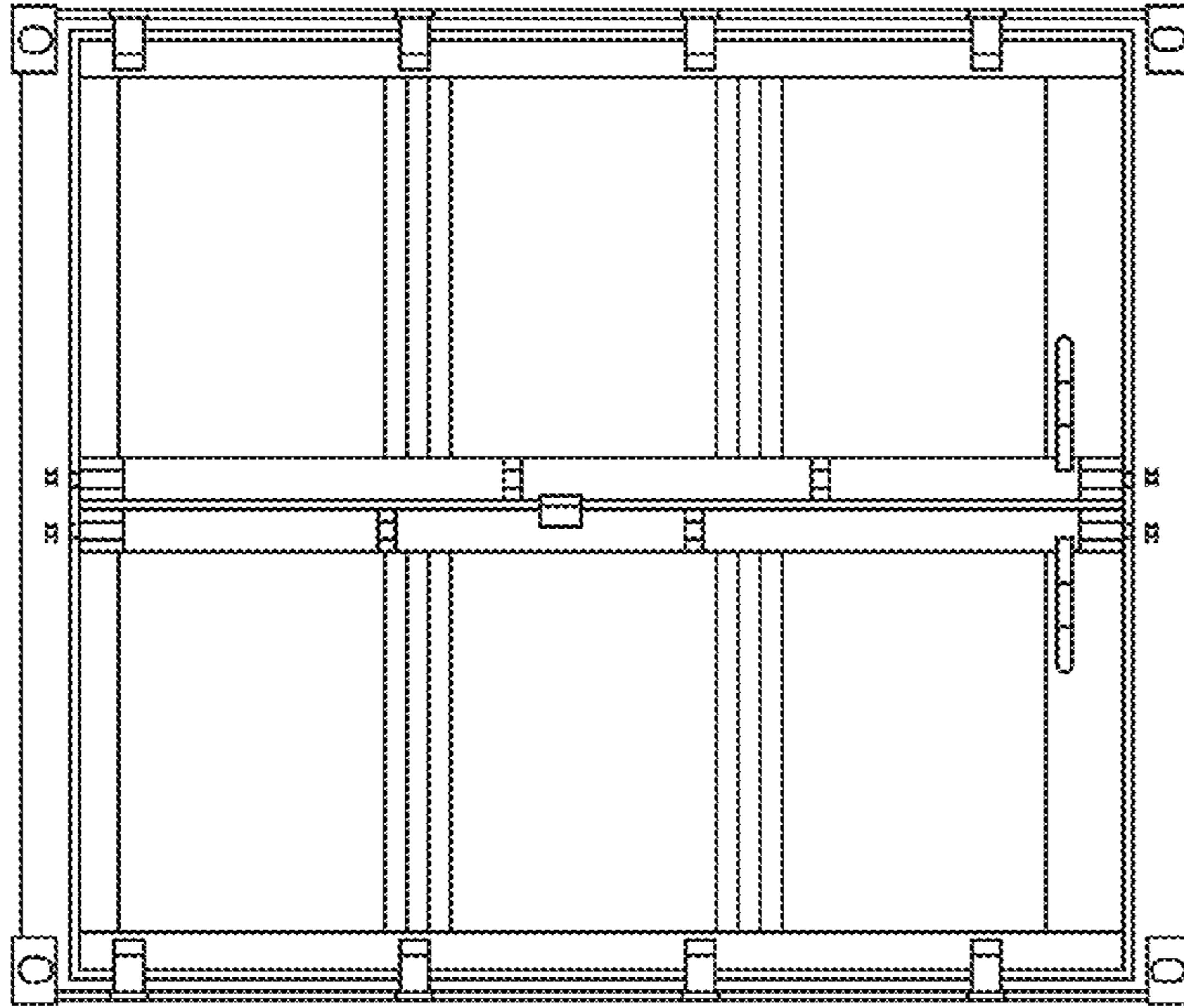

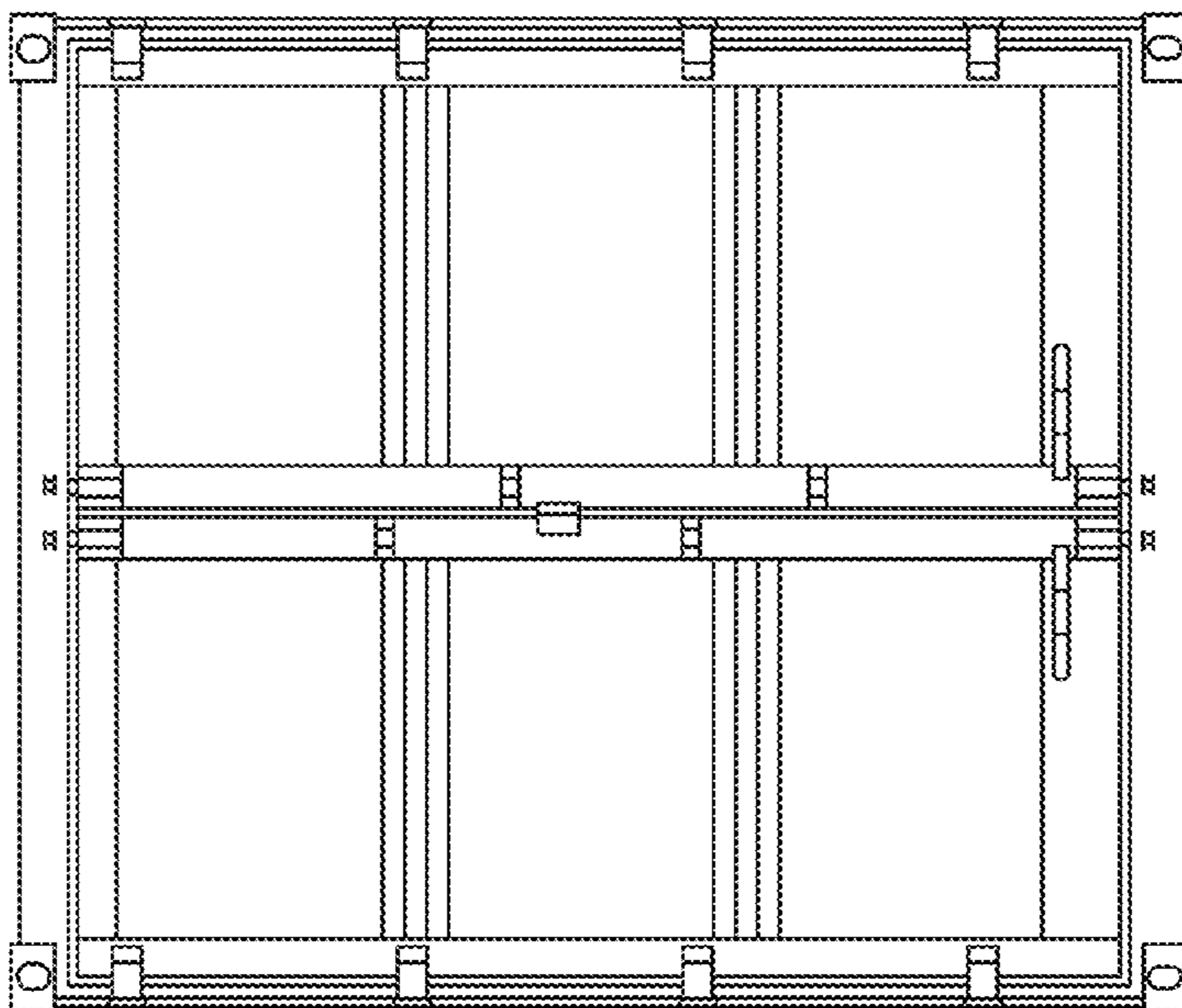

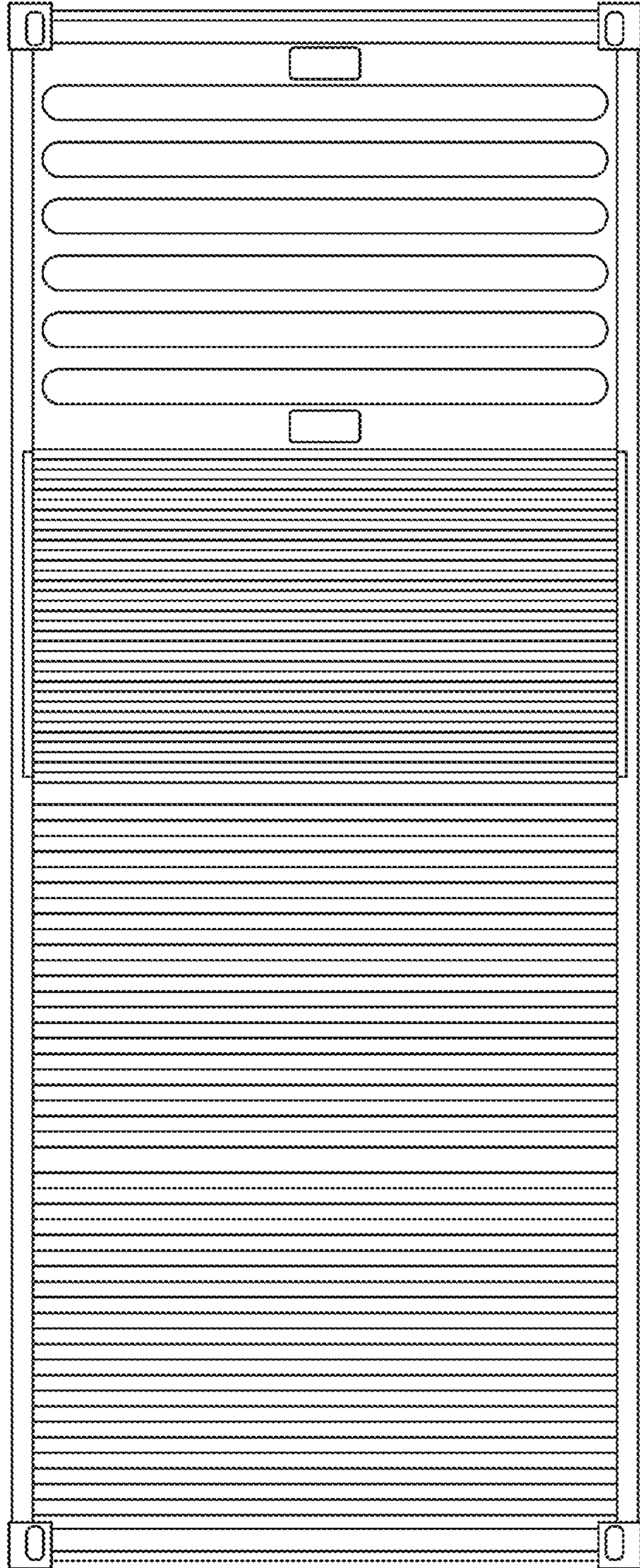
