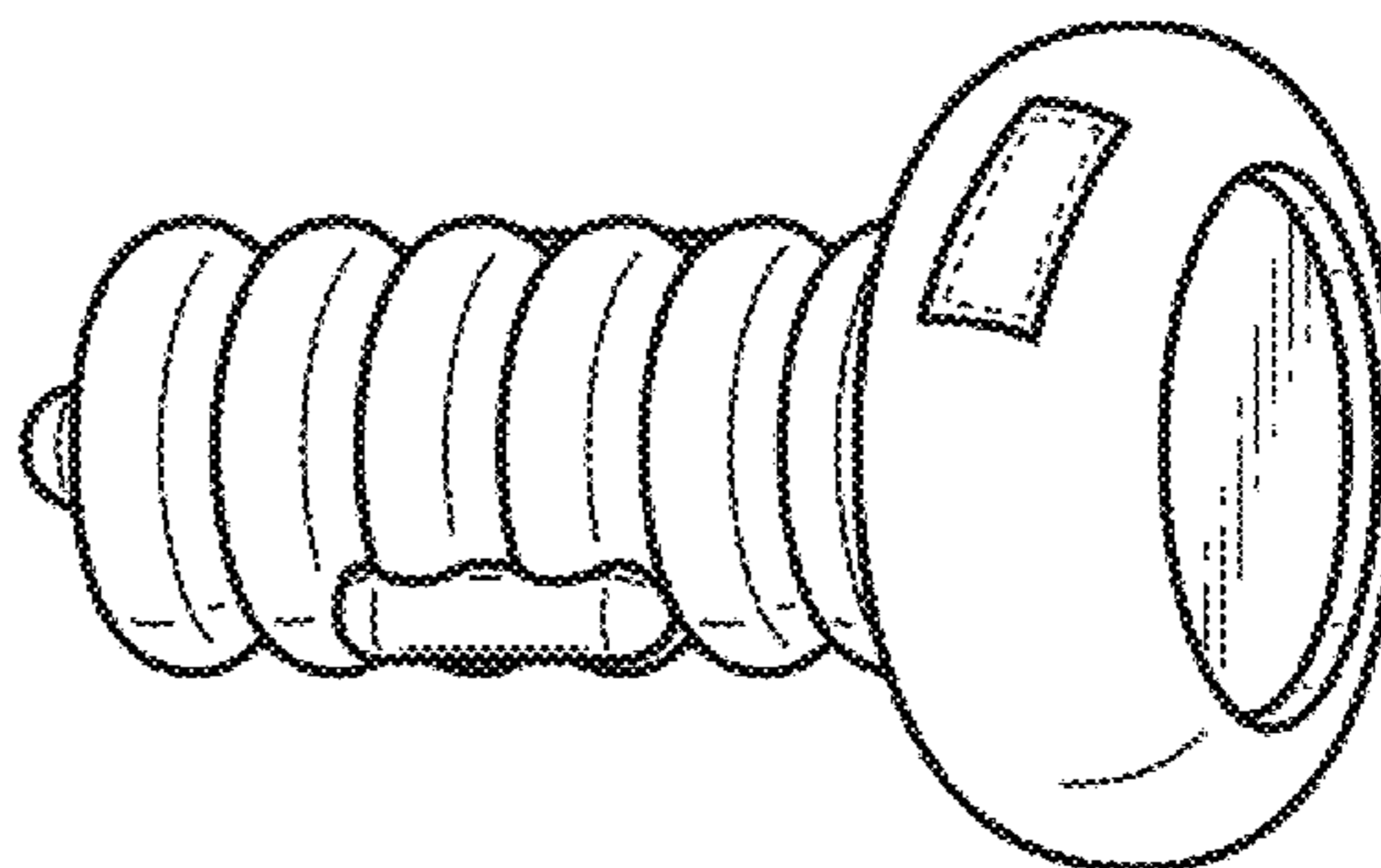
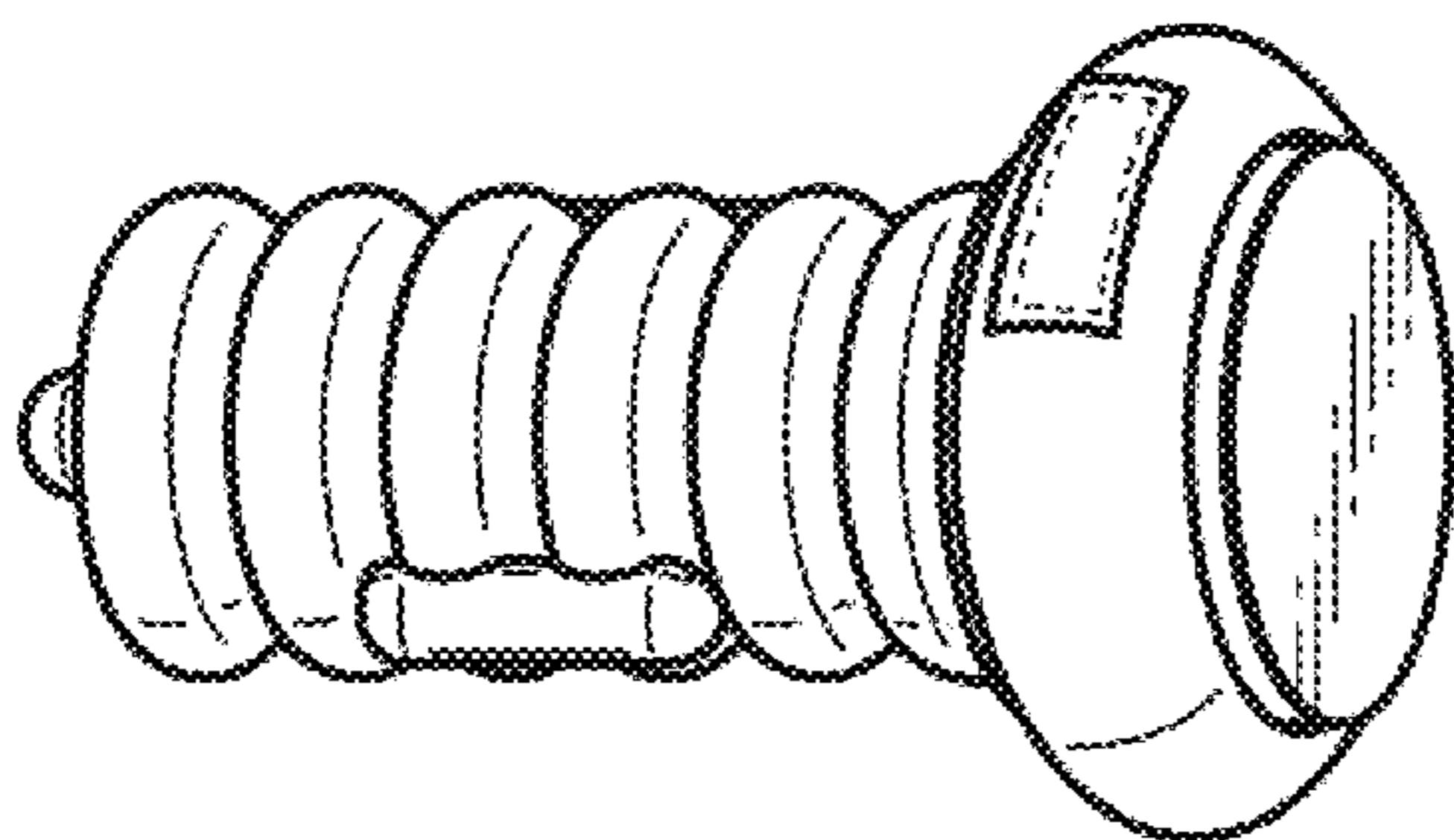
The ornamental design for an accessory charger, as shown and described.

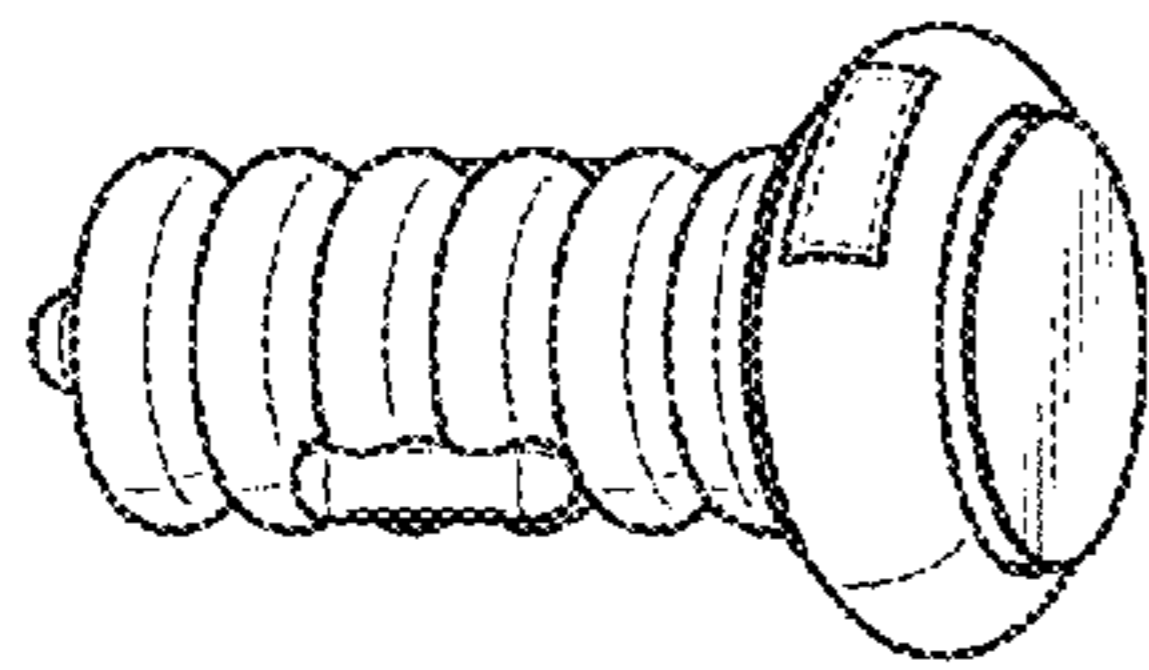

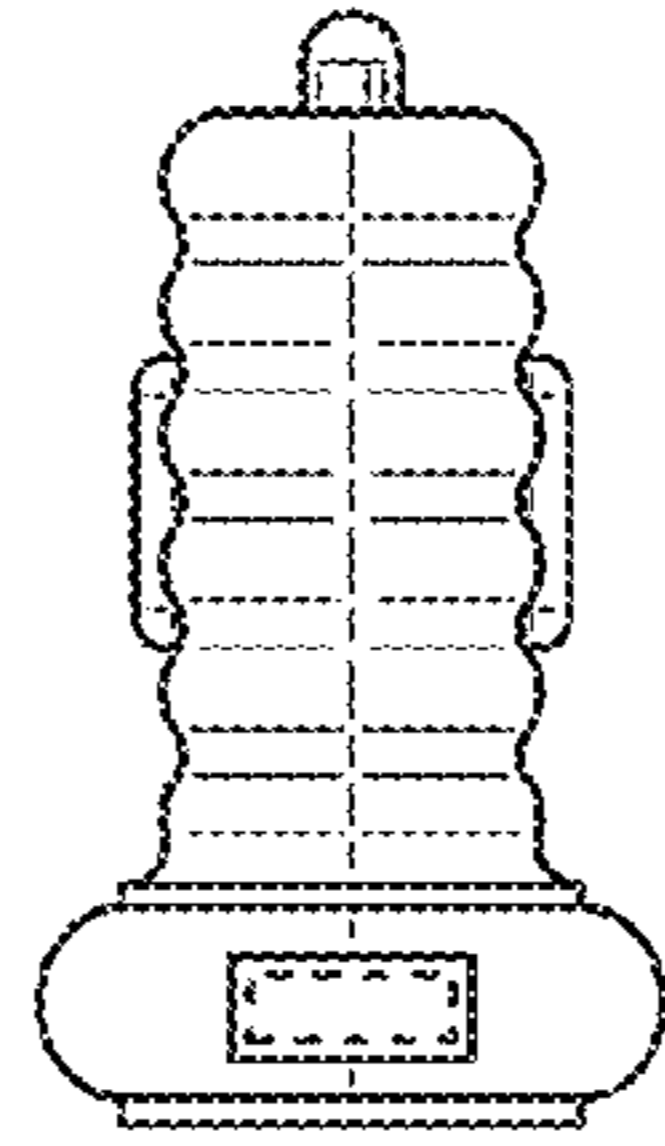

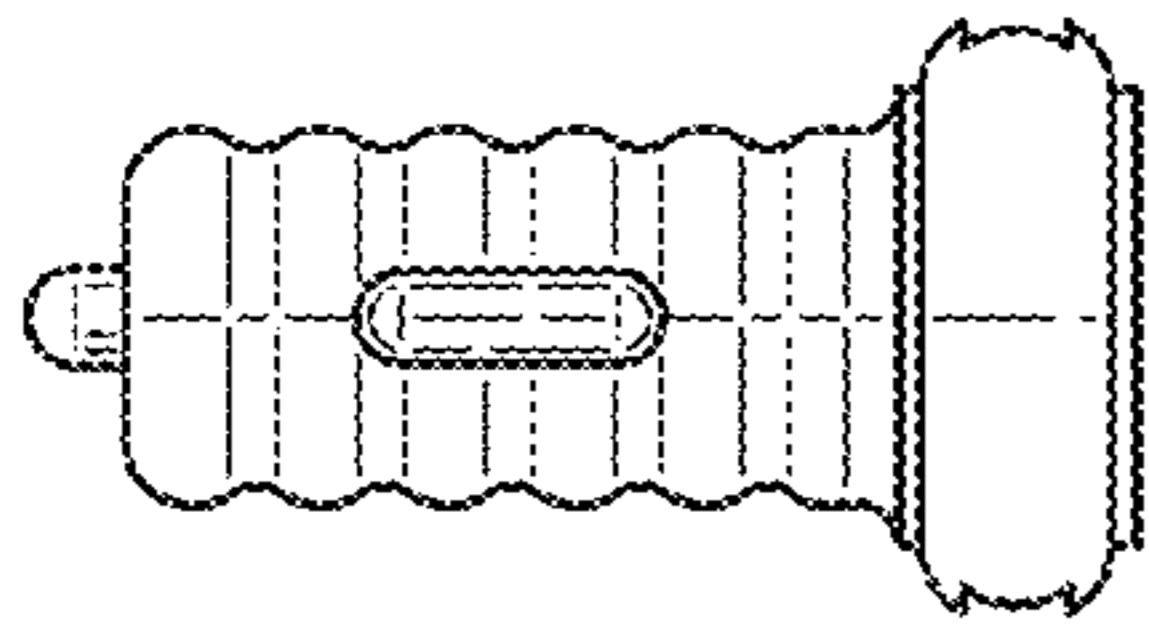

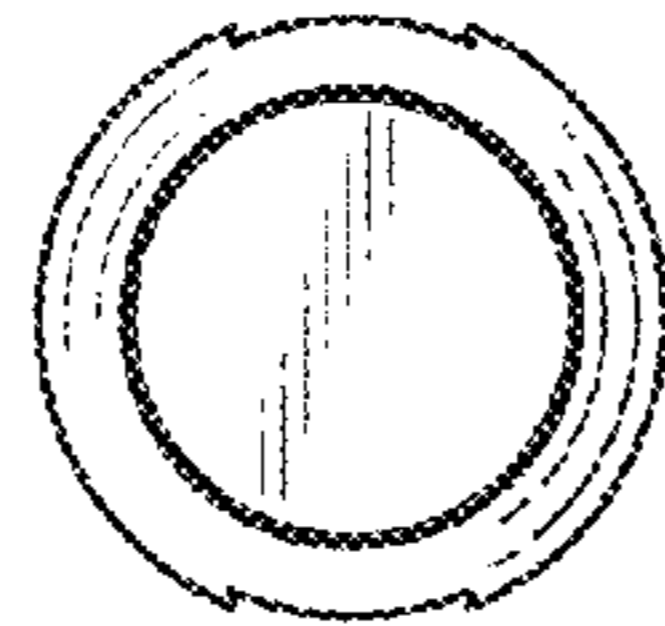

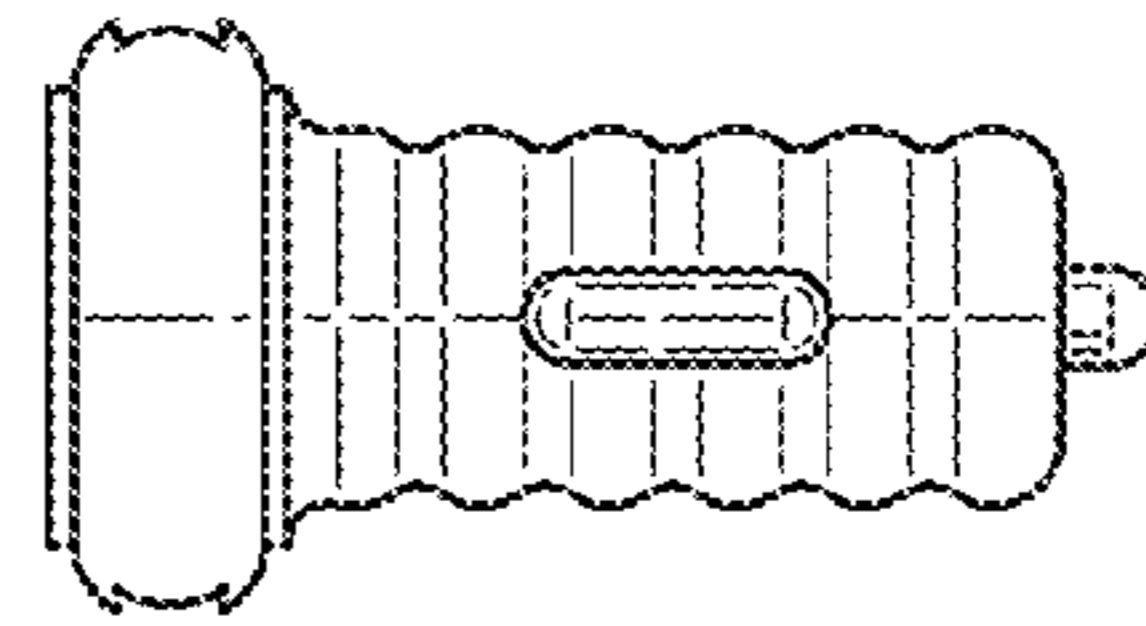

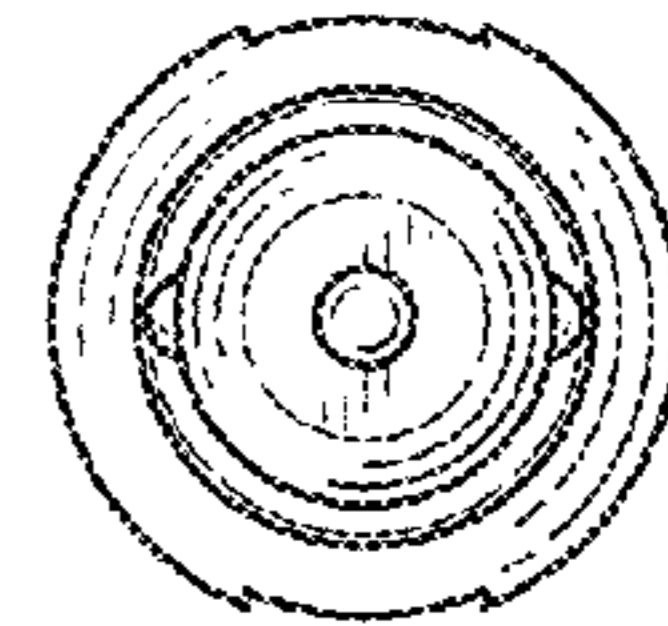

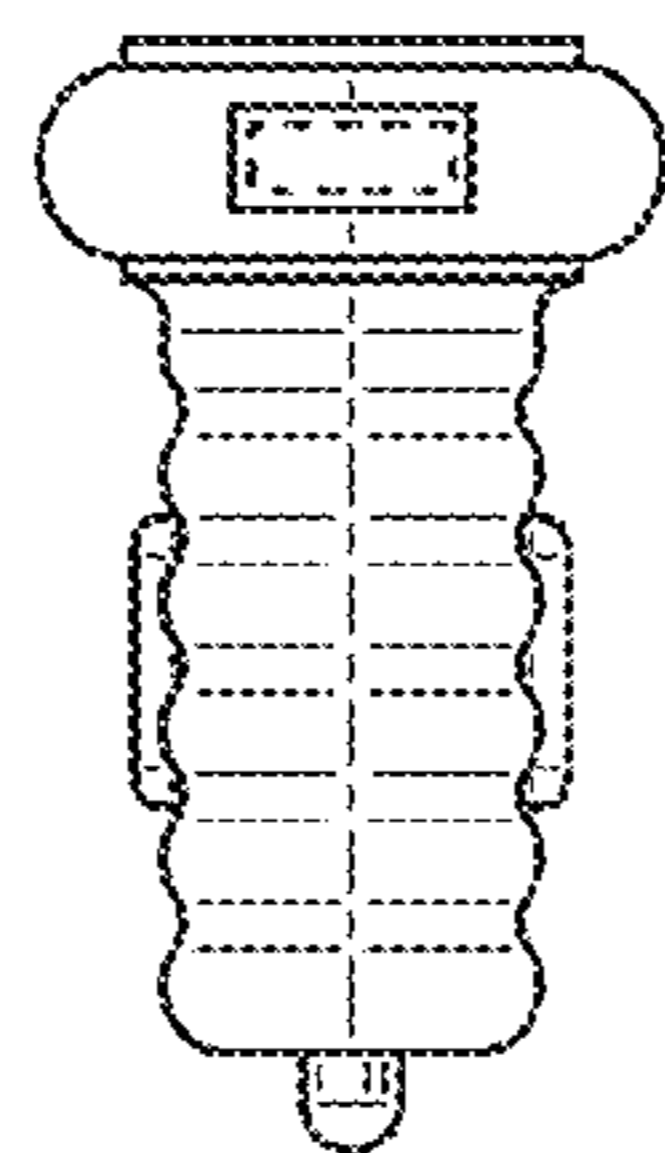

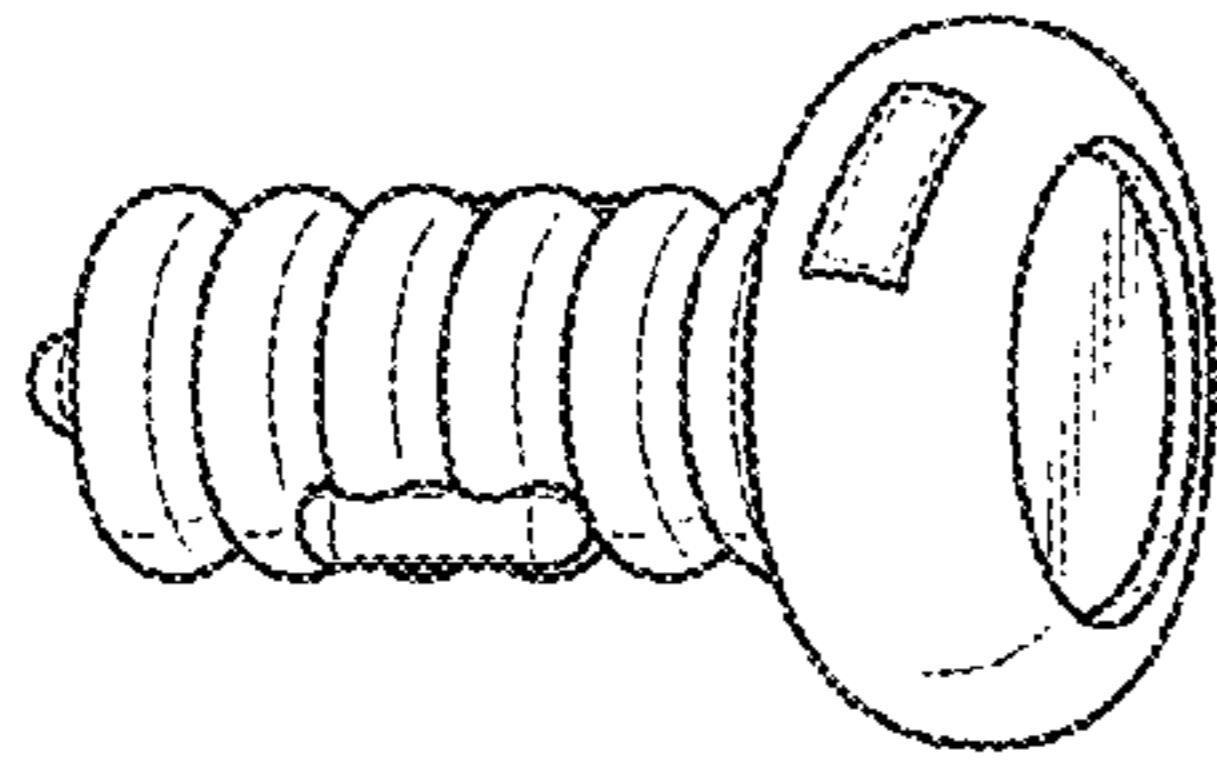

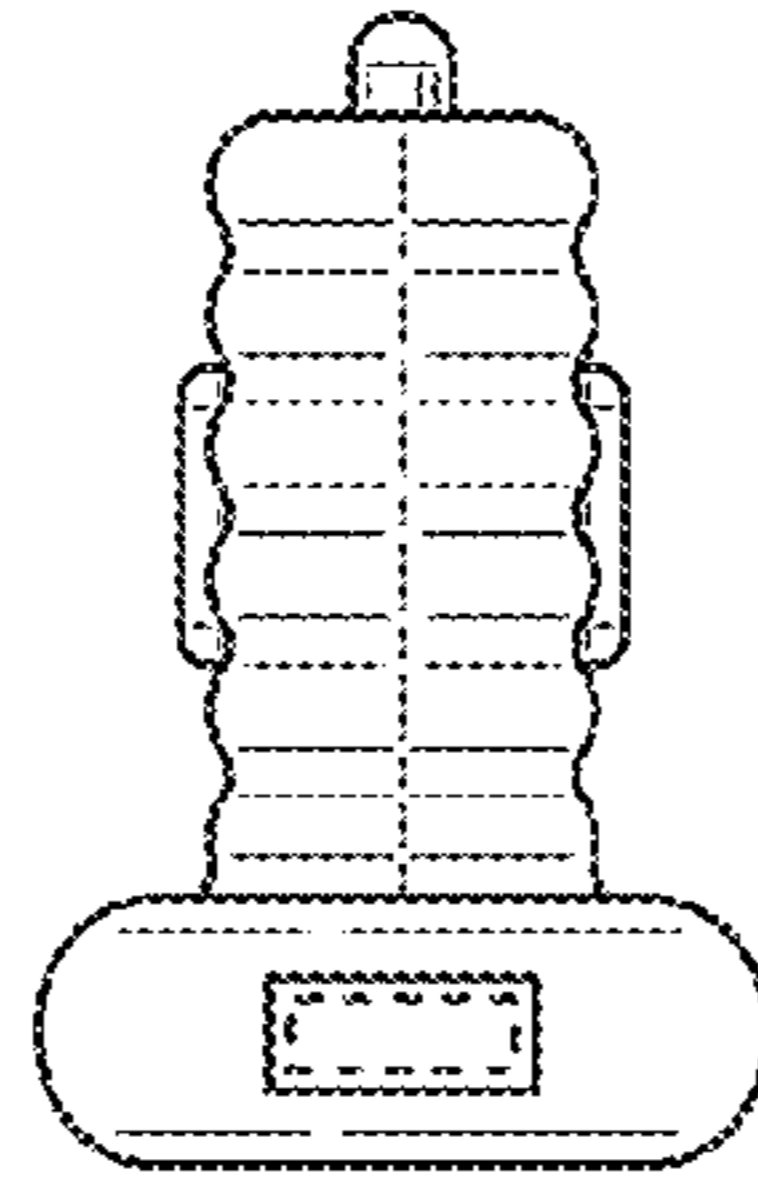

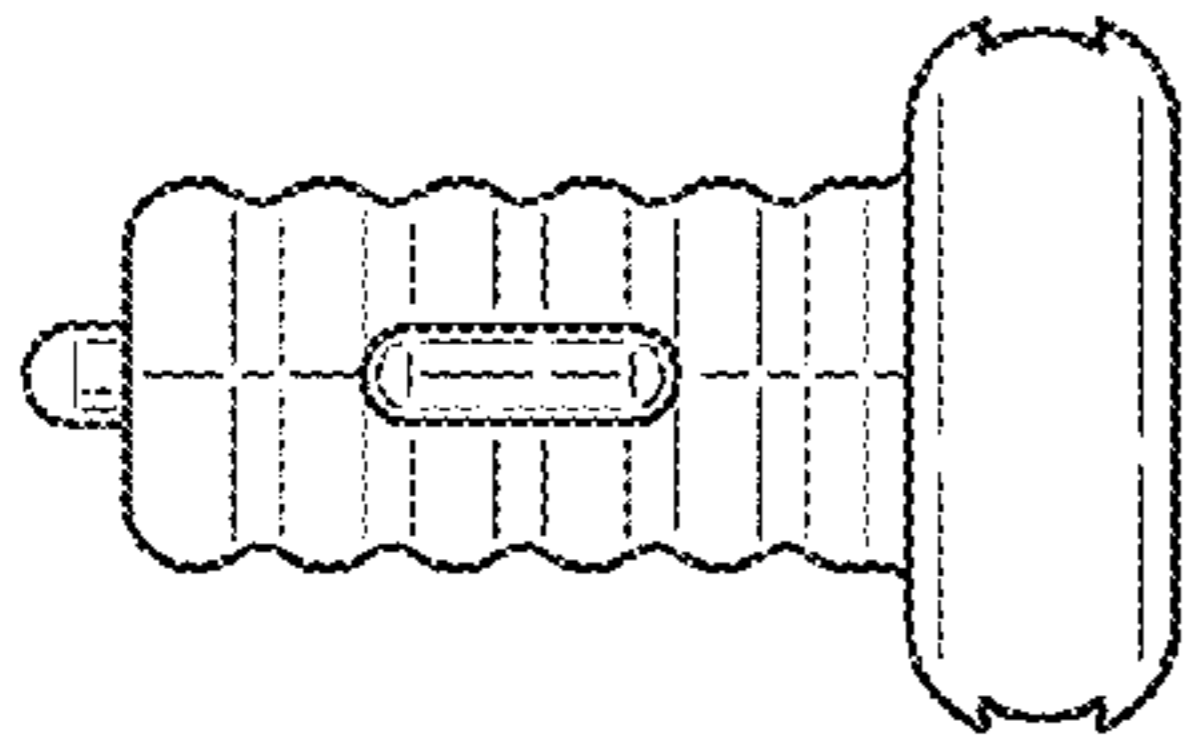

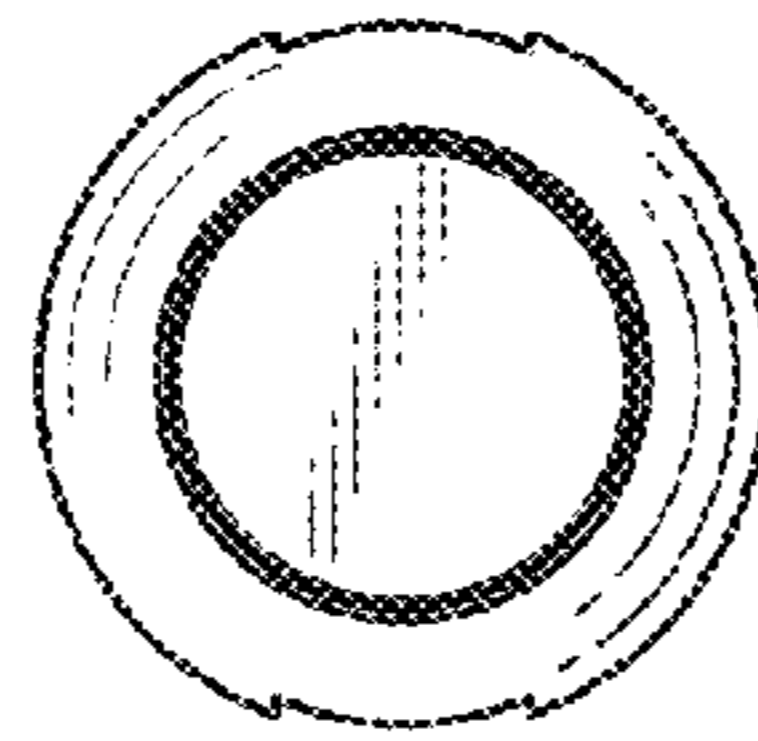

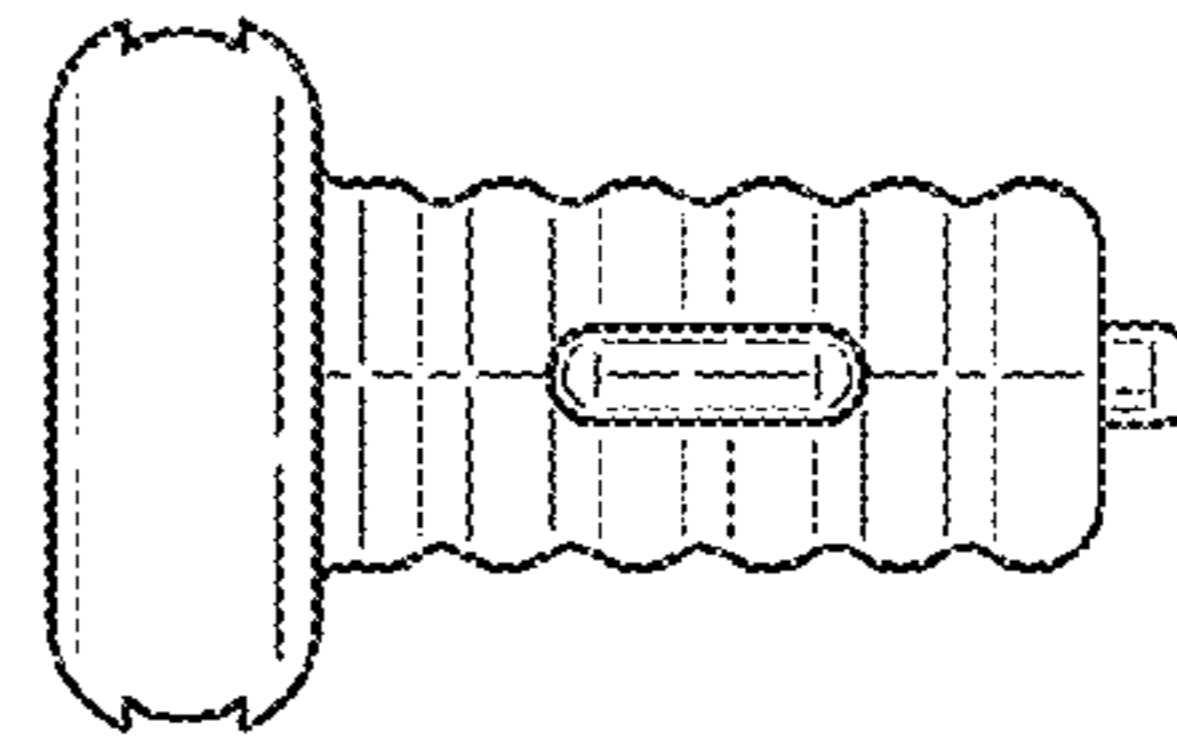

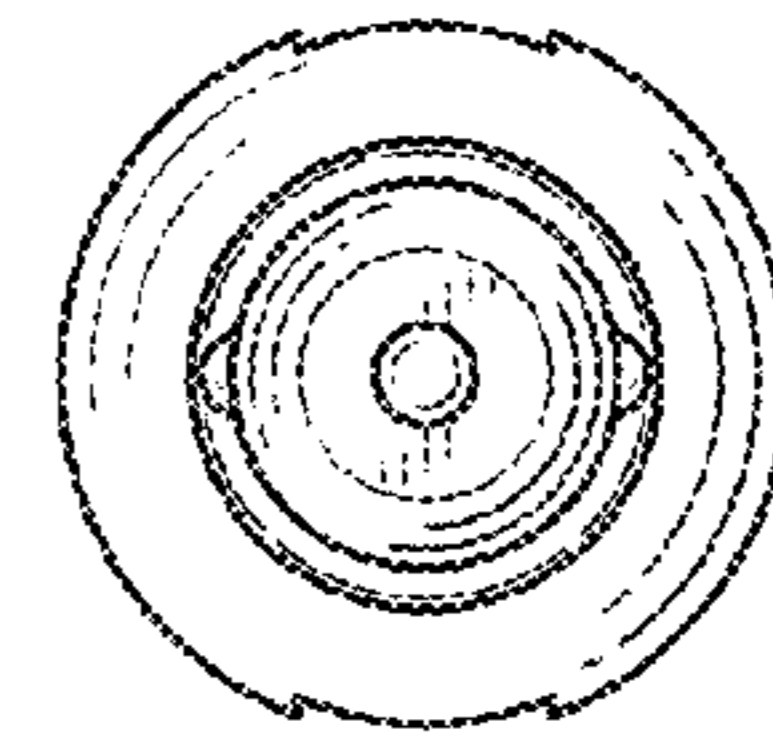

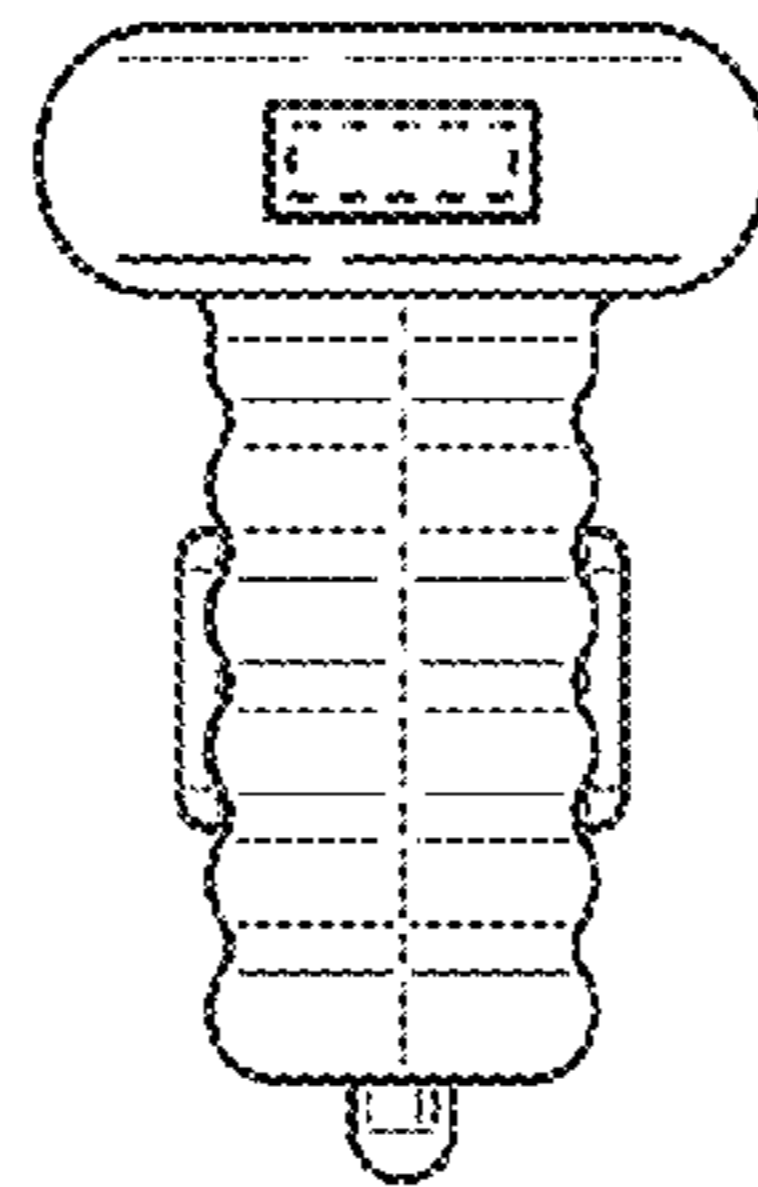
