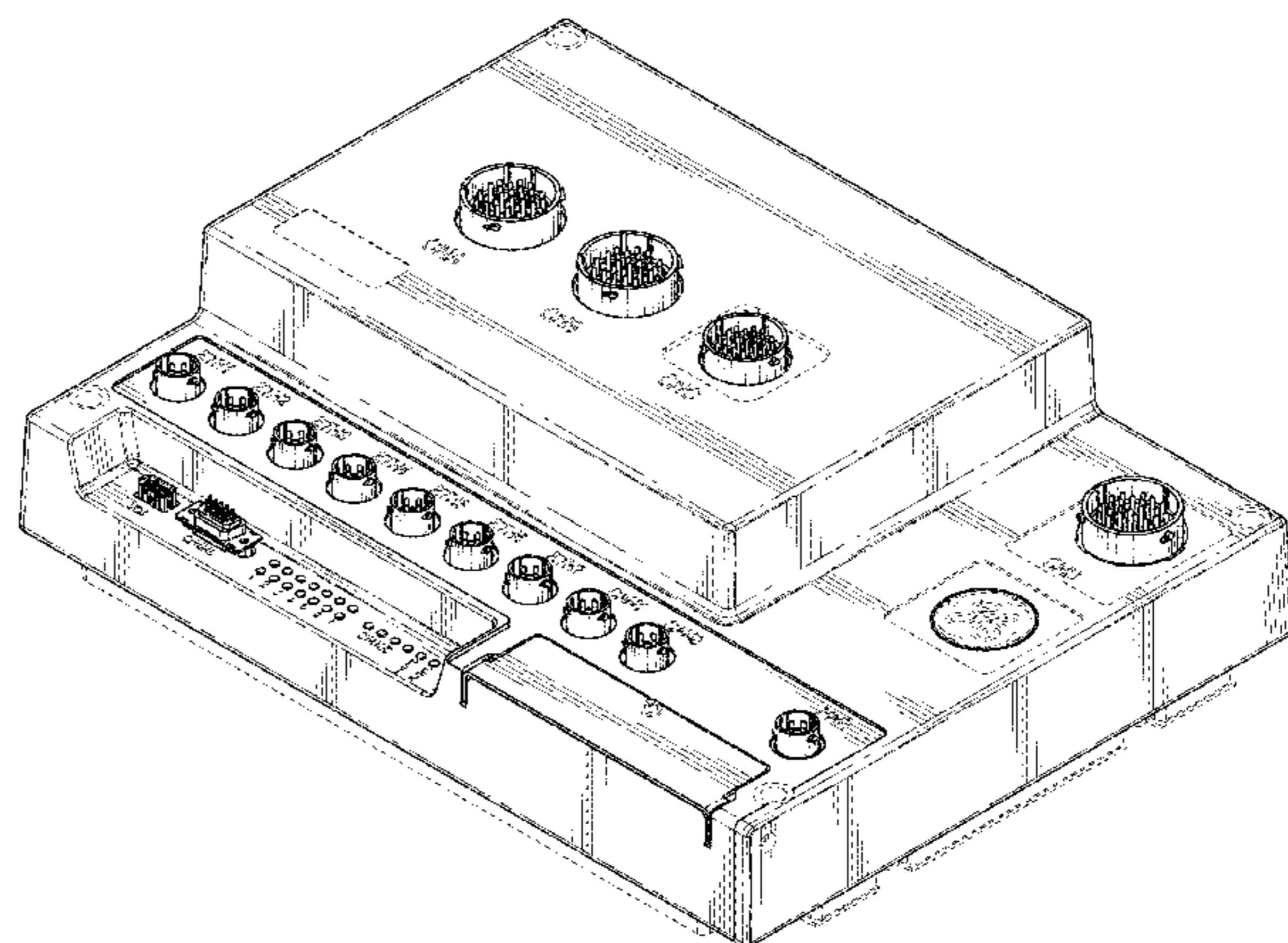
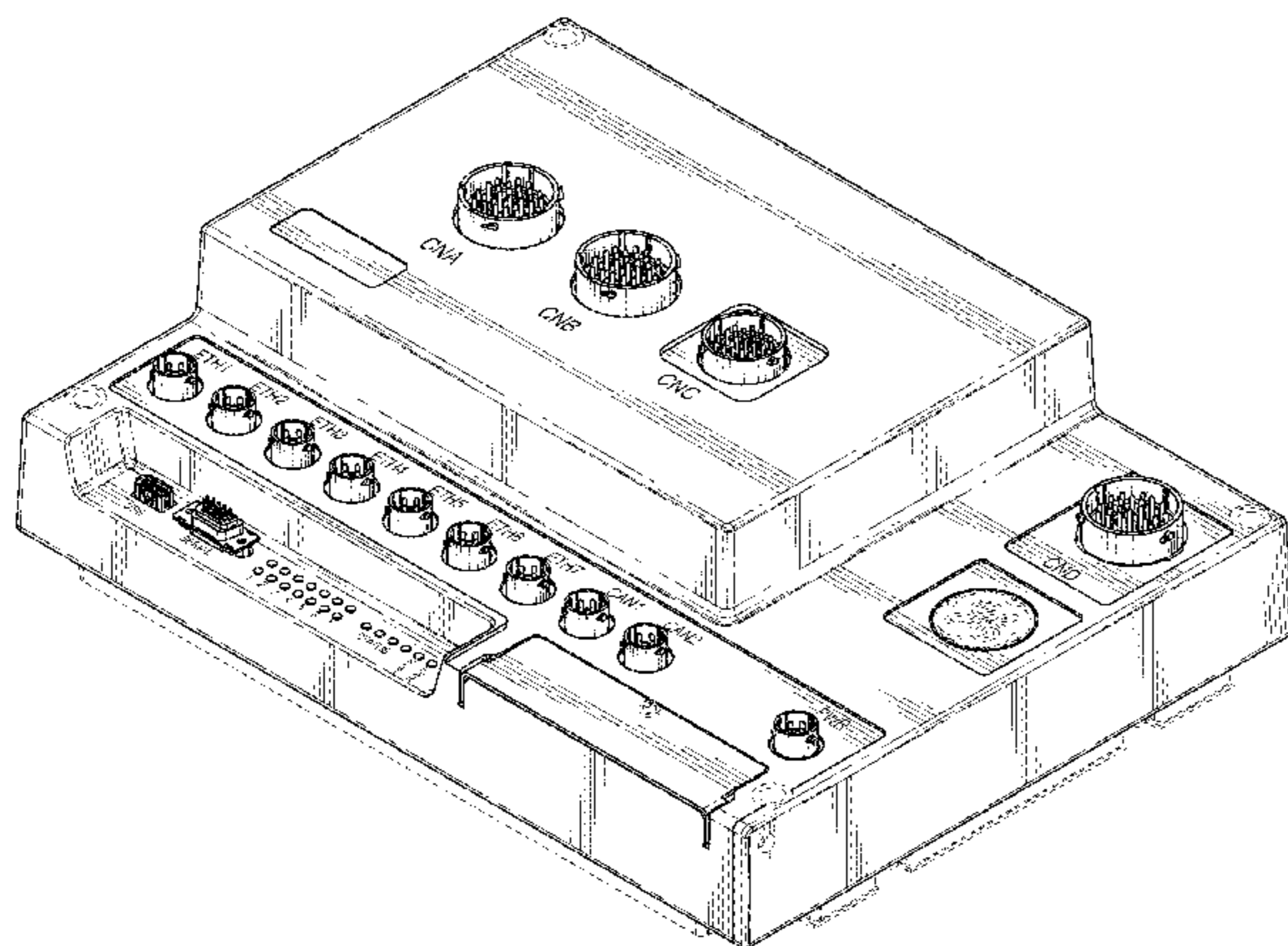
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a system controller enclosure  
depicting a first embodiment of a new design;  
FIG. 2 is a front elevational view thereof;

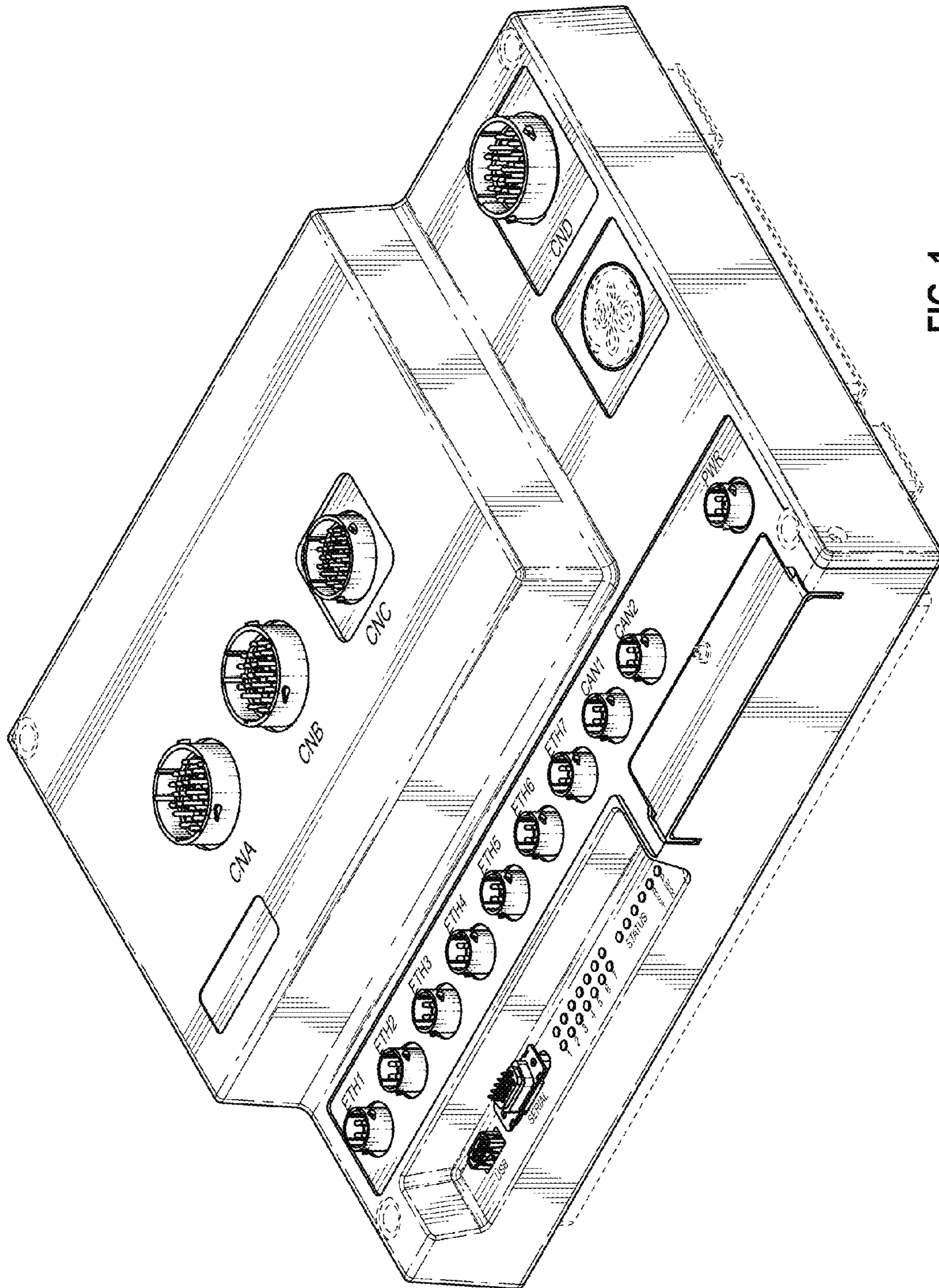

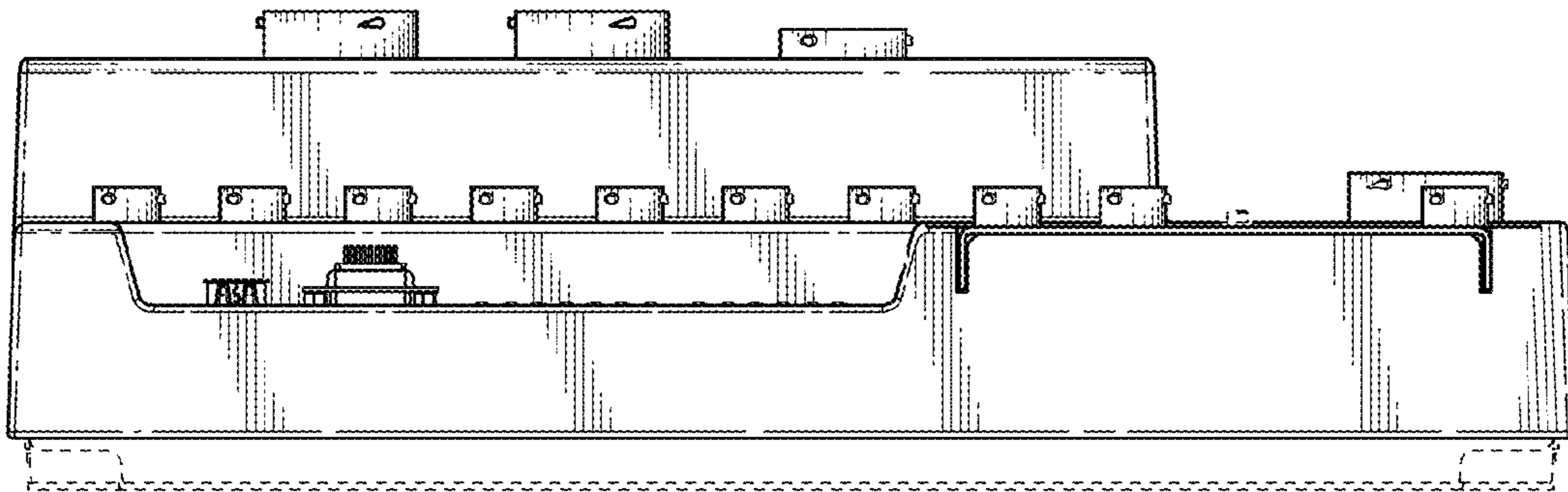

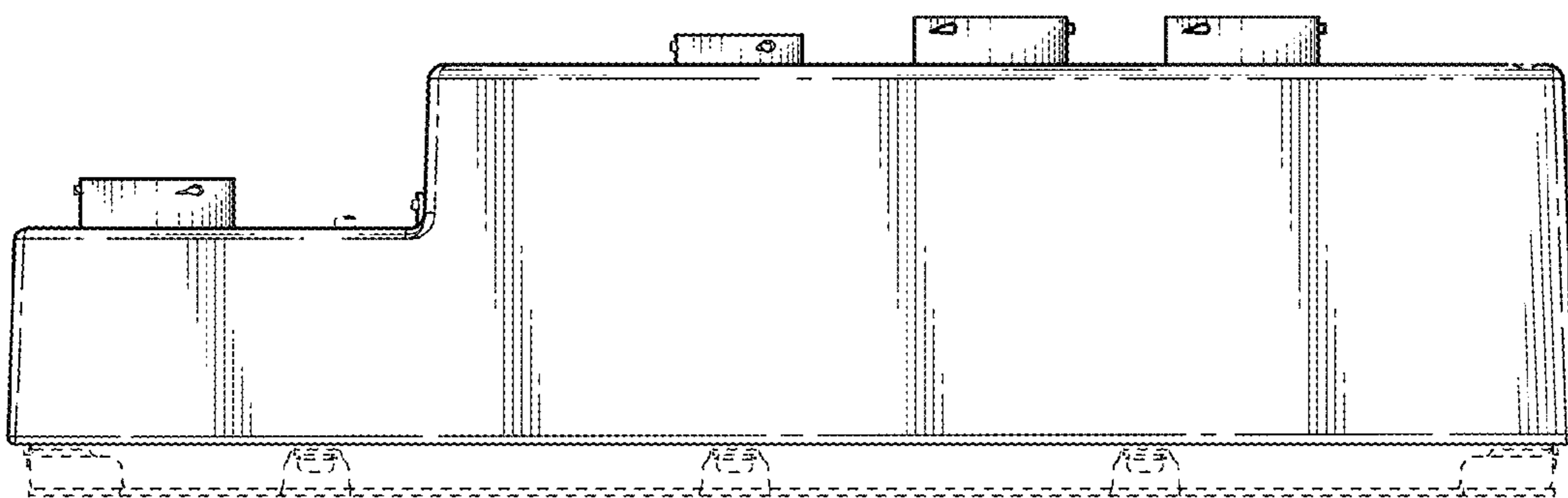

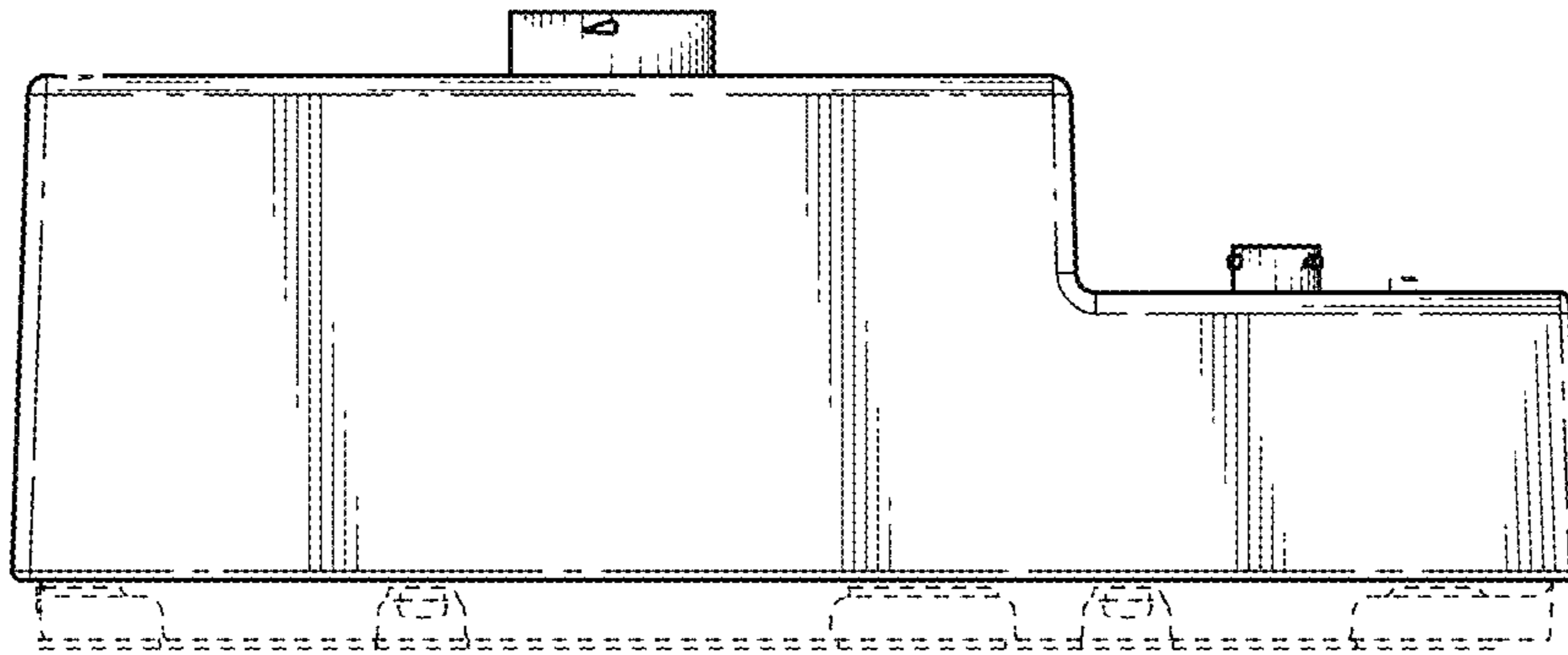

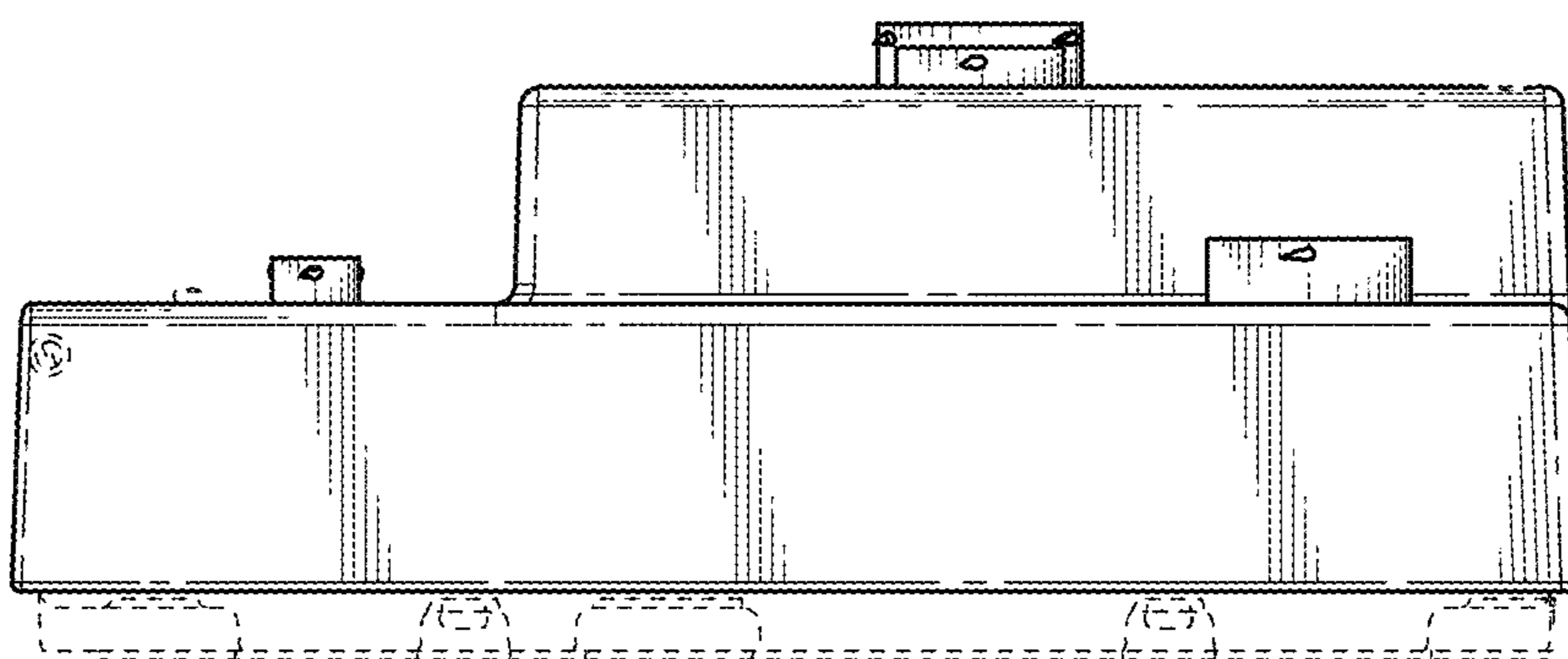

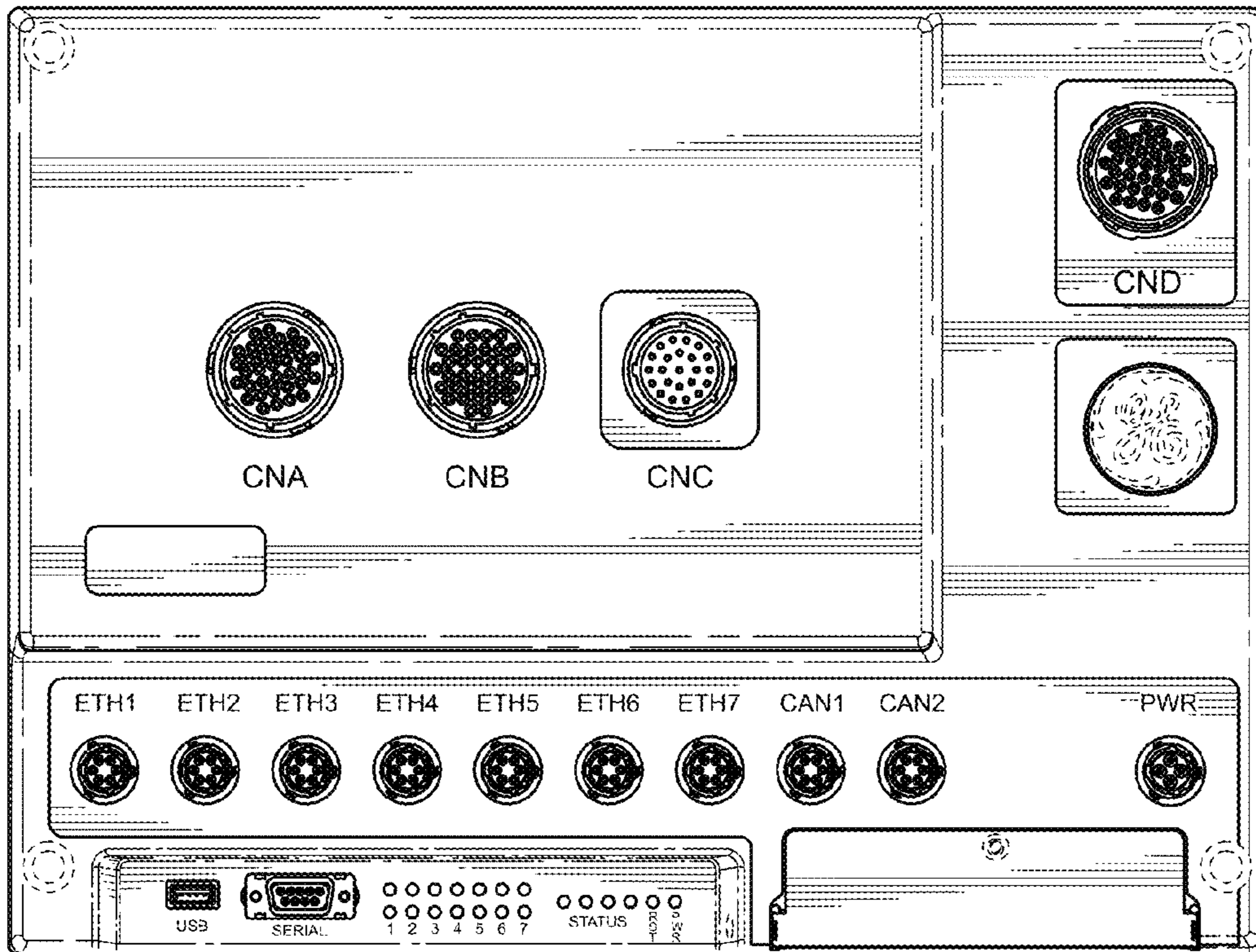

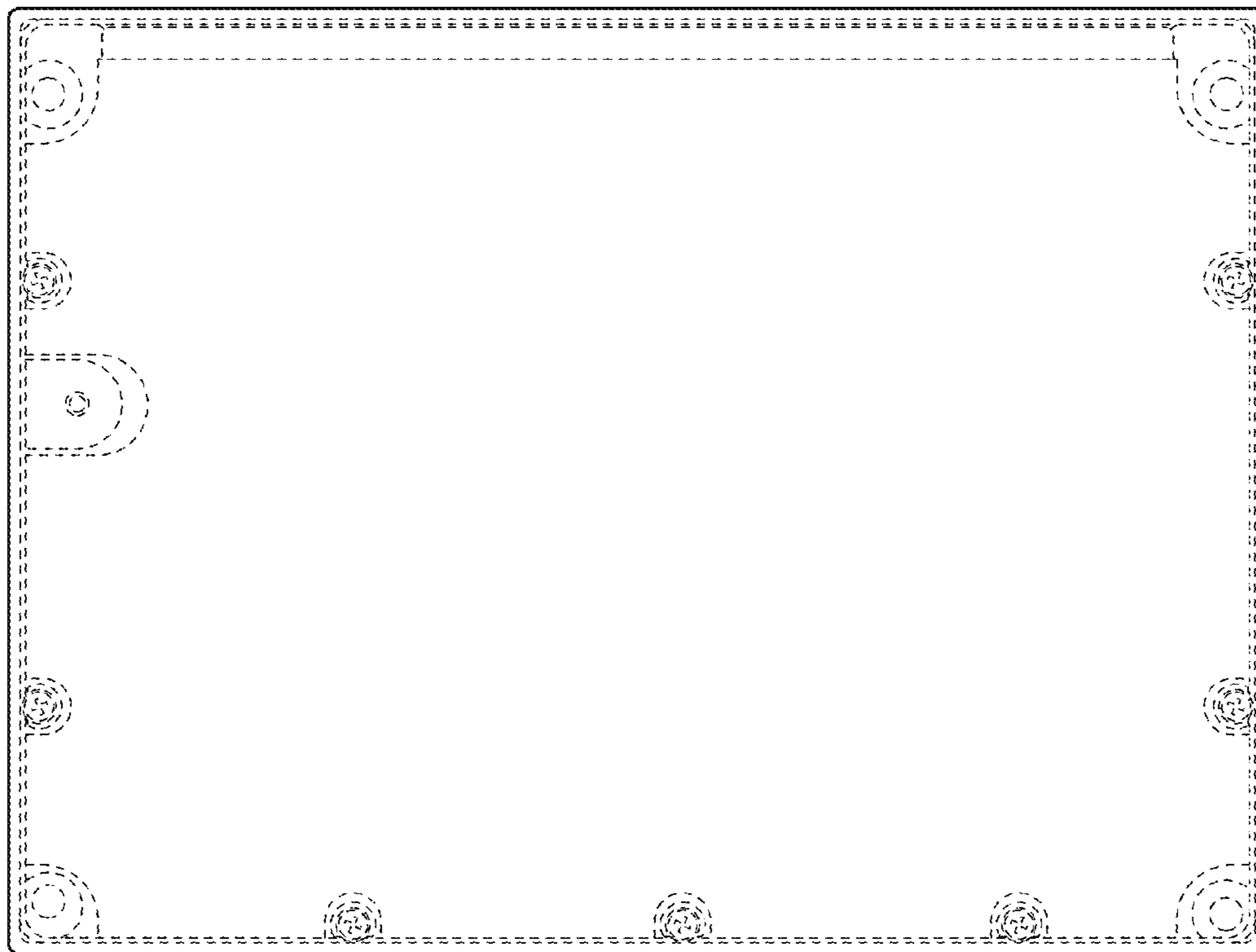

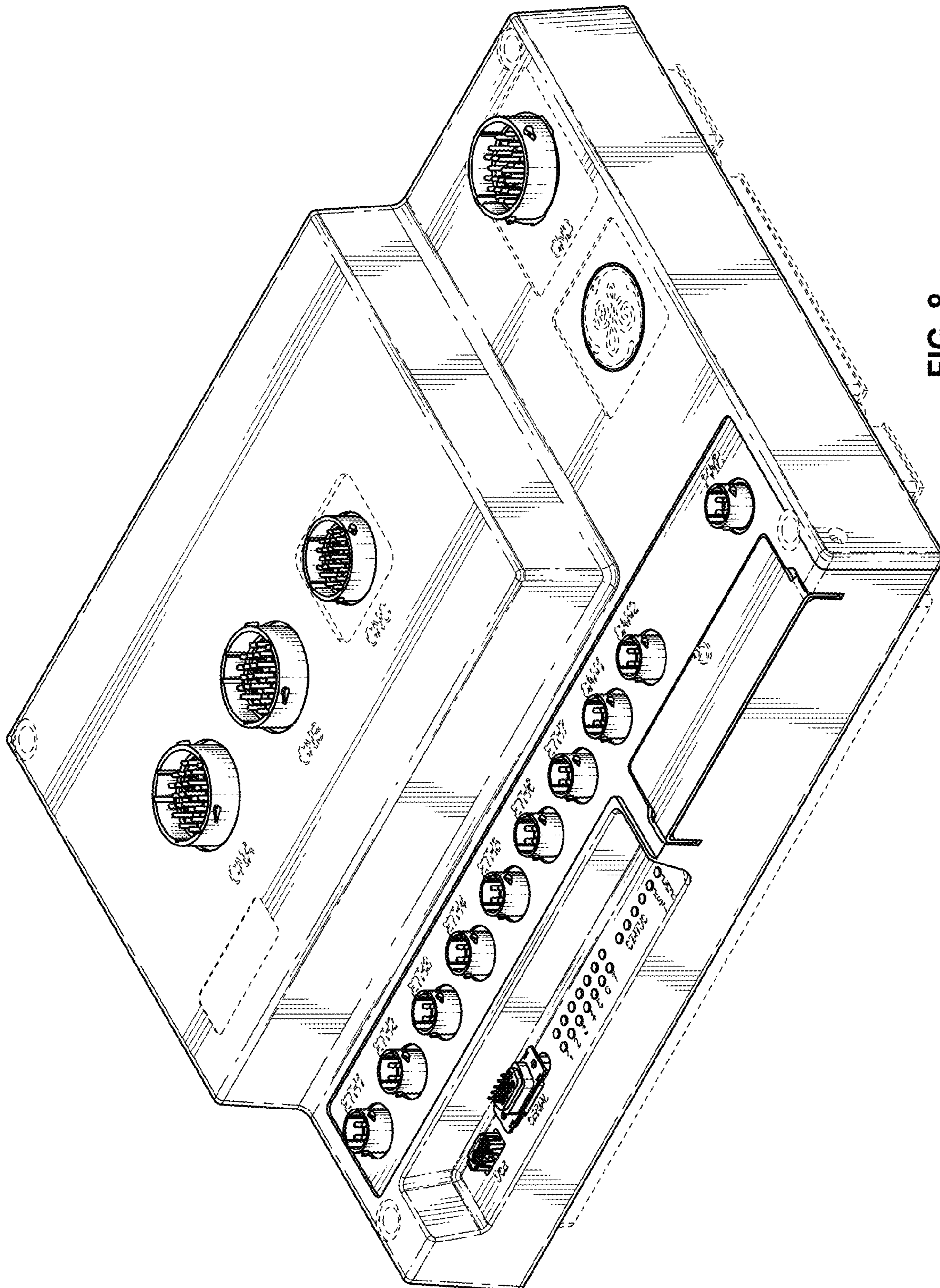

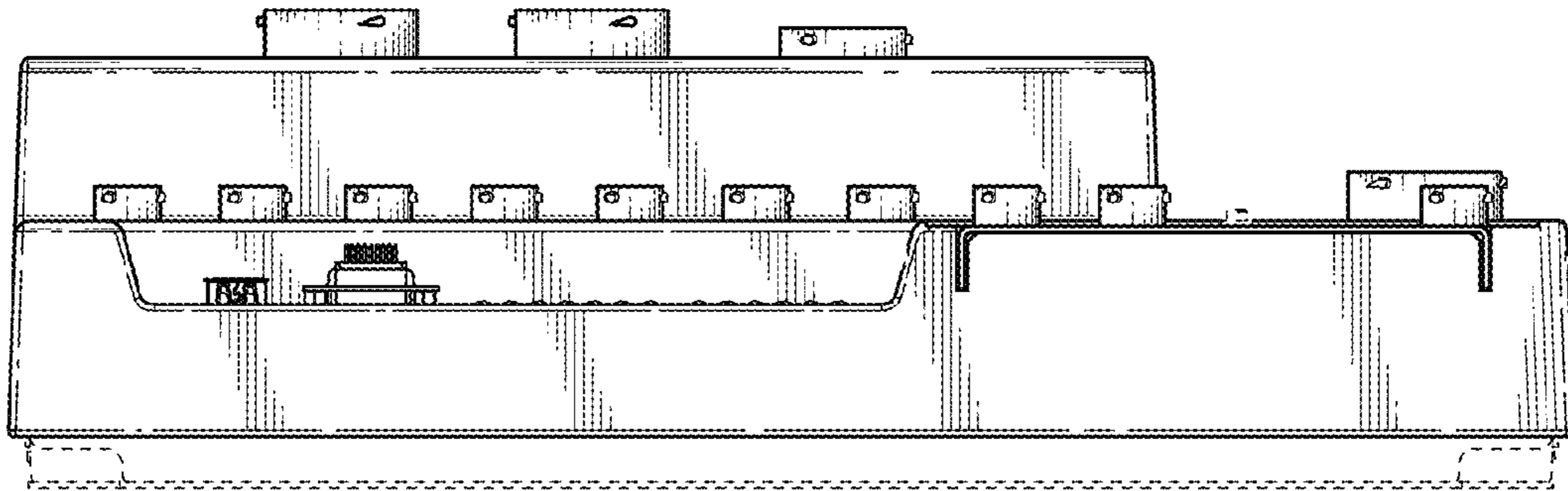

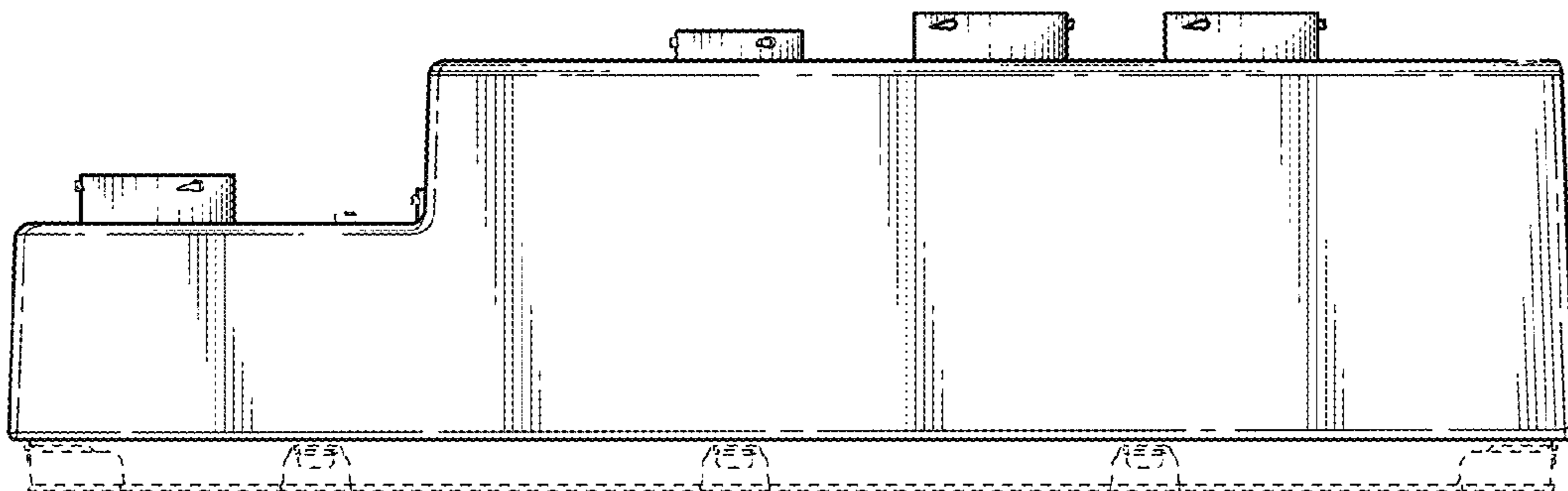

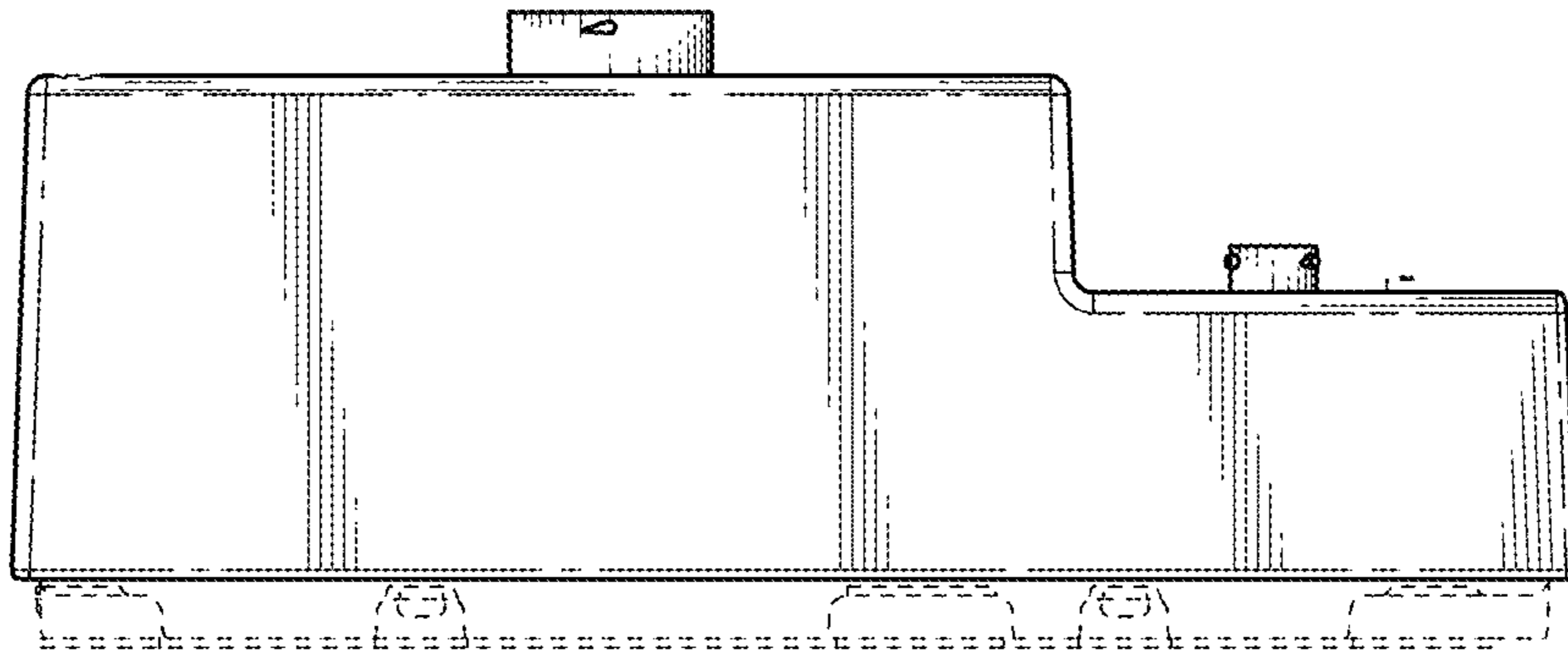

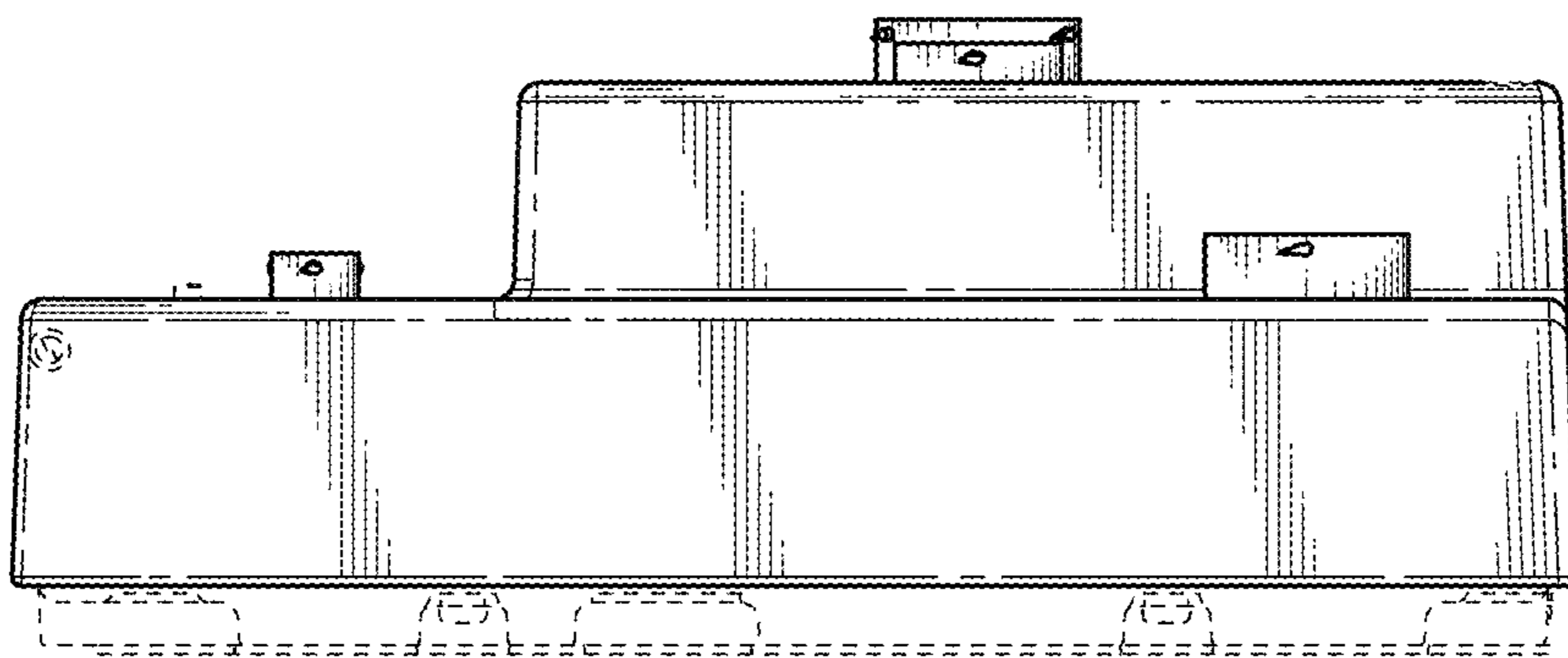

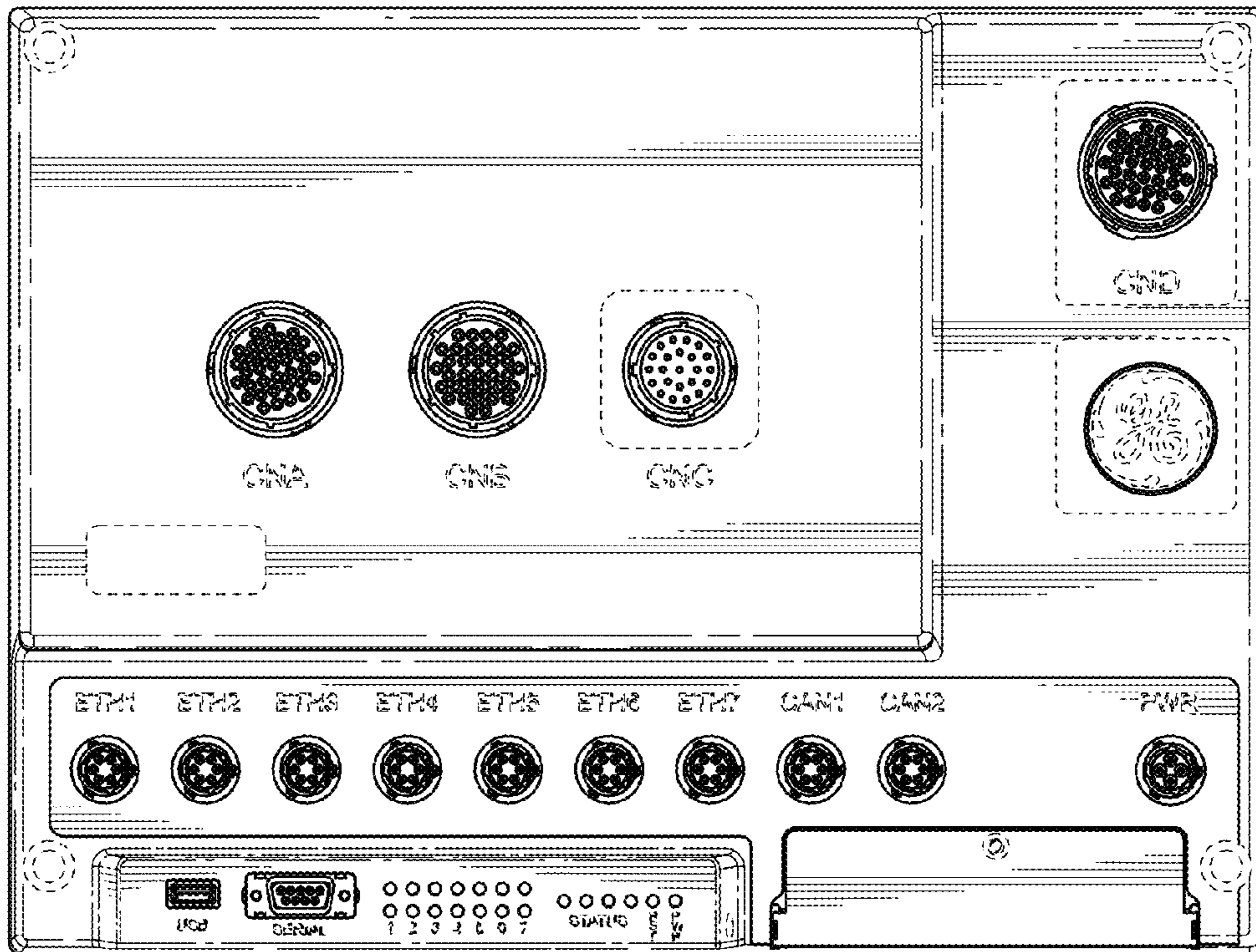

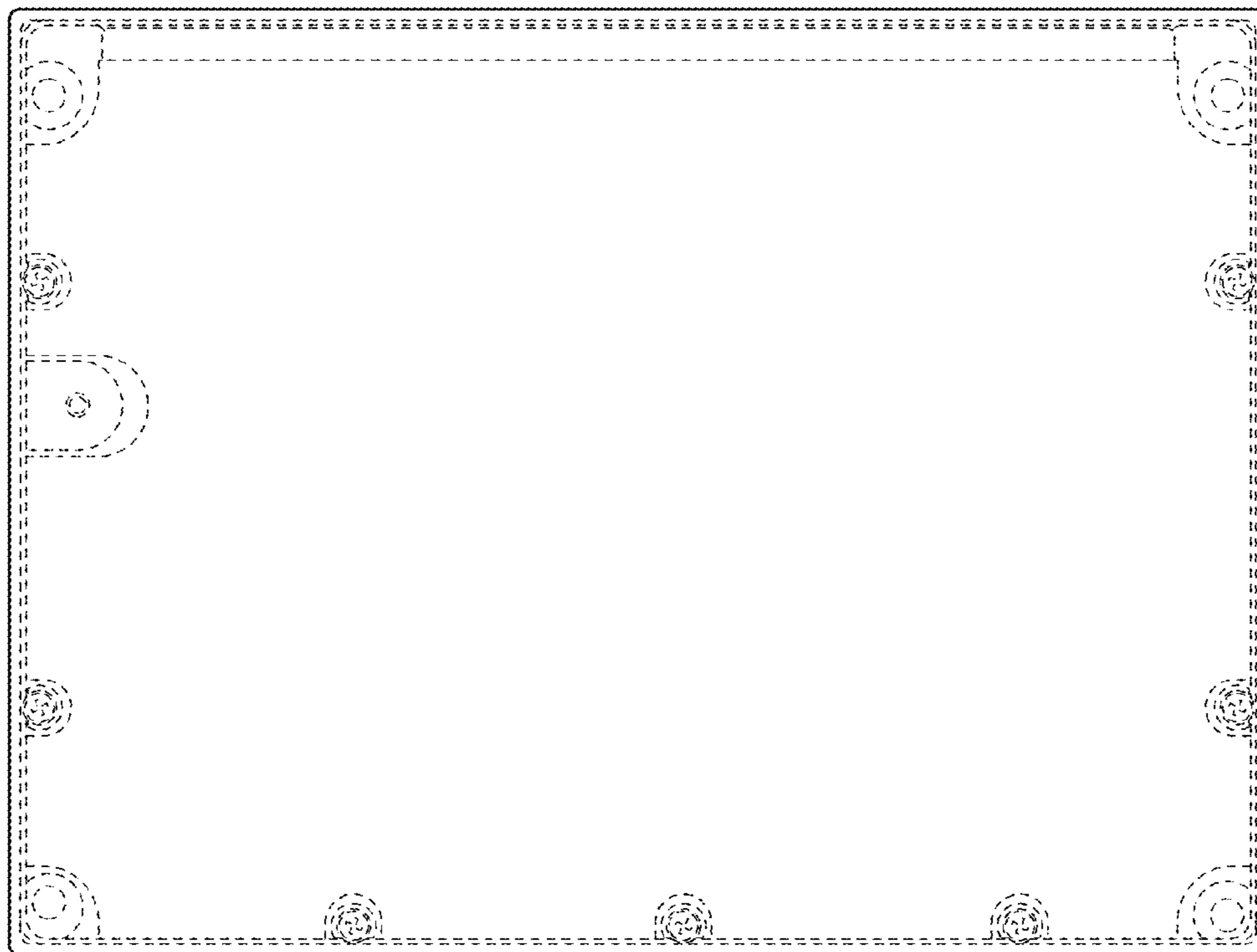
